Nucleosynthesis constraints on heavy in the presence of annihilations to majorons

A bstract

We show that in the presence of su-ciently strong—annihilations to majorons, primordial nucleosynthesis constraints can not rule out any values of the—mass up the present laboratory limit.

The tau-neutrino is the only one which can have mass in the M eV range. A mong all studied \lim its on m , the kinematical ones are the only model-independent bounds. The last result from ALEPH [1] is

In addition to this, there are stronger bounds from cosm ological considerations. From the contribution of stable to the present relic density one gets m < 92 h 2 eV [2], where h = H $_0$ =(100 km s 1 M pc 1). This means that a massive with mass in the M eV range must be unstable with lifetimes smaller than the age of the Universe.

M oreover, if m assive 's are stable during nucleosynthesis (lifetime longer than 100 sec), one can constrain their contribution to the total energy density, using the observed amount of primordial helium. This bound can be expressed through an elective number of massless neutrino species No. Using No. 43:403:6, the mass range

has been excluded [3, 4]. This forbids all masses on the few MeV range. However, such masses are theoretically viable [5], and interesting for a possible solution of the structure formation problem as described in [6].

It is possible to weaken the constraints on masses of (2), by adding new interactions of beyond the standard ones. One may consider either that the 's are unstable during nucleosynthesis [7] or that they possess new channels of annihilation beyond the standard ones. The last case is what we have considered.

We studied the elect of the presence of Majorana annihilations to majorons (J). The interaction term of the Lagrangian that describes the coupling between neutrinos and majorons can be expressed [5] as L $_{\rm J}$ gJ $^{\rm T}$, where g is a 3 3 matrix containing all possible couplings. In particular for the main processes are those described in gure (1). We assume that the coupling constants g_{23} (non-diagonal) and g_{33} (diagonal) are such that during nucleosynthesis time only annihilations are important. In previous works only the decay processes were taken into account, though in general g_{23} and g_{33} may be simultaneously important.




Figure 1: Non-diagonal and diagonal couplings of Majorana tau neutrinos and majorons.

where g g_{33} and represents a two-component M a jorana spinor. The corresponding elastic processes do not change the particle densities, but as long as they are elective they maintain all species with the same temperature.

Even after the 's have decoupled from standard weak interactions, they rem ain in contact with majorons. Therefore, as happens with photons and neutrinos when the e^+e^- pairs annihilate, after the decoupling there are two plasm as with dierent temperatures, one constituted of 's and J's and the other of the rest of the particles.

The evolution of the number densities of tau neutrinos (n) and m a jorons (n $_{\rm J}$) is given by the solution of a set of Boltzm ann dierential equations

where h vi is the therm ally averaged cross section of the annihilation process of 's to particle-type [8], where = e; 0; J. In the above equations we assumed Boltzmann statistics and $n_i = n_i^{eq}$ for i = e; 0.

Now let us brie y describe the calculations. First we norm alized the number densities to the number density of massless neutrinos, n_0 ' 0:18T ³. We introduced r $n=n_0$, where = ;J, and the corresponding equilibrium functions $r^{\rm eq}$. On the other hand we perform ed the integrations using the dimension-less variable x m =T. The set of equations (4) and (5) is completed with the evolution of the temperature, which is obtained from one of E instein's equations

Here and P are the energy density and pressure of tau neutrinos and majprons, respectively.

We have integrated numerically the coupled dierential equations in (4-6), obtaining the solutions of reforeach pair of values (megg). The initial conditions are, for su ciently high temperatures, $r=r^{eq}$, $r_J=r_J^{eq}$ and $T=T_J=T_0$.

The value of r (m ;g) is used to estim ate the variation of total energy density $_{\rm tot} = _{\rm R} +$. In $_{\rm R}$ all relativistic species are taken into account, including m a jorons and two m assless neutrinos, whereas is the energy density of m assive 's.

We can calculate now the elective number of massless neutrino species (N) corresponding to each r (m ;g). First we run a program which calculates the evolution of the neutron fraction (r_n) , as presented e.g. in [9], varying the value of N . Then we incorporate $_{\rm tot}$ to the same program and perform the integration for each pair of values (m ;g). Comparing r_n obtained in each case at T $^\prime$ 0:065 M eV (the moment when practically all neutrons are wound up in $^4{\rm H\,e})$, we can relate (m ;g) and N .

The results are shown in gure (2). One can see that for a $xed N^m ax$, a wide range of tau neutrino m asses is allowed for large enough coupling constants g. One sees that all m asses below 23 M eV are allowed by nucleosynthesis arguments, provided that the coupling between 's and J's exceeds a value of a few times 10^4 . Such values are reasonable for many majoron models [5]. A more detailed study of this problem will be presented elsewhere [10].

Our conclusion is that the constraints on the mass of a Majorana from primordial nucleosynthesis can be relaxed if annihilations \$ JJ are present.




Figure 2: E ective number of massless neutrinos equivalent to the contribution of massive neutrinos with dierent values of gexpressed in units of 10^{-5} . For comparison, the dashed line corresponds to the case when g=0 and no majorons are present.
