# Them ${ }^{4} \mathrm{~mm}$ Contribution to the Nucleon M ass in CHP T

A bstract

In CHPT the hadron $m$ asses obtain loop corrections from the pseudoscalarm esons which are identi ed w th the G oldstone bosons ofbroken chiral sym $m$ etry. A $n$ expansion of the baryon $m$ ass in the quark $m$ asses therefore includes non-analytic term s . W e calculate the nucleon m ass in the one-loop approxim ation to order $m^{4} \quad \mathrm{~m}_{\mathrm{q}}^{2}$. W e com pare the result in the relativistic and in the heavy $m$ ass form ulation of the theory and derive $m$ atching relations betw een corresponding low -energy constants. W e calculate the pion-nucleon loop in old-fashioned perturbation theory and nd a contribution to the $m^{4} \mathrm{ln} m$ term from an interm ediate state which does not occur in the heavy baryon theory.

## 1 Introduction

The QCD Lagrangian for $n$ avours of $m$ assless quarks is invariant under chiral rotations of the elds. The spontaneous breaking of the $S U(n)_{R}$ $\operatorname{SU}(n)_{L}$ chiral symm etry to $S U(n)_{V}$ gives rise to $n^{2} \quad 1 G$ oldstone particles which lead to infrared divergences. In the presence of $s m$ all quark $m$ asses the G oldstone bosons also becom e m assive and are identi ed w th the light pseudoscalar $m$ esons. The square of the $m$ eson $m$ ass $\mathrm{m}^{2}$ is proportional to the quark m ass $\mathrm{m}_{\mathrm{q}}$. The m ass of a hadronic bound state is determ ined by the QCD scale and by the quark $m$ asses. D ue to the G oldstone nature of the $m$ esons the expansion of the hadron $m$ ass in the quark $m$ asses is not a sim ple Taylor series but contains non-analytic term $s$ proportional to $\mathrm{m}_{\mathrm{q}}^{3=2}$ and $\mathrm{m}_{\mathrm{q}}^{2} \ln \mathrm{~m}_{\mathrm{q}}$.

H adronic low-energy processes cannot be com puted directly from the Q CD Lagrangian but they can be described by an e ective Lagrangian which reproduces the correct sym $m$ etry properties. Chiral Perturbation Theory (CHPT) is based on a sim ultaneous expansion in powers of derivatives and of quark $m$ asses [ $[1] 1]$. In a relativistic form ulation of the e ective theory the loop expansion coincides w ith the expansion in sm all m om enta and m asses. In the $m$ esonic sector higher dim ension operators are typically suppressed by factors ofm ${ }^{2}={ }^{2}$ where $=4 \mathrm{~F}$ is the QCD scale of order 1 GeV .

In the baryonic sector the chiral expansion is com plicated by the additional scale introduced by the $m$ ass $M$ in the baryon propagator whidh is of the sam e order as itself. T he loop expansion no longer coincides w th the sm allm om entum expansion. A consistent power counting is only possible if the baryon kinem atics is treated in a non-relativistic fram ew ork 畒].

In this article we consider the dependence of the nucleon $m$ ass on the m asses of the two lightest quark avours, the $u$ and $d$ quark, keeping $\mathrm{m} \mathrm{s}_{\mathrm{s}}$ xed. In the two- avour sector the low-energy particle spectrum consists of nucleons and pions. W e work in the isospin lim it, setting $\mathrm{m}_{\mathrm{u}}=\mathrm{m}_{\mathrm{d}}$. Then the proton and neutron form a mass degenerate isospin doublet while the pions belong to a triplet. The expansion of the pion $m$ ass squared starts w th $\mathrm{m}^{2}=\left(\mathrm{m}_{\mathrm{u}}+\mathrm{m}_{\mathrm{d}}\right) \mathrm{B}+\mathrm{O}\left(\mathrm{m}_{\mathrm{q}}^{2} \mathrm{ln}_{\mathrm{m}}^{\mathrm{q}}\right.$ ) where B is related to the quark condensate. It is convenient to use the abbreviation $m^{2} \quad\left(m_{u}+m_{d}\right) B$. The
expansion of the nucleon $m$ ass is given by

$a_{0}$ is the value of the nucleon $m$ ass in the chiral lim it where $m=0$. The coe cient $a_{2}$ receives contributions from pion-nucleon loops and pion tadpoles. In this article we com pare these contributions in CHPT and in the heavy baryon expansion. This com parison leads to $m$ atching conditions for corresponding low-energy constants. W ith the help of non-relativistic oldfashioned perturbation theory we can then show that the pion-nucleon loop contribution to $a_{2}$ in CHPT is due to two di erent interm ediate states. O ne of them contains an anti-nucleon and has no corresponding counterpart in the heavy baryon theory.
$T$ his article is organized in the follow ing way. In section 'ī1 we list those term $s$ in the pion-nucleon Lagrangian which are relevant for the calculation of the nucleon $m$ ass. W e give them in the relativistic theory and in the heavy baryon approxim ation. Section ' cients $a_{i}$ in both approaches and $m$ atching conditions for the corresponding low-energy constants. In section ', ${ }_{-1}^{1 / 1}$ we calculate the pion-nucleon loop contribution in old-fashioned perturbation theory and discuss the origin of the non-analytic term s , in particular ofm ${ }^{4} \mathrm{ln} m$, in the di erent approaches. Section 'S.-1 contains a short sum $m$ ary of the results.

## 2 The E ective Lagrangian

The chirale ective Lagrangian forbaryonshasbeen given by G asser et al. [\$ַ,1].]. It is given by a string of interaction Lagrangians of increasing chiral power,

The superscript (i) in $L^{(i)}$ gives the num ber of derivatives and/or powers of quark $m$ ass. $L^{(1)}$ contains the free nucleon Lagrangian. The nucleon $m$ ass to order $m{ }^{4}$ in the one-loop approxim ation is determ ined by tree graphs and one-loop graphs with vertioes from $L^{(1)}$ and $L^{(2)}$. From the higher order Lagrangians $L^{(3)}$ and $L^{(4)}$ we only have to consider tree diagram s. In the calculation of the selfenergy there arises a term of dim ension zero which
requires the introduction of a counterterm Lagrangian $L^{(0)}$. Explicitly we have

$B$ rackets denote the trace in isospin space, $M$ is the bare nucleon $m$ ass, F $\quad$, 93 M eV the pion decay constant and $g_{A}{ }^{\prime} 1: 25$ is the axial-vector coupling constant. The three pions are param etrized w ith the help of the Paulim atrioes ,

There is no term in $L^{(3)}$ which can give a contribution to the nucleon $m$ ass up to order $\mathrm{m}^{4}$. The term proportional to $\mathrm{C}_{2}$ in $\mathrm{L}^{(2)}$ does not contribute to the nucleon m ass. T hus we have om itted it, together w ith other interaction term $s(+\quad)$ which are irrelevant for the determ ination of the coe cients a and $a_{3}$ ofequation ( $i_{-1}^{1}$ ). The constants $c_{1} ; c_{3}$ and d are divergent and have to be renom alized.

is the renom alization scale introduced by dim ensional regularization. T he nite low -energy constants $C_{i}^{R}()$ are a prioriundeterm ined but can in principle be xed from phenom enology. Their corresponding counterparts $c_{i}^{0}$ in the heavy baryon approxim ation have been calculated (see equation (2̄) below). In section 'ī1 we derive $m$ atching conditions betw een the low -energy constants of both theories at the renorm alization scale $=M$ and give num erical

N ote that the D irac m atrioes have been expressed in term sofv and the velocity-dependent spin operator $S=\frac{i}{2} 5 \mathrm{v}$ which obeys $S \mathrm{v}=0$. In the heavy baryon approxim ation the nucleon $m$ ass vanishes in the chiral lim it, therefore there is no $\mathrm{L}_{\mathrm{hb}}^{(0)}$. The term $s$ in $\mathrm{L}_{\mathrm{hb}}^{(2)} \mathrm{w}$ th have xed coe cients are due to the $1=\mathrm{M}$ expansion of the Lagrangian $L^{(1)}$. The rst two contributions are corrections to the kinetic energy. The term proportional to (v @)does not contribute to $m$ atrix elem ents at order $1=\mathrm{M}$ because of the leading order $D$ irac equation for $B$. The counterterm $d^{0}$ has to be renorm alized.

The low energy coe cients $\mathrm{c}_{\mathrm{i}}^{0}$ are nite. They are determ ined from the pion-nucleon term and from N scattering lengths. W e take the num erical
values given by M ei ner in ref. $[\overline{-}$ ] $]$ where one can nd a criticaldiscussion of these num bers and their errors.

## 3 The N ucleon M ass

The relativistic calculation yields the follow ing results for the coe cients $a_{i}$ of equation (

$W$ e have chosen the value of $M$ in such a way that $M$ phys: $=M=a_{0}$ in the chiral lim it. The result in the heavy baryon lim it is

The huge error of $C_{3}^{R}(M)$ is due to the fact that the central values alm ost cancelwhile the errors sum up: $\left(5 q+\frac{1}{4} c_{2}^{0}+c_{3}^{0}\right)=\left(\begin{array}{ll}0: 16 & 1: 56\end{array}\right)$.

## 4 The O rigin of the $\mathrm{m}^{4} \mathrm{lnm}$ term

The coe cient $\mathrm{a}_{2}$ of the non-analytic term proportional to $\mathrm{m}^{4} \ln m$ receives contributions both from the pion-nucleon loop and from pion tadpoles. H ow ever, depending on which theory one uses to calculate the nucleon $m$ ass, the loop and the counterterm splay a di erent role. The coe cient of the leading non-analytic term proportional to $\mathrm{m}^{3}$ on the other hand is entirely due to the pion-nucleon loop in both $m$ odels. In the relativistic theory we have

$W$ e can calculate $a_{2 ; \text { loop }}$ from the pion-nucleon interaction in $L^{(1)}$ by using old-fashioned perturbation theory. There one looks for a solution of the eigenvalue problem

where $\mathrm{H}_{0} ; \mathrm{E}_{0}$ and 0 are the unperturbed quantities and E (int:) is the energy of the interm ediate state jint:i. The energy-shift directly translates into the $m$ ass-shift and we can therefore investigate the contributions of the possible interm ediate states to the coe cients $\mathrm{a}_{\mathrm{i}}, \mathrm{H}_{1}$ is proportional to $\mathrm{L}^{(1)}$ and we nd two interm ediate states which give a non-vanishing $m$ atrix elem ent. They are depicted in gure ${ }_{\text {Line }}$. State (a) contains one pion and one nucleon, state (b) contains one pion, two nucleons and one anti-nucleon. T heirm atrix elem ents are determ ined by three-dim ensional integrals,

The sum of the two contributions is just the relativistic loop integral in the rest fram e of the nucleon, $p=(M ; 0)$, after integration over the tim e com ponent $l^{\circ}$.

$W$ e expand the integrands in term sofm and use dim ensional regularization to evaluate the integrals. The leading non-analytic term proportional to $m^{3}$ in equation (1̄1) is entirely due to the interm ediate state (a) as we would expect. The contributions to the coe cient $a_{2 ; 100 p}=a_{2}^{(a)}+a_{2}^{(\mathrm{b})}$ from the two states are given by

The reason that state (a) contributes to the logarithm ic divergence is clearly due to the singular behaviour of the denom inator in the integral: $M \quad e(m) \quad e(M)]$ is infrared divergent for vanishing $m^{2}$ (chirallim it). Still it does not give the full contribution to $\mathrm{a}_{2}$.

The surprising result is, that there is also a non-zero $a_{2}^{(0)}$. The integral which gives the contribution from state (b) has a denom inator proportionalto 2 M in the chirallim it, it is nite. O bviously, its derivative w ith respect to $\mathrm{m}^{2}$ is not and the singularity com es from the expansion of the integrand in term $s$ of $m$. The interm ediate state (b) contains an anti-particle, a con guration which does not occur in the fram ew ork of the heavy baryon expansion. H ere the loop contribution from $L_{h b}^{(1)} \quad L_{h b}^{(1)}$ is independent of $M$. It gives just the non-analytic term proportional to $\mathrm{m}^{3}$ and no contribution to $\mathrm{a}_{2}$ or $\mathrm{a}_{3}$. The non-zero contribution to $a_{2}$ com es from the $L_{h b}^{(1)} \quad L_{h b}^{(2)}$ loop. W e have

while the heavy baryon calculation gives $\mathrm{a}_{3 ; \text { loop }}=0$.
W e have the follow ing results. The pion-nucleon loop is alw ays responsible for the leading non-analytic term proportional to $\mathrm{m}^{3}$. In the relativistic theory, the loop of $L^{(1)} \quad L^{(1)}$ contributes to the coe cients $a_{2}$ and $a_{3}$. In old-fashioned perturbation theory it is the interm ediate state (a) with one $m$ eson and one baryon which gives the leading singularity. The perturbative treatm ent shows that state (b), which contains an anti-baryon, gives also a contribution to $a_{2}$. W e would not have expected this, since the integral expression which describes its contribution to the nucleon $m$ ass looks perfectly innocuous. In the heavy $m$ ass theory the loop of $L_{h b}^{(1)} L_{h b}^{(1)}$ can only contribute to orderm ${ }^{3}$. It gives no contribution to $\mathrm{a}_{2}$ or $\mathrm{a}_{3}$. Them ${ }^{4} \mathrm{lnm}$ term s
are due to pion tadpole contributions of $\mathrm{L}_{\mathrm{hb}}^{(2)}$ and to the loop of $\mathrm{L}_{\mathrm{hb}}^{(1)} \quad \mathrm{L}_{\mathrm{hb}}^{(2)}$, which are both suppressed by a factor of $1=\mathrm{M}$.

## 5 Sum m ary

W e have calculated the nucleon $m$ ass in the one-loop approxim ation to order $\mathrm{m}^{4} \quad \mathrm{~m}_{\mathrm{q}}^{2}$ in CHPT and in the heavy baryon approxim ation. W e reproduce the $m$ atching condition for the low -energy constant $\mathcal{C}_{1}^{R}(M)$ of Bemard et al.
 have used old-fashioned perturbation theory to decom pose the contribution of the relativistic pion-nucleon loop into the sum of term scorresponding to two di erent interm ediate loop states. T he leading singularity proportional to $m^{3}$ is alw ays due to the pion-nucleon loop. The coe cient $a_{2}$ ofthem ${ }^{4} \mathrm{lnm}$ term in equation ( $\bar{i} 1 \mathbf{1})$ can have contributions from the pion-nucleon loop and from pion tadpole diagram $s$. T hese contributions are $m$ odel dependent.

In the relativistic theory there is a contribution to the logarithm ic divergence from the loop of $L^{(1)} L^{(1)}$. O ther contributions com e from the tadpole diagram s ofL ${ }^{(2)}$, they are proportionalto the counterterm $s$ $c_{1}$ and $c_{3}$.

In the heavy baryon approxim ation the loop of $\mathrm{f}_{\mathrm{Hb}}^{(1)} \mathrm{I}_{\mathrm{hb}}^{(1)}$ gives no contribution to the logarithm ic term. To leading order in $1=\mathrm{M}$ there is just the leading singularity proportionalto $\left.\mathrm{m}^{3}{ }_{4}^{[4]}\right]$. C onsequently, all contributions to $\mathrm{a}_{2}$ are suppressed by a factor of $1=\mathrm{M}$.

In old-fashioned non-relativistic perturbation theory there are two interm ediate states (see gure 'i्1-1). State (a) contains one pion and one nucleon. The relevant integral gives an $\mathrm{m}^{4} \mathrm{lnm}$ contribution due to the vanishing of the denom inator in the chiral lim it. State (b) contains one pion, two nucleons and one anti-nucleon and also contributes to the $m^{4} \mathrm{ln} m$ term although the denom inator in the corresponding integral is nite. In this case the logarithm ic singularity arises from the expansion of the integrand in $m$.
