Induced Light-Quark Yukawa Couplings as a probe of Low - Energy Dynam ics in QCD

A bstract

We exam ine the heavy-quark-induced Yukawa interaction between light quarks and a light Higgs eld, which is facilitated in the chiral lim it by the dynam ical mass of light quarks anticipated from the chiral-noninvariance of the QCD vacuum. A low-energy estimate of the strong coupling near unity can be obtained from a comparison of the explicit perturbative calculation of the induced Yukawa interaction at zero momentum to a Higgs-low-energy theorem prediction for the same interaction.

The e ective coupling of zero-m om entum H iggs particles to nucleons is well-known [1,2] to be approximately of magnitude 70M eV N_h=h i, where N_h is the number of heavy quark avours, and where h i is the vacuum expectation value of the H iggs eld. A lthough this result is physical only if the mass of the H iggs is light compared to $F_{\rm ew}$, the electroweak scale, we can nevertheless use it at the quark level to probe the strong coupling at low energies.

In this paper we consider the coupling of a zero m om entum Higgs particle to light quarks to get insight into the magnitude of the low-energy QCD coupling. In other words, we augment QCD with a light (gedanken) Higgs boson in order to explore nonperturbative QCD dynamics. Specically, we compare Higgs-low-energy theorem predictions appropriate for light quarks to the explicit perturbative calculation of the Yukawa interaction induced via heavy-quarks. This comparison provides an estimate of the QCD coupling characterizing the latter calculation. In both cases, we work in the chiral lim it in which the light quark is assum ed to have no tree-level Yukawa interaction, but is assum ed to obtain mass dynamically via the chiral noninvariance of the QCD vacuum [3, 4, 5]. For the low-energy theorem calculation of the light-quark Yukawa interaction, this assumption in plies an e ective quark mass proportional to OCD, leading to a calculation identical in form to the low-energy-theorem prediction [2] for the Higgs-nucleon interaction. For the explicit perturbative calculation, we consider a mass function suggested by Holdom [6] that falls o with momentum with asym ptotic 3 = p^2 behaviour. The com parison of the quark-level low-energy theorem to the explicit quark-level calculation suggests a low energy value for s near unity, as anticipated from chiral symmetry breaking [3, 5] and other low-energy considerations [7].

To begin the perturbative quark-level calculation, we set consider the coupling of the zero 4-m omentum Higgs eld to two gluons that is induced by a heavy quark triangle (Figure 1), with progresponding to the external gluon momentum [8]. The triangle is given by the

following tensor:

In (1) and (2), M is the heavy quark mass, s is $g_s^2 = (4)$, and h i is the vacuum expectation value of the H iggs eld. Thus, the parameter c contains the dimensionless Yukawa coupling between heavy quarks and the H iggs eld. The factor of 2 preceding the integral in (1) accounts for the two possible directions for the fermion arrows in Fig. 1. The denominator in (1) can be combined via the usual Feynman parameterization, so as to obtain $(k^0 + px; p^2 + 0)$

The transversality of this expression ensures gauge-parameter independence of light-quark Yukawa couplings induced via Figure 2. Two limits of interest are the limits of in nitemass and in nitemomentum:

Equation (5) illustrates the well-known result that for very heavy quarks, the quark triangle is independent of the heavy quark mass [1, 2], suggesting that heavy avours c, b, and t will generate equivalent contributions to the Yukawa interaction induced via Figure 2. This property ensures that the contribution of Figure 2 to the light-quark Yukawa interaction will be proportional to the number of heavy avours, as anticipated from the Higgs-nucleon interaction discussed at the begining of this paper. Substitution of (6) into (3) demonstrates that the quark triangle will serve as a cut-o in integrals over the gluon momentum of Figure 2, ensuring a nite renormalization—independent result. In other words, the induced Yukawa interaction is an infrared elect.

The Yukawa coupling to light quarks induced via Figure 2 m ay be expressed as follows:

To evaluate this expression, we nd it convenient to express the heavy quark triangle (3) in the following form:

Let us rst suppose that the light quark's mass term is constant. In this case we must replace the factor $_{QCD}$ [(k p) 2] in the denominator of the integrand in (7) with a hard mass denoted by m $_{\rm dyn}$. We then that the induced Yukawa interaction is given by

This induced Yukawa interaction is seen to be characterized by a mass that is suppressed by a factor of 2 $_{\rm s}^2$ [In (M =m $_{\rm dyn}$) + 5=6]=(3 2) relative to the hard (dynamical) light-quark mass. However, this estimate tells us very little{the presence of the large logarithm in (10) necessarily indicates sensitivity of the Feynman integral to the ultraviolet region, in which case one cannot assume that the factor $_{\rm s}^2$ appearing in (10) characterizes exclusively lowenergy dynamics.

We now consider the more realistic case in which $_{QCD}[(k p)^2]$ is interpreted as a dynam ical mass function generated by the chiral noninvariance of the QCD vaccuum. This self-energy is expected to fall o like $1=(k p)^2$ for large j_k p_j . Since this dynam ical mass decreases sharply with increasing momentum, the Yukawa interaction induced via Figure 2 is more sensitive to the infrared portion of the integration region, corresponding to the low-energy region for $_s$. We utilize the phenomenological self-energy proposed by Holdom [6]

in conjunction with (8), in order to obtain the following expressions for $C(k^2)$ and $B(k^2)$ in (7):

We can easily evaluate these integrals numerically when $k^2=0$, the quark's Lagrangian-mass shell in the chiral limit. Upon performing the Wick rotation $d^4p!$ $id^4p_E=i^2xdx$, we not

that

Choosing A = 2 and = 317M eV [6], we nd that

In the chiral lim it, there is no Lagrangian m ass term for the light quark, and the C (k^2) * is expected (via Lagrangian eld equations) to annihilate an external light quark spinor u (k) when $k^2 = 0$. However, the contribution of C (0) to the induced Yukawa interaction is seen to be small even if we go so far as to identify k with an order-300M eV dynamical mass. Specifically, we ind C (0) = 0.051 $_s^2$ =h i when A = 2 and = 317M eV, in which case C (0)m $_{dyn}$ [15 $_s^2$ M eV=h i] is still substantially smaller than B (0).

Thus, we not from (16) that the elective mass characterizing the induced Yukawa interaction between a zero-momentum light quark and a zero-momentum Higgs to be of order 60 $_{\rm s}^2{\rm M}$ eV. Inclusion of a dynamical mass shell [i.e., adding C (0)m $_{\rm dyn}$ to B (0)] would increase this estimate to about 77 $_{\rm s}^2{\rm M}$ eV. We reiterate that the light quarks are assumed to possess only dynamical mass contributions (the Lagrangian Yukawa coupling to light quarks is assumed to be zero, consistent with the chiral limit.

We now compare (16) to the Yukawa coupling anticipated via Higgs Boson low-energy theorems. The relevant low-energy theorem between matrix elements A! B and A! B+ Higgs is given by [2]

where N $_{\rm h}$ is the number of heavy quarks. If A and B are both identied with constituent u ord quarks, then the physical matrix element M (A ! B) is just the dynamical quark mass m $_{\rm dyn}$, which is clearly proportional to $_{\rm QCD}$. To one loop order,

with d=4=9 for three light quark avours. Consequently, one nds that if $m_{\rm dyn}$ $_{\rm QCD}$, then

Substitution of this result into the low-energy theorem for light-quark (q) higgs couplings yields the result

corresponding, for $N_h = 3$ (c,b,t) to a Yukawa coupling characterized by a mass of about 70M eV.³

We see that comparison of (20) and (16) suggests a low-energy value for $_{\rm s}$ near unity, consistent with criticality arguments for chiral symmetry breaking [3,5] as well as with the freeze-out of the strong coupling near unity discussed by Mattingly and Stevenson [7]. There are, of course, concerns that such a large value of $_{\rm s}$ will destroy the validity of the perturbative expansion. There is some reason to believe, however, that the relevant expansion parameter near criticality of $_{\rm s}$ is $_{\rm s}$ N $_{\rm c}$ =4 [10], perhaps providing some additional supression of higher-order contributions. Note also that a comparison of (20) to the hard dynamical mass result (10) for each heavy quark about would suggest a smaller value for

 $^{^3}$ T his is precisely the sam em echanism used by D aw son and H aber [2] to predict the H iggs-nucleon-nucleon coupling, as the chiral lim it of the nucleon m ass is also assumed to be proportional to $_{Q\,C\,D}$. Replacing the dynamical quark mass with the nucleon mass in (19) leads to Daw son and H aber's prediction for the Higgs-nucleon-nucleon coupling of order 200M eV=h i.

 $_{\rm s}$ ($_{\rm s}$ 1=2), but this value cannot be exclusively identied with the low energy region of hadron physics, as has already been discussed.

Moreover, we see from (20) that the mass associated with the induced Yukawa coupling to light quarks via heavy quark loops is considerably larger in magnitude than the current (Lagrangian) mass usually assumed for light quarks. One can also apply the low energy theorem (17) to exam inewhether or not Yukawa couplings to heavy quarks (Q) are similarly characterized by enhanced masses (masses substantially larger than those in the Lagrangian):

The heavy quark mass m $_{\mathbb{Q}}$ is not proportional to $_{\mathbb{Q}\,\mathbb{C}\,\mathbb{D}}$, but depends on $_{\mathbb{S}}$ via the relation—ship

where m is a renorm alization-group invariant quark mass, and where d^0 12=(33 2 μ). Substituting (22) into (21), we note that

corresponding to an enhancement of at most 14% over the Lagrangian Yukawa coupling m $_{\rm Q}$ =h i if $_{\rm S}$ 1.

In conclusion, we not that a comparison of the low-energy-theorem Yukawa interaction, characterized by a mass of 70M eV, to an explicit perturbative calculation of the same interaction, characterized approximately by a mass between 60 $_{\rm s}^2$ 80 $_{\rm s}^2$ M eV, suggests that the strong coupling at low energies is surprisingly close to unity.
