## A B STRACT

W e consider a scalarm assless quantum eld $m$ odel, at nite tem perature $T$, both renorm alizable and asym $p$ totically free. Focussing on the singular structure of the e ective perturbation theory about the light cone, several new insights are put forth, regarding the interplay betw een hard therm alloop resum $m$ ation and the overall com pensation of collinear singularities.

## 1. Introduction

The inherent non perturbative character of nite tem perature quantum eld theorieshasbeen recognized a few years ago on the basis of general group theoretical argum ents [1]. At the sam e time, the form al perturbative series them selves were shown to necessitate a full rede nition of their original form so as to yield (hopefully) sensical results. This is the resum $m$ ation program devised by B raaten and $P$ isarski and also by Frenkel and Taylor [2], hereafter referred to as "e ective theory" for short.
In order not to be just an academ ic recipe, such a program im plicitly requires that the original and/or re-organised perturbative series be infrared safe. In the recent years, a great dealofe orts has been devoted to the study of the infrared structure of the original perturbative series, $w$ ith the conclusion that, roughly speaking, the situation at non zero tem perature ( $T \in 0$ ) was not worse, globally, than at zero tem perature ( $\mathrm{T}=0$ ) [3].

But re-de ning a perturbative series is rarely trivial an operation. P roperties which were known to hold true for the original series $m$ ay becom e $m$ uch harder to control in the rede ned one. In our opinion, the collinear singularity recently found in them alQCD by using the e ective perturbative series $[4,5] \mathrm{m}$ ight reveala salient ilhustration of this fact. N ote that we are aw are that this point of view di ers, at rst sight, from the ones adopted in the solutions proposed in [6] and [7]. Very recently, though, it has been realized [18], that som e unexpected connection could exist w ith the analysis proposed in [6]. In this paper we will restrict ourselves to a scalarm odel and analyse the singular structure of the e ective theory in $m$ uch details.

A prelim inary report of the present w ork appeared in [8], which is here corrected, com pleted and en larged. The paper is organized as follow s. Section 2 is an introduction to the model, and the necessary elem ents of the particular real tim e form alism which is used, are given. In section 3, the singularity structure of a whole series of diagram $s$ is investigated, deferring som e lengthy details to an appendix. The results of this section rely on an approxim ation which consists in keeping only the potentially most singular part of the hard them al loop (H T L) self energy. This approxim ation gets com pleted in section 4, where the other term s are taken into account. Further consequences are draw $n$ in sections 5 and 6 , respectively related to the problem of the $T=0$ and $T$ \& singularity $m$ ixing, and to the possibility of an unam biguous renorm alisation constant de nition in a therm al context. Eventually, a conclusion gathers our results.

## 2. Them odel

In order to get rid of unessentialcom plications, we dealw ith the toy $m$ odelprovided by a $m$ assless herm itian scalar quantum eld. It is endowed with a cubic self interaction, of coupling strength $g$, renorm alisable at $D=6$ space-tim e dim ensions. Furtherm ore, its quanta are assum ed to form a plasm a in them odynam ical equilibrium at tem perature $T$. Infrared as well as ultraviolet singularities are taken care of by working at $D=6 \quad 2 "$ space-tim e dim ensions respectively. A lso, we will use the convention of upper case letters for $D$ m om enta and low er case ones for their com ponents, ie, $P=\left(p_{0} ; p\right)$.
U se w illbe m ade of the $m$ aterial and results of a previous w ork [9] where a calculation perform ed at second non trivial order ofbare perturbation theory, $O\left(g^{4}\right)$, was able to display the overall com pensation of infrared and collinear singularities for som e particular topology.
$T$ he process under consideration consists in a "H iggs" particle of $m$ om entum $Q=(q ; 0)$ in the rest-fram $e$ of a plasm a in equilibrium at tem perature T.But, contrary to the case studied in [9], this $\mathrm{D} \rightarrow \mathrm{m}$ om entum is here assum ed to be soft, that is $q=O(g T)$. A lso, our analysis $w$ ill take place in the fram ew ork of the real tim e form alism, w thin "the basis" provided by the retarded and advanced free eld functions, $R(\mathbb{K})$ and

A ( $K$ ) respectively [5]. At any step, though, we have checked that the sam e expressions are obtained in the $m$ ore custom ary realtime form alism of the $K$ obes and Sem eno rules (the "1/2" form alism, say).

The realpart of the them al one loop self energy reads [9]
where a com binational weight factor $1=2$ is taken into account, and where $P$ stands for a principal value prescription. A lso, throughout the calculations, use will be $m$ ade of the follow ing relations for statistical factors

The phase-space dom ain where collinear singularities come from has been recognized to be determ ined by the condition $P^{2} \ll \mathrm{p}^{2} \ll \mathrm{~T}^{2}$. In this dom ain, the function $\mathrm{fRe} \mathrm{T}_{\mathrm{T}} \mathrm{g}$, that we choose to describe in term S of the tw $O$ independent variables $P^{2}$ and $p^{2}$, is approxim ated by a realfunction $A$, de ned for all $P^{2}$ values

Expression (2.3) displays the full HTL (that is, leading, order $\mathrm{g}^{2} \mathrm{~T}^{2}$ part) entailed in the real part of the them al self energy function. Only for space-like values of its argum ent $P^{2}$, does the them al self energy function develop an im aginary part of sam e leading order $\mathrm{g}^{2} \mathrm{~T}^{2}$. T his corresponds to the so called "Landau dam ping $m$ echanism ", and one can w rite eventually

$N$ ote that in (2.6), the lim it " = 0 can be safely taken and that the them alselfenergy function is a regular function of $\mathrm{P}^{2}$ in any neighbourhood of the light cone. O ne gets e ectively

which, expressed in term s of the variables $P^{2}$ and $p^{2}$, is nothing but the $m$ ore fam iliar form [12] of the HTL self energy of the $m$ odel, with its second kind Legendre function $Q_{1}\left(p_{0} ; p\right)$ approxim ate form at $p_{0} j p$. In the $R=A$ real tim e form alism we will be using, retarded and advanced functions $m$ ust be used. They are sim ply related to the Feynm an ones by the set of relations

In the region D where one has $\mathrm{P}^{2} \ll \mathrm{p}^{2} \ll \mathrm{~T}^{2}$ and $\mathrm{O}(\mathrm{p})=\mathrm{gT}$, e ective propagators ( P ) m ust be used so as to get the full leading order $g^{2} \mathrm{~T}^{2}$ correction to the free quantities, w th

A point to be stressed is that the dom ain which requires that e ective perturbation theory be used, is also the dom ain where $m$ ass (or collinear) singularities stem from, thereby opening up the very "w indow "where the light cone singular behaviour of the e ective them al expansion $m$ ust be studied.

An im portant rem ark is in order. Adm ittedly, there is no HTL in the three-point function of the $\left(g^{3}\right)_{6}$ theory [10], in the sense that $\mathrm{g}^{2} \mathrm{~T}^{2}$ leading parts, eventually, cancel out, leaving order $\mathrm{g}^{2} \mathrm{~T}^{3=2}$ pieces at m ost. H ow ever, in [10], not all the term s w ere considered and, m ore generally, it should be noted that this statem ent is not su cient for ignoring the one loop three point function. For exam ple, it has been stressed recently [7] that, over collinear con guration of extemal soft m om enta, a specialenhancem ent ofbare orders ofm agnitude, results out of collinear singularities, leading to a breakdow $n$ of the $\mathrm{H} T \mathrm{~L}$ resum $m$ ation program . H ow ever, besides the new intemaldi culties encountered by the im proved H T L resum $m$ ation program itself [24], it is im portant to realize that such a situation does not show up here. $T$ his is basically because the $H$ iggs particle has tim elike $D \rightarrow m$ om entum $Q=(q ; 0)$. Explicit calculation then show $s$ that no collinear singularity ever develop in that case. N ow, a wider analysis of the three point function is certainly worth undertaking, but falls beyond the scope of the present article where one loop vertex corrections w ill not be considered.

## $3-$ S ingular structure

W e begin w ith considering the case of N one-loop self energy insertions along the P -line as depicted

$w$ here $V_{R R A}$ is the bare vertex $w$ th two extemal lines of the retarded type, corresponding to $D$ m om enta $P$ and $Q$, and one advanced extemal line of $D \rightarrow m$ entum $P^{0}$. The convention for the ow ofm om enta is that their sum vanishes: $P+Q+\left(P^{0}\right)=0$. At zeroth order, $V_{R R A}$ is sim ply given by the "electric charge", $e$, which couples the $H$ iggs particle to the herm itian scalar eld. Eventually, the prescription "D iscp " $m$ eans that the discontinuity in the variable $p_{0}$ is to be taken. In the $f R=A g$ realtim eform alism we are using, this is sim ply achieved by w riting

where " $\left(p_{0}\right)$ is the sign of $p_{0}$, and ${ }^{(N)}$ the $N^{\text {th }}$ derivative of the -distribution. In view ofequations (2.3), (2.5) and of their bounded $P$-dom ain, note that the real and im aginary parts of the $f{ }_{R}^{H T L}(\mathbb{P}) g^{N}$-insertions are acceptable test-fiunctions, yielding well de ned expressions when acted upon with ${ }^{(N)}\left(P^{2}\right)$ and $P=\left(P^{2}\right)^{N+1}$ distributions respectively. H ow things are working out is instructive to observe. At $\mathrm{N}=1$, we have from the ${ }^{(1)}\left(P^{2}\right)$-term

$T$ he sum of the two tem s displays the com pensation of the collinear singularity, as noticed long ago by $m$ any authors for scalar as w ell as for gauge theories.
At $N=2$, one has $R e{ }_{R}^{2}(P)=A^{2}(P) \quad B^{2}(P)$. The function $B$ is of the order of $\left(P^{2}\right)^{1+"} w$ ith "positive, and therefore does not contribute when acted upon with the ${ }^{(2)}\left(P^{2}\right)$ distribution. Indeed, for exactly the sam e reason, only the $f A^{N} g-p a r t$ of $R e{\underset{R}{N}}_{N}^{(P)}$ w ill ever contribute at generalN, because of the ${ }^{(N)}\left(\mathbb{P}^{2}\right)$ distribution. In the present case, $N=2$, one gets

the sum of the two term s (3.9) and (3.10) is readily seen to display the expected singularity com pensation. Indeed, inspection of the rst values of $N(1 \quad N \quad 5)$, show sthat onem ay drop the term $s 2$ "; 4 "appearing in (2.3) and (2.5) w thout spoiling at all the singularity cancellation mechanism. In what follow s , we w ill take advantage of that sim pli cation in order to avoid overcharging $w$ ith details.

At $\mathrm{N}=3$, one has

Them ass singularity com pensation is now $m$ ade obvious as the rst term in the last parenthesis of (3.16), the +1 , com pensates for the realterm (3.13), whereas the second term and (3.14) canceleach other, just leaving regular contributions. N ote that with respect to the previous case, $\mathrm{N}=2$, expanding the trigonom etric functions has becom e $m$ andatory in order to $m$ anifest the singularity com pensation.
A swe have been able to check that a sim ilar com pensation of all leading and subleading $m$ ass singularities, occur at $\mathrm{N}=4$ and $\mathrm{N}=5$ as well, these results strongly suggest that, for all N , such an overall cancellation ofm ass singularities is extrem ely likely to take place, and not just at N 2, as was incorrectly stated in [8]. H ow ever, the control of the ensuing nite parts and their subsequent sum $m$ ation over $N$, rem ains som ew hat puzzling. This is why we will carry out the sum $m$ ation over N a di erent way.

First, we take the com plicated expressions (2.3) and (2.5) to the much sim pler form s

O fcourse, w ith (3.17) as a crude approxim ation of (2.3) and (2.5), only the leading $m$ ass singularities cancel out for all $N$, while leaving a nite series of subleading $m$ ass singularities. The latter, though, can be resum $m$ ed into regular functions. Then, bringing the expressions (3.17) to com pletion, that is to the form $s$ (2.3)-(2.5), the full result can be derived rather easily out of those regular functions. This procedure will further open tw o interesting possibilities, dealt w ith in sections 5 and 6. A lso, it applies straightforw ardly to the (ferm ionic) cases where HTL self energies are proportional to the second kind Legendre function $Q_{0}\left(p_{0} ; p\right)$ rather than $Q_{1}$.

A lso, it displays the m ass (or collinear) singularity character of the encountered poles. H ad we choosen $p_{0}$ and jpj as another, m ore custom ary choige of two independent variables, none of these tw o properties were obtained.

H ow ever a m ilder singularity (like (3.14)) rem ains non cancelled. The phenom enon of course starts out at $\mathrm{N}=3 \mathrm{w}$ ith the $\mathrm{fB}^{3} \mathrm{~g}$ term, and is, thereof, general. O ur previous treatm ent of selfenergy insertions is based on (3.17), that is on the leading, singularm ost term $s$ in an " expansion of the functions A and B. H ow ever, nothing guarantees that the less singular parts could be safely ignored. This possibility even appears som ew hat paradoxical. Singular pieces, generated by this order " ${ }^{1}$-part, usually cancel out in the calculation of transition rates, as we have just seen, and are accordingly not expected to be the $m$ ost relevant ones. Indeed, we are carrying out the calculation a di erent way, and we must now show how our previous results get modi ed when proper account is taken of the subleading "-expansion term s. For the sake of simplicity this is ilhustrated by considering zero self energy insertion along the $P^{0}$ line.

## 5-T he $m$ ixing of singularities

A well known feature of realtim e form alism s is the fact that $T=0$ and $T \in 0$ parts com e out additive. This property of rst non trivialorder ofordinary perturbation theory does not persist at higher orders w hich $m$ ix up zero and non-zero tem perature contributions. W hen the latter are singular, the situation is the one of "singularity m ixing", an adm ittedly com plicated one [9,12], which, at least at the author know ledge, has
not been $m$ uch investigated untilnow. In the present situation though, the singularity $m$ ixing problem tums out to be unexpectedly sim pli ed and this is worth em phasizing.
At $T=0$, the one loop order self energy is well know $n[9,13]$

In the function $a\left(P^{2} ;{ }^{2}\right)$, the rst term, given by the +1 in the parenthesis, is the ultraviolet counter-term of the $T=0$ renorm alization procedure. $W$ hen di erentiated $w$ ith respect to $P^{2}$, though, the sam e factor $1="$ is to be understood as the dim ensional regularization of an infrared (oollinear) singularity, as is $m$ ade obvious by sim ple pow er counting argum ents.

N ow, a $\mathrm{T} \in \mathrm{O}$ realtime form alism can be used to calculate pure $\mathrm{T}=0$ quantities, just by letting T tend to zero. This long known property of real tim e form alism s [14] has been explicitly veri ed in [9] at second non trivial order of perturbation theory. Thus, in principle, the global one loop self energy correction can be inserted in our previous equations, so as to get by the sam e token, both zero and non zero tem perature corrections. In practice how ever, the di erent analytical properties involved at $T=0$ and $T \in 0$, have long $m$ ade this property short of any practical purpose.
H ere instead, wew illtake advantage of the results ofprevious sections 3 and 4, dealing rst w th the fiunctions $A$ and $B$ of section 3. Then, rem arking that $D_{u}$, the in nitesim aldilatation operator in the variable $u{ }_{n=0}$ (p), ignores both $Z(" ; p)="$ and $T=0$ variables, the results are $m$ ade com plete by acting upon them $w$ ith $D u$,

In these topologies how ever, these term s do not regularise any singular behaviour and their " = 0 lim it can be taken $w$ th the alluded result (likew ise, for the sam e reason, writing (5.7) and (5.8), the $T^{2 "}$ and $(\mathrm{T}=\mathrm{p})^{2 "}$ term s of (5.3) and (5.4) have been ignored).

A s a consequence, the whole series we have just analysed in the pure them alcase, goes through, unchanged, in the global treatm ent of both $T=0$ and $T \& 0$ parts, but for the tw o replacem ents

Expressions (5.11) and (5.12) are obviously rem in iscent of the elem entary rst order additivity of the $\mathrm{T}=0$ and $T \in 0$ parts, while displaying its full one loop leading order (HTL) realization. O fcourse, we do not expect that this simple pattem should extend beyond the leading HTL approxim ation. C learly, the HTL peculiarity is at play (see rem ark (i) below ). By construction, the them al contributions of (5.11) and (5.12) are valid for soft intemalm om enta and are thus enhanced by a factor $1=g^{2} \mathrm{w}$ th respect to the $\mathrm{T}=0$ ones. Som e rem arks are in order.
(i) $-T$ he striking sim ilarity betw een the renorm alized $T=0$ selfenergy and its $T \in 0, H T L$ counter part is worth em phasizing (com pare equations (5.2) w ith (5.4) and (5.5)). It is at the origin of a possible global treatm ent, as we have just sketched. Unfortunately, we have been unable to nd any sim ple interpretation of this am azing fact, except that it is certainly in line $w$ ith [21].
(ii)-Things can be view ed the other way round. O nce it is veri ed that the couples of functions (a;b) and ( $A$; B ) are involved in phase space dom ains over which they develop the sam e singular structures, then, (5.7) and (5.8) obviously indicate that the issues of singularity com pensations $w$ ill be the sam $e$ in either cases. For the topologies considered here, where only $m$ ass singularities show up, the above statem ent is nothing but an altemative form of a $N$ iegaw a's recent result [15].

## 6. Renorm alization constants

In the past tw elve years, e orts have been som etim es devoted to the possibility of de ning renorm alization constants in a therm alcontext [16]. W hen ferm ionic elds are involved, for exam ple, such a notion could be shown to be alm ost unreliable [16], whereas m ore room was left in the case of B ose $E$ instein statistical elds [17]. H ow ever, even in the sim pler scalar case, som e am biguity w as left regarding its de nition.

A ccording to [17], the extemal leg renorm alisation constant should be de ned as

B esides the fam iliar lack of Lorentz invariance inherent to non zero tem peratures, and re ected in the p$m$ om entum dependence, de nition (6.1) di ers signi cantly from (6.2) by the very place where the realpart prescription, Re , should be taken. Furthem ore, it is worth rem arking that, if pertinent, (6.1) should also apply at $T=0$ for unstable particles [17]. In a few particular cases both de nitions agree. For massless elds $w$ thin the dim ensional regularization schem e (see (2.3) and (2.5)), for exam ple, and also in the case of a real valued selfenergy function $\left(P^{2} ; p^{2}\right)$, because of the $+i=p_{0}$ advanced or retarded prescription which com pletes the dressed propagator determ ination. But the one loop selfenergy is not realvalued in general.

Indeed, the identi cation (6.1) is obtained by a form al resum $m$ ation of the term $s$ involving (N) (P ${ }^{2}$ )distributions only, as they appear on the right hand side of (3.3). N ow, our analysis has show $n$ that these contributions can not be disentangled from those involving principal value distributions, folded with im aginary parts of self energy insertions. W hen the latter are non zero, that is, when the self energy is com plex valued, it was recognized in [17] that an expansion in the num ber of self energy insertions was necessary in order to give a well de ned $m$ eaning to the calculations.
The analysis of the previous sections relies on such an expansion and is accordingly able to identify

The integral over $p$ factorizes the total solid angle of the $m$ odel. Then, the integration over pj ranges from $p=q=2$ to $p=1$ because of the $(2 p \quad q)$ distribution, but the sign distribution " $\left(\begin{array}{ll}q & p\end{array}\right)$ splits the integral into two parts. The second part, say, with an integration range from $p=q$ to $p=1$, will be discarded because, then, one is leaving the dom ain of softness of the $P ; P^{0}$ lines, that is, the realm of relevance of the e ective perturbation theory. Even though, it is easy to check that this neglected integral is perfectly regular. $T$ he rst part, w ith an integration range from $p=q=2$ to $p=q$, exhibits light cone singular behaviours at the $p=q=2$ low er bound, through the factors (3.33). In section 3, equation (3 26), we have pointed out the occurence ofa global factorizing expression Z (";p). Together w th the overall factor $1="$, the function $Z$ contributes the global sim ple fiunction $p^{2}=m^{2}$ (as seen from (3 29)), which is recovered also throughout the analysis perform ed insection 4. In this latter section though, the function $Z$ is not itself $\mathrm{im} m$ ediately apparent, thereby obscuring som ehow its interpretation as a renorm alization constant. It is indeed an artefact of the approach followed in section 4. The point is that at any given order ${ }^{\mathrm{n}}$ in the expansion (4.6), the coe cient $\mathrm{b}^{(\mathrm{n})}(1)$ is independent of $N$. O $n$ view of (4.5), we conclude that the sum $m$ ation over $N$ can be carried out, and that the ensuing expression fZ (";p)="g keeps entering the result, for all $n$ and $a l l k$, as an overall $m$ ultiplicative factor.

## 7. C onclusion

On the basis of a scalar $m$ odel of eld theory, renorm alizable and asym ptotically free, the light cone singular behaviour of the corresponding therm ale ective perturbation theory has been investigated for som e given process.

U sing the H T L form of the selfenergy near the light cone where m ass singularities develop, one can conclude that, at any num ber of self energy insertions, a full com pensation of singularities is obtained. This conclusion brings a correction to the erroneous statem ent which appeared in [8], and was due to an insu cient dim ensional expansion of the self energy functions. In this respect, it m ay be recalled that after a rst series of calculations perform ed at rst and second non trivialorders of therm alperturbation theory [3,9,19], it has been observed (and then conjectured) that singularity cancellation took place w ithin each topology separately [20]. W e can rem ark that our analysis supports and enforoes this con jecture.

O nce the detailed balance com pensation of $m$ ass singularities is achieved, the result for the process under consideration, can be obtained by sum $m$ ing over $f N$; $N{ }^{0} g$ the regular contributions which are left, as this sum $m$ ation is $m$ andatory in order to get the full leading order correction $O\left(g^{2} \mathrm{~T}^{2}\right)$ to the B om approxim ation.
$T$ hroughout the present analysis, how ever, the sum $m$ ation has been carried out a som ew hat di erent way. A though the full H T L self energy is recognized a perfectly regular function of $\mathrm{P}^{2}$ in any light cone neighbourhood, we have stressed that it entails a potentially singularm ost part, dealt with in section 3, and w hich tums out to yield the basic result. Rem arkably enough, at the level of approxim ation where we have been working, this basic result en joys tw o interesting properties. First, it is im mediately related to the cases in which the HTL self energies are given by the (second kind) Legendre function $Q_{0}$ (ferm ionic elds) and is therefore relevant to the study of therm alQED and QCD, the infrared problem included [22]. Second, it is sim ply enough related to the case under consideration, where one has to cope with a H T L selfenergy on the order of the Legendre fiunction $Q_{1}$ rather than $Q_{0}$.
Furtherm ore, proceeding that way, a striking analogy can be put forth between the $T=0$ renorm alized self energy and its HTL countenpart. This is certainly a rem arkable and intriguing aspect which, at least in our opinion, can only be read in line w th the ideas developed in [21]. In particular, the issued mass singularity structures (poles and residues), tum out to be identical, and a globaltreatm ent ofboth zero and non zero tem perature corrections is $m$ ade possible, resulting in a sim ple resolution of the otherw ise intricate singularity $m$ ixing problem. Likew ise, a new, unam biguous identi cation of a renorm alization constant in the them al context is obtained, and tums out to be at variance w ith som e previous attem pts.

The function $F(p)$, and a fortiori, its generalization $\longmapsto^{\circ}(p)$, is new and interesting in this context, as it could not be obtained in previous related w orks [12], [18], where the e ective perturbation theory was used right from the onset. Rem arking the sim ilarity of $F$ w th a rst order brehm sstrahlung function, one recovers a physical picture of the HTL's which is closely related to their interpretation in term s of forw ard Thom pson scattering am plitudes [21].

E ventually, we can stress that our guiding strategy has been to express the singular structure of an e ective quantum eld theory at tem perature $T$, in term $s$ of the sam e bare tem perature quantum eld theory. Such a strategy $m$ ay be thought of as arduous. On the other hand, though, the complexity of the e ective perturbation theory, the $m$ ixing of topologies it envolves, renders hazardous the control of such ne tuning $m$ echanism $s$ as singularity com pensations, if not the very m eaning of the ensuing nite results. The sam e approach is extended to the case of gauge eld theories for tim elike and lightlike extemalm om enta [22].
