# M ini-jet T otalC ross-sections and O verlap Functions through B loch-N ordsiedk Sum m ation

A bstract
Predictions for total inelastic cross-sections for photon induced processes are discussed in the context of the QCD-inspired minijet m odel. Large theoretical uncertainties exist, som e of them related to the parton distributions of hadrons in im pact param eter space. A m odel for such distribution is presented, based on soft ghon sum $m$ ation. This $m$ odel incorporates (the salient features of distributions obtained from ) the intrinsic transverse $m$ om entum behaviour of hadrons. U nder the assum ption that the intrinsic behaviour is dom inated by soft ghon em ission stim ulated by the scattering process, the b-spectrum becom es softer and softer as the scattering energy increases. In $m$ inijet $m$ odels for the inclusive cross-sections, th is $w$ ill counter the increase from jet .

The im pact of parton scattering on the rise of inclusive cross-sections with energy was suggested by C line and H alzen [ī1], after such rise was rst observed in proton-proton collisions at ISR . M inijet m odels were put forw ard to describe quantitatively the further

w ith the rise controlled only by an energy dependent param eter, nam ely $p_{\text {tn }}$ in, whidh regulated the R utherford scattering divergence in the QCD jet-cross-section. The ladk of unitarity of this $m$ odel was am ended in the eikonalized $m$ ini-jet $m$ odel, where inelastic hadron-hadron cross-sections are w ritten as

$w$ th xed $p_{t n}$ in. In this version, the excessive $Q C D$ rise, controlled by $p_{t n}$ in ( $s$ ) in the nonunitarized $m$ odels, was softened through eikonalization and introduction of the overlap function A (b), which thus becam e a key ingredient of allm odels w ith a QCD com ponent. This function, which describes $m$ atter distribution in im pact param eter space, in $m$ ost applications [.] has been assum ed to be the Fourier transform of the product of hadronic form factors of the colliding particles. In other $m$ odels $[\underline{1} 2 \bar{i}]$, a gaussian shape has been preferred, thus relating $A(b)$ to the intrinsic transverse $m$ om entum distribution of partons in the colliding hadrons. In either case, detailed inform ation on A (b) relies on param eters to be determ ined case by case. H ow ever, while direct $m$ easurem ents of the EM form factors are available for nucleons and pseudoscalar $m$ esons, experim ental inform ation regarding photons or other hadrons such as vector $m$ esons is lacking. The sam e observation applies to the intrinsic $-p_{t}$ interpretation for the spatial distribution of partons in vector $m$ esons or photons. Thus the extension of this $m$ odel to photonic cross-sections unveils one of its $m$ ain draw badks, viz. lack of a fundam ental description of parton b-distributions. To reduce the uncertainties in the Q CD description of the rise of the inelastic cross-section, and allow this $m$ odel to graduate to $Q C D$ respectability, it is $m$ andatory to arrive at a QCD description of the overlap fiunction $A$ (b).

For the case ofphotonic processes, there are further uncertainties related to the hadronic behaviour of photons. The m odel has been adapted to photonic processes by writing the inelastic cross-section as

where $\mathrm{P}_{\mathrm{ab}}^{\text {had }}$ gives the probability that both colliding particles a;b be in a hadronic state ${ }_{10}^{1}{ }_{1}^{-1} 1$ and $n(b ; s)=n_{\text {soft }}(b ; s)+n_{\text {hard }}(b ; s)$. The predictions of the eikonalised $m$ ini-jet $m$ odel [1] $\overline{1}$ i] for photoproduction processes therefore depend on 1) the assum ption of one orm ore eikonals 2) the hard jet cross-section

where $F$ is the Fourier transform of the b-distribution of partons in the colliding particles and 5) last, but not the least, $\mathrm{P}_{\mathrm{ab}}^{\text {had }}$.

To study the param eter dependence of this $m$ odel, one can restrict attention to a single eikonal : m ore eikonal term $s$ although im proving the ts, de facto introduce new sets of param eters and very $m$ uch reduce the predictivity of the $m$ odel. The hard jet cross-sections have been evaluated in LO perturbative QCD using two di erent photonic parton densities D G [1] †īin]. C learly this dependence is strongly correlated w ith the parton densities used. H ere we shall only show the results for eikonalised $m$ inil jet cross-sections using G RV densities. Further, for the purposes of this note, we try to estim ate soft from $\underset{\text { soft }}{p}$ which in tum is determ ined by a $t$ to the photoproduction data. For collisions, we use the $Q$ uark Parton M odel suggestion soft $=\frac{2}{3} \underset{\text { soft }}{p}$.

In the original use of the eikonal model, the overlap function $A_{a b}(b)$ of eq. 'i-1 was obtained using for $F$ the electrom agnetic form factors and thus, for photons, a num ber of authors $[1]$ D om inance (VMD).Asmentioned, another possibility is that the b-space distribution of partons in the photon is the Fourier transform of their intrinsic transverse $m$ om entum distributions. For protons this has been assum ed to correspond to a gaussian shape. For photons, the perturbative part $\left[\begin{array}{l}{[19} \\ \hline-1\end{array}\right]$ of the intrinsic transverse $m$ om entum has been suggested to correspond to the fiunctional expression

Recently this expression was veri ed by the ZEUS [2] $\overline{0}]$ C ollaboration, w th $k_{0}=0: 66$ $0: 22 \mathrm{GeV}$. It is interesting to notioe that for photonic collisions the overlap function will have the same analytic expression for both ansatze for $F$ : the VM D inspired pion form
factor or the intrinsic transverse m om entum ; the only di erence being that the form er corresponds to a xed value ofk $\mathrm{k}_{0}=0: 735 \mathrm{GeV}$ whereas the latter allow s to vary the value of the param eter $\mathrm{k}_{0}$. Thus both possibilities can be easily studied by sim ply changing $\mathrm{k}_{0}$ appropriately. T he overlap function, which for proton-proton collisions would be given by

As for $\mathrm{P}^{\text {had }}$, this is clearly expected to be $\mathrm{O}(\mathrm{em})$ and from VMD one would expect $1=250$. It should be notioed that the eikonalised $m$ inijet cross\{sections do not depend on A and $P^{\text {had }}$ separately, but depend only on the ratio of the two $\left[\frac{2}{2} \overline{1}, 1,12 \overline{2} \overline{2}\right]$; which for our ansatze for $A \quad m$ eans ratio of $k_{0}$ and $P^{\text {had }}$. From phenom enological considerations ts to HERA data, xing $k_{0}=0: 735 \mathrm{GeV}$ one nds a value $\mathrm{P}_{\text {had }} \quad 1=200$, which indicates at these energies a non-VM D com ponent of $20 \%$.

A smentioned, the QCD description requires the de nition of $p_{t m}$ in. From HERA data, one notioes that while lower values of $p_{\mathrm{tm}}$ in, i.e. 1.4 GeV , can be invoked to describe the beginning of the rise, a higher value, i.e. 2.0 or even 2.5 G eV , is better suited to describe the rise at higher energy. In Fig.la we show the to HERA data obtained w th the above param eters, using a purely phenom enological $t$ to determ ine the non-perturbative part of the cross-section.

H aving thus established the range of variability of the quantities involved in the calculation of total photonic cross sections, we now proceed to calculate and com pare w ith existing data the eikonalized $m$ inijet cross-section for collisions. For photon photon collisions, we use the central value $p_{t n}$ in $=2: 0 \mathrm{GeV} . \mathrm{W}$ e also use $\mathrm{P}^{\text {had }}=1=204$, and A (b) from eq. (ī-ī) w th 3 di erent values of $k$ o which correspond to values $w$ thin two standard deviations from the ZEUS [2̄ $\overline{\text { In }}$ collaboration value. O ur predictions for collisions are show $n$ in $F$ ig. (1b). A com parison $w$ ith existing data show $s$ that data points are better tted by a higher larger value of $\mathrm{k}_{0}$, and we choose $\mathrm{k}_{0}=1 \mathrm{GeV}$.

A s stressed, the theoretical description is rather unsatisfactory and we now m ove to present a model for the overlap function which,in principle, should allow for a clearer predictability and to provide an expression for A (b) which could be applied to various cases of interest. W e shall use $B$ loch-N ordsiedk techniques to sum soft ghon transverse m om entum distributions to all orders and com pare our results w th both the intrinsic transverse $m$ om entum approach as well as the form factor approach. In what follow $s$, we shall rst illustrate the B loch N ordsied result and show that it gives a gaussian fall-o

In ref. ( of partons in the colliding hadrons is the Fourier transform of the transverse $m$ om entum distribution resulting from soft gluon radiation em itted by quarks as the hadron breaks up because of the collision. This distribution is obtained by sum $m$ ing soft gluons to allorders,

A $n$ inspection of eq. H ow ever, this is not case in the present context, where we are dealing w ith soft gluon em ission in low -pt physics (responsible for large cross-sections). H aving set up our form alism，we shall now exam ine its im plications．T he distribution $A$（b）depends upon the hadronic scale $M$ in the function $h(b)$ ．$T$ his scale depends upon the energy of the speci c subprocess and，through this，upon the hadron scattering energy．It plays a crucial role，just as it did for the D rell－Y an process，where the expression of eq．（īī） hasbeen successfiully $1 \overline{3} \overline{4}, 1,1$

Unlike the usual expressions for $n(b ; s)$, eq. ( $\overline{2} \overline{2} \overline{2})$ does not exhibit factorization between the longitudinal and transverse degrees of freedom since the distribution $A_{B_{N}}$ depends upon the quark subenergies. Factorization can be obtained how ever, through an averaging process whereupon one can factorize the b-distribution in eq. For $p_{t m}$ in $=1: 4 \mathrm{GeV}$, as in typical eikonalm ini-jet m odels for protonproton scattering [ $[-1 /]$, one obtains values of $<\mathrm{I}_{\mathrm{n}}$ ax $(\mathrm{s})>$ which range from 0.5 to 5 GeV for ${ }^{\mathrm{P}} \overline{\mathrm{s}}$ between $10^{-1} \mathrm{GeV}$ and 14 TeV respectively. A m ore precise evaluation of the above quantities depends upon the type of parton densities one uses, and will be discussed in a forthoom ing paper.

From the discussion about the large $b$-behaviour of the function $h(b)$, we then expect $A_{B N}(b ; s)$ to fall at large $b \mathrm{~m}$ ore rapidly as the energy increases from $\mathrm{P} \overline{\mathrm{S}}=10 \mathrm{GeV}$ into the $T e V$ region. In $F$ ig. 2, we com pare this behaviour for the function $A(b)$ w th the one obtained through the Fourier transform of the squared em. form factor of the proton, eq. ( ('8-1). . The function A (b) from the $B$ loch $N$ ordsiedk $m$ odel is calculated for $=0: 1 \mathrm{GeV}$
 $\mathrm{P}_{\overline{\mathrm{s}}} \quad 10 \mathrm{GeV} \quad 14 \mathrm{TeV}$.

W e notice that, as the energy increases, $A(b)$ from the form factor $m$ odel rem ains substantially higher at large $b$ than in the $B$ loch $-N$ ordsiedk case. A s a result, for the sam $e$ jet the $B \operatorname{loch}-N$ ordsieck $m$ odel will give $s m$ aller $n(b ; s)$ at large $b$ than the form factor $m$ odel and a softening e ect of the totaleikonalm ini-jet cross-sections can be expected.

In conchusion, we have studied the param eter dependence of the eikonalized $m$ ini-jet $m$ odel for photonic and hadronic total inelastic cross-section and found that a large uncertainty arises through the description of parton distributions in im pact param eter space.

A model, derived from soft ghon sum $m$ ation techniques, is described and com pared w ith expectations from the currently used form factor models for such disatribution. Such com parison indicates a distinctly di erent behaviour in this large b-region suggesting a softening of the rise of the total cross-section in $m$ ini-jet $m$ odels relative to the ones $w$ ith the hadron form-factors.
