Stable Superstring Relics

A bstract

W e investigate the cosm ological constraints on exotic stable matter states which arise in realistic free ferm ionic superstring models. These states appear in the superstring models due to a \W ilson { line" breaking of the unifying non { A belian gauge sym m etry. In the models that we consider the unifying SO (10) gauge sym m etry is broken at the string level to SO (6) SO (4), SU (5) U (1) SU (2) U $(1)^2$. The exotic m atter states are classified according to the patterns of the SO (10) sym metry breaking. In SO (6) SU (5) U (1) type m odels one obtains fractionally charged states with Q_{em} : 1=2. In SU (3) SU (2) U $(1)^2$ type m odels one also obtains states with the regular charges under the Standard M odel gauge group but with \fractional" charges under the U $(1)_{\mathbb{Z}^0}$ sym m etry. These states include down {like color triplets and electroweak doublets, as well as states which are Standard Model singlets. By analyzing the renormalizable and nonrenormalizable terms of the superpotential in a speci c superstring model, we show that these exotic states can be stable. We investigate the cosmological constraints on the masses and relic density of the exotic states. We propose that, while the abundance and the m asses of the fractionally charged states are highly constrained, the Standard M odel { like states, and in particular the Standard M odel singlet, are good dark m atter candidates.

1 Introduction

Superstring theories [1] are believed to provide a consistent fram ework for the uni cation of gravity with the gauge interactions. An important task is to connect superstring theory with the Standard M odel [2, 3]. Several approaches may be pursued to derive the Standard M odel from superstring theory. One possibility is to go through a simple [4] or a sem i(simple [5, 6, 7, 8, 9] unifying gauge group at intermediate energy scale. Another is to derive the Standard M odel directly from superstring theory [10, 11, 12, 13, 14]. Proton lifetime considerations motivate the hypothesis that the Standard M odelmust be obtained directly from superstring theory [15, 16]. A second important question is whether there exist some property of superstring models that will distinguish them from other attempts to understand the origin of the Standard M odel. If such a property exists it may result in an experimental signal that can prove or disprove the validity of superstring unication.

In this paper we explore one such possible signature of superstring unication. We argue that realistic superstring models produce additional heavy stable matter, beyond the spectrum of the Standard Model. The specien atternstates and their properties vary between models. However, the existence of additional stable matter, beyond the observed spectrum of the Standard Model, is generic. One type of such generic states in superstring models are of course the modulields. Indeed, it as been argued that because of the absence of superpotential for the modulields, they will decouple at a very early stage in the evolution of the universe and will overclose the universe [17]. However, in the class of models that we study, it has been suggested that all the moduli (except, of course, the dilaton) are projected out by the GSO projections [18]. Thus, these models the cosmological moduli problem can be resolved. The matter states that we study in this paper arise due to the superstringy breaking of the unifying gauge symmetry. We investigate the possibility that these stringy stable matter states can be the dark matter and can perhaps be detected.

In the attempts to derive the Standard Model from superstring theory one traditionally starts with a larger, unifying, gauge symmetry G. The gauge symmetry is then broken to the Standard Model by means of Wilson lines. In many respects the unifying gauge symmetry G is similar to the gauge group of four dimensional grand unication and the Wilson lines are similar to the Higgs bosons in the adjoint representation. However, there are some notable dierences. The eigenvalues of the Wilson lines are quantized while the eigenvalues of the Higgs in the adjoint representation are continuous. A nother important dierence is that the breaking of the gauge symmetries by Wilson lines results in massless states that do not tinto multiplets of the original unbroken gauge symmetry. We refer to such states generically as exotic \Wilsonian" matter states. This is an important property as it may result in conserved quantum numbers that will indicate the stability of these massless \Wilsonian" states. The simplest example of this phenomenon is the existence of states with fractional electric charge in the massless spectrum of superstring models

[19, 20, 21, 22]. Such states are stable due to electric charge conservation. As there exist strong constraints on their masses and abundance, states with fractional electric charge must be diluted away or extremely massive. Remarkably, however, the same \W ilson line" breaking mechanism, which produces matter with fractional electric charge, is also responsible for the existence of states which carry the \standard" charges under the Standard Model gauge group but which carry fractional charges under a dierent subgroup of the unifying gauge group. For example, if the group G is SO (10) then the \W ilsonian" states carry non {standard charges under the U (1)_Z o symmetry, which is embedded in SO (10) and is orthogonal to U (1)_Y. Such states can therefore be stable if the U (1)_Z o gauge symmetry remains unbroken down to low energies, or if some residual local discrete symmetry is left unbroken after the U (1)_Z o symmetry breaking.

In this paper we propose that the existence of heavy stable $\$ ilsonian" matter may be the $\$ sm oking gun" of string unication. The existence of stable $\$ ilsonian" states at intermediate energy scale have important cosmological implications. In a previous letter [24] we exam ined the possibility that one type of the extra $\$ ilsonian" states constitute the dark matter of the universe. These states consist of heavy down { like quark with the standard down { like charge assignment. Due to its role in the string unication we referred to this type of particle as the uniton. We proposed that because of its $\$ fractional" charge under the U (1) $_{\rm Z}$ o symmetry, the uniton may be stable.

In this paper we extend the analysis of ref. [24]. We discuss in detail the cosmological constraints on the existence of heavy \W ilsonian" states. We provide the details of the analysis of ref. [24] and extend our investigation to other exotic m atter states which appear in the realistic superstring derived models. In the superstring models that we consider the unifying gauge symmetry is SO (10). The SO (10) sym m etry is broken at the string level to SO (6) SO (4), SU (5) SU (3) SU (2) U (1²). We classify the exotic \Wilsonian" matter states according to the pattern of the SO (10) sym m etry breaking. The SO (6) SO (4) and SU (5) U (1) type m odels give rise to fractionally charged states with Q_{em} : 1=2.0 n the other U (13) type models produce in addition states with the hand, the SU (3) SU (2) regular charges under the Standard M odel gauge group but with \fractional" charges under the U (1)z o gauge group. These states include down { like color triplets and electroweak doublets, as well as states which are Standard M odel singlets. We show, by analyzing the renormalizable and nonrenormalizable terms of the superpotential in a speci c superstring m odel, that these exotic states can be stable. We investigate the cosm ological constraints on the m asses and relic density of the exotic states. We propose that, while the abundance and the masses of the fractionally charged states are highly constrained, the Standard M odel { like states, and in particular the Standard M odel singlet, are possible candidates for the dark m atter.

The exotic \W ilsonian" matter states that we study in this paper are divided into three distinct classes:

The rst class consists of down { like color triplets with \fractional" charge under the U $(1)_{Z^0}$ sym m etry. The existence of such a heavy colored state is motivated from the constraints arising from string gauge coupling unication [25]. In a specic superstring model we analyze the interaction terms of this colored triplets with the Standard Model states. In that model we show that if we assume that an hidden SU (3)_H gauge group remains unbroken then all the interaction terms in the superpotential vanish to any order of nonrenormalizable terms. This result arises due to the fractional U $(1)_{\mathbb{Z}^0}$ of the color \W ilsonian" triplets and because in the speci c string model which we analyze in detail the only other Standard Model singlet states which carry fractional U (1) $_{\rm Z}{}_{\rm 0}$ charge are triplets of SU (3) $_{\rm H}$. Thus, we argue that the \W ilsonian" states can arise as stable states. We then proceed to analyze the constraints on the relic density of stable heavy color triplets. The heavy color triplets can annihilate into quarks, squarks, gluons and gluinos. We exam ine the possibility that the heavy color down { like triplets are the dark matter. The heavy stable down { like states form charged and neutralm eson bound states with the up and down quarks, respectively. An important issue in this regard is the mass splitting between the charged and neutralm eson states. We argue that with our present understanding of QCD, and the experimental determination of the light quark masses, there exists a region in the param eter space in which the neutral heavy m eson state is the neutral one.

Next we exam ine the constraints on the relic density of fractionally charged states, with electric charge 1=2. We show that generically these states either have to be super massive or have to be in ated away. We demonstrate in one specie model that all the fractionally charged states have a cubic level mass term. Thus, all the fractionally charged states can decouple from the massless spectrum by some choices of at directions. An alternative is that all the fractionally charged states are conned by some non {A belian gauge group in the hidden sector. A nother novel feature that arises in some string models is the appearance of fractionally charged baryons and fractionally charged leptons. Thus, one can speculate that the these baryons and leptons will continue to scatter in the early universe until they coalesce to form neutral heavy hydrogen { like atom s.

The nalclass of \W ilsonian" states that we consider are Standard M odel singlets with fractional U $(1)_{Z^0}$ charge. These type of states arise in the superstring derived standard { like m odels and interact with the Standard M odel states only via the U $(1)_{Z^0}$ gauge boson and are candidates for weakly interacting dark matter (W IM Ps). We exam ine four possible scenarios: with and without in ation and with the U $(1)_{Z^0}$ gauge boson being heavier or lighter than the \W ilsonian" { singlet states. We propose that this Standard M odel singlet states is the most likely candidate for the dark matter in the superstring models.

Our paper is organized as follows. In section two we review the realistic free ferm ionic superstring models. In section three we describe the exotic \W ilsonian" states and classify them according to the patterns of the SO (10) symmetry break-

ing. In section four we exam ine the cosm ological constraints on the di erent classes of \W ilsonian" matter states which are obtained from the superstring models. In section we we present our conclusions. Our discussion of the mass dierence in the heavy meson system are given in appendix A. The details of the calculation of the annihilation cross sections are give in appendix B.

2 Realistic free ferm ionic models

In the free ferm ionic formulation of the heterotic string [2] all the degrees of freedom needed to cancel the conform alanom aly are represented in terms of internal free ferm ions propagating on the string world (sheet. In four dim ensions, this requires 20 left{m oving and 44 right{m oving real world{sheet ferm ions. Equivalently, some real ferm ions may be paired to form complex ferm ions. Under parallel transport around a noncontractible loop, the ferm ionic states pick up a phase. Speci cation of the phases for all world (sheet ferm ions around all noncontractible loops contributes to the spin structure of the model. Such spin structures are usually given in the form of boundary condition \vectors", with each element of the vector specifying the phase of a corresponding world (sheet ferm ion. The possible spin structures are constrained by string consistency requirem ents (e.g., modular invariance). A model is constructed by choosing a set of boundary condition basis vectors, which satis es the modular invariance constraints. The basis vectors, b, span a nite additive group = IN 1. The physical massless states in the Hilbert space of a where $n_k = 0$; given sector 2 , are obtained by acting on the vacuum with bosonic and ferm ionic operators and by applying the generalized G SO projections. The U (1) charges, Q (f), with respect to the unbroken C artan generators of the four dimensional gauge group, which are in one (to (one correspondence with the U (1) currents f f for each complex ferm ion f, are given by:

where (f) is the boundary condition of the world sheet ferm ion f in the sector , and F (f) is a ferm ion number operator counting each mode of f once (and if f is complex, f m inus once). For periodic ferm ions, (f) = 1, the vacuum is a spinor in order to represent the C li ord algebra of the corresponding zero modes. For each periodic complex ferm ion f there are two degenerate vacua j+ i; j i, annihilated by the zero modes f_0 and f_0 and with ferm ion numbers F (f) = 0; 1, respectively.

The realistic models in the free ferm ionic formulation are generated by a basis of boundary condition vectors for all world (sheet ferm ions [6, 11, 7, 12, 23, 13, 9, 14]. The basis is constructed in two stages. The rst stage consists of the NAHE set [6, 13], which is a set of ve boundary condition basis vectors, f1;S;b₁;b₂;b₃g. The gauge group after the NAHE set is SO (10) SO $(6)^3$ E₈ with N = 1 space{time supersymmetry. The vector S is the supersymmetry generator and the superpartners of the states from a given sector are obtained from the sector S + . The space{time}

vector bosons that generate the gauge group arise from the Neveu{Schwarz sector and from the sector = $1 + b_1 + b_2 + b_3$. The Neveu{Schwarz sector produces the generators of SO (10) SO (6)³ SO (16). The sector = $1 + b_1 + b_2 + b_3$ produces the spinorial 128 of SO (16) and completes the hidden gauge group to E₈. The vectors b_1 , b_2 and b_3 correspond to the three twisted sectors in the corresponding orbifold formulation and produce 48 spinorial 16 of SO (10), sixteen from each sector b_1 , b_2 and b_3 .

The NAHE set divides the 44 right{m oving and 20 left{m oving real internal ferm ions in the following way: 1 ; 1 if 1 complex and produce the observable SO (10) sym metry; 1 ; 1 if 1 complex and produce the hidden E $_{8}$ gauge group; 1 f 1 ; 1 ; 1 give rise to the three horizontal SO (6) sym metries. The second stage of the basis construction consists of adding three additional basis vectors to the NAHE set. The allowed boundary conditions in the additional basis vectors are constrained by the string consistency constraints, i.e. modular invariance and world (sheet supersymmetry. These three additional basis vectors correspond to \W ilson lines" in the orbifold formulation. The additional basis vectors distinguish between dierent models and determine their low energy properties. Three additional vectors are needed to reduce the number of generations to three, one from each sector b_1 , b_2 and b_3 . At the same time the additional boundary condition basis vectors break the gauge symmetries of the NAHE set. The SO (10) symmetry is broken to one of its subgroups SU (5) U (1), SO (6) SO (4) or SU (3) SU (2) U (1), U (1) $_{13}$ U (1) $_{13}$ This is achieved by the assignment of boundary conditions to the set 17 :

To break the SO (10) sym metry to SU (3) SU (2) U (1) U (1) both steps, (22) and (23), are used, in two separate basis vectors. In the superstring derived standard (like models the three additional basis vectors, beyond the NAHE set, are denoted by f; g. The two basis vectors and break the SO (10) sym metry to SO (6) SO (4) and the vector breaks the SO (10) sym metry to SU (5) U (1). Since the standard (like superstring derived models contain the SO (6) SO (4) breaking

sectors, as well as the SU (5) U (1) breaking sectors, their m assless spectra adm its also the exotic representations that can appear in these m odels. Therefore, below we will focus mostly on the superstring derived standard (like models and comment on the overlap with the other models.

The observable gauge group after application of the generalized G SO projections is SU (3)_C U (1)_E SU (2)_E U (1)_E U (1)³ U (1)³ U (1)⁵. The electrom agnetic charge is given by

The horizontal SO (6)³ sym m etries are broken to factors of U (1)s. The rst three horizontal U (1) sym m etries arise from the world {sheet complex ferm ions, j , (j=1;2;3). The additional U (1)ⁿ sym m etries arise from complexifying two right {moving real ferm ions from the set fy;! g^{1} ; .'For each right {moving gauged U (1) sym m etry there is a corresponding left {moving global U (1) sym m etry. A Itematively, a left {moving real ferm ion can be paired with a right {moving real ferm ion to form an Ising model operator [28]. The hidden gauge group after application of the generalized G SO projections is SU (5)_H SU (3)_L U (1)². The U (1) sym m etries in the hidden sector, U (1)₇ and U (1)₈, correspond to the world {sheet currents 1 1 8 8 and 2 1

The massless spectrum of the standard { like models contains three chiral generations from the sectors b_1 , b_2 and b_3 with charges under the horizontal symmetries. Three generations from the sectors b_1 , b_2 and b_3 are common to all the free fermionic standard { like models. For example in the model of Ref. [27] we have,

and for the doublets we have written the electric charge of the two components. In the superstring {derived standard {like models the vectors b_1 , b_2 and b_3 are the only vectors in the additive group which give rise to spinorial 16 of SO (10). In this case the three light generations are idential and unambiguously with the states from these three sectors.

The states above complete the representations that we identify with possible representations of the Standard M odel. In addition to the Standard M odel states, sem if realistic superstring m odels may contain additional multiplets, in the 16 and $\overline{16}$ representation of SO (10), in the vectorial 10 representation of SO (10), or the 27 and $\overline{27}$ of E $_6$. Such states can pair up to form super massive states. They can mix with, and decay into, the Standard M odel representation unless some additional symmetry, which forbids their decay, is in posed. For example, in the ipped SU (5) superstring models [6], two of the additional vectors which extend the NAHE set produce an additional 16 and $\overline{16}$ representation of SO (10). These states are used in the ipped SU (5) model to break the SU (5) U (1) symmetry to SU (3) SU (2) U (1).

All the states above t into standard representation of the grand uni ed group which may be, for example, SO (10) or E $_6$. They carry the standard charges under the Standard M odel gauge group or of its GUT extensions. The superstring m odels, however, contain additional states that cannot t into multiplets of the original unifying gauge group. In the next section we enumerate the states that appear in free ferm ionic models. These states have important cosmological implications which we study below.

3 Exotic matter in free ferm ionic models

At the level of the NAHE set the observable gauge sym m etry is SO (10) SO (6) and the number of spinorial 16 representations of SO (10) is 48. The basis vectors of the NAHE set are seen to correspond to Z_2 Z_2 orbifold compactication at an enhanced sym m etry point in the toroidal compactication space [26]. To reduce the number of generations, and to break the SO (10) gauge group to the Standard M odel gauge sym m etry, additional basis vectors are added to the NAHE set. Three additional basis vectors are needed to obtain three generations, one from each of the sectors b_1 , b_2 and b_3 . The additional basis vectors which break the SO (10) gauge sym m etry correspond to W ilson lines in the orbifold formulation.

Adding to the untwisted sector the three twisted sectors b_1 , b_2 and b_3 results in additional massless states from these sectors. In the same way adding the sectors f; g to the NAHE set results in additional massless spectrum from combinations of these basis vectors with those of the NAHE set. However, since these sectors correspond to \W ilson lines" they give rise to massless states that do not tinto representations of the original SO (10) sym metry. As a result the massless spectrum contains states with fractional charges under the unbroken U (1) generators of the original non (A belian gauge group. This is a new feature of superstring models. Due to the absence of adjoint representations, at least in superstring models with level one gauge groups, \W ilson line" breaking is the only available mechanism to break the unifying gauge symmetry perturbatively. Therefore, the appearance of massless states with fractional U (1) charges is a comm on phenom enon in superstring models. In many examples the exotic states appear in vector(like representations and can acquire a heavy m ass. The \W ilsonian" m atter phenom enon is an important feature as it may result in discrete symmetries that may prevent the decay of the exotic m assive states into the Standard M odel states.

The following exotic matter representations can appear in free ferm ionic level one models. Sectors that break the SO (10) symmetry to SO (6) SO (4) can contain the basis vectors or . Sectors that break the SO (10) symmetry to SU (5) U (1) contain the basis vector with a combination of the other basis vectors. We use the following naming scheme for our particles. An exotic quark state will be denoted by W $_{\rm Q}$, W $_{\rm Q}$, while all the non {colored exotic states will be denoted by W $_{\rm Q}$, W $_{\rm Q}$.

From the SO (6) SO (4) type sectors we obtain the following exotic states.

Such states appear for example in the model of ref. [14] from the sectors $1+b_1+2$ (i = 1;2;3). In the model of ref. [11] from the sectors $+b_1+2$ and +2, and in the model of ref. [7] from the sectors b_1+2 , b_1+2 , b_2+3 , b_3+3 , b_4+4 , b_4+3 , b_5+4 .

We also obtain from this type of sectors fractionally charged SU (3)_C SU (2)_L singlets. In the SO (6) SO (4) models these states are doublets of SU (2)_R which have zero U (1)_C charge and the SU (3)_C singlet in the quartets of SU (4) with zero U (1)_L charge. In the standard { like models these states are SU (3)_C SU (2)_L singlets with electric charge Q $_{em}$: = 1=2.

There are several important issues that are important to exam ine with regard to the exotic states. Since some of these states carry fractional charges, it is desirable to make them su ciently heavy or su ciently rare. All the exotic matter states appear in vector{like representations. They can therefore obtain mass terms from renormalizable or higher order terms in the superpotential. We must then study the renormalizable and nonrenormalizable superpotential in the speci cmodels. The cubic level and higher order terms in the superpotential are extracted by applying the rules of ref. [28]. The problem of fractionally charged states was investigated in ref. [22] for the model of ref. [11]. In the notation of ref. [11] the massless states fV_{41} ; V_{42} ; V_{43} ; V_{44} ; V_{47} ; V_{48} ; V_{49} ; V_{50} g are of the form of Eq. By exam ining the fractionally charged states and the trilinear superpotential, it is observed that all the fractionally charged states receive a P lanck scale m ass by giving a VEV to the neutral singlets $_4$; $_4^0$; $_4^0$; $_4^0$; which imposes the additional F atness constraint ($_4$ $_4^0$ + $_4$ $_4^0$) = 0. The other exotic states which are Standard M odel singlets do not receive m ass by this choice of at direction. Therefore, at this level of the superpotential, the fractionally charged states can decouple from the remaining light spectrum. Similarly, the issue of fractionally charged states in the model of ref. [12] was studied in ref. [29] where it was found that all the fractionally charged states receive large m ass from renormalizable or nonrenormalizable terms. Similar results were also found in the case of the G epner models [21].

The second issue that must be exam ined with regard to the exotic \W ilsonian" matter is the interactions with the Standard M odel states. The fractional charges of the exotic states under the unbroken U (1) generators of the SO (10) gauge group, may result in conserved discrete symmetry which forbid their decay to the lighter Standard M odel states. In the following we will investigate this question with regard to particular states that appear in speci c models.

4 Cosmology of \Wilsonian" matter

4.1 Introduction

The $\$ ilsonian" m atter states obtained from the realistic superstring m odels are heavy and stable. Their m ass density has important cosm ological implications, since if they are too abundant they will overclose the universe. This gives a lim it on their present relic density $_{0}$

The relic density of a particle depends on its mass, couplings and on the reheating temperature after in ation. If the relic density is the same as (or at least comparable to) the critical density of the universe, it could account for the existence of dark matter in the universe.

Since the \W ilsonian" matter states are heavy, they are non{relativistic at the time of structure formation and are candidates for cold dark matter. Models consisting of only hot dark matter, such as neutrinos of a few eV mass, are ruled out phenomenologically, since they fail to explain the large{scale structure curve of the universe. Only models which contain cold dark matter, like the mixed (cold + hot) dark matter model [47] and the cold dark matter with extra radiation model [48], survive, except for models with non{standard cosmology scenarios, such as models with non{zero cosmological constant. The heavy \W ilsonian" matter states are candidates for cold dark matter. The possible existence of heavy stable particles in the realistic superstring models provides further motivation to study this class of models.

Since these \W ilsonian" states cannot decay into normal particles, their number density can only change by annihilation processes. In several examples that we study below, the \W ilsonian" states are interacting strongly and therefore remain in them all equilibrium until they become non {relativistic. We will consider one exception of a SU(3) SU(2) U(1) singlet which interacts weakly. A given \W ilsonian" matter state decouples from the thermal bath when its annihilation rate falls below the expansion rate of the universe. The annihilation rate of a particle is given by

If a massive particle is weakly interacting (W IM P) at high temperature, it can decouple from them all equilibrium when it is still relativistic. In this case the upper bound for its mass is very low, since the Y_0 value is too high. This can be deduced from Eq. (4.12). In the case of an in ationary scenario, however, this bound can be raised. We will elaborate over this possibility in some detail in the following sections.

The class of superstring models which we have discussed in the previous sections allow several kinds of stable \W ilsonian" matter states. In the following we will specifically focus our attention on three cosmologically interesting cases.

4.2 A stable heavy down { like quark: the uniton

In this section we investigate the possibility that the dark matter is composed of heavy down{like color triplets of the form of Eq. (3.8). This will be our most detailed quantitative and complex analysis, and the discussion with regard to the other potential dark matter candidates from superstring models will be somewhat more qualitative.

4.2.1 M otivation: string gauge coupling uni cation

It would seem that in an extrapolation of the gauge param eters over freen orders of magnitude, a problem involving a single order of magnitude would have many possible resolutions. Indeed, in string theory there are many possible elects that can a priori account for the discrepancy. For example, there could be large corrections to the gauge couplings due to the in nite tower of heavy string modes [35]. A Itematively, additional matter [36, 27, 9, 25] or gauge structure beyond the MSSM could reconcile the two scales. Yet another possibility is that the weak hypercharge normalization in string theory is not necessarily the one that is traditionally found in GUTs and could take values that would yield meeting of the couplings at the string scale [37].

Surprisingly, however, the discrepancy is not easily resolved. In ref. [25] the string scale gauge coupling unication problem was investigated in detail in the context of the realistic free ferm ionic superstring models. It was shown, in a wide range of realistic free ferm ionic models, that heavy string threshold corrections, non standard hypercharge normalizations, light SUSY thresholds or intermediate gauge structure do not resolve the problem. Instead, the problem may only be resolved due to the existence of additional intermediate matter thresholds, beyond the MSSM spectrum. This additional matter takes the form of additional color triplets and electroweak doublets, in vector like representations. Remarkably, some string models contain in their massless spectrum the additional states with the specie weak hypercharge assignments, needed to achieve string scale unication [27]. Perhaps even more intriguing is the fact that in some models the additional states are those that arise due to the \W ilson line" breaking. Thus, the existence of stable \W ilsonian" states at intermediate energy scales is motivated also from requiring consistency of the string scale gauge coupling unication with the observed low energy gauge parameters.

The mass scale of the additional color triplets is constrained by requiring agreement between the low energy gauge observables and unication of the gauge couplings at the string scale. In ref. [25] the following two constraint equations on the inter-

Next we turn to the model of ref. [14]. The superpotential terms of the exotic color triplets with the Standard Model states were studied in ref. [16]. The potential interaction terms are

For the term s in Eq. (4.28) the type of correlators that have to be checked are of the form $b_ib_jD^n$, where b_i and b_j represent states from the sectors b_i and b_j , D

are the additional color triplets, and ⁿ is a string of Standard M odel singlets. For the rst two pairs of color triplets from the sectors $b_{1,2}+b_3+\cdots+$, the operators b_ib_iD are invariant under the weak hypercharge. However, they break U $(1)_Z\circ because$ $Q_{Z^0}(D) = (1=2)Q_{Z^0}(D_{45})$. Thus, D has one half the $U(1)_{Z^0}$ charge of the triplets from the N eveu {Schwarz and $b_1 + b_2 +$ + sectors. Therefore, all the operators in Eq. (4.28), with D being a triplet from one of the sectors $b_{1,2} + b_3 + +$, break U $(1)_Z \circ$. Thus, the string h in contains a U $(1)_{\mathbb{Z}^0}$ breaking VEV. However, in this model all the available Standard M odel singlets with nontrivial U $(1)_{Z^0}$ charge transform as 3 and 3 of the Hidden SU (3) gauge group [27]. The U (1)₂₀ charges of the hidden SU (3) triplets are 5=4. The U (1) charges of the color triplets from the exotic \W ilson line" sectors are 1=4 (see table 1). The last pair of color triplets has \fractional weak hypercharge $Q_Y = 1=12$. Consequently, term softhe form of Eq. (428), with D being a triplet from one of the exotic \W ilson line" sectors, cannot be form ed in this model. This result was veri ed by a computer search of the relevant nonrenormalizable terms up to order N = 12.

The term in Eq. (4.29) breaks U $(1)_{Z^0}$. Therefore, the product ⁿ in a potential non {van ishing higher order term must break U (1)_{z0}. The available elds are fH₁;H₂;H₁;H₂g. These elds transform as 3 and 3 of the hidden SU (3)_H gauge group with opposite charges under U $(1)_{Z^0}$ for the states and the bared states. Consequently, to obtain term swhich are invariant under the hidden SU (3) gauge group, som e of the $fV_{1,2,3}$; $V_{1,2,3}g$ elds, which transform as 3 and 3 of SU (3)_H, must get a VEV. Therefore if we impose that the VEVs of the V_i , V_i are suppressed, the terms of the of Eq. (429) are suppressed to all orders of nonrenormalizable terms. We rem ark that there is no phenom enological constraint that requires the VEVs of V_i , V_i to be non {vanishing. In contrast to the model of ref. [12] in which generation mixing is obtained by these VEVs [40], in this model the generation mixing is obtained by the VEVs of the elds T_i , T_i . Finally, the term in Eq. (4.30) is invariant under U (1)_Y and U (1)_Z. However the product D D carries nontrivial charges under U (1)₇ and U $(1)_8$. A lithe Standard M odel singlet elds which are charged under U $(1)_7$ and U (1) $_8$ transform as 5, 5 of SU (5) $_{\rm H}$ or as 3, 3 of SU (3) $_{\rm H}$. Consequently, the product "must contain a baryonic factor under SU (5)_H or SU (3)_H. Such terms were not found up to order N = 12. Im posing that the VEVs of V_i , V_i are suppressed, suppresses the term s of the form of Eq. (4.30), because the U $(1)_{7:8}$ charges of the $_{\rm H}$ cannot be canceled. Thus, with this assumption the term DD $u_{\rm L}^{\rm c}$ is forbidden to all orders of nonrenorm alizable term s. To sum m arize, if we assum e that $SU(3)_H$ remains unbroken at the Planck scale, it is seen that all the interaction term s in Eqs. (428,429,430) vanish, to all orders or nonrenormalizable term s.

4.2.3 Uniton dark matter

In the previous sections we have seen that superstring models in the free fermionic formulation motivate the existence of vector (like heavy stable SU (3)_C triplets, $(3;1)_{1=3}$,

 $(3;1)_{1=6}$. In this notation the second quantum number denotes their SU $(2)_L$ content and the subscript denotes the hypercharge. The uniton [24], i.e. the state $(3;1)_{1=3}$, is a d{type quark and interacts with the color force. In the mass range we are interested in $(10^3 < M < 10^{14} \text{ G eV})$, the interaction rate is greater than the expansion rate of the universe, unless the number density of these particles is signicantly suppressed. In general it is well known that it is hard to envision a scenario in which a particle carrying unbroken gauge charges decouples in a relativistic regime. Thus, the uniton can be decoupled only when it becomes non{relativistic. In the non{relativistic lim it T=M < 1, the annihilation rate of the uniton is given by

A discussion of this result can be found in appendix B where we present a complete calculation of all the main channels of annihilation of this particle. The amplitudes c_f are obtained by taking the non{relativistic limit of the cross sections. The calculation is implemented in the case of N = 1 supersymmetric QCD with heavy quark-antiquark (QQ) initial states and light gluinos (g), squarks (q), quarks (q) and gluons (g) in the nal state (QQ! qq;QQ! qg;QQ! qq;QQ! qg;QQ! qg). We refer to gs. 5-10 for details.

We now turn to discuss the case in which we have in ation. The elect of in ation is in portant if the decoupling temperature is greater than the reheating temperature ($T_{\rm dec} = T_{\rm R}$). If $T_{\rm R} = T_{\rm dec}$ the uniton will be diluted away, although it can be regenerated after reheating by out-of-equilibrium production [44]. Therefore we can approximately set the initial density of the uniton to be zero and obtain the relation

W ithout in ation, we have a strict bound on the mass of the uniton which is around 10^5 GeV. However, in ation can raise the mass bound to any arbitrary order, depending upon the estimated value of the reheating temperature.

In ref. [50] it was pointed out that an exotic stable heavy quark, which decouples at high tem perature, can annihilate after color con nement. At low tem perature heavy quarks will form bound states of nite size a_f with ordinary quarks. Since the tem perature at con nement is quite small compared to the heavy quark mass, the scattering cross section of two of these heavy hadrons will approximately be equal to their geometric cross section 4 $\frac{2}{4}$, with a_f about 1 fm. We cannot estimate the corresponding annihilation cross section at this tem perature. However, it is not

unreasonable to assume that the two cross sections (annihilation and scattering) are proportional to each other:

At this point we need an estimate of . If we assume that the scattering and the annihilation cross sections are of same order, i.e. '1, and if we insert the value T_i 1 GeV, which is the temperature at the conning phase, the upper bound on the uniton mass can be raised up to 10^7 10^6 GeV. However, we do not have any denitive argument which can help us estimate the value of . Therefore this issue remains open.

If we ignore this re-equilibrium process, then the mass of the uniton should be smaller than 10^5 GeV or greater than 0 (10) reheating temperature, which is the result presented in Eqs. (4.37) and (4.41).

On the other hand, the uniton can make a stable neutral bound state and as such can be component of dark matter. This issue is crucially connected to the question of whether the neutral (U_0) or the the charged (U_1) bound state is the lightest between the two possible states of this meson. We refer to appendix A for a discussion of this point. There we use arguments based both on QCD potential models and results from the heavy quark elective theory to conclude that the possibility of having U_0 as the lowest state is not ruled out. The splitting between the two states is likely to be of 1 $2 \, \text{MeV}$, which is of the order of the electromagnetic mass splitting, and allows a conversion of U_1 into U_0 by beta decay.

If U_0 is a component of dark matter then its relic energy density should have the same order of magnitude as the critical energy density $_{\rm c}$. Therefore from Eq. (4.14) we can estimate the mass of the U_0 both in the case of in ation and without. In the rst case we get

We remark that there are three windows (in the parameter space M = $_{\rm p}$, with $_{\rm p}$ denoting the scattering cross section on protons) for strongly interacting dark matter (such as U $_{\rm 0}$) [49] which possibly meet our requirements. The rst window is in the relatively low mass range (10 GeV < M < 10^4 GeV) and in the range 10^{-24} < $_{\rm p}$ < 10^{-20} cm 2 . In other two windows it is required to have 10^5 GeV < M < 10^7 GeV and M > 10^{10} GeV, respectively, assuming a cross section, in both cases, less than 10^{-25} cm 2 . These constraints include bounds from various experiments (such as experiments performed using solid state cosmic-ray detectors and plastic track cosmic-ray detectors) and from cosmological consideration (such as the galactic halo infall rate and the life-time of neutron stars [45]).

4.3 Fractionally charged matter

As we have discussed in the previous sections, among the \W ilsonian" states predicted by the free ferm ionic superstring models in the low energy limit, there are also heavy particles which are SU $(2)_L$ doublets and singlets (and which are SU (3) singlets), $(1;2)_0$, $(1;1)_{1=2}$. These two states are lepton like, are stable and have fractional electric charge 1=2. The behavior of these two states at high tem perature is supposed to be the same as in the uniton case since the three gauge couplings become of the same order.

We have also seen that superstring models contain fractionally charged vector{ like quarks $(3;1)_{1=6}$. We refer to this particle as the sexton. This particle is expected to form bound states with u;d quarks (since it is a color triplet) and can make stable baryons and mesons with fractional electric charge of 1=2 and 3=2. The experimental searches for free quarks in various materials show that the upper bound on the number density of fractionally charged particle should be smaller than 10^{-19} 10^{-26} [51]. This implies that the relic density of fractionally charged matter can be estimated to be

This result almost excludes the possibility of fractionally charged dark matter since from Eq. (4.15), the lower bound of the masses of fractionally charged states should

Since the sexton is a color triplet, we can estimate its relic density Y_0 by the same way as in the uniton case (see (4.36) and (4.39). It is clear that the relic density of the sexton cannot satisfy the constraint given in Eq. (4.48) without in ation if the mass of the sexton is greater than 1 eV. Instead, if the mass is lighter than 10 eV, then the sexton behaves like a light quark (u;d) and is conned in a hadron bound state. However, the densities of fractionally charged hadron bound state at low temperature are severely constrained [51]. Therefore, string models which predict light stable fractionally charged particles cannot survive without in ation, since all these fractionally charged particles should be diluted away. A nother possible scenario is that the states which carry fractional charges also transform under a non (A belian gauge group in the hidden sector in which case the fractionally charged states are conned [6]. In this case the fractionally charged states form bound states which are integrally charged [20]. It should be noted, however, that in this scenario one must insure that the neutron star constraints [45] are not violated.

From Eq. (4.39) we can also derive a bound on the relic density of these particles in an in ationary scenario,

In order to evade the experim ental constraints on the relic densities of fractionally charged bound states, it is mandatory to show that the density of these states is suppressed. Our arguments on this matter are quite dierent from those presented in the earlier literature [50]. Two new elements appear in our analysis: a) the value of the charge of the sexton (1=6), which is dierent from the usual quark charge assignment (1=3; 2=3); and b) the presence of fractionally charged leptons.

At the con nement temperature, the sexton (denoted) can form neutral and charged color singlet bound states (;q ;qq;q) and their corresponding antiparticle (;q ;qq;q). It is not hard to show that the number of fractionally charged bound states which can be generated in hadronic reactions is not small. For instance we can classify all the possible conversion processes for both integer and fractional nal states. Typical examples of these processes are

and their converses. Integer charged nal states can be easily reconverted into fractionally charged states due to the large amount of ordinary particles (qq and qqq) present in the thermal bath. As we can see from (4.52), annihilation channels () are always present, which in turn can reduce the total number of sexton bound states. This number has been estimated in the case of the uniton in the previous sections. As the temperature goes down due to the expansion of the universe, it is possible that the remaining fractional hadrons will form bound states of integer charge with fractionally charged heavy leptons $(1;2)_0$ and $(1;1)_{1=2}$ (in our conventions $Q_{em} := T_3 + Y$), therefore making neutral heavy hydrogen (type bound states (e.g. $B_{1=2} + L_{1=2} ! H_0$). We can estimate the cross section for this process as follows.

At a tem perature of few eV, the fractionally charged bound state B $_{1=2}$ or L $_{1=2}$ can capture an electron and form a bound state of radius a_B (B ohr radius) which is hydrogen (like fractionally charged bound state (B $_{1=2}$ + e). Therefore we can assume that the cross section for two of these fractionally charged bound state to interact and form a neutral bound state is proportional to the scattering cross section of two hydrogen-like atoms

If this neutral bound state H_0 is a dark matter candidate, it should have the maximally allowed value of Y_i , i.e. the critical density is

If we assume, in the most optim istic scenario, that 1, from Eqs. (4.48) and (4.57) we easily deduce that a large $Y_i = Y_f$ ratio is allowed only if the mass M of this bound state is quite small (10 20 GeV). This is clearly unrealistic since our calculation is valid only if these particles are non{relativistic. Therefore we conclude that light fractionally charged particles cannot be dark matter candidates.

From Eq. (4.55) m ore generally, we can deduce the relic density of the fractionally charged particles in the form

Here, we ignore $1=Y_i$ compared with $1=Y_f$, assuming that this scattering process can suppress the relic density. If we insert the values a_B ' 2.7 10^6 GeV 1 and T_i ' 10 eV, it cannot satisfy the constraint (4.48) unless its mass is much smaller than the temperature T_i ' 10 eV. Since a light particle with non{zero charge has not been detected in the laboratory experiments [51], it is hard to imagine that there is a strong suppression on the relic density of the fractionally charged matter at low temperature. These arguments seem to indicate that string models which contain light fractionally charged states always need in ation. Finally, we comment that fractionally charged states with Planck scale mass could perhaps constitute the dark matter, but in this case the tools that we have used for the analysis may not be adequate.

4.4 A singlet of SU (3)_c SU (2)_t U (1)_t

A nother \W ilsonian" state which is obtained in the superstring m odels, and which is a possible candidate for dark matter is a singlet of SU (3)_c SU (2)_L U (1)_L, carrying an additional non {standard U (1)_Z o charge. This type of \W ilsonian" matter state arises due to the breaking of the SO (10) sym metry to SU (3) SU (2) U (12) and appears generically in the superstring derived standard {like models. For example, in the model of refs. [27, 14] such states appear from the sectors $b_{1,2} + b_3 + ...$ In this model these states transform as 3 and 3 of a hidden SU (3)_H gauge group. As in section 4.2.2 their interactions with the Standard Model states vanish to all orders of nonrenormalizable terms if the SU (3)_H is left unbroken.

The U $(1)_{Z^{\,0}}$ sym m etry should be broken som ewhere in between the weak scale and the P lanck scale. In this section we refer to this state as the \W {singlet" (W_S) .

A fiter sym m etry breaking the W {singlet interaction is suppressed by $1=M_{Z^0}^2$ and can be classified as a weakly interacting massive particle (W IM P).




Figure 1: W sW s ! ff decay




Figure 2: W s W s ! ff decay

The W {singlet can annihilate into two light Standard M odel ferm ions and into their superpartners. The latter can decay afterwards into two Z 0 gauge bosons. This decay will be suppressed if the gauge boson m ass is greater than them ass of W {singlet and this singlet, therefore, will be a stable particle.

Let M be the W (singlet mass, and M $_{\rm Z}\,^{_0}$ the mass of the Z $^{\rm 0}$ gauge boson. Let us consider the total cross section for the annihilation of two W (singlet into two normal ferm ions and their superpartners.

The two diagrams in gs. 1 and 2 are similar to those shown in gs. 9 and 10, except for the color factors and for the mass of the s{channel gauge boson, which is now assumed to have a mass M $_{\rm Z}{}_{\rm O}$. We get

In this equation Q_i are the U $(1)_{Z^0}$ charges of the W {singlet and of the Standard M odel particle f. Notice that we have to introduce a 1=2 suppression factor for each scalar partner if there is no m ixing between the left{handed sferm ion and the right{handed sferm ion.}




Figure 3: W_sW_s ! Z^0Z^0 decay




Figure 4: W sW s ! Z⁰Z⁰ decay

Let us comment on the calculation of this cross section, which can be obtained with a slight modi cations of the results of Appendix B. For this purpose we start distinguishing two cases: that of a heavy Z 0 and that of a light Z 0 . In the case of a heavy Z 0 the only relevant diagrams are those of gs. 1 and 2. Notice that we do not allow, in this case, Z 0 's in the nal state. Notice also that the annihilation of W $_{\rm S}$ into regular quarks and leptons (and into their supersymmetric partners) is allowed, since all the quarks carry an extra U $(1)_{\rm Z}$ 0 charge. In the case of a leptophobic Z 0 charge [52, 53] we would include in the nal states only color states.

In the second case, when Z 0 is light, we include also the channel W $_{\rm S}$ W $_{\rm S}$! 2 Z 0 beside those considered before. The cross section for this last channel is shown in q.3 and 4.

The annihilation cross section into two Z^0 is given by

Since the decoupling tem perature of W IM P's depends on both the mass and coupling constant, we cannot use the same estimate as in the uniton case.

Here we consider four di erent cases.

In this case, the W {singlet is a strongly interacting particle when it decouples from the heat bath and therefore the relic density estimate is the same as in the uniton case. The W $_{\rm S}$ is non{relativistic at decoupling and its total annihilation cross section into two Z $^{\rm O}$ s and into two gauginos is given by

A lthough the W $_{\rm S}$'s are strongly interacting particles at decoupling from the thermalbath, they interact weakly in the present universe since the interaction of this particle with the Standard M odel particles goes only through the U $(1)_{\rm Z}{}^{\,_{0}}$ gauge bosons. This interaction, at the present epoch, is suppressed by the heavy Z 0 gauge boson m ass since the symmetry is broken. Therefore the bounds on the three windows for the strongly interacting dark matter which we discussed above (section 42) are not valid in this case. This leads to constraints which are similar to those of the uniton

If the reheating tem perature is greater than M $_{\rm Z}\,^{\rm o}$, the estimated cross section is the same as for the rst case. Using Eq. (4.39) similarly we can estimate the relic density of the W $_{\rm S}$ in an in ationary scenario and obtain a bound on its mass

However, if the reheating temperature is less than M $_{\rm Z}\,^{\circ}$, the regeneration of W $_{\rm S}$ goes through a weak U (1) $_{\rm Z}\,^{\circ}$ process and the bound given above is not valid. This scenario will be discussed in the fourth case below.

3) W (singlet mass is less than M $_{\rm Z}\,^{\circ}$ and no in ation.

In this case the W $_{\rm S}$ is a W IM P. Therefore we will assume that decoupling will occur when it is still relativistic. Their number density in the com oving volume is then estimated to be

In Eq. (4.67) we assumed that the particle content is that of the M SSM and that the decoupling tem perature is larger than 1 TeV. The W $_{\rm s}$ with a few keV can be a candidate of warm dark matter.

4) W {singlet mass less than M $_{\rm Z}\,^{\circ}$ with in ation.

A heavy mass W IM P can be a dark matter candidate only in the presence of in ation. In fact, in ation will dilute away all the existing W (singlets which will then be regenerated after reheating. In this limit, i.e. M < M $_{\rm Z}\,^{\rm o}$ and $T_{\rm R}$ < M $_{\rm Z}\,^{\rm o}$, we approximate the Z 0 {m ediated interaction by a four{point Ferm i interaction. In this temperature regime, a W $_{\rm S}$ W $_{\rm S}$ pair cannot annihilate into two Z 0 s because it is too massive. We also observe that after supersymmetry breaking the mass of the superpartners of the Z 0 s is of the same order (modulo soft breaking corrections) of the Z 0 m ass. Therefore the decay channel of two W $_{\rm S}$'s into two Z 0 gauginos is forbidden as well.

Since there are three unknown parameters (M ; M $_{\rm Z}$ $^{\rm o}$; $T_{\rm R}$) in Eq. (4.74) we cannot infer a de nite value for the m ass of the W $_{\rm S}$ and Z $^{\rm o}$, but we nevertheless deduce that Z $^{\rm o}$ should be very heavy.

There is still another possibility to be considered. The W {singlet can be a triplet of a hidden gauge group. If this gauge group is not broken, then the W {singlets can annihilate into two hidden gauge bosons. This will lead to the same result as for the triplet case (the uniton) and we can obtain similar mass bounds.

5 Conclusion and discussion

In this paper we studied the cosm ological constraints on the exotic m atter states that appear in the massless spectrum of realistic free ferm ionic superstring models. The free ferm ionic superstring models are among the most realistic string models constructed to date, and reproduce many of the observed properties of the Standard Model. Among those, the replication of three and only three families and the qualitative spectrum of ferm ion masses [23, 40]. The realistic nature of the free ferm ionic models is perhaps not accidental but may reject deeper properties of string compactication, which are at present unknown. Indeed, the free ferm ionic models are constructed at a highly symmetric point in the moduli space and the appearance of three generations is deeply rooted in the underlying \mathbb{Z}_2 orbifold structure [26].

In the derivation of the Standard M odel from superstring theory we start with some larger symmetry which is subsequently broken to the Standard M odel. Absence of adjoint representations in the massless spectrum of level one K ac{M oody algebras restricts the possible gauge groups in the elective low energy eld theory. Furthermore, proton lifetime constraints motivate the hypothesis that the Standard M odel must be derived directly from string theory, without an intermediate non{Abelian gauge symmetry. Within the free fermionic construction the breaking is achieved by constructing boundary condition basis vectors which are equivalent to Wilson lines in the geometrical formulation. The use of Wilson lines to break the non{Abelian gauge symmetries is quite generic in superstring theory.

The breaking of the non $\{A \text{ belian gauge sym m etries by } W \text{ ilson lines has an im portant feature: it produces m atter representations that do not tinto multiplets of the$

original unbroken gauge sym m etry. This is an important feature as it may result in local discrete sym m etries that forbid the decay of the \W ilsonian" matter states into the lighter Standard M odel particles. Superstring models thus provide an intrinsic mechanism that produces heavy stable states.

The \W ilsonian" m atter states are classified by the patterns of symmetry breaking, induced by the \W ilson" lines. In the free fermionic models the underlying SO (10) gauge symmetry is broken to SO (6) SO (4), SU (5) U (1) or SU (3) SU (2) U (1)^2. All three cases give rise to fractionally charged states with Q_{em} : These states may all be connect, they may all be superheavy, or they may diluted by in ation. Nevertheless, it may be worthwhile to search for such states in experimental searches for rare matter.

Of further interests are the exotic states which appear speci cally when the symmetry is broken directly to the Standard M odel. The \W ilsonian" sectors then contain also states which carry the Standard M odel charges, but with fractional charge under the U $(1)_{Z^0}$ symmetry. We have shown, in a specien model, that these states can, in fact, be stable. This is an exciting observation, for then the stable \W ilsonian" matter states can be natural dark matter candidates. Furthermore, their stability arises due to a well motivated local discrete symmetry [39].

The superstring derived standard{like models give rise to \W ilsonian" color triplets, electroweak doublets with the standard charge assignment, and to Standard M odel singlets. Of those the Standard M odel singlets are the most suited to be the dark matter.

The appearance of a good dark matter candidate in the superstring derived standard like models provides further motivation to focus on the phenomenology of this class of models. A knough our analysis and results are limited to the models in the free fermionic formulation, the mechanism which gives rise to the \W ilsonian" matter states is generic in superstring models. Thus, exotic \W ilsonian" matter states may be the generic, long {sought, signature of string unication. It is of further interest to study other phenomenological properties of these states. Such questions are currently under investigation and will be reported in future publications.

Appendix A. The Mass splitting

In this appendix we comment on the mass splitting relation between the two heavy{light mesons U_0 and U_1 . The goal of our discussion here is to show in a sem i-quantitative way that the mass splitting between these two heavy-light mesons is compatible with zero and even with a U_0 lighter than U_1 .

W hile transition and elastic form factors are calculable in the heavy quark e ective theory, the calculation of the static properties of hadrons, such as the electrom agnetic m ass splitting of m esons containing heavy { light quarks, relies on drastic approximations with a built { in model dependence.

However, a simple estimate of the mass splitting between the two states U_0 (Dd) and U $_1$ (D u) can be obtained in the context of potential models within a non { relativistic approximation. Although this may not look appropriate, it has been shown that, even in the context of light mesons, the non (relativistic approximation to the analysis of the spectra of these systems (which are relativistic) has been quite successful when a Coulomb + linear + constant potential has been used to model the interaction. On the other hand, relativistic approaches based on bag models [54] have also produced satisfactory results. In ref. [55] it has been argued that there is an interesting duality relation between the bag model solutions (with a quadratic potential) and those produced by non (relativistic potential models. This observation seems to clarify, to some extent, that the non{relativistic approach is in part consistent even for systems which are intrinsically relativistic [59]. With these motivations in m ind, let us set analyze the electromagnetic (plus mass di erence of the two constituent quarks) contributions to the mass splitting. The interaction may be taken to be Coulomb (at short distances) + linear (the con ning tail). We may assume that, in a meson, when one of the two quarks gets very heavy, the bound state is hydrogen { like. If we neglect the e ect of the strong interactions (which is a questionable assumption since $_{\rm s}$ is not small at distances of 1 fm) the potential of the Breit (Ferm i Ham iltonian corresponding to the electrom agnetic interaction, for states of with zero angular momentum is given by

If we use the estim ate m $_{\rm d}$ m $_{\rm W}$ M $_{\rm K}$ 0 M $_{\rm K}$ + = 4 M eV for the constituent m ass of the two light quarks [56] and a size of the bound state of 1 fm , then we get that the electrom agnetic corrections are 1 M eV , thereby giving a positive M $_{\rm U_0}$ M $_{\rm U_0}$ 3 M eV . This di erence can be reduced by strong interaction e ects which can provide a M $_{\rm S}$ which can even over{compensate M $_{\rm em}$ [56]. In fact, the di erence between the up and the down quark m asses causes a di erence between the expectation values of the strong interaction B reit{Ferm i H am iltonian. This e ect, therefore, can be responsible of a reduction of the m ass splitting between the two states. We remark here that, in the case of neutral and charged B m esons, all these arguments do apply. The particle data book [51] gives a mass splitting between B $^{\rm O}$ and B which is compatible with zero.

Let us now com m ent on the estim ate of the electrom agnetic interaction to the m ass splitting of heavy {light m esons in the context of the heavy quark e ective theory. At the same time we will also comment on the strong interaction contribution to the splitting which plays a signicant role {but is still not calculable{ in the context of these same e ective theories. Unfortunately, the evaluation of the binding energy of the light degrees of freedom from the heavy quark theory su ers from a large uncertainty. The discussion which follows has been included to make this point more explicit.

In the heavy quark lim it, the interaction between the quark spin and the chrom omagnetic eld vanishes, being inversely proportional to the heavy quark mass m $_{\mathbb{Q}}$. Beside the spin symmetry, a new symmetry appears in the elective description of the bound state, since the interaction between the heavy and the light degrees of freedom (u; d) is avor blind. We picture the heavy quark then acting as a static color force. There are two basic scales appearing in the elective theory: m $_{\mathbb{Q}}$ and = m $_{\mathbb{Q}}$ (mhadron m $_{\mathbb{Q}}$)=m $_{\mathbb{Q}}$, with the scale of the light degrees of freedom . While m $_{\mathbb{Q}}$ sets the scale for the perturbative expansion (in $_{\mathbb{S}}$ (m $_{\mathbb{Q}}$)) of the theory, the second scale characterizes the nonperturbative contributions of additional form factors in the form of matrix elements of higher dimensional operators. Notice that the QED analogy breaks down exactly due to the presence of this second scale. To leading order in 1=m $_{\mathbb{Q}}$, = m $_{\rm hadron}$ m $_{\mathbb{Q}}$ is avor and spin independent. From QCD sum rules, using the pole mass for m $_{\mathbb{Q}}$ (and neglecting renormalon ambiguities (see [58] and refs. therein) one gets the estimate

(see [58] and refs. therein). The uncertainty in Eq. (A.4) largely over compensates the electrom agnetic contribution to the splitting.

Let us now comment brie y on the electrom agnetic breaking contributions as estimated in the context of the heavy quark electrom in ref. [57]. The calculation of the electrom agnetic splitting has been based, in the past, on the use of dispersion relations for forward Compton scattering [60]. We remark that the study of factorization in exclusive processes [62] [61] and of dispersion relations, in particular for

xed angle C om pton scattering [63], has a long and involved history. In the forward region, where perturbative Q C D breaks down, the treatment of the process su ers from a strong model dependence. Therefore, the use of dispersion relations at very low momentum transfer, as needed in the case of the calculation of mass splittings, is an uncharted territory. The basic strategy of the method in [57] is to relate the order e^2 isospin breaking corrections to the forward C om pton scattering amplitude T and then use the heavy quark elective theory in the large N $_{\rm C}$ limit to write T in terms of heavy meson form factors.

Neglecting $1=m_g^2$ corrections, the authors of ref. [57] give

where $1=m_Q$ m easures the matrix element of the decay of the rst excited heavy meson state into the ground state plus a photon.

The use of large N $_{\rm C}$ arguments and the ansatze used to match the dimensional counting behavior of the heavy quark form factor introduce a model dependence into the theory. The authors of ref. [57] argue that their results are accurate within 30%. Notice that this result is compatible with the naive estimate obtained from the quark model discussion we have presented above. Also, notice that the combination of this result with Eq. (A.4), in particular the large uncertainty in the estimate of tells us that M $_{\rm U_0}$ M $_{\rm U_1}$ is not incompatible with zero, as suggested by potential model calculations.




Figure 5: Momentum and ferm ion number ow




Figure 6: Gluino vertices




Figure 7: QQ ! gg annihilation




Figure 8: QQ ! gg annihilation

Let us now comment on the QQ annihilation into two gluons. The calculation is performed in the Feynman gauge and we have included the ghost contribution diagram (since there are two gluons in the nal state) to remove the unphysical polarizations. We recall that in the case of massive quarks all the interference diagrams give a non {vanishing contribution.

We give expressions for all the cross sections in the relativistic and in the non { relativistic cases. The total cross section is given by

$$= \frac{16 \frac{2}{s}}{27m^2 s^2 A^2}$$
 (7s + 31m²)A + 4(s² + 4m²s + m⁴) log $\frac{s + A}{s A}$: (B 19)

In the non{relativistic lim it we get

$$\dot{y}\dot{y} = \frac{14 + \frac{2}{s}}{27m^2} + 0 \text{ (v}^2)$$
: (B 20)




Figure 9: QQ ! qq annihilation




Figure 10:QQ ! qq annihilation

In the case of the annihilation of a heavy Q Q pair into a light qq pair we get

$$= \frac{8 \frac{2}{s} (s + 2m^2)}{27s s (s 4m^2)};$$
 (B 21)

which in the non{relativistic lim it gives

$$jvj = \frac{2 + \frac{2}{s}}{q_{m}^{2}} + 0 (v^{2})$$
: (B 22)

If we sum over all 6 quark avors of the nal state we get

$$jvj = \frac{4 + \frac{2}{s}}{3m^2} + O(v^2)$$
: (B 23)

The total cross section for squark production from QQ annihilation is given by

$$= \frac{4 \frac{2}{8} (s + 2m^{2})}{27s s (s + 2m^{2})}$$

$$= \frac{4 \frac{2}{s} (s + 2m^{2})}{27sA}$$
(B 24)

In the non{relativistic lim it we get

$$jvj = \frac{\frac{2}{s}}{9m^2} + 0 (v^2)$$
 (B 25)

If we sum over all 6 avors of the quarks in the nal state we get

$$jvj = \frac{2 + \frac{2}{s}}{3m^2} + 0 (v^2)$$
 (B 26)
