Heavy SUSY Higgs Bosons at ete Linear Colliders

A bstract

The production mechanisms and decay modes of the heavy neutral and charged Higgs bosons in the Minimal Supersymmetric Standard Model are investigated at future e+ e colliders in the TeV energy regim e. We generate supersymmetric particle spectra by requiring the M SSM Higgs potential to produce correct radiative electroweak symmetry breaking, and we assume a common scalar m ass m $_{0}$, gaugino m ass m $_{1=2}$ and trilinear coupling A, as well as gauge and Yukawa coupling uni cation at the Grand Uni cation scale. Particular em solution in this scenario where decays of the phasis is put on the low tan Higgs bosons to Standard Model particles compete with decays to supersymm etric charginos/neutralinos as well as sferm ions. In the high tan supersym m etric spectrum is either too heavy or the supersym m etric decay m odes are suppressed, since the Higgs bosons decay almost exclusively into pairs. The main production mechanisms for the heavy Higgs particles are the associated AH production and H + H pair production with cross sections of the order of a few fo.

1. Introduction

Supersym m etric theories [1,2] are generally considered to be the most natural extensions of the Standard Model (SM). This proposition is based on several points. In these theories, fundam ental scalar Higgs bosons [3, 4] with low masses can be retained in the context of high unication scales. Moreover, the prediction [5] of the renormalized electroweak m ixing angle $\sin^2 w = 0.2336$ 0.0017, based on the spectrum of the M in in al Supersym m etric Standard M odel (M SSM) [6], is in striking agreem ent with the electroweak precision data which yield $\sin^2 w = 0.2314(3)$ [7]. An additional attractive feature is provided by the opportunity to generate the electroweak symmetry breaking radiatively [8]. If the top quark mass is in the range between 150 and 200 GeV, the universal squared Higgs mass parameter at the unication scale decreases with decreasing energy and becomes negative at the electroweak scale, thereby breaking the SU (2), gauge symmetry while leaving the U (1) electrom agnetic and SU (3) color gauge symmetries intact [8]. The analysis of the electroweak data prefers a light Higgs mass [7, 9] as predicted in supersymm etric theories; however since the radiative corrections depend only logarithm ically on the Higgs mass [10], the dependence is weak and no m conclusions can yet be drawn.

The more than doubling the spectrum of states in the M SSM gives rise to a rather large proliferation of parameters. This number of parameters is however reduced drastically by embedding the low {energy supersymmetric theory into a grand unied (GUT) framework. This can be achieved in supergravity models [8], in which the elective low {energy supersymmetric theory [including the interactions which break supersymmetry] is described by the following parameters: the common scalarmassmo, the common gaugino mass mass mass mass mass coupling A, the bilinear coupling B, and the Higgs higgsino mass parameter. In addition, two parameters are needed to describe the Higgs sector: one Higgs mass parameter [in general the mass of the pseudoscalar Higgs boson, Mal and the ratio of the vacuum expectation values, tan $v_2 = v_1$, of the two Higgs doublet elds which break the electroweak symmetry.

The number of parameters can be further reduced by introducing additional constraints which are based on physically rather natural assumptions:

- (i) Uni cation of the b and Yukawa couplings at the GUT scale [11] leads to a correlation between the top quark m ass and tan [12, 13, 14]. A dopting the central value of the top m ass as m easured at the Tevatron [15], tan is restricted to two narrow ranges around tan 1:7 and tan 50, with the low tan solution theoretically somewhat favored [14].
- (ii) If the electroweak symmetry is broken radiatively, then the bilinear coupling B and the Higgs{higgsino mass parameter are determined up to the sign of . [The sign of might be determined by future precision measurements of the radiative b decay amplitude.]

(iii) It turns out a posteriori that the physical observables are nearly independent of the GUT scale value of the trilinear coupling $A_{\rm G}$, for ${}^{\star}\!\!/ A_{\rm G}$ j < 500 GeV.

M ass spectra and couplings of all supersymmetric particles and H iggs bosons are determined after these steps by just two mass parameters along with the sign of ; we shall choose to express our results in terms of the pseudoscalar H iggs boson A mass M $_{\rm A}$ and the common GUT gaugino mass m $_{\rm 1=2}$.

In this paper we focus on heavy Higgs particles A, H and H with masses of a few hundred GeV, and therefore close to the decoupling limit [16]. The pattern of Higgs masses is quite regular in this limit. While the upper limit on the mass of the lightest CP (even Higgs boson his a function of tan [17],

M oreover, the properties of the lightest CP (even Higgs boson h become SM (like in this lim it. The production of the heavy Higgs bosons becomes particularly simple in e⁺ e collisions; the heavy Higgs bosons can only be pair(produced,

C lose to this decoupling lim it, the cross section for H H iggs{strahlung e e ! Z H is very small and the cross section for the W W fusion mechanism e e e e e e H is appreciable only for small values of tan , tan 1, and relatively small H m asses, $M_{\rm H}$ < 350 G eV . The cross section for Z Z fusion of the H is suppressed by an order of magnitude compared to W W fusion. The pseudoscalar A particle does not couple to W = Z boson pairs at the tree level.

The decay pattern for heavy H iggs bosons is rather complicated in general. For large tan the SM ferm ion decays prevail. For small tan this is true above the tt threshold of M $_{\rm H\ A}$ $^>$ 350 G eV for the neutral H iggs bosons and above the to threshold of M $_{\rm H\ A}$ $^>$ 180 G eV for the charged H iggs particles. Below these mass values many decay channels compete with each other: decays to SM ferm ions ff [and for H to gauge bosons VV], H iggs cascade decays, chargino/neutralino $_{\rm i\ j}$ decays and decays to supersymmetric sferm ions ff

In this paper, we analyze in detail the decay modes of the heavy Higgs particles and their production at e⁺ e linear colliders. The analysis will focus on heavy particles for which machines in the TeV energy range are needed. The paper is organized in the following way. In the next section we do not the physical set{up of our analysis in the fram ework of the M SSM embedded into a minimal supergravity theory. In section 3, we discuss the production cross sections of the heavy Higgs bosons. In the subsequent sections, we discuss the widths of the various decay channels and the nal Higgs decay products. For completeness, analytical expressions for supersymmetric particle masses and couplings will be collected in the Appendix.

2. The Physical Set{Up

The Higgs sector of the Minimal Supersymmetric Standard Model is described at tree-level by the following potential

The quadratic H iggs term s associated with — and the quartic H iggs term s com ing with the electroweak gauge couplings g and g^0 are invariant under supersym m etric transform ations. M $_{\rm H\,_1}$, M $_{\rm H\,_2}$ and M $_3$ are soft{supersym m etry breaking parameters with M $_3^2$ = B . ij [i; j = 1;2 and $_{12}$ = 1] is the antisym m etric tensor in two dimensions and H $_1$ (H $_1^1$; H $_1^2$) = (H $_1^0$; H $_1$), H $_2$ — (H $_2^1$; H $_2^2$) = (H $_2^+$; H $_2^0$) are the two H iggs-doublet elds. A ffer the sym m etry breaking, three out of the initially eight degrees of freedom will be absorbed to generate the W — and Z m asses, leaving a quintet of scalar H iggs particles: two CP { even H iggs bosons h and H , a CP {odd [pseudoscalar] boson A and two charged H iggs particles H .

where the ellipses stand for the soft mass terms corresponding to the rst and second generation sferm ions.

Besides the three parameters $m_{1=2}$; A_G and m_0 the supersymmetric sector is described at the GUT scale by the bilinear coupling B_G and the Higgs{higgsino mass parameter $_G$. The theoretically attractive assumption that the electroweak symmetry is broken radiatively constrains the latter two parameters. Indeed, radiative electroweak symmetry breaking results in two minimization conditions [see Ref.[19] for details] of the Higgs potential; at the low {energy scale in the tree approximation, they are given by

For given values of the GUT parameters m $_{1=2}$; m $_0$; A $_G$ as well as tan , the rst m inimization equation can be solved for $_{\rm H_1}$ to within a sign]; the second equation can then be solved for B . Since m $_{\rm H_1}^2$ and m $_{\rm H_2}^2$ are related to M $_{\rm A}$ through the RGEs, the solution for and B can be approximately expressed as a function of M $_{\rm A}$ and tan . The power of supergravity m odels with radiative electroweak symmetry breaking becomes apparent when one includes the one-loop contributions to the Higgs potential. It is through these one{loop terms that most of the supersymmetric particle masses are determined; the minimization conditions [which are also solved for to within a sign and B] x the masses in order that the electroweak symmetry is broken correctly, i.e. with the correct value of M $_{\rm Z}$. [U (1) $_{\rm EM}$ and SU (3) remain unbroken of course]. The one{loop contributions and the minimization equations are given in Ref.[19] to which we refer for details.

A heavy top quark is required to break the electroweak symmetry radiatively, since it is the large top Yukawa coupling which will drive one of the Higgs mass parameters squared to a negative value. As emphasized before, the additional condition of unication of the b{ Yukawa couplings gives rise to stringent constraints on tan . The attractive idea of explaining the large top Yukawa coupling as a result of a xed point solution of the RGEs leads to a relationship between M $_{\rm t}$ and the angle $_{\rm t}$, M $_{\rm t}$ $^{\prime}$ (200 GeV) sin for tan $_{\rm t}$ 10, giving a further constraint on the model.

To lim it the parameter space further, one could require that the SUGRA model is not ne{tuned and the SUSY breaking scale should not be too high, a constraint which can be particularly restrictive in the small tan region. However, the degree of ne{tuning which can be considered acceptable is largely a matter of taste, so we disregard this issue in our analysis.

We now detail the calculations of the supersymmetric particle spectrum more precisely. We incorporate boundary conditions at both electroweak and GUT scales, adopting the am bidextrous approach of Ref.[19]. We specify the values of the gauge and Yukawa couplings at the electroweak scale, in particular M $_{
m t}$, tan $\,$ and $\,$ $_{
m s}$. The gauge and Yukawa couplings are then evolved to the GUT scale M $_{\rm G}$ [de ned to be the scale \sim for which $_2$ (~)] using the two{loop RGEs [13]. At M $_{\rm G}$ we specify the soft supersym m etry breaking param eters m $_{1=2}$, m $_{0}$ and A $_{\rm G}$. W e then evolve param eters down to the electroweak scale where we apply the one { loop m in in ization conditions derived from the one { loop e ective Higgs potential and solve for to within a sign and B [we then can integrate the RGEs back to M $_{\rm G}$ and obtain $_{\rm G}$ and B $_{\rm G}$]. By this procedure, the supersymmetric spectrum is completely specied; that is, we generate a unique spectrum corresponding to particular values of $m_{1=2}$, m_0 , A_G , tan and the sign of . It turns out that the spectrum is nearly independent of A_G , for A_G j < 500 G eV. In most of our calculations, we substitute a particular value of M $_{\rm A}$ for m $_{\rm 0}$ in order to introduce a m ass parameter which can be measured directly; in this case the value of m₀ is chosen by iteration] so as to produce the desired value of M $_{\rm A}$.

We discuss the SUSY spectrum and its phenomenological implications for two representative points in the M $_{\rm t}$ {tan plane². We choose M $_{\rm t}^{\rm pole}=175\,{\rm G\,eV}$, consistent with the most recent Tevatron analyses [15] throughout our calculations, and values of tan = 1:75 and 50, which are required (within uncertainties) by b{ unication at M $_{\rm G}$. In particular, we emphasize the low tan solutions; they are theoretically favored from considerations such as b! s [21] and cosmological constraints [22]. The low tan solutions generate much lighter SUSY spectra, more likely to be seen at future e colliders. In both the low and high tan regions we take $_{\rm S}$ (M $_{\rm Z}$) = 0:118 [23] and A $_{\rm G}$ = 0, though the qualitative behavior in each region should not depend greatly on these parameters.

(a) Low tan

As a typical example of the low tan region we consider the point M $_{\rm t}^{\rm pole}=175~{\rm GeV}$ and tan = 1:75 for which $_{\rm t}$ (M $_{\rm G}$) lies in its \ xed-point" region [12, 14]. If M $_{\rm A}$ is xed, the scalar m ass parameter m $_{\rm 0}$ can be calculated as a function of the common gaugino m ass parameter m $_{\rm 1=2}$ so that all H iggs and supersymmetric particle m asses can in principle be parameterized by m $_{\rm 1=2}$. The correlation between m $_{\rm 0}$ and m $_{\rm 1=2}$ is shown in F ig 2 for three values of M $_{\rm A}=300$; 600 and 900 G eV in the low tan region.

Some of the parameter space is already elim inated by experimental bounds on the light H iggs m ass, the chargino/neutralino m asses, the light stop m ass, the slepton m asses and the squark/gluino m asses from LEP1/1.5 and the Tevatron [24]. The lower limits are indicated by the non{solid lines in Fig.2. Low values of m $_{1=2} \leq 60~\text{GeV}$ are excluded by the lower bound on the gaugino m asses. For >0, the bound from the negative search of charginos at LEP1.5 almost rules out completely the scenario with M $_{\rm A} \leq 300~\text{GeV}$. If the h boson is not discovered at LEP2, i.e. if M $_{\rm h} \geq 95~\text{GeV}$, the whole <0~scenario [for m $_{1=2}$; m $_0 < 500~\text{GeV}$] can be excluded, while for >0~only the m $_{1=2} > 200~\text{GeV}$ range [which implies very large values of M $_{\rm A}$] would survive. The requirement that the lightest neutralino is the LSP, and therefore its mass is larger than the lightest $\sim m$ ass, excludes a small edge of the parameter space [dotted line] at small m $_0$ with m $_{1=2} > 200~\text{GeV}$ in the <0~case.

The m asses of the H iggs bosons are shown in Fig.3a as a function of m $_{1=2}$ for tan = 1:75, both signs of and for two representative values of m $_0$ = 100 and 500 GeV. The lightest H iggs boson has a rather small tree{level m ass and M $_h$ comes mainly from radiative corrections; the maximal values [for m $_{1=2}$ 400 GeV] are M $_h^{\rm max}$ 90 GeV for < 0 and 100 for > 0. Because the pseudoscalar mass is approximately given by M $_A^2$ B = $\sin 2$ B [at the tree{level] and since B turns out to be large

in this scenario, the pseudoscalar A is rather heavy especially for large values of m $_0$, and thus is alm ost m ass degenerate with the heavy CP (even and charged Higgs bosons, M $_{\rm A}$ $M_{\rm H}$ ' M $_{\rm H}$. Note that M $_{\rm A}$ is below the tt threshold, M $_{\rm A}$ < 350 GeV, only if m $_0$ and m $_{1=2}$ are both of O (100) GeV .

The chargino/neutralino and sferm ion masses are shown Fig.3b-d as a function of m $_{1=2}$ for the two values M $_{A}$ = 300 and 600 G eV and for both signs of . In the case of charginos and neutralinos, the masses are related through RGEs by the same ratios that describe the gauge couplings at the electroweak scale. The LSP is almost bino{like [w ith a mass m $_{0}$ M $_{1}$] while the next{to{lightest neutralino} and the lightest chargino are wino{like [w ith masses m $_{0}$ m $_{1}$ M $_{2}$ 2m $_{0}$]. The heavier neutralinos and chargino are primarily higgsinos with masses m $_{0}$ m $_{4}$ m $_{2}$ j j. The analytical expressions for the chargino and neutralino masses [and their limiting values for large j j] are given in Appendix A . Note that the masses approximately scale as M $_{A}$ and that the decay of the heavy scalar and pseudoscalar Higgs bosons into pairs of the heaviest charginos and neutralinos is kinematically not allowed.

The left{ and right{handed charged sleptons and sneutrinos are almost mass degenerate, the mass differences not exceeding 0 (10) GeV; the mixing in the sector is rather small for small tan , allowing one to treat all three generations of sleptons on the same footing. In the case of squarks, only the rst two generations are degenerate, with left{ and right{handed squarks having approximately the same mass. The mixing in the stop as well as in the sbottom sector leads to a rather substantial splitting between the two stop or sbottom mass eigenstates. Only for small values of M_A and for < 0 is δ_1 the lightest squark; otherwise ϵ_1 is the lightest squark state. Note that the squark masses increase with m₁₌₂ and that they scale as M_A i.e. as j j. The slepton masses decrease with increasing m₁₌₂: this is due to the fact that when m₁₌₂ increases and M_A is held constant, m₀ decreases [see Fig 2], and the dependence of the slepton masses on m₀ is stronger [for xed m₀, the slepton masses would increase with increasing m₁₌₂]. The analytical expressions for the sferm ion masses are given in Appendix B.

(b) High tan

In this region we take tan = 50 as a representative example, a value consistent with the unication of the t, b and Yukawa couplings. The set of possible solutions in the parameter space [m $_{1=2}$, m $_{0}$] for M $_{A}$ = 300 and 600 G eV is shown in Fig.4. At tan = 50 and M $_{t}^{pole}$ = 175 G eV, we not solutions only for < 0; this is a result of the large one loop contribution to M $_{A}$, the sign of which depends on [25]. The boundary contours given in the gure correspond to tachyonic solutions in the parameter space: m $_{t}^{2}$ < 0, M $_{t}^{2}$ < 0 or M $_{t}^{2}$ < 0 at the tree level. The latter constraint is important for algorithm ic reasons: M $_{t}^{2}$ at the tree level enters into the minimization equations in the form of a logarithm [19]. Also the requirement of the lightest neutralino to be the LSP excludes a

sm alledge of the param eter space at sm all values of m_0 ; this explains why the curves for $M_A = 300$ and 600 GeV are not extended to low m_0 values.

The sparticle spectra for M $_{\rm A}$ = 300 and 600 G eV and two sets of m $_{\rm 1=2}$ and (extrem e) m $_{\rm 0}$ values are shown in Table 1. In all these cases, the particle spectrum is very heavy; hence most of the SUSY decay channels of the H iggs particles are shut for large tan . The only allowed decay channels are H; A! $_{\rm 1}$ $_{\rm 1}$ $_{\rm 1}$ and H! $_{\rm 1}$ $_{\rm 1}$ [for large M $_{\rm A}$ values]. However, the branching ratios of these decay channels are suppressed by large bb and the widths of the H iggs particles for large tan : while the supersymmetric decay widths are of the order O (0:1 G eV), the decays involving b quarks have widths O (10 G eV) and dominate by 2 orders of magnitude.

(c) Additional Constraints

There are additional experim ental constraints on the parameter space for both high and low tan; the most important of these are the b! s, Z! bb, and dark matter [relic LSP abundance] constraints. These constraints are much more restrictive in the high tan case.

Recent studies [21] have indicated that the combination of b! s, dark matter and m_b constraints disfavor the high tan solution for which the t, b and Yukawa

couplings are equal, in particular the m inim al SUSY {SO (10) m odel with universal soft-supersym m etry breaking term s at M $_{\rm G}$. This m odel can, however, be saved if the soft term s are not universal [im plying a higgsino { like lightest neutralino], and there exist theoretical m otivations for non {universal soft term s at M $_{\rm G}$ [26]. The presently favored Z ! bb decay width would favor a very low A m ass for large tan .

For low tan , these additional constraints do not endanger the model, yet they can significantly reduce the available parameter space. In particular the Z ! $b\bar{b}$ constraint favors a light chargino and light stop for small to moderate values of tan [27, 28] so that they could be detected at LEP2 [28]. The dark matter constraint essentially places an upper limit on m₀ and m₁₌₂ [29]. The b! s constraint [30], on the other hand, is plagued with large theoretical uncertainties mainly stemming from the unknown next-to-leading QCD corrections and uncertainties in the measurement of sMz). However, it is consistent with the low tan solution and may in the future be useful in determining the sign of [31].

3. Production Mechanisms

The main production mechanisms of neutral Higgs bosons at e^+e^- colliders are the Higgs strahlung process and pair production,

The cross section for the fusion process, e^+e^- ! $_{e^-}e^H$, is enhanced at high energies since it scales like M $_{\rm W}$ 2 log s=M $_{\rm H}$. This m echanism provides therefore a useful channel for H production in the mass range of a few hundred GeV below the decoupling lim it and sm all values of tan , where cos^2 () is not prohibitively small; the cross section, though, becomes gradually less important for increasing M_H and vanishes in the decoupling lim it. In the high energy regime, the W W $\,!\,$ H fusion cross section is well approximated by the expression

obtained in the e ective longitudinal Wapproximation. Since the NC couplings are small compared to the CC couplings, the cross section for the ZZ fusion process is $16\cos^4 w$, i.e. one order of magnitude smaller than for W W fusion.

For large tan the Higgs couplings to down (type ferm ions dom inate over all other couplings. As a result, the decay pattern is in general very simple. The neutral Higgs bosons will decay into bb and + pairs for which the branching ratios are close to 90% and 10%, respectively. The charged Higgs particles decay into pairs below and into the pairs above the top (bottom threshold.

These decay modes can be signicant only for low values tan [which implies $\sin^2 2$ 1]. However, in this regime the decay widths are inversely proportional to M $_{\rm H}$, and thus cannot compete with the decay widths into charginos/neutralinos and ordinary ferm ions which increase with increasing Higgs mass. Therefore, the decays into rst and second generations are unlikely to be important.

For $\,$ and $\,$ At values of the order of the Higgs boson masses, these decay widths will be competitive with the chargino/neutralino and standard ferm ion decays. Therefore, if kinematically allowed, these decay modes have to be taken into account.

4.4 N um erical results

The decay widths of the H ; A and H H iggs bosons into the sum of charginos and neutralinos, squark or slepton nal states, as well as the standard and the total decay widths are shown in Figs.6a, 7a and 8a as a function of m $_{1=2}$ for two values of the pseudoscalar H iggs boson m ass M $_{\rm A}$ = 300 and 600 G eV , and for positive and negative values; tan is xed to 1:75.

Fig.6a shows the various decay widths for the heavy CP (even Higgs boson. For M $_{\rm A}=300~{\rm GeV}$, the H ! tt channel is still closed and the decay width into standard particles is rather small, being of O (250) M eV . In this case, the decays into the lightest stop squarks which are kinematically allowed for small values of m $_{1=2}$ will be by far the dominant decay

channels. This occurs in most of the m $_{1=2}$ range if > 0, but if < 0 only for m $_{1=2}$ < 50 GeV which is already ruled out by CDF and LEP1.5 data.

The decays into charginos and neutralinos, although one order of magnitude smaller than stop decays when allowed kinematically, are also very important. They exceed the standard decays in most of the m $_{1=2}$ range, except for large values of m $_{1=2}$ and < 0 where no more phase space is available for the Higgs boson to decay into combinations of the heavy and light chargino/neutralino states. For small m $_{1=2}$ values, chargino and neutralino decays can be larger than the standard decays by up to an order of magnitude.

As expected, the decay widths into sleptons are rather small and they never exceed the widths into standard particles, except for large values of $m_{1=2}$. Note that due to the isospin and charge assignments, the coupling of the H boson to sneutrinos is approximately a factor of two larger than the coupling to the charged sleptons. Since all the sleptons of the three generations are approximately mass degenerate [the mixing in the ~ sector is very small for low values of tan], the small decay widths into sleptons are given by the approximate relation: (H! ~~)' 4 (H! \frac{T}{4},\frac{T}{4})' 4 (H! \frac{T}{4},\frac{T}{4}).

For larger values of M $_{\rm H}$, M $_{\rm H}$ > 350 G eV, the decay widths into supersymmetric particles have practically the same size as discussed previously. However, since the H $_{\rm H}$ the channel opens up, the decay width into standard model particles becomes rather large, O (10 G eV), and the supersymmetric decays are no longer dominant. For M $_{\rm H}$ ' 600 G eV, Fig.6a, only the H $_{\rm H}$ eqq decay width can be larger than the decay width to standard particles; this occurs in the lower range of the m $_{\rm 1=2}$ values. The chargino/neutralino decays have a branching ratio of 20%, while the branching ratios of the decays into sleptons are below the 1% level.

Fig.6b and 6c show the individual decay widths of the heavy H boson with a mass M $_{\rm H}$ ′ 600 G eV into charginos, neutralinos, stop quarks and sleptons for the set of param eters introduced previously. For decays into squarks, only the channels H ! t_1t_2 ; t_1t_2 , and in a very small range of $m_{1=2}$ values the channel H ! b_1b_1 , are allowed kinematically [see Fig.3c]. The decay into two dierent stop states is suppressed by the [small] mixing angle, and due to the larger phase space the decay H ! t_1t_1 is always dominating.

For the decays into chargino and neutralinos, the dom inant channels are decays into mixtures of light and heavy neutralinos and charginos, in particular H $\,!\,\,\,_1^+\,\,_2^-$ and H $\,!\,\,\,_1^0\,\,_3^0$ or $\,_2^0\,\,_3^0$. This can be qualitatively explained, up to phase space suppression factors, by recalling the approxim ate values of the relative branching ratios in the large j j lim it given in eqs.(4.18{20}: (H $\,!\,\,\,\,_1^-\,\,_2^-)$ 1, while (H $\,!\,\,\,\,_2^0\,\,_3^0$) 1 and (H $\,!\,\,\,\,_1^0\,\,_3^0$) tari $_{\rm W}$ because $\sin 2$ is close to one. The mixed decays involving $_4^0$ are suppressed since they are proportional to (1 $\,$ sin 2), and all other decay channels are suppressed by powers of M $_{\rm Z}^{\,2}=\,^2$ for large j jvalues.

The decay widths for the pseudoscalar Higgs boson are shown in Fig.7a. There are no

decays into sleptons, since the only decay allowed by CP (invariance, A ! $\gamma_1 \gamma_2$, is strongly suppressed by the very small \sim m ixing angle. For $M_A = 300$ GeV, the decay into the two stop squark eigenstates, A ! $t_1 t_2$, is not allowed kinem atically and the only possible supersymmetric decays are the decays into charginos and neutralinos. The sum of the decay widths into these states can be two orders ofm agnitude larger than the decay width into standard particles.

For values of M $_{\rm A}$ above the tt threshold, the decay w idth into charginos and neutralinos is still of the same order as for low M $_{\rm A}$, but because of the opening of the A $_{\rm I}$ tt m ode, the total decay w idth increases dram atically and the chargino/neutralino decay branching ratio drops to the level of 20%. As in the case of the heavy CP (even H iggs boson H , the relative decay w idths of the pseudoscalar boson into charginos and neutralinos, F ig.7b, are larger for the channels involving m ixtures of light and heavy neutralinos or charginos; the dom inant decay m odes are, roughly, A $_{\rm I}$ $_{\rm I}$ and A $_{\rm I}$ $_{\rm I}$ or $_{\rm I}$ $_{\rm I}$ A gain, this can be qualitatively explained, up to phase space suppression factors, by recalling the approximate formulae of eqs.(4.18(19), since the situation is the same as for H , w ith the two neutralino states $_{\rm I}$ and $_{\rm I}$ being interchanged.

For small values of the common gaugino mass, m $_{1=2}$ < 100 GeV, the decay mode of the pseudoscalar Higgs boson into stop squarks, A ! t_1t_2 , is phase space allowed. In this case, it is competitive with the top {antitop decay mode. As discussed previously, the 1=M $_{\rm A}^2$ suppression [and to a lesser extent the suppression due to the mixing angle] of the A! t_1t_2 decay width compared to (A! tt) will be compensated by the enhancement of the At₁t₂ coupling for large values of and A_t.

Fig.8a shows the decay widths for the charged Higgs boson. Since the dominant decay channel H $^+$! to is already open for M $_{\rm H}$ $^\prime$ 300 G eV [although still slightly suppressed by phase space], the charged Higgs decay width into standard particles is rather large and it increases only by a factor of 4 when increasing the pseudoscalar mass to M $_{\rm A}$ = 600 G eV. The situation for the supersymmetric decays is quite similar for the two masses: the chargino/neutralinos decay modes have branching ratios of the order of a few ten percent, while the branching ratios for the decays into sleptons, when kinematically allowed, do not exceed the level of a few percent, as expected. Only the decay H $^+$! $f_1 g_1$, the only squark decay mode allowed by phase space [see Fig.3c] for relatively low values of m $_{1=2}$, is competitive with the to decay mode.

The decay widths of the charged H iggs into the various combinations of charginos and neutralinos are shown in Fig.8b for M $_{\rm H}$ 600 GeV. The dom inant channels are again decays into mixtures of gauginos and higgsinos, since j j is large. The pattern follows approximately the rules of eq.(422), modulo phase suppression.

As discussed in section 2, since the chargino, neutralino and sferm ion masses scale as M $_{\rm A}$, the situation for even larger values of the pseudoscalar H iggs boson mass, M $_{\rm A}$ 1

TeV, will be qualitatively similar to what has been discussed for M $_{\rm A}$ 600 GeV. The only exception is that there will be slightly more phase space available for the supersymmetric decays to occur.

5. Final Decay Products of the Higgs Bosons

In this section, we will qualitatively describe the nal decay products of the produced H iggs bosons. A ssum ing that M $_{\rm A}$ is large, M $_{\rm A}$ > 500 G eV, the decays into standard particles [and m ore precisely, the tt for the neutral and the tb decays for the charged H iggs bosons] always have substantial branching ratios, even for the value tan =1.75 which will be chosen for the discussion. Therefore, to investigate decays into SUSY particles in the main production processes, e $^{+}$ e $\,!\,$ H A and H $^{+}$ H $\,$, one has to look for nal states where one of the H iggs bosons decays into standard m odes while the other H iggs boson decays into charginos, neutralinos or stop squarks. As discussed previously, the decays into the other squarks are disfavored by phase space, while the branching ratios into sleptons are always small and can be neglected.

Let us st discuss the case where one of the Higgs bosons decays into chargino and neutralino pairs,

The lightest chargino $^{\dagger}_{1}$ and next{to{lightest neutralino $^{0}_{2}$ decay into [possibly virtual] W; Z and the lightest Higgs boson h, assuming that decays into sleptons and squarks are kinematically disfavored. In the limit of large j; the decay widths [in the decoupling limit] are proportional to [37]

In most of the parameter space, the W=Z=h are virtual [in addition to the three{body phase space factors, the decay widths are suppressed by powers of M $_2$ M $_z$ = 2] except near the upper values of m $_{1=2}$. In the case of $_2^0$, the channel $_2^0$! $_1^0$ Z mode is always dominant although suppressed by additional powers of M $_2^2$ = 2 compared to the $_2^0$! h $_1^0$ m ode, since both h and Z are o {shell, and the Z boson width is much larger than the width of the h boson for small values of tan . The radiative decay $_2^0$! $_1^0$ should play a marginal role except for very small values of m $_{1=2}$ where the dierence between the $_2^0$ and Z boson masses becomes too large.

For large values of $m_{1=2}$, the sleptons become rather light compared to the gauginos and the decays of the light chargino and neutralino into leptons+ sleptons are kinematically

possible. In this case, these cascade decays become dominant since the partial widths for large j jare given by

and therefore not suppressed by powers of M $_{\rm Z}$ M $_{\rm Z}$ = 2 , unlike the previous decay m odes [we assum e of course that there is no suppression by phase(space). The sleptons will then decay into the LSP and massless leptons, leading to multi(lepton nal states.

The heavier chargino, in the absence of squark and slepton decay modes, will decay preferentially into the lightest chargino and neutralinos plus gauge or light H iggs bosons. The decay widths, in units of $G_FM_W^2$ $j \neq (8 2)$ may be approximated in the decoupling limit by [37]

The branching ratios for the various nal states are roughly equal. Since $_2^+$ is almost higgsino{like, the decay widths into sleptons and partners of the light quarks, when kinematically allowed, are extremely small since they are suppressed by powers of m $_{\rm f}^2$ =M $_{\rm Z}^2$. Because of the large m $_{\rm t}$ value, only the decays into stop squarks and bottom quarks will be very important. This decay is allowed in most of the parameter space for M $_{\rm A}$ > 600 GeV and, up to suppression by mixing angles, it is enhanced by a power m $_{\rm t}^2$ [37]

The dom inant mode is the charged decay, $^0_{3;4}$! $^+_1$ W, followed by the modes involving the h(Z) boson for 0_4 (0_3). Because $\sin 2$ 1, only one of the h or Z decay channels is important. Here again, because of the higgsino nature of the two heavy neutralinos, the decay widths into sleptons and the scalar partners of the light quarks are negligible; the only important decays are the stop decays, $^0_{3;4}$! tt_1^* , when they are allowed kinematically [i.e. for not too large values of $m_{1=2}$]. The ratio between stop and W=Z=h decay widths, up to suppression by mixing angles, is also given by eq.(5.6), and the stop decays will therefore dom inate.

Only the last decay mode occurs for relatively small values of m $_{1=2}$, since m $_{t_1}$ < m $_{t}$ + m $_{1;2}^0$ in this case. For these m $_{1=2}$ values, the three decay modes of eq.(5.9) will have approximately the same magnitude since the chargino and the neutralinos are gaugino (like and there is no enhancement due to the top mass for the t_1 ! to decays.




Fig. 1: M asses of the CP (even H iggs bosons h; H and of the charged H iggs particles H as a function of M $_{\rm A}$ for two values of tan = 1:75 and 50; the common squark m ass M $_{\rm S}$ at the weak scale is xed to M $_{\rm S}$ = 1 TeV and we take = A $_{\rm t}$ = 0.




Fig. 2: The correlation between m $_0$ and m $_{1=2}$ for tan = 1:75 and three values of M $_A$ = 300;600 and 900 GeV. The non-solid lines show the boundaries which can be excluded by including the experimental bounds from LEP1.5 and Tevatron.




Fig. 3a: The masses of the H iggs bosons as a function of m $_{1=2}$ for tan = 1:75, for the two values m $_0$ = 100 and 500 G eV and both signs of .




Fig. 3b: The masses of the two charginos (dashed lines) and the four neutralinos (solid lines) as a function of m $_{1=2}$ for tan = 1.75, M $_{\rm A} = 300$ and 600 G eV and for both signs of . The chargins/neutralinos are ordered with increasing masses.




Fig. 3c: The masses of the two stop (solid lines), sbottom (dotted lines) and rst/second generation squark (dashed lines) eigenstates as a function of m $_{1=2}$ for tan = 1:75, M $_{\rm A}$ = 300 and 600 G eV and for both signs of .




Fig. 3d: The masses of the charged sleptons (solid and dotted lines) and the sneutrino (dashed lines) of the three generations as a function of m $_{1=2}$ for tan =1.75, M $_{\rm A}=300$ and 600 GeV and for both signs of .




Fig. 4: The correlation between m $_0$ and m $_{1=2}$ for tan ' 50, < 0, and two values of M $_A$ = 300 and 600 GeV . The boundary contours correspond to tachyonic solutions, m $_{\sim}^2$ < 0, M $_A^2$ < 0 and M $_h^2$ < 0 at the tree{level.




Fig. 5a: Cross sections for the pair production processes e^+e^- ! HA and e^+e^- ! H H as a function of e^- s for tan = 1:75 (solid lines) and tan = 50 (dashed lines) and three values of M $_A$ = 300;600 and 900 G eV.




Fig. 5b: Cross sections for the production processes e^+e ! HZ, e^+e ! hA and e^+e ! HZ as a function of \bar{s} for tan = 1:75 and the values M_A = 300 and 600 GeV.




Fig. 6a: Decay widths (in GeV) of the heavy CP (even Higgs boson H into charginos and neutralinos (dotted lines), squarks (dashed lines), sleptons (dash (dotted lines), standard particles (dott(long(dashed lines) and the total decay widths (solid lines) as a function of m $_{1=2}$ for tan = 1.75, M $_{\rm A} = 300$ and 600 GeV and for both signs of .




Fig. 6b: Partial decay widths (in GeV) of the heavy CP (even Higgs boson H into all combinations of chargino and neutralino pairs [ij $_{i\ j}$] as a function of m $_{1=2}$ for tan = 1:75, M $_{A}$ = 600 GeV and for both signs of .




Fig. 6c: Partial decay widths (in GeV) of the heavy CP (even Higgs boson H into stop and sbottom squarks and into slepton pairs as a function of m $_{\rm 1=2}$ for tan $\,$ = 1:75, M $_{\rm A}$ = 600 GeV and for both signs of .




Fig. 7a: Decay widths (in GeV) of the pseudoscalar Higgs boson A into charginos and neutralinos (dotted lines), stop squarks (dashed lines), standard particles (dott{long{ dashed lines) and the total decay widths (solid lines) as a function of m $_{1=2}$ for tan = 1:75, M $_{\rm A} = 300$ and 600 GeV and for both signs of .




Fig. 7b: Partial decay widths (in GeV) of the pseudoscalar Higgs boson A into all combinations of chargino and neutralino pairs [ij $_{\rm i\ j}$] as a function of m $_{\rm l=2}$ for tan = 1:75, M $_{\rm A}$ = 600 GeV and for both signs of .




Fig. 8a: Decay widths (in GeV) of the charged Higgs bosons into charginos and neutralinos (dotted lines), squarks (dashed lines), sleptons (dash{dotted lines}), standard particles (dott{long{dashed lines} and the total decay widths (solid lines) as a function of m $_{1=2}$ for tan = 1:75, M $_{\rm A}$ = 300 and 600 GeV and for both signs of .




Fig. 8b: Partial decay widths (in GeV) of the charged Higgs boson H into all combinations of charginos and neutralinos [ij $^+_{\rm i}~^0_{\rm j}$] as a function of m $_{\rm l=2}$ for tan $\,=\,1.75$, M $_{\rm A}\,=\,600$ GeV and for both signs of .
