IND IRECT SIGNALS OF SUSY IN GAUGE BOSON PAIR PRODUCTION AT LEP AND NLC

ABSTRACT

We compute the dominant one-loop radiative corrections to the cross-section for $e^+\,e^-\,!\,V_1V_2$ (V₁₌₂ = ;Z;W) in the MSSM. We not that the genuine vertex corrections are very small. The oblique corrections are potentially large enough to be tested at LEP-II or NLC. However, the sensitivity is below the one from other high precision electro-weak measurements but can serve as a self-consistency check.

1. Introduction

LEP-I experim ents essentially rule out new physics below m $_{\rm z}$ = $2^{1)}$. However, the high statistics allow even to constrain virtual e ects from particles not kinematically accessible at LEP-I energy. Thus, it is natural to ask whether this is also possible at upcoming ete colliders. The higher center-of-m assenergy, E_{cm} , opens new channels even within the fram ework of the standard model. In addition, the clean environment of an ete collider is ideal to test the triple gauge boson coupling (TGC). In light of the success of the Standard M odel (SM) it is hard to im agine that the TGC will exhibit a deviation from the SU (2) U (1) gauge structure. Nonetheless, it m ight be possible to detect anomalies indicating virtualle ects of new physics. In table 1 we have listed upcoming collider experiments. In ete colliders a pair of gauge bosons can be

produced in three possible chanels as depicted in g.1.Note, there is no s-chanel (no u-chanel) for , Z,ZZ (W $^+$ W) production at tree-level. In table 2 we have listed the cross-section

for gauge boson pair production in an ete collider obtained by integrating the dierential cross-section

where the sym m etry factor $f_S = 1$ (1/2) for W W and Z (and Z Z). We also present the expected precision to which this cross-section can be measured at LEP-II ($E_{cm} = 200 \text{ GeV}$) and NLC (E $_{\rm cm}$ = 500 GeV) assum ing that the statistical errors dom inate. W ith a precision in the percent range these processes are potentially sensitive to radiative corrections (RC). The agreem ent (disagreem ent) of the theoretical and experim ental values provide an important self-consistency check of the SM (hint for new physics). However, before we can appreciate the importance of this process we have to answer the question whether we can actually learn anything new from testing the TGC? One of the most important achievem ents at LEP-II will be

a very precise m easurem ent of m $_{\rm w}$ to $~{\rm m_w}$ = ~50 M eV .This will pose the strongest constraint on new physics via $~{\rm r}^{2)}$ with an expected precision

Here the uncertainty of the top quark mass of presently $m_t = 9 \, \text{GeV}$ is expected to reach $5 \, \text{GeV}$. Similar constraints can be derived from measurements of the forward-backward asymmetry, neutral current processes, and the running $_{\text{em}}$. Thus, any virtualle ects of new physics on $(e^+e^- + V_1V_2)$ has to be compared to the ones on $_{\text{r}}$, etc. In this paper we will focus on the minimal supersymmetric extension of the SM $(M \text{ SSM})^3)$.

2.RC due to Squarks/Sleptons

The calculation of the RC to the gauge boson production in e⁺e collider in the SM is quite elaborate⁴⁾⁵⁾. Thus, in extending this calculation to the M SSM we restrict ourselves to the dominant e ects expected to arise from the squark/slepton sector which are enhanced by

large top Yukawa coupling.

None of these enhancements exist for the selectron-chargino loops. Thus, we will rely throughout this work on the assumption that these contribution can be neglected. (For a more complete treatment see ref. 6).

One consequence of our assumption is that virtual SUSY contributions only enter via the gauge boson self-energy and the TGC. (In this sence, our approach is similar to ref. 7 where the supersymmetric RC to the TGC were calculated). As a result, the amplitude can be written as A (; 1; 2;s;t) = P M ; (1; 2)F; (s;t) with the matrix elements (= 1=2; P = 1=2+ 5) 4)

where $g_{eeZ}^{+\,1=2}=g\sin^2_w=\cos_w$, $g_{eeZ}^{\,1=2}=g_{eeZ}^{+\,1=2}+g=2\cos_w$, $g_{Z\,W\,W}=g\cos_w$. The form factors for e^+e^- ! V_1V_2 ($V_{1=2}=$; Z) are . Note that for squark-loops the factors $^4_{V\,W^+W}$ and all $^1_{V\,V_1\,V_2}$ de ned in g.2 vanish.

3.Num ericalResult

Our sferm ion mass spectrum is characterized by a universal mass parameter m $_0$ (here, we om it the possibility of mass-splitting due to renormalization group evolution), a L=R mixing parameter A_0 and the ratio of Higgs VEVs tan . In g.3 we see that the dierential cross-sections with 's in the nal state diverges for joos j= 1. In this case, we choose the range




Fig. 3.di erential and total cross-sections vs. cos and tan , respectively. In b) results are presented with and without the 3. generation squarks for E $_{\text{cm}}$ = 190 G eV .

of integration as joss j < 0.95. Furtherm ore, we not that the dominant RC come indeed from the third generation squarks due to large mass splitting within SU (2) multiplet. For the superpartners of the light ferm ions this splitting is generated by the SU (2)_L D term , M $_{\rm u_L}^2$ M $_{\rm dr}^2$ = ghD 3i = m $_{\rm w}^2$ cos 2 .

The counter terms in eq. 2 depend on the renormalization scheme, ie. the parameterization of the Born term . Sofar we have used $g^2 = 4$ $_{em} = \sin^2$ $_{w}$ It is easy to understand that the RC vanish in this scheme while those to ete! W + W to e⁺ e ! (see g.4b). However, if we change the renormalized coupling constant to g^2 ! $2m_{\rm H}^2G$ then we have to replace g=g! g=g+ r and 2 r. In this scheme the RC to = ! = are very tiny (g.4b). For $(e^+e ! ZZ)$ and $(e^+e !$ e^+e ! W ^+W Z) the situation is sim ilar. In the SM $\,$ it is convenient to use G $\,$; $\,$ $_{em}$;m $_{z}$ and possibly m $_{w}$ to parameterize the tree-level term because these observables are know to such a high precision. However, in the M SSM the largest uncertainty arise from our ignorance of the SUSY parameters. Thus, it is convenient to param eterize in such a way that RC cancel, even if that means to use observables with larger errors. Eg.: it is easy to see that no sferm ionic RC exist to the relation

where the ellips stands for som e kinem atical factors. Thus, with an error of $0.3\%^{-1}$ in the leptonic width of the Z boson an expected precision of at best 0.4% for $(e^+e^-e^-e^-)$ at NLC this process is not suited to yield new information on sfermions. A similar relation holds between $(e^+e^-e^-)$ ZZ), (Z ! e^+e^-), and (Z ! hadrons). A deviation of the TGC from the SM prediction (assuming ragrees with the SM prediction) will indicate new physics other than the MSSM.

4. Sum m ary

We have investigated virtual elects of sferm ions on the cross-sections of gauge boson pair productions. We not that

the genuine vertex corrections of sferm ions to ZW + W and W + W are very small;




Fig. 4. the sferm ionic RC to the total cross-sections vs.m $_0$ and A $_0$. The born term is parameterized by a) $_{\rm em}$ and b) G .

the genuine vertex corrections of sferm ions to $V_1V_2V_3$ vanish if $V_i = ;Z$;

all oblique corrections can be absorbed by a suitable param etrization of the Born term;

the experimental precision on $(\stackrel{.}{e} e ! V_1V_2)$ is lower than the precision of the corresponding EW observables (Z! hadrons) or (Z! leptons) etc;

sferm ions cannot explain any anomalous TGC that may be observed at LEP-II unless there is also evidence of new physics in other observables (e.g. R);

if a deviation in e.g. r is found then $(e^+e^- V_1V_2)$ provides an additional cross-check;
