Fixing the renormalisation scheme in NNLO perturbative QCD using conformal limit arguments

Abstract

We discuss how the renormalisation scheme ambiguities in QCD can be xed, when two observables are related, by requiring the coe-cients in the perturbative expansion relating the two observables to have their conformal limit values, i.e. to be independent of the —function of the renormalised coupling. We show how the next-to-leading order BLM automatic scale—xing method can be extended to next-to-next-to-leading order to—x both the renormalisation scale and $_2$ in a unique way. As an example we apply the method to the relation between B jorken's sum rule and $_{\rm e+e}$ —and compare with experimental data as well as other scheme—xing methods.

I. IN TRODUCTION

In perturbative QCD, observables are given by expansions in the strong coupling $\,\,_{\rm s}$,

where the coe cients R_i can be calculated from the appropriate Feynm an diagram s. The individual term s in the series depends on the renormalisation scheme one is using but the sum of the entire series is independent of the scheme according to the renormalisation group equation. However, when the series is truncated the result becomes renormalisation scheme dependent. This dependence is formally of higher order than the terms calculated in the series but numerically the dierence between dierent schemes can be large. These dierences give a theoretical uncertainty which in principle makes it impossible to make any absolute predictions since any result can be obtained by a nite renormalisation. By going to higher order in perturbation theory the renormalisation scheme dependence becomes smaller but in principle the problem remains. One can argue that it is only bad scheme choices that give 'crazy' results and that as long as one uses a 'sensible' scheme the result will also be 'sensible'. The question then arises, what is a 'sensible' scheme?

The question of how to choose an appropriate renormalisation scheme in QCD has been discussed many times. Three well-known methods for choosing the renormalisation scheme are the E ective Charge Scheme' by Grunberg [1], the Principle of Minimum Sensitivity' by Stevenson [2] and Automatic Scale Fixing' (BLM) by Brodsky, Lepage and Mackenzie [3]. All these methods are based on some more or less intuitive principle or set of arguments for how a perturbative series should behave.

Of special interest here is the BLM method which $\,$ xes the scale in next-to-leading order (NLO) using conformal limit arguments. In a conformally invariant theory the coupling a= ()= is scale invariant, i.e.

It is therefore natural to de ne the conform all im it of perturbative QCD as the lim it $_{\rm i}$! 0 [3,4]. This means that the coe-cients R $_{\rm i}$ in the perturbative series have their conform all lim it values if they do not contain any explicit dependence on the —function. For example, in NLO the perturbative coe-cients should have no explicit $_{\rm 0}$ -dependence. In the BLM method this is achieved by absorbing all $_{\rm 0}$ -dependent NLO terms ($_{\rm 0} = \frac{11}{2} - \frac{1}{3} \rm N_{\, f}$ where N $_{\rm f}$ = number of active quark—avours) into the running of $_{\rm S}$ by a suitable rede nition of the renormalisation scale. It should be noted that the renormalisation scale obtained by the BLM method can also be interpreted as the mean value of the virtualities in the gluon propagators [3,5,4,6,7].

A useful concept when discussing renormalisation scheme uncertainties is the elective charge [1] of an observable which contains all QCD-corrections. For example, the elective charge \hat{a}_R of R_{e^+e} is defined by,

Each e ective charge has its own -function [1] connected to it,

where $_0$ and $_1$ are renormalisation scheme independent and $^{^\circ}_{i;R}$, i 2 are renormalisation scheme invariants. Thus, for each physical observable A there is a specience $^{^\circ}_{2;R}$ connected to it which is an inherent property of the enertial energy of the perturbative series for an energy edepends on the renormalisation scheme even in the conformally invariant theory but when two energies are related, one gets a relation that is independent of the intermediate scheme that was used.

In this paper we present a new generalisation of the BLM method to next-to-leading order (NNLO) using the conformal limit arguments as starting point which exemples both the renormalisation scale and $_2$ when two physical observables are related. The value for $_2$ that is obtained is an intermediate value between the $^\circ_2$'s of the two exective charges. (A generalisation to the factorisation scheme problem will be considered in a separate paper [8]). This is a variation of an approach by Grunberg and Kataev [9], but whereas they claimed that the prescription for making the coexcients N_f —independent is ambiguous, we will show that once the initial renormalisation scheme is executed by relating two physical observables, the conformal limit arguments exest he scheme in a unique way. We also compare with the single [10] and multi-scale extensions [4,9,11] of the BLM method to NNLO which exest he renormalisation scale when two exective charges A and B are related, $^\circ_A$ = $^\circ_B$ (1+ $^\circ_{1:A=B}$ $^\circ_B$ + :::), using $^\circ_{2:B}$. As an example the conformal limit scheme exing method is applied to the relation between B jorken's sum rule in polarised deep inelastic scattering and R_{e+e} . The result is compared with a recently reported experimental determination of B jorken's sum rule and the general renormalisation scheme dependence.

II. THE CONFORMAL LIM IT SCHEME FIX ING METHOD

Consider an observable in NNLO depending on one energy scale Q such as R_{e^+e} (Q_R) de ned by Eq. (3). The electric charge \hat{R} contains all QCD-corrections,

where the coe cients r_i can be calculated using perturbative QCD. The renormalisation scheme dependence can be parametrised through the renormalisation scale and the coe cients in the -function, i for i 2 [2]. Strictly speaking it is the ratio, i of the renormalisation scale and the QCD scale parameter that is the relevant parameter but in the following we will often make the implicit assumption that i is held i we will often make the implicit assumption that i is held i we will be shown later.

The rst two terms in the renormalisation group equation for the coupling a = s()

are renormalisation scheme independent,

whereas the higher order terms depend on the renormalisation scheme.

Applying self-consistency for the perturbative expansion of the e ective charge with respect to the renormalisation scheme parameters,

where $\hat{c}_{2;R}$ is the coe cient in the renormalisation group equation for the elective charge given by Eq. (4). In passing we also note that the expression for the renormalisation scheme invariant \hat{c}_1 shows explicitly that it is = that is the relevant parameter for parametrising the renormalisation scheme dependence.

From the self-consistency requirements we also get the explicit — and $\,_{\rm j}$ -dependence of the coe cients $\rm r_{i}$,

where we have assumed that the coexients have been calculated in the MS scheme with = Q to x the integration constants. (The is used to indicate terms that are independent of $_0$ and $_1$.) We also assume that r_1 and r_2 only contain $_0$ —and $_1$ -dependent terms from loop—insertions which is why the $_0$ term in r_1 and the $_1$ term in r_2 are the same, i.e they are both given by d. This way we also x the redundancy in how to divide x into x0 and x1 dependent parts.

We are now in the position to apply the conformal limit arguments to the excive charge \hat{a}_R to x the renormalisation scheme parameters and $_2$. First the renormalisation scale is

xed by requiring \mathbf{r} to be $_0$ -independent. From Eq. (11) we see that this can be obtained by choosing the renormalisation scale as

We also note that the renormalisation scale obtained in this way is the same as in the original BLM method.

Next $_2$ is xed by requiring \underline{r} to be $_0-$ and $_1-$ independent, i.e. $r_2=r_2$. Using the renorm alisation scheme invariant $\hat{}_{2;\mathbb{R}}$ we get the following expression for r_2 ,

From this we see that by choosing a renormalisation scheme where 2 is given by,

we get $r_2=r_2$. Note that this value of $_2$ in general is dierent both from the elective charge value, $_{2,\mathbb{R}}$ and from $_{2,\overline{\mathbb{M}}|S}$ which was used in the calculation. However, if $r_i=0$ then $_2=_{2,\mathbb{R}}$ and if $r_i=r_i$ then $_2=_{2,\overline{\mathbb{M}}|S}$.

This is set the renormalisation scheme in NNLO up to the question of initial scheme, which is resolved when two physical observables are related as shown below. This does not introduce any new uncertainties since only relations between observables can be predicted in a renormalised theory and for each pair of observables we get a unique relation. The situation here is not dierent from what happens in the BLM method and its earlier extensions where it is also necessary to initial renormalisation scheme to get a unique result. In [9] it was argued that in QCD, setting $r_i = r_i$ is always possible, but leaves us with an ambiguous prescription'. However, as we have shown above, there are no ambiguities once the initial renormalisation scheme has been in xed and this can be done using a physical observable as shown below.

The perturbative series for the e ective charge & in NNLO thus becomes

where the r_i 's contain no explicit j-term s. In this way we obtain the required feature that all signs of scale breaking, i.e. 60, is con ned into the running of the coupling and the coe cients in the perturbative series have their conformal limit values. Finally a can be obtained by solving the renormalisation group equation (6) with the xed 2.

Before ending this section we note that the method for xing $_2$ can be generalised to arbitrary order, n $_2$. For this we need the renormalisation scheme invariants $_{n,R}$ in the renormalisation group equation for the elective charge Eq. (4). The general form for $_{n,R}$ is given in [1] and can be rewritten as,

In previous steps of applying the conform all im it arguments, the renormalisation scale has been xed so that $r_{i} = r_{i}$ and the $_{i}$'s, (2 $_{i}$ n 1) have been xed to $_{i} = r_{i}$. So by requiring $r_{i} = r_{i}$ to contain no explicit $_{i}$ -terms for i n 1 the value of $_{i}$ is xed to be,

III. COM PARISON W ITH OTHER SCALE FIXING METHODS

In previous multi-scale extensions of the BLM m ethod (denoted MBLM in the following) [4,9,11] one has dierent scales for each sterm, i.e.

where $_1$ is parametrised as $_1 = _0 \exp[a()]$ and $_3$ are arbitrary (they will be xed in higher order approximations but here we simply set them to be the same as $_2$). The MBLM scale xing method is constructed to have $_2$ unchanged and instead and $_2$ are introduced which gives three ($_1 = _0 \exp[a()]$, $_2$ and $_2$) unphysical parameters instead of the minimal two (and $_2$). Requiring that the elective charge does not depend on these parameters, to the present order of perturbation theory, gives the explicit $_2$, $_3$ -

where again the integration constants are $\,$ xed by assum ing that the calculation was made in the $\overline{M~S}\,$ scheme with $\,$ = Q. Comparing with Eqs. (11,12) we see the elects of having diegrent renormalisation scales and also how the $\,$ -dependence enters. In the MBLM scale xing all N_f -dependent terms should be absorbed so that, $r_1=r_1$ and $r_2=r_2$ just as in the conformal limit scheme. Keeping in mind that $_2$ should be unchanged we see that this can be achieved by choosing

so that $_1 = Q \exp f$ d $_0$ [f $_0$ [f $_0$ [f $_0$]a ($_2$)g. From Eqs. (20,21) it is also easy to see that one only needs a single renorm alisation scale if is chosen appropriately. In this single-scale extension [10] of the BLM scale xing method (denoted SBLM in the following) one chooses $_2 = _1 = _0 \exp [a()]$ where $_0 = Q \exp (d)$ and $_0 = _0 (f + (d)^2)$ e + 2r₁d.

IV.FIXING THE INITIAL SCHEME WITH A PHYSICAL OBSERVABLE

Up to now we have assumed that the initial renormalisation scheme (and thereby) is xed. Now we will show how this can be accomplished using a physical observable so that a unique prediction of another physical observable can be made. As an example we will relate R de ned in Eq. (3), to K, B jorken's sum rule for polarized deep-inelastic electroproduction [12].

The e ective charge for R is in NNLO given by (in the MS scheme),

where r_1 and r_2 can be obtained from [13,14]. For B jorken's sum rule, one can also de ne an e ective charge \hat{a}_k (using the same normalisation as in [15]),

where k_1 and k_2 have been calculated in [16].

Recognising that the M S scheme is only an intermediary scheme suited for calculations we can not a unique relation between the two observables $\hat{a}_{\!\! K}$ and $\hat{a}_{\!\! K}$. Inverting Eq. (22) for $a_{\!\! M-S}$ and inserting into Eq. (24) gives

Hereby all dependence on the \overline{M} S scheme has disappeared. E ectively what we have done is to go from the \overline{M} S scheme to the R-scheme, the elective charge scheme for R which is the renormalisation scheme where \hat{a}_R (Q_R) has no perturbative corrections, i.e. $Q_R = \hat{a}_{2,R} = \hat{a}_{2,R} = \hat{a}_{1,R} = \hat{a}_{1$

Applying the conform all lim it criteria so that the coe cients c_1 and c_2 take their conform all lim it values, $c_1 = \frac{3}{4}C_F = 1$ and $c_2 = \frac{9}{16}C_F^2$ '= 1 ', we get the conform all lim it renorm alisation scheme parameters Q_R and Q_R

which relates one e ective charge ($\frac{1}{4}$) to another one (a_R) which has been modiled in a unique way. This relation resembles the non-perturbative C rew ther relation [17], $3S = K R^0$, which is derived using conform aland chiral invariance. It relates A dler's anom alous constant (S), B jorken's sum rule for polarized deep-inelastic electroproduction (K) and the isovector part of R (R^0). A coording to the no-renormalisation theorem for the axial anomaly [18] one might think [19] that the perturbative corrections to K and R cancel. This is not the case, but instead one nds [19] that the combined corrections are proportional to the —function, (1+ $\frac{1}{4}$ R) (1 $\frac{1}{4}$ R) 1 / (a), if the light-by-light term is neglected. The generalised C rew ther relation has been studied in more detail in [10].

The modi ed e ective charge, $\mathbb{R}(\mathbb{Q}_R; \mathbb{Q}_R)$, can be obtained from the third order standard solution to Eq.(6),

which is valid for $\ln (Q_R = R)$ 1. The value of R should be determined by experiment from R = R = R and a well defined starting renormalisation scheme which is then modified into the conformal limit scheme where the scheme parameters are given by R = R = R.

V.DISCUSSION

Fig. 1 (a,b) illustrates the renorm alisation scheme dependence of \hat{a}_K ($Q_K = 50~G\,\mathrm{eV}$) as given by Eq. (25) using the standard solution, Eq. (32), for a_R with $_R^{(5)} = 502~M\,\mathrm{eV}$. We see that for not too small renormalisation scales the $_2$ -dependence dominates whereas for smaller scales both the scale dependence and $_2$ -dependence is quite strong. Since the renormalisation scheme dependence is parametrised by the renormalisation scale Q_R and Q_R when Q_R is kept xed, the whole space of schemes should in principle be obtained by varying Q_R and Q_R and Q_R and Q_R are two small renormalisation scales Q_R or too large Q_R this solution is no longer valid.

To be self-consistent, one should also take into account that Eq. (6) has to make sense perturbatively. In other words, if j_2ja_R 1 then we are no longer in the perturbative regime where the contribution from consecutive terms are smaller then the preceding ones and therefore the perturbative expansion breaks down. The lines $_2 = _{1} = a_R$ ' $_{1}$ $_{0} \ln (Q_R = _R)$ which indicates where this happens are shown in Fig. 1 (b). These lines also indicates where the solution given by Eq. (32) is no longer valid and the numerical results should therefore not be trusted in that region. The conformal limit scheme $x = x + a_R + a_R$




FIG. 1. Renorm alisation scheme dependence of \hat{a}_{R} ($Q_{R}=50~{\rm GeV}$) in (a,b) and B jorken's sum rule, K ($Q_{R}=3:16~{\rm GeV}$) in (c,d); shown as surface plots (a,c) and contour plots (b,d). Note that has been kept xed so that all the renorm alisation scheme dependence is given by the renorm alisation scale Q_{R} and Q_{R} . Some well-known scheme and scale choices are marked in (b) and (d) for reference and the corresponding numerical values are given in Table I and II respectively. The dashed lines indicates the limit of the perturbative regime, $p_{R}=p_{R}$ as explained in the text. In addition to the scheme dependence there is also a experimental uncertainty from the value of q_{R} .

schemes like the \overline{M} S scheme, the Principle of M in im um Sensitivity' (PMS) and the exctive charge schemes (ECH) for R and K.

Conceptually the PMS and ECH schemes are dierent from the conformal limit schemes in that they prescribe a unique scheme for each observable instead of giving schemes for relations between observables. It should also be noted that the PMS and ECH schemes sometimes gives renormalisation scales which are dicult to interpret physically. For instance in jet-production, both in e^+e^- [20] and D IS [21], the resulting renormalisation scales grow when the typical jet-mass ($y_{cut}W^-^2$) is decreased which is counter-intuitive. In addition the PMS prescription depends on the intermediate scheme. For example, applying the PMS prescription to two observables given in the \overline{MS} scheme separately and then relating them gives a dierent result compared to if the observables are restrelated so that the dependence on the \overline{MS} scheme is removed and then the PMS prescription is applied.

For reference, the numerical values of $_2$, Q_R , \hat{a}_K and B jorken's sum rule K in the dierent schemes are given in Table I (together with the MBLM method which has two renormalisation scales). Comparing the conformal limit scheme xing (CLSF) with the SBLM and MBLM scale xing methods in Table I we see that even though the coe cients c_i are the same, the scales, $_2$ and the resulting elective charge \hat{a}_K are dierent. This shows the importance of not only taking the commensurate scale relation into account as in the SBLM and MBLM methods but also the commensurate $_2$ relation as in CLSF.

t taking both electroweak and QCD corrections into account, $R_{\text{e+e}} = R_{\text{Born}}^{\ \ 2}$ (1+ \hat{a}_{R}), and num erical values for $R_{\text{Q}} = 1+\hat{a}_{\text{R}}$ are given for some distinct energies. In the following we have used the value $R_{\text{Q}} = 1.0463$ 0.0044 for $Q_{\text{R}} = 59.2$ GeV. The reasons for picking this particular energy are that we want to have a large scale Q_{R} where the standard solution, Eq. (32), is a good approximation (especially since $\hat{a}_{2,\text{R}}$ is so large) and at the same time we do not want to extrapolate the experimental result too much outside the measured range.

Following the prescription given above for determining $\binom{(5)}{R}$ we get,

from $\hat{a}_R=0.0463-0.0044$ using Eq. (32) w ith $\hat{a}_{2,R}=57.9$ and $\hat{Q}_R=59.2$ GeV . To be able to compare with the SMC measurement we also need \hat{a}_R . This is obtained by matching \hat{a}_R numerically at the avour threshold, $\hat{Q}_R=m_b=5$ GeV, for $N_f=4$ and 5 w ith $\hat{a}_2=\hat{a}_2$ which gives,

The conformal limit renormalisation scheme parameters are then obtained from Eqs. (29) and (30), $Q_R = 1.64\,\text{GeV}$ and $Q_R = 1.56$, and together with the conformal limit coecients $Q_R = 1.165\,\text{and}$ (4) this gives $Q_R = 0.159^{+0.139}_{0.048}$. Finally the conformal limit result for B jorken's sum rule given by Eq. (23) becomes

$$K = 0:176_{+0:010}^{0:029};$$

where $jg_A=g_V\ j=1.2573\ 0.0028\ [23]$ has been used and the error comes from the uncertainty in R $_Q$. This is in good agreement with the experimental value K = 0.199 0.038 measured by SMC. To be able to make a more challenging test of the conformallimit scheme arguments one would need much more precise measurements of both R $_{e+e}$ and K.

For illustration we also show the renormalisation scheme dependence of B jorken's sum rule in Fig.1 (c,d) and the numerical values of $_2$ and Q_R for the special cachemes indicated in Fig.1 (d) are given in Table II together with the resulting values for \hat{a}_R and B jorken's sum rule K. Comparing with Fig.1 (a,b) we see that the scheme dependence is much stronger which is also expected since we are at a much an aller Q_R . We also see that the perturbative regime indicated by the dashed line in Fig.1 (d) is narrower than in Fig.1 (b) and in fact both the SBLM and MBLM methods as well as the R-scheme are outside the perturbative regime. Therefore the numerical results given for these schemes should not be trusted. However, one must keep in mind that the SBLM and MBLM scale axing methods advocates the use of a physical measurement of \hat{a}_R at this scale and in this way the problem with the validity of the solution used for $_S$ never enters. Even so, Fig.1 (c,d) illustrates clearly that there is a strong renormalisation scheme dependence for B jorken's sum rule at this scale which should be taken into account when comparing the experimental result with theoretical expectations.

VI.SUM M ARY AND CONCLUSIONS

In sum mary we have shown that it is possible to generalise the conformal limit arguments of the BLM method to NNLO to x the renormalisation scheme, i.e. both the renormalisation scale and 2, when two observables are related. In this way all signs of scale breaking,

ie. € 0, is con ned into the running of the coupling and the coe cients in the perturbative series have their conformal lim it values. We have also shown (contrary to [9]) that this prescription for making the coe cients have their conformal lim it values is unique. Comparing with earlier extensions of the BLM method to NNLO they only x the scale using from the elective charge. This means, that the conformal lim it scheme xing gives both a so called commensurate scale relation as well as a commensurate relation which, in a unique way, species how should be modied when two physical observables are related to each other.

Applying the conform al lim it scheme — xing method to the relation between B jorken's sum rule K and R $_{\rm e+\,e}$ — gives a simple relation between the two. U sing the elective charge value ${\rm a_R}=0.0463$ — 0.0044 for $Q_R=59.2$ G eV from a global analysis of R $_{\rm e+\,e}$ — data gives K = $0.176_{+\,0.010}^{\,0.029}$ for $Q_K^{\,2}=10$ G eV 2 where the error comes from the experimental uncertainty in ${\rm a_R}$. A sæssing a theoretical error is much more complicated. The theoretical uncertainty is illustrated by the renormalisation scheme dependence which is shown to be quite large even though it can be reduced by requiring the scheme to belong to the perturbative regime. Still, the problem of quantifying the theoretical error remains to be solved. However, comparing with the experimentally measured K = 0.199 — 0.038 the agreement is good and theoretical uncertainties are still smaller than the experimental ones.
