# The Extended ChiralB osonisation A nd $P$ ion -D iquark E ective A ction

#### Abstract

W e consider bosonisation of the low -energy Q CD based on integrating the anom aly of the extended chiral ( $E$ ) transform ation which depends both on pseudoscalar $m$ eson and scalar diquark elds as param eters. T he relationship between extended chiral and usual chiral anom alies and related anom alous actions is studied. The e ective action for the extended chiral eld $U$ depending on com plete set of anom alous generators of the $E$ transform ation is given. The term s of this e ective action relevant to interaction of pions and $3_{c}$ scalar diquarks are w ritten dow $n$ explicitly.

## 1 Introduction

In a conventional understanding of the QCD physics diquarks $[1,2]$ and the quantum anom alies [3] usually are considered as unrelated topics. H ow ever in the recent paper [4] a possible connection between these two areas has been proposed. In [4] it has been show $n$ that $J^{P}=0^{+}$diquarks can be introduced together $w$ ith pseudoscalar $m$ esons as param eters of œertain transform ations | extended chiral ( E ) transform ations, including usual chiral as a subgroup. The chiralbosonisation $m$ ethod based on integrating chiral anom aly has been applied in order to obtain the e ective action for diquarks and to study their properties. The values for the $m$ ass of the ud-diquark $m_{u d} \quad 300 \mathrm{M} \mathrm{eV}$ and $m$ ean square charge radius $h r u d_{2} i^{1=2} \quad 0: 5 f m$ obtained in ref. [4] stim ulate an interest for further investigations in this direction.

The present paper is devoted to calculation of the e ective interaction of pions and scalar diquarks w ithin the approach based on E transform ations. This is a natural extension of the results of the ref. [4] on the case when the extended chiral eld $U$ depends on pions, scalar diquarks and other elds needed for closure of the E group [4]. All these states are introduced on a quasi-goldstone $m$ anner as angle-like variables corresponding to anom alous (non-preserving $m$ easure of quark path integral) generators of E transform ations. A $n$ especial status of pions which are as usually supposed to be goldstone particles in the chiral lim it is regarded by $m$ eans of choosing the param eterization of the eld $U$ in a certain form. All results of the pion physics known from the chiral bosonisation approach [5] are reproduced. W e do not introduce any new param eters.

The Sect 2 contains $m$ ain elem ents of the chiral bosonisation approach adopted to our purposes. At rst, we rem ind the structure of the E transform ations and consider the sym $m$ etry properties of the quark path integral. A fter that, the E -bosonisation is form ulated. At last, herein we study the correspondence betw een the extended chiral and usual chiral anom alies and related anom alous actions.

The Sect. 3 is devoted to studying the e ective action $W$ eff ( $U$ ) which contains infor$m$ ation about low -energy pion-diquark interaction. W e start from the explicit expression for $W_{\text {eff }}$ in term softhe eld U.The $3_{c}$ scalar diquark sector of $\mathrm{W}_{\text {eff }}$ is studied and $m$ ain properties of the diquark are exhibited. N ext, we discuss the proper param eterization of the eld $U$ which regards the goldstone nature of pions. W e nish the Sect. 3 by resulting expression for the e ective interaction lagrangian of pions and $3_{c}$ scalar diquarks.

## 2 The E -boson isation of the quark path integral

### 2.1 The E transform ations of the quark elds

Let us rem ind the form ulation of the E -transform ations follow ing ref.[4]. Introduce the M ajorana-like eight-com ponent spinor constructed from the ordinary D irac spinor

The generators ! are of quantum num bers of scalar diquarks. The colourless part of corresponds to pions. In ref.[4] it has been shown that $E$-group is $G=U(2 N)$, the generators span the Lie algebra ofH $=\mathrm{O}(2 \mathrm{~N})$ and the ${ }_{5}$ generators belong to the coset $\mathrm{G}=\mathrm{H}=\mathrm{U}(2 \mathrm{~N})=\mathrm{O}(2 \mathrm{~N})$. The transform ations (2) are m ost generalglobal transform ations under whose action the kinetic term of the ferm ion eld is invariant.

To study the quantum theory let us introduce extemal vector elds $v, a, 5$, generating and vector currents and which have the sam em atrix structure as the generators ( $\frac{-1}{-1}$ ) respectively. In term s of spinor the quark lagrangian can be written as

Because of the noninvariance of the $m$ easure $w$ th respect to 5 -transform ations [10] the quark path integral ( $\underline{i}_{1}$ ) does not invariant under action of transform ations (2ָ) or ( Thus $Z$ has the structure $Z=\exp i\left(W_{\text {an }}+W_{\text {inv }}\right)$ where $W_{\text {an }}$ and $W_{\text {inv }}$ are noninvariant and invariant functionals of the extemal elds correspondingly. This $m$ eans that there exists an E -anom aly, which is de ned as follow s

### 2.2 The E -boson isation

In refs.[6] it has been show $n$ that if the quark path integral has an anom aly $w$ ith respect to som e transform ations then we can perform a bosonisation of the variables generating these anom alous transform ations. This general result plays an im portant role in our suggestion to consider scalar diquarks as associated w ith ! while pseudoscalar m esons as usually w ill be associated w th .

Let us now form ulate the E -bosonisation. This can be done by generalization of the chiralbosonisation approadh developed in refs. 5,6$]$.

An im portant ingredient of the chiralbosonisation of the low -energy QCD is the hypothesis that there exists som e low -energy region $L$ w here the noninvariant or anom alous uctuations of quark variables are essential while out of this region they are negligible. The region $L$ can be form ulated as a some region of the spectra the $D$ irac operator $\hat{G}$, as it done below. Because $Z$ is the determ inant, $Z=\operatorname{det}^{1=2} \hat{G} \quad Q \quad 1=2,2$ spec $\hat{G}$, the hypothesis of existing the low-energy region $L m$ eans that $Z=Z^{L} Z_{i n v}$. The fiunctional $Z^{L}={ }^{Q}{ }_{2 \mathrm{~L}}{ }^{1=2}$ contains all inform ation on -noninvariant processes while $\mathrm{Z}_{\text {inv }}$ is invariant functional. Thus all contributions in E -anom aly com es from $\mathrm{Z}^{\mathrm{L}}$.

The E boosonisation can be form ulated as follow s

where argum ent $s m$ eans corresponding transform ation of background elds. The effective action $W$ eff is the $m$ ain $o b$ ject which we are looking for. It describes the e ective low -energy interaction of the -variables. The explicit expression for $W$ eff is $w$ ritten in the next Section, where it is studied.

### 2.3 The E -anom aly and $W$ an

In ( $(1001)$ ) the action $W$ eff is de ned through $E$-anom aly or, equivalently, through $W$ an . Thuswe have to nd the explicit expressions for $A^{a}$ or $W_{\text {an }}$ in term softhe extemal elds.

To nd the E -anom aly and the related anom aly action one should regularize the functional $Z$. U sually the chiralbosonisation $m$ ethod is arm ed by nitem ode regularization schem e $[11,5]$ which consists in continuation to Euclidian dom ain and specifying the low-energy region $L$ as some region of spectra of the herm itian operator $\hat{G}_{\mathrm{E}}$. In fact, the expression for the $E$-anom aly $A^{a}$ can be obtained from the usualchiral's one, expressed in term s of $\mathrm{v} ; \mathrm{a}$ only. Indeed, in our case the operator $\hat{\mathrm{G}}$ is presented in the form of the usualD irac operator (se ( $(\underline{4})$ )) where instead of $v$; $a$ we have block antiherm itian extemal elds V and A given by ( ${ }_{-1}$ ). Because V ; A are transform ed in nitesim ally by like $v ; a$ are transform ed by usual chiral , the E -anom aly can be obtained from the know $n$ chiral one $[3,5,11]$ by $m$ eans of form al substitution

accom plished by taking additionally trace in two-dim ensional \block" space and by taking into account the overall factor $1 / 2$ com ing from the power of determ inant in ( $\left(1 \overline{1}_{-1}\right)$. The sam e argum ents are valid when $\hat{G}$ depends on extemal scalar elds as well.

As it is well known [3,5], the anom aly consists out of topologically trivial A ${ }^{+}$and non-trivialA parts: $A=A^{+}+A$. Thepart A after integration in ( 10001$)$ form the $W$ essZum ino-w itten action responsible for $P$-odd processes. The dynam ics (decay constants, $m$ asses ets.) is contained in that part of $W$ eff which is related to $A^{+}$and this part is relevant for our investigation. Instead of $A^{+}$we present here the corresponding part of W an

N ote that the argum ents presented above about substitution of the elds are valid for the expression ofW an aswell. Therefore the results of ref. [5] can be used straightforw ardly in order to obtain the expressions both for $W$ an and $A^{a}$ if it is needed to take into account the scalar elds together $w$ ith the vector ones.

## 3 Pion-diquark e ective action

### 3.1 An expression for the $W$ eff

D ue to relationship between E -anom aly and chiral anom aly established in previous Section, the pion-diquark e ective action in term s of E - eld U looks like as pure pion one 5] and reads

Herein we drop the $W$ ess-Zum ino-w itten action. For sake of sim plicity we also drop all extemal elds except the vector eld $v$ containing relevant dynam ical elds of ghons $\mathrm{V}=\mathrm{G}=\mathrm{g} \mathrm{G}^{\mathrm{a}}\left(\frac{\mathrm{a}}{2 \mathrm{i}}\right)$. TheE - eld $U$ in (1-4í) is de ned as $U=U^{2}$ where $U=\exp$ asabove. Butbelow we rede ne $U$. Before explanation of the reasons of rede nition $U$ we would like to consider the diquark sector of the e ective action ( $1 \overline{4} \overline{4}$ ).

### 3.2 The $3_{c}$ scalar diquark sector of $W$ eff

The $3_{c}$ scalar diquark sector of $W$ eff corresponds to the case when contains $3_{c}$ scalar diquark elds only, i.e.
where j;k are avour and a;b;c are colour indioes. $f$ ! is the diquark decay constant which w ill be determ ined below .

The reduction ( $\left.\overline{1} \bar{T}_{1}\right)$ has been considered in [4]. It has been shown that in this case $G=S U(4) \quad O(6), H=S U(3) \quad U(1)$ and scalar $3_{c}$ ud-diquarks ! belong to $G=H=$ $C P^{3}=S U(4)=S U(3) \quad U(1)$.

The diquark $m$ ass term com es from the last term of ( $\overline{1} \overline{4})$, , because the later contains the term $G^{a} G \quad{ }^{i}!_{c}!_{c}$. Substituting quasi-classically instead of $G^{a} G \quad{ }^{\text {a }}$ its vacuum expectation value we obtain the follow ing expression for the inverse diquark propagator

For actual value of gluon condensate $\mathrm{C}_{\mathrm{g}}=(365 \mathrm{M} \mathrm{eV})^{4}$ we get M! 300 M eV . A s it was $m$ entioned in ref.[4] the correction of this evaluation due to quark $m$ asses is provided by
$M!\left(m_{q} \notin 0\right)=M{ }_{!}^{2}\left(m_{q}=0\right)+m^{2}$. This gives $M{ }_{!}^{2}\left(m_{q} \not 0\right) \quad 340 \mathrm{MeV}$, which falls into the region allowed in the other models [2]. The low m ass of diquark can be explained by a reason that this is in fact \current" $m$ ass because we do not take into account the interaction w ith ghons which leads to \dressing" the diquark.

The diquark decay constant $f$ ! is de ned by requirem ent that the residue of the diquark propagator at $p^{2}=M_{!}^{2}$ is unity,

The additional term depended upon the diquark $m$ ass in $(\underline{2} \overline{0} \overline{-})$ com es due to tachion pole of the propagator ( 1 it can be neglected.

In fact, the relation $f_{!}={ }^{q} \frac{2}{3} f$ reproduce the results of the ref.[12] where instead of f ;! therein g ;! has been used ${ }_{1}^{1 \mathrm{I}}$. In the chiral lim it which we consider here, f ;! and g ;! are related through quark condensate $\mathrm{C}_{\mathrm{q}}(<0)$ as

### 3.3 The E - eld U w ith all possible -variables

[^0]Then the sum $=+$ represents decom position on the colour singlet ( ) and nonsinglet ( ) parts.
$N$ ow we are going to discuss the reasons for rede nition of the $U$ if it is taken in the usual form $U=\exp 2$. A lso we describe the $m$ ost obvious $m$ ethod of its rede nition which $m$ eans changing variables from unphysical to physical ones.

On this way we take in advance the goldstone nature ofpionsw hich are related to exact SU (2) $L_{\mathrm{L}} \quad \operatorname{SU}(2)_{\mathrm{R}}$ Sym $m$ etry of the $m$ assless $Q C D$ lagrangian. The goldstone particles have an im portant and general property: they can interact betw een them selves and w ith any other particle only through vertioes w ith derivatives. A s far as pions are considered as goldstone particles this property m ust be preserved in description of those physical processes in whose pions take part [8].

H ow ever this property w illbe lost if one identi es $U$ in a usualway as $U=\exp 2=$ $\exp 2(+)$ where both and are put to be nonzero. T he puzzle arises due to the term $\left.\operatorname{tr} \mathbb{E} ; \mathrm{U}] \mathbb{E} ; \mathrm{U}^{+}\right]$in $W_{\text {eff }}$ which contains pion interaction term s starting from the ${ }^{4}$. This happens only because of speci c dependence on pion elds in $U=\exp 2(+\quad)$ w th and are given by (25)'. Because $[; \mathrm{F} \quad]=0$, there are no pure pion vertioes (togetherwith $G \mathbb{G}$ ) in $\operatorname{tr} \mathbb{E} ; \mathrm{U}] \mathbb{E} ; \mathrm{U}^{+}$]. But because [ ; ] 0, we nd that the term $\left.\operatorname{tr} \mathbb{E} ; \mathrm{U}] \mathbb{F} ; \mathrm{U}^{+}\right]$contains $\left\{!_{3} ;!_{6} ; 8\right.$ interaction term S without derivatives. A 11 this indicates that $U$ taken in the form does not preserve the goldstone nature of pions in the $\{$ interaction sector of $W$ eff .

Therefore when the term $\left.\operatorname{tr} \mathbb{E} ; \mathbb{U}] \mathbb{F} ; \mathrm{U}^{+}\right]$(and only this term in $W_{\text {eff }}$ ) contains non-goldstone type of pion vertioes, we have to rede ne the eld $U$ in order to elim inate the dependenœ of $\operatorname{tr} \mathbb{F} ; \mathbb{U}] \mathbb{F} ; \mathrm{U}^{+}$] on pion elds. This $m$ eans that instead of $U=$ $\exp 2(+)$ we have to take som e $U$ phys $=U_{\text {phys }}(;)$ which $m$ ust satisfy the follow ing condition

To determ ine Uphys we can use the relationship between the nite 5 -transform ation and the corresponding E - eld. Choosing any speci c form of param eterization of the nite 5 -transform ation we get som e speci c form of the E - eld trying to satisfy the condition (2, $\overline{\mathbf{Q}})$. The follow ing param eterization of the elem ent $\mathrm{g} 2 \mathrm{G}=\mathrm{H}$ is suitable for our punposes

$N$ ote that reparam eterization of the $E$ - eld does not a ect the properties of the states $\overline{(\overline{3}} \overline{3})$ entering in the . It only corrects the structure of the $\{$ interaction
and does not touch any term from the -sector of the $W$ eff. This occurs because the reparam eterization of the elem ent $\mathrm{g} 2 \mathrm{G}=\mathrm{H}$ does not change the W eff considered as a function of the eld $U$. The functional dependence of $W$ eff on $U$ is closely determ ined by the anom aly action $W_{\text {an }}$ whose expression in term s of extemal elds (133), obviously is independent on param eterization of the nite 5 -transform ation.

The described scheme can be easily extended on the case of three avours. The presence of the additional term $s$ due to nonzero quark $m$ asses does not in uence the argum ents just explained. The condition ( $\overline{2} \overline{-} \overline{-})$ is the only condition which has to be satis ed in order to guarantee that in the chiral lim it the pseudoscalar colourless $m$ esons appear to be exact goldstones.

## 3.4 $P$ ion-diquark e ective interaction

In what follow s we will assume that $U$ in $W_{\text {eff }}$ alw ays is $U_{\text {phys }}$ given by (2̄Oq). Introduce the follow ing notations

The term $s$ of ( $3(2 \pi)$ ) show $n$ explicitly determ ine the $m$ ain contributions in the vertex $G$ reen functions at $s m$ all extemal $m$ om enta. H ere we would like to stress again that the term $\operatorname{tr} \mathbb{F} ; \mathrm{U}] \mathbb{F} \quad ; \mathrm{U}^{+}$] of W eff does not contribute in L ; (see Sect.3.3). This term is closely contained in -sector of $W$ eff which can be found if we put $U=U$ in ( $(\overline{1} \overline{4})$.

The expression ( $\overline{3} \overline{3} \overline{1}$ ) provides us an inform ation about pion-diquark e ective interaction at low energies. U sing the vertioes contained in ( scattering at sm all pion $m$ om enta provided we have a good $m$ odeldescription ofbounding diquark together w ith the third quark into nucleon. Of cause, in order to obtain
the predictions com parable w ith the data the in uence of quark $m$ asses should be taken into account. H ow ever it is im portant that we succeeded in description of pion-diquark interaction from universal point of view of extended chiral transform ation approach.
