# Experim ental C on sequences of a M in im al M essenger M odel for Supersym m etry B reaking<sup>1</sup>

#### Abstract

W e calculate the low -lying spectrum of new particles expected in a m inim al m odel wherein supersymmetry breaking at < 100 TeV is indirectly transmitted to the Standard M odel. We calculate the couplings of these particles relevant to their most nearly accessible experimental signatures, and estimate those signatures quantitatively. Running of various couplings plays a crucial role in the phenom enology, speci cally in generating an adequate  $\mathbb{N}_1$   $\mathcal{R}_R$  splitting.

# 1 Introduction

Since the widespread realization that successful uni cation of gauge couplings can be achieved in models including the minimal supersymmetric extension of the standard model (perhaps augmented with complete SU (5) multiplets) [1], anticipation of the imminent discovery of direct evidence for real { as opposed to virtual { supersymmetry has become almost palpable. On the other hand, there has been no consensus regarding the form this discovery might take. Theoretical control over the many new parameters that arise even in minimal supersymmetric extensions of the standard model is not adequate to guide one through a bewildering number of choices that substantially a ect the predictions for observable phenomena.

Recently a class of m odels that potentially enjoy great predictive power has been identi ed [2]. The leading idea of these m odels is that the fundam ental breaking of supersym m etry occurs in a hidden sector" and is characterized by a scale <br/> 100 TeV. This breaking is supposed to be conveyed to our observable sector, including the m inimal supersym m etric standard m odel, by a speci c, highly sym m etric interaction term

(to be discussed m ore precisely below). This is to be contrasted with the situation in a class of m odels, com m only referred to as supergravity m odels, that has been m uch m ore popular. In supergravity m odels the fundam ental sym m etry breaking scale is

 $10^9$  TeV, and the hidden sector communicates with the observable sector by gravitational-strength interactions. A decisive phenom enological di erence between these classes of models arises because of the di erent role played by the gravitino G, which is essentially the N am bu-G oldstone ferm ion of spontaneous supersymmetry breaking. Its mass is generically given as M  $_{\mathcal{C}} = \frac{2}{M_{P \text{ lanck}}}$ , whereas its couplings to ordinary matter scale as  $\frac{1}{2}$  [3]. In most supergravity models the gravitino is massive and very weakly coupled, and although it could be signi cant cosm ologically, it plays no very direct role in ordinary phenom enology. In the (relatively) low energy messenger m odels the gravitino is exceedingly light, and although its couplings are very feeble they can be such as to cause the next lightest, photino-like particle  $\mathbb{N}_1$  to decay via N₁ ! + G within a distance that might be di cult to resolve experimentally [4]. Generically, then, in these models one will nd that pair-production of supersymmetric (R-odd) particles will lead eventually, perhaps after a cascade of decays, to nal and m issing energy. The recent observation [5] of a dram atic states containing event with a nalstate containing hard  $e^+e$ and m issing transverse energy by the CDF collaboration therefore lends special interest to these models.

In this paper we shall calculate the low -lying spectrum and interactions in a m inim alm essenger m odel of the kind m entioned, in su cient detail to estim ate the m ost nearly accessible processes. We might and specific pattern of consequences. In the course of the analysis we shall not that some apparent disculties of the model are resolved by careful attention to the nunning of various couplings. Similarly a possible disculty with the apparent sm allness of the B parameter, which if valid would imply the existence of a weak scale axion, is autom atically repaired.

# 2 Spectrum

In the m inim alm essenger m odel (M M M) supersymmetry breaking is conveyed to the standard m odel particles by the matter elds  $(q^0; v^0) + (\overline{q}^0; \overline{v}^0)$  having the quantum numbers  $5 + \overline{5}$  under SU (5). These elds are assumed to acquire supersymmetry breaking m asses through their couplings to a standard m odel singlet eld X which develops vacuum expectation values along its scalar as well as its F (components. Explicit m odels where this occurs dynam ically have been constructed [2]. Typically these m odels contain the superpotential couplings

which renders a non{supersymmetric spectrum for the  $(q^0; {}^{0})$  elds through  $F_X \in 0$ . The  $(q^0; {}^{0})$  elds, through their standard model gauge interactions, induce SUSY breaking masses for the R-odd scalars  $(q; {}^{\circ})$  and gauginos  $(\mathcal{B}; \overline{\mathbb{M}}; g)$ . The gaugino masses arise through one{loop diagrams and are given (in the approximation  $F_X = q_i \cdot hX i^2$ ) as

Here  $F_x = hX$  i is the elective SUSY breaking scale, which is close to the mass scale of the  $5 + \overline{5}$  elds. The scalar masses arise through two{loop diagram s and are given as

We have adopted the usual SU (5) norm alization of the hypercharge coupling,  $_1$  $\frac{5}{3}$  <sub>Y</sub> and de ned Y as Q = T<sub>3</sub> +  $\frac{Y}{2}$ . In Eq. (3), C<sub>3</sub> = 4=3 for colored scalars and zero for sleptons, C<sub>2</sub> = 3=4 for SU (2) doublets and zero for singlets.

The mass relations of Eqs. (2){(3) will arise in a large class of models which might di er in the details of supersymmetry breaking; it is su cient that SUSY breaking is conveyed to the standard model particles through the  $5 + \overline{5}$  elds as in Eq. (1). Thus the mass relations would hold even if SUSY is broken spontaneously by the O'R aifearteigh mechanism (F {type breaking). The  $5 + \overline{5}$  elds is of course the simplest extension of the standard model sector that preserves the successful uni cation of the gauge couplings.

The relations in Eqs. (2) { (3) in ply that there is a clean separation of scales am ong the SUSY particles, as their masses scale with the interaction strength. Thus the squarks are the heaviest, followed by the gluino, left{handed sleptons ( ${}^{e}_{L}$ ),  $\bar{\mathbb{M}}$ , right{ handed sleptons ( ${}^{e}_{R}$ ), and the B {ino, which is the next-to-lightest R-odd particle (the lightest is the gravitino ( ${}^{e}$ ). Their masses (neglecting RGE-running) are in the ratios 11:6 : 7:0 : 2:5 : 2 : 1:1 : 1:0. From an immediate experimental perspective the most interesting particles are the lightest ones,  ${}^{e}_{R}$ , the chargino (which we shall denote by  $\bar{\mathbb{M}}$ ) and the two neutralinos ( $\bar{\mathbb{M}}_{1}$  and  $\bar{\mathbb{M}}_{2}$ ). The latter are essentially pure gaugino eigenstates since their mixing with the Higgsinos are suppressed by the large parameter required in the model.

The relations in Eqs. (2)  $\{$  (3) receive signi cant corrections from the renorm alization group evolution. This evolution has several interesting consequences:

It drives the mass-squared of  $H_a$ , the M SSM Higgs doublet that couples to the top quark, which is positive at the scale , to a negative value near M  $_z$  and thus facilitates electroweak symmetry breaking. The mass-splitting between H  $_u$  and H  $_d$  is given by




Figure 1: (a) Boundaries of interesting regions in the (M  $_2$ ;tan ) plane: the region above the dark, solid line does not have a QED -preserving potentialm inimum; in the region above the light solid line, the  $e_R$  is the NLSP; in the region to the right of the dashed line, the decay  $\[mathbf{M}\]$ ! W  $\[mathbf{M}\]_1$  is kinem atically allowed; to the right of the dotted line the decay  $\[mathbf{M}\]_2$ !  $\[mathbf{M}\]_1$  is kinem atically allowed. (b) Contours of m $\[mathbf{m}\]_R$  in GeV, for < 0.

Observe that H<sub>u</sub> receives a mass correction proportional to  $m_{e'}^2$ , which is much larger than  $m_{H_u}^2$ .

It lowers the masses of the  $\mathbb{F}; \mathbb{F}$  ), and raises the masses of  $\mathbb{F}_{\mathbb{R}}$  (as well as  $\mathbb{F}_{\mathbb{L}}$  and q), from their bare values at . Consequently, the mass splitting between  $\mathbb{F}$  and  $\mathbb{F}_{\mathbb{R}}$  is enhanced at the weak scale. We not that a mass splitting of 10 GeV at

typically becomes (20 25) GeV at  $M_z$ . Upon including, as well, the positive D {term correction to the mass of  ${}^{e}_{R}$ , the mass splitting becomes about 35 GeV for  $M_2$ ' 200 GeV. (For de nitiveness we have taken = 100 GeV for the num bers given here.) Contours of this splitting are shown in Figure 1. This di erence has signi cant impact on the interpretation of the observed ee event at CDF.

It supplies a su ciently large m ass to the would {be axion of the model. The soft bilinear m ass term B for the Higgs eld, (B H  $_{\rm u}$ H  $_{\rm d}$  + H x:) in the Higgs potential, is extremely small at . If not for the elect of running (and in the absence of other contributions to B ()), one would not a weak scale axion, in conject with observation. However, we not that a large enough B is generated in the process of running so that  $m_A^2 = 2B = \sin 2$  (400 G eV)<sup>2</sup>.

A fler including the e ects of renom alization group evolution and D-term  $s_r$  the mass spectrum of the model looks as follows. The gaugino masses obey a simple

scaling with the the gauge couplings, so that

The masses of  ${}^{\boldsymbol{e}}_{\ R}$  ,  ${}^{\boldsymbol{e}}_{\ L}$  and H  $_d$  are given by

where the last term s are the D-term contributions, and should be om itted for  $m_{H_d}^2$ . The A and B parameters are given by

which hold for low to interm ediate values of tan . Here  $Y_t = h_t^2$  is the top Yukawa coupling squared, and  $Y_f$  ' 2:79.  $A_{u;c}$  are obtained from  $A_t$  by setting  $Y_t = 0$ . The nalm ass ratios for  $\mathbf{q}: \mathbf{g}: \mathbf{e}_L : \mathbf{k} : \mathbf{e}_R^* : \mathbf{k}_1$  are given by 9:3:6:4:2:6:1:9:1:35:1:0. (All of our num erical results are derived using the complete one { loop RGE 's.)

In the minimal messenger model without any modi cation of the Higgs sector, one expects A and B parameters to be negligible at , since they arise only from higher loops (see how ever R ef. [7]). How ever, in the process of running, signi cant A and B can be induced. Furtherm ore, in this constrained version, the parameter tan and the sign of are determined. These results follow from minimizing the Higgs potential, which leads to

The last relation implies that is large in the model. If B () = 0, we can infer its e ective value at M<sub>z</sub>. Tan is then determined through the RGE -improved tree-level potential of Eq. (9) to lie at tan 30; estimates of the full 1-loop contributions appear to push tan up to values near tan 40 to 50. In this most econom ical version, one also nds the sign of to be negative. A further constraint arises from dem anding that the  $e_R$  m ass(squared not turn negative (otherwise the vacuum will be superconducting). In Figure 1 we show the contour of  $m_{e_R}^2 = 0$  in the tan  $M_2$  plane; tan > 50 is excluded. A more stringent constraint along these lines is to require, in the spirit of the phenom enology we are attempting to address, that  $m_{e_R} > m_{Re_1}$ , otherwise  $N_1$  will decay dom inantly into  $+ e_R$ , destroying the signature. The contour where  $e_R$  m ass equals that of  $N_1$ is also shown in Figure 1; above that line the  $e_R$  is the lighter. Because the bound corresponds roughly to tan 25, we shall focus only on the range tan 25 in presenting our num erical results.

# 3 Production and Decay of Sparticles

G iven the physical parameters M<sub>2</sub>, tan and sgn all cross-sections and branching ratios within the MMM can be calculated. It is particularly in portant that within the MMM there are three widely separated m ass scales: light particles with only U (1) hypercharge interactions, interm ediate m ass particles with SU (2)<sub>L</sub> interactions, and heavy particles with SU (3)<sub>c</sub> interactions. The heavy states (squarks and gluinos) are typically around 1 TeV for light particle m asses consistent with LEP bounds; therefore their production rates even at the upgraded FNAL will be orders of m agnitude below observable signal levels. Finally, the electrow eak breaking constraint usually xes such that M<sub>2</sub> jj<sup><</sup> M<sub>3</sub>, pushing sparticles w hose m asses come from (i.e., higgsinos and the second doublet of H iggs bosons) out of the reach of current accelerators.

On the other hand, the light and interm ediate m ass sparticles can have non-negligible production rates even in Run I of FNAL ( $_{L}$  ' 120 pb<sup>-1</sup>). For this study of the M M M, we consider a pp collider/detector with s = 1.8 TeV, as at FNAL Run I, with 100% e ciency for tagging all relevant nal states. Because the sparticles are always produced in pairs, and because the gluinos and squarks are too heavy to be produced at reasonable x, we need only consider D rell-Y an (DY) production processes. Each process is calculated at the parton level for  $\hat{s} = x_1 x_2 s$ , then integrated over the proton parton distribution functions,  $f_{q=p}(x_i)$ , in this case using those of the CTEQ 3M set [8]. P revious calculations of DY sparticle production were used or altered for the parton level processes studied here [9]. The parameter space studied is spanned by the three parameters (M<sub>2</sub>; tan ; sgn ) in the ranges 50 M<sub>2</sub> 400, 1 < tan 25 and taking both signs.

There are a limited number of sparticle DY processes which can be expected to

be observable at the current generations of hadron colliders:

where i; j = 1; 2. Not surprisingly, in order for production rates of the heavier slepton modes (ee,  ${}^{\mathbf{e}}_{\mathbf{L}} {}^{\mathbf{e}}_{\mathbf{L}}$ ) to be observable, rates for the lighter sparticles would be much larger, already providing an unambiguous signal at a collider. Since a large signal has in fact not been observed we will not consider the DY production of left-handed sleptons further.

O ne also expects (and we have explicitly veried) that the rate for double neutralino production  $(N_1 N_j)$  is small compared to the others, since in the lim it  $N_1 = B^0$  and  $N_2 = M_1^0$  there are no  $Z N_1 N_j$  interaction terms in the MSSM. (This fact also implies that the calculation of  $N_1$  m associates from non-observation of Z!  $N_1 N_1^0$  at LEP1.5 need not coincide with the kinematic lim it of approximately 65 GeV; in fact we not the appropriate mass bound from OPAL [10] to be 10 15 GeV below this lim it.) Likewise, the  $N_1 M_1$  channel is suppressed due to the lack of a  $W^+ M_1$  B interaction. We not the production rate of  $N_1 M_1$  to be at least two orders of magnitude below the rates for competing processes, making it inaccessible at current colliders.

The exact signature of each channel will depend on how its constituents decay. Consistent with the MMM and the CDF event, we take the gravitino to be the lightest R-odd particle, to which the next-lightest R-odd particle (the  $N_1$ ) decays via  $N_1$ ! G. Then essentially all sparticles produced will eventually decay to  $N_1$  and in turn to  $+ \mathbf{E}_2$ ; thus  $+ \mathbf{E}_2$  is a mandatory ingredient of the nal state in allMMM sparticle production processes.

W ithin the MMM, the  ${}^{\mathfrak{S}}_{R} = {}_{\mathfrak{S}}_{R}; e_{R}$  and the  $e_{R}$  can only decay directly to the 2-body nalstate  ${}^{\mathfrak{N}}_{1}$  or  ${}^{\mathfrak{N}}_{1}$ , where  ${}^{\mathsf{v}} = e$ ; (we treat leptons separately for later convenience). Since the production cross-section for each avor of slepton is the same,




Figure 2: C ross-sections at the Tevatron for  ${}^{e}_{R} {}^{e}_{R}$  (solid),  ${}^{e}_{N} {}^{f}_{2}$  (dashed), and  ${}^{e}_{N} {}^{f}_{N}$  (dotted) production. (Slepton avors and gaugino charges sum m ed over.) The contours are labelled in fb; the labels at the top of the plot labelboth gaugino production channels, while those at the bottom label the slepton production. The contours for 1 event in 100 pb<sup>-1</sup> are in bold.

one observes a signal +  $+ \mathbb{F}_2$  1/3 of the time, and  $+ \mathbb{F}_2$  2/3 of the time. Such a nalstate describes the  $\mathbb{E}_2$  event at CDF.

There has been some discussion in the literature as to whether the MMM could describe the CDF event through  ${}^{\mathfrak{S}}_{R} {}^{\mathfrak{S}}_{R}$  production given the small mass splitting between  $\stackrel{\mathbf{e}}{\mathbb{R}}$  and  $\mathbb{N}_1$  [6]. The authors of Ref. [6] were concerned because one of the electrons in the CDF event is highly energetic (E<sub>2</sub> ' 59G eV) while they assumed  $m_{e_{c}}$  ' 1:1  $m_{e_{c}}$ , which in the mass range of interest corresponds to  $\hat{R}$ N∮₁ m ass splitting of only about 10 GeV. The required boost for the initial pairs of sleptons seem ed to reduce signi cantly the probability of interpreting this event as com ing from MMM  ${}^{e}_{R}$  production. This may be too pessim istic given the analysis of the  ${}^{\mathbf{e}}_{_{\mathrm{R}}}$  { ${}^{\mathrm{f}}_{_{1}}$  m ass dierence in the previous Section. From that analysis, we nd for the  $m_{re}$  ' 35G eV and the required boost is small appropriate m ass range that m <sub>e</sub> ( ' 1:3). However, as pointed out in [6], larger mass di erences in turn in ply smaller rates for  ${}^{\mathbf{e}}_{\mathbf{R}} {}^{\mathbf{e}}_{\mathbf{R}}$  production with respect to the  $\mathbf{W} \ \mathbf{N}_2$  and  $\mathbf{W} \ \mathbf{W}$  channels. For a 35 G eV m ass splitting, this suppression is about a factor of two relative to a 10 GeV splitting. G iven the current paucity of data, this is completely consistent with observation.

Because  $\mathbb{N}_2$  and  $\mathbb{W}$  are nearly degenerate in mass, the preferred decay of the heavier of the two to the lighter via  $\mathbb{W}$  !  $\mathbb{N}_2 \mathbb{W}$ , cannot occur. If  $\mathbb{M}_{\mathbb{W}} = \mathbb{M}_{\mathbb{W}_1} > \mathbb{M}_{\mathbb{W}}$  then the 2-body decay  $\mathbb{W}$  !  $\mathbb{N}_1 \mathbb{W}$  will be allowed. In Figure 1 (a) the contour along which the decay becomes kinematically allowed is displayed. However, the coupling

is suppressed by the lack of any W  $\overset{\circ}{\mathbb{W}}$   $\overset{\circ}{\mathbb{B}}$  interaction in the M SSM, so unsuppressed 3-body decays can compete with the 2-body mode. (Calculations of all relevant 2and 3-body decay widths exist in the literature [11].) The 3-body decays proceed through t-channel exchange of  ${}^{\circ}_{L}$  or e:  $\overset{\circ}{\mathbb{W}}$  !  $\overset{\circ}{\mathbb{W}}_{1}$ . (In this way it might be possible to account for the CDF event using  $\overset{\circ}{\mathbb{W}}$   $\overset{\circ}{\mathbb{W}}$  production, without having to invoke coincidence against a  $\frac{1}{9}$   $\frac{1}{9}$  suppression in the W decay branching ratios. A signal for this possibility is the existence of equal num bers of like and unlike lepton pair events, e.g., both  $e^{+}e^{-} + \mathbb{E}_{2}$  and  $e^{+}^{+} + \mathbb{E}_{2}$ .)

At large tan there is a strong enhancement in the 3-body decay into  $N_1$ . This arises because at large tan the -Yukawa coupling becomes 0 (1) and couples to the  $\hat{H}_D$  component of  $\hat{W}$ , which can be relatively large. For example, for positive (negative) and tan greater than 5 (10), the branching ratio of  $\hat{W}$ !  $\hat{N}_1$  exceeds 50%.

The decay channels of  $\mathbb{N}_2$  are similarly a mix of 2-body decays suppressed by small couplings and 3-body decays suppressed by phase space. The three 2-body decays are to  $\mathbb{N}_1 h^0$ ,  $\mathbb{N}_1 Z$  and  $\mathbb{C}_R^\circ$  nal states. The rst two can be either allowed or disllowed in alternative large regions of the parameter space; the third is always allowed. Each 2-body process su ers from small couplings which go to zero in the lim it  $\mathbb{N}_2 = \mathbb{W}^0$  and  $\mathbb{N}_1 = \mathbb{B}^0$ . For small gaugino-higgsino mixing the leading 2-body coupling is through the -Yukawa coupling so that even at relatively small tan , decays to 's predom inate.

When it is kinematically allowed, the decay  $\Re_2$  !  $\Re_1 h^0$  has a large (50%) branching fraction. Such a process could provide an interesting route toward pursuing Higgs physics at the Tevatron, with Higgs production neatly tagged by the hard photon pair. Because the lightest Higgs boson,  $h^0$ , receives large radiative corrections to its mass, there is considerable uncertainty about the precise prediction of  $m_{h^0}$  for each point in our parameter space. Further,  $m_{h^0}$  is sensitive to deviations from minimalm essenger models, for example to inclusion of a singlet Higgs eld (perhaps useful for generating a -term). Therefore in presenting our results, we have pretended that the Higgs decay mode is disallowed; if it is allowed at all it is appreciable. We will highlight where applicable the swath through parameter space where the Higgs mode is open in the truly-minim alM M M. When on-shell Higgs production is disallowed, the coupling suppression serves to make any 3-body decay through the Higgs unobservably small. The contour along which the Higgs decay mode becomes accessible is shown in Figure 1 (a).

The two 3-body decays of  $\mathbb{N}_2$  are via t-channel  $\mathbb{C}_L$  and e:  $\mathbb{N}_2$  ! \* \*  $\mathbb{N}_1$  and  $\mathbb{N}_2$  !  $\mathbb{N}_1$ . At large tan the  $\mathbb{N}_1$  nal state receives substantial enhancement from the  $\mathbb{H}_D$  component of  $\mathbb{N}_2$  coupling to  $\mathbb{P}_L$  via the large -Yukawa coupling, as discussed in the case of  $\mathbb{W}$  above. This means that for large tan , the production of  $\mathbb{W}^{+}$   $\mathbb{N}_2$  will give a signal of  $\mathbb{P}^{+}$  +  $\mathbb{P}_2$  nearly 100% of the time, while  $\mathbb{W}$   $\mathbb{W}$  production will bok the same with one fewer nal state -lepton.

In Figure 3 we have folded the branching ratios into the production cross-sections

to show the expected production rates for various sets of  $\ nal"$  states in the detector. Here we have de ned on-shell W , Z, and h<sup>0</sup> to be nal states; the reader can identify the observed nal states associated with production of these particles sim ply by multiplying by their well-known branching ratios. By keeping the gauge bosons in the nal state, one also learns about the invariant m asses of their decays products. Speci cally, Figure 3 displays the BR of nine nal states for  $M_2 = 200 \, \text{GeV}$  and varying tan . The two pairs of plots show the results for both signs of .

Figure 3 (a) shows the verm ost relevant channels at small tan and > 0 (all channels that follow include  $+\mathbb{F}_{?}$ ): ``(solid), W ``(dotted), W (short-dashed), W W (long-dashed), and W Z (dot-dashed). Figure 3 (c) is the same for < 0. Figure 3 (b) shows the four most relevant channels at large tan and > 0 (not including ``): (solid), (dotted), ``(short-dashed), and W (long-dashed). Figure 3 (d) shows the same vecurves for < 0. In all four plots, the shaded region is the portion of parameter space that would allow the decay  $\mathbb{N}_2$  !  $\mathbb{N}_1h^0$ .

From this analysis, it clearly emerges that if one is to interpret the CDF event to suggest BR (pp !  ${}^{e}_{R} {}^{e}_{R}$ )' (5 10) fb, then the MMM implies that there are several other channels which should also be accessible at the Tevatron. If tan < 5 or 10 (depending on sgn ), then the largest available channel is W `` (for `= e; ) with W decaying into 2 jets (2/3 of the tim e) or a single lepton (1/3 of the tim e): pp ! `` ` jj +E; orpp ! `` ` +E; . Second to this rate willbe W W +E; channels (with the usual W decay branching ratios) and W +E; . There is also a sm all window around 3 < tan < 5 and > 0 in which W Z +E; is an important nal state.

For large tan , production of all kinds dom inates. If tan > 5(10), then the Tevatron should be producing (n )X  $+ \mathbb{F}_{?}$  at rates comparable (or larger than)  $\approx + \mathbb{F}_{?}$ , for n = 1;2;3.

### 4 D iscussion

We have described a minimal in plementation of a low-energy messenger model for supersymmetry breaking. Outstanding features of the model include: generic production of nal states including and missing energy; clean separation of scales in the R-parity odd spectrum, with the squarks and gluinos much heavier than the electrow eak gauginos and sleptons; and very smallmixing of the SU (2) U (1) neutralinos with Higgsinos and with each other. Many species features are predicted in terms of very few parameters, so that the model could be rigorously tested, or eliminated, with quite a small amount of relevant data. If the CDF  $e^+e^-$  event represents a rst indication, such data is not far beyond current reach.

Of course in insisting upon the absolutely minimal model we may have overreached. We have shown that some apparent di culties with the minimal model are rem oved upon careful treatment of coupling renormalization and proper inclusion of D-term s. Nevertheless, one must remain open to such possibilities as di erent overall




Figure 3: Cross-section times branching ratio for M<sub>2</sub> = 200 GeV with tan varied along the x-axis. Both signs of are shown: (a) { (b) > 0, (c) { (d) < 0. The nine most relevant channels are displayed, divided between two sub gures for each sgn. The shading is in the region for which  $\mathbb{N}_2$  !  $\mathbb{N}_1h^0$  is allowed in the minimal model. See the text for a full description.

m ass scales for the sleptons as against the gauginos, or additional contributions to the param eters of the H iggs sector.

Finally let us brie y mention another possibility for physics capable of generating the CDF  $e^+e^-$  event, which if nothing else might serve as a useful foil. If there were heavy pion-like particles whose decay modes were dominantly ! W + and <sup>0</sup> ! ZZ or Z or , their production and decay could induce many of the same nal states as we have analyzed above, including the CDF event. The missing energy in this event would be carried o by neutrinos; but in other cases one might have without signi cant missing energy, so that this alternative will be readily distinguishable.
