SUSY-QCD corrections to scalar quark decays into charginos and neutralinos

Abstract

We calculate the supersymmetric QCD corrections to the decays $q_i \rightarrow q_j^0$ ($i, j = 1, 2$) and $q_i \rightarrow q_k^0$ ($k = 1, \dots, 4$) within the Minimal Supersymmetric Standard Model. In particular we consider the decays of squarks of the third generation, t_i and b_i ($i = 1, 2$), where the left/right mixing must be taken into account. The corrections turn out to be of about 10%, except for higgsino-like charginos or neutralinos, where they can go up to 40%.

1 Introduction

In supersymmetry (SUSY) [1] every quark has two scalar partners, the squarks q_L and q_R . Quite generally, q_L and q_R mix giving the mass eigenstates q_1 and q_2 (with $m_{q_1} < m_{q_2}$). Whereas the mixing can be neglected for the partners of the light quarks, it can be important for the third generation due to the Yukawa coupling which is proportional to m_t or m_b [2].

In the case that the gluino is heavier than the squarks, the squarks have the decay modes $q_{1,2} \rightarrow q^0 \tilde{\chi}_j^0$ ($j = 1, 2$), and $q_{1,2} \rightarrow q \tilde{\chi}_k^0$ ($k = 1, \dots, 4$), where $\tilde{\chi}_j^0$ and $\tilde{\chi}_k^0$ denote the charginos and neutralinos, respectively. These decays were discussed so far only on the basis of tree-level calculations, for the partners of the light quarks in ref. [3] and with inclusion of the third generation ($t_i, b_i, i = 1, 2$) in ref. [4]. A detailed study of the t_i and b_i decays can be found in [5, 6].

Here we calculate the $O(\alpha_s)$ QCD corrections (including the exchange of SUSY particles) to these decays within the Minimal Supersymmetric Standard Model (MSSM). In particular, we do not neglect the masses of quarks and take into account q_L - q_R mixing, so that the formulae are also applicable to the decays $t_i \rightarrow b_j^+ \tilde{\chi}_j^0$, $t_i \rightarrow t_j^0 \tilde{\chi}_j^0$, and $b_i \rightarrow t_j^- \tilde{\chi}_j^0$, $b_i \rightarrow b_j^0 \tilde{\chi}_j^0$. We work in the on-shell renormalization scheme. For the renormalization of the squark mixing angle we use the scheme introduced in [7], where we applied it to the case of $e^+ e^- \rightarrow q \bar{q}$. We also give a numerical analysis of the QCD corrections to the decays $t_i \rightarrow b_j^0 \tilde{\chi}_j^0$ and $t_i \rightarrow t_k^0 \tilde{\chi}_k^0$.

For the decays of a squark into a light quark ($m_q = 0$) and a photino the SUSY-QCD corrections were already calculated in [8]. The QCD corrections to the decay $t \rightarrow t \tilde{\chi}_k^0$ have been computed very recently within the MSSM in ref. [9]. The SUSY-QCD corrections to the strong decays $q \rightarrow q g$ were calculated in ref. [10].

2 Tree level formulae

The squarks q_L and q_R are related to the mass eigenstates q_1 and q_2 by:

Their interaction with charginos \tilde{q}_j ($j = 1, 2$) and neutralinos $\tilde{\chi}_k^0$ ($k = 1, \dots, 4$) is given by [5]:

q , t , b , \tilde{q}_j^+ , and $\tilde{\chi}_k^0$ denote the four component spinors of the corresponding particles. The respective decay widths at tree level are

where $(x; y; z) = x^2 + y^2 + z^2 - 2xy - 2xz - 2yz$ and

The $\tilde{q}_j - \tilde{q}_j^0 - \tilde{q}_j$ couplings \tilde{a}_{ij}^q and k_{ij}^q are

The $\tilde{q}_j - \tilde{q}_j^0 - \tilde{\chi}_k^0$ couplings a_{ik}^q and b_{ik}^q are given by

$$h_{Rk}^b = Y_b (N_{k3} \cos N_{k4} \sin); \quad f_{Rk}^b = \frac{p}{3} \sin w (\tan w N_{k2} - N_{k1});$$

N_{ij} is the 4×4 unitary matrix diagonalizing the neutral gaugino{higgsino mass matrix in the basis $\sim, Z^0, H_1^0 \cos \theta_W, H_2^0 \sin \theta_W + H_1^0 \cos \phi_W, H_2^0 \sin \phi_W$ [1, 11]. U_{ij} and V_{ij} are the 2×2 unitary matrices diagonalizing the charged gaugino{higgsino mass matrix [1, 12]. Assuming CP conservation, we choose a phase convention in which N_{ij}, U_{ij} , and V_{ij} are real. Y_f denotes the Yukawa coupling,

3 SUSY {QCD corrections

The $O(s)$ SUSY-QCD corrected decay width can be decomposed in the following way:

$$= \text{bare} + \text{(v)} + \text{(w)} + \text{(c)} + g_{\text{real}}; \quad (13)$$

The superscript v denotes the vertex correction (Figs. 1b, c), w the wave function correction (Figs. 1d-h), and c the shift from the bare to the on-shell couplings. g_{real} is the correction due to real gluon emission (Figs. 1i, 1j) which has to be included in order to achieve infrared finiteness. According to eq. (3) $\text{(a)} (a = v, w, c)$ can be written as

with X as defined in eq. (5). An analogous expression holds for $\text{(a)} (\tilde{q}_i ! \tilde{q}_k^0)$ by replacing $\tilde{q}_j ! \tilde{q}_k^0, \tilde{q}_k ! \tilde{q}_j, X ! X^0, \tilde{q}_{ij} ! a_{ik}^{\tilde{q}}, k_{ij}^{\tilde{q}} ! b_{ik}^{\tilde{q}}, \tilde{q}_{ij}^{(a)} ! a_{ik}^{\tilde{q}(a)},$ and $k_{ij}^{\tilde{q}(a)} ! b_{ik}^{\tilde{q}(a)}$. $\tilde{q}_{ij}^{(a)}, k_{ij}^{\tilde{q}(a)}$, etc. get contributions from gluon exchange, gluino exchange, and the four-squark interaction. As we will see, in the renormalization scheme used the four-squark interaction contribution turns out to be zero.

In what follows we will take the squark decays into charginos as example. For the decays $\tilde{q}_i ! \tilde{q}_k^0$ one has to make the replacements just mentioned before.

3.1 Vertex corrections

The gluonic vertex correction (Fig. 1b) yields

$$\begin{aligned} \mathbf{k}_{ij}^{(vg)} &= \frac{s}{3}^n [(4m_{q^0}^2 + 2X)(C_0 + C_1 + C_2) + (2m_{\tilde{q}}^2 + X)C_1 + B_0] \mathbf{k}_{ij}^{q^0} \\ &\quad + [2m_{q^0} m_{\tilde{q}} C_2] \mathbf{k}_{ij}^{q^0}; \end{aligned} \quad (16)$$

B_0 , C_0 , C_1 , and C_2 are the standard two- and three-point functions [13]. In this case, $B_0 = B_0(m_{\tilde{q}}^2; m_{q^0}^2; m_{q^0}^2)$ and $C_m = C_m(m_{q^0}^2; m_{\tilde{q}}^2; m_{q^0}^2; m_{q^0}^2; m_{\tilde{q}}^2)$, where we follow the conventions of [14]. As usually, we introduce a gluon mass for the regularization of infrared divergencies.

The contribution to the vertex correction due to the graph shown in Fig. 1c with a gluino and a squark \tilde{q}_n^0 ($n = 1, 2$) in the loop is:

$$\begin{aligned} \mathbf{q}_{ij}^{(vsg)} &= \frac{2}{3}^n m_{\tilde{q}} [(m_{q^0 LR} + m_{q RL} - m_{q LL}) \mathbf{k}_{nj}^{q^0} + m_{\tilde{q}} m_{RL} \mathbf{k}_{nj}^{q^0}] C_1 \\ &\quad + m_{q^0} [(m_{q^0 RL} - m_{q LR} + m_{q RR}) \mathbf{k}_{nj}^{q^0} - m_{\tilde{q}} m_{LR} \mathbf{k}_{nj}^{q^0}] (C_1 + C_2) \\ &\quad + m_{\tilde{q}} [(m_{q^0 RR} - m_{q LL} + m_{q RL}) \mathbf{k}_{nj}^{q^0} - m_{\tilde{q}} m_{LL} \mathbf{k}_{nj}^{q^0}] C_0 + (X C_1 + B_0) m_{RL} \mathbf{k}_{nj}^{q^0}; \end{aligned} \quad (17)$$

$$\begin{aligned} \mathbf{k}_{ij}^{(vsg)} &= \frac{2}{3}^n m_{\tilde{q}} [(m_{q^0 RL} + m_{q LR} - m_{q RR}) \mathbf{k}_{nj}^{q^0} + m_{\tilde{q}} m_{LR} \mathbf{k}_{nj}^{q^0}] C_1 \\ &\quad + m_{q^0} [(m_{q^0 LR} - m_{q RL} + m_{q LL}) \mathbf{k}_{nj}^{q^0} - m_{\tilde{q}} m_{RL} \mathbf{k}_{nj}^{q^0}] (C_1 + C_2) \\ &\quad + m_{\tilde{q}} [(m_{q^0 LL} - m_{q RR} + m_{q LR}) \mathbf{k}_{nj}^{q^0} - m_{\tilde{q}} m_{RR} \mathbf{k}_{nj}^{q^0}] C_0 + (X C_1 + B_0) m_{LR} \mathbf{k}_{nj}^{q^0}; \end{aligned} \quad (18)$$

with

Here, $B_0 = B_0(m_{\tilde{q}}^2; m_{q^0}^2; m_{q^0}^2)$, and $C_m = C_m(m_{q^0}^2; m_{\tilde{q}}^2; m_{q^0}^2; m_{q^0}^2; m_{\tilde{q}}^2; m_{q^0}^2; m_{q^0}^2)$.

3.2 Wavefunction correction

The wavefunction correction is given by

$Z_{q^0}^{Ly}$ and $Z_{q^0}^{Ry}$ are the quark wavefunction renormalization constants due to gluon exchange (Fig. 1d),

with $B_m = B_m(m_{q^0}^2; m_{q^0}^2; m_{q^0}^2)$, $B_{\bar{m}} = B_{\bar{m}}(m_{q^0}^2; m_{q^0}^2; m_{q^0}^2)$, and due to gluino exchange (Fig. 1e),

$$Z_{q^0}^{Ry(g)} = \frac{2-s}{3} \sin^2 q^0 B_1 + \cos^2 q^0 B_1 + m_{q^0}^2 B_1^2 + B_1^2 + \frac{m_g}{m_{q^0}} \sin 2 q^0 (B_0^1 - B_0^2); \quad (24)$$

where $B_m^i = B_m(m_{q^0}^2; m_g^2; m_{q_i^0}^2)$ and $B_{\bar{m}}^i = B_{\bar{m}}(m_{q^0}^2; m_g^2; m_{q_i^0}^2)$. The parameter r in eq. (22) and eq. (32) exhibits the dependence on the regularization. As r does not cancel in the final result we have to use the dimensional reduction scheme [15] ($r=0$) which preserves supersymmetry at least at one-loop order.

The squark wavefunction renormalization constants Z_{in} stem from gluon, gluino, and squark loops according to Figs. 1f - 1h. They are given by:

with $-ii(m^2) = @_{ii}(p^2) = @p^2 |_{p^2=m^2}$. The squark self-energy contribution due to gluon exchange (Fig. 1f) is

$$\begin{aligned} -ii^{(g)} (m_{q_i}^2) = & \frac{s}{3} n [3B_0(m_{q_i}^2; 0; m_{q_i}^2) + 2B_1(m_{q_i}^2; 0; m_{q_i}^2) \\ & + 4m_{q_i}^2 B_0(m_{q_i}^2; 2; m_{q_i}^2) + 2m_{q_i}^2 B_1(m_{q_i}^2; 0; m_{q_i}^2)]; \end{aligned}$$

and that due to gluino exchange (Fig. 1g) is

$$\begin{aligned} -ii^{(g)} (m_{q_i}^2) = & \frac{2-s}{3} B_0(m_{q_i}^2; m_g^2; m_q^2) + (m_{q_i}^2 - m_q^2 - m_g^2) B_0(m_{q_i}^2; m_g^2; m_q^2) \\ & 2m_{q_i} m_g (-1)^i \sin 2 q^0 B_0(m_{q_i}^2; m_g^2; m_q^2); \end{aligned} \quad (26)$$

$${}_{12}^{(g)}(m_{q_1}^2) = {}_{21}^{(g)}(m_{q_1}^2) = \frac{4}{3} \frac{s}{h} m_g m_q \cos 2 \theta_B (m_{q_1}^2; m_g^2; m_q^2); \quad (27)$$

The four-squark interaction (Fig. 1h) gives

where $A_0(p^2)$ is the standard one-point function in the convention of [14]. Note that $\frac{(q)}{ii^0}(p^2)$ is independent of p^2 and hence $\frac{(q)}{ii^0}(m_{q_1}^2) = \frac{(q)}{ii^0}(m_{q_2}^2) = \frac{(q)}{ii^0}$.

3.3 Renormalization of the bare couplings

In order to make the shift from the bare to the on-shell couplings it is necessary to renormalize the quark mass as well as the squark mixing angle:

where

$O_{j2}^t = V_{j2}(\frac{p}{2} m_w \sin \theta) m_t$, $O_{j2}^b = U_{j2}(\frac{p}{2} m_w \cos \theta) m_b$, and analogously for h_{Rk}^q and h_{Lk}^q according to eqs. (10) – (12). The gluon contribution to m_q is

$$m_q^{(g)} = \frac{2}{3} \frac{s}{h} m_q [B_0 - B_1] \quad r=2]; \quad B_m = B_m(m_q^2; 0; m_q^2); \quad (32)$$

and the gluino contribution is

$$m_q^{(g)} = \frac{s}{3} \frac{h}{m_{q_1}^2} m_q (B_1^1 + B_1^2) + m_g \sin 2 \theta_B (B_0^1 - B_0^2) \frac{i}{B_m}; \quad B_m = B_m(m_q^2; m_g^2; m_{q_1}^2); \quad (33)$$

For the renormalization of the squark mixing angle we use the scheme introduced in [7]:

$$\frac{(q)}{q} = \frac{s}{6} \frac{\sin 4 \theta_B}{m_{q_1}^2} \frac{h}{m_{q_2}^2} A_0(m_{q_2}^2) \frac{i}{A_0(m_{q_1}^2)}; \quad (34)$$

$$\frac{(q)}{q} = \frac{s}{3} \frac{m_g m_q}{I_q^{3L}(m_{q_1}^2; m_{q_2}^2)} \frac{h}{B_0(m_{q_2}^2; m_g^2; m_q^2)} v_{11} \frac{i}{B_0(m_{q_1}^2; m_g^2; m_q^2)} v_{22}; \quad (35)$$

with v_{ih} the Z quark couplings, $v_{11} = 4(I_q^{3L} \cos^2 q - \frac{2}{3} e_q)$ and $v_{22} = 4(I_q^{3L} \sin^2 q - \frac{2}{3} e_q)$. Here I_q^{3L} is the third component of the weak isospin and e_q the charge of the quark q .





Fig. 1: Feynman diagrams relevant for the $O(s)$ SUSY-QCD corrections to squark decays into charginos and neutralinos: (a) tree level, (b) gluon vertex correction, (c) gluino vertex correction, (d) and (e) quark wavefunction renormalization, (f) and (g) squark wavefunction renormalization, (h) four-squark interaction, and (i) and (j) realgluon emission.

With this choice of q the squark contribution to the correction is zero: $(w_{\text{sq}}) + (c_{\text{sq}}) = 0$. Moreover, the off-diagonal contribution ($i \neq h$) of Fig. 1g vanishes in this scheme. We checked analytically that the resulting SUSY-QCD corrected decay width is ultraviolet finite.

3.4 Real gluon emission

The $O(s)$ contribution from real gluon emission, as shown in Figs. 1i and 1j, gives the decay width of $\tilde{q}_i ! g q^0 \sim_j$:

where $Z = [(k_{ij}^q)^2 + (\tilde{k}_{ij}^q)^2]X - 4 k_{ij}^q \tilde{k}_{ij}^q m_{\tilde{q}_i} m_{\sim_j}$. The phase space integrals I , I_h , I_{nm} , and I_n^m have $(m_{\tilde{q}_i}; m_{q^0}; m_{\sim_j})$ as arguments and are given in [14]. An analogous expression holds for the $\tilde{q}_i ! g q^0 \sim_k$ decay width.

4 Numerical results and discussion

We now turn to the numerical analysis of the $O(s)$ SUSY-QCD corrected decay widths. As examples we consider the decays $\tilde{t}_1 ! b \sim_1^+$ and $\tilde{t}_1 ! t \sim_1^0$. Masses and couplings of the charginos and neutralinos depend on the parameters M_χ , M^0 , $\tan\beta$, and $\tan\alpha$. The squark sector is determined by the soft-breaking parameters M_Q , M_U , and M_D , the trilinear couplings A_t and A_b , and $\tan\beta$ and $\tan\alpha$, which all enter the squark mass matrices. For the following analysis we use physical squark masses and mixing angles as input parameters. We take $m_t = 180$ GeV, $m_b = 5$ GeV, $m_Z = 91.187$ GeV, $\sin^2 w = 0.23$, $w(m_Z) = 1=128.87$, and $s(m_Z) = 0.12$. Moreover, we use the GUT relations $M^0 = \frac{5}{3}M \tan^2 w - 0.5M$ and $m_{\tilde{q}} = \frac{-s}{2}M - 3M$. Furthermore, we use $s(Q^2) = 4 = (b_0 x) [1 - 2b_0 \ln x/(b_0^2 x)]$ with $b_0 = 11 - 2=3n_f$, $b_1 = 51 - 19=3n_f$, and $x = \ln(Q^2 = 2)$ [16]. Here, n_f is the number of flavours.

For discussing the $\tilde{t}_1 \rightarrow b \tilde{\chi}_1^+$ decay mode we take $m_{\tilde{\chi}_1^0} = 75$ GeV, $m_{\tilde{t}_2} = 300$ GeV, $m_{\tilde{b}_1} = 220$ GeV, $m_{\tilde{b}_2} = 230$ GeV, $\cos \beta = 0.4$, and $\tan \alpha = 2$. In order to study the dependence on the nature of the chargino (gaugino-like or higgsino-like), we choose three sets of M and β values: $M_{\tilde{t}} = j + M = 66$ GeV, $= 500$ GeV, $M_{\tilde{b}} = j + M = 70$ GeV, $= 61$ GeV, and $M_{\tilde{b}} = j + M = 300$ GeV, $= 62$ GeV). In Fig. 2 we show the dependence of the QCD corrections on the \tilde{t}_1 mass (in % of the tree-level decay width) in the range of $m_{\tilde{t}_1} = 80$ GeV (LEP 2, Tevatron) to $m_{\tilde{t}_1} = 220$ GeV (LHC, e^+e^- linear collider). Here, we take $\cos \tau = 0.72$ which corresponds to $M_Q = M_U$. If the $\tilde{\chi}_1^+$ is gaugino-like (solid line) the correction is about 10% to 20% for a light \tilde{t}_1 ($m_{\tilde{t}_1} < 100$ GeV) and decreases with the stop mass. In the case of $M_{\tilde{t}} = j + M$ (dashed line) the correction lies between +10% and -10%. Due to the large top Yukawa coupling the biggest effect is found for a higgsino-like $\tilde{\chi}_1^+$ (dash-dotted line). Here, the correction lies in the range of -10% to -20%.


Fig. 3: Tree-level (dashed lines) and SUSY-QCD corrected (solid lines) widths of the decay $\tilde{t}_1 \rightarrow b \tilde{\tau}_1^+$ in GeV as a function of $\cos \theta_t$ for $m_{\tilde{\chi}_1^0} = 75$ GeV, $m_{\tilde{t}_1} = 150$ GeV, $m_{\tilde{\chi}_2^0} = 300$ GeV, $m_{\tilde{b}_1} = 220$ GeV, $m_{\tilde{b}_2} = 230$ GeV, $\cos \beta_b = 0.4$, $\tan \beta = 2$. Three scenarios are studied: (a) $M = 66$ GeV, $= 500$ GeV, (b) $M = 70$ GeV, $= 61$ GeV, and (c) $M = 300$ GeV, $= 62$ GeV.

The $\cos \tau$ dependence is shown in Fig. 3 where we plot the O (s) corrected decay widths (solid lines) together with the tree-level widths (dashed lines) as a function of $\cos \tau$ for $m_{\tilde{t}_1} = 150$ GeV and the other parameters as given above. The widths show the characteristic dependence on the stop mixing angle: If $\tilde{t}_1 \equiv \tilde{t}_R$ ($\cos \tau = 0$) it strongly couples to the higgsino component of $\tilde{\chi}_1^+$, whereas for $\tilde{t}_1 \equiv \tilde{t}_L$ ($\cos \tau = 1$) it strongly couples to the gaugino component. Again, a striking effect can be seen for $j + M$. However, also for $M_{\tilde{t}} = j + M$ and $M_{\tilde{b}} = j + M$ the correction can be larger than 10%, especially if the tree-level decay width is very small.

We have also studied the dependence on the masses and the mixing angle of the exchanged sbottom (Fig. 1c). In the cases studied these effects turn out to be small. The dependence on the gluino mass is more complex: On the one hand, the gluino mass enters in the propagator of the graphs in Figs. 1c, 1e, and 1g. On the other hand, the mass and the couplings of $\tilde{\chi}_1^+$ in the final state also depend on m_g via the relation $M_{\tilde{t}} = 0.3m_g$. However, if one relaxes this relation keeping M fixed and varying m_g the correction increases with the gluino mass. This has also been noticed in refs. [8, 9].

For the decay of \tilde{t}_1 into $t \tilde{\chi}_1^0$ we take $m_{\tilde{\chi}_1^0} = 50$ GeV, $m_{\tilde{t}_2} = 400$ GeV, $m_{\tilde{b}_1} = 320$ GeV, $m_{\tilde{b}_2} = 340$ GeV, $\cos \beta = 0.4$, and $\tan \alpha = 2$. Again, we choose scenarios with a gaugino-like $\tilde{\chi}_1^0$ ($M_{\tilde{t}} = 98$ GeV, $= 500$ GeV) and a higgsino-like $\tilde{\chi}_1^0$ ($M_{\tilde{t}} = 250$ GeV, $= 55$ GeV), as

well as one where $M_{\tilde{t} \tilde{t}} = 93 \text{ GeV}$, $= 90 \text{ GeV}$). We show in Fig. 4 the dependence of the SUSY-QCD correction (in % of the tree-level width) on the \tilde{t}_1 mass in the range of $m_{\tilde{t}_1} = 230$ to 400 GeV , for $\cos \tau = 0.72$. As in the case of the $\tilde{t}_1 \rightarrow b \tilde{\chi}_1^+$ decay, the decay width gets the biggest correction if $\tilde{\chi}_1^0$ is higgsino-like: It is between -15% and -20% and decreases with increasing \tilde{t}_1 mass. For $M_{\tilde{t} \tilde{t}} = 90 \text{ GeV}$ the correction lies between +8% and 5% (-3%).


Fig. 5: Tree-level (dashed lines) and SUSY-QCD corrected (solid lines) widths of the decay $\tilde{t}_1 \rightarrow t \tilde{\tau}_1^0$ in GeV as a function of $\cos \theta_t$ for $m_{\tilde{\chi}_1^0} = 51$ GeV, $m_{\tilde{t}_1} = 260$ GeV, $m_{\tilde{\chi}_2^0} = 500$ GeV, $m_{\tilde{b}_1} = 320$ GeV, $m_{\tilde{b}_2} = 340$ GeV, $\cos \beta_b = 0.4$, $\tan \beta = 2$. Three scenarios are studied: (a) $M = 98$ GeV, $= 500$ GeV, (b) $M = 93$ GeV, $= 90$ GeV, and (c) $M = 250$ GeV, $= 55$ GeV.

The dependence of the tree-level (dashed lines) and the QCD corrected (solid lines) decay widths of $\tilde{t}_1 \rightarrow t \tilde{\chi}_1^0$ on the stop mixing angle is shown in Fig. 5 for $m_{\tilde{t}_1} = 260 \text{ GeV}$ and the other parameters as given in Fig. 4. Again there is a strong dependence on the nature of the lightest neutralino. The corrections are large for a higgsino-like neutralino.

Summarizing, we have computed the O(α_s) SUSY-QCD corrections to the decays of squarks into charginos and neutralinos. We have concentrated on the third generation squarks, where the quark masses cannot be neglected, and the left-right mixing plays an essential rôle. The corrections strongly depend on the nature of the charginos or neutralinos. They are about 10%, but go up to 40% for higgsino-like charginos/neutralinos.
















