Ferm ion Virtual E ects in e^+e ! W + W C ross Section 1

A bstract

We analyse the contribution of new heavy virtual ferm ions to the e^+e^- ! W $^+$ W cross section. We not that there exists a relevant interplay between trilinear and bilinear oblique corrections. The result strongly depends on the chiral or vector{like nature of the new ferm ions. As for the chiral case we consider sequential ferm ions: one obtains substantial deviation from the Standard model prediction, making the e ect possibly detectable at $^{\rm P}$ = 500 or 1000 G eV linear colliders. As an example for the vector{like case we take a SUSY extension with heavy charginos and neutralinos: due to cancellation, the nale ect turns out to be negligible.

We present here a study of virtual elects from new physics in the cross{section for e^+e^- ! W ^+W . This analysis has been motivated by the following questions. What room is left for deviations with respect to the SM predictions, once the constraints coming from the LEP1 results have been properly accounted for? A rethese deviations entirely due to the appearance of anomalous trilinear vector{boson couplings, as generally assumed? Is there any role played by the so{called oblique corrections?

To deal with these questions we have focused on two simple SM extensions:

Model 1: the SM plus heavy chiral fermions. In particular we consider an extra doublet of heavy quarks, exact replica of the SM counterparts, as far as their electroweak and strong quantum numbers are concerned;

Model 2: the SM plus heavy vector{like ferm ions. As an example we take the Minimal Supersymmetric Standard Model (MSSM) with heavy (above the production threshold) electroweak gauginos and higgsinos, and very heavy (decoupled) squarks, sleptons and additional higgses.

In both models the one { loop corrections to the process in question are concentrated in vector { bosons self { energies and three { point functions, which makes it possible to analyse the interplay between the two contributions [1]. Box corrections are obviously absent in the rst model, while they are negligibly small in the second case, provided that the scalar masses are su ciently large. Then the only relevant contributions remain those of gauginos and higgsinos to vertices and self { energies.

The constraints coming from LEP1 results are quite dierent in the two models. A mass splitting between the two new quarks, whose left{handed components are partners of a common SU $(2)_L$ doublet, results in a potentially large contribution to the $_1$ parameter. To avoid disagreement with the experimental result [2], we will consider the case of degenerate quarks (a detailed discussion concerning this point is provided in [3]). A more stringent limitation comes from the $_3$ variable, which depends mildly on the quark masses. Each new degenerate quark doublet contributes to $_3$ with the positive amount

For m $_{\rm t}$ = 175 G eV and m $_{\rm H}$ = 100 G eV, a single new coloured doublet (with the possible addition of a lepton doublet) saturates the present 2 upper bound on $_{\rm 3}$, and additional chiral doublets beyond the multiplet considered here are experimentally ruled out.

On the contrary, the version of the M SSM here analysed easily respects the constraints from LEP1. Indeed contributions to the variables come in inverse power of the gaugino and higgsino m asses and they turn out to be num erically quite small, within the experimental bound. For practical purposes we have considered the case of degenerate electroweak gauginos of mass M and degenerate higgsinos of mass. This is the case when the mixing terms among gauginos and higgsinos are much smaller compared to the SUSY breaking gaugino mass term M and the supersymmetric contribution coming from the H $_1$ H $_2$ term in the superpotential.

A fter the inclusion of the one{loop corrections due to the new particles and of the appropriate counterterms, the reduced amplitude for the process at hand reads, following

the conventions of ref. [5]:

In eq. (3) = $(1 + 4m_W^2 = s)^{1-2}$, is the scattering angle of W with respect to e in the e⁺ e cm. fram e; , , are the helicities for e , e⁺, W and W ⁺, respectively; = ;A ,A^Z,B and C are tree{level SM coe cients listed in Table 1; (s), k(s), (s), r w and e₆ are nite self(energy corrections [4,7], given in the Appendix where also the elective weak angle is de ned. Finally, A and A^Z represent the corrections to the trilinear gauge boson vertices. For the models considered, they can be expressed in terms of the CP (invariant form factors f_i^{Z} (i = 1;2;3;5) according to the relations:

Here f_i^V includes both the contribution coming from the 1PI one{loop correction to the vertex VWW and the wave{function renormalization of the external Welgs, taken on the mass{shell. This makes the terms f_i^V nite. Other choices in the renormalization conditions are equivalent (see for example [6]).

Some comments are in order. The tree{level SM amplitudes are recovered from the above formulae by taking (s) = k(s) = (s) = r $_{\rm W}$ = e₆ = A = A² = 0. In the high{energy limit, the individual SM amplitudes from photon, Z and exchange are proportional to when one W is longitudinal and the other is transverse (LL) and proportional to when one W is longitudinal and the other is transverse (LL). The cancellation of the ² and terms in the overall amplitude is guaranteed by the tree{level, asymptotic relation A = A² = B . When one{loop contributions are included, one has new terms proportional to ² and (see A and A² in eq. (4)) and the cancellation of those terms in the high{energy limit entails relations among oblique and vertex corrections. We have explicitly checked that in all cases considered, this cancellation does take place. We stress that om itting, for instance, the gauge boson self{energies such cancellation does not occur any longer and the resulting amplitudes violate the requirement of perturbative unitarity.

On the other hand, one of the possibilities one can think of to have appreciable deviations in the cross{section is to delay the behaviour required by unitarity [6]. This may happen if in the energy window m $_{\rm W}$ << $^{\rm p}$ $^{\rm p}$ $^{\rm s}$ 2M (M denoting the mass of the new particles) the above cancellation is less e cient and terms proportional to positive power of survive in the total amplitude. If is su ciently large, then a sizeable deviation from the SM prediction is not unconceivable.

We now come to the quantitative discussion.

Model1: Chiral ferm ions.

In g. 1 we plot N, the number of W $^+$ W events per bin, versus at p \bar{s} = 500 G eV in the channel LL, taking M = 300 G eV and assuming a luminosity of 20 fb 1 . The error bars refer to the statistical error, the full line denotes the SM expectation at tree level, while the dashed line gives the prediction for model 1. We notice a clear indication of a signicant signal, fully consistent with present experimental bounds. The departure from the SM prediction [8] becomes even more conspicuous for larger p \bar{s} . In g2 we report the result for p \bar{s} = 1000 G eV, M = 600 G eV and a luminosity of 100 fb 1 .

that represents the deviation between the SM and new physics dierential cross{section normalized to the SM . For cos not close to 1, and in the lim it m $_{\rm W}$ << M ; s we have derived the following analytical expression for R $_{\rm LL}$:

 $^{^1}$ SM corrections shift both curves in $\,$ g. 1 by the same amount. Hence, although they change the number N , they do not a $\,$ ect our result concerning the size of the deviation due to the presence of new physics.




Figure 1: Number of W $^+$ W events per bin versus cos at p $\overline{s} = 500$ G eV in the LL channel, taking M = 300 G eV and assuming a luminosity of 20 fb 1 .

For s >> M 2 , F grows only logarithm ically and unitarity is respected. When M 2 >> s, F $^\prime$ s=12M 2 and the decoupling property is violated, as one expects in the case of heavy chiral ferm ions. In the range of energies we are interested in, m $_{\rm W}$ << $^{\rm P}$ s $^{\rm 2}$ M $_{\rm C}$ K is of order G $_{\rm F}$ M 2 , which explains the magnitude of the elect exhibited in g. 1 and 2. A similar behaviour is also exhibited by the T L channel. Indeed, the absolute deviation in the T L channel is of O (), but an additional factor comes from the SM cross section in the denominator of R. In g. 3 we depict the quantity R as a function of cos for L L channel and for the unpolarized cross section at $^{\rm P}$ s = 500 G eV . Notice that the elect which is so large in the L L channel for all the angles essentially disappears in the unpolarized cross section for cos $^\prime$ 1 where bigger is the number of events expected. This makes it clear that for the observation of the elect under discussion good identication of the W polarization and large luminosity are essential.

Model 2: Vector { like ferm ions.

In this case the deviations at $\overline{s} = 500 \text{ GeV}$ or even higher energies reach at most a few permille making it questionable to have a chance at all to observe the e ect [9]. The analytic expressions for R both in the LL and in the TL channel, in the limit $m_{W} << M$; \overline{s} , are vanishing, showing that in the case of gauginos or higgsinos, which




Figure 2: Number of W $^+$ W events per bin versus \cos at $^p \bar{s} = 1000$ G eV in the LL channel, taking M = 600 G eV and assuming a luminosity of 100 fb 1 .

have vector{like coupling, no unitarity delay takes place. This is in agreement with the decoupling theorem [10].

To exemplify the danger of including in the cross{section only the contribution of trilinear anom alous gauge couplings, we have computed the R $_{\rm LL}$ ratio at $^{\rm P}$ $\bar{\rm s}=500\,{\rm G\,eV}$, for model 2, M $=300\,{\rm G\,eV}$ and >> M , by leaving out the contribution from the vector boson self{energies}. Due to the improvident om ission of an essential part of the one{loop correction, one gets an irrealistic R $_{\rm LL}$ ' 02, with failure of unitarity when higher energies are considered.

Appendix

The quantities (s), k(s), r w and e_6 appearing in eqs. (2) and (3) are de ned by the following relations in terms of the unrenormalized vector-boson vacuum polarizations:




Figure 3: Relative deviation R versus \cos in the LL polarization channel and for the unpolarized \cos section (tot) at $s = (500 \text{ GeV})^2$ and M = 300;600;1000 GeV for model 1.

and m = m $_{\rm Z}$ = 0, m $_{\rm Z\,Z}$ = m $_{\rm Z}$ and m $_{\rm W\,W}$ = m $_{\rm W}$. If s = m $_{\rm Z}^2$ then (s), k(s), coincides with the corrections , k, which characterize the electroweak observables

at the Z resonance. Finally, the e ective weak angle is de ned by:

where (s) is the electrom agnetic coupling with all the e ects coming from SM particles included at the given energy s.
