R egularization at the next-to-leading order in the top-m ode standard model without gauge bosons

A bstract

We study Higgs condensation H tt in the top-mode standard model at the next-to-leading (NTL) order in 1=N $_{
m c}$, by calculating the e ective potential as a function of a hard m ass term $_{
m 0}$ of the top quark. We include the e ects of the third generation quarks, the Higgs and the Goldstone elds, and the leading QCD exects, but not the exects of the transverse components of the electroweak gauge bosons. The resulting elective theory contains in ite energy outo parameters ($_{
m f\prime}$ $_{
m b}$) for the ferm ionic and the bosonic degrees of freedom. Condensation is supposed to take place at energies b. The paper describes how to regularize the integrals over the ferm ionic m om enta in a way free of momentum branching ambiguities and how to treat the term sof 1=Nc expansion mutually consistently. This is achieved by the proper time approach, employing speci cally the proper time cuto (PTC) or a Pauli-Villars (PV) regulator. For comparison, we use also the covariant spherical (S) cuto . On the other hand, for the bosonic m om enta we have to use the covariant spherical cuto . We discuss how to ensure the validity of Goldstone theorem. Dem anding that the NTL contributions not \wash out" the leading ones, we obtain rather low bounds for the cuto s: = 0 (1TeV). The results for the corresponding cases with PTC, PV and S regularization di er only marginally. Thus, in the described fram ework, $1=N_C$ expansion approach has a predictive power only if = 0 (1TeV), a result largely independent of the regularization procedure.

1 Introduction

Higgs meson could be a bound state of heavy quark pairs [1]-[16] (and references therein). This idea originates from an earlier work of Nambu and Jona-Lasinio (NJL) [17] where it was applied to low energy QCD, and independently from Vaks and Larkin [18]. The bound states (condensates) are treated in these works either in the leading-N_C approximation, or in a form that takes into account part of the elects beyond the leading-N_C (by using improved Schwinger-Dyson equations, or renormalization group equations (RGEs). A particularly straightforward NJL-type framework, containing the essential features of the idea of the condensation, is the top-mode standard model (TSM) Lagrangian, in its simplied form known also as the BHL (Bardeen-Hill-Lindner) Lagrangian [4].

In recent works, we studied the next-to-leading order (NTL) contributions in 1=N $_{\rm C}$ expansion in TSM by including quadratic uctuations of the composite Higgs H $_{\rm C}$ tt [19], as well as those of the composite Goldstones [20] in the elective potential $V_{\rm C}$. We were using for the fermionic (quark) and the bosonic momenta the simple covariant spherical cutos $f_{\rm C}$. These two cutos are indicative of the energy at which the condensation is supposed to occur: $f_{\rm D}$. QCD elects were included, but their impact was found to be small. We considered the elective potential as a function of a hard bare mass term $f_{\rm C}$ of the top quark, i.e., the expectation value $f_{\rm C}$ of a composite (initially auxiliary) Higgs eld $f_{\rm C}$ High elementary, that the 1=N $f_{\rm C}$ expansion approach in this framework have predictive power. In the present work, we continue the work of Refs. [19]-[20]. We concentrate on various regularization procedures and the dependence of the mentioned results on these procedures. The reasons for this are at least two:

Firstly, objections may be raised against the results of [19], [20], on the grounds that they may be largely the consequence of our choosing only one specic regularization { the simple covariant spherical cuto, and that other regularizations may give substantially dierent results.

Secondly, theoretical objections had been raised in the past against using simple covariant spherical cutos for the quark momenta [21], particularly because of the momentum branching ambiguity which has its origin in the translational noninvariance of the procedure.

One possibility to remedy this problem is to use dispersion relations (DR) with nite cuto for the bubble-chain-corrected scalar propagators { this method was applied by the authors of Refs. [17]

and [22] at the leading-N $_{\rm C}$ order. The leading-N $_{\rm C}$ gap equation, determ ining the relationship between the four-ferm ion coupling, the dynam ical quark mass and the cuto—is then obtained by requiring that the pole of the Goldstone propagator be located at the zero momentum. However, when we want to include the NTL corrections to the gap equation with the method of the elective potential, it is unclear how to relate the DR cuto—appearing in the NTL part V $^{(1)}$ of the elective potential (containing as integrands the logarithms of the bubble-chain-corrected scalar propagators) and the cuto—in the leading-N $_{\rm C}$ part V $^{(0)}$. For the latter part, there seems to be no dispersion relation representation available, because the integrand there contains only one (quark) momentum.

Therefore, we apply in this paper the so-called proper time regularization approach for the ferm ionic momenta, using the Schwinger representation for the \bosonized" elective action. This regularization, in contrast to the spherical cuto , does not suler from the momentum branching ambiguity problems, since it is translationally invariant in the momentum space. Furthermore, in contrast to the DR cuto regularization, the present procedure treats mutually consistently the leading-N $_{\rm C}$ and the NTL contributions, due to the introduction of a ferm ion momentum regulator function that is common to both contributions.

In Sec. II, we calculate the elective potential, including the NTL contributions. We take into account the elects of the third generation quarks, and at the NTL level in addition the elects of the Higgs and the three Goldstones. The latter degrees of freedom represent, in the Landau gauge, the bingitudinal degrees of freedom of the Z and W. The elects of the transverse components of the electroweak gauge bosons are not included. Several technical details of the derivation, in the proper time regularization framework, are given in Appendices A and B.We employ two dierent fermionic regulators in the proper time regularization framework: the proper time cuto (PTC) regulator, and the Pauli-Villars (PV) two-subtractions regulator; for additional comparison, we also employ the simple covariant spherical cuto (S) as used in Ref. [20]. For the bosonic momenta, which appear only at the NTL level and possess no momentum branching ambiguity in our problem, the proper time approach turns out not to lead to a regularization, and therefore we always use the covariant spherical cuto there.

In Sec. III, we derive the NTL gap equation, i.e., the requirement of the minimum of the elective potential in the vacuum. The solutions of the NTL gap equation give us the ratio (m $_{\rm t}$ () = $_{\rm f}$) of the bare mass of the top quark and the fermionic cuto parameter. Furthermore, we discuss in detail how to eliminate the singularities in the NTL integrals over the bosonic momenta in all (PTC, PV, S) cases, thus ensuring that Goldstone theorem is respected at the NTL level.

In Sec. IV, we include the mass renormalization elects. We also include the leading Q C D elects $\{$ in the gap equation and in the mass renormalization.

In Sec. V, we investigate num erically the gap equation solutions (\P m $_t$ () = $_f$)) and their mass renormalization (\P m $_t^{ren}$ = $_f$). The obtained values of the latter ratios lead to the values of the cuto parameters $_f$ and $_b$ (using: m $_t^{ren}$. 180 GeV). We also compare in Sec. V how the choice of regularization of the fermionic momenta (PTC, PV, S) in uences the numerical results, in particular the NTL corrections to the solutions of the gap equation. It turns out that these corrections are in the S regularization cases somewhat weaker and in the PV cases somewhat stronger than in the corresponding PTC cases. We demand that the leading-N $_c$ and the NTL solutions of the gap equation not dier drastically, i.e., that the NTL corrections not \wash out" the leading-N $_c$ solutions. As a consequence, it turns out that the cuto parameters are rather low: $_f$; $_b$ 0 (1TeV).

In Sec. VI, we recapitulate the basic conclusions of the paper and compare it with related works of other authors and, in particular, with the works [2]-[5].

2 The model, the e ective potential, proper time regularization

The top-m ode standard m odel (TSM) Lagrangian [4], known also as the BHL (Bardeen-Hill-Lindner) Lagrangian, contains a truncated SU $(2)_L$ U $(1)_\ell$ invariant four-ferm ion interaction at a high energy scale E. This term is assumed to be responsible for the creation of a composite Higgs eld H.

In this expression, a and b are the color and i the isospin indices, $^{\rm T}_{\rm L}=(t_{\rm L};b_{\rm L})$. $L_{\rm kin}^0$ contains the usual gauge invariant kinetic terms for fermions and gauge bosons. The model (1) is a specic Nambu { Jona-Lasinio (NJL) type model with the Standard Model symmetry SU(2)_L U(1)_Y. It leads to an elective framework for the minimal Standard Model. It can be rewritten in terms of an additional, as yet auxiliary, scalar SU(2)_L isodoublet, by adding to it the following quadratic term

The addition of such a term changes the generating functional only by a source independent factor [23]. Here, H, $G^{(0)}$, $G^{(1)}$ and $G^{(2)}$ are the Higgs and the three real Goldstone components of

the auxiliary complex isodoublet eld , and M $_0$ is an unspecied bare mass term for at E . The physical results will turn out to be independent of the specie value of M $_0$. These scalar elds eventually become the physical H iggs and the \scalar" longitudinal components of the massive electroweak bosons through quantum elects. We ignore the transverse components of W and Z, and all the lighter quarks which we assume to be and remain massless. It can be shown that the massless G oldstones discussed here correspond to the Goldstone degrees of freedom of W and Z in the Landau gauge (! 1). In this gauge, the ghosts do not couple to the scalar degrees of freedom and therefore the ghosts do not contribute to the elective potential [24], at least not at the leading-N $_{\rm C}$ and the NTL level.

The resulting e ective Lagrangian now reads

We used for the auxiliary scalar elds the following notation:

where we introduced a dimensionless coupling constant $g = G M_0^2$. Equations of motion give

thus signaling that the introduced auxiliary elds, once they become physical (dynamical) through quantum e ects, will represent the composite Higgs and the composite Goldstone (i.e., the composite longitudinal Z and W) degrees of freedom.

The e ective potential V_e ($_0$), as a function of the expectation values $_0$ of the scalar elds, can then be calculated in the W ick rotated Euclidean space by m eans of the following general form ula

where we set h=1. The bars over space-time components, derivatives and momenta from now on denote Euclidean quantities. is the four-dimensional volume (formally in nite). The elective potential is the energy density of the physical ground state when the order parameters $H_0 = hH$ is

and $G_0^{(j)} = hG^{(j)}i = 0$ (j = 0;1;2) are kept xed. In the expression (7) we explicitly kept also the expectation values $G_0^{(j)}$, in order to show later the explicit SU (2)_L U (1)_r invariance of the expression. This form ula is equivalent to a conventional expression for the elective potential obtained by using Legendre transform ation of the ground state energy density, as shown by Higashijim a [25]¹.

As the next step, we could simply integrate out the quark degrees of freedom, as was done in Ref. [20] (for the case of $G_0^{(j)}=0$). This would then naturally lead us to the imposition of the covariant spherical cuto on the ferm ionic momenta. At this stage, however, we decide to follow the proper time method which will give us the possibility of regularizing the ferm ionic momenta in the leading-N c and in the NTL terms in a mutually consistent way, as mentioned earlier. First we note that the ferm ionic operator \hat{D} is not positive denite and not herm itian, while $\hat{D}^{\gamma}\hat{D}$ is. Furtherm ore, the integration over the ferm ionic degrees of freedom would result in no imaginary part for the elective action, i.e., the Lagrangian (without the electroweak gauge bosons) has no anomalous terms. Therefore, the following identities can be used

The ferm ionic proper time regulator $_{\rm f}$ () has been introduced, satisfying the conventional boundary conditions 2

where f represents an elective cuto parameter for the fermionic momenta; it is of the same order of magnitude as the cuto of the discussed elective theory (1)-(4): f. After integrating out the fermionic (quark) degrees of freedom in this way, we obtain

where $m_t()$ is the bare mass of the top quark in the elective theory (1)-(4) after the dynamical symmetry breaking.

Now we perform the expansion of the action in the exponent of (11) in powers of the scalar quantum uctuations $s_k(x)$ (k=0;1;2;3) up to and including the quadratic term s. It turns out that the term s linear in s_k , except for those proportional to $J_k s_k$ (i.e., the functions), do not contribute to the elective action in the exponent of (11), precisely because of the functions. The term s with no uctuations then yield the leading-N c contribution N cV $^{(0)}$, and the term s quadratic in uctuations yield the next-to-leading (NTL) contribution V $^{(1)}$ of the form al (1=N c) expansion

The leading-N $_{\rm C}$ contribution can therefore be read o $\,$ im m ediately from (11)

In Appendix A we wrote down the entire expression for the herm itean operator matrix $\hat{D}^y\hat{D}$ (f $_jg$) in the Euclidean metric. The matrix has dimension 8 8 in the combined spinor and isospin space [cf.(4)], and we diagonalized it there by means of a unitary matrix U

The matrix above is a block matrix made up of blocks of dimension 4. From here we see that only the top quark isospin component contributes to N $_{\rm C}$ V $^{(0)}$ in the physical vacuum, since the o-diagonal elements in U matrix of (A.4) are zero then: ${\bf g}_0^{(\)}=0$. Inserting (17) into (16), performing the tracing

over the coordinates in the momentum basis, and tracing also in the color and isospin space, we end up with the general leading-N $_{\rm C}$ contribution in the proper time approach

where the factors N $_{\text{C}}$ and 4 com e from tracing the identity m atrix in the color space and in the spinor space of the top quark, respectively. We denoted by $_{0}$ simply the expectation value of the scalar isodoublet, i.e.,

and we introduced the notation $^2=^P_{0\ j}^3$. From (18) we see explicitly that the leading-N $_C$ contribution is a function of the SU (2) $_L$ U (1) $_f$ invariant Y_0 0, and is therefore itself an SU (2) $_L$ U (1) $_f$ invariant expression, as it should be. Certainly, in our calculations we will take at the end Y_0 0 = 2_0 =g = m 2_t ()=g, since we will be searching for the physical vacuum that dynam ically breaks the SU (2) $_L$ U (1) $_f$ to U (1) $_e$ m.

The leading-N $_{\rm C}$ expression (18) can be obtained also diagram matically, in its nonregularized form, by calculating the 1-PI one-loop G reen functions corresponding to the diagram s of Fig. 1 with outer legs of zero momentum. This is described in detail in [27].

At this point, we introduce two specic choices for the ferm ionic (quark) proper time regulator $_{\rm f}$ () (i.e., the regularization for the ferm ionic momenta of the model): proper time cuto (PTC), and the Pauli-Villars (PV) regularization with two subtractions:

The leading-N c part N cV $^{(0)}$ (2) of the elective potential was calculated explicitly for these two cases (PTC, PV) in Appendix B. We note that the two $_{\rm f}$'s in (20) and (21) are not equal in the corresponding cases with equal four-ferm ion coupling G = 8 2 a=(N $_{\rm C}$ $_{\rm f}$) of the Lagrangian (1). In fact, if we require that $_{\rm f}^2$ term s in N $_{\rm C}$ @V $^{(0)}$ =@ $_{\rm f}^2$ be equal in the two cases, we obtain [cf.(B.4)-(B.5)]: $_{\rm f}^2$ (FTC) = (2 ln 2) $_{\rm f}^2$ (FV). The ln $_{\rm f}^2$ term s then agree autom atically with each other.

Next we turn to the derivation of the next-to-leading (NTL) contribution V $^{(2)}$. First we expand $\hat{D}^{y}\hat{D}$ up to quadratic terms in the scalar uctuations $fs_{i}(x)g$ (12)

O perators $\hat{4}_1$ and $\hat{4}_2$ are linear and quadratic in the scalar uctuations $fs_j(x)g$, and the dots denote term swhich are at least cubic in $fs_j(x)g$. Explicit expressions for $\hat{4}_1$ and $\hat{4}_2$ are given in (B.6)-(B.8)³. Furtherm ore, we denoted: $\hat{4}_0 = \hat{D}^y\hat{D}$ (f_jg). Inserting expansion (22) into (11), we then obtain the NTL contribution V (1) to the excitive potential by keeping only the contributions quadratic in the uctuations (and by keeping the functions, as mentioned earlier)

We calculate the above traces in the momentum basis and in the unitarily rotated spinor-isospin basis in which the 8 8 matrix $\hat{4}_0$ (f $_j$ g) = $\hat{D}^y\hat{D}$ (f $_j$ g) is diagonal [cf.(17)]. The steps and some details are explained in Appendix B. It turns out that the proper time action in the curly brackets of the exponent in (23) can be written in the following form:

Here we introduced a nite spherical cuto $_b$ ($_b$ $_f$) for the bosonic momenta p. If we hadn't cut of the integration this way, and if we had tried to regularize the bosonic momenta again with the proper time method, we would have ended up with severely divergent integrals over the bosonic proper times, since the elective actions K_j in momentum space are not proportional to p^2 as p^2 ! 1 (i.e., no kinetic terms for bosons at p^2 $_f^2$), but rather converge to a constant. However, the spherical cuto for the bosonic momenta is not as problematic as it is for the fermionic momenta. Namely, unlike the fermionic spherical cuto case, the integrals over the bosonic momenta evidently don't suer in our expressions from the momentum branching ambiguities { the integrands in (28) don't depend on scalar products p k (k being a fermionic momentum), but only on p^2 .

The kemels \hat{A}_j have the following structure in the x basis:

where the explicit expressions for the functions (k) and (k) in terms of the integrals over the proper time are given in (B.10)-(B.11). In the momentum basis, applying (28), we nally get for the NTL part of the elective potential

Note that the three terms on the RHS of (30) correspond to the NTL contributions of the Higgs, the neutral Goldstone and the two charged Goldstones, respectively. It turns out, as shown in Appendix B, that $^{(1)}$ (2_0) is in general exactly twice the derivative of the leading-N $_{\rm C}$ part of the e-ective potential

This quantity is zero by de nition if $_0$ is the solution $_0$ = $m_{\rm t}^{(0)}$ of the leading-N $_{\rm C}$ gap equation. However, if $_0$ is equal (or in the vicinity) of the NTL gap equation solution, i.e., if $_0^2$ = $m_{\rm t}^{(0)2}$ (1 + 0 (1=N $_{\rm C}$)), then $_0^{(1)}$ ($_0^2$) is formally of order 0 (N $_{\rm C}$ (1=N $_{\rm C}$)) = 0 (N $_{\rm C}^0$) in the (1=N $_{\rm C}$) expansion, and it changes sign from m inus to plus as $_0$ increases across m $_{\rm t}^{(0)}$. On the other hand, the rest of the arguments in each of the logarithms in (30) is always positive and formally of order 0 (N $_{\rm C}$), as can be immediately seen from (B 17)-(B 18). For any special regulator $_{\rm f}$ (), the explicit expressions for all these arguments can be calculated from the corresponding general formulas (B 10) and (B 17)-(B 18). Here we write down the results for the PV case (21), as an explicit series in inverse powers of the cuto parameter $_{\rm f}$:

The corresponding expressions for the PTC case are similar and were calculated explicitly in (B.14) and (B.20)-(B.21). As mentioned toward the end of Appendix B, the PV results (33)-(34) can be calculated from formulas (B.17)-(B.18) in a way very similar as in the PTC case. Moreover, we can even obtain closed analytical expressions for these quantities in the PV case [cf. (B.23)-(B.25)].

The NTL part of the e ective potential, in its nonregularized form, can be calculated also diagram matically, by evaluating the 1-P Imulti-loop G reen functions of the \beads" diagram s of Fig. 2. The calculation is described in detail in Appendix C of Ref. [19], and its extension to the case when G oldstone bosons are included is mentioned in [20].

3 G ap equation at the next-to-leading order

In order to write down the NTL gap equation that is suitable for num erical evaluations, it is useful to de ne the dim ensionless analogues of: the momenta, the scalar expectation values, the proper time, the four-ferm ion coupling and the elective potential. We rescale the bosonic momenta p^2 ! ${}_f^2p^2$, and introduce the following dimensionless analogues:

The dim ensionless coupling parameter a is of order 1 by the leading-N $_{\rm C}$ gap equation, i.e., a is form ally of order 0 (N $_{\rm C}^{0}$) in 1=N $_{\rm C}$ expansion, as will be shown explicitly below. The explicit expressions for A $^{(1)}$ ($^{"2}$;a), ($^{"2}$;a), ($^{(1)}$ $^{(1)}$ $^{(1)}$) ($^{(2)}$; $^{"2}$) and (A $^{(2)}$ + B $^{(2)}$) ($^{(2)}$; $^{"2}$) for the PTC and PV cases can therefore be read o directly from (B $^{(1)}$)–(B $^{(1)}$) (or equivalently from: (B $^{(1)}$) and (32)] and from (B $^{(2)}$)–(B $^{(2)}$), (33)–(34). W ith the exception of A $^{(1)}$, they are form ally O (N $^{(0)}$); A $^{(1)}$ is O (1=N $^{(2)}$).

The general leading-N $_{\rm C}$ gap equation is obtained by m in im izing the potential $^{(0)}$ w ith respect to $^{\rm m^2}$

where $\mathbf{w}_0 = \mathbf{m}_t^{(0)} = \mathbf{m}_t$, and $\mathbf{m}_t^{(0)}$ is the top quark mass approximation as obtained from this leading-N_C gap equation. From (40) we also see explicitly that the dimensionless coupling constant a, as defined by (35), is really of order 1.

At this point, we note that the NTL contribution in (38) is ill-de ned for all "2's that are smaller than the leading-N_C gap equation solution $^{12}_{0} = (m_{t}^{(0)} = f)^{2}$. The reason for this is that, as already mentioned in the previous Section, $_{1}$ and hence A $^{(1)}$ become negative for $^{12} < ^{12}_{0}$, while B $_{1}^{(1)}$ B $_{2}^{(1)}$ and A $^{(2)} +$ B $^{(2)}$, being nonnegative always, go to zero when 2 ! 0, as seen from (B.17)-(B.18). Therefore, the arguments of the logarithms for the Goldstone contributions in (38) become negative in such a case. This problem is manifest already in formula (25) where the argument in the exponent

in the integral over the sources I_j becomes positive for $"^2 < "^2_0$ (for j=1;2;3) and the integral becomes divergent. Furtherm ore, for the same reasons, the argument of the logarithm for the Higgs contribution in (38) becomes negative for small $"^2 < "^2$ (substantially smaller than $"^2_0$) when p^2 ! 0.

A sm entioned in the previous Section, however, the problem atic part A $^{(1)}$ (n2 ;a) of the arguments of the logarithm s in the NTL part (38) of the elective potential is formally suppressed by ($^{1=N}$ c) in comparison to the other parts. Therefore, we may be tempted to simply ignore that term there, on the grounds that it gives formally the next-to-next-to-leading order (NNTL) corrections which have not been taken into account in its entirety here anyway. However, this argument is dangerous and misleading, because the physically relevant relations are obtained from the gap equation involving the derivative of the elective potential, and not the elective potential itself. It is straightforward to see from (37) and (40) that the derivative $^{(1)}$ = $^{(1)}$ = $^{(1)}$ = $^{(2)}$ = $^{(2)}$ ($^{(1)}$ = $^{(1)}$ =

The fact that $B_1^{(1)}$ $B_2^{(1)}$ and $A_2^{(2)} + B_2^{(2)}$ are proportional to p^2 when p^2 ! 0 is in (41) a manifestation of Goldstone theorem (masslessness of Goldstones). We will denote the solution to the NTL gap equation simply as: $\mathbf{u}^2 = \mathbf{u}_{\text{gap}}^2$, or $(\mathbf{u}_{\text{gap}}^{(NTL)})^2$. This NTL gap equation is \exact in the sense that it includes all the NTL exects of the composite scalars (Higgs and Goldstones). This means that it includes also the contributions of the longitudinal components of the electroweak gauge bosons (in the

 $^{^4}$ On the other hand, we are allowed to ignore A $^{(1)}$ = O (1=N_C) in the NTL gap equation; in fact, we must do this because otherwise the three integrands in the NTL part of (41) would have singularities [cf. discussion following Eqs. (31) and (40)] and G oldstone theorem would be violated.

Landau gauge); it does not include the e ects of the other { transverse { components of these gauge bosons. It does not yet include the e ects of the gluons – this will be done in the next Section. The NTL gap equation (41) can be solved numerically, for any given value of $_{\rm b}^2 = _{\rm f}^2$ and any allowed given value of the input parameter a [a > 1 for the PTC, and a > 1=(2 ln 2) for the PV case].

There exists an alternative way of solving this equation { namely in the \((1=N_C)\) perturbative" approach. We can make for the solution $^{12}_{\text{gap}}$ the familiar $1=N_C$ expansion ansatz

Incidentally, in Eq. (45) we do not have to worry about setting the problem atic term s A $^{(1)}$ (12 ;a) to zero, since they are zero autom atically for 12 = 12 0. This latter approach was also applied in Ref. [20], where we employed the spherical covariant cuto. We also discussed there brie y the problem of singularities that would occur otherwise. These problems of singularities in the NTL derivatives $^{(1)}$ =0 12 0 at 12 2 at 12 3 have also been discussed by the authors of Ref. [28], in the context of an SU (2) invariant NJL model which they regarded as a model for low energy QCD.

Expression (45) is a reasonably good approximation to the actual NTL change as determined by the \exact" NTL gap equation (41) only as long as the values of j ($^{"2}$) $_{gap}^{(NTL)} = ^{"2}$ j $^{"2}$ j $^{"2}$ j, and 2 gap 2 gap are all su ciently small ($^{<}$ 0:5). Even in such cases, expression (45) can frequently overestimate j ($^{"2}$) $_{gap}^{(NTL)}$ j by more than ten percent. This expression is less precise in the PV cases than in the corresponding PTC and S cases. For all these reasons, we use the \exact" NTL gap equation (41) in our calculations.

In this context, we mention that it is possible also in the case of the covariant spherical cuto
(S) of ferm ionic momenta to write down the \exact" NTL gap equation free of any singularities, in

close analogy with (41). The form al expression for $(^{(1)}=0^{-12})$ in the S case was obtained in Ref. [20]. That expression contains as integrands the S-regulated bubble-chain-corrected scalar propagators a [1 aJ $_X$ (p²; "²)] $^1=2$ (X = H;Gn;Gch) 5 , which are represented in Fig. 3 as dashed lines with a blob. Their analogues in the proper time approach are the inverses of the arguments of logarithms in (38): $[A^{(1)}+B_1^{(1)}]$ $B_2^{(1)}$ (p²; "²)] 1 and $[A^{(1)}+A^{(2)}+B^{(2)}]$ (p²; "²)] 1 . The S-regulated scalar propagators as integrands for $(^{(1)}=0^{-12})$ have the same kind of singularities as their analogues in the proper time framework: for X = Gn, Gch singularities occur for "² < "², for X = H singularities occur for "² < "² (< "²). The trick now is to replace them in $(^{(1)}=0^{-12})$ by $(^{(1)}=0^{-12})$ in $(^{(1)}=1^{-12})$ and the difference between the inverse of the old and of the latter expression is equal to $(^{(1)}=0^{-12})$, as was also the case in the proper time approach. This represents form ally a next-to-next-to-leading (NNTL) modication, which is again completely legitimate at the level of the NTL gap equation. The resulting modied inverse propagators of the scalars can be shown to be positive everywhere, and therefore the NTL gap equation written below is free of any singularities:

4 M ass renormalization, QCD corrections

We calculate and include at this point also the top quark m ass renorm alization e ects m $_{\rm t}$ () 7 m $_{\rm t}^{\rm ren}$. In this context, we stress that the hard m ass of the NTL gap equation (41) is the xed (nonrunning) m ass in the dynam ically broken e ective theory (1) with a cuto $_{\rm f}$ $_{\rm b}$, i.e., it is the bare m ass m $_{\rm t}$ () (" $_{\rm gap}$ = m $_{\rm t}$ ()= $_{\rm f}$). In order to obtain the values of the cuto parameters $_{\rm f}$ and $_{\rm b}$, we therefore have to perform, after having solved the NTL gap equation (7 m $_{\rm t}$ ()= $_{\rm f}$), also the m ass renorm alization (m $_{\rm t}$ ()= $_{\rm f}$ 7 m $_{\rm t}^{\rm ren}$ = $_{\rm f}$), since the m ass of the top quark is m ore or less known (m $_{\rm t}^{\rm ren}$: 180 GeV) [29]. It is straightforward to check that there are no leading-N $_{\rm c}$ contributions to these renorm alization corrections, and that only the 1-PI diagram s shown in Fig. 3 account for the NTL renorm alization e ects (cf. also [19], [20]). Therefore

Here, we denoted by "² the \bare" mass value "² $_{gap} = m_t^2$ ()= $_f^2$, i.e., the solution of the NTL gap equation. The expressions above were obtained by assuming rst a (normalized) Euclidean momentum $q^2 > 0$ for the external top quark line in the diagrams of Fig. 3. Then the analytic continuation to the (approximate) on-shell values $q^2 = q^2 = m^2 = m$

The expressions $^{(X)}_{jr}$ for the case of the covariant spherical (S) cuto were written in Ref. [20] where we substituted for $^{"2}$ the leading-N $_{\rm C}$ gap equation solution $^{"2}_{0}$, instead of the \bare" mass solution $^{"2}_{\rm gap}$ of the NTL gap equation. This was formally an acceptable approximation, because the renormalization contributions $(^{"2})^{(NTL)}_{\rm ren}$ are $1=N_{\rm C}$ e ects, as are the NTL gap contributions $(^{"2})^{(NTL)}_{\rm gap} = ^{"2}_{\rm gap} = ^{"2}_{0}$. However, we investigate the borderline cases where the NTL gap contributions are large: $j(^{"2})^{(NTL)}_{\rm gap} j^{< "2}$, in general larger than $j(^{"2})^{(NTL)}_{\rm ren}$. Therefore, it would be more realistic also in the S case of [20] to insert in the integrands for $^{(X)}_{jr}$'s the \bare" mass solution of

the NTL gap equation (46): $"^2 = "^2_{\rm gap} (< "^2_0)$. However, once we do that, the formulas for $^{(X)}_{\rm jr}$'s (X = Gn;Gch) become singular. W e insert in these expressions the NTL \bare" m ass value $^{"2} = ^{"2}_{gap}$.

Finally, we include the leading part of QCD e ects. This was already done in Refs. [19], [20] and we cite here only the results. The leading \gap" part of QCD is represented by the contributions coming from the diagrams of Fig. 2, where the internal dashed lines represent now the gluon propagators (in Landau gauge). Since QCD e ects turn out to be only of minor numerical importance in our framework, we decided to regulate the corresponding QCD integrals by means of only one specic approach { by the proper time cuto $1 = \frac{2}{f}$ for the quarks and $1 = \frac{2}{b}$ for the gluons. The corresponding contribution to $\frac{1}{f}$ to be added in (38) was derived in [19]

Here, a_{gl} is the relevant QCD coupling parameter: $a_{gl} = 3_s (m_t) = 0.105$. The (proper time regulated) two-point G reen function J_{gl} appearing in (58) is

It is worth mentioning that QCD expression (58), unlike (38), turns out to be numerically almost equal to its two-loop approximation (obtained by the replacement: $\ln [1 \quad a_{gl}J_{gl}(p^2; "^2)]$ $q_{gl}J_{gl}(p^2; "^2)$), the dierence being only a fraction of a percent. This has to do with the small values of $a_{gl}(E)$ at the relevant energies E^{-} m_t . That's why the QCD contributions to $("^2)_{gap}$ turn out to be quite small (almost negligible) in comparison to the NTL contributions of the scalars in the present framework.

The leading QCD m_t-m ass renorm alization e ect, which is numerically more important than the QCD contribution to $("^2)_{gap} = "^2_{gap} \quad ^2_{0}$, comes from the version of the diagrams of Fig. 3, where the dashed line with a blob is now the gluonic propagator. With the proper time cuto we obtain (cf. [19])

In our original paper [19], we regarded only the scalar sector contributions to V_e and $V_e = "^2$ as being organized in an 1=N $_{\mathrm{C}}$ expansion, and assumed that QCD contributions can be organized in a perturbative series in powers of $_{\rm s}$ (m $_{\rm t}$). However, as argued in [2], [5] and [16], the dominant part of the QCD contributions is form ally a leading-Nc contribution. The reason lies in the fact that $_{\rm S}$ = 0 (N $_{\rm C}$ ¹). In $^{(1;g]}$ in (58), the factor 2 is replaced in the case of a general N $_{\rm C}$ by (N $_{\rm C}$ 1)=4= $a_{1}J_{q1}/a_{q1}/s=0$ (N $_{C}$). Therefore, $a_{1}J_{q1}=0$ (N $_{C}$) O (N $_{\rm C}^2$); furtherm ore, $\ln (1 - a_{\rm gl} J_{\rm gl})$ when added to the NTL part $^{(1)}$ = 0 (N $_{\rm C}^{0}$) of (38). Hence, we see really that $^{(1,{\rm rgl})}$ is formally not NTL, but leading-N $_{\rm C}$ contribution to $_{\rm e}$ in the expansion (36). Also the QCD renormalization contribution (60) is form ally leading-N c. N am ely, the factor 2=3 in (60) is in the general case replaced by (N $_{\rm C}^2$ 1)=(4N $_{\rm C}$) = 0 (N $_{\rm C}$), and since $a_{\rm gl}$ = 0 (N $_{\rm C}^{-1}$), we have ($^{\rm u2}$) $_{\rm ren.}^{\rm Q\,C\,D}$ = 0 (N $_{\rm C}^{-0}$), i.e., form ally leading-N $_{
m C}$ e ect. However, it will turn out that for the cases considered in the present paper (with 1 TeV when the NTL contributions of the scalars become comparable to the leading-N $_{
m C}$ quark loop contributions), QCD contributions are numerically almost an order of magnitude smaller than both the leading-N c quark loop contributions and the NTL scalar contributions. That's why we included in our formulas QCD contributions in the NTL parts.

5 Num erical evaluations

The inputs for the integrations are the values of the parameter $a = N_c G_f^2 = 8^2$ of (35), which is essentially a dimensionless measure of the strength of the original four-ferm ion coupling G_f^2 in (1),

as well as the values of the ratio $_{b}=_{f}$ (1) of the bosonic and ferm ionic cuto parameters. The diagram s of Fig. 2 suggest p_{max}^2 k_{max}^2 , in plying the input values $_{b}=_{f}$ 1, at least in the more intuitive cases of the ferm ionic S or PTC cuto . Therefore, we have made three input choices for these ratios in the PTC case: $_{b}=_{f}$ $_{f}$ $_{f}$ = 0.5;1= $_{f}$ $_{f}$

It turns out that both the NTL gap equation (41) [with QCD contributions from (58) included] and the (NTL) mass renormalization e ects (49), (52)-(54), (60) decrease the ratio "2" when compared to the leading-N $_{\text{C}}$ value $^{12}_{0}$ of (40). In other words, we have: $(^{12})_{\text{gap}} = ^{12}_{\text{gap}} = ^{12}_{0} < 0$ and $(^{12})_{\text{ren.}} = ^{12}_{0} < 0$ $^{"2}_{ren.}$ $^{"2}_{gap}$ < 0. In general, we have j ($^{"2}$)_{gap} j> j ($^{"2}$)_{ren.j.} W hen $^{"2}_{gap}$! 0, ($^{"2}$)_{gap} rem ains relatively stable while j ("2) $_{\rm ren.j}$ (< "2 $_{\rm gap}$) ! 0. Hence, ("2) $_{\rm gap}$ is identi ed as the source of the observed \1=N $_{\rm C}$ nonperturbative" behavior, unlike $("^2)_{ren.}$, when $"^2_{gap}$ m_t^2 () = $\frac{2}{f}$! 0. Therefore, if we require $1=N_{\rm C}$ expansion in our fram ework to have at least some qualitatively predictive power, than the NTL gap change j $(\mathbf{n}^2)_{gap}$ jshould not be too large in comparison to \mathbf{n}_0^2 , i.e., \mathbf{n}_t ()= \mathbf{n}_t^2 = \mathbf{n}_t^2 should not decrease beyond som e critical sm all value. Consequently, the leading-N $_{\rm C}$ ratio $^{12}_{0}$, or equivalently the input parameter a [cf. (40)], should not decrease beyond certain corresponding critical values. In Table 1, we chose in the PTC case, for given ratio $_{b}$ = $_{f}$ (second column), various \critical" small values for m_t^2 ()= $m_t^{(0)2} = m_0^2 = m_0^2$: 1=4, 1=3, 1=2, 2=3 (third column). There is a certain arbitrariness in deciding which of these values represents most realistically the breakdown of the 1=N_C expansion approach in the PTC case. In the fourth column, the corresponding ratio of the renormalized mass vs.m $_{\rm t}^{(0)}$ is given. The last two columns contain the corresponding values of the cuto parameters $_{\rm b}$ and f^{PTC} , which are obtained from the calculated values of $m_{\text{ren.}}^2 = (m_{\text{t}}^{\text{ren.}} = f)^2$ and the approximate experim ental value m + ren = 180 G eV [29]. In the rst column, the corresponding values of the coupling input param eter a (PTC) are given. We note that the values in the last two columns are the upper bounds of the cuto param eters, once we take the stand that the NTL gap equation e ects should not be stronger than in the speci c case, i.e., that the ratio $m_t() = m_t^{(0)}$ should not be smaller than the chosen critical value in the third column.

 unacceptable in the present fram ework, i.e., 1=N c expansion loses predictability in this case.

In addition, in columns 5-6 we included the values of $m_t() = m_t^{(0)}$ and $m_t^{ren} = m_t^{(0)}$ in the corresponding cases for the PV, and in columns 7-8 for the S regularization. By the \corresponding values" we mean those values which correspond to the same values of the four-ferm ion coupling G of Eq. (1) and the same values of the cuto b, since this parameter represents always the covariant spherical cuto for the bosonic momenta and is not in uenced by the regularization choice (PTC, PV, S) for the ferm ionic momenta. Technically, to not these corresponding values, i.e., to not the corresponding input parameters y(X) = b = f(X) and a(X) (X denotes PV or S), we have to require in the numerical program that the two numbers $E_1 = a(X) = \frac{2}{y}(X) = \frac{2}{b}GN_c = (8^{-2})$ and $E_2 = a(X) = \frac{2}{ren} \cdot (X) = (m_t^{ren} \cdot)^2 GN_c = (8^{-2})$ be the same as in the PTC case.

It should be mentioned that certain entries in Table 1 should be regarded with additional reservations { those for which the leading-N_C values " $_0 = m_t^{(0)} = f$ are larger than 1. These are the entries of the last line for the PTC case, the last three lines for the PV case, and for the S case the lines corresponding to a (FTC) = 5:091 and 7:935. On the other hand, all the entries in Table 1 have the values of " $_{gap}^{(NTL)} = m_t$ () = $_f$ and " $_{ren}^{(NTL)} = m_t^{ren} = f$ sm aller than 1.

A few additional technical remarks: In the PV case, the series for $\binom{\sim (1)}{1}$ $\binom{\sim (1)}{2}$ in inverse powers of f [Eq. (33)] is, unfortunately, quite slow by convergent for low values of f (0.5 TeV), unlike the series for $\binom{(2)}{2} + \binom{\sim (2)}{2}$ [Eq. (34)]. Therefore, we used in our calculations in the PV case for $\binom{\sim (1)}{1}$ $\binom{\sim (1)}{2}$ the closed analytic expression (B 23). For $\binom{(2)}{2} + \binom{\sim (2)}{2}$ in the PV case we used the closed analytic expression (B 24), except in Eq. (54). In this equation for $\binom{(G \text{ ch})}{1r}$, describing the mass renormalization e ects due to the charged G oldstone degrees of freedom, a part of the integration is performed over a region with negative p^2 , for which formula (B 24) is not suitable. Therefore, we applied there in the PV case the series (34), including the terms in the sum up to n=8.

In all regularization cases, we are led to the same qualitative conclusion: the cuto $_{b}$ does not surpass O (1 TeV) as long as we dem and that the NTL gap e ects not drastically \wash out" the leading-N $_{c}$ e ects. Comparing the ratios $(m_{t}()=m_{t}^{(0)})=\frac{q}{\frac{m_{2}^{2}=m_{0}^{2}}{gap}=0}$ for the corresponding cases of the PTC, PV and S regularization, as well as the ratios $(m_{t}^{ren}=m_{t}^{(0)})=\frac{q}{\frac{m_{2}^{2}=m_{0}^{2}}{ren}=0}$, we conclude the following:

The S cases give som ewhat smaller gap NTL changes j (n)_{gap}= $^{n_0^2}j$ of the solution of the gap equation than the corresponding PTC cases; this implies that the NTL-tolerable values of the cuto parameter $_b$ are somewhat higher in the S cases. On the other hand, the full NTL changes j[($^{n_0^2})_{gap} +$ ($^{n_0^2})_{ren}$) $= ^{n_0^2}j$ are almost the same in both cases.

The PV cases give som ewhat larger NTL changes j (n)_{gap}= $^{n2}_{0}j$ than the corresponding PTC cases; this implies that the NTL-tolerable values of the cuto parameter $_{b}$ are som ewhat lower in the PV cases. Also the full NTL changes 1 $_{ren}^{n2} = ^{n2}_{0} = ^{n2}$

When inspecting more closely the separate contributions of the various degrees of freedom to the NTL gap shift $("^2)_{gap} = "^2_{gap} \quad "^2_0$ of (41) and to the mass renormalization NTL shift $("^2)_{ren.} = "^2_{ren.} \quad "^2_{gap} \quad of (49)$, (52)-(54), (60), for the cases displayed in Table 1, we see the following 6 : the Higgs and each one of the three Goldstone degrees of freedom contribute comparable negative values to $("^2)_{gap}$, and gluons a small positive value which is by an order of magnitude smaller than the absolute values of the separate scalar contributions; the Higgs and the charged Goldstone degrees of freedom contribute each a negative value and the neutral Goldstone and gluons weaker positive values to $("^2)_{ren.}$, resulting thus in a negative $("^2)_{ren.}$. Therefore, both $("^2)_{gap}$ and $("^2)_{ren.}$ are negative, and j $("^2)_{gap}$ j is usually larger than j $("^2)_{ren.}$ jby more than a factor of 2.

In Ref. [20] we calculated the NTL e ects for the S case of regularization of ferm ionic mom enta. Comparing them with the results of Table 1 for the Scase, we not that the cutos $_{\rm b}$ in Table 1 are som ew hat larger in the corresponding cases. These di erences arise because, unlike in [20], here we inserted in the nonsingular (\regularized") expressions of the renorm alization contributions (55)-(57) and (60) the NTL corrected \bare" m ass param eter $^{2}_{qap}$, as m entioned earlier, and not $^{2}_{0}$ ($^{2}_{0} > ^{2}_{qap}$), resulting thus in numerically smaller numbers for $("^2)_{ren.} = "^2_{ren.} "^2_{gap}$. In [20], on the other hand, we used singular integral expressions for $\frac{(X)}{1r}$ (X = H, Gn, Gch), and we had no other choice there but to insert for $^{"2}$ the value $^{"2}_0$ to avoid singularities in the integrals over bosonic m omenta. If we inserted " $^2 = ^2_0$ in the nonsingular (\regularized") expressions (55)-(57), these would give us results for $_{1r}$ identical with those in [20], as it should be. In addition, in [20] we used the approximate NTL gap equation (45) to obtain $("^2)_{qap}$, and not the \exact" NTL gap equation (46) for the S cuto . This resulted in [20] in som ew hat larger values for j $(^{112})_{gap}$ j and contributed thus additionally to smaller values of b (and f). Incidentally, in [20] we regarded $(\mathbf{n}^2)_{gap} + (\mathbf{n}^2)_{ren} = \mathbf{n}^2 [\mathbf{n}^2] \text{ (m } \frac{ren}{t} = \mathbf{n}^{(0)}_{t})^2]$ as a measure of the NTL changes. On the other hand, in the present paper we chose to regard only the NTL gap e ects as the genuine NTL e ects, i.e., we chose as a measure of the NTL changes the ratio $("^2)_{gap} = "^2_0 [\% (m_t() = m_t^{(0)})^2].$

⁶ To estim at roughly the separate contributions to $("^2)_{gap}$, we use the approximate NTL gap equation (45), where these contributions are purely additive.

6 Conclusions and comparison to other works

In this work, we calculated the next-to-leading (NTL) term s in 1=N c expansion of the e ective potential of the condensate and of the corresponding gap equation, in the elective non-gauged SU (2) I. Nambu{Jona-Lasinio type model (called also the top-mode standard model { TSM) of dynamical symmetry breaking (DSB). Furtherm ore, we calculated also the (NTL) mass renormalization e ects after the DSB.We included all the degrees of freedom that are relevant at the NTL level of this fram ework: the Higgs and the three Goldstone condensates, and the quarks of the third generation (top and bottom). In addition, we included also the dom inant part of QCD contributions. The latter turned out to be num erically less in portant in the present fram ework. We considered the exctive potential as a function of a hard mass term 0 of the top quark, i.e., of the expectation value 0of the composite scalar isodoublet eld $= p_{\overline{q}}$. We concentrated in particular on the question of regularizing the integrals over the ferm ionic Euclidean momenta in a way that is mutually consistent at the leading-N $_{\rm C}$ and at the N T L level, and is free of the m om entum branching am biguities. These ends are achieved by employing the proper time regularization techniques, and we specically employed the proper time cuto (PTC) and the Pauli-Villars (PV) two-subtractions regulator for the ferm ionic m om enta within the proper time fram ework. Furtherm ore, we discussed in detail how to ensure the validity of Goldstone theorem at the NTL level { in the proper time regularization framework and in the case of the simple covariant spherical (S) cuto for the ferm ionic momenta. For integrals over the bosonic momenta, no branching ambiguity problem appeared, but the proper time approach doesn't regularize them . We always employed covariant spherical cuto for them . The dependence of our results on the various regularization schemes (PTC, PV, S) for the ferm ionic momenta was investigated. The basic conclusions of the previous paper [20], in which a (simplied) S regularization approach was applied, remain unchanged: as long as the cuto energy h), at which the tt condensation is assumed to take place, is larger than 0 (1 TeV), then the negative NTL gap corrections $({\it {^{12}}})_{\rm qap}$ to the DSB (the gap equation solution) have absolute values quite close to the values of the positive leading-N $_{\rm C}$ quark loop contributions $^{\rm 12}_{\rm 0}$, thus essentially \washing out" the latter ones and making the model dicult or impossible to interpret. On the other hand, for < 0 (1 TeV), explicit calculations here show that the PTC, PV and S regularizations, when physically acceptable, give sim ilar num erical results, the PV regularization having som ewhat stronger and the S regularization som ew hat weaker NTL gap corrections than the PTC in the corresponding cases.

As argued in the previous Section, we identify $j("^2)_{gap}$ jas the source of the 1=N $_{\rm C}$ expansion breakdown, in contrast to the smaller $j("^2)_{ren.}$ j. The conclusion that the NTL gap contributions can

easily become strong [for > 0 (1 TeV) too strong for the applicability of 1=N c expansion] is not quite implausible. The NTL contributions come primarily from the coupling of the composite scalar sector itself to its constituent top quarks (some kind of \feedback e ect"). This coupling must be relatively strong because otherwise the condensation cannot occur in the rst place.

The conclusions of this paper seem to contrast with those of Bardeen, Hilland Lindner (BHL) [4] and Miransky, Tanabashi and Yamawaki (MTY) [2]; however, they don't necessarily exclude them. In the following, we brie y describe the approaches and results of BHL and MTY, compare them with our approach and results, and point out analogies, dierences, and those points that remain unclear and deserve further investigation.

The authors of [4] em ployed the one-loop renorm alization group equation (RGE) of the m inim al SM for the top quark Yukawa coupling g_t and dem anded that it diverge or become large at the energy of condensation . This is motivated by the compositeness condition which says that the renormalization constants of the composite scalar elds should vanish in a theory with the cuto as high as E =, i.e., that the composite particles disappear (disintegrate) at that energy. This RGE approach implicitly assum es that is large, i.e., that $\ln (=E_{ew})$ 1, and that the details of the condensation mechanism get decoupled from the minimal SM behavior at energies which are, on logarithmic scale, quite close to (but below) the energy . Their approach results in very large 's; the larger the , the smaller P_{lanck} (10^{19} G eV), they obtain m $_{t}^{ren}$. 220 G eV, still substantially higher than the m ren. For 170 180 GeV [29]. The authors of [4] argue that, due to the quasi infrared (IR) xed-point behavior of the RGE, their prediction of m $_{t}^{ren} = g_{t}^{ren} v = \frac{p}{2}$ is quite stable against any details of the actual condensation mechanism. More specifically, their men. is quite stable when g_t^2 ()=(4) is changed between the values 1 and 1, and/or ln(=E $_{\rm ew}$) is changed by values of 0 (1). This is reasonably true as long as $> 10^{10}$ GeV, \lim iting thus the applicability of their method to the scenarios with thus large cuto s. Including the two-loop e ects in the then coupled RGEs for g_t and for the composite scalar self-coupling doesn't change much the results of this method [14] { the predicted m_{+}^{ren} is then increased by a few GeV.

The approach by M TY $\ [2]$, and subsequently by K ing and M annan $\ [5]$, is closer to the approach

of the present paper. Unlike BHL, they investigate the actual condensation mechanism of TSM, by considering the Dyson-Schwinger (DS) integral equation for the top quark mass function $_{\rm t}(q^2)$ and the Pagels{Stokar relation (PS) [30]. The DS equation was applied at the leading-N $_{\rm C}$ order (including QCD), and is basically the variational version of the usual gap equation; the gap equation at the leading-N $_{\rm C}$ order can be recovered from this DS equation by replacing $_{\rm t}(q^2)$ by m $_{\rm t}($) and the one-loop running $_{\rm S}(p^2)$ by a constant $_{\rm S}(E_0)$ (E $_0$ mt). The mass function $_{\rm t}(q^2)$ appears in the top quark propagator and is essentially the running mass of the top quark, in the non-perturbative sense.

M TY approach, as performed by [2] and [5] at the leading-N c level, was shown to be numerically [15] and analytically [16] equivalent to the leading-N c version of BHL approach. On the other hand, the results of the present paper suggest that $1=N_c$ expansion fails for > 0 (1 TeV). Therefore, the rst question to be asked is: Would the modi cation of our approach, by changing the NTL gap equation (41) [with QCD e ects from (58) included] to its variational version of M TY -type, change the basic conclusions of the paper? We have indications that it would not. However, our calculations do not exclude the possibility of much higher values of the cuto ie, values of several orders of magnitude larger than 1 TeV. The reason may lie in our separation of the calculation of the mass gap and of the mass renormalization e ects. It is possible that this approach m ay not work well for very large 's [n (=1 TeV) 1] where the interplay between the two e ects m ay becom e im portant. In such a case, the variational (DS) version of the gap equation at the NTL level, which takes into account both the mass gap and the mass running e ects simultaneously and thus also their interplay, would be the appropriate tool to apply. Then we could possibly see whether the scalar NTL corrections to $(q^2) = (q^2) = (q^2)$ sm all for $1=N_{\rm C}$ expansion to m ake sense. One possible signal that our paper cannot exclude the entire region > 0 (1 TeV) from the 1=N c expansion approach lies in the fact that the leading QCD contributions to "2 , while for O (1 TeV) being substantially smaller than the quark loop (bubblechain) contributions, start for much higher 's to compete with the bubble-chain contributions and substantially change the results in the DS + PS approach [16]. Therefore, we believe that perform ing the calculations at the NTL level with the variational (DS) approach would be important at this stage, in order to investigate the region of very high momenta. This could be done by employing the form alism of Cornwall, Jackiw and Tomboulis (CJT) [31] in which it is possible to calculate the e ective potential as a functional of the top quark propagator, and hence of the m ass function $_{t}(q^{2})$. In addition, the inclusion of the BS equation at the NTL level would represent an additional important step in investigating the whole realm of the NTL e ects of the strong composite scalar sector on the condensation mechanism.

One may also ask how the results would change when including the pure (i.e., transverse) components of the electroweak gauge bosons in the calculations. The RGE approach of BHL indicates that these contributions, at least as to the mass renormalization, are of minor importance, due to the relatively small SU (2)_L U (1)_L gauge couplings. Furthermore, the condensation occurs primarily due to the strong enough four-quark attractive coupling G of Eq. (1), so that the NTL contributions of the strong composite scalar sector to itself, i.e., the elects of the composite scalar couplings to its own constituent top quarks (\feedback elects"), are expected to be stronger and more important than those of the weak SU (2)_L U (1)_L couplings.

As a point independent of the discussion above, we stress that the simple TSM framework (1), in which the 6-dimensional four-quark contact term triggers the top quark condensation, m ight not be su cient for a fully realistic picture when the energy at which the condensation takes place is as low

as 0 (1 TeV). This is because higher dimensional femionic contact terms [32]-[33], which come from the details of the underlying physics at E > 1, might contribute to the physical quantities relative corrections as high as $1 = \ln (2 = m_t^2)$ 0.3. However, these corrections can be, for specient odels of the underlying physics, substantially smaller [34].

O ther authors have investigated NTL e ects in NJL-type fram eworks without gauge bosons [28], [35]-[38]. The authors of [28] calculated the NTL e ects with an elective action from alism, and those of [35] with diagram matic methods. Both groups regarded their discussed SU (2) symmetric NJL type model as a fram ework of the low energy QCD and took particular care that Goldstone theorem remains valid.

The authors of [36] calculated NTL contributions to critical exponents of the elds at the xed point, i.e., at the location of the nontrivial zero of function, for various dimensions d 4. The im plications of [36] for physical predictions of four-dim ensional NJL models with nite cuto are not clear from these works and would deserve investigation. On the other hand, A kam a [37] investigated the NTL contributions by considering the compositeness condition which says that the renormalization constants of composite scalar elds and their self-interaction parameters should be zero. Also, Lurie and Tupper [38] had earlier investigated the compositeness condition, taking into account at least some of the NTL e ects. Both Akam a and Lurie and Tupper conclude that the compositeness condition im plies that the NTL contributions to physical quantities for $N_c = 3$ are larger than the leading- N_c contributions, indicating that 1-N c expansion diverges. We stress that these three authors treated TSM as a renormalizable Yukawa type model without gauge bosons plus the compositeness condition, an approach similar (not identical) to the approach of BHL [4]. Hence, implicitly they assumed that the cuto s are large, i.e., that In term sentirely dom inate over the -independent term s. Therefore, their results apparently don't contradict the results of the present paper and [20] { i.e., that TSM without electroweak gauge bosons can make sense at the NTL level only if the cuto s are quite low:








Fig. 3: the 1-PI diagrams with two external top quark legs which give the leading (O (1-N_{C})) contribution to the renormalization of the mass m_t. Unlike the diagrams of Figs. 1-2, the top quark propagators here contain the nonzero bare mass m_t() which was the solution to the NTL gap equation. The dashed lines are the propagators of the nondynamical scalars (either the Higgs, or the neutral Goldstones, or the charged Goldstones), while the dashed lines with a black blob are the propagators of the corresponding scalars that became dynamical through the NTL quantum e ects. For the case of charged Goldstone propagators, the fermion loops contain one massive top quark and one massless bottom quark.
