# Nuclear modication of the avor asymmetry $\overline{u}$ $\overline{d}$

In order to test the NMC nding of avor asymmetry  $\overline{u}$   $\overline{d}$  in the nucleon, existing D rell-Y an data for the tungsten target are often used. However, we have to be careful in comparing nuclear data with the nucleon ones. We investigate whether there exists signi cant nuclear modi cation of the  $\overline{u}$   $\overline{d}$  distribution in a parton-recombination model. It should be noted that a nite  $\overline{u}$   $\overline{d}$  distribution is theoretically possible in nucleieven if the sea is symmetric in the nucleon. In neutron-excess nuclei such as the tungsten, there exist m ore d-valence quarks than u-valence quarks, so that m ore  $\overline{d}$ -quarks are lost than  $\overline{u}$ -quarks due to parton recombinations. Our results suggest that the nuclear modi cation in the tungsten is a 2{10 % e ect on the NMC  $\overline{u}$   $\overline{d}$  distribution. The nuclear modi cation of the avor asymmetry should be an interesting topic in connection with ongoing D rell-Y an experiments.

The New Muon Collaboration (NMC) suggested that the Gottfried sum rule should be violated in 1991. It indicates d excess over u in the nucleon. Since then, there have been e orts to investigate mechanisms of creating a avor asymmetric distribution u d in the nucleon<sup>1</sup>. In order to test the NMC nding, D rell-Y an experiments are in progress at Ferm ilab. On the other hand, there exist D rell-Y an data for various nuclear targets, so that some people use, for example, tungsten data in investigating the avor asymmetry. How ever, we have to be careful in comparing the NMC result with the tungsten data because of possible nuclear medium e ects. In order to nd whether such a comparison makes sense, we estimate a nuclear modi cation e ect.<sup>2</sup> It in turn could be found experimentally by analyzing accurate D rell-Y an data in the near future.

We investigate the u d distribution in the tungsten nucleus. If isospin symmetry could be applied to parton distributions in the proton and the neutron, the distribution per nucleon becomes x  $[u(x) \ d(x)]_{h} = "x [u(x) \ d(x)]_{proton}$  without considering nuclear modi cation. It is just the summation of proton and neutron contributions. The neutron-excess parameter " is de ned by " = (N Z)=(N + Z), and it is 0.196 for the tungsten  $^{184}_{74}$ W  $_{110}$ . A coording to the above equation, the avor distribution should be symmetric ( $[u \ d]_{W} = 0$ ) if it is symmetric in the nucleon. However, it is not the case in a parton-recombination model.

It is well known that shadowing phenomena occur in nuclear structure functions at small x. One of the ideas for explaining the shadowing is the recombination model.<sup>3</sup> In an in nite momentum frame, the longitudinal localization size of a parton with momentum  $xp_N$  exceeds the average longitudinal nucleon separation in a Lorentz contracted nucleus  $[(2 \text{ fm})M_A = P_A = (2 \text{ fm})m_N = p_N]$  in the small x region (x < 0.1). Therefore, partons from di erent nucleons could interact, and the interaction is called parton recombination. We apply studies of this model in the structure function  $F_2$  to the asymmetry u d in nuclei.




Figure 1: Recombination contributions to u d in the tungsten nucleus.

The avor asymmetry could be created in the recombination model in the following way. In a neutron-excess nucleus (" > 0) such as the tungsten, more d quarks are lost than

u quarks in the parton recombination process  $qq \\ G$  because of the d quark excess over u in the nucleus. The  $qq \\ G$  type recombination processes produce positive contributions at small x. In the (u d)<sub>N</sub> leftondow 0 case, the  $q(x)G \\ l q$  process is the dom inant one kinem atically at small x. Its contribution to u(x) d(x) becomes negative due to the neutron excess. In the medium x region, the qG l q(x) process becomes kinem atically favorable. Because it produces q with momentum fraction x, its contribution becomes opposite to the one at small x. These results are shown in Fig. 1.

We evaluate the recombination elects on the u d distribution at  $Q^2=4$  GeV<sup>2</sup> in the tungsten nucleus  ${}^{184}_{74}W_{110}$  (" = 0:196)<sup>2</sup>. Input parton distributions are those of the MRS-D0 (1993). In the (u d)<sub>N</sub> = 0 case, = 0 is taken in the MRS-D0 distributions. O btained results are shown in Fig. 1, where the solid curve shows recombination contributions to u d (pernucleon) in the tungsten nucleus, and the dashed curve show s the result in the (u d)<sub>N</sub> <del>6</del>

We brie y comment on Q<sup>2</sup> dependence of our calculation. Because the recombinations are higher-twist e ects, there is a Q<sup>2</sup> dependent factor  $_{s}(Q^{2})=Q^{2}$  in the contributions. It may seem to be very large at small Q<sup>2</sup>; however, parton distributions  $p(x;Q^{2})$  are also modiled. As a consequence, the overall Q<sup>2</sup> dependence is not so significant. A coording to our estimate, there are merely factor-of-two dimensions between the asymmetric distribution at Q<sup>2</sup>= 4 G eV<sup>2</sup> and the one at Q<sup>2</sup> 1 G eV<sup>2</sup>. Considering this factor of two, we indicate the nuclearm odication is of the order of 2% {10% compared with the asymmetry suggested by the NMC.

A lthough our estim ate is based on a special model, the results indicate roughly several % nuclear modi cation in the u d distribution of the tungsten nucleus. Therefore, the existing tungsten D rell-Y and ata should not be compared with the NMC avor asymmetry within several % magnitude. On the other hand, the modi cation itself is an interesting topic for future theoretical and experimental studies.
