E ective Field Theory of Gravity, Reduction of Couplings and the Renormalization Group

Abstract

The structure of the renormalization group equations for the low energy exceptive theory of gravity coupled to a scalar eld is presented. An approximate solution to these equations with a nite number of independent renormalized parameters can be found when the mass scale characteristic of the uctuations in the geometry is much smaller than the Planck mass. The cosmological constant problem is reformulated in this context and some conditions on the matter eld content and interactions required in order to have a su ciently small cosmological constant are identiced.

I. IN TRODUCTION

This work can be classified within the perturbative approach in which quantum gravity is seen as a theory of small quantum uctuations around a at Minkowski background spacetime. From this point of view quantum gravity can be regarded as just another eld theory to be quantised in a standard way as it should be the case for any relativistic quantum theory at low energy [1]. This leads to identify an elective eld theory with the gravitational eld described by a symmetric two-index tensor eld as the low energy elective eld theoretic formulation of quantum gravity.

Like any e ective eld theory its Lagrangian density will contain an in nite number of terms of arbitrary dimensionality and, therefore, is not perturbatively renormalizable in the usual power counting sense [2]. But it is renormalizable in the sense that all the ultraviolet divergences can be cancelled by a renormalization of the in nite number of parameters corresponding to the most general action invariant under general covariant transformations [3]. Then the perturbative approach of renormalized elective theories [4] can also be applied in general relativity. This point of view has been recently advocated by JFD onoghue [5] who shows how some large distance quantum gravitational elects can be derived within this framework.

In order to compute results for physical quantities in an elective eld theory it is necessary to specify the lagrangian together with a renormalization scheme. A natural way to parametrize the lagrangian is based on the introduction of a xed mass scale M, which is a characteristic scale of the physical system described by thee ective theory, and a dimension-less parameter for each term in the lagrangian giving the corresponding coecient in units of M raised to the appropriate power. Then one has an expansion of the lagrangian with terms of dimensionality greater than four suppressed by negative powers of the mass scale M. If one wants to have a well-de ned expansion (with terms of higher dimension being

less im portant in the calculation of physical quantities) a m ass-independent renormalization scheme must be chosen [6].

Each term in the lagrangian of the elective theory of gravity is a product of (covariant derivatives of) matter elds and components of the Riemann tensor. At su ciently low energies and for su ciently small uctuations in the matter elds and the geometry of space-time, the lower dimensional terms in the lagrangian will be dominant and the expansion in the elective lagrangian is a good approximation. At higher energies, and/or for larger uctuations of the matter system or the geometry, higher order terms in the elective lagrangian become comparable to the lower dimensional terms. There is an intermediate situation where corrections to the dominant term can be incorporated as a small perturbation.

In the general case, at each order in the expansion new free parameters appear and the predictibility of the elective theory is reduced. But this is not always necessarily the case. The renormalization group equations, xing the dependence of the renormalized parameters on the renormalization scale, allow to identify special situations where only a nite number of renormalized parameters can be chosen freely. In those cases the predictibility of the theory is not lost when successive terms in the expansion of the elective theory are incorporated.

If one goes beyond the dom ain of validity of the perturbative approach to gravity then new interactions and new degrees of freedom will be required in a new theory beyond quantum eld theory based on some unknown general principles [7]. The main point of this work is to investigate the possibility that this new theory going beyond the perturbative regime is such that its low energy limit is as independent on the details of the theory as possible. In other words we consider an elective eld theory with a minimal number of free renormalized parameters.

In a previous work [8] the general structure of the renorm alization group equations for the e ective eld theory of pure gravity was identied. In the limiting case where the mass scale of the e ective theory is much smaller than the Planck mass (a possibility compatible with the renormalization group equations), a theory with just one free renormalized parameter is

obtained when contributions suppressed by inverse powers of the P lanck m ass are neglected. The aim of this work is to extend these results to the elective eld theory of gravity, including m atter elds and non-gravitational interactions. A dditional renormalization group equations for the new parameters as well as the modications induced by these new parameters on the renormalization group equations of the pure gravity theory have to be considered. Then one has to identify what are the conditions to be able to express the elective lagrangian in terms of a nite number of free parameters in a way consistent with the renormalization group equations.

In the next section we consider the renorm alization of the theory of a scalar eld coupled to a sym metric two-index tensor eld invariant under general covariant transform ations. The absence of a dimension full ultraviolet cut-o in a mass independent substraction scheme (dimensional regularization and minimal substraction) allows us to give the general structure of the renormalization group equations for the dimension less renormalized parameters of the theory. The renormalized parameters corresponding to terms in the lagrangian of dimension less than four (mass and cosmological term) can be set equal to zero. In this case the renormalization group equations for the remaining parameters have a triangular structure. For a given term in the lagrangian, the renormalization group equation for the corresponding parameter depends only on a nite number of parameters corresponding to the terms in the lagrangian of dimensionality smaller or equal than that of the original term. The functions are xed by dimensional arguments up to the dependence on the parameter corresponding to the scalar quartic self-coupling term. There is a series expansion in this parameter which can be determined order by order in perturbation theory.

In section 3 a discussion of the possibility to $\,$ nd a renormalized lagrangian with a $\,$ nite number of independent renormalized parameters is presented. Two special cases are identified. In the $\,$ nst case one has a generalization of the reduction obtained in a previous work in pure gravity [8] with a mass scale $\,$ M $_{R}$, characteristic of the $\,$ uctuations in the geometry of space-time, much $\,$ smaller than the Planck mass and an additional dependence on the scalar self-coupling determined perturbatively. A second case corresponds to the

presence of still another new independent param eter corresponding to a term of dimension six in the matter eld lagrangian. This new param eter de nes a new mass scale, associated to the matter eld uctuations, together with the Planck mass and the scale M $_{\rm R}$. In both cases the reduction of the in nite number of param eters in the general elective lagrangian in terms of three or four independent param eters can be determined systematically order by order in perturbation theory by using the renormalization group equations of the elective theory.

In section 4 we discuss the modi cation induced in the renormalization group equations when a mass term in the lagrangian is added. In the general case a cosm ological term is unavoidable and, due to the presence of term s of dim ension less than four in the lagrangian, the renorm alization group equations lose its simple structure and all the in nite parameters appear in the renorm alization group equation of each param eter. The only way to translate to this case the discussion of the possibility to have an elective theory with a nite number of param eters is based on the assumption that the dimensionless parameters corresponding to the mass and cosmological terms in the lagrangian are sudiently small to treat the modications they induce on the functions of the remaining parameters as a small perturbation that can be neglected in a rst approximation. In fact the experimental upper bound on the cosm ological constant forces this to be the case for the cosm ological term and the param eter corresponding to the mass term has to be tuned in such a way that the scalar mass is much sm aller than the remaining mass scales of the elective theory. The consistency of the tuning required on the cosm ological param eter with its renormalization group equation leads to a reform ulation of the cosm ological constant problem [9] at the level of the e ective theory. Di erent alternatives to the solution of this problem in connection with the reduction of param eters in the e ective theory of gravity are discussed.

We end up in section 5 with a sum mary and some concluding com ments.

II. RENORM ALIZATION GROUP EQUATIONS. MASSLESS CASE

The main idea in this work is to try to get some information on quantum gravity from the renormalization group equations of its elective eld theory formulation. This equations can be derived following the same steps of a perturbatively renormalizable theory in the power counting sense [10]. A very important tool in the perturbative renormalization of an elective eld theory is dimensional regularization [11] and the minimal substraction scheme [12].

We will consider for deniteness the simplest matter system (a real scalar eld) coupled to the gravitational eld but most of the discussion can be translated directly to a general matter system. It is convenient to introduce a xed mass scale M as a reference unit for all the couplings of the elective theory. The general expression for the action can be written, using the invariance under general covariant transformations, in the following form

where L_g , is the lagrangian density of the gravitational eld, and L_m , $L_{n\,m}$: are the lagrangian densities for the m in imal and non-m in imal coupling of the scalar and gravitational elds respectively

A cosm ological constant (constant term inside the brackets in (2.2)) and a mass (2 term in (2.3)) have not been included (later we will see how the structure of the renormalization group equations would be a ected in the presence of such terms). The coe cients $_1$, $_2$, $_4$,..., $_0$, $_2$, $_4$,..., $_0$, $_2$, $_4$,..., are dimensionless parameters.

The dim ensionality of the di erent terms in the action $\,$ xes the power dependence on the mass scale M $\,$ of the elective theory. In the lagrangian density of pure gravity L $_{\rm g}$, R

is the scalar curvature, $R^{(2)}$ is a vector with the three dierent invariants built out of two R iem ann tensors as components, the dierent invariants with three R iem ann tensors or two R iem ann tensors and two derivatives are the components of the vector $R^{(4)}$ and so on. The expansion in inverse powers of the mass scale for the terms depending on the matter eld has been written in a compact notation where $\Gamma_m^{(2n)}$ is a vector whose components are the dierent terms of dimension 4+2n built out of the scalar eld and derivatives of the scalar eld with all derivatives replaced by general covariant derivatives. The additional terms of the same dimension involving the R iem ann tensor are the components of $\Gamma_{nm}^{(2n)}$; in the energy expansion of the norm in in all coupling of the scalar and gravitational elds (2.4).

For the 1st term s in the e ective eld theory expansion one has

The general param etrization of the elective action is redundant for two dilerent reasons. First, a change in the scale M is equivalent to an appropriate rescaling of every dimensionless param eter. Second, by using a non-linear rede nition of elds it is possible to eliminate some of the terms in the action (2.1)-(2.4). Nevertheless it is simpler to use this redundant param etrization in order to identify the general structure of the renormalization group equations. There are two simple examples for a convenient choice of the mass scale of the elective theory M. If there is a choice of the scale M such that all the dimensionless parameters $^{(i)}_{2n}$ in the lagrangian density of the gravitational eld L_g are simultaneously of order one then this scale characterizes the size of the uctuations in the geometry. A Itematively, if there is a choice of M such that all the dimensionless parameters $^{(i)}_{2n}$, $^{(i)}_{2n}$ are of order one then this is the scale characteristic of the matter eld uctuations. Once the scale of the elective theory M has been choosen as one of the scales of the physical system, using the Newtonian limit of this action one has $^{(2)}_{1} = 16$ $^{(M)}_{1}_{2n}$ where M $_{1}_{2n}$ is the Planck mass. Then $^{(1)}_{2n}$ gives the scale M in units of the Planck mass.

The simplest case, a system with a unique natural scale (Planck mass), corresponds to an elective action with all the dimensionless parameters of order one when M Mpl. Next one can consider a case where all the parameters except 1 are of order one at a given value of M and it corresponds to a system with two mass scales, one associated to the classical limit and a common scale for the geometry and matter eld uctuations. A nother possibility is that there are two dierent choices for M, one making all $\frac{(i)}{2n}$ of order one and a second one making all $\frac{(i)}{2n}$, $\frac{(i)}{2n}$ of order one; in this case there are two dierent scales for the uctuations of the geometry and the matter system together with the Planck scale. One could consider even more complicated systems with more and more dierent characteristic mass scales corresponding at the level of the elective eld theory to richer hierarchies for the dimensionless parameters.

A perturbative analysis of the action (2.1)-(2.4) based on the decom position of them etric

can be done [13{15] by using the standard methods of gauge theories. A non-invariant term (gauge xing) has to be added to the action (2.1), for example

where $^{\sim}$, $^{\sim}$, are the set of dimensionless parameters appearing in L_g , L_m , $L_{n\,m}$: respectively. The renormalization group functions are determined perturbatively from the residues of the simple poles at =0 in the relations between bare and renormalized dimensionless parameters. In the parametrization used in (2.1)–(2.4) any interaction term with the gravitational eldh is proportional to $_1$. This is the reason why the parameters corresponding to the non-minimal coupling appear in the renormalization group equations through the combination $_1^{\sim}$.

D im ensional arguments together with the presence of a single mass scale M (the dependence on the renormalization scale is logarithmic) lead to identify a simple structure for the renormalization group equations which is a generalization of the structure found in the case of pure gravity [8]. The functions satisfy the homogeneity conditions

These conditions put strong restrictions on the dependence of the functions on all the dimensionless parameters with one exception, the scalar self coupling $_{0}$. Each renormalization group beta function will be a polinomial in the remaining parameters of a given degree with a series expansion in $_{0}$ as coefcients which can be determined order by order in perturbation theory. From (2.12)–(2.14) one can see that the dependence of \sim_{2n} , \sim_{2n} , \sim_{2n} , is xed by a nite number of parameters \sim_{k} , \sim_{k} and \sim_{k} with k 2n. This triangular structure of the renormalization group equations in a mass independent renormalization scheme is the main ingredient in the discussion of the elective eld theory formulation of gravity presented in this work.

A mass for the scalar eld and a cosmological constant term corresponds, in the parametrization of the eld theory we are using, to the addition of a term $_2$ M 2 and $_2$ M 2 inside the brackets in (2.3) and (2.2) respectively. The modi cations in the renormalization group equations are the addition of two equations for $_2$ and $_2$ and the presence of new contributions in the functions depending on $_2$, $_2$. The homogeneity conditions (2.11)-(2.14) can be generalized including $_2^0$ = t $_2^2$ and $_2^0$ = t $_2^2$ or $_2^2$ and then a vanishing mass and cosmological constant parameters, required in order to get the simple triangular structure for the dependence of the parameters of the elective action, is consistent with the renormalization group equations.

To illustrate the general previous considerations we will end up this section by writing explicitly the renormalization group equations for the rst terms in the $\frac{1}{M}$ expansion of the ective action. One has

where $B_0^{(k)}$ are power expansions in $_0$. There is no e ect of the gravitational interaction on the dependence of the scalar self-coupling and (2.16) is the renormalization group

equation of the ⁴ theory. The function for ₀ can be read from the insertion of an external graviton and a single gravitational coupling on the scalar self-energy and it does not involve any e ect from the uctuations of the gravitational eld. This is the reason why there is a common power expansion in ₀ for the two terms in the function for ₀, and the relative coe cient, 12, can be read from the one loop results for the divergencies of gravitation interacting with a scalar particle [13].

Next one has

This is because any gravitational interaction is proportional to $_1$ and it is not posssible to have a divergent $^{\frac{1}{2}}$ contribution compatible with (2.11). At order $^{\frac{1}{M^2}}$ the renormalization group equations are

where once more one has several coecients B $_2$ as power expansions in the self-coupling $_0$. The generalization to higher orders terms in the $\frac{1}{M}$ expansion is obvious.

The zero order term in the expansion of $B_2^{(i;1)}$, $B_2^{(i;2)}$, $B_2^{(i;3)}$ for the gauge xing in (2.7) can be read from the one loop calculations in [13,14]. The determ ination of the renormalization group coe cients for $A_2^{(i)}$ in lowest order requires a two loop calculation whose results in the case of pure gravity are given in [14]. Although the divergences, and then the coe cients of the renormalization group equations, depend on the gauge xing condition [16], there are no additional substractions and a modi cation of the gauge xing condition simply gives an equivalent formulation of the ective eld theory.

The general structure of the renorm alization group equations based on dimensional arguments will be valid beyond the simple example of a scalar eld considered in this section. The only dierence will be on the number and explicit form of the dierent terms in the minimal and non-minimal coupling of the matter system to the gravitational eld and on the values for the coe cients of the counterterms which determine the coe cients in the renormalization group equations.

III.REDUCTION OF COUPLINGS

A . G eneral considerations

The idea of looking for relations between the couplings of a renormalizable eld theory which are independent of the renormalization scale and compatible with the renormalizability of the theory has been studied in recent years for dierent purposes [17]. The program of reduction of couplings was initiated in [18] by looking for massless renormalizable theories in the power counting sense with a single dimensionless coupling parameter. The same basic ideas were considered in [19] in order to understand the presence of a nite number of parameters in a renormalizable theory despite the appearence of an in nite number of interaction terms in the light-cone quantization method. The underlying Lorentz covariance and gauge invariance, which are not manifest in this quantization scheme, are rejected in the possibility to determine the renormalization group trajectories in terms of a nite number of running variables.

In the case of the elective eld theory formulation of gravity one also has an in nite number of interaction terms as required by the ultraviolet divergences of the theory but one can consider the possibility to have a nite number of independent renormalized parameters. The reduction of couplings in this case could be a consequence of a symmetry of the underlying fundamental theory which is hidden in the eld theoretical limit. If the elective eld theory of gravity is a result of the application of the reduction program then one has

a situation where the eld theoretical approach goes as far as possible in the sense that the low energy lim it of the theory is only sensitive to the details of the underlying theory through the value of a nite number of parameters.

This idea has been studied in the simpler case of pure gravity in [8]. The result is that it is possible to express all the parameters \sim_{2n} in terms of two parameters \sim_{1} and \sim_{2} in a way compatible with the renormalization group equations. But in the general case there are as many free parameters in these relations as parameters \sim_{2n} due to the trivial dependence of \sim_{1} . Then one has a real reduction of couplings only when one assumes that \sim_{1}^{2} which corresponds to a mass scale for the uctuations of the geometry much smaller than the Planck mass, and keeps only the dominant term in the expansion in powers of \sim_{1} . The aim of this section is to consider possible extensions of the reduction of couplings in the presence of a scalar matter eld coupled to the gravitational eld. The main difference with the pure gravity case is the presence of a parameter, \sim_{1} , in the renormalization group equations and in the relations between couplings. The dependence on this new parameter is not xed by dimensional considerations and is incorporated order by order in a perturbative expansion. A nother difference comes from the possibility to consider new reductions of couplings with an additional independent parameter \sim_{2} associated to the matter system.

B. M in im al reduction

The triangular structure of the renormalization group equations allows to look for reduction of parameters order by order in the $\frac{1}{M}$ expansion of the elective theory. In lowest order the relevant parameters to consider are $_0$, $_0$ and the renormalization group equations (2.16), (2.17). A reduction at this level corresponds to express $_0$ as a power expansion in $_0$ with coefcients are in order to reproduce its dependence. The only posssible reduction is a trivial one, $_0$ = $\frac{1}{12}$.

At order $\frac{1}{M^2}$ the rst parameter to consider is \sim_2 . The renormalization group equation (2.19) can be written, using the reduction of $_0$, as

The factorization at this level of the radiative corrections due to the matter eld leads to identify a unique power expansion in $_{0}$, A_{2} ,

where the zero order term in A_2 is chosen to be one and the constant coe cients a $_2^{(0)}$ can be read from the one loop result [13] for the counterterm's quadratic in the Riemann tensor. A reduction of couplings at this level can be obtained if one introduces a dimensionless parameter $_2$ with a renormalization scale dependence given by

Then it is possible to write the parameters $_{2}^{(i)}$ in terms of $_{2}$ and $_{1}$ in a way compatible with the renormalization group equations,

but, as a consequence of the independence of $_1$ on the renormalization scale, the coe cients $a_2^{(1)}$ are free parameters and the relations (3.4) are not real reduction equations but $\sin ply$ a reparametrization. If $_1^2$, and one takes the dominant term in the expansion in powers of $\frac{2}{1}$ in (3.4), then one has a reduction of couplings for the terms quadratic in the Riemann tensor.

The next step is to consider the renormalization group equations for the parameters corresponding to terms of dimension 6 in the minimal coupling of the scalar and gravitational elds. Using the reduction of \sim_2 and $_0$ one has

If one does not consider additional free parameters (m in im al reduction) then one has to be able to express $_2^{(i)}$ in term s of $_0$, $_1$ and $_2$. Consistency with the renormalization group equations leads to

where I_2 are power expansions in $_0$ with coe cients determined order by order as the solution of consistency equations which reduce to a linear system of equations.

If one inserts the reduction of parameters in the previous steps into the renormalization group equations (221) for the normal inimal couplings of dimension 6, one obtains

Once more the reduction of the parameters $2^{(i)}$ is uniquely determined by the renormalization group equations,

where each term in the expansion in powers of $_0$ of \mathbf{x}_2 is the solution of a linear system of equations.

The iterative procedure to reduce param eters can be applied to the rem aining param eters of the e ective theory. For the term s of order $\frac{1}{M-4}$ in L_g one has

and a reduction consistent with the renormalization group leads to

The coe cients $a_4^{(k)}$, k=0;1;2, are power expansions in 0 determined by a system of linear equations with one exception, the coe cient of 0 in $a_4^{(2)}$, which does not appear in the consistency equations. Then once more the relations (3.10) are not a real reduction but a reparam etrization in terms of the arbitrary constant coe cients of $a_4^{(2)}$.

For the $\frac{1}{M^{\ 4}}$ terms in L_m one has the reduced renormalization group equations

which can be used to extend the reduction to the non-minimal couplings

The steps followed in the determ ination of the reduction of the parameters corresponding to term soforder $\frac{1}{M-4}$ can be repeated order by order in the expansion in $\frac{1}{M}$ to get the minimal reduction of the eld theory of gravity coupled to a scalar eld which is given by the relations

The condition to have a real reduction of couplings is that $\frac{2}{1}$ 2. In this case we have shown that there is a unique way to not perturbatively a unique lagrangian with the property that all the couplings can be written, at any renormalization scale, in terms of three independent dimensionless parameters 0, 1 and 2. The reduction equations (3.14) as well as the -dependence of the independent parameters (2.16), (2.18), (3.3) can be determined from a perturbative calculation of counterterms.

Each of the parameters of the reduced theory allows to identify a typical scale of the system. The scale associated to the parameter $_0$ can be taken for example as the scale M $_0$ such that $\frac{_0 \, (\, = \, M_{\, 0}\,)}{4} = 1$ and it is set the range of validity of the perturbative approach to the elective theory. If we choose the scale M in the energy expansion of the elective theory as M $_0$ then the second parameter $_1$ is associated to the scale characteristic of the classical limit, the P lanck mass M $_{P\,1}$ through the relation $\frac{2}{16} = \frac{M_{\, 0}^{\, 0}}{M_{\, P\,1}^{\, 2}}$. The parameter $_2$ (M $_0$) allows to introduce a third scale in the system which is the scale characteristic of the uctuations of the geometry M $_R$ generated by the matter system at the scale M $_0$. From the expansion

of L_g in powers of the Riemann tensor one gets $_2$ (M $_0$) = $\frac{M_0^2}{M_R^2}$ and the condition for the validity of the reduction $_1^2$ $_2$ in terms of the three scales of the system corresponds to the condition that M $_R$ M $_{P,1}$.

C. Non-m in im al reduction

The m in im all reduction of couplings is an extension of the reduction found in the case of pure gravity in [8] with the addition of the self-coupling $_0$ to the independent parameters $_1$ and $_2$. An alternative to this reduction corresponds to introduce still another independent parameter from the matter system lagrangian. This can be done by going back to the renormalization group equations for $_2^{(i)}$ (3.5) and introducing a new independent parameter $_2$ with a renormalization scale dependence given by

where L_2 is a new expansion in powers of $_0$ to be conveniently choosen in a way compatible with the renormalization group equations. The most general form for the reduction of the parameters $_2^{(i)}$ compatible with dimensional arguments has three terms proportional to $_2$, $_2$ and $_1^2$ respectively with one cients, depending on $_0$. These one cients can be determined perturbatively through the consistency conditions on the reduction in posed by the renormalization group equations. The solution can be written in the form

The parameter $_2$ can be chosen such that L_2 is a constant corresponding to one of the eigenvalues of the matrix given by the zero order term in the expansion of $L_2^{(i;j)}$ appearing in the renormalization group equation of $_2^{(i)}$ (3.5). The zero order terms in the expansion in powers of $_0$ of $L_{2;0}^{(i)}$ are the components of the corresponding eigenvector. The remaining terms in the expansion of the coefficients in the reduction, $L_{2;0}^{(i)}$ and $L_{2;1}^{(i)}$, are the solutions of the remaining consistency conditions which reduce to a system of linear equations.

Once the new independent parameter $_2$ has been introduced, with its corresponding renormalization group equation (3.15), there is no diculty to repeat the step by step reduction of the remaining dimensionless parameters in the elective theory. The results for the rest terms in the $\frac{1}{M}$ expansion are

The expansion in powers of $_0$ of the reduction coe cients \mathbf{a} , $_0$, is xed by a set of linear systems of equations with the exception of the term proportional to $_0^3$ in $\mathbf{a}_{4,3}$ which remains undetermined. Once more a real reduction of couplings requires to assume that $_1^2$ and to neglect terms supressed by powers of $_2^2$ in the reduction equations (3.17).

The new independent parameter $_2$ in this nonm inimal reduction corresponds to a new mass scale M $_E$ in the energy expansion of the matter system related to the dimensionless parameter $_2$ by $_2$ (M $_0$) = $\frac{M_0^2}{M_E^2}$. One can see the nonm inimal reduction as an extension of the scalar elective eld theory with two free parameters $_0$ and $_2$. The gravitational interaction introduces at least two additional parameters $_1$ and $_2$. The main difference with respect to the minimal reduction discussed in the previous subsection is that the contributions of higher dimensional operators in the matter system lagrangian are not necessarily suppressed by inverse powers of the Planck mass.

IV.MASSIVE CASE.COSMOLOGICAL CONSTANT PROBLEM

If one considers the gravitational interaction of a massive spinless particle then one has to include a term $_2$ M 2 in the matter lagrangian density. The dimensionless parameter $_2$ has to be taken into account in the discussion based on dimensional arguments leading to

the general structure of the renormalization group equations. The homogeneity conditions of the functions for the parameters $_1$, $_{2n}$, $_{2n}$, $_{2n}$, $_{2n}$ include the rescaling of the additional parameter, $_2^0$ = $_2^0$, and the simple triangular structure is lost due to the contributions proportional to positive powers of $_2^0$ which will be accompanied by the parameters corresponding to terms of higher dimensionality. If one wants the reduction of couplings to be applicable also in this case then one has to assume that the dimensionless parameter $_2^0$ is suiciently small to treat its elects as a small perturbation. The additional parameter is associated to a new mass scale in the system, the scalar particle mass m $_2^0$ = $_2^0$ M $_2^0$, and the reduction of couplings requires this scale to be much smaller than any of the other mass scales of the system. The reduction of couplings identified in the previous section for the massless case can be taken as the zero order term of an expansion of the reduction equations in powers of the parameter $_2^0$.

A nothere ect of the mass of the scalar particle is that one has to consider simultaneously a cosm ological constant. This can be seen from the renormalization group equation for the dimensionless parameter $_2$, corresponding to the cosm ological term, which can be written in the form

The rst terms in the expansion in powers of $_2$ for the renormalization group equation of the dimensionless cosmological parameter are

The cosm ological constant parameter $=\frac{2}{2}M^4$ can be written in units of the scalar mass by using the dimensionless parameters $_1$, $_2$ and $_2$ as

$$\frac{1}{m^4} = \frac{2}{\frac{2}{1}\frac{2}{2}} = \frac{2}{\frac{2}{1}\frac{2}{1}\frac{2}{2}} : \tag{4.4}$$

This, together with the renormalization group equation (4.3), gives a reformulation of the cosm ological constant problem at the level of the elective eld theoretic formulation. It is not possible to have $\frac{2}{1} = \frac{2}{2}$ over the energy range of validity of the elective theory and then it is not possible to have $\frac{2}{m^4} = 1$ as required by the experimental upper bound for the cosmological constant.

In order to discuss possible solutions to the cosm ological constant problem one has rst to consider, instead of a scalar eld, a realistic matter system including ferm ion and gauge elds with the strong and electroweak interactions of the minimal standard model of particle physics. If the matter system content of elds and interactions is such that as a consequence of a symmetry $\frac{1}{2} = 0$, then

and the cosm ological param eter can be made arbitrarily small.

Taking into account that $\frac{2}{1-2} = \frac{m^2}{M_{Pl}^2}$ is of the order of 10^{-32} for a mass scale of the matter system m of the order of 1 Tev, another possibility to solve the cosm ological problem

is based on the assumption that the rst two terms in the expansion of $_2$ vanish. The remaining terms can be made compatible with the smallness of the cosmological constant if the combinations of parameters, appearing in the coe cient of $_2$ inside the brackets in (4.1), are not much bigger than $_1$.

If one considers a m in im all reduction of the electric theory for a realistic matter system with the same number of independent parameters $_2$, $_0$, $_1$, $_2$ as in the case of a scalar eld, then the renormalization group equation of the cosmological parameter will be given by

where the coe cients $A^{(k)}_2$ are power expansions in the parameter $_0$. In this case the possible solution of the cosm ological constant problem based on the vanishing of the rst few terms in the $_2$ expansion of the -function gives just two conditions on the matter system,

A ssum ing that the remaining coe cient expansions are of order one, one has the additional condition for the independent dimensionless parameters $\frac{2}{2}$ 10 which corresponds to the restriction on the mass scales of the elective theory $\frac{M_R^2}{M_{Pl}^2}$ 10 on the contrary, if the solution to the cosmological problem is based on some symmetry of the underlying theory leading to A $_2^{(k)}$ = 0 there is no restriction, due to the smallness of the cosmological constant, on the mass scales of the elective theory.

The cosm ological constant problem can be discussed along the same lines if there is a nonm in imal reduction of the elective theory with an additional parameter $_2$. In this case one has the renormalization group equation for the dimensionless cosmological parameter

In this case a solution to the cosm ological constant problem based on the vanishing of the rst two terms in the expansion in powers of 2 requires that the matter system satisfies the three conditions

and one also has the bounds for the param eters $_2$ and $_2$,

which gives a restriction on the aditional mass scale M $_E$, $\frac{M_E^2}{M_{p_1}^2}$ 10^3 .

V.SUM MARY

It has been shown that the perturbative renormalization of the theory of a scalar eld coupled to the gravitational eld, which requires an in nite number of counterterms, is com patible with the presence of only a nite number of renormalized parameters which can be choosen arbitrarily at a given scale. In this sense one has a theory with the same predictibility as a renormalizable theory in the power counting sense. The corrections to the low energy lim it due to the higher order terms in the energy expansion of the e ective theory do not necessarily involve additional free param eters. This result found in the case of pure gravity [8] has been extended to the case of a scalar eld coupled to gravity in two di erent forms (minimal and non-minimal reduction of couplings). The e ective theory has several characteristic mass scales: the scale associated to the classical limit (the Planck m ass M $_{\rm P\,I}$), the scale associated to the uctuations of the geom etry (M $_{\rm R}$), the scale of the uctuations of the matter system (M $_{\rm E}$), the scale limiting the validity of the perturbative treatm ent (M $_{0}$) and the mass of the scalar eld (m). Each of these scales is in one to one correspondence with the independent dimensionless parameters of the elective theory after a reduction of couplings compatible with the renormalization group equations. The reduction of couplings puts som e limitations on the mass scales. The reduction of the couplings in the gravitational lagrangian requires $\frac{2}{1}$ 1 and then M $_R$ M $_{P\,1}$. The treatment of the scalar mass as a perturbation requires $_2$ $_2$ 1 which implies that m M $_E$. In the case of minimal reduction one has $_2$ $_1^2$ and then M $_E$ M $_{P\,1}$.

In order to have an energy range within the perturbative domain where some of the low energy limit corrections have to be included, it is necessary for either M $_R$ or M $_E$ to be smaller than M $_0$. In the case of minimal reduction of couplings the contribution from a term $L_m^{(n)}$ in the matter lagrangian, which is of order $\frac{2n}{M}E^{2n}$ when one is considering the matter system at energies of order E, gives an elect of order $\frac{E}{M_{Pl}}$ $\frac{E^2}{M_R^2}$. Then even if the scale M $_0$ for the domain of validity of the perturbative treatment can be much lower than M $_{Pl}$ one has to consider energies E. M $_R$ in order to go beyond the low energy limit.

It is natural to expect that the results found for a scalar eld coupled to gravity can be generalized to m ore general cases for the m atter system. Instead of the scalar self-coupling $_{0}$ one will have a set of dimensionless couplings for the non-gravitational interactions and instead of the m ass of the scalar one will have one or several m asses for the m atter elds.

The cosm ological constant problem has been reform ulated at the level of the renorm alization group equations. In the presence of a mass for the scalar eld the (logarithmic) derivative of the cosm ological parameter with respect to the renormalization scale has a contribution which is not proportional to the cosm ological parameter. Then it is not possible to have an arbitrarily small value for this parameter over a given range of scales. Two possible solutions of this problem have been considered corresponding to the possibility that these terms in the —function of the cosm ologic parameter which are not proportional to it either vanish for an appropriate choice of matter lagrangian or are su ciently small to be compatible with the smallness of the cosm ological constant. The number of conditions that the matter system have to satisfy, in order to have a solution to the cosm ological constant problem based on the second possibility mentioned above, is signicantly reduced if one considers an elective theory with a reduction of couplings.
