# M ultifractal M ultiplicity D istribution in Bunch ing $P$ aram eter A nalysis

## A bstract

A new multiplicity distribution $w$ th $m$ ultifractalpropertiesw hich can be used in high-energy physics and quantum optics is proposed. It m ay be considered as a generalization of the negative-binom ial distribution. We nd the structure of the generating function for such distribution and discuss its properties.

1. Introduction

M ultifractalanalysis in high-energy physics and quantum optics has received a great interest in recent years due to the possibility to obtain quantitative and qualitative results conceming multiparticle production in di erent processes. In addition, the analysis is becom ing an im portant theoretical tool to discrim inate betw een di erent dynam icalm odels.

The fact that the norm alized factorialm om ents (N FM s)

( $n$ is the num ber of particles in a restricted phase-space interval , h: : :i is the average over all events) depend on the size of the phase-space interval (bin) as $\mathrm{F}_{\mathrm{q}}$ (interm ittency phenom enon) is a manifestation of non-statistical uctuations in the m ultiplicity distribution of secondary particles produced in high-energy physics [1] [4]. The multifractal behavior, when the anom alous fractal dim ension $d_{q}=q_{q}=\left(\begin{array}{ll}q & 1\end{array}\right)$ depends on q , is particularly im portant because such behavior is typical for the vast majority of experim ents $2[4]$. It is $m$ ore pronounced in two-and three-dim ensional

[^0]phase-space dom ains. This behavior has also been found in photon-counting experi$m$ ents on laser uctuations near threshold, where is the counting tim e intervalt [\$]. $T$ hus, the problem ofm ultifractality is a com $m$ on one both for high-energy physics and quantum optics.

In this paper, we shall discuss the theoretical aspect of the problem in the context of high-energy physics by $m$ eans of bunching param eters (BPs) [G]. We introduced this quantity in order to get a sim ple and e cient m ethod for the analysis of com plex multiplicity distributions in restricted phase-space intervals. Our consideration can also be used in any eld of research, where local dynam ical uctuations are a sub ject of investigation.

A s is well know $n$, the negative-binom ialdistribution hasbecom e the focus of interest in view of its applicability to the study of $m$ ultiparticle productions in high-energy physics. H ow ever, it hasbeen noted that this distribution has no m ultifractalproperties for sm all phase-space intervals [6, [].

M oreover, the study of charged-particle $m$ ultiplicity distributions in restricted rapidity intervals conform $s$ that the negative-binom ial distribution is not su cient to describe the data in $Z^{0}$ hadronic decays due to a shoulder structure of the experim ental distributions 圂]. A sim ilar conclusion was obtained by A LEPH collaboration 回]: it was show $n$ that the negative-binom ial distribution does not describe the experim ental data, either in restricted rapidity intervals or in the full phase space. The UA 5 collaboration has also observed that the negative-binom ial distribution fails to give a good $t$ to data at the center-ofm ass energy of 900 GeV [10] in fullphase space due to a shoulder structure. This structure is explained by the superposition of 2 -jet events w th low multiplicities and 3-jet and 4-jet events yielding much larger multiplicities. A s a rule, this leads to $m$ ore com plex $m$ ultiplicity distribution for fullphase space than the negative-binom ial one.

The conchusion must be that the negative-binom ial distribution is not su cient to describe the experim ental distributions both for restricted rapidity windows and for full phase space in de nite experim ental situations and, hence, a true multiplicity distribution $m$ ust be $m$ ore com plicated.

In this paper we propose a new multiplicity distribution which has multifractal properties for $s m$ all phase-space intervals and is very sim ilar to conventional negativebinom ial form for large phase-space intervals. We shall analyze this distribution in term $s$ of BPs and bunching $m$ om ents. A s we shall see, such an investigation is sim pler than the analysis of multiplicity distributions w th the help of NFM s. M oreover, recurrence relations for probabilities can lead to a non-traditional form of generating functions, both forwell-known distributions (P oisson, geom etric, logarithm ic, positivebinom ial, negative-binom ial distributions) and the $m$ ultiplicity distribution with m ultifractal properties for the sm all phase-space intervals.

In the second section, we give a short introduction to the bunching-param eter m ethod. In the third section, we consider the general form of a $\mathrm{m} u$ ultifractal negativebinom ial like distribution and derive its generating function. In Sect. 4, the properties ofM arkov branching process leading to this m ultiplicity distribution are considered. In

Sect. 5, we discuss a particular form of such a generalization of the negative-binom ial distribution and illustrate its multifractal properties. In Sect. 6, we present the conclusions.

## 2. Bunch ing-param eter approach

N orm alized factorial $m$ om ents have become an im portant and popular topic of experim ental and theoretical investigations in high-energy physics and quantum optics. M easuring the NFM s is equivalent to m easuring the m ultiplicity distribution. On the other hand, recently another sim ple $m$ athem atical tool to investigate the behavior of the multiplicity distribution in di erent phase-space intervals has been proposed. In order to reveal \spike" structure of events, one can study the behavior of probabilities them selves by m eans of the BP s. T he de nition of the BPs is given by the form ula [6]

where $P_{q}$ is the probability of nding $q$ particles inside the lim ited phase-space interval 7. For exam ple, $q=1$ for the Poisson distribution. If the size of the phase space is sm alland the average num ber ofparticles in this interval is approxim ately proportional to , then we have the follow ing approxim ate relation between the NFM s and the BPs [6]

Such relation, in fact, $m$ eans that BP s share w ith the N FM sthe property of suppression of Poissonian noise.

For the interm ittent uctuations, one expects $2 / d_{2}$ ( $d_{2}$ is the second-order anom alous fractal dim ension), while the high-order BP s m ay have a di erent dependence on . In [ [ ${ }^{[ }$] it has been shown that for the high-energy collisions w th the multifractalbehavior of the N FM s $d_{q}=d_{2}\left(\begin{array}{ll}1 & r\end{array}\right)+d_{2} r q=2$, the power-like behavior of the BPs ${ }_{2} / d_{2},{ }_{s}={ }_{2}^{r}, s>2$ is valid. The positive param eter $r$ can be interpreted as a degree ofm ultifractality (for $r=0$, we have exactly $m$ onofractalbehavior). Thus, the problem of the multifractalmultiplicity distribution $w$ ith inverse power -dependence of allBPs is central one.

A s discussed in [G], the use of the BPs can give a general answer to the problem of nding a multiplicity distribution leading to observed interm ittency. Indeed, any multiplicity distribution can be expressed as

O $n$ the contrary, a m ultiplicity distribution can not be expressed in term sof its factorial m om ents if this distribution is not truncated one [4].

A necessary and su cient condition for a multiplicity distribution $P_{n}$ to be negative－ binom ial one（ $\left(\mathrm{P}_{\mathrm{n}}^{\mathrm{N}}\right)$ is the recurrence relation 11］

where $a, b$ are positive constants for xed $(b<1)$ ．N ote that throughout this paper we shall treat the probabilities and the param eters $C_{n}, a, b$ as continuous functions of the phase－space interval of size．If $a \in 0, b \notin 0$ ，trerations of（ $\$$ ）$w$ th the norm alization condition ${ }^{P}{ }_{n=0} P_{n}^{N}=1$ give the negative－binom ial distribution．In the lim it b！0，the recurrence relation gives a Poisson distribution．The case a ！ 0 at constant b show s that the negative－binom ial distribution reduces to a logarithm ic distribution．For $\mathrm{a}=\mathrm{b}$ ，we get a geom etric m ultiplicity distribution．For a＞0，b＜0 and $a=b$ integer，we have a positive－binom ial distribution．U sing the de nition of the BPs，固）and theorem of［⿴囗⿱一一 $]$ ，it is easy to see that none of these distributions leads to multifractality if any assum ption is chosen for the behavior of $a, b$ in $s m$ all phase－space bins．

Thus，it is im portant to nd som em ultifractalgeneralization of the com $m$ only used multiplicity distributions．From a physicalpoint ofview，to nd such a multiplicity dis－ tribution，in fact，$m$ eans to understand the reasons of interm ittency with multifractal behavior of the anom alous fractal dim ensions．H ow ever，the level of theoretical under－ standing of this phenom enon is still insu cient（hadronization problem）and is quite di erent for various types of collision processes［ 4 ］．Nevertheless，from a $m$ athem atical point of view，we can propose a distribution that has a priorim ultifractalbehavior．

There is a naturalw ay to include BP sw ith pow er－law behavior into a new recurrence relation in order to obtain a m odi cation of（5）which can generate the multifractal multiplicity distribution in the lim it ofsm all．To see this，let us rew rite the de nition （2）ofBPs as follows

A smentioned in Sect．2，for a m ultifractalbehavior $w$ th $r=1$ ，all BP s have the sam e pow er－law behavior，i．e．，in the sim plest case，we can write

$T$ he is a positive constant and is taken as a $m$ easure of the strength of the $m$ ultifractal e ect．A fter that，by com bining（5）and（6），we assum e the follow ing recurrence relation

where $n$ 1．Here，in fact，$g$ can be either a new param eter or som e com bination of the param eters $a$ and $b$（the latter case we shall discuss below）．Equation（8）is a
su cient condition to construct a distribution which for a large phase-space interval
( $g \quad 1$ ) is very sim ilar to the multiplicity distribution (S) and has the multifractal behavior for a sm all phase-space interval (the value of $g$ is not $s m a l l)$.

The expression (8) can be rew ritten as

W e have $m$ ultifractal behavior because the second term in 11) has power-law behavior and, for enough $s m$ all , can be the leading one. The multiplicity distribution corresponding to ( $\mathrm{g}^{\prime}$ ), (G) is

Throughout this paper, we consider the probability $P_{0}=1 \quad P_{n=1}^{1} P_{n}$ of having no particles in as a norm alization constant. Since in the lim it 9 ! 0 expression (14) reduces to a negative-binom ialdistribution, we shall call this distribution a m ultifractal negative-binom ial distribution (MNBD) and denote it as $P_{n}^{M}$.

Let us note that we can analyze a multiplicity distribution w ritten in term $s$ of the recurrence relations using the generating function for $P_{n}=P_{n} \quad$. Let

N ow let us mention two lim iting cases:
a) In the sim plest Poisson case, when $b=0$, we have the follow ing multifractal Poisson distribution w th the generating function of the form

Here $a$ is not an average multiplicity as for a usual Poisson distribution.
b) The lim it a! 0 is also interesting since it leads to the multifractal logarithm ic distribution

where $q>2$ and $P_{1}$ is a nom alization constant (for the logarithm ic multiplicity distribution, $P_{0}=0$ ). We see that these $m u l t i p l i c i t y ~ d i s t r i b u t i o n s ~ h a v e ~ t h e ~ s a m ~ e ~ p o w e r ~$ law behavior of the high-order BPs for sm all. In this sense, the distributions are equivalent for sm all phase-space intervals.

It is im portant to em phasize here that an in nite sequence of probabilities $\mathrm{P}_{\mathrm{n}}$ can be norm alized if it converges, i.e., if $\mathrm{P}_{\mathrm{n}}$ ! 0 for $\mathrm{n}!1$. This is possible if, for every i greater than som e number, we have the follow ing condition

For any other dom ain of $g$, we m ust truncate the $M N B D$, putting $P_{i}^{M}=0$ for $i>$.
O ne can understand, from de nition (8), that BP s are sensitive to the localm ultiplicity uctuations (or to the behavior of the multiplicity distribution in sm all phasespace intervals) near the multiplicity $q=n \quad 1$. In order to study the totalcontribution from multiplicity uctuations for large values of $n$, it is appropriate to introduce the \bunching $m$ om ents" $b_{q}$ as follow s

follow ing an analogy w ith factorialm om ents. The know ledge ofthe generating function gives us a possibility to calculate both the BPs and the bunching $m$ om ents. The higher the rank of the $b_{q}$, the $m$ ore sensitive they are to the \tail" of the multiplicity distributions for large $n$. In order to norm alize the bunching $m$ om ents $B_{q}$, we put

This $m$ eans that the negative-binom ial distribution is broader than the Poisson distribution $\left(B_{q}^{N}>B_{q}^{P}\right)$. For the geom etric multiplicity distribution $(k=1)$, the nor$m$ alized bunching $m$ om ents are larger than those of the negative-binom ial distribution $w$ ith $k>1$. In this case, we can say that the geom etric distribution is broader than the negative-binom ial one. For the positive-binom ialm ultiplicity distribution, where $\mathrm{k}<0$ and integer, the norm alized bunching $m$ om ents are $s m$ aller than unity because this distribution is narrow er than P oisson.

Form NBD (2G), one gets

$q=1::: 1$. For a small $g$ (or for a large phase-space interval), the M NBD slightly di ers from the negative-binom ial distribution. For $g!0\left(B_{q}^{M}!B_{q}^{N}\right)$, the M NBD tends to the negative-binom ial distribution. The situation drastically changes when large $g$ (or sm all ) is considered. The $B_{q}^{M}$ becom es larger than $B_{q}^{N}$, since the M NBD becom es broader than the negative-binom ialdistribution for all $k$. Bear in $m$ ind of this property, it is not surprising that for this region of phase space the MNBD re ects the increase of the local interm ittent uctuations and can lead to a multifractal behavior of the anom alous fractal dim ension.

The generating function $Q={ }_{\mathrm{P}}^{1}{ }_{\mathrm{n}=0} \mathrm{z}^{\mathrm{n}} \mathrm{P}_{\mathrm{n}}$ com m only considered in probability theory and its applications can also be used in the $m$ ultifractalgeneralization 12]. To analyze this generating function, it is appropriate to use the usual NFM s or the nom alized cum ulant $m$ om ents [7]. In fact, these two "languages", using the BPs and the NFM s for the study of $m$ ultiplicity distributions in term $s$ of the generating functions $G$ and $Q$, are equivalent. N evertheless, in som e cases, the analysis of $m$ ultiplicity distributions in small with the help of BPs and the bunching $m$ om ents is sim pler, because an analytical form of the N FM s for som em ultiplicity distributions $m$ ay be too com plicated. For exam ple, to nd a simple form of the generating functions form ultifractal distributions (12), (22), (23), is rather di cult. The technical advantage of the use of these quantities com es $m$ ainly from the fact that, as a rule, the structure of the ratio $P_{n}=P_{n}$ is simpler than the form of the probabilities $P_{n}$ them selves.

It is appropriate to $m$ ake som e rem arks here on the relationship between the form of the recurrence relation (8) and the de nition of the generating function (13). The particular form of recurrence relation (8) was chosen because of its sim plicity. For exam ple, the factor ( $n \quad 1$ ) $=\mathrm{n}$ in the last term of ( $\$$ ) was chosen only because it is possible to rew rite this relation in the form of generating function (13). It is easy to check that other sim ilar form $s$ involving $P_{n}$ and $P_{n} \quad$ in the recurrence relation can lead to qualitatively sim ilar results, providing a singular form of BPs for all order.

H ow ever, in these cases, one needs to introduce other form s of generating function in order to obtain a di erential equation for the M NBD w ith sim plest solutions.

## 4. The M NBD as a solution of non-linear M arkov process

Now we shall show that the form of the M NBD can be obtained from a stochastic $M$ arkov process with non-linear birth rate. Let $P_{n}(t)$ be the probability to have $n$ particles at timet. Of course, such a choice of an evolution param eter is not unique. In principle, the evolution variable $t$ can be connected, for exam ple, $w$ th the squared $m$ ass of the branching parton in the parton shower. For sim plicity, we shallassum e that the process starts at tim $\mathrm{e}=0$, w ith the in itialcondition $\mathrm{P}_{0}(\mathrm{t}=0)=1, \mathrm{P}_{\mathrm{n}}(\mathrm{t}=0)=0$, $n>0$. We shall consider a very generalbirth-death process $w$ ith an in nitesim albirth rate $\mathrm{w}_{\mathrm{n}}^{+}$and an in nitesim al death rate $\mathrm{w}_{\mathrm{n}}$ of particles, treating these param eters as continuous functions of $t$. The corresponding $M$ arkov equation is

[13]. For a stationary process, when tim e goes to in nity, the $P_{n}(t)$ are $t$-independent constants. Then, from (34) one has $n \quad n+1=0, n=1 ; 2 ;: \% \quad n=w_{n} P_{n} \quad w_{n}^{+} P_{n} P_{1}$. Taking into account $0=0$, we have $n=0, n \quad 1$ and, hence, a solution of (34) in the form of the recurrence relation

The negative-binom ial distribution can be considered as a stationary solution of (34) if we put the linear form $s$ for $w_{n}^{+}$and $w_{n}$,

where $\mathrm{a}==$ and $\mathrm{b}==($, aret-independent $)$. Ifwe adm it that the param eter $\mathrm{w}_{\mathrm{n}}^{+}$is the non-linear function of n , i.e.,

then the M NBD can be found as a stationary solution of the evolution equation (34). Here, in fact, param eter $g$ represents the strength of in uence of the non-linearity in the equation. For ! 0 the non-linearity of the birth rate increases.

So, the multifractal structure of M NBD can be caused by the non-linearity of the stationary $M$ arkov process. From the point of view of high-energy physics, the multiparticle production in QCD and the subsequent transition to hadrons have a strongly non-linear nature. In this sense, the form of (37) m ay re ect the non-linearity of the underlying m ultiparticle dynam ics leading to m ultifractality.

## 5. The choice of param eter $g$ and application to experim ental data

Up to now, we have considered $g$ as a free param eter $w$ ith the power-law behavior g / . The next question is how does one choose $g$, if one wants to obtain the multiplicity distribution with a degree of multifractality r (see Sect. 2). T he sim plest way is to assume the follow ing form

where ! ( $r$ ) is som e function which tends to zero for $r$ ! 0 (in the sim plest case, ! $(\mathrm{r})=$ r). T he param eter $r$ allow $s$ interpolation betw een the negative-binom ial distribution $w$ th m onofractalbehavior $(r=0)$ and the M NBD w ith the multifractalbehavior ( $r>$ 0). Let us rem ind that the aggregation coe cient k ${ }^{1}$ is related to them ean multiplicity $\langle\mathrm{n}\rangle=\mathrm{a}=\left(\begin{array}{ll}1 & \mathrm{~b}\end{array}\right)$ and the dispersion D of the negative-binom ialdistribution $a s \mathrm{D}^{2}=<$ $\mathrm{n}\rangle+\langle\mathrm{n}\rangle^{2} \mathrm{k}^{1}$ 。

From the point ofview ofhigh-energy physics, ourchoice is justi ed by the follow ing reasons:
i) Ifwe have the negative binom ialdistribution, for a large (pseudo) rapidity interval $k^{1}$ has a small value $\left(k^{1} \quad 0: 1 \quad 0: 01\right)$. A pplying a $t$ by (12), we can hope that $g$ in the M NBD will be sm all also and this distribution will be sim ilar to the negativebinom ialdistribution.
ii) It is essential that the negative-binom ialdistribution is approxim ately valid, not only for large phase-space intervals, but also for sm all ones. For the negative-binom ial distribution, the behavior $k^{1} /$ lies in the fram ew ork of the assum ption that interm ittency is govemed only by the aggregation coe cient. In [7V an H ove showed that, if $k^{1} /$ for sm all , then the negative-binom ialdistribution has $m$ onofractal behavior, $\mathrm{F}_{\mathrm{q}} / \mathrm{d}_{\mathrm{q}}\left(\mathrm{n}{ }^{1)}, \mathrm{d}_{\mathrm{q}}=\right.$. Then $2 /, \mathrm{s}=$ const:, $\mathrm{s}>2$ [6]. In our case, the assum ption ! (r) 0 yields interm ittency with the multifractal behavior of the anom alous fractal dim ension.

From the experim ental point of view, a good approxim ation for the aggregation coe cient of the negative-binom ial distribution is [4]

where and are three-dim ensionalfulland lim ited phase-space intervals, respectively, $\mathrm{d}_{2}$ is the anom alous fractal dim ension of the second order. For di erent reactions, the param eters $c$ and $d_{2}$ are of the sam e order ofm agnitude, $m$ oreover, the $d_{2}$ has alm ost universal value 0:4 [14]. Expression (3p) has been obtained from the well-known relation $\mathrm{F}_{2}^{\mathrm{N}}=1+\mathrm{k}^{1}$ between second-order NFM and the aggregation coe cient which is correct for the negative-binom ial distribution.
iii) Since the ts for di erent reactions show a logarithm ic increase of $k{ }^{1}$ w ith energy ${ }^{P} \bar{s}$ in the negative-binom ial distribution, one $m$ ay expect that for the M NBD
we shall obtain the sim ilar e ect. Then, the distribution (12) in the full phase space $m$ ay slightly di er from the standard negative-binom ial distribution for large energies. $T$ his is quite im portant because, as $m$ entioned already in the introduction, the usual negative-binom ial distribution fails to describe multiplicity distributions at 900 GeV in pp collisions and in $\mathrm{Z}^{0}$ hadronic decay for full phase space.

Let us obtain the anom alous fractaldim ension for the M NBD in the particular case, when $g=!(r) k{ }^{r}$. The calculation of the NFM s can be smpli ed when an average multiplicity in is sm all. Then, the N FM s are given by expression (\$). Let us discuss two dom ains of the param eter $r$ :
(i) 0 r 1: From (11) we have

W e se that, if $\mathrm{k} / \mathrm{d}_{2}$, the leading term s of the BP s have the follow ing behavior: 2/ $\mathrm{d}_{2}$, $\mathrm{s} / \mathrm{rd}_{2}, \mathrm{~s}>2$. Then

For $r=0$, we have the $m$ onofractal behavior $d_{q}=d_{2}$, and the MNBD reduces to the negative-binom ial distribution.
(ii) $r>1$ : The leading term $s$ of the BPs are given by the expression ${ }_{q} /{ }^{r d_{2}}$, q 2. The corresponding anom alous fractal dim ension is

The values of $r$ for di erent reactions have been discussed in 6].

## 6. C onclusion

W e have proposed a new multiplicity distribution w th m ultifractal properties for sm allphase-space intervals, basing on the sim plicity of the analysis ofm ultifractality in term $s$ of BP $s$ and bunching $m$ om ents. G uided by the fact that, for the $m$ ultifractality of norm alized factorial m om ents the sam e power-law behavior for all orders of the BPS is necessary and su cient, in this paper we focus our attention on the analysis of the M NBD w th the multifractal behavior. The MNBD may be considered as a generalization of the negative-binom ial distribution w th a new free param eter $g$ (or $r$ for the particular case, when $g=!(r) k{ }^{r}$ ) which has a power-like behavior for sm all phase-space intervals.

Theoretically, the question arises what is the physical reason of such multifractal distribution (or sim ilar to it). The problem ofm ultifractality is very com plicated and requires further exam ination both in high-energy physics and quantum optics. N ote, as an exam ple, that som $e$ versions of cascade $m$ odels can lead to this distribution
because they have the sam e anom alous fractal dim ension (see model [15], where the anom alous fractal dim ension has the form (43) w ith $r=1$ ).

On the experim ental side of the question, we hope that the MNBD is interesting since it yields a new possibility to describe experim ental data.
