W PLUS HEAVY QUARK PRODUCTION AT THE TEVATRON

W e present the next-to-leading order QCD corrections to the production of a w -boson in association with a jet containing a heavy quark. The calculation is fully di erential in the nal state particle m om enta and includes the m ass of the heavy quark. W e study for the case of the Tevatron the sensitivity of the cross section to the strange quark distribution function, the dependence of the cross section on the heavy quark m ass, the transverse m om entum distribution of the jet containing the heavy quark, and the m om entum distribution of the heavy quark in the jet.

W plus heavy quark production at the Tevatron

W e present the next-to-leading order QCD corrections to the production of a W -boson in association with a jet containing a heavy quark. The calculation is fully di erential in the nal state particle momenta and includes the mass of the heavy quark. W e study for the case of the Tevatron the sensitivity of the cross section to the strange quark distribution function, the dependence of the cross section on the heavy quark mass, the transverse momentum distribution of the jet containing the heavy quark, and the momentum distribution of the heavy quark in the jet.

1. IN TRODUCTION

The study of jet production in association with a vector boson at hadron colliders has been succesful in the recent past. The advantage of this signal over pure jet production is that the lepton (s) from the vector boson decay can be used as a trigger, such that jets can be studied free from jet-trigger bias. Furtherm ore, the low er rate obviates the need for prescaling. On the theory side, progress in calculational techniques to construct next-to-leading order (NLO) M onte-C arlo program s [1] has allowed a m eaningful confrontation with data [2]. For a review of such techniques and m ore recent progress, see [3].

The tagging of heavy hadrons in the jet o ersa unique possibility of studying the hadronic structure inside the jet. By considering jets where the leading hadron is tagged, a clear connection can be m ade with perturbative QCD. At the parton level, the tagging of a heavy hadron corresponds to the tagging of a heavy- avor quark. Experimentally, the presence of a D or B m eson is inferred through its decay products. The im portance of heavy avor tagging has been clearly dem onstrated in the analysis that led to the top quark discovery [4]. In the future, heavy avor tagging will continue to be an important analysis tool. It will provide m ore detailed information about the event, and test of the underlying QCD theory.

If one dem ands the presence of a charm quark in the jet recoiling against a W -boson, the signal is directly sensitive to the strange quark distribution function in the proton, at a scale of the order of the W -m ass.

Replacing the charm quark by a bottom quark, one could use this process as an alternative calibration of the b-quark tagging e ciency. This will be useful at lum inosities achieved by the M ain Injector. How ever, by far the dom inant contribution to W + bottom production is due to W + bb production, where the heavy quark pair is produced by gluon splitting. Here the inclusion of the gluon to B m eson fragm entation function is probably m ore im portant than the inclusion of N LO e ects to the W + bottom process, which im plies that this reaction can constrain this fragm entation function.

In this report, which is based on Ref. [7], we present the calculation of the QCD corrections up to 0 ($_{s}^{2}$) of the process pp ! W + Q where Q is an heavy quark, keeping the mass of the heavy quark explicit, and the nal state fully exclusive.

2. M ETHOD

The m ethod we used to calculate the O ($\binom{2}{s}$) QCD corrections to pp ! W + Q is a generalization [8] of the phase space slicing m ethod of Ref. [9] to include m assive quarks.

The leading order (LO) calculation involves the simple subprocess q + g ! W + Q, where q is a light quark and g a gluon, at tree level.

The virtual corrections consist of the interference between the lowest order diagram s and their one-loop corrections. The integrals over the loop m om enta were performed in d = 4 2 dim ensions. Ultraviolet singularities were absorbed through m ass (on-shell schem e) and couplingconstant (m odi ed \overline{MS} schem e [10]) renorm alization. The remaining soft and collinear singularities, appearing as $1 = {}^2$ and 1 = poles, factorize into a universal factor multiplying the B orn cross section.

The real corrections consist of the contributions from all the subprocesses ij ! W Q k, where i; j;k are massless partons, and the subprocess ij! W Q Q [11]. Some of these contributions exhibit soft and/or collinear singularities. W e do not consider diagram s where the heavy quark is in the initial state. The method we used to isolate the singularities consists of slicing up the phase space, using a cut-o sm in and color-ordered subam plitudes, into a hard region ($s_{m in} < 2p_r$ p for any r;s), containing no singularities, and a com plementary region in which the nal state parton is either soft or emitted collinearly with one of the initial state partons. In the hard phase space region, one can work in four dim ensions and perform the phase space integration num erically. In the soft and collinear region, the integration is done analytically in d dimensions using soft and collinear approximations, which are valid in the lim it that $s_{m\ in}$ is small. The cross section in this region again factorizes into a universal factorm ultiplying the Born cross section. The initial state collinear singularities are factorized into parton distribution functions in the \overline{MS} scheme, using the formalism of crossing functions [1].

Note that the process ij ! W Q Q is quite di erent from the other subprocesses: the heavy quark does not originate from the W vertex, and it is independent of $s_{\text{m in}}$, because it is free from singularities.

A dding the realand virtual corrections leads to the cancellation of all rem aining singularities. We checked gauge invariance for both the virtual and real corrections. Finally, we constructed a M onte C arb program for the present process, including these corrections.

Before showing any numerical results, we rst list here the default choices we made for parameters and cuts in producing the results of this paper. Any deviation from these choices will be indicated explicitly. For the case of charm (bottom) we assumed three (four) light avors. We used both at LO and NLO the CTEQ 3M [12] set of parton distribution functions, and a two-loop running coupling constant with $^{(2;4)}_{QCD}$ the value supplied with the CTEQ 3M set (0.239 GeV). We implemented continuity across heavy avorthresholds [13] using the parametrization of Ref. [14]. We used the Snowm ass convention [15] for the denition of a jet. Our conditions on the

transverse energy and pseudorapidity of the jet were E_T (jet) > 10 GeV, j jet j < 3, and no cuts on the W .W e took a jet cone size of R = 0.7, the W mass equal to $m_W = 80.23$ GeV, and the heavy quark mass m equal to 1.7 GeV for charm and 5 GeV for bottom .W e used $V_{cs} = 0.97$ and $V_{cd} = 0.22$ for the relevant C abibbo-K obayashi-M askawa matrix elements. W e chose the factorization scale equal to the renorm alization scale and denote it by , taking = m_W . At least one heavy quark was required to be inside of the jet, with the sign of its electric charge correlated with the W charge, as in the LO case.

We veried the independence of the calculation on the arbitrary parameter $s_{m\ in}$. The results given in the remainder of this report are averaged over $s_{m\ in}$ between 1 and 10 GeV.

W e further found the scale dependence of the inclusive cross section to be som ew hat reduced by the inclusion of the NLO corrections.

3. STRANGE QUARK DISTRIBUTION FUNCTION

We rst discuss the elect that the inclusion of the NLO QCD corrections to W + charm -tagged jet

production has on constraining the strange quark distribution function s(x;) in the proton. Here x is the momentum fraction of the strange quark in the proton, and is the factorization scale. See R ef. [5] for an extensive study of this issue using the shower M onte-C arb program PYTHIA [6].

In Table 1 we give the NLO cross section for the parton distribution function sets CTEQ IM[16] and MRSD 0' [17]. The MRSD 0' set derives its strange quark distribution from dim uon data, whereas the CTEQ IM set uses D IS data. At low ² and low x the di erence is as much as a fac-

tor of two. Also shown is the result obtained with the more recent CTEO 3M set, which uses the sam e assum ption about the strange quark distribution as MRSD0'. Comparing the CTEQ3M and MRSDO'sets, we see that the dierence due to using more recent data sets in the global t for the parton distribution functions is small. This is also rejected in the cross section for $W + cc_{\mu}$ which is the same for all three sets. We can conclude that the di erence between CTEQ1M and MRSD0' of 15.4 % is due to the strange quark distribution function. This di erence becom es 14.5% when one includes the W + b background (9 pb, alm ost all of it com ing from the gluon splitting contribution, see Table 1), and assuming conservatively that each bottom quark is mistagged as a charm quark. This shows that the conclusions reached in Ref. [5] are still valid at NLO. In both the NLO calculation and the PYTHIA analysis about 50% of the contributions are initiated by strange quarks. One major di erence is that PYTHIA suggests that the gluon splitting contributes about 35%, whereas in the NLO calculation it is only about 15%. This number is how ever quite sensitive to the choice of scale in

the gluon splitting contribution.

4. M ASS DEPENDENCE OF JET PRO-DUCTION




Figure 1. Ratio of W + charm-tagged inclusive one-jet production over W + inclusive untagged one-jet production as function of the jet transverse energy. The solid line is the NLO ratio and the dashed line the LO ratio. The W + cc contribution to the NLO ratio is also shown (dotted line).

Next we com pare W + untagged jet production² [1] and W + charm tagged jet production. In particular, we study the jet transverse energy $(E_{T}$ (jet)) distribution. In Fig. 1 we show the ratio of the charm -tagged jet over the untagged jet E_{T} (jet)-distribution for the LO and NLO cases. At LO the charm -tagged jet is simply represented by a charm quark. The ratio in Fig. 1 has a characteristic shape which can readily be understood at tree level. At low E_T (jet) the charm -tagged jet rate is suppressed relative to the untagged-jet rate due to its ferm ionic nal state. The untaggedjet rate is dominated by the gluonic nal state which has a soft singularity, that is absent for the ferm ionic nal state. At high E_{T} (jet) we again observe a relative suppression of the charm tagged jet because at LO this process has a gluon in the initial state. At high E_{T} (jet) the dom inant scattering in the untagged-jet rate is due to quark-antiquark collisions, again favoring the gluonic nal state. Clearly, apart from an approximate overall K -factor, the NLO cross section retains these features. A lso shown in Fig. 1 is the W + cc contribution. At low E_T (jet) its suppression is more pronounced due to the charm quark pair production threshold. At high E_{T} (jet) there is no suppression for this process because it. is instigated by a quark-antiquark collision.

We now turn to the mass dependence of the cross section. We will show that there are im -

portant m ass e ects at NLO, especially when we look in detail at the tagged jets. (At LO one m ay safely take the m ass to zero; the answer does not change.)

Let us rst consider the W + Q Q contribution. Because the mass of the heavy quark regulates the collinear singularity, it is expected that the strongest mass dependence will come from the collinear region. In this region the cross section factorizes into the cross section for W + gluon production multiplied by a universal factor. A flerintegration over the invariant mass of the heavyquark pair we nd that the mass dependent partof this universal factor has the following form :

where M is the upper lim it of the heavy quark pair invariant m ass de ning the collinear region, and $P_{q\bar{q}!~g}(z)$ is the m assless A ltarelli-P arisi [18] splitting function:

We chose the following de nition of z

$$z = \frac{E + P_k}{E_{jet} + P_{jet}}$$

where E and P_k are the heavy quark energy and momentum projected on the jet direction, and E_{jet} and P_{jet} are the jet energy and momentum. O ther choices, such as $z = E_T (Q) = E_T$ (jet), do not change any of the conclusions in what follows. In the strictly collinear limit M is much smaller than the energy of the gluon, but in a leading logarithm ic approximation one may take




Figure 2. a) Ratio of the $W + \infty$ component of the charm tagged one-jet inclusive cross section to the W + gluon cross section, as a function of the jet tranverse energy. b) The z-distribution of the W + ∞ component.




Figure 3. The z-distribution of the charm -tagged one-jet inclusive cross section, with m = 0.01 GeV.a) W cc component. b) Total contribution m inus the W cc component.

M to be of the order of E_T (jet). The behavior of Eq. (1) can be seen qualitatively in Fig. 2a, where the ratio of the W + cc cross section over the W + gluon cross section is shown as a function of the transverse energy of the jet. One can see an approximate logarithm ic enhancement with increasing E_T , as predicted by the leading logarithmic approximation. However the z-distribution, plotted in Fig. 2b, does not conform with the zdependence in Eq. (1). First, the peak at z = 1 is due to events where the Q is not inside of the jet, such that the whole jet is form ed by the lone Q. Second, the cross section is suppressed near z = 0and z = 1 (excluding the peak) due to term s in the collinear region that depend strongly on z, but not on M . One way to enhance the e ect of the leading logarithm term of Eq. (1) in the z distribution is to low er the m ass of the heavy quark in our calculation. This is done in Fig. 3a, where we show the z-distribution for the case m = 0.01 G eV.C learly it now resembles the functional form of Eq. (2) much closer.

The ln (m²) term in Eq. (1) diverges in the lim it of vanishing quark mass, and is not cancelled by any other contribution³. In principle, any observable should be \collinear safe", i.e. if them ass is taken to zero, the observable should be nite and approach the massless result. This is needed to describe situations where the relevant scale is much larger than the heavy quark mass. In the present case we are dealing with a nal state divergence in ln (m²) that should be factorized into the fragm entation function of a gluon into a heavy hadron. The evolution of fragm entation functions will then resum the large logarithm s ln (\mathbb{E}_{π}^2). This problem is the nalstate version of the problem of heavy quark distribution functions [19]. It will be discussed in more detail in [8]. Som e studies in this regard were done in Ref. [20]. Here, we simply keep the mass nite. Let us now turn to

the NLO single charm contribution (excluding the W + cc contribution). In the collinear region, the cross section again factorizes, leading, after integration over the invariant m ass of the collinear partons, to the universal factor:

where $P_{qq! q}(z)$ is the splitting function:

$$P_{qg! q}(z) = \lim_{t \to 0} 2(1 - \frac{1}{N_c^2}) - \frac{1 + z^2}{1 - z}$$

$$(1 - z -) + (\frac{3}{2} + 2\ln -) - (1 - z) = (5)$$

In Fig. 6b we show for the single charm quark contribution the z-distribution, with the contribution of Eq. (4) enhanced by taking m = 0.01 G eV. Note that it resembles the functional form in Eq. (5). From Eq. (5) one derives Z $_1$




Figure 4. a) E_T distribution ratio of NLO charm-tagged one-jet inclusive cross section to LO one. Solid line has no restrictions on the z-integration, the dotted and dashed line have restrictions of z < 0.9 and z > 0.9 respectively. b) z-distribution of NLO charm-tagged one-jet inclusive cross section. The W + ∞ component is not included in these plots.

which must hold for the probability to nd a quark in a quark of the same avor to be one [18]. From Eqs. (6) and (4) we can now make the im portant observation that as long as the cuts on the heavy quark-tagged jet are such that all z-values are allowed to contribute, there are no large logarithm s ln (E $_{T}^{2}$ =m²). H ow ever, if the cuts are such that the z-integration is restricted, or convoluted with a z-dependent function, some $\ln (E_{\pi}^2 = m^2)$ term s will rem ain. An example of such a convolution is the E_T distribution of the heavy quark itself. All this is illustrated in Fig. 4a, where two cases of z-restrictions (z > 0.9 and z < 0.9) are plotted in addition to the all-z case. Note that for the all-z case the ratio is indeed essentially independent of E_T (jet), but that for the z-restricted cases the logarithm ic dependence is apparent. For completeness we show in Fig. 4b the z-distribution for the single charm contribution for m = 1:7 GeV.

Thus care must be taken when calculating tagged cross sections in determ ining whether or not there are large logarithms present due to restrictions on the z-integration. Such restrictions would also necessitate the introduction of the appropriate fragm entation function to absorb the $\ln (m^2)$ term s, as in the W QQ case.

 $^{^3}$ In the W $\,$ + 1 jet calculation, this singularity is cancelled by a companion collinear singularity in the quark-loop correction to the outgoing gluon in the Born diagram . In our calculation this diagram is not present.

N ote that for the example of the jet transverse energy distribution given in Fig.4 there is no constraint on the z-integration, so that the only nal state $\ln (m^2)$ term arises from the W cc contribution.

5. CONCLUSIONS

We have presented the calculation of the O ($_{\rm s}$) corrections to the reaction pp ! W + Q. We found that the inclusion of the NLO corrections does not change the conclusions of Ref. [5] about constraining the strange quark distribution function using W + charm-tagged jet events at the Tevatron. How ever, using our NLO calculation, this procedure can constrain the NLO strange quark distribution function, once a reasonable data sample is collected. We studied the E $_{\rm T}$ distribution of the jet containing the heavy quark and them ass dependence of the cross section, and noted the need to include the heavy hadron fragmentation functions.
