On the Decay Mode B!

ABSTRACT

A QCD relativistic potential model is employed to compute the decay rate and the photon spectrum of the process B $\,!\,$. The result B (B $\,!\,$) ' 1 $\,10^{-6}\,$ con rm s the enhancement of this decay channel with respect to the purely leptonic mode, and supports the proposal of using this process to access relevant hadronic quantities such as the B -m eson leptonic decay constant and the CKM matrix element $V_{\rm ub}$.

Noticeable theoretical attention has been recently given to the weak radiative decay

The reason is in the peculiar role of this decay m ode for the understanding of the dynam ics of the annihilation processes occurring in heavy m esons [1, 2, 3, 4]. M oreover, it has been observed that (1) can be studied to obtain indications on the value of the B-m eson leptonic constant $f_{\rm B}$ using a decay channel which diers from the purely leptonic modes B!', and is not ham pered by the limitations a ecting those latter processes. Such diculties mainly consist in low decay rates 3 (using $V_{\rm ub}=3$ $10\,^3$, $f_{\rm B}=200\,{\rm M}$ eV and $_{\rm B}=1:646\,$ 0:063 ps [5] one predicts B (B! e)' 6:610 12 and B (B!)' 2:810 7) or in reconstruction problems for B!

In ref. [4] heavy quark symmetry and experimental data on D 0 ! D 0 have been exploited to study the dependence of B (B $^{\circ}$!) on the heavy m eson decay constant $\hat{F} = \overline{P} = \overline{m}_{b}$, which is the common value of f_{B} and f_{B} (modulo logarithm ic factors) in the limit m_{b} ! 1. The analysis is based on the dominance of polar diagrams contributing to the process B $^{\circ}$! , the pole being either the vector meson B or the positive parity $J^{P} = 1^{+}$ state B_{1}^{0} (see ref. [4] for further details). A coording to the analysis in [4], in correspondence to the expected range of values of \hat{F} : \hat{F} ' 0:35 G eV $^{3-2}$, the branching ratio B (B $^{\circ}$!) should be O (10 6), which represents an enhancement with respect to the purely leptonic mode.

In order to give further arguments in support of that analysis, we want to consider the process (1) in a dierent context. More precisely, whereas in [4] we have studied the feasibility of extracting $f_B = \hat{F} = \overline{m}_b$ from future experimental data, in this letter we study the decay (1) within a well dened theoretical model in order to have an independent estimate of the decay rate.

We employ a relativistic constituent quark modelalready used to study several aspects of the B-meson phenomenology [7,8,9]. Within this model the mesons are represented as bound states of valence quarks and antiquarks interacting via a QCD inspired istantaneous potential with a linear dependence at large distances, to account for connement, and a modied coulombic behaviour at short distances to include the asymptotic freedom property of QCD. We adopt the interpolating form between such asymptotic dependences

provided by the R ichardson potential [10]⁴. In the rest fram e, the state describing a B_a m eson is represented as:

where and are colour indices, r and s are spin indices, b y and d_{a}^{y} are creation operators of the quark b and the antiquark q_{a} , carrying m om enta K_{1} and K_{1} respectively. The B - m eson wave function $_{B}$ (K_{1}) satis es a wave equation with relativistic kinematics (Salpeter equation) [11] taking the form (in the m eson rest fram e):

where V $(K_1; K_1^0)$ is the interaction potential in the momentum space and B is covariantly normalized:

Solving eq.(3) by num erical methods one obtains the wave function; we shall present this result later on. It can be mentioned that by this model a number of predictions have been derived; for example, the heavy meson spectrum, leptonic constants [7, 8], sem ileptonic form factors and strong decay constants [9].

In the fram ework of the relativistic QCD potential model the wave function $_{\rm B}$ is the main dynam ical quantity governing the decay (1). As a matter of fact, the amplitude of the process B (p)! (p_1) (p_2) (k;) can be written as

where G_F is the Ferm i constant, V_{ub} is the CKM matrix element involved in the decay, $L = (p_1)$ (1_5) (p_2) is the weak leptonic current, and is defined by = (is the photon polarization vector); represents the correlator

In eq.(6) q is $q = p_1 + p_2$, J(x) = u(x) (1 5)b(x) is the weak hadronic current and $V(0) = \frac{2}{3}eu(0) u(0) = \frac{1}{3}eb(0) b(0)$ is the electromagnetic (e.m.) current. The two

pieces in the em. current correspond to the coupling to the light quark and to the heavy quark, respectively. The corresponding contributions to $\,$ will be referred to as $\,$ and $\,$ h depicted in gs. 1a,b. $\,$ contains the light quark propagator:

while h contains the analogous b quark propagator.

The calculation of the time-ordered product appearing in (6) gives:

The analogous expression for h can be obtained by the replacements: $\frac{2}{3}$ \$ $\frac{1}{3}$, m_u \$ m_b , J^h . The operators J^h and J^h , which depend on the integration variable x, are written as $J^h = u(0) b(x)$ and $J^h = u(x) b(0)$, with the matrices given by u(0) b(x) = u(0) b(x) and u(0) b(x) = u(x) b(0). In the constituent quark model such operators can be expressed in terms of quark operators; for example one has:

where $E_q(q) = \frac{q^2 + m_q^2}{q^2 + m_q^2}$ and $u_q(v_q)$ are quark (antiquark) spinors.

By exploiting anticom mutation relations among annihilation and creation operators, we obtain, in the B meson rest frame:

where $q_1=(E_u; K_1)$ and $q_2=(E_b; K_1)$. We recognize in the two factors in the curly brakets the contributions of 'and ' , respectively.

Since only depends on two vectors, the B m eson momentum p and the photon momentum k, it can be written in terms of six independent Lorentz structures:

By gauge invariance one has = 0 and = p k; moreover, after saturation by one gets:

i.e. only the terms proportional to and survive: they are the vector and the axial vector contribution, respectively. It is convenient to compute eq.(12) in the B rest frame $p = (M_B; 0)$, with $k = (k^0; 0; 0; k^0)$; the result reads:

At this point, it is straightforward to calculate the rate of the decay process (1); one obtains $(m \ ' \ 0)$:

whereas the S-wave reduced function u is related to $_{\rm B}$:

we plot in g2 the function u_B obtained as a solution of the wave equation (3).

Let us now point out that in computing the diagrams in gs.la,b and, therefore, in eqs.(15), (16), we have so far imposed 4-m omentum conservation for the physical particles B, , and in the process (1). On the other hand, energy conservation has to be imposed also at quark level since, otherwise, (15) and (16) would present spurious kinematical singularities. In order to deal with this problem we follow the approach originally proposed within the ACCMM model [12] for the decay b! u `.one assumes that the spectator quark has a denite mass, while the active quark has a "running" mass, dened consistently with the energy conservation:

Therefore, as in the case of the ACCMM model, the running mass of the active b quark can be de ned by:

M oreover, by requiring that the right hand side of eq. (21) is positive, an upper bound on the quark momentum \mathfrak{K}_1 ; can be obtained

N otice that the m asses of the light constituent quarks, as obtained by $\,$ ts to the m eson spectrum , are m $_{\rm u}$ = m $_{\rm d}$ = 38 M eV .

The contribution of the two physical processes when the photon couples to the light or to the heavy quark is still recognizable in eqs. (15)-(16), since the quantities f and g come from the light and heavy quark propagators respectively. It turns out that the contribution of the terms proportional to $\frac{1}{g}$ are numerically much smaller than those proportional to $\frac{1}{f}$. This is not surprising, since the em. coupling of the photon to the quarks corresponds to a magnetic transition, and therefore it is inversely proportional to the quark mass.

A nal remark concerns the photon energy. In eq.(14) we have allowed k^0 to vary in the range $[0;M_B=2]$; however the integral diverges at the lower limit $k^0=0$. This result is unphysical since it would correspond to a zero energy photon in the nal state. Formally, this divergence would be canceled by radiative corrections to the formulae (15) and (16). On the other hand, one should take into account that at future experiments, e.g. at the SLAC B-factory, the smallest measurable photon energy is of the order of 50 M eV; therefore, it is a reasonable assumption to cut of from the integral the small photon energies, and, at the same time, to neglect radiative corrections.

In our calculation, the e ect of the unphysical divergence begins around a photon energy k^0 ' 350 M eV , and therefore we use this value as a lower bound for the photon energy.

In g.3 we plot the photon spectrum for the decay (1); the dierential distribution has a peak around 1.5 GeV, which should render it quite accessible to experimental analyses.

For the decay width we obtain the result (B !) = 3:7 10 19 ($\frac{V_{ub}}{3\ 10^{-3}}$) 2 G eV , which corresponds to

This result is obtained with a cut-o $= 350 \,\mathrm{M}$ eV in the photon energy. As it can be seen from g.3, the uncertainty related to this choice should not be significant. For example, putting $= 100 \,\mathrm{M}$ eV the result for the branching ratio increases by less than 10%.

The conclusion we can draw from this result is that the relativistic quark model gives predictions in agreement with the expectations discussed in ref. [4]; the weak radiative decay B! has an appreciable rate and might be observed in the near future.

As for on the theoretical uncertainties of the result (23), a part from the energy cut-o they mainly come from the choice of the B meson wave function. A possible estimate of this theoretical error consists in assuming a dierent wave function. A commonly used quark momentum distribution inside the B meson is given by the ACCMM model [12]; in our notations it corresponds to the gaussian wave function:

The param eter P_F is related to the heavy quark average squarem om entum : $< p^2 > = \frac{3}{2} P_F^2$. In a recent analysis [13] this param eter has been—tted using experim ental data for the inclusive decay B ! X_c ' 、[14] with the result: $P_F = 0.51\,\text{GeV}$. Using (24) with such a value of P_F in the previous form ulas, one would obtain B (B !) ' 0.8 10^6 . This result suggests that the estimate given in eq. (23) is rather accurate; the rate for the weak radiative decay B ! is large enough for a measurement at future accelerators.

P redicted photon energy spectrum.








