Photon {m eson transition form factors  $^{0}$ , and  $^{0}$  at low and moderately high Q<sup>2</sup>

We study photon {m eson transition form factors  $(Q^2)$ ! ;  $^0$ ; ;  $^0$  at low and moderately high virtualities  $Q^2$  of one of the photons, the second photon being real. For the description of the form factor at low  $Q^2$ , a nontrivial quark {antiquark (qq) structure of the photon in the soft region is assumed, i.e. the photon is treated much like an ordinary vector meson. At large  $Q^2$ , along with a perturbative tail of the soft wave function, as it is for a hadron, the photon wave function contains also a standard QED point-like qq component. The latter provides the  $1=Q^2$  behavior of the transition form factor at large  $Q^2$  in accordance with perturbative QCD. Using the experimental results on  $^0$  form factor, we reconstruct the soft photon wave function which is found to have the structure similar to pion's, which has been formerly determined from a study of the elastic pion form factor. A ssuming the universality of the ground {state pseudoscalar meson wave functions we calculate the transition form factors ,  $^0$  and partial widths ! ,  $^0$ ! , in a perfect agreement with data.

#### I. IN TRODUCTION

In the present paper we continue the study of the transition regime from soft nonperturbative physics to the physics of hard processes described by the perturbative QCD (PQCD). In Ref. [1] we have proposed a method to consider a form factor in a broad range of momentum transfers starting from the nonperturbative region of small Q² and moving to moderately large Q² where form factor is represented as a series in saccounting for the nonperturbative term and O(s) corrections. This allows a continuous transition from small to asymptotically large momentum transfers. Within this procedure, we have determined the pion light{cone wave function by describing the pion elastic form factor in the range 00° 10 G eV².

Recent experiments on pseudoscalar meson production in e<sup>+</sup>e collisions [2] provide new data on the transition form factors (Q<sup>2</sup>) ! <sup>0</sup>;; <sup>0</sup> in the region of the momentum transfers 0 Q<sup>2</sup> 20 GeV<sup>2</sup>. These results open a new possibility for studying the onset of the asymptotical PQCD regime. Reconstruction of the pseudoscalar meson wave function and photon qq-distribution provides a bridge between the phenomenological softphysics description and rigorous results of PQCD.

Theoretical investigation of the photon(meson transition processes which has a long history has given two important results on the photon(pion transition form factor:

(1) A dler{Bell{Jackiw axial anomaly  $\beta$ } yields nonvanishing transition form factor of the pion into two real photons in the chiral lim it of vanishing quark masses

(2) In the kinem atical region where at least one of the photon virtualities is large, PQCD gives the following prediction for the behavior of the transition form factor [4]

where (x) is the leading twist wave function (distribution amplitude) which describes the longitudinal momentum distribution of valence quark {antiquark pair in the pion. PQCD also predicts asymptotic behavior of the pion distribution amplitude in the following form [5]:




FIG. 1. D iagram s relevant to the description of the transition form factor at low and moderately high  $Q^2$ .

At asym ptotically large Q  $^2$  one can use the asym ptotic pion distribution amplitude to nd the leading behavior of the transition form factor

The leading term corresponds to the diagram of Fig. 1b with point-like vertices of the quark {photon interaction.

A problem starting from which Q $^2$  the form factor can be reliably described by the leading PQCD term only has been extensively discussed in connection with pion elastic form factor [6], [7]. As was rstly underlined in Ref. [6], asymptotical regime is switched on at considerably largemomentum transfers, whereas in the region of Q $^2$  10 20 GeV $^2$  the soft nonperturbative wave function gives a substantial contribution. Quantitative results for the pion form factor [1] agree with the statements of Ref.

The procedure of Ref. [1] is the following: we divide the pion light{cone wave function into soft and hard components,  $_S$  and  $_H$ , such as  $_S$  is large at s =  $(m^2 + \kappa_?^2) = (x(1-x)) < s_0$ , while  $_H$  prevails at s >  $s_0$ . We performed this decomposition of the wave function using the step{function as a simplest ansatz

It is reasonable to represent the hard component,  $_{\rm H}$  , as a series in  $_{\rm S}$  . Then at small and intermediate Q  $^2$  the elastic pion form factor reads

where F  $^{\rm SS}$  is a truly nonperturbative part of the form factor, and F  $^{\rm SH}$  is an O (  $_{\rm S}$ ) term with one(gluon exchange. The rst term clearly dominates in the pion form factor at sm all Q  $^2$ . With minor corrections at sm all Q  $^2$ , the second term, as is known, provides the leading  $_{\rm S}$  (Q  $^2$ )=Q  $^2$  behavior of the elastic form factor at asymptotically large Q  $^2$ . So, the rst two terms in the righthand side of Eq. (8) accumulate the leading behavior from the two regions of small and large Q  $^2$ , thus allowing a realistic description in the region of intermediate momentum transfers.

H ard wave function,  $_{\rm H}$  , is represented as a convolution of the one-gluon exchange kernel V  $^{\circ}$  with  $_{\rm S}$

So, soft pion wave function  $_{\rm S}$  is responsible for pion form factor behavior both at sm all and m oderately large Q  $^2$  .

This strategy, with the incorporation of "photon wave function", is applicable for the description of the photon { pion transition form factor:

However, an important distinction of the photon hard wave function compared with that of a hadron should be taken into account: namely, in addition to the hadronic component of the hard wave function which is related to the soft wave function via Eq. (9), the photon hard wave function contains also a standard point-like QED qq{component such as

Our analysis shows that at smallm omentum transfers the F  $^{\rm SS}$  part dominates in the transition form factor, i.e. in the soft region photon should be treated much like an ordinary hadron, just in the spirit of the vector meson dominance. At large Q  $^2$ , the soft{point term (F  $^{\rm Spt}$ ), gives the leading 1=Q  $^2$  fallo , whereas the contribution of the O (  $_{\rm S}$ ) term s (F  $^{\rm SH}$   $^{\rm (1)}$  + F  $^{\rm SH}$   $^{\rm (2)}$ ) is suppressed by the additional factor  $_{\rm S}$ : the behavior of the photon {pion transition form factor diers from that of the elastic pion form factor where the soft{point term is absent and the soft{hard term s are dominant.}

At interm ediate m om entum transfers, Eq. (12) provides substantial corrections to the  $1=Q^2$  fallo: namely,

these corrections are due to the transverse motion of quarks in the soft{point term as well as to contributions related to the nontrivial qq{structure of the soft photon (the terms involving  $_{\rm S}$ ). The allowance for the corrections of the  $\,$ rst type is a standard procedure in moving from asymptotically large to intermediate momentum transfers within the hard scattering approach [8] and modified hard scattering approach [9] which are based on the account for transverse motion and Sudakov elects [10]. However, as the present analysis shows, in the region of a few  $\rm G\,eV^2$  the contribution of the terms originated from the nontrivial qq{structure of the soft photon is substantial and cannot be neglected.

The proposed method allows a self(consistent description of the photon {pion transition form factor in a broad range of  $Q^2$ . We use the soft pion wave function which has been previously determined in Ref. [1] by thing elastic pion form factor. The description of the photon {pion transition form factor reveals a similarity of the low {seq-structure of soft photon with that of a pion.

Sum m ing up, we obtain the following results:

1. We the available data on the photon {pion transition form factor at  $Q^2 = 0$  8 G eV 2 and determ in the soft qq wave function of the photon. P ion wave function is taken from our description of elastic pion form factor [1]. Soft photon wave function turns out to be close to the ground { state m eson wave function at low s, i.e.  $_{\rm S}$  (s) at s  $2~{\rm G\,eV}^{\,2}$ . The sim ilarity of  $_{\rm S}$ and s at s 2 GeV 2 seems to be quite natural and corresponds to the vector meson dominance in the vertex ! qq. At  $s = s_0$  the photon wave function satis es the boundary condition  $_{S}$  (s<sub>0</sub>) =  $_{pt}$  (s<sub>0</sub>), which provides a correct sewing of the F SS and F Spt term s. Soft wave functions determ ined, we calculate the photon {pion transition form factor in a broad range of Q2. Calculations show that severalkinem atical regions, where dierent contributions to the transition form factor dom inate, m ay be isolated:

(i) At small  $Q^2 = 0$  5 GeV  $^2$  the transition form factor is dominated by the soft soft term which corresponds to nontrivial hadron (like structure of the soft photon.

(ii) At large Q  $^2$  50 G eV  $^2$  the Q ED point-like component of the photon gives the main contribution reproducing the PQCD result.

(iii) In the interm ediate region the transition form factor is an interplay of the soft{soft, soft{point and soft{hard contributions. Numerically, the form factor behavior is very close to the interpolation formula proposed by Brodsky and Lepage [4]:

2. We calculate and  $^{0}$  transition form factors, assuming universality of the K-dependence of wave functions of all the ground{state pseudoscalar mesons where K is relative momentum of constituent quarks,

 $s=4m^2+4K^2$ . This assumption is in line with the conventional quark model. In accordance with vector meson dominance, the same ansatz is used for relating the nonstrange and strange components of the soft photon. Then

and  $^{0}$  form factors are calculated with no free param eters. The results for the  $\,$  and  $^{0}$  transition form factors are in an excellent agreem ent with the experimental data both on the shape of the form factors and on the decay partial widths, ( ! ) and ( $^{0}$ !). It provides an argument for small admixture of a glueball (two gluon) component into  $\,$  and  $^{0}$ : within the experimental accuracy we estimate corresponding probabilities as W (glueball) < 10% and W  $_{0}$  (glueball) < 20% .

The paper is organized as follows: In Section II the calculation of the  $^{\,0}$  transition from factor is performed and the soft transition vertex  $\,!\,$  qq is reconstructed. Section III is devoted to the calculation of and  $^{\,0}$  transition form factors. Conclusive remarks are given in Section IV . Appendix presents the calculation details.

#### II. O TRANSITION FORM FACTOR

We consider the  $\,^{0}$  transition from factor using the method presented in detail in Ref. [1]. So we om it here a discussion of the basic points of the technique, outlining only a skeleton of the calculation procedure.

#### E.Calculation results

Calculations of form factors at low and intermediate Q $^2$  include masses which are related to the soft physics: constituent quark mass and elective gluon mass. We use standard constituent quark mass m = 0:35 GeV while for elective gluon mass, m $_{\rm G}$ , we consider, just as in Ref. [1], the following two variants (masses are given in GeV):





FIG. 2. Relative contributions of dierent terms to the form factor: the ratios of dierent terms contributing to the whole form factor are shown. Four variants for the SH {term correspond to: (1) m  $_{\rm G}$  = 0,  $_{\rm S}$  (t) { the upper solid curve; (2) m  $_{\rm G}$  = 0,  $_{\rm S}$   $\frac{{\rm Q}^2}{4}$  { the lower solid curve; (3) m  $_{\rm G}$  = m  $_{\rm G}$  (t),  $_{\rm S}$   $\frac{{\rm Q}^2}{4}$  { the lower dotted curve.

The rst variant corresponds to a frozen  $_{\rm S}$  (t) at low t: it is the sam e variant as in Eq. (31). In the second variant we take  $_{\rm S}$  (t) in the middle point, j.j! Q  $^2$ =4. So, Eqs. (56) and (57) provide four possible variants for the soft( hard form factors. Corresponding results for soft(hard term are shown in Fig. 2. The main conclusion coming from the study of these variants is that a concrete choice of m  $_{\rm G}$  and  $_{\rm S}$  in the soft region does not much in uence the result.




FIG.3.  $qq\{distribution function for pion (a) and for photon (b).$




FIG. 4.  $^{0}$  transition form factor: the quantity  $\frac{1}{4}$   $^{2}$ m  $^{3}$ F  $^{2}$  (Q  $^{2}$ ) is shown. Dierent curves correspond to different sets of parameters in the SH -term; the curve notation is the same as in Fig. 2. Experimental data are taken from Ref. [2].

M uch more important is a choice of the soft photon wave function. There are two constraints on the soft photon wave function: the normalization condition (28) which guarantees the correct decay widht  $^{0}$ !, and the sewing condition of Eq. (33). In addition, we impose the third constraint in the spirit of vector dominance model and SU (6) {symmetry: the slope of G (s) in the region  $4\text{m}^2 < \text{s} < 1.5 \text{ GeV}^2$  is the same as that

of (s). Using these constraints we reconstruct the photon qq{distribution function G (s) which is shown in Fig. 3, together with G (s) for the comparison. The reconstructed distribution function has a dip in the region s 2 4 G eV  $^2$  similar to that of G (s). In Ref. [1] the qq{distribution in the pion is referred as quasizone one. The reconstructed G (s) behaviour provides an argument that the quasizone structure in the qq{distributions is of a common nature. The quantity  $\frac{1}{4}$   $^2$ m  $^3$ F  $^2$  (Q  $^2$ ) with the reconstructed G (s) is presented in Fig. 4.




FIG.5. The quantity  $\frac{1}{4}$   $^2$ m  $^3$ F  $^2$  (Q  $^2$ ) for the variant (1) of Eq. (57) { dotted line, and for the variant (2) { dashed line. The solig line is the same as in Fig. 4.

The results are shown in Fig. 5. The variant (1) corresponds to the low {s qq{distribution similar to G (s) but without a dip at s  $3 \text{ GeV}^2$  (the factor 0.98 is due to renormalization of the qq{distribution to have =  $2\cdot23\text{ eV}$ ). The absence of a dip in the photon qq{distribution results in raising the calculated curve at large Q². The variant (2), which corresponds to the point-like vertex qq! photon at low s, represents neither nor low {Q² form factor correctly.

## III. AND <sup>0</sup>TRANSITION FORM FACTORS

In our calculations of the and  $^{0}$  transition form factors we assum e, in the spirit of the quark model, the universality of soft wave functions of the 0 {nonet. This universality is usually form ulated in the r{representation, or in terms of the relative quark momenta. So, let us rewrite the pion wave function (s) (see Eq. (26)) as a function of K which is connected with the energy squared by  $K^{2} = (s + 4m^{2}) = 4$ .






FIG. 6. Q  $^2$ -dependence for the quantities  $_4$   $^2$ m  $^3$ F  $^2$  (Q  $^2$ ) and  $_4$   $^2$ m  $^3$ F  $^2$   $_0$  (Q  $^2$ ). D i event curves correspond to di event sets of the parameters in the SH -term (the curve notation is the same as in Fig. 2). Experimental data are taken from Ref. [2].

#### IV.CONCLUSION

We have analyzed the  $^{0}$ , , and  $^{0}$  transition form factors at low and moderately high Q  $^{2}$  in the framework of the method developed in Ref. [1] which allowes us to cover the range of momenta from the soft to PQCD physics. Calculation results back up the eciency of the proposed method.

This consideration support the results of Ref. [1] where the pion wave function has been reconstructed. Here we have reconstructed the soft  $qq\{distribution of the photon:$  it has been found to be similar to the quark distribution in the pion, that is quite natural in the fram ework of the vector dominance model for soft qq.

The calculated and <sup>0</sup> transition form factors are in a perfect agreem ent with the experim ental data, once we assume the universality of the soft wave functions of the ground {state pseudoscalar mesons, the members of the lightest nonet. This assumptions looks very natural and inherent to the conventional quark model.

The transition photon {m eson form factors at low Q  $^2$  were calculated in Refs. [12], [13] using the diagram of Fig. 1b with point{like quark{photon vertex. Such a treatment of low {Q  $^2$  photon{m eson form factor has been criticized in Ref. [14]. Our consideration also does not support this picture: whereas the hard photon can be treated as a standard Q ED point-like particle, the soft photon structure is nontrivial and is very much like the structure of other ground state m esons. This hadron-like structure of the soft photon is crucial for the description of the photon {m eson transition form factors at low Q  $^2$ .

In the case when both of the photon virtualities are nonzero, our approach recovers at large Q  $^2$  the 1=Q  $^2$  { behavior as PQCD does, and not 1=Q  $_1^2$ Q  $_2^2$  as m ight be expected from the naive application of the vector m eson dom inance. The vector m eson dom inance reveals itself m ore in the hadron-like structure of the soft photon, and not in a naive 1=Q  $_1^2$  behavior of the form factors.

The study of transition form factors in the region of a few GeV<sup>2</sup> has been considered in some papers (see Ref. [15] and references therein) as a possibility to discriminate between the pion distribution amplitudes of the Chemyak-Zhitnitsky type and the asymptotic one of Eq. (4): it was assumed that the form factor in this region can be described by the leading PQCD term which is considered within modi ed hard scattering picture. Our analysis shows that such an approach is not well justied in the region of a few GeV2: the contribution of the soft region is far from being small. The detailed quantitative analysises performed in Ref. [1] and in this paper as well as recent QCD sum rule results [16] show that the distribution am plitude is num erically very close to the asym ptotic form of Eq. (4) and disregard the double { hum ped distribution am plitudes of the Chemyak {Zhitnitsky type.






FIG.7. Momentum notations in soft{hard terms F  $^{\rm S\,H}$  (1) (a) and F  $^{\rm S\,H}$  (2) (b).
