Baryogenesis Through Mixing of Heavy Majorana Neutrinos

A bstract

A mechanism is presented, in which the mixing of right handed heavy M a jorana neutrinos creates a CP asym metric universe. When these M a jorana neutrinos subsequently decay more leptons than antileptons are produced. The lepton asym metry created by this new mechanism can exceed by a few orders of magnitude any lepton asymmetry originating from direct decays. The asymmetry is nally converted into a baryon asymmetry during the electroweak phase transition.

The generation of the baryon asym metry in the universe has been discussed in many articles [1,2]. Two prominant scenarios are the Grand Unied Theories [3,2] and the production of an asym metry through extended solutions of eld theories (sphalerons) [4,5]. At this time both scenarios generate asym metries which are small. This comes about because in the former case CP violation is produced by higher order eects and in the latter the tunneling rate through potential barriers is small (in addition, if the higgs particles are heavier than 80 GeV, then the baryon asym metry thus generated will be completely erased) [5].

A third scenario includes heavy M a prana neutrinos whose decays generate a lepton asym m etry, which later on is converted into the baryon asym m etry. By their very nature M a prana neutrinos posses L = 2 transitions and in addition they may have couplings which allow them to decay into the standard higgs and leptons, i.e., N! y1 [6]. In these models the CP violation is introduced through the interference of tree-level with one-loop diagram s in the decays of heavy neutrinos, which we shall call otype e ects (direct violation) [6, 7]. An additional contribution from self-energies was included in ref [8-10]. A new aspect was pointed out [9] when it was realised that the heavy physical neutrino states are not CP or lepton-number{ eigenstates. Therefore as soon as the physical states are formed there is imprinted on them a CP asymmetry and a lepton {asymmetry. This we shall call type e ects (indirect CP violation). It is a property which appears in the eigenstates of the Hamiltonian at an early epoch of thermodynamic equillibrium, even before the temperature of the universe falls down to the m asses of the heavy M a jorana particles.

We demonstrate the phenomenon with a Gedanken experiment. Consider a universe consisting of a large per pollider which produces seand sepairs. The send sequences into Keep and \overline{K} mesons whose superpositions

the above asymmetry survives as an asymmetry of the detected e^+ 's and e^- 's. The electron-positron asymmetry generated is the same for the K $_{\rm L}$ and K $_{\rm S}$ [11].

In this article we point out that a similar situation arises in the formation and decays of Majorana neutrinos. We adopt the wave function formalism to calculate the eigenstates of the Hamiltonian and their decay rates. In this formalism we can extend the region of our calculation to the case of very smallmass dierences using degenerate perturbation theory. We not that for smallmass dierences between the two generations the indirect CP violation (type) produces a lepton asymmetry much larger than that of the type.

We work in an extension of the standard model where we include one heavy right handed Majorana eld per generation of light leptons (N_i , i = 1;2;3). These new elds are singlets with respect to the standard model. The lagrangian now contains a Majorana mass term and the Yukawa interactions of these elds with the light leptons,

where $^{\rm T}$ = ($^{\rm T}$;) is the higgs doublet of the standard model, which breaks the electroweak sym metry and gives mass to the fermions; $l_{\rm L}$ are the light leptons, h $_{\rm i}$ are the complex Yukawa couplings and is the generation index. We have adopted the usual convention for charge conjugation: N $^{\rm C}$ = $^{\rm C}$ N $^{\rm T}$. Without loss of generality we work in a basis in which the Majorana mass matrix is real and diagonal with eigenvalues M $_{\rm i}$.

The states N_i > decay only into leptons, while the states N_i^c > decay only into antileptons (gure 1). For this reason the states N_i > and




Figure 1: N $_{\rm i}$ and N $_{\rm i}^{\rm c}$ decaying into $\frac{1}{2}$ and ($\frac{1}{2}$) $^{\rm c}$

 $\mathfrak{N}_{i}^{\,\mathrm{c}}>$ have de nite lepton numbers and are the appropriate states to describe CP violation in the leptonic sector. They are analogous to the K and $\overline{\mathrm{K}}_{}^{\,\mathrm{c}}$ states. The idea is as follows: Through the presence of the Yukawa interactions we obtain one loop corrections to the mass matrix (gure 2), such that the corresponding mass eigenfunctions are no longer the $\mathfrak{N}_{i}>$ and $\mathfrak{N}_{i}^{\,\mathrm{c}}>$ states, but a mixture of them. It is these physical eigenstates which evolve in time with a denite frequency. If they are shown to be asymmetric linear combinations of the $\mathfrak{N}_{i}>$ and $\mathfrak{N}_{i}^{\,\mathrm{c}}>$'s then we have created a CP asymmetric universe. By asymmetric linear combinations we mean that the $\mathfrak{N}_{i}>$ and $\mathfrak{N}_{i}^{\,\mathrm{c}}>$'s enter with dierent complex phases into the decomposition of the eigenfunctions. The subsequent decay of these elds

will produce the desired lepton asymmetry.

As a result even if we start with equal numbers of N_i and N_i^c , they will evolve according to the asymmetric eigenstates of denite time developement. Since N_i and N_i^c carry dierent lepton numbers given by their interactions, this means that a lepton asymmetry is established through mixing before the elds actually decay. Herein lies the main dierence between our model and the literature.

For the sake of simplicity we consider two generations of M a prana neutrinos, where the indices i and j take the values 1 and 2. We assume the hierarchy M₂ > M₁. In the basis ($N_1^c > N_2^c > N_1 > N_2 > 1$) the elective H am iltonian of this model can be written as,

Once we include the one loop diagram of gure 2, there is an additional contribution to the e ective H am iltonian, which introduces CP violation in the mass matrix. We treat the one loop contributions as a small perturbation to the tree level H am iltonian.




Figure 2: One loop contributions to the mass matrix

as can be easily read o from gure 2. The dispersive part g^{dis}_{ij} can be absorbed in the wave function and mass renormalization. The absorbtive part g^{ab}_{ij} of the loop integrals is given by,

neglecting terms of order O (m 2 = p^2), O m 2 = p^2 with p^2 M $_i^2$.

Employing ordinary rst order perturbation theory the eigenfunctions of the e ective H am iltonian H = H $^{(0)}$ + H $^{(1)}$ are found to be

where the normalization factor is N = 2 + j₁ $^{\circ}$ + j₂ $^{\circ}$.

The states j $_1$ > and j $_1^0$ > are eigenstates with mass eigenvalues $M_1+ H_{11}^{(1)}$). They are related by a chiral $_5$ transformation and correspond to the same physical state. The same holds for the states j $_2$ > and j $_2^0$ > with eigenvalues $M_2 + H_{22}^{(1)}$). For the rest of our calculation we shall only consider j $_1$ > and j $_2$ > .

The asymmetry parameter can be de ned as,

which is a measure of the lepton asymmetry generated when the physical states j $_{\rm i}$ > nally decay. This can be calculated using,

In addition to the CP $\,$ violating contribution due to the m ixing of the states $N_i>$ and $N_i^c>$, which we call $\,$, there is another contribution 0 com ing from the direct CP $\,$ violation through the decays of $N_i>$ and $N_i^c>$,

Then it is straightforward to show that the asymmetry parameter consists

The new indirect CP violation , which enters through the mass matrix, is given by,

From this expression it is clear that this contribution becomes significant when the two mass eigenvalues are close to each other (gure 3). On the other hand the perturbation theory used for this expression is valid only for M_1 M_2 j $H_{ij}^{(1)}$ jor $H_{ij}^{(1)}$ j.

To nd out the value of in the vicinity of M $_1$ = M $_2$ we now write M $_1$ = M and M $_2$ = M + M and consider the case M \sharp_{ij} jor equivalently $\overset{P}{j}$ h $_i$ h $_j$ j. Then the total H am iltonian,




Figure 3: Com parison of the two CP $\,$ violating contributions to the lepton asymmetry in units of C , where r = M $_2^2$ =M $_1^2$

Note that the states j₁ > and j₂ > are not CP symmetric, because under CP transform ations N_i > transform s into N_i > . W ith this we can now calculate the lepton asymmetry for the degenerate scenario dening the asymmetry parameter as before. It is now given by,

This expression vanishes for ! 0 as expected, because there is no detectable mixing between two identical particles (gure 4). The matching of the two solutions occurs at P h $_{1}$ h $_{2}$ =5 and thus we obtained an asymmetry for small and large mass dierences. This is shown in gures 3 and 4. For P j h $_{1}$ h $_{j}$ jabig enhancement of the asymmetry parameter , by several orders of magnitude, is achieved. The enhancement factor is roughly 1= . For large values of the two distinct contributions 0 and 0 become of the

The dynam ical evolution of the lepton number in the universe is governed by the Boltzm ann equations. This is the appropriate tool to describe any deviation from thermal equilibrium. The framework and the derivation of the Boltzm ann equation is reviewed in [2]; we adopt the same notation. We make the approximations of kinetic equilibrium and Maxwell-Boltzm ann




Figure 4: Lepton asymmetry in units of C generated for a smallmass dierence, where P = $^{\rm P}$ h $_1$ h $_1$ and r = M $_2^2$ =M $_1^2$.

statistics. The out-of-equilibrium conditions occur, when the tem perature T drops below the mass scale M $_1$ = M $_1$ + H $_{11}^{(1)}$, where the inverse decay is e ectively frozen out.

The density of the lepton number asymmetry $n_L = n_1$ n_P for the left-handed leptons can be shown to evolve in time according to the equation:

where $_1$ is the contribution proportional to $1=^P$ $_1$ $_1$ $_1$ in the expression for . The second term on the left side comes from the expansion of the universe, where H is the Hubble constant. $_1^{th}$ is the thermally averaged decay rate of the j $_1$ i state, n is the usual photon density and the term h juji describes the thermally averaged cross-section of $1+^y$! 1^c+ scattering. We note that the rst term of the right side of this equation describes the creation of lepton number and is proportional to $(^0+_1)$, while the last two terms are responsible for any depletion of lepton number and are coming from the inverse decay and the scattering respectively. The density of the $_1$ state satis es the Boltzmann equation,

In order to $\,$ nd a solution to this set of coupled di erential equations it turns out to be useful to transform to new variables. We introduce the dimensionless variable x = M $_{\rm 1}$ =T, a particle density per entropy density $Y_{\rm i}=n_{\rm i}=s$ and make use of the relation t = $x^2=2H$ (x = 1).

In addition we de ne the parameter $K=_{i}(x=1)=H$ (x=1) which is a measure of the deviation from equilibrium. For $K=_{1}$ at $T=_{1}$ M $_{1}$ we are far from thermal equilibrium so that both inverse decays and 2~\$ 2~CP non-conserving scattering processes are not important and can be safely ignored. With these simplications and the above redenitions the Boltzmann

equations e ectively read:

For very large times the solution for Y_L has an asymptotic value which is approximately given by

where g denotes the total number of e ectively massless degrees of freedom and is of the order of 0 (10^2) for all usual extensions of the standard model. The lepton asymmetry thus generated will then be converted to the baryon asymmetry of the universe during the electroweak phase transition [12] and is approximately given by $n_B = \frac{1}{3} n_L$. So we have demonstrated that the baryon asymmetry is proportional to $(^0+_1)$. This new contribution was shown to be at least of the same order as the 0 (as shown in gure 3) and for small values of r, exceeds 0 by several orders of magnitude (gure 4).
