Low energy supersymmetry with a neutralino LSP and the CDF $ee + E_T$ event

Abstract

We present a re-ned and expanded analysis of the CDF ee $+ \not\!\!\!E_T$ event as superpartner production, assuming the lightest neutralino is the lightest supersymmetric particle. A general low-energy Lagrangian is constrained by a minimum cross section times branching ratio into two electrons and two photons, kinematics consistent with the event, and LEP1-LEP130 data. We examine how the supersymmetric parameters depend on the kinematics, branching ratios and experimental predictions with a selectron interpretation of the event, and discuss to what extent these are modiled by other interpretations. Predictions for imminent CERN LEP upgrades and the present and future Fermilab Tevatron are presented. Finally, we brie y discuss the possible connection to other phenomena including a light stop, the neutralino relic density, the shift in R_b and the associated shift in $_s$, and implications for the form of the theory.

1 Introduction

M inimal low energy supersymmetry provides the most promising framework to extend the Standard M odel (SM). Such extensions take the form of complete models that encompass the gauge group structure and particle content of the SM, along with the supersymmetry interactions and superpartners. General low energy theories of supersymmetry have over 100 parameters in addition to the SM parameters; such parameters can certainly be constrained by direct collider searches, but in general one needs more information or more assumptions to do calculations that examine many parts of the remaining parameter space. In many cases only one or a few parameters enter the calculation of a given observable, so useful predictions can often be made from a small subset of the supersymmeter space are to use theoretical assumptions, and (direct and indirect) experimental constraints.

In Ref. [1] we showed that the CDF \cong + E_T event [2] at the Ferm ilab Tevatron could be interpreted in low energy supersymmetry with roughly the expected rate and kinematics. If we assume this interpretation is correct and the event is due to supersymmetry, then we can reduce the parameter space by searching for sets of parameters that satisfy the event's constraints. We use the term is odel' to describe a distinct set of parameters, but of course all of our in odels' parameterize only one basic supersymmetric low energy Lagrangian. The primary di culty in deriving precise parameter constraints (hence predictions) is the somewhat arbitrary notion of interpreting one event in terms of a cross section times branching ratio. Instead of advocating a particular low en (or upper) threshold value, we vary the value in a reasonable range and show the e ect on parameter space and predictions. In this way we attempt to give an appreciation for the robustness or con dence of particular constraints or predictions.

W e work within a general low energy (electrow eak scale) supersymmetric theory without assuming common scalar or gauginom assess at the unication scale [3]. To determ ine branching ratios and scalar interaction contributions to cross sections, we do assume squark mass degeneracy except possibly for the light stop t_1 , and a mass degeneracy among sleptons with the same electrow eak quantum numbers. Such assumptions are not crucial to our analysis, and could be removed if necessary. We assume R-parity is exactly conserved, so the lightest supersymmetric particle (LSP) is stable (consistent with the equation H_T event where the two LSP is escape the CDF detector). Finally, throughout this paper we assume the LSP is the lightest neutralino N_1 , and not the gravitino. A nalyses of the equation H_T event assuming the LSP is a light gravitino have been presented by us [1, 4] and in other R efs. [5, 6]. One cannot distinguish these scenarios based solely on the equation. In this paper we assume that N_1 is the LSP, or is at least long-lived enough to escape the detector. If N_1 is idential ed as a stable LSP, then it is a possible cold dark matter particle [7]. In m inim allow energy supersymmetry the possibility of one-loop radiative decay of neutralinos [8, 9, 10, 11] leads to signals with hard isolated photons plusm issing energy in the nal state, a signal predicted m any years prior to the ee $+ E_T$ event. This is by no m eans the only mechanism to produce photons plus m issing energy, but it does allow the interpretation of the ee $+ E_T$ event as selectron production $p\overline{p}$! $e^+e^-(+X)$, with the selectron e decaying m ainly into the next-to-lightest neutralino N_2 and an electron, followed by N_2 ! N_1 . It is also possible to imagine other interpretations that involve the radiative decay of N_2 , but for which the initial superpartner production is di erent. The two possibilities in this class that we consider below are chargino pair production and neutralino pair production.

The plan of the paper is as follows. In Sec. 2 we discuss the kinem atics of the ee + 🗹 event in the selectron interpretation, the chargino interpretation, the neutralino interpretation, and other interpretations. Using superpartner mass constraints established from the ee + <u></u><u></u><u></u><u></u><u></u><u></u>_T event kinem atics, we discuss low energy supersymmetric model building in Sec. 3. Here we present a discussion of the radiative neutralino branching ratio, slepton decay and constraints from LEP. In Sec. 4 we discuss the results obtained from a numerical scan of the parameter space, using the structure built up from Sec. 3. The bulk of our results are contained in Sec. 4, where we discuss the model building results, the chargino/neutralino/slepton branching ratios, and predictions for LEP and Tevatron. In Sec. 5 we discuss the possibility of explaining the $+ E_T$ event with the further assumption of a light stop t_1 . Finally, in Sec. 6, we present our ee concluding remarks, including a summary of such questions as distinguishing left- and rightselectrons, and the main channels that can con m the $ee + E_T$ event is due to supersymmetry with an $LSP = N_1$. In Appendix A we discuss the viability of the chargino interpretation, and the results of attempts at model building. In Appendix B we give four sample models in the selectron interpretation.

N one added: A s we were completing this paper, three other papers appeared which discuss the CDF ee $+ \mathbb{H}_T$ event in various contexts [31, 32, 33].

2 K inem atics of the $ee + \mathbb{Z}_T$ event

The kinem atical requirem ents on the interm ediate particles involved in the $ee + \#_T$ event are stringent, and for completeness we present a re-ned analysis based on the procedure outlined in R ef. [1]. There are three basic possibilities for interm ediate (s)particles; we will present these in terms of LSP = N_1 interpretations, but the analysis is generic and could be applied to any set of interm ediate particles that satisfy the criteria below. All decays are assumed to occur close to the apparent vertex, which would be true of any LSP = N_1 interpretation. The procedure we use to not kinem atical constraints is to begin with the information on the observed particles [2], assume two- or three-body decays as appropriate, random by select unconstrained momentum components of the unobserved particles on both sides of the decay chain, and then reconstruct the interm ediate particle m asses based on all possible pairings of electrons and photons. The m asses of identical particles on both sides of the decay chain are required to be within 2.5 G eV to 'pass' the kinem atic cut. The net transverse momentum in the event from adding both the observed particles and the LSP s is assumed to be $\dot{p}_T j < 20 \text{ GeV}$.

2.1 Selectron interpretation




Figure 1: The kinem atically allowed region of the ee $+ E_T$ event in the $m_e \{m_{N_2} \text{ plane is show n} \text{ for various values of } m_{N_1}$ in the selectron interpretation. The allowed regions for $m_{N_1} = 0, 10, 20, 30, 40, 50, 60, 70 \text{ GeV}$ are to the inside and right of the indicated lines. The allowed region for any given m_{N_1} is roughly a subset of any lower m_{N_1} , except for large values of m_{N_2} . Since the lines are derived from the momenta of the ee $+ E_T$ event, they are only as precise as the associated measurement of momenta.

The rst possibility is selectron production $p\overline{p}$! $e^+e^-(+X)$ and decay via the 2-body mode e ! eN_2 followed by N_2 ! N_1 . All sparticles are assumed to be on mass shell. The general result is summarized in Fig. 1, where the allowed regions in the $m_e \{m_{N_2} \text{ plane} are$ given for a series of maximum values of m_{N_1} . The choice to cut o the graph at $m_e = 140$ GeV is motivated by a rough lower limit on the selectron cross section, which will be made precise in Sec. 4.2. Since the electron and photon momenta have experimental uncertainties, the kinematic results that we derive from the event will have associated uncertainties. A nalytic form s of the constraints have been extracted and are presented in Table 1; a few observations are in order that will be useful in model building:

- 1. $m_{N_1} < (50;74) \text{ GeV}$, for $m_e < (115;137) \text{ GeV}$.
- 2. $m_{N_{1}} > 21 \text{ GeV}$, this value increasing to 30 GeV as $m_{N_{1}} ! 0 \text{ GeV}$.
- 3. $m_e = m_{N_2} > 20 \text{ GeV}$, this value increasing for decreasing m_e .
- 4. Given $m_{N_1} > 33 \text{ GeV}$, then $m_e > 100 \text{ GeV}$.
- 5. Only one pairing of electron and photon gives consistent kinematics for m $_{\rm e}$ < 125 GeV .

The non-trivial mass di erences that are required are not surprising, since all of the particles in the event have large (transverse) energy. We incorporate the mass di erence constraints as well as the constraints on the ranges of m_{N_1} , m_{N_2} , and m_e in our model building e orts.

2.2 Chargino interpretation

The second possibility is chargino production $p\overline{p}$! C_iC_j (i; j = 1;2), with three possible decay chains: 3-body C ! N_2e_e (through an o -shell or possibly on-shell W), 2-body C ! e_e or C ! $\sim_e e$. For either 2-body decay, the on-shell slepton proceeds through another 2-body decay $e(\sim_e)$! $e(_e)N_2$, then the photons are obtained through N_2 ! N_1 . Calculating consistent kinematics requires specifying the six unknown momenta of the two neutrinos as well as the unknown LSP momenta in the nal state. This is too complicated to delineate any rigorous exclusion regions using the random ized momenta procedure as in the selectron

interpretation. However, we have checked that it is possible to generate consistent kinem atics form $_{\rm C}$ > 95 G eV, assuming the 2-body decay C ! 11⁰ and that all (s)particles are on-shell. The rough regions where we were able to nd kinem atical solutions have m₁ > 60, 75 for slepton = sneutrino, selectron. In addition, we found solutions with m_{N2} > 20 G eV, m_{N2} m_{N1} > 10 G eV, m_C > max [2:5m_{N2} 95; 1:5m_{N1} + 65; 95] G eV. Thus a solution in the selectron interpretation need not be a solution in the chargino interpretation, and vice versa.

2.3 Neutralino interpretation

The third possibility is neutralino production, e.g. $p\bar{p}$! N_2N_j , where either of the heavier neutralinos j = 3,4 decay as N_j ! $I^+ l N_2$, followed by the usual N_2 ! N_1 . This interpretation contrasts with the rst two by producing both leptons from one side of the decay, however it is calculable as in the selectron scenario (since the only unknown nal state momenta are the two neutralinos). The invariant mass of the electron pair can be extracted from the event m_{e^+e} 160 GeV [2], which implies the mass di erence between m_{N_j} and m_{N_2} must also be greater than 160 GeV. This is almost certainly too high for a reasonable Tevatron cross section while retaining a reasonable m_{N_2} and proper neutralino mixing to have N_2 ! N_1 . Further, in the particular case where the branching ratio for the decay N_j ! N_2Z is large, then a lepton pair from Z ! $I^+ 1$ will always reconstruct to to an invariant mass of about m_Z . Thus, a neutralino interpretation of the exert $+ \not_T$ event seem s extrem ely unlikely, and we will not consider it further.

2.4 Other interpretations

O ther supersymmetric interpretations with a neutralino LSP are in principle possible, and are based on variants of selectron production, chargino production or neutralino production. The di erences lie in the particular decay from which the electrons originate, plus possibly other invisible phenomena (neutrinos). In all cases the photon is obtained from the decay \mathbb{N}_2 ! \mathbb{N}_1 , and as a consequence the photon always appears in the last step of the decay chain. One example is stau production $p\overline{p} ! \sim^+ \sim (+X)$ with the decay $\sim ! N_2$, followed by ! e(+ e). The total branching ratio is suppressed compared with selectron production by a factor B ($! e_{e})^{2}$ 0:03, hence the rate into ee is much smaller than selectron production. A nother example is a variant of the selectron interpretation with a chargino ${\mathbb C}$ that is lighter than the selectron, such that the decay $e_L \ ! \ _eC \ (! \ N_2e \ _e)$ is dominant. In this case it is probably not possible to have a large decay $e_L ! C_e$, with both $e_L ! N_{1,2}e$ suppressed. Further, $C ! N_1 e_e$ has to be suppressed with respect to $C ! N_2 e_e$, which is dicult especially in the presence of \mathbb{N}_2 ! \mathbb{N}_1 . Finally, with four neutrinos carrying o invisible momentum it seems di cult to have a large probability for the high energy electrons required in the nal state, since the selectrons have to be light to have a large ee rate.

3 Modelbuilding

The main focus of this paper is on the selectron interpretation and not the chargino interpretation, since it is made clear in Appendix A that the chargino interpretation is di cult for many reasons. However, in the following we have attempted to provide a general discussion of the model building, since radiative neutralino decay is required in both interpretations.

3.1 Supersym m etric param eters

The chargino and neutralino tree-level masses and mixings are determined by specifying the gaugino soft masses M₁ and M₂, the ratio of the Higgs vacuum expectation values hH_2^0i/hH_1^0i and the Higgs super eld mass parameter . The form of the mass matrices is well known, but it will prove useful in the discussion of the radiative branching ratio to have the expressions in the particular basis as follows. Note that we assume no relation between M₁ and M₂.

The chargino mass matrix in the (10° , H) basis is

and can be diagonalized by a biunitary transform ation U M $_{\rm C}$ V 1 to yield the m asses and m ixing m atrices U,V (as well as xing the sign convention of , consistent with R ef. [12]). The chargino m asses can be found from the analytic expression

The neutralino m ass m atrix in the ($i\sim$, $~{\it I}$, H $_{\rm a}$, H $_{\rm b})$ basis is

and can be diagonalized by a unitary transform ation N M $_{\rm N}$ N 1 to yield the four neutralino m ass eigenvalues $_{\rm i}$ m $_{\rm N_i}$ and the m ixing m atrix N that we assume to be real and orthogonal (exact expressions for the m ixings and m asses can be found in [13, 14]). The sign of the neutralino m ass eigenvalue $_{\rm i}$ enters the supersymmetric Feynman rules, while the physical m asses m $_{\rm N_i}$ are always positive with the ordering 0 m $_{\rm N_1}$ m $_{\rm N_2}$ m $_{\rm N_3}$ m $_{\rm N_4}$. The (~, Z) basis is related to the (B, W³) basis through

and the (H_a, H_b) basis is related to the (H_1^0, H_2^0) basis through

O urnotation follows Refs. [12, 15], with H_1^0 and H_2^0 coupling to the down-and up-type ferm ions respectively. The production cross sections for charginos and neutralinos at LEP and at the Tevatron involve graphs with s-channel gauge boson exchange and t-channel slepton or squark exchange. In Table 2, we item ize the dependence of each chargino/neutralino cross section on the squark or slepton m ass.

The gluino does not enter phenom enology directly associated with the $ee + F_T$ event. Its tree-level m ass is given by the soft m ass parameter M₃ that is unconstrained without gaugino m ass uni cation. There need be no relation between M₁, M₂, and M₃, and we do not assume

one. However, one could imagine that the non-Abelian masses M₂, M₃ are equal at the uni cation scale, with the U (1) mass M₁ related to them in a more subtle way. Ref. [16] has suggested that the gluino may play a dramatic role at the Tevatron, if the lightest stop \mathfrak{l}_1 has a mass 0 (50) GeV. However, for the primary purposes of this paper we can focus on phenom enology that is independent of the gluino. In Sec. 5 we elaborate on the possibility of models that can generate an ee $+ \mathfrak{B}_T$ event with the additional assumption of a light stop.

The slepton sector is de ned by the m asses m $_{\rm L}$ and m $_{\rm L}$, with m $_{\sim}$ related by the SU (2) $_{\rm L}$ sum rule

for tan > 1, and the couplings to gauge bosons and gauginos xed by the SM gauge group. Slepton production cross sections at the Tevatron are given in Refs. [17, 18, 1], and depend only on the mass of the slepton. We assume slepton mass degeneracy (motivated by the absence of lepton avor changing decays), although it is not required by the theory nor the ee $+ \not\!\!E_T$ event. Where necessary, we remark on the elect of removing this assumption on associated phenomenology. We also assume L (R mixing in the slepton sector can be neglected.

The squark sector in ourm odelbuilding is de ned for simplicity by a common squark mass m_q , the stop masses m_{t_1} , m_{t_2} and the stop mixing angle t. In this way we achieve a useful reduction of parameter space through $m_q = m_{u_L} = m_{d_L} = m_{u_R} = m_{d_R} = :::, and we further assume for simplicity <math>m_{t_2} = m_q$. These assumptions can be removed if data becomes sensitive to them. The stop mass eigenstates are de ned by

with the stop trilinear coupling A_t (and the soft m asses m $_{\mathcal{Q}}$, m $_{\mathfrak{t}_R}$) uniquely determ ined by m $_{\mathfrak{t}_{1;2}}$ and the mixing angle $_t$, for a given and tan . We assume all other L {R squark mixing can be neglected.

The Higgs sector is determined from tan , the neutral CP-odd Higgs mass m_A , and higher order corrections [19, 20]. We include one-loop corrections from stops [20], and neglect all other contributions. In this fram ework we calculate the charged Higgs mass m_H , the neutral CP-even Higgs masses m_h , m_H and the mixing angle from the above parameters. The Higgs sector enters the radiative neutralino decay through the charged Higgs boson, and the branching ratios for the heavier superpartners into one or more of h, A, H, or H (neglecting o -shell Higgs exchange in 3-body C; N' ! C; N'ff decays).

3.2 Radiative decay of neutralinos

The radiative decay of neutralinos has been well studied [8, 9, 10, 11], and it su ces to review the mechanism that enhances the radiative branching ratio with respect to the traditional

3-body $N_2 ! N_1 f \overline{f}$ decays, as pertaining to the ee $+ E_T$ event. We exclusively discuss $N_2 ! N_1$, since heavier neutralinos always have sizeable tree-level branching ratios into 2-or 3-body channels, causing the radiative branching ratio to be negligible.

There exists both a kinem atical and a dynam icalm echanism that can give an enhancem ent of the radiative neutralino decay [9, 11]. The kinem atic enhancem ent can only occur when the m ass di erence m $_{\rm N_2}$ m $_{\rm N_1}$ is small 0 (10) GeV, so that other decay m odes are closed or suppressed. However, the kinem atics in the selectron interpretation enforce m $_{\rm N_2}$ m $_{\rm N_1} > 21$ GeV by 0 bservation 2, and so a kinem atic enhancem ent of the radiative branching ratio is not crucial for our purposes (although see Sec. 4.2 for exceptions).

The dynam ic enhancement of the radiative decay occurs as follows. First, exam ine the lim it when tan $(M_1 \ M_2) = 0$ [15]; the neutralino mass matrix (already written in a suggestive form in Eq. (3)) becomes particularly simple,

In this limit two neutralinos become pure photino (~) and Higgsino (H_b) states, with masses M₂ and j jrespectively. The other two neutralinos are mixtures of \mathbb{Z} (H_a , with masses

For pure ~ and H_{b} states, the tree-level couplings ~ $\text{H}_{b}^{\prime}\text{Z}$, ~ $\text{H}_{b}^{\prime}\text{h}$ (A), and $\text{H}_{b}^{\prime}\text{ff}$ (in the lim it m $_{\rm f}$! 0) go to zero, leaving the one-loop 'e ective' coupling ~ H_{b}^{\prime} dom inant. Thus, by associating $N_{1;2}^{\prime}$ with ~, H_{b}^{\prime} , then the one-loop decay N_{2}^{\prime} ! N_{1}^{\prime} is dom inant. One consequence of requiring the two lightest neutralinos to be either of the states ~ or H_{b}^{\prime} (hence the heavier two neutralino m asses are given by Eq. (9)) is that the required m ass ordering m $_{N_{1;2}}^{\prime} < m_{N_{3;4}}^{\prime}$ in plies

See Ref. [11] for a more comprehensive treatment of this issue. What is not determined by requiring a large radiative branching ratio by this mechanism is which one of the two lightest neutralinos is the photino or Higgsino.




Figure 2: (a) Contourplot for the branching ratio of the radiative neutralino decay $N_2 ! N_1$ in the M₁{M₂ plane for the case tan = 12, = 45 G eV, $m_{e_{L,R}} = 110 \text{ G eV}$, $m_{q} = m_{t_{1,2}} = 500 \text{ G eV}$, and $m_A = 400 \text{ G eV}$. The B ($N_2 ! N_1$) = 0.9, 0.75, 0.5, 0.3 levels are shown and labeled. The LEP excluded region is shaded. The solid thick line outlines the region where $N_1 H_b^0 i^2 h N_2 j \cdot f^2 > 0.7$. (b) C ontourplot in the same plane with the parameters above, show ing the mass di erence of the two lightest neutralinos in G eV. This gure is a result of the general radiative neutralino decay analysis of R ef. [11].

The extent to which a large radiative branching ratio is possible in general (and in particular through the dynam ical mechanism without the exact relations above) can be evaluated sem i-analytically and numerically [11]. As an example, Fig. 2 (a) shows contours of the branching ratio of N₂ ! N₁ in the M₁{M₂ plane, for = 45 GeV, $m_{e_L} = m_{e_R} = 110 \text{ GeV}$, $m_A = 400 \text{ GeV}$, tan = 12, and all squarks heavy $m_{t_1} = m_q = 500 \text{ GeV}$. The thick solid line bounding the region de ned by $hN_1 \#_b^0 i^2 hN_2 j \cdot i^2 > 0$:7 anticipates the constraint on selectron decay from

the ee + \mathbb{E}_{T} event (see Sec. 3.3 below). Contours in the mass di erence m_{N₂} m_{N₁} > 3, 10, 20, 40 G eV are shown in Fig. 2(b). Since the selectron interpretation requires a large mass di erence m_{N₂} m_{N₁} > 21 G eV, only a fairly small region of parameter space remains satisfying the constraint of a large radiative neutralino branching ratio. For example, the region bounded by B (N₂ ! N₁) > 0.5, m_{N₂} m_{N₁} > 20 G eV, and the LEP exclusion region is characterized by roughly 0.6 < M₂=M₁ < 1.5 for 60 < M₁ < 90 G eV, 45 < M₂ < 90 G eV, where the constraints on M₂=M₁ are stronger for larger values of M₁, M₂. Of course this example only applies to the choice of , tan , m_e, m_q, m_A values as above, but it gives a reasonable illustration of the constraints. The region with a large radiative neutralino decay centered on the line M₁ = M₂ persists as j j is increased or decreased (the region shifts up or down the M₁ = M₂ line), but tends to shrink (and eventually disappear) as tan is increased or the squark or slepton masses are decreased.

3.3 Slepton decay

In the selectron interpretation, the branching ratio of the selectrons e ! eN_2 is crucial to produce an $ee + E_T$ event. In general, sleptons couple to the gauginos through the usual supersymmetrized gauge interactions, and also to the Higgsinos through the Yukawa couplings. The Yukawa couplings $m_1=M_W$ are strongly suppressed by small lepton masses, and for our purposes can be neglected. Since the radiative branching ratio N_2 ! N_1 requires one of $N_{1,2}$ to be mostly a photino and the other mostly a Higgsino, then the requirement that the selectron decays as e ! eN_2 in plies the photino-Higgsino content of the neutralinos is unique and determined

Based on Sec. 32, this implies $j j < M_1 (= M_2)$, in the lim it of pure states.

If the $\mathfrak{E}_{\mathrm{T}}$ event is due to $\mathbf{e}_{\mathrm{L}} \mathbf{e}_{\mathrm{L}}$ production, one must also consider the branching fraction of \mathbf{e}_{L} to charginos if kinem atically accessible. In the kinem atics of the selectron interpretation no such decay was considered, and naively it would seem possible to suppress this decay through a judicious choice of chargino mixings. However, it is also possible that \mathbf{e}_{L} production occurs with the selectron decay \mathbf{e}_{L} ! \mathcal{C}_{1} e, then the decay \mathcal{C}_{1} ! $\mathbf{e}N_{2}$. In the tan = 1 lim it (with neutralinos pure states) the masses of the charginos simplies considerably from Eq. (2) to

This expression is the same as Eq. (9) with M_Z ! M_W, and shows that the chargino masses are directly correlated with the heavier two neutralino masses. It is a simple matter to show that $m_{C_1} > m_{N_2}$ is always true (in the tan $= 1, M_1 = M_2$ limit), while the coupling of C_1 to $N_2 (= \sim)$ and $N_1 (= H_b)$ is dependent on the gaugino-Higgsino mixings of the chargino. The $e_L \{C \in C \}$ couplings are also proportional to the gaugino component of C and so a full num erical calculation is necessary to determ ine the relative size of the branching fractions. This will be presented in Sec. 4.4.

3.4 Constraints from LEP

Throughout our analysis, we applied the most updated limits on the supersymmetric parameters and bounds on superpartner masses coming from searches at LEP1, as well as the more recent run with p = 130.3 and 136.3 GeV (collectively denoted LEP130-136') where integrated luminosities of about 2.8 and 2.3 pb 1 were accumulated [21]. We also show the combined e ect of the LEP limits and kinematical constraints on the selectron and light neutralino masses in the selectron interpretation of the ee $+ E_T$ event, and the derived ranges

of , M₁ and M₂ values. The som ewhat conservative LEP1 bounds we imposed are [22, 23]:

The evaluation of the supersymmetric contribution to the invisible Z width included not only the contribution from the direct LSP production Z ! N_1N_1 , but also the contribution from other channels Z ! $N_1(! N_1 N_1(! N_1). These contributions were then subtracted when calculating the supersymmetric contributions to the visible Z width.$

The constraints we applied at LEP 130-136 are

corresponding to the 5 visible event level (before detector cuts) for each of the two runs [21]. A few remarks on the calculation of the expected total visible supersymmetric cross section are in order. First, we considered only the contribution from chargino/neutralino production, since charged sleptons relevant to the $ee + \note_T$ event need to be heavier than 75 GeV just to satisfy the kinematics (see Table 1). We require squarks to be heavier than can be produced at LEP, except possibly a light stop whose production cross section is always too small to see any events at LEP 130-136 with the data sam ple collected. The total visible supersymmetric cross section obviously does not include processes like $e^+ e + N_1N_1$, and $e^+ e + N_1N_j$ when both $N_{i;j} + N_1$. This was achieved by doing a complete calculation of the branching ratios for chargino/neutralino decays for every model. To ensure the visibility of the signal, we also required large enough phase space in the decay of the produced N_i , C_i , which in practice in plied the mass difference $m_{C_1,N_2} = m_{N_1} > 10$ GeV, in accord with [21].

The following observations are useful to understand in some detail how the LEP constraints a ect our analysis in a general low energy supersymmetric framework (without assuming any relation between M_1 and M_2). Combining the bounds arising from neutralino searches at LEP with the need for a next-to-lightest neutralino $m_{M_{2}} > 30 \text{ GeV}$ from the ee + E_{T} event kinem atics (see Sec.2), one nds the \light Higgsino-gaugino window "with M₁, M₂, j j M_Z 1 [23] is excluded. This also implies $j j^{>}$ 33 GeV, at least for small tan . and tan Further, given the light Higgsino-gaugino window is excluded for our purposes, only < 0 survives LEP constraints such that a large radiative neutralino branching ratio is present [11], 33 GeV. For tan > 1:3 either the LEP chargino m ass bound thus we are left with < or the direct search for neutralinos begin to exclude regions with small negative , irrespective of M $_1$ and M $_2$ values. Given a value of % 1 , one can % 1 nd rough regions in the M $_1$ (M $_2$ plane that are allowed by LEP constraints, generally independent of tan . In our fram ework, the constraints we listed above exclude $M_1 < 30$ GeV and, for instance, when = 45 GeV then $M_1 \leq 55 \text{ GeV}$ is not allowed if $M_2 \leq 20 \text{ GeV}$. The region in $M_1 \{M_2 \text{ space excluded by LEP}$ is indicated in Fig. 2 for = 45 GeV, etc. Notice that since the ee $+ \text{ E}_{\text{f}}$ event requires a suitable slepton decay, then the neutralino contents in Eq. (11) can exclude a comparable region (see Sec. 3.3, and in particular Fig. 2). In contrast, the requirement $(m_{N_2} m_{N_1}) > 21 \text{ GeV}$ of Observation 2 in Sec. 2 combined with the LEP constraints electively sets a minimum suitable value of M_1 around 52 GeV for any values of the other parameters. Only weaker bounds on M_2 can be identied in a similar way.

In addition to the constraints from chargino and neutralino production, we also imposed

on our models from LEP constraints. Since the inputs to our model building to calculate the Higgs sector include m_A and tan , the above mass bounds in pose a constraint on m_A and higher order corrections from the stop sector. This will be important for the discussion about models with a light stop in Sec. 5. Small tan also su ers from possible non-perturbativity constraints, that have been discussed recently in e.g. Ref. [23] for the light Higgsino-gaugino window that requires small tan . However, the constraint is relatively weak (tan > 12), since as we shall see the allowed region of tan extends up to tan 2:0! 2:8.

4 Numerical results { selectron interpretation

4.1 Prelim inaries

Interpreting one event as a cross section is a tenuous procedure, although som e general m ethodology can be applied. First, we establish a m in im um threshold in the Tevatron selectron cross section times branching ratio into two electrons and two photons,

where A $(\vec{B})_{j_{n}i_{n}}$ is the minimum threshold value. Since the choice of the threshold A is somewhat arbitrary, we show the elect of increasing the threshold from 5 to 7.5 to 10 fb to give at least some indication as to how sensitive the constraints are to the value. Imposing A = 20 fb excludes all of our models, so there is a non-trivial importance of the precise numerical value of the threshold for phenomenology.

The quantity B^2 used in the general analysis does not include detector cuts, but we have simulated particular models to get indicative e ciencies (see Sec. 4.8). For a detection e ciency of 0.2, the lowest threshold cut A = 5 fb corresponds to assum ing a cut on the e ective ee rate of $s = B^2$ EFF = 1 fb or 1=10 of an event. G iven an expected number of events s, the probability of observing exactly n events is from Poisson statistics

For s = 0:1 corresponding to 1 fb cross section at the Tevatron, one still has a 9% chance of seeing exactly one event.

The results are presented assuming a branching ratio into only one family, although it is straightforward to compute the total two lepton plus two photon rate including sm uon and/or stau production. The e ect is of course to increase our calculated rate by a factor of 2 or 3. (O ur results remain unchanged if the threshold A is increased by the same factor.) Note that including m ore than one family is of course crucially dependent on the assumption of slepton m ass degeneracy.

In the selectron interpretation there is no a priori requirement of having \mathbf{e}_{L} or \mathbf{e}_{R} production. We consider three cases: A selectron interpretation from \mathbf{e}_{L} production, where the kinematics of the $\mathbf{e}_{L} + \mathbf{E}_{T}$ event must be satisfied form \mathbf{e}_{L} , but must not be satisfied form \mathbf{e}_{R} . In this way, $\mathbf{e}_{R} \mathbf{e}_{R}$ production can still give an \mathbf{e}_{R} signal but the kinematics are not consistent with the $\mathbf{e}_{R} + \mathbf{E}_{T}$ event; hence only the rate from $\mathbf{e}_{L} \mathbf{e}_{L}$ production ought to be considered. Second, the opposite scenario with \mathbf{e}_{R} production where the kinematics must be satisfied form \mathbf{e}_{R} , but not for m \mathbf{e}_{L} . Finally, we consider a set of models with the simultaneous $\mathbf{e}_{L} \mathbf{e}_{L}$ and $\mathbf{e}_{R} \mathbf{e}_{R}$ production (denoted $\mathbf{e}_{L} + \mathbf{e}_{R}$ models'), where the kinematics are satisfied for the \mathbf{e}_{L} and m \mathbf{e}_{R} . The threshold A is applied as follows,

where $_{L,R}$ (\overline{pp} ! $\stackrel{e}{}_{L,R} e_{L,R}$) and $B_{L,R}$ B ($e_{L,R}$! $N_2 e$)B (N_2 ! N_1). The case of $e_L + e_R$ m odels assumes that the contributions to the ee cross section from e_L and e_R production can be summed, hence the requirement that the kinematics of the event is satisfied for both contributions. Further, for $e_L + e_R$ models we enforce $_{L,R} > 1$ fb to avoid the diffusion of $_{L,R}$ B²_{L,R} being arbitrarily close, but below the threshold A while the other contribution can

L

be very small. In such a case them odel could still pass the cut on the sum $_{\rm L}$ $B_{\rm L}^2 + _{\rm R}$ $B_{\rm R}^2 > A$, but would be on the borderline of classi cation as either an $e_{\rm L}$, $e_{\rm R}$, or $e_{\rm L}$ + $e_{\rm R}$ model. We will show that this bose requirement on the cross section does not a ect our results. Finally, note that since B (N_2 ! N_1) depends in general on both selectron masses $m_{e_{\rm L}}$ and $m_{e_{\rm R}}$, then $e_{\rm L}$, $e_{\rm R}$ and $e_{\rm L}$ + $e_{\rm R}$ models can each be considered a distinct class of models.

4.2 M odel building results

In Table 3, we present the parameters that enter our analysis common to all selectron interpretations, and the relevant ranges. For the e_L and e_R interpretations, the allowed range of m_e is determined by the lower bound from kinematics $m_e > 100 \text{ GeV}$ using 0 bservation 4 in Sec. 2 (indeed j j $m_{N_1} > 33 \text{ GeV}$, from Sec. 3.4). The upper bound is obtained from the minimum threshold in the cross section times branching ratio A. For A = 5, 7.5, 10 fb, the upper bound on the slepton mass is $m_{e_L} < 137, 125, 118 \text{ GeV}$, and $m_{e_R} < 115, 105, 97 \text{ GeV}$, in the e_L and e_R interpretations. Notice that e_R models always fail the highest threshold, since the cross section never exceeds 10 fb in the allowed mass range. The mass of the other slepton that is not the source of the ee $+ E_T$ event (hence ee $+ E_T$ event kinematics do not apply) is allowed to take on a much wider mass range 60{500 GeV}. For the $e_L + e_R$ interpretation, both sleptons stillmust be greater than 100 GeV by ee $+ E_T$ event kinematics, but the upper limits are somewhat relaxed since each individual rate $L = B_L^2$ or $R = B_R^2$ need not be larger than the threshold; only the sum must satisfy the E_T constraint.

We have explicitly constructed roughly 2500 models in total, with somewhat more \mathbf{e}_{L} models than \mathbf{e}_{R} or $\mathbf{e}_{L} + \mathbf{e}_{R}$. The results are shown in a series of scatter plots and bar graphs that are intended to give the general character of the models. Figures 3, 4, 5 show the distribution of all the allowed models in the M₁{M₂ plane, with groupings of models split up into three plots. All of the models pass the ee $+ \mathbf{E}_{T}$ event kinematic cuts for one or both sleptons




Figure 3: The models satisfying the $ee + E_T$ event kinematics and the minimum threshold cut A = 5 fb are shown in the M₁{M₂ plane. In this gure, e_L (L), e_R (R) and $e_L + e_R$ (L+R) have been separated to show the varying restrictions on either type of model.




Figure 4: As in Fig. 3, except the models are distinguished by the cut on A = 5, 7.5, 10 fb.




Figure 5: As in Fig. 3 except that the models are distinguished by the value of tan $\$.

(de ned by the model type), and all models pass the minimum threshold cut A = 5 fb. In Fig. 3, the models are grouped by the type e_L , e_R , or $e_L + e_R$ according to which slepton (s) passed the ee $+ E_T$ event kinematic cuts. In Fig. 4, the models are grouped by the rate, $5 < B^2 < 7.5, 7.5 < B^2 < 10$, and $B^2 > 10$ fb. In Fig. 5 the models are grouped by tan into the (arbitrary) ranges $1 < \tan < 1.5, 1.5 < \tan < 2$, and $\tan > 2$. There are perhaps four regions with distinct character, and we will discuss each of them in the follow ing.

Region 1 de ned by roughly 0.8 < M₂=M₁ < 1.2 represents the anticipated M₁ M₂ region. All three types of models e_L , e_R and e_L + e_R fall into this range, with e_R models almost contained within the M₂=M₁ limits. This is the region where the dynam ical enhancement of the radiative neutralino branching ratio is present, with the limiting case (M₁ M₂)! 0, tan ! 1 giving the largest value. Hence, the highest B^2 can be found in this region, but the rate need not be high since the slepton cross section can be low independent of the branching ratio. For example, e_R models always have $R = B_R^2 < 82$ fb with $B_R^2 < 98$ %, whereas e_L models have $L = B_L^2 < 162$ fb with $B_L^2 < 88$ %. Since the decay $e_L ! C_1 e$ is always present, the maximum branching ratio B_L^2 is always less than the maximum for B_R^2 .

Region 2 de ned by roughly M $_2$ =M $_1 > 1.2$ is populated with mostly e_L models, extending barely up to the M $_2 = 2M_1$ line near M $_1$ 60 G eV. The reason for the much larger range in M $_2$ values for e_L models is a direct consequence of the higher cross section $_L$ 22 $_R$ for a given slepton mass. W ith a higher cross section, the total squared branching ratio can be lower, which translates into looser restrictions on the radiative neutralino branching ratio. For e_L and e_R models, the minimum B² is 25% and 56%, which corresponds to a minimum B (N $_2$! N $_1$) of 50% and 75% respectively (when B (e ! N $_2$ e) = 100%). Fig. 2 already showed (for a speci c set of , tan , m $_q$, m $_A$ values) that a looser restriction on the radiative branching ratio admits a larger region in the M $_1$ (M $_2$ plane. The models observed with M $_2$ =M $_1$ > 12 lie in just this extended region which bene t from the kinem atical mechanism (in addition to the dynam ical mechanism) for the radiative neutralino decay enhancem ent. This can be deduced by exam ining the slepton masses for the e_L models in this region, where one nds m e_R m $_e_L$ by a factor of




Figure 6: All of the models are shown in the {tan plane, distinguished by the cut on A = 5, 7.5, 10 fb.

2 or m ore. This is necessary to obtain a large radiative neutralino decay, since the branching ratio for 3-body decays $N_2 ! N_1 l^+ l$ through sleptons cannot be reduced to zero when the kinem atical mechanism for a large B ($N_2 ! N_1$) operates [11]. In addition, the squark m asses m ust also be heavy to prevent the analogous 3-body decays mediated by squarks, although the choice of m_q 250 GeV in our models is su cient. Finally, the existence of only e_L models in this region is due to the fact that kinem atical enhancement of the radiative neutralino decay cannot be maximized simultaneously with the $m_{N_2} m_{N_1} > 21 \text{ GeV}$, and so B^2 cannot be very large. Thus, one needs a large cross section to supplement a lower B^2 , which can only be achieved with e_L models.

The character of the extended e_L m odels in Region 2 ism one clearly visible in Fig.5, where all of the m odels have been plotted in the M₁{M₂ plane distinguished only by the tan value. The m odels with M₂=M₁ > 12 always have 1:5 < tan < 2.8, where the upper limit in tan (and M₁, M₂) is established by the smallest allowed radiative neutralino branching ratio. Indeed, the kinem atical mechanism that contributes to the enhanced radiative neutralino decay in this region does not necessarily require tan ' 1 [11]. In Fig. 4 it is clear that increasing the threshold A to 7:5, 10 pb restricts M₂=M₁ < 1:9, 12, and so the existence of m odels with M₂ = 2M₁ is sensitive to the choice of the minimum threshold. Further, while M₂ = 2M₁ seem ingly admits gaugino m ass unication, we noted above that for the extended e_L m odels m_{e_R} m_{e_L}. Hence, scalar m ass unication probably cannot be achieved, at least in the slepton sector, and a completely uni ed scenario seem s not to be compatible with the ee + E_T event.

In Region 3 loosely de ned as M $_2=M_1 < 0.8$, e_R models appear near M $_1$ 75 GeV and 50 GeV. These models have $_{\rm R}$ $B_{\rm R}^2$ 55 fb and tan 2. This is the only region M 2 where the usual mass hierarchy j j < M $_{\rm 2}$ can be slightly violated. On closer inspection one nds the chargino mass is about 68 GeV. We found no e, models in this region, due to the light chargino that induces a large branching ratio for e_L ! C_e over e_L ! N_2e . A lso, the width for the 3-body decay $N_2 ! N_1 e^+ e^-$ turns out to be considerably enhanced when the e is light. Hence the radiative neutralino decay is strongly suppressed in such a case, and thus e_L models cannot be constructed in Region 3. As tan is increased, the chargino mass becom es smaller and thus is excluded by LEP 130-136 constraints. Low ering tan decreases the radiative neutralino branching ratio, and so is excluded by the B^2 cut. This localized region is basically due to a hybrid of the dynam ical and kinem atical enhancem ent of the radiative neutralino decay. One can use an argument analogous to that used for Region 2, to observe $m_{e_{E}}$ in all of the m odels. The absence of light e_{L} is a consequence of the kinem atical that m _e mechanism at least partly at work. Thus, these models sit at the edge of exclusion, between a multitude of constraints.

Finally, the voids with no models found for $M_1 \ge 85$ GeV with $M_2=M_1 \le 0.8$ or $M_2=M_1 \ge 12$ are excluded by a low radiative neutralino branching ratio. This behavior can be discerned from Fig. 2, but of course the num erical result here encompasses a full range of and tan values.

In general, $e_L + e_R$ m odels tend to be constrained similar to e_R m odels, but boser bounds on M₂=M₁ are present and larger M₁ values accessible. The region with $e_L + e_R$ models that is devoid of e_{L} or e_{R} models, de ned as Region 4, has the properties that the $B^2 < 7.5 \text{ fb}$ and tan < 1.5, while simultaneously $_{\rm L}$ $B_{\rm L}^2 < 5$ fb and $_{\rm R}$ $B_{\rm R}^2 < 5$ fb. For M₁ (M₂) > 90 GeV, larger chargino and neutralino masses are allowed than in either e_L or e_R models. In particular, m_{N_2} is near the upper bound from ee $+ E_T$ event kinematics, so presum ably values of M $_1$ higher than obtained in e_L + e_R m odels are not accessible. As for the size of the rate, the maximum (summed) $\vec{B} < 19$ fb, so it would appear one does not gain æ more than a factor of about 1:2 over the maximum ee rate for e models alone. Further, since $e_L + e_R$ models enlarge the allowed region of parameter space by reducing the minimum $_{L,R}$ $B_{L,R}^2$, one can use the results as an indication of the region resulting from relaxing the A = 5 fb cut in e_L or e_R models separately. It is clear that $e_L + e_R$ models have a distinct character separate from e_L or e_R models.

In Fig. 6 we show the models in the {tan plane to completely specify the parameters. Three features are worthy of explanation: First, the upper and lower limits on j jare approximately the upper and lower limits on m_{N_1} , since N_1 H_b. From Observation 1 in Sec. 2, we know the upper limit on m_{N_1} is 50, 74 GeV for e_R and e_L models, and this can be translated into rough upper limits on j j. The lower limit on m_{N_1} j j 33 GeV, and the region devoid of models in the upper right-hand corner (larger tan , smaller j j), come from a con uence of LEP1, LEP130-136 and $e_L + \mathbb{F}_T$ constraints as explained in in Section 3.4. For example, the LEP constraints on chargino and neutralino production forbid models with j j 40 (50) GeV for tan > 15 (2), once very small j jare excluded by $e_L + \mathbb{F}_T$ event kinematics.




Figure 7: The allowed mass spectrum is shown for all models (shaded bands on the left) and for e_R models only (thick solid outline on the right). The increasingly darker shades in the left-hand column correspond to increasing stricter cuts on A = 5, 7.5, 10 fb. As for tan , the allowed range in all models is $1.0 < \tan < (2.8; 2.6; 1.8)$ for A = 5, 7.5, 10 fb respectively. The allowed range of tan in e_R models only is $1.0 < \tan < 2.0$.




Figure 8: As in Fig. 7, except that m ass di erences between certain charginos and neutralinos are shown.

The nalallowed ranges of M₁, M₂, and the ranges of masses m_{N1}, m_{N2}, m_{N3}, m_{N4}, m_{C1}, m_{C2} derived from them are presented in Fig. 7. The e ect of imposing a stricter cut A = 5, 7.5, 10 fb is shown, in addition to the ranges for e_R models only. The latter is to give an idea of the stronger constraints that exist when a speci c origin of the ee + E_T event is assumed. C orrelations between a selection of chargino/neutralino masses can be discerned from Fig. 8. Sleptons can also have correlations with chargino/neutralino masses, which are relevant for the branching ratios. We present these mass ranges in Table 4. For example, notice that the mass of the slepton satisfying the ee + E_T event kinematics always obeys m_e > m_{C1}.

Squarks do not play a large role in our analysis, since they are assumed to be heavier

than charginos and neutralinos. However, two e ects for a given value of the squark mass persist: First, in 3-body decays of neutralinos, the t-channel exchange of squarks can low er the branching ratio of N₂! N₁, hence the rate B^2 . Second, the stops enter in the loops of the one-loop radiative neutralino decay width (since the Yukawa coupling of H^{*}_b to t is signi cant), and also tend to slightly decrease the radiative neutralino branching ratio for lighter m $t_{1,2}$ [11]. W ith m $q = m_{t_2} = 250 \text{ GeV}$, we found no e_R models satisfying the A = 5 fb cut, and e_L or $e_L + e_R$ models always have $B^2 < 8 \text{ fb}$.

The e ect of di erent neutral CP-odd Higgs m asses m_A is primarily conned to the neutralino branching ratios, although H does enter the one-loop radiative neutralino decay width. We nd that varying m_A from 50 to 400 GeV does not significantly change the size of the radiative neutralino branching ratio, hence the B^2 for the ee + E_T event.

4.3 Neutralino com position and branching ratios




Figure 9: The allowed range of all four neutralinos' composition hN $j \sim i^2$ in terms of the interaction eigenstates ~ = ~; Z; H_a ; H_b is shown for all of the models. The thick solid outline corresponds to e_R models only. Bars that touch the x-axis correspond to a neutralino com – ponent that can be lower than 10⁻²; the absence of a bar for the ~ component of N₃ in plies hN₃ $j \sim \hat{f} < 10^{-2}$ for all models.

In Fig. 9 we show the (maximum) allowed range of the neutralino composition $hN_i j \sim i^2$ of all of the models in the $\sim = \sim; \mathcal{I}; H_a; H_b$ basis. For a given threshold in B^2 applied to all

m odels, the m inimum radiative neutralino branching ratio is always larger for e_R than for e_L m odels. A larger m inimum radiative neutralino branching ratio in plies the constraints on the neutralino composition must be similarly stronger, hence the di ering notation for all m odels and e_R m odels in the plot. W e m ake three observations: First, we not that

so the lightest two neutralinos are composed of exactly the content expected from Eq. (11). To a lesser extent,

the heavier two neutralinos turn out have a fairly speci c composition as well. This will be relevant to the branching ratios and cross sections for associated phenom enology. Second, N_1 tends to have a much larger Z component than N_2 . Third, the required purity of the lightest neutralinos in e_R m odels is signi cant compared with e_L m odels, and this is perhaps most easily observed by looking at for example the photino content of N_1 and N_2 in Fig. 9.

In the following discussion of the branching ratios (and the discussion in subsequent sections), we discuss only the distinctions between e_L and e_R m odels, since the branching ratios in $e_L + e_R$ models are a relatively simple extension of e_L and e_R separately. The range of branching ratios of N₂ are shown in Table 5. In the pure state lim it N₂ = \sim , only the radiative channel is open for N_2 . However, the impurity of N_2 (see Fig. 9) causes other modes to have non-negligible branching fractions (N_2) is somewhat of a special case since the radiative decay branching ratio is required to be large). The possible decays for \mathbb{N}_2 in our models are: \mathbb{N}_1 , $\mathbb{N}_1 \setminus \mathbb{Z}$, $\mathbb{C}_1 \setminus \mathbb{W}$, \sim , \mathbb{L}_1 , \mathbb{L}_1 . We use $\setminus \mathbb{Z}$ and $\setminus \mathbb{W}$ to mean the 3-body decay mediated by an on-or o -shell Z and W , plus o -shell sleptons and squarks. The rate for the nal states $Z "! l' l; \overline{qq}$ and $W "! l; \overline{qq}$ are determ ined roughly by the corresponding SM gauge boson branching ratios. The only signi cant deviation from the SM gauge boson branching fractions is modes that involve sleptons, since the $ee + E_T$ event requires at least one slepton is light. The presence of som e m odes depends on the particular class of m odels; for example in e_L models, the mode N_2 ! If l is open if $m_{T_n} < m_{N_2}$. This never happens in e_R models since e_R ! N_2e is required to obtain the ee + E_T event! The 2-body mode N_2 ! ~ is open if m $_{\sim}$ < m $_{\rm N'_2}$, which happens in $e_{\!R}$ m odels and could potentially happen in $e_{\!L}$ m odels. However, for e_L models one never nds decays N_2 ! ~ because the mass splitting between ~ and 1/2 is never m ore than about 25 G eV (see Table 4). Since there always m ust be a large m ass dierence between m e_{L} and m $_{M_{2}}$ from $ee + E_{T}$ event kinem atics, then the 2-body m ode into a sneutrino is always closed.

The N_3 and N_4 branching ratio pattern is progressively more complicated than for the lighter neutralino due to possible 2-body decays into sleptons and H iggs bosons. For N_3 , there are several distinct classes of nal states: $N_{1,2} \setminus Z$ ", $C_1 \setminus W$ ", $N_1 h (A)$, $f_L l$, $f_R l$, \sim ; all other possible channels are strongly suppressed or forbidden. For example, for the heavier chargino one has $m_{C_2} > m_{N_3}$ in all of our models, hence N_3 decay into C_2 is forbidden.

The upper limits on the mass di erences m $_{N_3}$ m $_{N_1}$ < 60 G eV and m $_{N_3}$ m $_{C_1}$ < 35 G eV in our models are crucial to determ ining the allowed decays of N_3 . In particular, the decay $N_3 ! N_1 h \text{ or } N_3 ! N_1 A \text{ will only occur when } m_h \text{ or } m_A < 60 \text{ GeV}$, with constraints from LEP that exclude $m_h < 44$ GeV and the coupling $\sin^2($) $< \frac{m_h}{60}$ GeV. The restriction on the mass of A from LEP that excludes $m_A < 22 \text{ GeV}$ is considerably weaker than the one on m_h , and so decays $N_3! N_1A$ are always possible with an appropriate choice of m_A (provided this does not in ply an excluded m_h value). The situation is actually considerably m ore subtle. We nd decays into $N_1 \setminus Z$ " are not suppressed even if decays into the light H iggs h are open, with a maximum $B(N_3! N_1h)$ 35% while N_3 ! N_1A decay is closed. However, with low tan the mass splitting between m $_{\rm A}$ and m $_{\rm h}$ tends to be sm all for m $_{\rm A}$ 50 G eV, and because of the couplings, decays into A typically dom in the over h if kinem at ically accessible. In e_L (e_R) models, the decay $N_3 ! I_1 (N_3 ! I_R)$ is always kinematically forbidden. Thus, it is only when the other slepton (f_R in e_L models, f_L in e_R models) has a mass $m_{\gamma} < m_{N_{\gamma}}$ that 2-body decays into sleptons can dom inate. When kinem atically accessible, the branching ratio for the 2-body decay N_3 ! ~ can be 100%, and is always larger than decays into f_1 by a factor of at least 10. This is due to the larger Z in purity in N_3 , i.e. $hN_3 T i^2$ $hN_{3} \neq \dot{f}$, and Eq. (6) requiring m $_{\sim}$ < m $_{\rm L}$. The 3-body decays into the lightest chargino N $_3$! C $_1\backslash W$ " depend on the chargino mixings, but are always smaller than the 3-body decays N_3 ! N_1\Z " mainly due to phase space. The presence of decays into $C_1 \setminus W$ " can suppress the branching ratio for decays into $N_1 \setminus Z$ " by at m ost a factor of 2, but even then the branching ratios for N_3 are still larger into $N_1 \setminus Z$ ". A lso, N_3 decays into N_2 are strongly suppressed, because of the particular neutralino com position in our models.

The branching ratios of N₄ are quite intricate, however a few features can be discerned. The main possible decays include: N_{1/2/3}\Z", C_{1/2}\W", N₁h (A), and possibly open 2-body modes $\frac{1}{L}$ l, $\frac{1}{R}$ l, ~ . Since the mass di erence m_{N4} m_{N1} > 67 GeV and can be as large as 100 (120) GeV in e_R (e_L) models, then the decay N₄ ! N₁h is a prominent possibility if kinem atically allowed. We nd that even if N₄ ! N₁A is also open, it is always suppressed to of order 5% compared with a much largerN₁h mode. This is because the N₄ composition is roughly inverted with respect to the N₃ one, which feeds into the N₄ couplings to the H iggs sector. In e_R models, the 2-body slepton decay N₄ ! I_R l is always open, and can be 100%. In e_L models, the decay N₄ ! ~ is typically open, but sometimes can be kinem atically inaccessible. Note that if both N₄ ! ~ and N₄ ! I_L l are accessible, then N₄ ! ~ always overwhelm s N₄ ! I_L l by at least a factor of 5 due to the large Z component of N₄ (see Fig. 9) and phase space. Similarly, if none of the 2-body modes are open, then the neutralino composition of N₄ in plies N₁\Z" dom inates over all other 3-body decays.

4.4 Chargino composition and branching ratios

The chargino composition is determined by the mixing matrices U and V, as de ned in




Figure 10: Scatter plot of the chargino mixing matrix elements U_{11} , V_{11} for all models. The narrow band of points indicates the presence of strong constraints in our models from the $ee + \not{\mathbb{F}}_T$ event.

Sec. 3.1. U and V (real and orthogonal in our conventions) can be expressed in terms of two independent rotation angles (see e.g. Ref. [14]), however the D irac nature of the chargino spinors does not allow an intuitive identication of their W ino and H iggsino components. Nevertheless, in Fig. 10 we present the elements $\mathbf{j}'_{11}\mathbf{j}' = \cos^2 + vs$. $\mathbf{j}'_{11}\mathbf{j}' = \cos^2$ to give a sense of the constraints that the ee $+ \mathbf{k}_T$ event in poses on the chargino composition. In the limit tan ! 1, the chargino m assmatrix is symmetric which in plies = +, and so U = V. In Fig. 10, this is the diagonal line where $\mathbf{j}'_{11}\mathbf{j}' = \mathbf{j}'_{11}\mathbf{j}'$, and note that along this line our models lie in the region 0:15 $< \mathbf{j}'_{11}\mathbf{j}' < 0.25$, due to the mass hierarchy M $_2 > \mathbf{j}$ \mathbf{j} . Here, one can identify C_1 as mostly a charged H iggsino. For larger tan values, $\mathbf{j}'_{11}\mathbf{j}'$ tends to increase, while $\mathbf{j}'_{11}\mathbf{j}' < 0.25$ throughout our models.

The branching ratios of \mathbb{C}_1 are displayed in Table 7, that assumes $\mathfrak{m}_{\mathfrak{t}_1}$ is heavier than both charginos as in the discussion below. There are only a few possible channels: $\mathbb{N}_{1,2} \setminus \mathbb{W}$ ", \mathfrak{t}_{-} , ~l. Further, the 3-body decays into $\mathbb{N}_2 \setminus \mathbb{W}$ " are always ≤ 5 % due to the photino nature of \mathbb{N}_2 , the H iggsino nature of \mathbb{C}_1 and phase space. Thus, the 3-body decays into $\mathbb{N}_1 \setminus \mathbb{W}$ " are the typical decay pattern. In \mathfrak{e}_L m odels \mathfrak{t}_L , ~ are always heavier than \mathbb{C}_1 , thus it is only in \mathfrak{e}_R m odels that 2-body channels into \mathfrak{t}_L and ~l can possibly be open. When both are allowed, these 2-body decays can sum to a branching ratio of 100% (when sum med over three families).

The branching ratios of C_2 are displayed in Table 8. The possible decays include: $N_{1;2;3} \setminus W$ ", $C_1 f f (f = 1, , q)$, f_L , ~1, and the Higgs channels $N_{1;2}H$, $C_1 h$ (A). When only 3-body de-

cays are open, $N_1 \setminus W$ " dom inates over all other decays. However, $N_2 l_1$ is roughly 1{5%, and can be larger than the decays into $N_2 q \overline{q}^0$ due to the possible enhancement from light slepton exchange in the 3-body decay. The 2-body decay C_2 ! ~l sum med over three families can have a branching ratio up to 95%, when it is the only slepton mode open (the remainder is distributed to the 3-body decays as above). When both C_2 ! ~land C_2 ! I_L are simultaneously open, the sum can be nearly 100%. Finally, the 2-body decay into N_1H is also possible when $m_H \leq 90$ (120) G eV, for e_R (e_L) models, which requires $m_A \leq 50$ (100) G eV. In addition, decays into neutral Higgs bosons are possible when $m_{C_2} = m_{C_1} < m_{h/A}$.

4.5 Sneutrino branching ratios

In the selectron interpretation, sneutrinos do not directly enter the branching ratios relevant for the ee $+ E_T$ event, how ever the mass of the sneutrino \sim_e is necessarily smaller than m_{e_L} due to the sum rule in Eq. (6), and so the sneutrino is certainly relevant in e_L and $e_L + e_R$ models. In Ref. [1] it was shown that the cross section for sneutrino production $p\overline{p}$! $\sim_e \sim_e$ is com parable to $e_L e_L$ production, and $e_L \sim_e$ production is larger by a factor of 2{3 for a xed value of m_{e_L} . Thus, the viability of the $e_L + E_T$ event as e_L production (and the ability to distinguish e_L from e_R) depends in part on the phenom enology associated with sneutrinos.

The dom inant branching fraction of sneutrinos depends on the size of the Z component of the neutralinos and the gaugino m ixings of the chargino, in addition to the mass hierarchy. There are 4 3 kinematic possibilities, where m_{\sim} is lighter or heavier than $m_{\tilde{N}_{2,3,4}}$ and $m_{\tilde{C}_{1,2}}$. In the limit of pure neutralino states $\tilde{N}_1 = \tilde{H}_b$ and $\tilde{N}_2 = \sim$, the sneutrino has no coupling to the lightest two neutralinos since it does not couple to either pure state. Thus, in the case where $m_{\sim} < m_{\tilde{C}_{1,2}}$, the dom inant decay of \sim will be to the kinematically accessible neutralino with the largest \tilde{Z} component. The relative branching fraction into \tilde{N}_1 or \tilde{N}_2 is therefore determ ined by the size of their Z component in purity. The branching ratios are shown in Table 9.

For e_L models, $m_{\sim} > m_{C_1}$, so that decays into the lightest chargino are always possible. The branching ratio for ~ ! C_1 l is always larger than 53%, while the branching ratio for the ~ ! C_2 l channel (if open) can reach 26%. The next largest channel is ~ ! N_1 , with a branching ratio up to 36%. The decay ~ ! N_2 is always open, but with a branching ratio below 6% due to the small Z component in N_2 .

For $\mathbf{e}_{\mathbf{R}}$ models m ~ is unconstrained, so the decay ~ ! N₁ is the only mode that is always open. If decays into N₂ are also allowed, then the dom inant decay of ~ can be into either N₁ or N₂ . In special cases, we found it is possible for the Z in purity to be larger in N₂ than N₁, thus the dom inant decay could be ~ ! N₂ . This is possible when m_{N₂} < m ~ < m_{C1}, i.e. decays into charginos must be kinem atically forbidden (an impossible scenario in $\mathbf{e}_{\mathbf{L}}$ models). When a channel into a chargino is su ciently open, it dom inates over decays into the lightest two neutralinos by a factor of m ore than 10. However, if the sneutrino is heavy m ~ > m_{N_{3,4}, decays into the heavier neutralinos can be moderately large (branching ratio 10{30%}), with decays ~ ! N₄ dom inating over ~ ! N₃ due to the larger Z component in N₄.}

4.6 Selectron branching ratios

We have already discussed \mathbf{e}_{L} branching ratios for \mathbf{e}_{L} models, and \mathbf{e}_{R} branching ratios for \mathbf{e}_{R} models in Sec. 3.3, since they are a fundamental part of the model building. The other skepton (\mathbf{e}_{R} in \mathbf{e}_{L} models, and \mathbf{e}_{L} in \mathbf{e}_{R} models), will have branching ratios similar to \mathbf{e}_{L} (in \mathbf{e}_{L} models), or \mathbf{e}_{R} (in \mathbf{e}_{R} models) if its mass is roughly included in the \mathbf{e}_{R} + \mathbf{E}_{T} allowed range. In general, \mathbf{e}_{R} , \mathbf{e}_{L} will decay into the kinematically allowed nal states with neutralinos, with the largest branching ratio for the channel N₂e, if open. \mathbf{e}_{L} can also decay into $C_{1;2}$ e if open, with a maximum branching ratio of 27% and 59% respectively.

4.7 Predictions for LEP

The imm inent upgrade of LEP to p = 161 GeV (LEP161) and the forthcom ing upgrade to $p_{s} = 190 \text{ GeV}$ (LEP190) provide a potential testing ground for the models constructed. W ith expected integrated lum inosities of 25 pb 1 and 500 pb 1 (per detector), the one event level is at 40 fb and 2 fb for $\bar{s} = 161, 190$ GeV respectively. The rst priority is to identify which processes have non-negligible production cross sections, then determ ine the possible signatures that depend on the branching ratios of the produced sparticles. It is important to emphasize that the following predictions assume the minimum cut A = 5 fo is placed on the B^2 + E_T event. For instance, in some cases we are able to predict a non-negligible for the ee m in im um num ber of events with a particular signature must be produced, although we do not necessarily give detector e ciencies. In principle, if one could dem onstrate that failure to detect such events in plies they do not occur at all, then only two possibilities remain: (1) A supersymmetric explanation of the ee $+ E_T$ event in our framework must rely on an upward B^2 even lower than 5 fb, or (2) a supersymmetric explanation in our uctuation from fram ework is not possible.

B ased on O bservation 4 in Sec.2, selectron production is always kinem atically forbidden at LEP 161 and LEP 190 for the selectron that satis as the kinem atics. The other slepton (e_R in e_L models, or e_L in e_R models) can potentially be kinem atically accessible at LEP 161 or LEP 190 by simply requiring its mass be less than the threshold. This is obviously not a requirement (nor a constraint) of the selectron interpretation of the $e_R + E_T$ event, and so we ignore selectron production at LEP. However, in e_L models it was shown in Eq. (6) that m \sim must be less than m e_L , and so sneutrino production could be a visible signal at LEP 190 (since m $\sim_e > 81$ G eV for all e_L models), as will be discussed below.

4.7.1 LEP161




Figure 11: The range of the non-negligible cross sections at LEP161, for all models (shaded bar on left) and only e_R models (thick solid line on right). Each bar represents a particular production cross section, where the maximum and minimum height of the bar (or thick solid line) is the maximum and minimum cross section respectively. The shading on the left bars indicates the range of cross section for all models passing the cut A = 5,75,10 fb. Bars that touch the x-axis correspond to cross sections that can be smaller than 1 fb.

In Fig. 11 we present all of the chargino/neutralino production processes that have cross sections above about 10 fb. The cross sections were computed with initial state radiation e ects included. In e_L or $e_L + e_R$ models, none of the processes need to have large cross sections, although if it were possible to establish an upper bound on $(N_1 N_3) \leq 600$ fb, then an upper bound on B^2 for the $ee + E_T$ event can be established at 7.5 fb, and in e_R models

 $B^2 < 5$ fb (i.e. all of our e_R m odels would be excluded). Given the cut A = 5 fb, then in e_R m odels one expects a m in im um of 22 N_1N_3 pairs to be produced, but no other process (nor any processes in e_L or $e_L + e_R$ m odels) can have non-negligible m in im um rates at LEP161. There are only four processes that could have large rates, which have the following m axim um

for $(\mathbf{e}_{\mathrm{L}}, \mathbf{e}_{\mathrm{R}}, \mathbf{e}_{\mathrm{L}} + \mathbf{e}_{\mathrm{R}})$ m odels. Notice that the maximum pair production rates are always largest for \mathbf{e}_{R} models, then \mathbf{e}_{L} m odels, then $\mathbf{e}_{\mathrm{L}} + \mathbf{e}_{\mathrm{R}}$ models. The rate for N₁N₃ is roughly the same in all models since the cross section is dominated by Z exchange. For the other processes, di ering interference contributions between the Z exchange and light slepton exchange cause the di erences in the production cross sections (see Table 2). In addition, stop pairs could be produced at LEP161 (see Table 11).

The character of the signal from N_1N_3 production is completely dependent on the decay of N_3 which was described in Sec. 4.3 (see also Table 6). The dom inant decay possibilities are $N_3 ! N_1 \setminus Z ", N_3 ! N_1 \wedge (h)$ (if $m_A (m_h) < 60 \text{ GeV}$), $N_3 ! T_R \lim e_L \mod dels$ (if $m_{T_R} < m_{N_3}$), and $N_3 ! \sim \inf e_R \mod dels$ (if $m_{\sim} < m_{N_3}$). The general signature is therefore $\setminus Z " + E'$. Extra $b\bar{b} + E'$ occurs if the mass di erence $m_{N_3} m_{N_1}$ is larger than $m_h \operatorname{orm}_A$. Some other signatures are possible in special cases: In e_L models one could have excess $l^+ l + E'$ (if $m_{T_R} < m_{N_2}$), or l l + E' (if $m_{T_R} < m_{N_3}$). In e_R models the decay $N_3 ! \sim becomes the dom inant decay if the sneutrino (and necessarily <math>T_L$) are light. Thus the dom inant signature could be invisible, or + E', or l l + E', if the mass hierarchy is $m_{\sim} < (m_{N_2}; m_{C_1})$, or $m_{N_2} < m_{\sim} < m_{C_1}$, or $m_{C} < m_{\sim}$ respectively. However, in these cases the cross section for $T_L \sim$ at the Tevatron would be quite large (see below).

The dom inant signal of $\mathbb{N}_2\mathbb{N}_2$ production is $+\mathbb{E}$ in all models. Note that the process $(\mathbb{N}_2\mathbb{N}_2)$ is always accompanied by $(\mathbb{N}_2\mathbb{N}_3)$ at a comparable rate (when kinem atically allowed), which has the same signatures as $\mathbb{N}_1\mathbb{N}_3$ production (as above) plus one photon.

 $C_1^+C_1$ production can be present with a large rate, the decay signature of C_1 being the usual W "+ E' in all models (see Table 7). The exception is if m_~ (and possibly m_{I_L}) is lighter than m_{C₁}, which can happen only in e_R models. In this special e_R model scenario, if

As an aside, we nd that a maximum of (14, 13, 12) N_1N_1 pairs can be produced, which can be observed as a + E signal once visible initial state radiation is attached. A lthough the SM background is severe, there are other possibly in portant contributions from e.g. N_1N_3 (! N_1).




Figure 12: Range of inclusive cross sections for selected signatures at LEP 161 w thout detection e ciencies; all signatures necessarily have m issing energy in addition to that above. The shaded bar on the left corresponds to e_L models and the thick solid outline on the right corresponds to e_R models. Here, X = leptons, photons, jets, or nothing, and $l = e_r$, or sum m ed over both charges and all three fam ilies. See the text for details.

In Fig. 12 we present the ranges of the inclusive production of particular signals at LEP 161 for e_L and e_R models. These signatures were generated by searching all possible decay paths. No e ciencies resulting from detector geometry or lepton/photon energy cuts are included. If the signals are the result of decays with moderate mass splittings, then presumably some of the events could be detected after applying reasonable cuts. A lepton l can be either e, or , with either charge 1. In particular, when referring to a \21" signal, we sum over all family and charge possibilities (including, e.g., like-sign dileptons). X can be any combination of leptons, photons, jets, or nothing. In addition, all the signals im plicitly include missing energy in their signature. We only include chargino/neutralino production processes in the inclusive sum, since e_L in e_R models and e_R in e_R models is too heavy to be produced. If the other slepton (e_R in e_L models, e_L in e_R models) is light, then the maximum cross section for particular signatures can be higher.

Jet production is also an important signal. If N_1N_3 production is kinematically allowed and if only 3-body decays of N_3 occur, then the rate into the jj + X + E' signal is between roughly 400{1800 fb for both e_L and e_R models. If chargino production is open then the rate can be larger. But, if 2-body decays into sleptons are open for N_3 , then the rate can be near zero.

Notice that in e_R models only the 21+ X (+ E) must be produced, the rate being between 2 to 20 events in 25 pb¹ of integrated luminosity. The reason that the 21 rate always has a non-negligible minimum is due to a combination of e ects: e_R models have a minimum $(N_1N_3) > 850$ fb, and decays of $N_3 ! N_1I^+1$ are always non-zero, even if 2-body decays operate. If only 3-body decays occur, then $N_3 ! N_1 \setminus Z$ "(! I^+1) occur, with a rate of nearly 10% (summed over families). A iternatively, if $N_3 ! \sim is$ open, then $\sim ! C$ (! 1) is the decay pattern. If $m_{\sim} < m_C$, then it turns out that $m_{I_L} < m_{N_3}$, and so decays $N_3 ! I_{L}^{*}$ (! $N_{1;2}$) are non-zero, giving an appreciable 21 signal. A ll of the other inclusive signals could have rates smaller than the one event level. If one of these signatures were found (and deduced to be above background), then looking in the other channels might serve to con m the signal.




Figure 13: C om parison of the missing invariant mass distribution in the + E signal at LEP161 from two di erent selectron interpretation models, (a) a sample $N_1 = LSP$ model with m $_{N_{1,2}} = 37;65$ GeV (dashed line), and (b) a model with a gravitino LSP and m $_{N_1} = 65$ GeV (solid line).

model background for $+ \mathbf{E}$ is distinguishable from the gravitino signal $e^{\dagger} e + \mathbf{N}_1 \mathbf{N}_1$

GG using the m issing invariant m ass distribution [4]. Here, we point out that a selectron interpretation with a neutralino LSP can be distinguished from one with a gravitino LSP using the m issing invariant m ass distribution, assuming the SM background is small (see Ref. [4] for a discussion of the background). In Fig. 13 we show the missing invariant m ass distribution $M_{inv}^2 = (p_{e^+} + p_e - p_1 - p_2)^2$ at LEP161 for two di erent models: (a) The e_L sam ple model in Appendix B with $m_{N_{1,2}} = 37;65 \text{ GeV}$, and as usual N_1 ' H_b , N_2 ' ~. (b) A model with a (very light) gravitino LSP with $m_{N_1} = 65 \text{ GeV}$, and N_1 ' ~. The di erence in the missing invariant m ass distribution for the gravitino LSP model in Fig. 13 is not particularly sensitive to m_{N_1} , but simply that m_G is very sm all compared to the neutralino or selectron m asses.

4.7.2 LEP190




Figure 14: As in Fig. 11, for LEP 190.

In Fig. 14, we present all the chargino/neutralino production processes with cross sections

possibly larger than about 1 fb for LEP with ${}^{p}\overline{s} = 190 \text{ GeV}$. A s above, the cross sections were computed with initial state radiation e ects included. Now, $N_{1}N_{3}$ production must be large in all models, and m any other processes can easily give large rates. The processes with large rates include all of the ones at LEP161, and also $N_{1}N_{2}$, $N_{1}N_{4}$, $N_{2}N_{4}$, $C_{1}C_{2}$. for $(\mathbf{e}_{\mathrm{L}}, \mathbf{e}_{\mathrm{R}}, \mathbf{e}_{\mathrm{L}} + \mathbf{e}_{\mathrm{R}})$ models. For N_1N_3 production, the minimum number of pairs produced is (400, 475, 320) for $(\mathbf{e}_{\mathrm{L}}, \mathbf{e}_{\mathrm{R}}, \mathbf{e}_{\mathrm{L}} + \mathbf{e}_{\mathrm{R}})$ models given the minimum threshold A = 5 fb. For \mathbf{e}_{R} models only, a minimum of $5 N_1N_4$ pairs, $25 N_2N_2$ pairs, $40 N_2N_3$ pairs, and $250 C_1^+ C_1^-$ pairs must be produced given the minimum threshold A = 5 fb. As for N_1N_1 pair production we found a maximum of (177, 164, 152) pairs can be produced.

In addition, sneutrino pair production (if open) is another process that is relevant for e_L models. To have $\sim_e \sim_e$ production kinematically accessible with $m_{\sim_e} < 95$ GeV, then the sum rule in Eq. (6) implies tan > 12 is required for $m_{e_L} > 100$ GeV (as needed by the kinematics of the ee $+ \not{e}_T$ event), and for $m_{e_L} = 107$ (118) GeV, then tan > 1.5 (2.8). Hence sneutrino production in e_L models never occurs at LEP190 if $m_{e_L} > 118$ GeV. The signature of $\sim_e \sim_e$ production depends on the sneutrino branching ratio, but it was already established in Sec. 4.5 that $\sim_e ! eC_1(! N_1 \setminus W ")$ is the dominant decay pattern. Thus the signature is ee\W "\W "+ \not{e} , which is indeed quite prominent.




Figure 15: Range of inclusive cross sections for selected signatures without detection e ciencies, as in Fig. 12, but for LEP 190.

In Fig. 15 we present the ranges of the inclusive production of particular signals at LEP 190 for $e_{\rm L}$ and $e_{\rm R}$ models. As in Fig. 12, no detection e ciencies are included. Notice that while only

4.8 P redictions for Tevatron

The assumption underlying the selectron interpretation is that the Tevatron has already observed a candidate selectron pair production event. Because m any m ore states of the underlying supersymmetric model are accessible at a hadron collider, we here focus on the associated signals that should be observed in the present data set (100 pb⁻¹ per detector) or in the next scheduled upgrade (1{2 fb⁻¹ per detector). As in Sec. 4.7, we identify the processes that have non-negligible production cross sections, then determ ine the possible signatures that depend on the branching ratios. Again, it is important to emphasize that the follow ing predictions assume the minimum cut A = 5 fb is placed on the B² for the ee + E_T event.




Figure 16: As in Fig. 11, for Tevatron $P_{\rm s} = 1.8$ TeV with all $C_{\rm i}$ $C_{\rm j}$, $N_{\rm i}N_{\rm j}$, $C_{\rm i}$ $N_{\rm j}$ processes shown that can have cross sections larger than about 50 fb.

In Fig. 16 we present all of the chargino/neutralino production processes that can have cross

sections above about 50 fb. W e use leading order CTEQ 3L [25] structure functions evaluated at $Q^2 =$ \$. At the Tevatron the cross sections do have a contribution from t-channel squark exchange (see Table 2), but the dependence on the squark mass is usually weak for the squark m asses in ourm odels. If only $\mathbf{e}_{\!R}$ is light, then these are the only necessary associated processes event. If $e_{\rm L}$ is light, however, then there must also be $e_{\rm L} \sim_{\rm e}$ and $\sim_{\rm e} \sim_{\rm e}$ production. to the ee In Ref. [1] we found $(\sim_e \sim_e)$ $(\mathbf{e}_{\mathrm{L}} \mathbf{e}_{\mathrm{L}})$ and $(\mathbf{e}_{\mathrm{L}} \sim_{\mathrm{e}})$ (2 ! 3) ($e_{e_{L}}$) for the same $m_{e_{r}}$, i.e. the cross sections are typically tens of fb. It is also possible that both e_L and e_R can be light; in particular, the other slepton (e_R in e_L models, e_L in e_R models) can be lighter than the one + $E_{\rm T}$ event, which can dram atically a ect the signatures. The pair production giving the ee processes that have the largest cross sections and also have a non-negligible minimum cross section are given in Table 10, where the full range from the minimum to the maximum number of pairs produced for an integrated lum inosity of 100 pb 1 are shown.

The signatures for $\mathbb{N}_1\mathbb{N}_3$ and $\mathbb{C}_1^+\mathbb{C}_1^-$ are the same as for LEP (described in Sec. 4.7.1) and the decays of \mathbb{C}_2^- were also discussed in Sec. 4.7.2. For completeness we list the possible signatures of all of these processes here: $\mathbb{N}_1\mathbb{N}_3^-$ will mainly give $\mathbb{V}_2^- + \mathbb{E}_T^-$, or $\mathbb{b}_1^- + \mathbb{E}_T^-$ if $\mathbb{m}_A^- < 60 \text{ GeV}$. If 2-body slepton decays are allowed, then in \mathbb{e}_L^- models one can have $\mathbb{I}^+ \mathbb{1} + \mathbb{E}_T^-$, or in \mathbb{e}_R^- models one of invisible, \mathbb{E}_T^- , or $\mathbb{I}^+ \mathbb{1} + \mathbb{E}_T^-$. $\mathbb{C}_1^+\mathbb{C}_1^-$ production gives typically $\mathbb{I}^+ \mathbb{1} + \mathbb{E}_T^-$, or if 2-body decays into $\mathbb{I}_+^- \sim \text{occur}$ (in \mathbb{e}_R^- models only), then depending on the mass hierarchy one can have \mathbb{E}_T^- , or $\mathbb{I}^+ \mathbb{1} + \mathbb{E}_T^-$, $\mathbb{C}_2^+\mathbb{C}_2^-$ production gives similar signatures as $\mathbb{C}_1^+\mathbb{C}_1^-$ production, given $\mathbb{m}_{\mathbb{C}_1}^- \mathbb{1}^- \mathbb{m}_{\mathbb{C}_2}^-$ and allowing for the possibility of 2-body decays in

the context of both e_L and e_R m odels as above.

In F ig. 17 we present the cross section for m any prom ising signatures at the Tevatron. As in F igs. 12 and 15, no detection e ciencies have been included. We include chargino/neutralino processes in the sum, as well as $e_R e_R$ production in e_R m odels, and $e_L e_L$, $\sim_e \sim_e$, $e_L \sim_e$ production in e_L m odels. We see that all six inclusive signatures involving leptons or photons are expected to have minimum rates of roughly 2 to 30 events, regardless of the type of m odel (e_L or e_R). The

+ X, l + X and l + X signatures can be much larger in \mathfrak{g} models, but this only happens in the particular kinem atic scenario with $m_{\mathfrak{N}_2} < m_{\mathfrak{L}}$; $\mathfrak{m}_{\sim} < \mathfrak{m}_{\mathfrak{C}_1}$ (< $\mathfrak{m}_{\mathfrak{S}_R}$). In this case, charginos always decay through the 2-body channels \mathfrak{C} ! \mathfrak{I}_L and \mathfrak{C} ! $\sim l$, with \mathfrak{I}_L ; \sim ! \mathfrak{N}_2 (! \mathfrak{N}_1). Thus, processes with intrinsically large cross sections such as $\mathfrak{C}_1\mathfrak{N}_1$ production can lead to a

large $1 + \mathbb{E}_T$ signal, and similarly for other processes involving charginos.

M any of these signatures should be detectable, since the m ass di erences between superpartners is often constrained to be sm allbut non-zero, as in Fig. 8. For example, in decays such as N_3 ! $N_1 \setminus Z$ and $C_{1,2}$! $N_1 \setminus W$ ", the invariant m ass of the virtual $\setminus Z$ " or $\setminus W$ " can be large. In particular, the invariant m ass of the $\setminus Z$ " from N_3 decay is between 0 to 40{60 GeV, thus an excess in pairs of leptons (or jets) that reconstruct to an invariant m ass m $_{1^+1}$ < 60 G eV accompanied by a large m issing energy is a distinctive signature of $N_1 N_3$ production in our m odels.

In addition to classifying the most promising signatures, we have also performed a number of event level simulations for a limited subset of our \mathbf{e}_{L} and \mathbf{e}_{R} models, with the other slepton heavy. The purpose is to get a feeling for the e ciency of detecting multillepton and/or photon signatures. First, we address the issue of e ciencies for the $\mathbf{e}_{\mathrm{R}} + \mathbf{E}_{\mathrm{T}}$ event, since this is in portant for interpreting the threshold A in the ee rate. An e ciency represents the probability that a certain class of events passes a particular set of cuts de ned before the data is analyzed. We chose a set of cuts such that: (1) the event would be triggered on and analyzed, and (2) the event would not su er from obvious detector backgrounds like jets faking leptons or photons. To show the dependence of our e ciencies on the particular set of cuts, we choose a loose set with $\mathbf{j}^{\,e}\mathbf{j} < 2$, $\mathbf{j}^{\,}\mathbf{j} < 1$, $(\mathbf{p}_{\mathrm{T}}^{(e;\,)}; \mathbf{E}_{\mathrm{T}}) > \mathrm{E}_{\mathrm{T}}^{\,\mathrm{min}} = 10 \mathrm{GeV}$ and a tight set identical to the loose set except $\mathrm{E}_{\mathrm{T}}^{\,\mathrm{min}} = 20 \mathrm{GeV}$. The e ciencies we found range from $0.02\{0.23$ for the loose cuts, and from $0.01\{0.12$ for the tight cuts, but e ciencies outside these ranges (from m odels not covered in the subset) are possible. If $\mathrm{E}_{\mathrm{T}}^{\,\mathrm{min}}$ is increased to 25 GeV, the mean e ciency is 0.04. The loose cuts are su cient for CDF to have triggered on the event.

We have also studied 1, 11, and 11 signatures using a similar set of cuts ($\mathbb{H}_T > 20 \text{ GeV}$ and $p_T^{(l;)} > E_T^{min}$), where for the purposes of detection 1 is sum med over e and only. Typically, when $E_T^{min} = 10 \text{ GeV}$ one expects between 1{5 (2{12)} 1 + \mathbb{H}_T events in 100 pb⁻¹ for \mathbf{e}_R models (\mathbf{e}_L models) from chargino/neutralino production alone. An additional 1{2 events are expected from $\mathbf{e}_L \sim_{\mathbf{e}}$ production in \mathbf{e}_L models. This result is essentially unchanged for the simulation subset of models if $E_T^{min} = 20 \text{ GeV}$. This is expected at least for the photons since the kinematics enforce hard photons in the nal state from slepton decay. The SM background from W production yields 105 and 37 events for each set of cuts respectively. W ith tighter cuts, it is possible to achieve a signal to background ratio near one for some models. The expected 11




Figure 17: Range of inclusive cross sections for selected signatures without detection e ciencies, as in Fig. 12, but for Tevatron.

signature, resulting mainly from C_iC_j production, is between 0{6 events for $E_T^{m\,in} = 10 \text{ GeV}$, and 0{2 for $E_T^{m\,in} = 20 \text{ GeV}$. Similarly, the expected ll signature is between 0{5 events for $E_T^{m\,in} = 10 \text{ GeV}$, and 0{2 events for $E_T^{m\,in} = 20 \text{ GeV}$. Other signatures, such as , 1 and 31, produce at most 1 or 2 events for $E_T^{m\,in} = 10 \text{ or } 20 \text{ GeV}$. Therefore, it would appear that the 1 channel is the most promising for con m ing the supersymmetric interpretation of the event (assuming $m_{t_1} > m_C$), though other signals with limited backgrounds are clearly possible.

4.9 A lternative interpretation

5 Comments on models with a light stop

We have seen that the e ect of requiring a large B^2 for the $ee + E_T$ event is to strongly constrain the chargino, neutralino and slepton sections. Up to now, we have assumed the squarks are su ciently heavy so as not to directly interfere with the necessary decay chain. However, it is possible that a light stop t_1 can exist simultaneously with the needed hierarchy in the other sectors. In particular, neutralino decays N ! t_1 t are absent in our models (with the cut A = 5 fb), since all neutralinos are lighter than the top quark. Therefore, the decay chain in the selectron interpretation need not be disrupted, if the radiative neutralino decay can be large with a light stop.

The chargino interpretation described in Appendix A is a di erent matter, since charginos would always decay to the light stop \mathcal{C} ! \mathfrak{t}_1 bifkinem atically accessible. This is true regardless of the mixing angle \mathfrak{t} that determines the \mathbb{W} {t coupling, since the Yukawa coupling H {t is large. Thus, it would seem that a chargino interpretation of the ee $+ \mathfrak{E}_T$ event from $p\overline{p}$! $\mathcal{C}_i \, \mathcal{C}_j$ is not possible unless m $\mathfrak{t}_i > \mathfrak{m}_{\mathcal{C}}$. This is basically the scenario described in Appendix A.

To construct m odels with a large $e + E_T$ event rate and a light stop, one m ust consider the e ects of a sm all m_{ti} on the radiative neutralino decay width and on the m ass hierarchy. As we have remarked in Sec. 4.2, the dynamical mechanism for a large radiative neutralino branching ratio appears not to be strongly dependent on m_{ti} [11]. For instance, m odels can be constructed with m_{ti} = 50 GeV, m_{ti} > 250 GeV, and a large radiative neutralino branching ratio arising from the dynam ical mechanism. However, some suppression to the radiative neutralino branching ratio from light stops is present, so the $ee + E_T$ rate is maxim ized in the limit of all squark masses large. For example, the largest $ee + E_T$ rate in e_L and e_R models with a light stop is 13.8 fb and 6.1 fb respectively. Since m_{N1} < m_{ti} must be obeyed so that N₁ = LSP, the upper limit on m_{N1} can be more restrictive than found above if m_{ti} < 74 (50) GeV in e_L (e_R) models by O bservation 1 in Sec. 2. This induces a rough upper limit on j j which also has implications for the chargino masses.

There is an additional degree of freedom in the value of t, which determ ines the SU (2) couplings of $t_{1,2}$ with the gaugino components of charginos and neutralinos. Maintaining a hierarchy between m_{t_1} m_{t_2} (' m_{q}) would seem dicult without giving a large [27], but this can be avoided if t_1 ' t_R (or t' =2 by our de nition). However, requiring m_{t_1} ' 50 GeV, t' =2 in plies m_{t_2} must be large (perhaps of order 1 TeV or more) if the light H iggs h is to have a mass that is not excluded by LEP. In general this in plies that m_h will lie within the region accessible to LEP, though further analysis is needed to be precise; \sin^2 () can be below one, and m_h can be near its present lower lim it from LEP1. Note also t slightly a ects the radiative neutralino decay [11].

A nother constraint on m odels with a light stop com es about if $m_{t_1} + m_b < m_t$. Then top quarks must decay into stops with a branching fraction of about 1=2 if m_{t_1} 50 GeV. It was observed in R ef. [16] that a branching ratio oft ! t_1 b of 50% is not excluded by Tevatron data, if gluinos and squarks with m asses of roughly 0 (250) GeV exist, giving additional top production to supplem ent the SM contribution while half the top quarks are greater than roughly 250 GeV, then they are not crucial in m aintaining a large radiative neutralino branching fraction.

The simultaneous existence of a light right stop, a heavy left stop, other squarks (except b.) and the gluino with m asses 0 (250) G eV, and a large $ee + E_T$ rate is therefore an interesting possibility. We explicitly constructed nearly 200 m odels, mostly of the et class due to their larger cross section. We did not nd signi cant di erences in the models' distribution in M $_1$ {M $_2$ plane, nor in the {tan plane. However, regions in these planes that were populated by heavy stop m odels w ith B^2 near the A = 5 fb cut are no longer are allowed. For instance, no light stop models approached the gaugino mass unication (M $_2 = 2M_1$) line, and j jwas restricted to be less than 62 GeV. Hence, there are a number of phenom enological consequences of assuming a light stop (m $_{t_1}$ = 50 GeV). First, as noted above, the branching ratio of C_i ! t_i b is virtually 100% (when kinem atically accessible), followed by the one loop decay $t_1 ! cN_1$ if $m_{f_1} < m_{C}$. Thus all the signatures as noted in Secs. 4.7 and 4.8 arising from charginos become bc + \mathbb{E}_{T} . For example, while the dilepton signal from $\mathbb{N}_{1}\mathbb{N}_{3}$ is unchanged, the dilepton signal from $C_i C_j$ becomes $bbc\overline{c} + E_T \cdot A lso,$ the restriction $m_{N_1} < m_{t_1} (= 50 \text{ GeV})$ results in som ew hat tighter restrictions on the upper bounds of the other chargino and neutralino m asses. In particular, m $_{C_1}$ < 90 GeV and m $_{N_3}$ < 100 GeV in our light stop m odels, and the sum $(m_{N_1} + m_{N_2}) \leq 150 \text{ GeV}$. One consequence is that $N_1 N_3$ production is always kinem atically allowed at LEP161, with a cross section in the range $1:1 < (\tilde{N}_1N_3) < 2:1$ pb.

Stop production at LEP161 m ay be directly visible with the expected integrated lum inosity if $2m_{t_1}$ is below threshold [28]. In Table 11 we present the cross section for stop production at LEP161 and LEP190 for a selection of light stop masses. At LEP161 one would expect roughly 20 (5) stop pairs produced per detector, for $m_{t_1} = 50$ (70) GeV. At LEP190 one would expect roughly 380 (95) stop pairs produced per detector, for $m_{t_1} = 50$ (70) GeV. At LEP190 one would expect roughly 380 (95) stop pairs produced per detector, for $m_{t_1} = 50$ (80) GeV. All of the cross sections were calculated with approximate nal state QCD corrections and QED initial state radiation e ects included, and assuming $t_1 = t_R$. Also, $t_1 t_1$ bound state e ects can be important close to the threshold.

It has been noted [16] that when there is a light stop (so that C_i ! t_i b and t ! t_i N_i), there is a large set of events predicted at the Tevatron by supersymmetry that has no parton-level SM background. Even after all branching ratios and detection e ciencies are included, tens of events remain in the present 100 pb⁻¹ at Tevatron. These events arise from three sources, (1) C_i (! t_i b) N_2 , see Table 10; (ii) t(! W b) \overline{t} (! t_i N_2); (iii) q(! qN_2)q(! qg(! t(! W b) t_i)). In all cases, N_2 ! N_1 , t_i ! dN_1 , and typically W ! jj. After branching ratios and cuts there should be approximately 35{100 events with the signature b + E' + jets. Jets' means

1{5 parton level jets, including 1{2 charm jets (an average of 1:5/event). This prediction could lead to a sample that allowed a robust (rather than one event level) detection of superpartners in the present CDF and D0 data. W hen W ! 1 for these events, additional good signatures arise and one expects an excess of W "bc events that would appear in the top sample, and 1 + E' + jets events.

The simultaneous existence of a light stop and a light chargino (as necessarily arises in $ee + E_T \mod els$) can give rise to a shift in R_b [29]. We have analyzed models with $m_{t_1} = 50 \text{ GeV}$, $t_1 = t_R$ and nd that the maximum shift in R_b is $R_b^{max} < 0.003$ from charginostop loops only. Charged Higgs top loops can also be significant, with a shift $R_b < 0.0005$ depending on m_A . In all cases tan must be near 1 for a maximal shift in R_b is at best 0.0028, 0.0021, 0.0018 for chargino-stop loops only. Further, R_b is sensitive more to the parameter tan than m_{C_1} , as is clear since the chargino mass is inversely related to tan ; in the above three cases m_{C_1} is roughly 83, 80, 70 GeV. We note that these calculations have been done assuming $m_{t_1} = 50 \text{ GeV}$, t = = 2, which is nearly optimal since the maximum shift in R_b decreases as either the stop mass is increased, or t_c is taken far from =2.

As has been emphasized, getting a signi cant shift in R_b requires a chargino that has a large Higgsino component, and the related result that is small and negative. It is interesting that the value of and the chargino properties coming from the analysis of the $ee + E_T$ event have the properties needed to give such an e ect. Finally, we note that a shift in R_b necessarily implies a shift in $_s$ extracted from the LEP Z lineshape, through the relation $_s M_Z$) 4 B [30]. This limits the maximum shift in R_b to about 0.0025, consistent with the above numbers and giving $R_b < 0.2182$. It is worth emphasizing that a signi cant shift in R_b (and $_s$) is only possible simultaneously with a supersymmetric interpretation of the $ee + E_T$ event if N_1 is the LSP [4].

6 Concluding rem arks

We have seen that supersymmetry with $N_1 = LSP$ is a viable explanation of the CDF ee + \mathbb{B}_{T} event. The primary constraints are the kinematics of the ee + \mathbb{B}_{T} event, the radiative neutralino branching ratio N_2 ! N_1 , the selectron decay e ! eN_2 and LEP1{ LEP 130 data. Given a minimum threshold on the cross section times branching ratio of $p\overline{p}$! $e^+e^-! e^+e^-$ N'_2N'_2 ! e^+e^- N'_1N'_1 at the Tevatron, a selectron interpretation requires M_1, M₂, tan , m_e in tight ranges (see Table 4 and Figs. 7, 8). The corresponding chargino and neutralino m asses and the cross sections at LEP and Tevatron are similarity constrained. This is the origin of the predictions m ade for both LEP and Tevatron based solely on the ee + ⊉⊤ event, where m any signals can be large, and som e m ust be produced. These signals are deduced from the cross sections and branching ratios without e ciencies, although in many cases the m ass di erences between sparticles cannot be arbitrarily sm all, and so presum ably the signals are detectable. For example, N_1N_3 production must occur at LEP 190 with the mass di erence $40 < m_{N_3} = m_{N_1} < 60 \text{ GeV}$ in all models, which implies a pair of leptons or jets from the decay $N_3! N_1 \overline{f}$ would have an invariant m assup to roughly 60 GeV. The inclusive signals that must be produced at LEP 190 with an integrated lum inosity of 500 pb⁻¹ are (21+ X + $\not\!\!$) > 50 events, and $(+X + E)^{>}$ 3 events. At the Tevatron, the inclusive signals that should have been produced (with an integrated lum inosity of 100 pb⁻¹) are (21+ X + E_T) > 30 events, $(+X + E_T) > 2$ events, $(1 + X + E_T) > 15$ events, $(21 + X + E_T) > 4$ events, $(1 + X + E_T) > 2$ events, and $(31 + X + E_T) > 2$ events. All of these signals assum e X = anything (leptons, photons, jets), and are valid for e_L or e_R m odels. For e_R m odels only, the inclusive signal that must be produced at LEP161 with an integrated lum inosity of 25 pb¹ is (21 + X + E) > 2 events. A loo for e_R models only, the inclusive signals that must be produced at LEP 190 (in addition to the ones above) are (1 + X + E') > 5 events, and $(21 + X + \mathbb{R}) > 5$ events. We have exam ined m any inclusive signals with leptons and photons, but of course inclusive signals with jets (+ photons) are also in portant and in som e cases can be larger.

The selectron interpretation can be made with the selectron e being either \mathbf{e}_{L} , \mathbf{e}_{R} , or a sum over \mathbf{e}_{L} and \mathbf{e}_{R} contributions. The di erence between \mathbf{e}_{L} and \mathbf{e}_{R} is in the SU (2)_L couplings of \mathbf{e}_{L} , causing for example the cross section at the Tevatron ($p\bar{p}$! $\mathbf{e}_{\mathrm{L}}\mathbf{e}_{\mathrm{L}}$) 2.2 ($p\bar{p}$! $\mathbf{e}_{\mathrm{R}}\mathbf{e}_{\mathrm{R}}$) (in the mass range of interest), and the presence of \mathbf{e}_{L} couplings to charginos. Thus one way to distinguish \mathbf{e}_{L} (and $\mathbf{e}_{\mathrm{L}} + \mathbf{e}_{\mathrm{R}}$) models from \mathbf{e}_{R} models is with the associated charged current channel $p\bar{p}$! $\mathbf{e}_{\mathrm{L}} \sim_{\mathrm{e}}$ that gives at least $1 + \mathbf{E}_{\mathrm{T}}$, with possibly more leptons or photons depending on the decay of \sim_{e} . Studies of such signals are relevant for $1 = \mathbf{e}$, . A further source of $1 + X + \mathbf{E}_{\mathrm{T}}$ events comes from $C_{1,2}$ (! $N_1 1$) N_2 (! N_1), as well as $C_1 \subset_{\mathrm{j}}$ with C ! $\mathbf{e}_{\mathrm{L}} = \mathbf{e}$ or C ! \sim_{e} e ifm \mathbf{e}_{L} or m \sim_{e} is lighter than the chargino. Thus if no excess of associated events can be attributed to the absence of $\mathbf{e}_{\mathrm{L}} \sim_{\mathrm{e}}$ production, then it becomes less likely that the original selectron was \mathbf{e}_{L} , though it cannot be de nitive until a clean result is published. In addition,

particular signals must be produced at LEP161/190 for e_R models that are not necessarily present for e_L models, and thus if these associated events were not found, then it becomes less likely that the original selectron was e_R , with the same caveat as above. At LEP it is necessary to study the relative rates of di erent channels to distinguish e_L from e_R , unless selectron pair production is actually observed there. In fact, if e_L or e_R production is observed (and the LSP can be established to be N₁), then we immediately know which charged slepton is not responsible for the $ee + E_T$ event, since as we have shown in this paper the slepton giving the $ee + E_T$ is kinematically forbidden at LEP161 and LEP190. Thus there is no unique signal to discriminate e_L from e_R (from $e_L + e_R$) models; only through the pattern of multiple signals can the nature of the selectron be determined.

We have also seen that a chargino interpretation of the $ee + E_T$ event is a distinct possibility. In either the selectron or chargino interpretation we expect at least the constraints from radiative neutralino decay to hold, and light sleptons are probably also a shared requirem ent for either interpretation (see Appendix A). One way to eventually distinguish the selectron interpretation from the chargino interpretation is to compare the rates of ee , and e A ssum ing a m ass degeneracy am ong the sleptons of di erent fam ilies, the selectron interpretation predicts roughly an equal number of ee and events, with a signi cantly depleted signal originating only from $\sim^{+} \sim$ production followed by $^{+}$! e + X . Alterе natively, in the chargino interpretation one would expect roughly double the number of e events as com pared with either ee events. Thus com paring the e rate with either or would provide a useful means to discriminate between the two interpretations. or ee N otice also that events of the type $1^+ 1^0$ production.

It is in portant to remark that the $ee + E_T$ event phenom enology could be connected with other phenom ena. If the LSP = N_1 is stable, then it could provide a cosm ologically signi cant relic density even if it is mostly a Higgsino [7] (as required by the $ee + E_T$ event). For a given value of h^2 the mass of N_1 is correlated with tan , and so gives a subset of the models constructed here. The predictions for associated phenom enology are tighter; and generally the signals can be larger. Also, we have described in detail the e ect of assuming a light stop in addition to the $ee + E_T$ event, in particular its connection to R_b [29] (and s [30]). A light stop has many other consequences [16], that we will not go into detail about here.

However, it is perhaps useful to remark on how can we learn if there is a light stop. The easiest way would be to observe it at LEP. The cross section ranges from about 0.2{0.8 pb over the range 50 < m_{t_1} < 70 (80) GeV of most interest for LEP161 (LEP190). LEP190 with tens of pb⁻¹ will be de nitive. For such light stops and even for somewhat heavier ones up to $m_t m_{N_1}$ (< 100 GeV in models considered here) searches in t(! $t_1N_1)t(!$ W b) or stop pair production can be de nitive. Indirect evidence for a light stop before there is de nitive collider data could come from a convincing R_b excess, from slepton pair production at the Tevatron without associated leptons, and photons from changino channels because C_i ! t_1b ,

from anom abus behavior of top properties [16], and from the +b+ jets events [16] commented on in Sec. 5. Note that t_1 could be near N_1 in mass, and therefore give very soft ferm ions plus large m issing energy.

We have stated that certain signals must be produced at LEP and Tevatron, and some signals might be produced if kinem atically accessible. For example, at LEP 161 three neutralino and one chargino pair cross sections are large enough to give a signal if about 25 pb⁻¹ is collected. The signatures are described in Sec. 4.7.1 and can sometimes be somewhat unusual. At LEP 190 m any m ore processes can be open, which can all give signals with possibly unusual signatures (see Sec. 4.7.2). It is important to emphasize that the predictions assume the minimum cut A = 5 fb is placed on the B² for the ee + \not{P}_{T} event. In principle, if one could demonstrate that failure to detect the signals implies they do not occur at all, then only two possibilities remain: (1) A supersymmetric explanation of the ee + \not{P}_{T} event in our fram ework must rely on an upward uctuation from B² even lower than 5 fb, or (2) a supersymmetric explanation in our fram ework is not possible. We note that even if the cut A = 5 fb needs to be relaxed, there are still constraints from requiring a moderate branching ratio for N² ! N¹ as demonstrated in Fig. 2.

The $ee + E_T$ event has given us a profound example of how low energy supersymmetry could be discovered with one event. It is not obvious that such an event could be explained by supersymmetry, and we emphasize here the predictability of the theory once such an explanation is adopted. In particular, we have shown that assuming the $ee + E_T$ event is due to supersymmetry with a $N_1 = LSP$ imposes strong constraints on the supersymmetric parameters, and predicts much associated phenomenology. C on mation at LEP or Tevatron from the myriad of associated signals described in this paper is necessary to be denitive. It is remarkable how much can be learned from the Tevatron data, if the signal is con med.

Appendix A: M odels in the chargino interpretation

The chargino interpretation purports to explain the ee + E_T event through chargino production and decay, a priori sharing only the requirement of radiative neutralino decay with the selectron interpretation. The possible sources of ee in the chargino interpretation are from $p\bar{p}$! $C_i C_j$ with $C_{i;j}$! N_2 e, followed by N_2 ! N_1 . The decay $C_{i;j}$! N_2 e can proceed through either on-shell or o -shell W, e_L and \sim_e . However, the 2-body decay C_1 ! W N_2

is not possible, since $m_{C_1} = m_{N_2}^{-1} \leq 25 \text{ GeV}$ when the radiative neutralino branching ratio B (N₂ ! N₁) is required to be large.

A.1 Chargino production and 3-body decays

If e_L , \sim_e are heavy, the branching ratio for the decay C_1 ! N_2e_e is dominated by W exchange, with a branching ratio the same as that for the SM decay \mathbb{W} ! e equal to 11%. Chargino production with heavy sleptons therefore in plies for every $1^{t} 1$ event, roughly 20 other events with jet activity (possibly accompanied by one charged lepton) or two di erent charged leptons (plus two photons). In addition, the channel C_1 ! N_1e is always open and it is generally favored by phase space, in particular in the case i = 1, since the mass dierence m $_{C_1}$ m $_{N_2}$ is never large. Further, it seems dicult to nd a region of the parameter space allowed by LEP data, consistent with a large neutralino radiative decay branching ratio and the general kinem atical ee requirem ents, where the non-radiative channels into N_1 are dynam ically suppressed. This holds for both on-and o -shell W -exchange, and as a result the branching ratio for the decay $C_1!$ N₂e hardly exceeds 6% for i = 1 and is even lower for i = 2. Hence, to get > 5 fb ee signal from $C_i C_j$ production and decay C_{ij} ! W ()(! e) N_2 (! N_1) one needs a cross section at least roughly 1:5 pb (even assuming B N_2 ! N_1) = 100%), since B ($\mathbb{C}_{i} \mathbb{C}_{i} \mathbb{C}_{i}$! $\mathbb{N}_{2} \mathbb{N}_{2} e^{+} e^{-} e^{-} e^{-}$) is well below 1%. This does not seem to be possible with an individual chargino pair production process, given all the other ee constraints. However, a sm all but non-zero signal can always arise from this source in models which are compatible with the selectron interpretation. We have found models with up to 1 fb ee total signal from the sum of $C_i C_j$ production and 3-body C_i decay in our selectron interpretation models. (These contributions were not included in the selectron interpretation.)

A.2 Chargino production and 2-body decays

We consider in the following chargino production followed by 2-body decays into sleptons, which allows an enhancement of the total possible branching ratio into the enalstate. The regions are somewhat dierent in the chargino interpretation with C ! If than in the selectron interpretation; in particular we found the constraint $m_{N_2} = m_{N_1} > 20 \text{ GeV}$ is no longer required. (We have checked that a neutralino mass dierence of order 10 GeV can be su cient in the chargino interpretation.) This may in principle allow the kinematical mechanism for the enhancement of the radiative neutralino decay branching ratio to operate simultaneously with the dynamical mechanism to obtain a large entropy to be allowed when m_{N_2} is small, so that it can presumably receive a large boost after the e_L or \sim_e decay and generate a hard

photon. The only way to construct a model with two very light neutralinos and a heavier chargino is to enter the \light gaugino-H iggsino window " (see Sec. 4.2), but even there it seems di cult to build a model which falls in the region suggested by the $ee + E_T$ event kinematics with the constraints from the branching ratios. A lso, with a neutralino mass di erence of order 10 G eV or more the radiative neutralino branching ratio never approaches 100% from only the kinematical enhancement [11]. Hence, as in the selectron interpretation it would appear that the dynamical mechanism for a large radiative neutralino decay is required. This, along with the follow ing argument for the need of a mostly gaugino N₂, explains why it seems possible to build models with large ee rates in the chargino interpretation only in regions of the gaugino-H iggsino parameter space similar to that in the selectron interpretation.

The maximum B $[\mathcal{C}_1 ! I^{\Gamma}(\cdot) ! \mathbb{N}_2)$] for $I = -e_e$ is 1=3, and for $I = e_L$ is 1=6 due to the slepton mass degeneracy assumption and $m_{-e} < m_{e_L}$ (assuming the decay into sneutrinos is not strongly suppressed). Also, the slepton decay channels with \mathbb{N}_1 in the nalstate are always open and enhanced by phase space. Thus to maximize the branching ratio into \mathbb{N}_2 , one has to minimize the \mathbb{N}_2 Higgsino components (which do not couple with sleptons) and maximize the Higgsino component of \mathbb{N}_1 . In this way, the branching ratio for e_L ! \mathbb{N}_2e is enhanced, analogous to the selectron interpretation. Typically, the branching ratio for the combined decay $\mathbb{C}_1 \mathbb{C}_j$! ee though 2-body decays into sleptons can reach at best 4%, assuming B \mathbb{N}_2 ! \mathbb{N}_1) = 100%. In the \mathbb{C}_2 case, a further source of suppression can come from the channel -e ! \mathbb{C}_1e (if open), that always dominates over -e ! \mathbb{N}_2e or -e ! \mathbb{N}_1e . A similar suppression in the \mathbb{C}_2 case can also come from e_L ! \mathbb{C}_1e . Thus, the actual ee rate depends strongly also on the mass hierarchy between m_{-e} , m_{-e} and m_{-e} .

M aximizing the Higgsino component of N_1 and m inimizing that of N_2 , leads us to the conclusion that N_2 is mostly photino and N_1 is mostly Higgsino, analogous to the selectron interpretation. However, di erences do exist between the chargino interpretation and e_L models in the selectron interpretation. For example, one needs $100 \le m_{e_L} \le 137 \, \text{GeV}$ in the selectron interpretation, while in the chargino interpretation one only needs at least one of e_L , \sim_e heavier than roughly 60 GeV but lighter than at least one of the charginos. Of course, additional constraints on m_{e_L} , m_{e_e} are present, due to the particularly complicated decay chain and the large radiative neutralino branching ratio needed. The right selectron enters the 3-body decay $N_2 ! N_1 e^+ e$, but if its mass is moderately large then the decay cannot be enhanced. Squark m asses are relatively unconstrained, although lighter squark m asses increase the C_2C_2 cross section, but decrease the radiative branching ratio.

5%, then a C_1C_2 interpretation (alone) can be excluded. For C_1C_1 and C_2C_2 production, the signal could be up to roughly 20 and 60 fb, therefore the lower bound on the radiative neutralino decay branching ratio is 50% and 30% respectively, to pass A = 5 fb cut used in the selectron interpretation. The C_1C_1 cross section drops rapidly as m $_{C_1}$ is increased, and it appears not to give a sizeable ee $+ E_T$ signal when m $_{C_1} > 110$ GeV. A lternatively, the $\mathbb{C}_2\mathbb{C}_2$ cross section can still be large, and give a sizeable ee signal for $\mathfrak{m}_{\mathbb{C}_2}$ 150 G eV (if 250 GeV). In practice, this sets rough upper limits for M_2 and j j which determine m 🕳 the chargino m asses. Further, our analysis of the $ee + E_T$ event kinem atics in the chargino interpretation gives an indication that large m ass di erences (> 30 GeV) between C_1 and N_2 m ay be required to reconstruct the $ee + E_T$ event. In the i = 1 case this is very di cult, if not in possible, given all the other constraints. Thus, we conclude that sizeable ee $+ E_T$ signals can probably only be achieved from $C_2^+ C_2^-$ production, with the decay chain $C_2^-! e^{\mathbf{e}_L}$ (! eN_2^-) or \mathbb{C}_2 ! $e_{e}(! e_{N_2})$, followed by \mathbb{N}_2 ! \mathbb{N}_1 . This appears to happen only in a region of the param eter space sim ilar to the selectron interpretation.

A few nal remarks on model building are in order. The sneutrino always plays a role when the mass hierarchy m $_{C} > m_{e_{t}} > m_{e_{t}}$ (> m $_{e_{t}}$) exists, and as a consequence the ee signal is depleted from C'! ~ee since ~e tends to have comparable branching ratio into N_1 and N_2 . Further, if $m_{e} < m_{N_2}$, then a 2-body decay opens for $N_2 ! e_{e}$, which often suppresses the radiative decay branching ratio. A lso, a sneutrino m ass larger than m r. in plies a possibly large branching ratio for $\sim_{\rm e}$! C_1 e. To ensure su cient phase space for the decay C_2 ! $e_{\rm L}$ e and to have the masses fall in regions where we found kinematical solutions, the mass di erence m_{e_L} > 0 (10) GeV probably should be enforced. The selectron also must be larger m 🚓 than m_{N_2} by at least 20 GeV for analogous reasons, but not larger than m_{C_1} otherwise the branching ratio for e_L will be dom in a ted by e_L ! C_1_e . It is clear that maintaining such a mass hierarchy between m $_{C_2}$, m $_{e_L}$, m $_{\sim_e}$, m $_{N_2}$, m $_{C_1}$, m $_{N_1}$ is considerably m ore di cult than in the selectron interpretation, and to some extent a ne-tuning of the masses of the particles involved is always required. A lso, the relevant branching ratio is always sm all and never exceeds a few percent while in the selectron interpretation it can in principle reach 100%. All of these facts seem to render a chargino interpretation problem atic (in stark contrast to a scenario with the gravitino as the LSP [4]).

A.3 Chargino interpretation { an example

We searched ourm odels amples compatible with a selectron interpretation of the $e + E_T$ event for cases where C_2C_2 production could yield an additional essignal. We found several tens of candidate models: some in the e_R samples, and a few in the e_L sample. However, the general kinematical requirements for a chargino interpretation of the $e + E_T$ event slightly favor the e_L models, which are located roughly in Region 2 (according to the classication of Sec. 4.2). Such models could give rise to a essignal with the kinematical characteristics of

the event, from simultaneously \mathbf{e}_{L} and \mathcal{C}_2 pair production, although the \mathcal{C}_2 signal is generally below 6 fb. We report one model as an example of the above: M $_1$ = 65 GeV, M $_2$ ' M $_z$, = 53 GeV tan = 2, m_{e_L} = 110 GeV, m_{e_R} = 350 GeV, m_{\sim} = 90 GeV, m_{t_1} = 150 GeV, $m_q = 250 \text{ GeV}$. The neutralino m asses m $N_{1;2;3;4} = 65;70;96;137 \text{ GeV}$, and the chargino m to masses m $_{C_{1,2}}$ = 72;137 GeV. The C_2C_2 production cross section at the Tevatron is 380 fb, while the $e_L e_L$ cross section is 13 fb. The B ($\mathbb{N}_2 \mid \mathbb{N}_1 \mid = 81\%$, the B ($\mathbb{C}_2 \mid \sim_e e \mid = 17\%$, the 100%, and B ($_{e}$! $C_{1}e$) = 77%. The ee $B(C_2 ! e_L e) = 16\%$, the $B(e_L ! N_2 e)$ rate is roughly 6 fb from only chargino production, and so is slightly above the A = 5 fb cut in posed in the selectron interpretation. It is worthwhile to remark on how sensitive the ee rate is to a change in the masses. For example, one can attempt to raise the ee rate from chargino production by slightly reducing the e. m ass in such a way to get a sneutrino lighter than the \mathcal{C}_1 , and gain the additional signal from \mathcal{C}_2 decays into on-shell sneutrinos and sneutrino decays into N₂. This would require $m_{e_1} \leq 96 \text{ GeV}$, although the modi ed model would appear to be farther from the region of masses satisfying the $ee + \mathbb{F}_T$ event kinematics. However, the radiative neutralino decay branching ratio drops quite sensitively when the already light slepton m asses are further reduced. Thus, constructing m odels in the chargino interpretation is som ew hat di cult, and it is not obvious how one ought to perturb around any given m odel to rate. However, we did nd some models with interesting characteristics, as increase the ee shown above. A more in-depth analysis is necessary to determ ine if the chargino interpretation is tenable, and if so the ranges of the param eters needed.

Appendix B: Sam ple M odels

Here four sample models from the set used in the selectron interpretation are provided in Tables 12 and 13. Input parameters and calculated masses are given, along with many branching ratios and cross sections. Notice that the four models' input parameters are similar (except for the slepton and stop masses), but the cross sections for both the ee $+ E_T$ event and associated phenom enology are quite di erent.
