# PROSPECTS FOR M EASUREMENTS OF CP VIOLATION AT HADRON COLLIDERS

A brief review of the strategies used in looking for CP violation in B decays is presented. Some problem s due to penguin diagram s are addressed. Penguin trapping is discussed, in the context of the upcom ing experiments. The high rates and the possibility to perform experiments on the  $B_{\rm s}$  system justify the interest in hadronic colliders.

#### 1 Introduction

In the Standard M odel, CP violation (CPV) arises from the clash of the Yukawa couplings with the charged current interaction. When the Lagrangian is written in the physical (m ass) basis, this shows up as an irrem ovable phase in the CKM<sup>1</sup> quark m ixing m atrix. The m agnitudes of m ost CKM m atrix elements are constrained experimentally<sup>2;3</sup>, and exhibit an hierarchy, with the magnitudes getting sm aller as one leaves the diagonal. Together with unitarity, this m otivates the W olfenstein<sup>4</sup> parametrization of the CKM m atrix. The W olfenstein parameters and A are known to 1% and 5%, respectively. The best (correlated) constraints on the W olfenstein parameters and arise from the m easurem ents of  $J_{\rm ub}=V_{\rm cb}\,J^5$ , B<sup>0</sup> B<sup>0</sup> m ixing<sup>6</sup>, and the m easurem ent of indirect CPV in neutral K aons<sup>7</sup>.

These constraints depend on hadronic matrix \m essy" elements, and hence have large errors. The corresponding allowed regions are shown in the gure, taken with the gracious permission of N eubert from his recent review <sup>2</sup>. In this gure, the CP conserving measurements of  $\mathbf{j}_{ub}=V_{cb}\mathbf{j}$  and of  $\mathbf{x}_d=M=$  (in the B<sup>d</sup><sub>d</sub> system) already im ply CP violation. At present, this feature disappears if we take the most conservative bounds.

A nother way to express these constraints is to look at the orthogonality of the rst and third (db) columns of the CKM matrix. This can be written as

$$1 = \frac{V_{ub}}{V_{cb}} + \frac{V_{td}}{V_{cb}}$$

The squared magnitudes of the two terms on the RHS are  $^2 + ^2$ , and (1)  $^2 + ^2$ , respectively, and the corresponding bounds lead to the two circular




Figure 1: Constraints on the – plane. The circles centered at (0,0) and (1,0) describe the bounds on  $jy_{ub}=V_{cb}j$  and  $x_d$ , respectively. The two hyperbolae arise from the CPV m easurem ent in neutral K aons.

sections in the gure. Equation 1 m ay be visualized as the well known unitary triangle in the plane. It is constructed from a side starting at (0,0), another at (1,0), and meeting at an apex lying within the allowed region in the gure. Its angles are uninspiredly known as , and , going clockwise from the apex. Increasing excitement is due to their upcoming measurement through CP asymmetries in B decays.

Depending on how the  $^{0}$ = experiments develop, this might be the rst independent measurement of CPV since 1964 (That was several years before I was born!!). In any event, it will help to constrain and , shedding new light on the structure of the CKM matrix and probing for New Physics e ects.

# 2 Searching for CPV in B decays

A lthough CPV in the CKM matrix is a purely E lectrow eak phenom enon, since quarks are included, we are unavoidably confronted with strong interactions. These bring with them several new features:

Though we can calculate reliably diagram s involving quarks and shortdistance e ects, the non-perturbative hadronic \m essy" elements are not known to the desirable precision. This is responsible for the large errors in the gure, and, unless such m atrix elements cancelout, also produces corresponding errors in B decays.

Besides tree diagram s, we also get gluonic-penguins, which will com plicate the analysis. There are also electroweak-penguins, which play a crucial role in certain decays<sup>8</sup>. Strong phases are induced by nalstate interactions. Two such phases are mandatory for direct CPV, but may obscure the interpretation of CPV from the interference between the mixing and the decay.

Since the strong interaction preserves avour, one m ay rephase the B  $^{0}$  states. This means that only the clash between two phases m ay have physical meaning.

- The last point leads to three classes of asym metry observables:
- 1. Indirect CPV, where we clash the phases of the B<sup>0</sup> B<sup>0</sup> m ixing m ass (M<sub>12</sub>) and width (<sub>12</sub>). We know that there is indirect CPV in the K<sup>0</sup> K<sup>0</sup> m ixing, due to the m easurem ent of the Re() parameter. Unfortunately, this is expected to be unm easurably sm all for the B<sub>d</sub> and B<sub>s</sub> system s.
- 2. Direct CPV, where we clash two independent decay paths. This requires at least two am plitudes (preferably of sim ilar magnitudes), two di erent weak phases, and two di erent strong phases. If the nal state is not common to  $B^0$  and  $B^0$ , the decays have the advantage of being self-tagging. This is most clearly seen in B decays. In the kaon system, a measurement of  $^0$  would be a signal of this type of CPV.
- 3. Interference CPV, occurring when the nalstate is common to B<sup>0</sup> and B<sup>0</sup>, where one clashes the direct decay path, B ! f, with the indirect B ! B ! f decay.

The rst two methods are plaqued by hadronic uncertainties. However, these cancel in interference CPV when the (common) nalstate is a CP eigenstate and the decay is overwhelm ingly dominated by one weak phase. One nds,

$$a(t) = \frac{B^{0}(t)! f}{B^{0}(t)! f} = \frac{B^{0}(t)! f}{B^{0}(t)! f} = f \sin(2) \sin(M t); \quad (2)$$

where  $_{\rm f}$  is the CP eigenvalue of the nal state f, and is the weak phase. O ne can also perform a time-independent measurement, thus paying a price of x=(1 + x<sup>2</sup>). The measured value of x<sub>d</sub> yields a modest suppression of 1=2. However, in the B<sub>s</sub> system, the current lower bound on x<sub>s</sub><sup>6</sup> already im plies a suppression of an order of magnitude. This is coming up on vertexing lim its<sup>9</sup>, and makes time-dependent measurements mandatory for the B<sub>s</sub> system.

The gold plated mode of this type is the B !  $J = K_S$  decay, which measures sin(2). This decay is important theoretically, because the penguin and tree contributions share the weak phase, and also experimentally, since the

J= is easy to tag with di-leptons. Current estimates for BABAR and BELLE predict uncertainties of order  $0.2^{10}$ . At hadronic machines one has much higher lum inosities, but also a much harder environment to work on. Comprehensive M onte C arlo simulations are still in their infancy. The xed target HERA-B experiment quotes uncertainties around 0:13, while LHC-B quotes  $0.023^{11}$ . In a very nice article, Butler<sup>12</sup> obtains 0:07, for the Tevatron running at  $10^{32}$  lum inosity<sup>13</sup>. I would like to thank him publicly for summarizing the e ects of the various cuts and e ciencies in a complete and clear table (rather than scatter them all over 357 pages of jargon).

The hadronic mess reappears when one has more than one weak phase, as it happens in B !  $^+$ , where the tree and penguin contributions come in with di erent phases. Here, besides the interference CPV sin (M t) term, we also get a direct CPV cos(M t) dependence. Even if there were no nal state phases (in which case the cos term would vanish), the penguin diagram would still a ect the extraction of sin(2) from the B !  $^+$  decay<sup>14</sup>. In fact, even for modest values of the penguin am plitude around 20% of the tree am plitude, we can nd deviations of up to 0:4 in that determ ination<sup>14</sup>.

To rem ove this problem, G ronau and London<sup>15</sup> have proposed the use of isospin sym m etry to relate this decay to  $B^0 ! ^{0} o$  and  $B^+ ! ^{+} o$ . Though one must also take the electroweak penquins into account<sup>16</sup>, these have been shown not to a ect this method <sup>8</sup>. Unfortunately, the  $B^0$  ! <sup>0</sup> branching ratio is of order 10  $^{6}$  and we would have to detect two neutral pions in the nal state. This is probably unfeasible at hadronic colliders. Still, we can use SU (3) symmetry and relate  $B^0$  ! + to the penguin dominated  $B^0$  ! K + Silva and W olfenstein introduced this idea to  $\trap"$  the penguin <sup>17</sup>. In fact, once is measured in  $B^0$  ! J = K<sub>S</sub>, all we need is the rate ratio<sup>17</sup>, for which CLEO already has a (rather bose) bound <sup>18</sup>. C learly, this technique will provide the rst experim ental handle on . Recently, G ronau and Rosner<sup>19</sup> have developed this idea, showing that one may remove the penguin factorization hypothesis by measuring in addition the branching ratio for B<sup>+</sup> ! K<sup>0</sup> +. This also allows for the independent determ ination of , though will be measured beforehand anyway (recall that + + = in the SM; a fact used in all these analysis).

A nother approach consists in constructing polygons relating various am – plitudes to extract the CKM angles. For example, G ronau and W yler <sup>20</sup> have suggested the extraction of the angle from triangles built using the B<sup>+</sup> ! K<sup>+</sup> (D<sup>0</sup>; D<sup>0</sup>; D<sup>0</sup>, ) decays, and their CP conjugates. Subsequently, D unietz applied this strategy to neutral decays<sup>21</sup>, in what the LHC-B collaboration calls M ethod Two<sup>22</sup>. For simplicity, I will use their notation. M ethod O ne is due to A leksan, D unietz and K ayær<sup>23</sup> and uæs B<sub>s</sub> decays into D<sub>s</sub> K<sup>-</sup>. O ne

m ay also combine these polygon constructions with SU (3) symmetry  $^{24}$  to extract the angles of the unitarity triangle. Such techniques have been further explored in a very large number of recent articles.

### 3 The use of the $B_s$ system

An important constraint on the parameters and would come from a measurement of the mass di erence between B $_s^0$  and B $_s^0$ , m $_s$ . Looking at gure 1, we realize immediately that the constraint on  $\mathbf{j}\mathbf{y}_{td}$  jarising from m $_d$  is rather poor. This is due to the hadronic uncertainties : the bag term and the decay constant for B $_d$  are only known to about 20%. However, their ratios to the corresponding factors for B $_s$  are much better known. Therefore, a clean determination of m $_s = m_d$  would greatly in prove our know ledge of the CKM matrix. The current LEP lim  $\mathbf{t}^{25}$  is m $_s > 7$ :7ps <sup>1</sup>, and the reader is encouraged to ask them about the meaning of the 8ps <sup>1</sup> m inimum in the likelihood plot. Should this value become much higher, we might run into technology lim – its<sup>9</sup>. Moreover, when looking for asymmetries in B $_s^0$  decays, the oscillations in equation 2 will become to to fast for detection.

Fortunately, the width di erence between  $B_s^0$  and  $B_s^0$  m ight come to the rescue. In a recent analysis, Beneke, Buchalla and Duniet $z^6$  nd

Hence, the width di erence cannot be neglected, and the decay rates  ${\tt m}$  ay be written as

$$[B ! f] / H (t=2) + I (M t)$$

For untagged decays, not only is there no statistics cost from tagging, but the rapid oscillation I (M t) terms drop out. Strictly speaking, one should now talk about the short lived and the long lived B<sub>s</sub> states. As pointed out eloquently by D unietz<sup>27</sup>, this provides a uniquely di erent way to measure CPV in the B system. In particular, M ethod O ne is applicable with untagged sam ples. D unietz<sup>27</sup> also proposes an untagged B<sub>s</sub> into D<sup>0</sup> version of M ethod Two. This is a hot topic, and rapid new developments are expected.

# 4 Conclusions

The fact that the SM has only one CPV independent quantity makes it very predictive, giving us an ideal setting in which to look for the Physics Beyond.

Since thirty two years is a lot of time to seat on our hands, this picture should (and will) be tested.

In the B system, the rst inform ation will be the measurement of in the gold plated B ! J= K s decay. For a measurement of in B ! <sup>+</sup> we must trap the penguin. This can be performed<sup>17</sup> comparing it to B ! K<sup>+</sup>, and we can avoid the penguin factorization approximation<sup>19</sup> by measuring in addition B<sup>+</sup> ! <sup>+</sup> K<sup>0</sup>. As for the extraction of , there are several classic methods<sup>20;21;23</sup>. The good news from Dunietz<sup>27</sup> is that we may be able to use untagged samples for M ethod O ne<sup>23</sup>, and for the B<sub>s</sub> into D<sup>0</sup> version of M ethod T wo<sup>27</sup>. This is specially interesting if the width and m ass di erences in the B<sub>s</sub> system turn out to be large.

The angle will soon be measured at BABAR, BELLE and HERA-B.W e will also learn a considerable am ount about penguin trapping. The high rates and the (com plem entary)  $B_s$  Physics opportunities available at the Tevatron and LHC warrant dedicated B-Physics experim ents. Understanding the real capabilities of such experim ents, under what is adm ittedly a very hard environm ent, will require extensive M onte C arb simulations. Please sum m arize each step of your cuts and e ciencies clearly. W e will thank you for it.
