FORM FACTORS OF KAON SEM LEPTON IC DECAYS ^a

A calculation of the sem i(leptonic decays of the kaon (K $_{13}$) is presented. The results are direct predictions of a covariant m odel of the pion and kaon introduced earlier by Ito, Buck, G ross. The weak form factors for K $_{13}$ are predicted with absolutely no parameter adjustments of the model. We obtained for the form factor parameters: f $(q^2 = m_1^2) = f_+ (q^2 = m_1^2) = 0.28$ and $_+ = 0.028$, both within experimental error bars. Connections of this approach to heavy quark symmetry will also be discussed.

A covariant m odel based on coupled B ethe{Salpeter and Schw inger{D yson equations w ith an N JL { like interaction w as successfully used earlier to describe electrom agnetic properties of pions and kaons $^{1/2}$

U sing this model, we analysed form factors of K $_{13}$ decays (describing the processes K ! 1). A ssum ing that only the vector weak current contributes to the decays, the matrix element may be written as

$$J = \frac{G_{F} \sin c}{P - 2} [f_{+} (t) (P_{K} + P) + f (t) (P_{K} - P)];$$

where P_K and P are the four{m omenta of the K and m esons, G_F is a Fermi coupling constant, $_C$ is a Cabibbo angle, and f_+ and f are dimensionless form factors which can depend only on $t = (P_K P)^2$. For the decay channel, the physical region is limited by the masses of the lepton, pion and kaon: $m_1^2 t (m_K m)^2$:

In our model, the pion and the kaon both share the same light quark mass of 250 MeV. It is this mass, together with the corresponding mesonic vertex functions (wave functions) employed in the calculation of the elastic and transition form factors of the pion and kaon that is now employed in the

K $_{\rm B}$ decays addressed here. The pion calculation provides a non-perturbative solution to the axial anomaly for space{like Q² and the charged pion form factor¹ while the kaon wave function provides a good description of the charged and neutral kaon form factors².

The main results of the predictive calculation of the K $_{13}$ decays are illustrated in the Table 1 and compared to selected theoretical models and experiment (see also Ref²). Results are in quite good agreement with available empirical data for all observables studied and, when one quark is in nitely heavy, we reproduce the heavy quark symmetry limit for the ratio f = f₊ ⁴.

It should be noted that Je erson Lab m easurem ents of charge form factor (E {93{021}, kaon charge form factor (E {93{018}, a $p ! pm easurem ent at the ^0 pole¹⁰ and K₁₃ transitions,¹¹ will further constrain theoreticalm odels addressing all electroweak pion{kaon reactions. M ore to the point, all of these experiments are connected; in fact, we contend that they must be connected without new parameter ts or adjustments.$

It is speculated that to employ these theoretical techniques in the study of the nucleon, our quark m asses m ust be accompanied by a rather large inter{ quark kinetic energy in order to bind the nucleon and extract form factors.
