QCD FROM A LARGEN PERSPECTIVE ${ }^{a}$

#### Abstract

The $1=\mathrm{N}_{\mathrm{c}}$ expansion of Q CD can be used to calculate properties of nucleons and baryons, such as $m$ asses, $m$ agnetic $m$ om ents, and pion couplings. The predictions of the $1=\mathrm{N}_{\mathrm{c}}$ expansion are in excellent agreem ent w ith the experim ental data. T he $1=\mathrm{N} \mathrm{c}$ expansion also provides an understanding of the relation betw een the quark $m$ odel, the Skym emodel, and QCD.This talk review s som e of the recent developm ents.


## 1 Introduction

$M$ any features of the baryon sector of QCD have recently been understood both qualitatively and quantitatively using the $1=\mathrm{N}_{\mathrm{c}}$ expansion ${ }^{n}{ }^{n} \mathrm{G}$ Here $\mathrm{N}_{\mathrm{c}}$ is the num ber of colors, which is three in the realw orld. T he $m$ ain results are:

There is a new symmetry in the baryon sector of QCD in the large $N_{c}$ lim it. For two light avors, the symmetry is a contracted SU (4) sym m etry which connects the $u$ ", u \#, d ", d \# in a baryon. The SU (4) $c_{c}$ sym $m$ etry relates the nucleon and , which belong to a single irreducible representation of $S U(4)_{C}$.

O ne can com pute the higher order $1=\mathrm{N}_{\mathrm{C}}$ corrections in a system atic way.
$M$ any results previously obtained in $m$ odels such as the quark $m$ odel or the Skym e model can be proved to be true in Q CD to order $1=\mathrm{N}_{\mathrm{c}}$ or order $1=\mathrm{N}_{\mathrm{C}}^{2}$. The $1=\mathrm{N}_{\mathrm{C}}$ expansion explains why som e m odel predictions w ork better than others; results obtained to order $1=\mathrm{N}_{\mathrm{c}}^{2}$ w ork about three tim es better than those obtained to order $1=\mathrm{N}_{\mathrm{C}}$. The $1=\mathrm{N}_{\mathrm{c}}$ expansion provides a uni ed understanding of di erent hadronic models, and $m$ ore im portantly, allow s one to com pute som e quantities (e.g. baryon $m$ asses, pion couplings, $m$ agnetic $m$ om ents) directly from $Q C D$ w thout any $m$ odel assum ptions.

The $1=\mathrm{N}_{\mathrm{c}}$ expansion is intim ately connected w ith baryon chiral perturbation theory. It explains why the $m$ ust be included to have a consistent perturbative chiralexpansion forbaryons. Including the converts

[^0]baryon chiral perturbation theory from a strong coupling expansion in powers of $\mathrm{N}_{\mathrm{c}}$ to a weak coupling expansion in powers of $1=\mathrm{N}_{\mathrm{C}}$.
$T$ he sigm a term puzzle, and the success of various baryon $m$ ass form ul such as the $G$ ell -M ann $\{\mathrm{O}$ kubo form ula can now be understood

The $1=\mathrm{N}_{\boldsymbol{e}}$ expansion provides som e inform ation on the nucleon-nucleon potential ${ }^{1 / 1}$ (See the talk by D B.K aplan in this proceedings.)

2 Large $\mathrm{N}_{\mathrm{C}} \mathrm{C}$ ounting Ru les
Large $N_{c} Q C D$ '8' 'is a non-trivial theory with con nem ent and chiral sym m etry breaking. The physical states are $m$ esons, and baryons. The $1=\mathrm{N}_{\mathrm{c}}$ counting rules in the $m$ eson sector are well-know notit $p$ he pion decay constant $f$, which is like a one-m eson am plitude, is of ordef_ $\mathrm{N}_{\mathrm{c}}$. Every additionalm eson in a vertex brings op suppression factor of $1=N_{c}$. Thus, three-m eson am plitudes are of order $1=\bar{N}_{c}$, fourm eson am plitudes are of order $1=\mathrm{N}_{\mathrm{c}}$, etc. The counting rules imply that while large $N_{c} Q C D$ is a strongly interacting theory in term $s$ of quarks and gluons, it is equivalent to a weakly interacting theory of $m$ esons (and, as wew ill soon see, baryons). Loop corrections in the $m$ eson theory are suppressed by pow ers of $1=\mathrm{N}_{\mathrm{c}}$, which is consistent w ith a sem iclassical expansion in powers of $h=\mathrm{N}_{\mathrm{C}}$.

Large $N_{c}$ baryons are $m$ ore di cult to study than $m$ esons, because the num ber of quarks in the baryon is $N_{C}$. T he large $N_{C}$ counting rules for baryon am plitudes were given by $W$ itten ${ }^{10}$ T he baryon $m$ atrix elem ents of any quark bilinear such as are $O\left(N_{c}\right)$, because the operator can be inserted on $N_{c}$ possible quark lines. O ne nds an inequality, rather than an equality, because it is possible that there is a cancellation betw een the various diagram s . These possible cancellations w ill tum out to be very im portant in the analysis that follow s. I w ill assum $e$ that the baryon $m$ ass $M$ and the axial coupling $g_{A}$ are both of order $\mathrm{N}_{\mathrm{c}}$, i.e. that there is no cancellation for these tw o quantities. A 11 $m$ odels of the baryon, such as the Skym e m odel, the non-relativistic quark $m$ odel, or the bag $m$ odel, satisfy this assum ption. For exam ple, in the nonrelativistic quark $m$ odel $g_{A}=\left(\mathbb{N}_{C}+2\right)=3$, which gives the well-know $n$ value of $5=3$ for $N_{c}=3$.

W ith these assum ptions, the pion-nucleon coupling is of the form

and is of order $\mathrm{p} \bar{N}_{c}$, since $g_{A} \quad N_{c}$ and $f \quad \mathrm{P} \bar{N}_{c}$. Recoile ects are of order $1=\mathrm{N} \mathrm{c}$, and can be neglected. T his allow s one to sim plify the expression for the nucleon axial current. The tim e com ponent of the axial current betw een two

nucleons at rest vanishes. The space com ponents of the axial current betw een nucleons at rest can be w ritten as

$w$ here $\mathrm{hN} j \mathrm{X}$ ia j i and $g$ are of order one. The coupling constant $g$ has been factored out so that the nom alization ofX ${ }^{\text {ia }}$ can be chosen conveniently. $\mathrm{X}^{\text {ia }}$ is an operator (or 44 m atrix) de ned on nucleon states p ", p \#, n ", n \#, which hasa nite $N_{c}$ ! 1 lim it.

3 C onsistency C onditions
O ne can use the qualitative $1=\mathrm{N}_{\mathrm{c}}$ counting rules to obtain consistency conditions for various baryonic quantities, such as the axial couplings $X{ }^{\text {ia }}$. These consistency conditions can be solved to obtain results for baryons that are in good agreem ent with the experim ental data at $\mathrm{N}_{\mathrm{c}}=3$.

C onsider pion-baryon scattering at xed energy $E$ (as $N_{C}$ ! 1 ) in the chiral lim it. T he leading contribution is from the pole graphs in Fig. ${ }^{1} 11$, w hich contribute at order E provided the interm ediate state is degenerate w ith the initial and nal states. O therw ise, the pole graph contribution is of order $\mathrm{E}^{2}$. In the large $\mathrm{N}_{\mathrm{C}} \lim$ it, the pole graphs are of order $\mathrm{N}_{\mathrm{C}}$. There is also a direct tw o-pion $N$ coupling that contributes at order $E$, which is of order $1=N_{c}$ in the large $N_{c} \lim$ it and can be neglected.
$T$ he pion-nucleon scattering am plitude for ${ }^{a}(q)+N(k)!{ }^{b}\left(q^{0}\right)+N\left(k^{0}\right)$ from the pole graphs is

where the am plitude is written in the form of an operator acting on nucleon states. B oth initial and nal nucleons are on-shell, so $q^{0}=q^{00}$. The product of the $X^{\prime}$ 's in Eq. interm ediate nucleon. Since $f \quad \bar{N}_{c}$, the overall am plitude is of order $\mathrm{N}_{\mathrm{c}}$, which violates unitarity at xed energy, and also contradicts the large $N_{c}$ counting rules of $W$ itten. Thus $N_{c}!1 Q C D$ with $a=J=1=2$ nucleon $m$ ultiplet interacting $w$ ith a pion is an inconsistent eld theory. There m ust be other states that cancel the order $N_{c}$ am plitude in Eq. ${ }^{2}$ in so that the total amplitude is order one, consistent with unitarity. O ne can then generalize $X^{\text {ia }}$ to be an operator on this degenerate set ofbaryon states, $w$ ith $m$ atrix elem ents equal to the corresponding axial current $m$ atrix elem ents. $W$ ith this generalization, the form of $\mathcal{F}$. $\overline{12}$ is unchanged, and we obtain the rst consistency condition for baryons,

This consistency condition im plies that the baryon axial currents are represented by a set of operators $X{ }^{\text {ia }}$ which com $m$ ute in the $N_{c}!1$ lim it, a result also derived by $G$ ervais and Sakita.$^{1111}$ There are additional com $m$ utation relations,

W e have just proved that the the $\mathrm{N}_{\mathrm{C}}$ ! $1 \lim$ it of CD has a contracted SU (4) sym $m$ etry in the baryon sector. T he unitary irreducible representations of the contracted Lie algebra can be obtained using the theory of induced representations, and can be shown to be in nite dim ensional. The simplest irreducible representation is a tow er ofstates with $I=J=1=2 ; 3=2$;etc:, which is the set of states of the Skym em odel, or the large $N_{c}$ non-relativistic quark m odel. M ore com plicated irreducible representations correspond to baryons containing strange quarks.

Thepion-baryon coupling $m$ atrix $X$ ia can be com pletely determ ined (up to an overall norm alization g ), since it is a generator of the $S U(4)_{c}$ algebra. It is easy to show that the $N_{c}!1$ QCD predictions for the pion-baryon coupling ratios are the, sam e as those obtained in the Skym em odel or non-relativistic quark mode ${ }^{21} 14$ in the $N_{c}$ ! 1 lim it, because both these $m$ odels also have a contracted SU (4) sym $m$ etry in this lim it. In the Skymmemodel, the axial current in the $N_{C}$ ! 1 lim it is $X^{\text {ia } / T r A ~}{ }^{i} A{ }^{1}$ a . The X 's commute (and so form part of an $S U(4)_{c}$ algebra), since $A$ is a c-num ber. W e have already seen how the quark $m$ odel algebra reduces to $S U(4)_{c}$ in the large $N_{c} \lim$ it.
$4 \quad 1=\mathrm{N}_{\mathrm{c}}$ C orrections
$W$ hat $m$ akes the $1=\mathrm{N}_{\mathrm{c}}$ expansion for baryons interesting is that it is possible to com pute the $1=\mathrm{N}_{\mathrm{c}}$ corrections. T his allow s one to com pute results for the physical case $N_{c}=3$, rather than for the strict $N_{c}=1$ lim it, which is only of form al interest.

The $1=\mathrm{N}_{\mathrm{c}}$ corrections to the axial couplings X ia are determ ined by considering the scattering process ${ }^{a}+N!b^{b}+{ }^{c}+N$ at low energies. The
baryon pole graphs that contribute in the $\mathrm{N}_{\mathrm{C}}$ ! 1 lim it are shown in F ig. $\overline{\text { In }}$. $T$ he axial coupling $X{ }^{\text {ia }}$ can be expanded in a series in $1=\mathrm{N}_{\mathrm{c}}$,

and violates unitarity unless the double com $m$ utator vanishes at least as fast as $N_{c}{ }^{3=2}$, so that the am plitude is at $m$ ost of order one. (In fact, one expects that the double com $m$ utator is of order $1=\mathrm{N}_{\mathrm{c}}^{2}$ since the corrections should only involve integer powers of $1=\mathrm{N}_{\mathrm{c}}$. This result also follows from the $\mathrm{N}_{\mathrm{c}}$ ! $\mathrm{p} \frac{1}{\mathrm{~N}}$ counting rules which im ply that each additional pion gives a factor of $1=\frac{p}{N_{c}}$ in the am plitude.) Substituting E q. ${ }^{\prime}$ gin into the constraint gives the consistency

where c is an unknown constant. The rst correction to $\mathrm{X}^{\text {ia }}$ is proportional to the low est order value, $X_{0}^{i a}$, so the $1=\mathrm{N}_{c}$ correction to the axial coupling constant ratios vanishes ${ }^{1_{1}} W$ e have now shown that the predictions for the ratios of pion couplings, such as $g_{\mathrm{N}}=\mathrm{g}_{\mathrm{N}} \quad$ or $_{\mathrm{g}_{\mathrm{N}}}=\mathrm{g}$ are equal to the prediction in the Skym em odel up to corrections of order $1=\mathrm{N}_{\mathrm{c}}^{2}$. The Skym e m odel results for the ratios of couplings are known to agree w th experim ent to about 10\% accuracy ${ }^{1}{ }^{51}$

At order $1=\mathrm{N}_{\mathrm{c}}$, the baryons in an irreducible representation of the contracted SU (4) Lie algebra are no longer degenerate, but are split by an order $1=\mathrm{N}_{\mathrm{c}} \mathrm{m}$ ass term M.The interm ediate baryon propagator in Eq. ${ }_{1}^{1}$, should be replaced by $1=(\mathbb{E} \quad M)$. The energy $E$ of the pion is order one, whereas $M$ is of order $1=\mathrm{N}_{\mathrm{c}}$, so the propagator can be expanded to order $1=\mathrm{N}_{\mathrm{c}}$ as

This constraint can be used to obtain the $1=\mathrm{N}_{\mathrm{c}}$ corrections to the baryon m asses. The constraint Eq. $1 \overline{2} \overline{2}^{1} \underline{1}_{1}$ is equivalent to a sim pler constraint obtained by Jenkins using chiralperturbation theort

 proportional to $J^{2}=\mathrm{N}_{\mathrm{c}}=j(j+1)=\mathrm{N}_{\mathrm{c}}$, where $j$ is the spin of the baryon ${ }^{2} \mathrm{~T}$ This is precisely the form of the baryon $m$ ass splitting in the Skym emodel.
$T$ he structure of the $1=\mathrm{N}_{\mathrm{C}}$ corrections show $s$ that the expansion param eter is $J=N_{c}$, where $J$ is the spin of the baryon. For exam ple, the baryon $m$ ass spectrum including the $J^{2}=N_{C} m$ ass splitting has the form shown in $F$ ig. $\overline{10}$. The correction term s are only sm all near the bottom of the (in nite) baryon tow er. For this reason, the $1=\mathrm{N}_{c}$ expansion w illonly be considered for baryons w ith spin $J$ held $x e d$ as $N_{C}!1$.

5 R esults
It is relatively sim ple to obtain consistency conditions such as Eq. using the $1=N_{c}$ expansion. Solving these equations is straightforw ard, but will
not be described here. The general solution for any physicalquantity $M$ has the form of a series expansion,

where $P$ is a polynom ial in its argum ents, $w$ th each operator appearing $w$ ith a coe cient $\mathrm{c}\left(1=\mathrm{N} \mathrm{C}_{\mathrm{c}}\right)$ which is order one as $\mathrm{N}_{\mathrm{c}}$ ! 1 . The overall pow er of r is given by the $N_{c}$ power counting rule for the quantity $M$ being considered. All the term $s$ in the polynom ialP $m$ ust have the sam e spin and isospin as M. In addition, there are a set of operator identities that allow one to elim inate $m$ any term $s$ in $P$ with contracted spin or isospin indices. For two avors, these identites are ${ }^{31}$

For exam ple, if $M$ is the baryon $m$ ass, $r=1$ since the baryon $m$ ass is of order $\mathrm{N}_{\mathrm{C}}$. The general expansion has the form

All other term $s$ in $P$ can be elim inated using Eq. ${ }^{1} \overline{5_{2}^{\prime}}$. At present, it is not known how to com pute the coe cients $\mathrm{C}_{\mathrm{i}}$.

O ne can obtain relations am ong baryon quantities by working to a given order in $1=\mathrm{N}_{\mathrm{c}}$, neglecting all higher order term S in P . The accuracy of the relations is determ ined by the order in $1=\mathrm{N}_{\mathrm{c}}$ of the neglected operators. As a trivial exam ple, consider the baryon $m$ asses in the two avor case. The physical states are the $N$ and,$w$ ith $I=J=1=2$ and $3=2$, respectively. To low est order, one nds that

$T$ his relation is a hom ogenous relation am ong the baryon $m$ asses. It is convenient to w rite Eq. '18 in in the form

where the num erator is the di erence of the two sides of Eq. 1 id, and the denom inator is the average of the two sides. The form Eq. 1 on the overall scale of Eq. 1 . $d$. Inchuding the rst correction gives

In this sim ple exam ple, there is no relation including the $1=\mathrm{N}_{\mathrm{c}}$ correction because two m asses are given in tem s of tw o param eters. H ow ever, one obtains $m$ any non-trivial predictions when the results are extended to three avors.

The baryon $m$ asses have been analyzed in a sim ultaneous expansion in SU (3)_preaking (due to $\mathrm{m}_{\mathrm{s}}$ ), isospin breaking, and $1=\mathrm{N}_{\mathrm{c}}$ by Jenkins and Lebed. ${ }^{16}$. They obtain a num ber of relations of the form Eq. ${ }^{1} \mathbf{g}_{1}^{\prime}$. T Their relations for isospin averaged $m$ asses (such as $\left(M_{P}+M_{N}\right)=2$ ) are show graphically in
 are the experim entalerrors on the $m$ easured baryon $m$ asses. The relations are valid to som e order in and $1=N_{c}$, where $0: 3$ is a m easure of $S U(3)$ breaking. It is clear from F ig. ${ }^{\prime} \mathrm{I}_{1}^{1}$ that the $1=\mathrm{N}_{c}$ expansion explains the hierarchy of the baryon $m$ ass relations. For exam ple, there are three relations w hich should be true up to corrections of order. O ne of them is order $=\mathrm{N}_{\mathrm{c}}$, one of order $=\mathrm{N}_{\mathrm{c}}^{2}$ and one of order $=\mathrm{N}_{c}^{3}$. The hierarchy betw een these relations is obvious from Fig. 'A'. An SU (3) analysis alone does not explain why som e of the order
relations work better than others. Sim ilarly, the $1=N_{c}$ expansion explains the hierarchy in the two ${ }^{2}$ relations. O ne can also see that the $1=\mathrm{N}_{c}^{2} \mathrm{~m}$ ass relation, which is not suppressed by $S U$ (3) breaking, works to about $11 \%$. O ne can understand the baryon $m$ ass spectrum to a fractional error of 0.001 (i.e.

1 M eV ) in the isospin averaged $m$ asses using $1=\mathrm{N}_{c}$ and $S U$ (3) sym metry.
 $1=\mathrm{N}_{\mathrm{c}}$ relations for the isovector and isoscalar m agnetic m om ents are show n in $F$ ig. 'I'I. M ost of the $m$ agnetic $m$ om ent relations derived using the quark $m$ odel can now be obtained directly from QCD, to some order in $1=\mathrm{N}_{\mathrm{C}}$. The $1=\mathrm{N}_{\mathrm{c}}$ expansion also explainsw hy som e relationswork better than others; som ething which is left unexplained by the quark m odel. There is also one new relation. Relation 7, which relates the ${ }^{+}$! p transition $m$ om ent to $p \quad n$, is a $1=N_{c}^{2}$ relation (which is also true in the quark model) which works to $30 \%$. This is one instance in which the $1=\mathrm{N}_{\mathrm{c}}^{2}$ correction is substantial. A $l l$ the $1=\mathrm{N}_{\mathrm{c}}$ relations are hom ogeneous, and do not set the scale of the $m$ agnetic $m$ om ents. In the quark $m$ odel, one can get a good estim ate of the size of the $m$ agnetic $m$ om ents from the constituent quark $m$ ass. $T h$ is is not explained by the $1=N_{c}$ expansion.

$T$ here are $m$ any other results that have been obtained using the $1=\mathrm{N}_{\mathrm{c}}$ expansion, som e of which are sum $m$ arized here.

O ne lop corrections to the baryon axial currents are large, and disagme w ith experim ent, unless one includes interm ediate states in loops ${ }^{19}$. T here are large cancellations betw een N and interm ediate states. The best $t$ values for the axial couplings when 's are inchuded are close to $S U$ (6) values. ${ }^{19}$ The $1=\mathrm{N}_{c}$ explains all of these results. O ne can show that the one-loop corrections to the axial currents have the structure

Eq. $\cdot \overline{2} \overline{1}_{1}^{1}$ is a com m utator that is constrained by the large $\mathrm{N}_{\mathrm{c}}$ consistency conditions, and is of order $1=\mathrm{N}_{\mathrm{C}}^{2}$. T hus including interm ediate states produces a cancellation to two orders in $1=\mathrm{N}_{\mathrm{c}}$, so the one-loop correction is of order $1=\mathrm{N}_{\mathrm{c}}$. This cancellation converts an expansion in $\mathrm{N}_{\mathrm{c}}$ to a sem iclassical expansion in $h=N_{c}$. If interm ediate states are not included, the one-loop correction is of order $\mathrm{N}_{\mathrm{c}}$ tim es the tree level result, since the cancellation conditions on $X$ do not hold in the nucleon sector alone. B aryon chiral perturbation theory w thout a is a strong coupling expansion in powers of $\mathrm{N}_{\mathrm{c}}$. T he strongly coupled theory presum ably dynam ically generates a .

O ne loop corrections to the baryon m asses are large ( 500 M eV ). M ost of the correction is $S U(3)$ singlet or octet, $S o$, the large non-linearities do not violate the $G$ ell $M$ ann $\{0$ kubo form ular. T his resolves the sigm $a-$ term puzzle ${ }^{211}$

## 7 C onclusions

The $1=\mathrm{N}_{\mathrm{c}}$ expansion show $s$ that $m$ ost of the spin- avor structure of baryons can be understood using contracted SU (4) sym m etry. It provides a unifying sym $m$ etry which connects the various quark $m$ odels (non-relativistic, bag), the Skym e model, and QCD. The $1=\mathrm{N}_{\mathrm{c}}$ expansion explains m any results found earlier in baryon chiral perturbation theory in a system atic way, and it is possible p com bine baryon chiralperturbation theory w ith the $1=\mathrm{N}_{\mathrm{c}}$ expansion of $Q$ CD $\underbrace{281}$
