## Quark M asses, C hiral Sym m etry, and the U (1) A nom aly

I discuss the m ass param eters appearing in the gauge theory of the strong interactions, concentrating on the two avor case. I show how the e ect of the CP violating param eter is simply interpreted in terms of the state of the ther via an e ective potential for meson elds. For degenerate avors I show that a rst order phase transition is expected at = :I speculate on the implications of this structure for W ilson's lattice ferm ions.

#### I. Introduction

This talk concerns the mass term m in the standard theory of quarks and gluons. It is an abridged version of my recent Phys. Rev. article<sup>1</sup>. One of my goals is to provide an intuitive picture for the physicalm eaning of the CP-violating parameter of the strong interactions. This term, offen called the term, is usually discussed in term softopological excitations of the gauge elds. Here, how ever, I treat it entirely in term softhe chiral symmetries expected in the massless lim it of the theory.

I conclude that a rst-order transition is expected at = when the avors have a sm all degenerate m ass. This transition can be rem oved if avorbreaking is large enough. At the transition, CP is spontaneously broken. I will also rem ark on the im plications for the structure of W ilson's lattice ferm ions.

This is a subject with a long history, and most of what I say is buried in num erous previous studies. The in plications of to the ferm ion mass matrix are well known to low-energy chiral Lagrangian discussions<sup>2</sup><sup>9</sup>. The possiblity of a rst-order phase transition at large has been discussed in<sup>3</sup>. The possibility of a spontaneous breaking of CP was pointed out even before the signi cance of the parameter was appreciated<sup>4</sup>. The relation of to lattice W ilson ferm ions was elucidated som e tim e ago by Seiler and Stam atescu<sup>5</sup> and was the subject of som e recent work of my own<sup>11</sup>.

The sign of the ferm ion mass is sometimes regarded as a convention. This is indeed the case for ordinary quantum electrodynamics in four space-time dimensions, where by Furry's theorem <sup>12</sup> there are no triangle diagrams and corresponding anomalies. However, it is explicitly false for the massive Schwinger model of electrodynamics in two space-time dimensions<sup>13;11</sup>. Furthermore, as the remaining discussion will argue, hadronic physics would change if the sign of one of the quark masses were ipped.




Figure 1: The phase diagram for the one avor case. The wavy line represents a rst-order phase transition, along which i  $_5$  acquires an expectation value. The end point of this transition line is renormalized away from the origin towards negative m<sub>1</sub>.

To start the discussion, consider a change of variables

The kinetic and gauge terms of the quark-gluon action are form ally invariant under this transformation. Thus, were one to start with the more general mass term of Eq. (2), one might expect a physical situation independent of . However, because of the chiral anomaly, this is not true. The angle represents a non-trivial parameter of the strong interactions. Its non-vanishing would give rise to CP violating processes. As such are not observed in hadronic physics, the numerical value of must be very small<sup>6</sup>.

If Eq. (1) just represents a change of variables, how can this a ect physics? The reason is entwined with the divergences of quantum eld theory and the necessity of regularization. Fujikawa <sup>14</sup> has shown how to incorporate the anom aly into the path integral form ulation via the the ferm ionic measure, which becomes non-invariant under the above chiral rotation. Under a Pauli-V illars<sup>15</sup> approach represents a relative  $_5$  rotation between the mass term




Figure 2: The two avor phase diagram. First-order lines run up and down the  $m_2$  axis. The second order endpoints of these lines are separated by a avor breaking m ass di erence. The chiral lim it is pinched between these endpoints.

for the fundam entalparticle and the mass term for a heavy regulator eld. On the lattice with W ilson's ferm ion prescription<sup>16</sup>, the doublers play this role of de ning the relative chiral phase<sup>10;11</sup>.

The phase diagram in the  $(m_1;m_2)$  plane is strongly dependent on the number of ferm ion avors. With a single species, a rst-order phase transition line runs down the negative  $m_1$  axis, starting at a non zero value for  $m_1$ . This is sketched in Fig. (1). For two avors I argue for two rst-order phase transition lines, starting near the origin and running up and down the  $m_2$  axis. For degenerate quarks these transitions meet at the chiral limit of vanishing ferm ion mass, while a small avorbreaking can separate the endpoints of these

rst-order lines. This is sketched in Fig. (2). W ith  $N_f > 2$  avors, the  $(m_1; m_2)$  plane has  $N_f$  rst order phase transition lines all pointing at the origin. The conventionally normalized parameter is  $N_f$  times the angle to a point in this plane, and these transition lines are each equivalent to going through .

W henever the number of avors is odd, there is a storder transition running down the negative m<sub>1</sub> axis. A long this line there is a spontaneous breaking of CP, with a natural order parameter being hi<sub>5</sub> i. This possibility of a spontaneous breakdown was noted some time ago by D ashen<sup>4</sup> and has reappeared at various times in the lattice context<sup>17;18</sup>.

I concentrate m y discussion on the two avor case. Here several sim pli - cations m ake the physics particularly transparent. I then discuss how the one

avor result arises when the other avor is taken to a large mass. Finally I conjecture on an analogy with heavy doublers and W ilson lattice fermions.

# II. The e ective potential

I begin by de ning eight elds around which the discussion revolves

The ferm ion has two isospin components, for which ~ represents the standard P aulim atrices. The factor c is inserted to give the elds their usual dimensions. Its value is not particularly relevant to the qualitative discussion that follows, but one convention is take  $c = F = \frac{1}{2}$  ij where F is the pion decay constant and the condensate is in the standard ther.

Corresponding to each of these quantities is a physical spectrum. In some cases this is dominated by a known particle. There is the familiar triplet of pions around 140 MeV and the eta at 547 MeV. The others are not quite so clean, with a candidate for the isoscalar being the  $f_0$  (980) and for the isovector being the  $a_0$  (980). I will use that the lightest particle in the channel appears to be heavier than the .

Now consider an elective potential V (;~;  $\hat{r}$ ) constructed for these elds. I rst consider the theory with vanishing quark masses. In the continuum limit, the strong coupling constant is absorbed via the phenom enon of dimensional transmutation<sup>19</sup>, and all dimensionless quantities are in principle determined. In the full theory with the quark masses turned back on, the only parameters are those masses and

For the massless theory m any of the chiral symmetries become exact. Because of the anomaly, the transformation of Eq. (1), which mixes the and

elds, is not a good sym m etry. However avored axial rotations should be valid. For example, the rotation




Figure 3: The \som brero" potential representing the chiral lim it of m assless quarks.

For the massless theory, the elective potential is invariant under such rotations. In this two avor case, the consequences can be compactly expressed by going to a vector notation. I de ne the four component objects = (;~) and = (;~). The elective potential is a function only of invariants constructed from these vectors. A complete set of invariants is f<sup>2</sup>; <sup>2</sup>; g. This separation into two sets of elds is special to the two avor case, but makes the behavior of the theory particularly transparent.

I now use the experim ental fact that chiral sym m etry appears to be spontaneously broken. The m inim um of the e ective potential should not occur for all elds having vanishing expectation. We also know that parity and avor appear to be good sym m etries of the strong interactions, and thus the expectation value of the elds can be chosen in the direction. Tem porarily ignoring the elds , the potential should have the canonical \som brero" shape, as stereotyped with the form

Here v is the magnitude of the there expectation value for , and is a coupling strength related to the mass. The normalization convention mentioned below Eq. (4) would have v = F = 2. I sketch the generic structure of the potential in Fig. (3). This gives the standard picture of pions as Goldstone bosons associated with elds oscillating along degenerate minima.

Now consider the in uence of the elds on this potential. Considering small elds, I expand the potential about vanishing

Being odd under parity,




Figure 4: The e ect of  $M_1$  on the e ective potential. The ellipse in this and the following gures represents the minima of the e ective potential from Fig. (3). The dot represents where the ther settles.

The term s proportional to and generate m assess for the and particles. Since  $2 = 2 + 2^{-2}$ , the term contributes equally to each. Substituting (v;0) gives ( $\frac{2}{3} + 2^{-2}$ ; thus, the term breaks the {~ degeneracy. Here is where the observation that the is lighter than the comes into play; I have written a m inus sign in Eq. (9), thus making the expected sign of positive.

Now I turn on the ferm ion masses. I consider small masses, and assume they appear as a general linear perturbation of the elective potential

Here the four-component objects M<sub>1/2</sub> represent the possible mass term s. The normalization constant c appears in Eq. (4). The zeroth component of M<sub>1</sub> gives a conventional mass term proportional to -, contributing equally to both avors. The mass splitting of the up and down quarks appears naturally in the third component of M<sub>2</sub>, multiplying  $-_3$ . The term m<sub>2</sub> of Eq. (2) lies in the zeroth component of M<sub>2</sub>.

The chiral sym m etries of the problem now tell us that physics can only depend on invariants. For these I can take  $M_1^2$ ,  $M_2^2$ , and  $M_1$  M<sub>2</sub>. That there are three parameters is reassuring; there are the quark m asses (m<sub>u</sub>;m<sub>d</sub>) and the CP violating parameter . The mapping between these parameterizations is non-linear, the conventional de nitions giving

If one of the quark m asses, say m<sub>u</sub>, vanishes, then the dependence drops out. W hile this may be a possible way to remove any unwanted CP violation from the strong interactions, having a single quark mass vanish represents a ne tuning which is not obviously more compelling than simply tuning to zero. A lso, having m<sub>u</sub> = 0 appears to be phenom enologically untenable<sup>8;9</sup>.




Figure 5: The e ect of M  $_2$  on the e ective potential. The dots represent two places where the ther can settle.

I now turn to a physical picture of what the two m ass term s M<sub>1</sub> and M<sub>2</sub> do to the M exican hat" structure of the massless potential. For M<sub>1</sub> this is easy; its simply tilts the som breno. This is sketched in Fig. (4). The symmetry breaking is no longer spontaneous, with the tilt selecting the direction for

eld to acquire its expectation value. This picture is well known, giving rise to standard relations such as the square of the pion m ass being linearly proportional to the quark m ass $^{20}$ .

The e ect of  $M_2$  is more subtle. This quantity has no direct coupling to the eld; so, I must look to higher order. The  $M_2$  term represents a force pulling on the eld, and should give an expectation value proportional to the strength, h i /  $M_2$ . Once gains an expectation value, it then e ects

through the and terms of the potential in Eq. (9). The term is a function only of <sup>2</sup>, and, at least for small M<sub>2</sub>, should not qualitatively change the structure of the symmetry breaking. On the other hand, the term will warp the shape of our som brero. As this term is quadratic in this warping is quadratic. With positive, as suggested above, this favors an expectation value of lying along the vector M<sub>2</sub>, but the sign of this expectation is undetermined. This e ect is sketched in Fig. (5).

To sum m arize, the e ect of  $M_1$  is to tilt our M exican hat, while the e ect of  $M_2$  is to install a quadratic warping. The three parameters of the theory are the am ount of tilt, the am ount of warping, and, nally, the relative angle between these e ects. To better understand the interplay of these various phenomena, I now consider two speci c situations in m ore detail.

## III.Case A:M<sub>1</sub>jM<sub>2</sub>

First consider M<sub>1</sub> and M<sub>2</sub> parallel in the four vector sense. This is the situation when we have the two mass term s of Eq. (2) and no explicit breaking of avor symmetry. Speci cally, I take M<sub>1</sub> =  $(m_1; 0)$  and M<sub>2</sub> =  $(m_2; 0)$ . In this case the warping and the tilting are along the same axis.

Suppose I consider  $m_2$  at some non-vanishing xed value, and study the state of the ther as  $m_1$  is varied. The  $m_2$  term has warped the som brero,




Figure 6: Varying  $m_1$  at xed  $m_2$ . A rst-order phase transition is expected at  $m_1 = 0$ . This corresponds to =. The dots represent places where the ther can settle.

but if  $m_1$  is large enough, the potential will have a unique minimum in the direction of this pull. As  $m_1$  is reduced in magnitude, the tilt decreases, and eventually the warping generates a second local minimum in the opposite direction. As  $m_1$  passes through zero, this second minimum becomes the lower of the two, and a phase transition occurs exactly at  $m_1 = 0$ . The transition is rst order since the expectation of jumps discontinuously. This situation is sketched in Fig. (6). From Eq. (11), the transition occurs at  $m_u = m_d$  and =.

As m<sub>2</sub> decreases, the warping decreases, reducing the barrier between the twom inim a. Thism akes the transition softer. A small further perturbation in, say, the 3 direction, will tilt the som brero a bit to the side. If the warping is small enough, the eld can then roll around the preferred side of the hat, thus opening a gap separating the positive m<sub>2</sub> phase transition line from that at negative m<sub>2</sub>. In this way su cient avor breaking can remove the rst-order phase transition at =. If I start at = 0 with a mass splitting between the up and down quarks, an isoscalar chiral rotation to non-zero will generate just such a term.

#### IV.Case B:M<sub>1</sub>?M<sub>2</sub>




Figure 7: Varying m<sub>1</sub> at xed quark m ass splitting. A second order phase transition occurs when the tilting is reduced su ciently for a spontaneous expectation of  $_3$  to develop. The dots represent places where the ther can settle.

I now turn to a situation where M<sub>1</sub> and M<sub>2</sub> are orthogonal. To be speci c, take M<sub>1</sub> =  $(m_1; 0)$  and M<sub>2</sub> = (0; 0; 0; m), which physically represents a avor symmetric mass term m<sub>1</sub> =  $(m_u + m_d)=2$  combined with a avor breaking m =  $(m_u m_d)=2$ . Now M<sub>2</sub> warps the sombrero downwards in the 3 direction. A large m<sub>1</sub> would overcome this warping, still giving an ther with only having an expectation value. However, as m<sub>1</sub> decreases in magnitude with a xed m, there eventually comes a point where the warping dom inates the tilting. At this point we expect a new symmetry breaking to occur, with 3 acquiring an expectation value. This is sketched in Fig. (7). As 3 is a CP odd operator, this is a spontaneous breaking of CP.

To make this into a proper two dimensional phase diagram , I add an m  $_{3}$   $_{3}$




Figure 8: The (m  $_1$ ;m  $_3$ ) phase diagram for unequal mass quarks. The wavy line represents a rst-order phase transition ending at the second order dots. The light box on the right shows how the one avor diagram of Fig. (1) is extracted.

piece to the potential. This e ectively twists  $M_1$  away from being exactly perpendicular to  $M_2$ . This term explicitly breaks CP and can be expected to rem ove the transition, just as an applied eld rem oves the phase transition in the Ising model. We thus have a phase diagram in the  $(m_1;m_3)$  plane with a rst-order transition connecting two symmetrically separated points on the  $m_1$  axis. This is sketched in Fig. (8).

P hysically, the endpoints of this transition line are associated with the points where the respective quark m asses vanish. The phase transition occurs when the two avors have m asses of opposite sign. Simultaneously ipping the signs of both quark m asses can always be done by a avored chiral rotation, say about the  $_3$  axis, and thus is a good symmetry of the theory.

Taking one of the avors to in nite mass provides a convenient way to understand the one avor situation. As sketched in Fig. (8), this represents looking only at the vicinity of one endpoint of the transition line. In terms of the light species, this transition represents a spontaneous breaking of CP with a non-vanishing expectation for  $i_5$ . In the lattice context the possibility of such a phase was mentioned brie y by Sm  $it^{17}$ , and extensively discussed by A oki and G ocksch<sup>18</sup>.

VI. Im plications for W ilson's lattice ferm ions


The Lagrangian for free W ilson lattice ferm ions is 16

Here j labels the sites of a four dimensional hyper-cubic lattice, runs over the space time directions, and e is the unit vector in the 'th direction. I have scaled out all factors of the lattice spacing. The parameter K is called the hopping parameter, and r controls the strength of the so called W ilson term," which separates o the fam ous doublers. I have also added an unconventional m<sub>2</sub> type m ass term to connect with my earlier discussion.

Being quadratic with only nearest neighbor couplings, the spectrum is easily found by Fourier transform ation. Conventionally, a massless ferm ion is obtained by taking  $m_1 = 8K$  r, but there are other places where this original particle is massive while other doublers from the naive theory become massless. At  $m_1 = 8K$  r one such species does so, at each of  $m_1 = 4K$  r there are four massless doublers, and at  $m_1 = 0$  I and the remaining 6 of the total 16 species present in the naive theory.

I conjecture that these various species should be thought of as avors. When the gauge elds are turned on, then the full chiral structure should be a natural generalization of the earlier discussion. Thus near  $m_1 = 8K r I$  expect a rst-order transition to end, much as is indicated in Fig. (1). This may join with num erous other transitions at the interm ediate values of  $m_1$ , all of which then nally merge to give a single rst-order transition line ending near  $m_1 = 8K r$ . The situation near 0 and 4K r involves larger num bers of avors, and properly requires a more general analysis. O ne possible way the lines could join up is shown in Fig. (9a).

For two avors of W ilson ferm ions, if we look near to the singularity at 8K r we should obtain a picture sim ilar to F ig. (2). However, further away these lines can curve and eventually end in the structure at the other doubling points. One possible picture is sketched in F ig. (9b).

### V III. Sum m ary and conclusions

I have presented a physical picture of the parameter in the context of an e ective potential for spin-zero bilinears of quark elds. I have argued for a rst-order transition at = when all avors are degenerate, and shown how avor breaking can remove this transition.

A number of years ago Tudron and I<sup>23</sup> conjectured on the interplay of the con nement mechanism with , and speculated that con nement might make unobservable. Recently Schierholz<sup>24</sup> argued that keeping con nement in the continuum limit may drive the theory to = 0. The connection with present discussion is unclear, but the symmetries seem to indicate no obvious problem with being observable. Furtherm ore, the fact that the is lighter than particle candidates in the channel suggests that there indeed must be the term of Eq. (9), and it is this term which is directly responsible for the physical dependence on .
