# Extended NJL M odel for light and heavy m esons without q-q thresholds

#### A bstract

We consider the NJL model as an elective quark theory to describe the interaction which is responsible for the quark avor dynamics at intermediate energies. In addition to the usual ultraviolet cut-o which is necessary since the model is non-renormalizable, we also introduce an infrared cut-o which drops of the unknown confinement part of the quark interaction, which is believed to be less in portant for the avor dynamics. The infrared cut-of eliminates all q-q thresholds, which plague the application of the usual NJL model beyond low-energy pion physics. We apply this two (cut-of prescription to the extended NJL model with chiral and heavy quark symmetries proposed recently by us. We not a satisfactoring description even of the heavy mesons with spin/parity  $J^P = (0^+; 1^+)$ . Furthermore, the shape-parameters of the Isgur-W ise function are studied as a function of the residual heavy meson mass.

### 1 Introduction

The NJL model has proved quite successful in describing the low-energy meson physics [1]. Its successes stem from the fact that it embodies chiral symmetry and its spontaneous breaking. Unfortunately, the model is not renormalizable. This necessitates the introduction of an ultraviolet , indicating the range of validity of the model. Futherm ore the model does not con ne the quarks, and as a consequence the model su ers from unphysical q-q thresholds, which severely restrict the applications of the model. The lack of quark con nement in NJL-type models is related to the fact, that the very infrared region of the gluon-mediated quark interactions is not adequately incorporated. In fact, such models are usually constructed to describe the low-energy properties of m esons, which are assumed to be dominated by the quark avor dynamics at intermediate scales, say between a con nem ent scale of a few hundred M eV and a scale of about 1 G eV. The success of these models is related to the very fact, that chiral symmetry is dynamically broken just in this energy region, and that the picture of (constituent) quarks interacting with mesons may be a reasonable approximation to strong interactions. Since on the other hand this picture must be wrong for very low scales where con nement becomes de nitely important, one better excludes the infrared region explicitly by introducing an IR cut-o as long as one has no de nite suitable way of introducing con nement<sup>1</sup>. We will show that the problems connected with unphysical quark-antiquark thresholds are then autom atically removed.

As an illustration we apply the two (cut-o prescription to the recently proposed extended NJL m odel with both chiral sym metry for the light quarks m  $_{q}$ OCD and heavy quark symmetries OCD [8]. There, the usual low-m om entum expansion (LME) has been for the heavy avors mo applied to analyze the quark determ inant, and reasonable results have been obtained for nearly all heavy meson observables. However, for the slope-parameter of the Isqur-W ise function we found a sm aller value than expected, and the heavy meson states with spin/parity  $J^P = (0^+; 1^+)$  could not be well described. It seems therefore necessary to study the in uence of the external momenta m ore carefully, which is however not under control as long as the quark model under concern has no explicit im plementation of con nement. In this case, for meson momenta larger than the (constituent) quark masses, the decay of a meson into a real quark-antiquark pair becomes kinem atically allowed, and one runs into trouble with unphysical imaginary parts due to quarkantiquark thresholds. The LME circum vents this problem; in this way the low-energy theorems in the light m eson sector can be recovered (see e.g. [1]), while in the heavy m eson sector the LM E seem s to be insu cient since a smooth dependence on external m om enta is not always found, i.e. the LME does not converge for momenta beyond thresholds.

We will st present the regularized NJL model and discuss the physical implications of the infrared cut-o on the spontaneous breaking of chiral symmetry. For this purpose we study the gap-equation that describes the dynamical generation of the constituent quark mass in dependence of the infrared cut-o. Then we apply the regularization method to the extended NJL model with chiral and heavy quark symmetries [8]. Them ass spectrum of heavy mesons is found, which indeed develops a smooth dependence on external momenta { even beyond the apparent thresholds { and leads to reasonable predictions. As an application, we nally discuss the slope and curvature of the Isgur-W ise function for nite external momenta and compare to the phenomenological ndings.

## 2 Implications of an infrared cut-o in the NJL model

The NJL model rewritten in bosonic degrees of freedom (see eq. (6) below) leads to an elective meson action where besides meson mass terms the quark determinant Trln iD=contributes. Here iD= is the D irac operator of the quarks in the presence of meson elds. The real part of the quark determinant is a diverging object. Using a propertime regularization, this quantity becomes (after continuation to Euclidean space)

Here is the before-mentioned ultraviolet cut-o. Furthermore we have introduced here also an infrared cut-o, which takes into account that our model is not applicable in the very low-energy regime due to the lack of connement. This infrared cut-o is the new feature of the present analysis. All previous applications of the NJL model have exclively used the limit! O. A simple way to understand that the suggested method indeed removes the quark-thresholds is to consider the simplest Greens function obtained from eq. (1), namely the exclive light quark propagator. In Euclidean space one obtains for the denominator

O bviously, the form er pole at  $k_E^2 = k^2 = m^2$  is rem oved by the infrared cut-o . We consider as an adjustable parameter which may be interpreted as the scale up to which the quarks have been integrated out. Especially, at = (which is the UV cut-o of the model) the contribution of the quark determinant vanishes by construction, and we recover the original interaction of (current) quarks with non-dynamical meson elds, where chiral symmetry is not (yet) broken. Note that the non-renormalizable NJL model is dened only after the regularization method has been specified, and in this sense the ultraviolet cut-o and the infrared cut-o together with the proper-time regularization are parts of the denition of the model.

In the NJL model [1] the spontaneous breaking of chiral symmetry is realized dynamically through a non-vanishing VEV for the scalar eld (chiral radius) which is determined by the following gap equation

This equation de nes the constituent quark mass mass an implicit function of the scale for given values of the remaining model parameters. Here  $[;x;y] = {R_y \atop x} dt exp(t) t^{-1} denotes the incomplete Gamma function.$




Figure 1: The light quark constituent mass m following from the gap-equation as a function of the scale for the chiral lim it m $_0$  = 0. The bold vertical line denotes the separation of the chirally symmetric and chirally broken phase. The dashed vertical line denotes the chosen separation of the IR (con nement) region at a scale 300 MeV.

For a numerical discussion we use the coupling constant and the cuto from ref. [8] as G  $_1$  =  $5.25~\rm G\,eV$   $^2$  and =  $1.25~\rm G\,eV$ . Fig. 1 shows the solution of the gap equation m as a function of the IR scale in the chiral limit (m  $_0$  = 0). For scales < 0.3 G eV the order parameter m of the chiral symmetry breaking is almost independent of , while it decreases rapidly when exceeds a value of 0.3 G eV and vanishes at a critical value  $_{\rm C}$  given by

For > chiral symmetry is restored. Consequently, in order to include the e ect of the spontaneous breaking of chiral symmetry, it is su cient to consider the quark avor dynamics down to scales of about 300 MeV. At lower values of one expects essential e ects of the IR singular gluon propagator, leading to a modiled gap- (or in this case Schwinger-Dyson-) equation and a presumably connect quark propagator. Clearly, this question cannot be addressed within the NJL model and is outside the scope of the present paper.

#### 3 Extended NJL model

In [8] we have presented an extension of the NJL model which combines chiral symmetry for light quarks with the heavy quark symmetries. In the heavy mass limit, heavy meson elds are organized in spin symmetry doublets [4]

with v being the heavy quark velocity. Here  $^{5}$  and denote the pseudoscalar and vector eld of the  $J^{P} = (0;1)$  multiplet, and  $^{5^{0}}$  are the heavy scalar and axial vector eld of the

 $J^P = (0^+; 1^+) \text{ multiplet.}$ 

A first introducing light and heavy m eson elds, the lagrangian of the extended N JL m odel can be rewritten as [8]

with iD= being the light quark determ inant:

which contains the light scalar, vector and axial-vector meson elds (;V;A) and heavy meson elds (H;K). N<sub>c</sub> = 3 is the color factor, m<sub>0</sub> is the current mass matrix of light quark avors and G<sub>1</sub>, G<sub>2</sub>, G<sub>3</sub> are independent coupling constants of four{quark interactions allowed by chiral and heavy quark symmetries (dim G<sub>1;2;3</sub> = mass<sup>2</sup>). For the light octet of Goldstone bosons we use the common non{linear representation = exp(i = F) where =  $^{a}$   $^{a}$  = 2 and F is the bare decay constant. The induced (axial-)vecotr elds V = i=2(@ y + y@), A = i=2(@ y y@) arise from a chiral rotation of the quark elds. Finally, the light scalar eld achieves a non {vanishing vacuum expectation value indicating the spontaneous breaking of chiral symmetry (see eq. (3) above). For further details we refer the reader to ref. [8].

For heavy m esons with the residual external m om entum v p the self-energy contribution from the quark loop, together with the constant terms in eq. (6), determines the residual masses M = M m<sub>Q</sub> and the renormalization factors Z

where the upper sign (+) is for the H - elds and the lower sign ( ) for the K - elds, indicating the mass splitting of the two parity conjugated states due to the broken chiral symmetry for m  $\in$  0. The function  $I_3$  which diverges linearly with the UV cuto is represented by the proper-time integral

with Erf[a] =  $\frac{R_a}{0}$  dx exp(  $x^2$ ) being the Gaussian error function.

Finally, the Isgur-W ise function is calculated from the quark determinant by inserting an arbitrary current for a weak transition between heavy quarks of dierent velocity Q  $_{\rm v^0}^0$  Q  $_{\rm v}$  with the result

The function  $I_5$  of the momentum transfer! =  $v^{-1}$  vis expressed through the parameter integral

The normalization condition (1) = 1 comes out naturally as a W and identity relating (8) and (11).

In ref. [8] we have discussed the Isgur-W ise function in the LME, which refers to the special case v = 0. In this case one has I(!) =  $2I_2 r(!)$  with

However, due to the introduced IR cut-o for the quark determ in ant (1) we can give up the LME around v = 0 and use eq. (11) for any value of v = 0.

Concerning the mass equation for the heavy mesons (8), let us point out that for v p > m the integral  $I_3$  generates non-physical behaviour in the IR region ( ! 0, s! 1). This is easily understood, since through the optical theorem this is connected with an imaginary part rejecting a decay of a meson into real quarks which should be absent in a conjning theory. For practical purposes for su ciently small values v p < m, an expansion in v p (LME) might be succient [8]. For the general case one better retains a nite value of which (in order to be on the safe side) we will chose in the following as = 300 MeV. The basic assumption of chiral quark models like the one presented here is then to assume that the IR region of the quark dynamics excluded by the cut-o might be unimportant for the low-energy properties of mesons.

## 4 Heavy meson spectrum and Isgur-Wise function




Figure 2: a) The behaviour of the residual masses M  $_{\rm H}$  (bold line) and of M  $_{\rm K}$  (thin line) as a function of 1= $G_3$  from eq. (8) for an infrared cut-o = 300 M eV compared to the LM E with = 0 (dotted lines).

Through eq. (8) the coupling constant  $G_3$  is related to the heavy m eson m ass spectrum. For the light quark m asses we will use the values  $m_u = m_d = 300 \, \text{M}$  eV and  $m_s = 510 \, \text{M}$  eV. Let us rst compare the numerical results for eq. (8) in contrast to the LME with = 0 in Fig. 2a. We observe significant differences between the two approaches for residual meson masses M > m. Furthermore, we can study the -dependence of the heavy meson masses (see Fig. 2b). For


300 M eV we observe a reasonable mass-splitting between the parity conjugated elds H ; K of about 200 (300 M eV .

In Table 1 we present the results in comparison with the LM E, including the model results for the weak decay constant of the heavy meson given as [8]  $^{P}\overline{M_{H}}$   $f_{H}=^{P}\overline{Z_{H}}=G_{3}$ :

Compared to the LME, the results for the heavy meson spectrum are improved, in the sense that they are leading to realistic masses even for the states with  $J^P=(0^+;1^+)$ , while the results for  $J^P=(0^+;1^+)$  are { as expected { only slightly e ected. Note that all masses are now rather smooth functions of the coupling constant, which was not the case for the LME with =0. The values for the weak decay constant lie on the lower side of the range obtained from lattice QCD [10],  $f_B=170-55~G~eV$ . The light avor dependence can be studied by considering the SU (3) mass-splitting, which in our case is induced by dierent light quark masses m  $_U$   $f_B$  masses. Experimentally one has M  $_B$  M  $_B$ 

Let us now concentrate on the Isgur-W ise function. In ref. [12] long-distance ( $1=m_Q$ ) and short-distance ( $_s$  ( $m_Q$ )) corrections have been estimated, which relate the Isgur-W ise function (!) to the experimentally accessible form factor(s) F ( $_q^2$ ). From this one of the CKM matrix elements has been estimated as  $_q^1$   $_0^2$ 

The result of the N JL m odel gives for dierent values of  $v-p=-M_{\rm H}$


The dependence on the external momentum is obvious. Values between M  $_{\rm H}$  = 300 MeV and 400 MeV reproduce the phenomenological situation, and the values of M  $_{\rm H}$ , and c $_{\rm 0}$  are positively correlated. Note that the inclusion of a nite curvature for the Isgur-W ise form factor is in portant in order to obtain an accurate to the data for the B! D' decays which were used for the extraction of  $y_{\rm cb}$  [14].




Figure 3: The behaviour of the shape parameters of the Isgur-W ise function, and  $^{0}$ (1) as functions of the IR scale  $^{2}$  for a) v p = 200 M eV and b) v p = 400 M eV. The vertical line denotes the choice = 300 M eV.

Finally, we like to investigate the -dependence of the shape parameters and  $^{0}$ (1) which is of course rather stable for v p m . For v p > m , our choice for the IR cut-o scale is justiled, since for < 300 M eV the predictions for and  $c_0$  become unreliable. This is illustrated in Fig. 3 for the two cases v p = 200 M eV and v p = 400 M eV, respectively.

## 5 Sum m ary

In this letter we have shown how the NJL model, which is phenomenologically successful at low meson energies, can be extended to higher energies. In particular we have shown that the appearance of quark thresholds, which plagues the application of the NJL model to higher external momenta can be avoided. This has been accomplished by introducing a nite adjustable IR scale when integrating out the quarks. We have found that for the spontaneous breaking of chiral symmetry the momentum regime between = 300 MeV and 125 GeV is responsible. Retaining a nite value for the IR scale (the choice 300 MeV has been favored by the data) prevents the quark determinant to suer from unphysical quark—antiquark thresholds, which would otherwise occur in chiral quark models without explicit quark con nement.

Including heavy quarks in the in nite mass limit one then obtains a smooth dependence on the external momenta for the heavy meson observables, and a reasonable mass spectrum is found

even for the heavy  $J^P = (0^+;1^+)$  spin-sym m etry multiplet. For the weak decay constants we found values of the order of  $f_B = 140$  M eV .

For the shape param eters of the Isgur-W ise function we have found a non-negligible dependence on external momenta, such that the value of the slope parameter—is positively correlated to the value of M  $_{\rm H}$ . For M  $_{\rm H}$  = 300 (400) M eV we found = 0.84 (0.94) which is consistent with the experimental and theoretical situation. We also give an estimate for the curvature at the non-recoil point,  $c_0$  =  $^{00}(1)$ =2 0.49 (0.72). At intermediate scales > 300 M eV the shape parameters develop only a weak dependence on .

In future work our analysis can be helpful also for the investigation of higher resonances, like the heavy  $J^P = (1^+; 2^+)$  multiplet, within NJL-type quark models, where the dependence on external momenta is assumed to be even more important. Also the description of the higher excited light avor states within the NJL model might be considerably improved. It can also be interesting to compare the approach presented here, with the results obtained in other relativistic quark models, which explicitly include connement in a heuristic way.
