## Goldstino Couplings to Matter

#### A bstract

A nonlinearly realized supersymmetric action describing the invariant couplings of the Goldstino to matter is constructed. Using the Akulov-Volkov Lagrangian, any operator can be made part of a supersymmetric invariant action. Of particular interest are interaction terms which include the product of the Akulov-Volkov Lagrangian with the ordinary matter Lagrangian as well as the coupling of the product of the covariant derivative of the Goldstino eld to the matter supersymmetry current. The later is the lowest dimensional operator linear in the Goldstino eld. A Goldstino Goldberger-Treim an relation is established and shown to be satisted by the elective action.

## 1 Introduction

If supersym m etry (SUSY) is to be realized in nature, it must be as a broken sym m etry. The breaking m echanism which maintains the perponderance of the dynam ical constraints of the sym m etry and hence is theoretically most attractive, is a spontaneous one. Indeed many of the currently investigated attempts to construct realistic models of electroweak sym metry breaking incorporating SUSY use spontaneous supersym metry breaking in one form or another. This includes both the so-called hidden sector [1] and visible sector classes of models [2].

A general consequence of the spontaneous breakdown of global supersymmetry is the appearance of a Nambu-Goldstone ferm ion, the Goldstino [3]; [4]. The leading term in the action describing its self-dynamics at energy scales below  $\frac{4}{}$ , where  $\frac{1}{}$  is the Goldstino decay constant, is uniquely xed by the Akulov-Volkov elective Lagrangian [3] which takes the form

Here () is the Goldstino Weyl spinor eld. This elective Lagrangian provides a valid description of the Goldstino self-interactions independent of the

particular (non-perturbative) m echanism by which the SUSY is dynam ically broken [5]. M oreover, if the spontaneously broken supersymmetry is gauged, with the erstwhile Goldstino degrees of freedom absorbed to become the lon-ditudinal (spin 1/2) modes of the gravitino via the super-H iggs mechanism, then the action formed from the Akulov-Volkov Lagrangian also describes the dynamics of those modes. This is completely analogous to using the gauged non-linear sigma model to represent the dynamics of the longitudinal degrees of freedom of the Wand  $\rm Z_0$  vector bosons independent of the particular mechanism employed to break the electroweak symmetry.

Nonlinear realizations of symmetry transformations allow a model independent analysis of the dynamical consequences of spontaneous symmetry breaking using the Nambu-Goldstone degrees of freedom. This is true whether the part of the theory responsible for the symmetry breaking is strongly or weakly interacting. If weakly interacting, such as in the standard electroweak model with a light Higgs scalar, then the low energy physics can be directly calculated in perturbation theory. On the other hand, if the symmetry breaking sector of the model is strongly interacting, then explicit direct calculations of dynamical consequences can prove quite dicult. Since there are many such models of SUSY breaking presently studied, it is worthwhile to determine, in a completely model independent way, the various consequences

of the supersym metry breaking.

U sing non-linear realizations of supersymm etry for both the Goldstino and non-Goldstino degrees of freedom, Samuel and Wess [6] constructed supersymm etric invariant couplings of the Goldstino to matter. Their construction entailed a somewhat elaborate procedure in which the Goldstino eld and all matter elds are promoted to become super elds whose lowest components are the ordinary elds them selves and whose higher components involve the product of Goldstino elds and derivatives of the lowest components. For the special case of the Goldstino promoted super elds, the or components also contain the Goldstino decay constant as an additive component. Using these super elds, every ordinary operator can then be cast as part of a manifestly supersymmetric action. While this procedure is elegant and complete, it does require the introduction of a considerable amount of additional (super) structure.

In this paper, we present an alternate construction of a non-linearly realized supersym m etric invariant action. Our procedure works directly with the ordinary (component) Goldstino and matter elds and does not require the introduction of entire super eld structures. Thus in a simple and straightforward manner, we can make any ordinary operator part of a manifestly supersymmetric action. A fter introducing the non-linear SUSY transform a-

tions and covariant derivative, we construct the SUSY (and internal symmetry) invariant action terms using the special properties of the Akulov-Volkov Lagrangian. We focus on two particular interaction terms. One involves the coupling of the Akulov-Volkov Lagrangian to the ordinary matter action. Once the ordinary matter action is appropriately normalized, the coecient of this term is xed solely by the Goldstino decay constant. Another action term, which is the lowest dimensional operator linear in the Goldstino eld, involves the coupling of its (SUSY covariant) derivative to the ordinary matter supersymmetry current. This coupling is then used to show that a Goldberger-Treim an relation [7] associated with the spontaneous supersymmetry breaking is indeed satis ed.

## 2 Nonlinear SUSY Transform ations

The selfdynam ics of the Goldstino can be encapsulated in the Akulov-Volkov Lagrangian Eq. (1:1). The supersymmetry transformations are nonlinearly realized on the Goldstino eld by

and hence the associated action

The supersym metry algebra can also be nonlinearly realized on the matter (non-Goldstino) elds, generically denoted by  $_{\rm i}$ , where i can represent any Lorentz or internal sym metry labels, as

This is referred to as the standard realization [6]. Form ing the SUSY Ward identity functional dierential operator

one readily establishes the SUSY algebra

As usual, the space-time translations are given by

Under the non-linear SUSY standard realization, the derivative of a matter  $\,$  eld transforms as

In order to elim inate the second term on the RHS and thus restore the SUSY covariance, we introduce a SUSY covariant derivative which transforms analogously to  $_{\rm i}$ . To achieve this, we note that

We are thus led to de ne the non-linearly realized SUSY covariant derivative as

In addition to the SUSY and space-time translations, we can also de ne R-transform ations under which the Goldstino eld transforms as [8]

Form ing the R-transform ation W and identity functionaldi erential operator

it is readily established that the algebra

holds independent of form of <sup>R</sup> (!) <sub>i</sub>. The action form ed from the Akulov-Volkov Lagrangian is invariant under R-sym m etry, supersym m etry and space-time translations. Moreover the improved currents associated with these sym metries have been shown [8] to form the components of a supercurrent [9]. Thus all conservation laws and anomalies are derivable from the supercurrent conservation law and the generalized trace anomaly [10][11].

Since the Goldstino eld transforms as a singlet under any internal sym-metry transformation,  $^{G}$  () = 0 =  $^{G}$  () \_, the Akulov-Volkov action is also invariant under internal sym metry transformations:

where parametrizes the transform ation. Denoting the internal sym m etry matter eld transform ation as  $^{\rm G}$  ()  $_{\rm i}$ , then the W ard identity functional di erential operator characterizing the internal sym m etry transform ation is

Note that if the internal sym metry is gauged, the non-linearly realized SUSY, gauge covariant derivative, Eq. (2:14), is replaced with

where D  $_{i}$  is the ordinary gauge covariant derivative.

## 3 Invariant Actions

We now construct actions containing the Goldstino and matter elds which are invariant under both SUSY and internal symmetry transform ations. The A kulov-Volkov action is one such term which contains the Goldstino kinetic term and self couplings. Using the A kulov-Volkov Lagrangian, we can form SUSY invariant actions out of any Lorentz and internal symmetry singlet operator O = O (;D). To achieve this, we note that under the non-linear standard realization of SUSY given by Eqs. (2:1;2:5;2:10), such an operator transform s as

with  $C_{\circ}$  a constant, is SUSY invariant:

Since  $L_{AV}$  is de ned so as to contain the additive constant term  $\frac{1}{2^{-2}}$  (or equivalently, the detA starts with the identity), the action  $I_0$  includes the piece  $C_0$   $^R$   $d^4xO$  (x) for any operator O.

One special case is a orded by using the internal symmetry invariant ordinary matter Lagrangian L (;D) where all derivatives are replaced by SUSY covariant derivatives. Under SUSY

Note that in the absence of Goldstino elds, this action reduces to the ordinary matter action  $I = {R \atop } d^4xL$  (;0) so  $I_{LL}$  contains the ordinary matter action as well as couplings of the Goldstino to matter. Thus once the normalization of the ordinary matter action is xed, so are its couplings to the Goldstino eld. As such this term requires no additional independent coupling constant. Further note that using the non-linear realization, various

higher dimensional operators such as the electron anomalous magnetic moment operator, can also be made part of a SUSY invariant action. On the other hand, such a term cannot be included in a SUSY invariant action if the supersymmetry is linearly realized [12].

Both  $I_{A\,V}$  and  $I_{L\,L}$  depend on ; only through A and thus only through the bilinear combination (and derivatives). While, by using the Goldstino eld, any Lorentz and internal symmetry singlet can incorporated into a supersymmetric invariant action, them ost natural setting is to consider those pure matter actions which allow for linear realizations of the supersymmetry. In that case, using the associated internal symmetry singlet supersymmetry currents Q (;@) and Q \_(;@), we can construct another invariant action whose Goldstino dependence is odd in ; and in fact starts o as linear in @. Letting Q = Q (;D) and Q \_ = Q \_(;D) be the matter supercurrents where all space-time derivatives are replaced by non-linearly realized SUSY covariant derivatives, it follows that under the standard realization of SUSY that

When used in conjunction with the SUSY transformations:

Using the form of the Akulov-Volkov Lagrangian and the SUSY covariant derivative, we see that

$$I_Q = C_Q d^4x [0 Q (;0) + Q_(;0) 0 -] + ::: (3.15)$$

which is coupling linear in the Goldstino eld. In fact, this mass dimension 6 operator contains the smallest power of coe cient of the various couplings of the Goldstino to matter. The appearance of the coupling of the Goldstino eld to the divergence of the matter supersymmetry current is certainly anticipated. In fact, it is reminiscent of the situation in spontaneously broken thiral symmetry where the Nambu-Goldstone pion couples derivatively to the spontaneously broken matter chiral symmetry current.

Combining the various term s, we secure the SUSY and internal sym m etry invariant action

# 4 Goldberger-Treim an Relation

As a consequence of their N am bu-G oldstone nature, the coupling of the Goldstino to matter is constrained to satisfy certain general relationships. One such constaint is the analog of the Goldberger-T reim an relationship [7] familiar from pion physics and spontaneously broken chiral symmetry. When applied to spontaneously broken supersymmetry, the analogous relation ties form factors of the supersymmetry and Goldstino currents at zero momentum transfer to the Goldstino decay constant and mass dierences between matter boson and fermion states. The Lorentz decomposition of the supersymmetry current Q taken between arbitrary single particle (scalar) Bose and (spin 1/2) Fermi states,  $\dot{p}_1$ ; B > and  $\dot{p}_2$ ; F >, of masses  $m_B$  and  $m_F$  and carrying 4-momenta  $p_1$  and  $p_2$ , respectively, takes the form

where  $q = (p_1 p_2)$  and  $k = (p_1 + p_2)$  and the ferm ion spinors satisfy

Conservation of the supersym m etry current, Q = 0 then relates the various form factors as

Since the massless Goldstino directly couples to the supersymmetry current, some of these form factors are singular in the  $q^2$ ! 0 limit. Thus before taking this limit, we need to include the elect of the massless Goldstino pole. This pole is rejected in the non-vanishing matrix element of the supersymmetry current between the vacuum and single Goldstino state, jq; >, of 4-momentum q which is given by

where 1 is the Goldstino decay constant.

It follows that the combination  $Q = \frac{1}{i} = -has vanishing matrix element between the vacuum and single Goldstino state. The matrix element of this combination taken between the single Bose state and single Fermion state can then be Lorentz decomposed just as in Eq. (4:1) where now the various form factors are all non-singular in the <math>q^2$ ! 0 limit.

Finally, the Goldstino current  $j^{\text{G}}$  is de ned through the Goldstino  $% \left( 1\right) =\left( 1\right) +\left( 1\right) +$

Taking its matrix element between the Bose and Fermi states leads to the Lorentz decomposition

and thus

Since the form factors of the combination Q  $\frac{1}{i}$  \_ - are regular as  $q^2$ ! 0, we see on comparison of Eqs. (4:1) and (4:7) that the  $A_1(q^2)$  form factor is regular while the  $A_3(q^2)$  form factor is singular. The singular piece is given by

Sustituting into Eq. (4:3) and taking the  $q^2$ ! 0 lim it we secure the Goldstino Goldberger-Treim an relation

To establish that the e ective action Eq. (3:16) satis es this Goldstino Goldberger-Treim an relation, we note that a Noether construction of the conserved supersymmetry current starts out as

while the Goldstino eld equation Eq. (321) provides the identication of the Goldstino current as

For the \m atter" supersym m etry current we use [9] [13]

where A () are the Bose (Ferm i) elds creating (destroying) the Bose (Ferm i) states in the matrix elements of the Lorentz decomposition of the supersymmetry and Goldstino currents. The matrix elements are readily computed yielding

and the Goldberger-Treim an relation, Eq. (4:9) is indeed satis ed.
