#### Abstract

W e study oc color-octet contribution to B! ( ${ }^{9}$ )X .W hen this contribution is included, the theoretical predictions for the branching ratios become in $m$ uch better agreem ent $w$ ith the experim ent. This $m$ echanism also enhances the partial rate asym $m$ etries by about a factor of ve. The inclusive ( ${ }^{0}$ ) resulting from b ! $\mathrm{d}+$ ghon can have asym $m$ etry around a few percent whereas those from b! s+ gluon has it around $4 \quad 10^{4}$. The asym m etry in the form erm odes should be observable, to a signi cance of 3 , w ith about


 (1) 10$) \quad 10^{8} B$ mesons.Recent experim entaldata from the Tevatron indicate that if only $\infty c$ color-singlet contribution is included the ${ }^{0}$ production rate at large transverse $m$ om entum predicted by Q CD is about a factor of 30 below the experim entaldata. It has been show $n$ by $B$ raaten and $F$ lem ing [ī1] 1 and C ho and Leibovich the experim ental data can be explained. C olor-octet also has signi cant contribution to the
production at the Tevatron [/].]. In this paper, we show that, if this mechanism is indeed the correct one, it also has im portant implications for ( ${ }^{\circ}$ ) decays of $B m$ esons, especially for $C P$ violating particle-antiparticle partial rate asym $m$ etry. The point is that the penguin graph leads to an appreciable branching ratio ( ${ }^{\prime} 10^{2}$ ) forb! $s+$ ghon. $N$ ow, in a purely perturbative approach, the form ation of ( ${ }^{\circ}$ ) from the gluon is severely suppressed. On the other hand, if B raaten et al.'s $m$ echanism tends to enhance the rate for the color-octet (oc or ghon) to form the ( ${ }^{9}$ ) then it can have im portant consequences for direct CP violation in inclusive $B$ decays, via $B!\left({ }^{9}\right)+X$. This mechanism also enhances the branching ratios in these decays so that they are $m$ uch closer to the experim entally $m$ easured ones.

In the $S M$ the am plitudes for $B$ decays are generated by the follow ing e ective H am iltonian:

$w$ here the superscripts $u ; c$; $t$ indicate the intemalquarks, $f$ can be $u$ or cquark. $q$ can be d or s quark depending on if the decay is a $S=0$ or $S=1$ process. The operators $O{ }_{i}^{q}$ are de ned as

O_{1 ; 2}$ are the tree level and QCD corrected operators. $O_{36}$ are the strong ghon induced penguin operators, and operators $\mathrm{O}_{710}$ are due to and Z exchange, and $\backslash \mathrm{box}$ " diagram sat loop level. The W C's
$C_{i}^{f}$ are de ned at the scale of $\quad m_{b}$. A though the $W C$ 's have been evaluated to the next-to-leading order in QCD [13, the $m$ atrix elem ents which were evaluated using NRQCD to the leading order. W e give the coe cients below form ${ }_{t}=176 \mathrm{GeV},{ }_{4}=0.2 \mathrm{GeV}$, and $=\mathrm{m}_{\mathrm{b}}=5 \mathrm{GeV}$,

where q is the m om entum carried by the virtual gluon in the penguin diagram s . W hen $q^{2}>4 \mathrm{~m}^{2}, \mathrm{G}\left(\mathrm{m} ; \mathrm{q}^{2}\right)$ becom es complex. In our calculation, we will use $\mathrm{m}_{\mathrm{u}}=5 \mathrm{MeV}$ and $\mathrm{m}_{\mathrm{c}}=1: 35 \mathrm{GeV}$. A though there is considerable uncertainty in the e ective values of these $m$ asses, especially so for $m_{u}$, our results are rather insensitive to the num erical values of these $m$ asses.

U sing factorization approxim ation, we have

If the color－octet contribution is neglected，the branching ratios for B！（ ${ }^{0}$ ）X are too sm all com pared w th the experim ental values．In order to reproduce the experim ental data，the num ber of colons $N$ is traditionally treated as a free param eter to param etrize the non－factorizable and the color－octet contributions．The e ective num ber of colors N is then determ ined from B ！（ ${ }^{9}$ ）X to be close to 2 ［⿶凵1］．T his does not really identify where the new contributions com e from．H ow ever，if the color－octet e ects identi ed above have signi cant contributions，onem ay not need to treat N as a free param eter； $\mathrm{N}=3$ as given by QCD may work ne．The color octet mechanism with $N=3$ indeed im proves the situation
 their results．In their work the penguin contributions are not included．W hen penguin contributions are included，they have im portant im plications for direct CP violation in particle－antiparticle partial rate asym $m$ etries in these decays although their e ect on the absolute rates is minim al．

In order to obtain non－zero partial rate asym $m$ etry，it is necessary to have non－zero CP violating phases and CP conserving strong phases due to the nal state rescattering for di erent am plitudes．In the above case，the CP violating phases are provided by the phases in the CKM m atrix elem ents $\mathrm{V}_{\mathrm{cb}} \mathrm{V}_{\mathrm{cs}}$ and $\mathrm{V}_{\mathrm{tb}} \mathrm{V}_{\mathrm{ts}}$ ．W ew ill use the W olfenstein param etrization such that the elem ent $V_{u b}$ is given by $J_{u b} \dot{e}^{i}$ ．For the strong phases，we will use the phases generated at the quark level by appealing to quark－hadron duality．This should be at least a good indication for the size of the phases $[\bar{\eta} \uparrow$ ． N aively the strong phases are generated by exchanging $u$ and $c$ quarks in the loop．H ow ever，CP T theorem dictates that the phases generated by the c quark in the loop not to contribute to the rate asym $m$ etry for
 penguin $W$ C＇s $\mathrm{C}_{7 ; 8 ; 9 ; 10}$ contribute to the strong phases．It is，how ever，interesting to note that if the color－octet am plitude is neglected，the strong penguin do not generate non－zero strong phases because the com bination $C_{3}^{\mu}+C_{4}^{\mu}=N+C_{5}^{\mu}+C_{6}^{\mu}=N$ in $A_{1}$ is identically zero as can be seen from Eq⿹ㅓㄱ．The leading non－zero strong phases are then generated by electrow eak penguin and are therefore sm all．If these phases are the only ones，the partial rate asym m etry is
predicted to be very sm all as shown in Figure 1 ［ī color－octet contributions have so far been included as discussed before．If the color－octet contribution tums out to be signi cant，the situation can becom e dram atically di erent．

Including the color－octet contribution，we have

From eq＇ī̄，the branching ratios and the CP violating partial rate asym m etries can be easily calculated．To quantitatively assess the im portance of the color－octet contribution
 color－octet to produce a（ ${ }^{9}$ ），the experim entaldata from the Tevatron can be understood．

W ithout the color－octet contributions，and w th $N=3$ ，the branching ratios predicted， are several tim es sm aller than the experim ental values： $\operatorname{Br}(\mathrm{B}!\quad X)=(0: 8 \quad 0: 08) \%$ ，and $B r\left(B \quad{ }^{0} X\right)=(0: 34 \quad 0: 05) \%$ ．The inclusion of the color－octet contributions in proves the situation w the branching ratios now predicted to be： $\operatorname{Br}(\mathrm{B}!\mathrm{X})=0: 54 \%$ ，and $\operatorname{Br}\left(B!{ }^{0} X\right)=0: 25 \%$ ，with $N=3$ ．These num bers are in good agreem ent with $K o$ et al ［⿶凵⿴囗⿰丨丨⿱一⿴囗十一一 ］and they are also m uch closer to the experim ental values．

U nfortunately the results are very sensitive to $\mathrm{c}_{1}$ and $\mathrm{c}_{2}$. T he dom inant color-singlet contributions are from operators $\mathrm{O}_{1 ; 2}$ w hich are proportional to $\mathrm{c}_{1}+\mathrm{c}_{2}=\mathrm{N}$. T here is an accidental cancellation here. H ad one used the next-to-leading coe cient for $\mathrm{C}_{1 ; 2}$, the cancellation is even $m$ ore severe. If one adjusts the scale and ${ }_{4}$ for the leading coe cient, one can get larger values for the branching ratios. There are other uncertainties in the evaluation of the branching ratios, nam ely, there are $m$ ore operators which $m$ ay contribute to the branching ratio. For exam ple, therem ay be contributions from $\mathrm{O}_{1 ; 8}\left({ }^{\left({ }^{9}\right)}\left({ }^{1} \mathrm{~S}_{0}\right)\right.$. The value for $\left\langle\mathrm{O}_{1}\left({ }^{1} \mathrm{~S}_{0}\right)\right\rangle$ is expected to be m uch sm aller than $\left\langle\mathrm{O}_{1}\left({ }^{\beta} \mathrm{S}_{0}\right)\right\rangle$. Its contribution to the branching ratios is expected to be mm all. The contributions from $\mathrm{O}_{8}\left({ }^{1} \mathrm{~S}_{0}\right) \mathrm{m}$ ay be potentially large because $\left.<\mathrm{O}_{8}\left({ }^{1} \mathrm{~S}_{0}\right)\right\rangle \mathrm{m}$ ay be not too m uch m aller than $\left\langle\mathrm{O}_{8}\left({ }^{3} \mathrm{~S}_{0}\right)\right\rangle$. If this is indeed the case, the experim ental branching ratios can be easily reproduced.

W hen the color-octet contributions are included the strong penguin also generate strong phases through the coe cient A 8 in Eq.'.1.1. These phases are much larger than the ones generated by the electrow eak penguins, and therefore $m$ uch larger partial rate asym $m$ etries result. The results are shown in $F$ igure 2. In the gure, we used $q^{2}=m^{2}$ ( 0 , because the ( ${ }^{\circ}$ ) carries $m$ ost of the $m$ om entum from the virtual ghon. $W$ e also set $s$ at $q^{2}=m^{2}$ ( 0 ) and the corresponding value ${ }_{s}\left(\mathrm{~m}^{2}(0)\right)=0.27$ for ${ }_{4}=0.2 \mathrm{GeV}$. If larger $s$ is used, the asym $m$ etries becom e bigger. The asym $m$ etry for $B!{ }^{\circ} X_{s}$ is slightly larger than that for $B!X_{s}$. This is due to the fact that the ratio of the color-octet $m$ atrix elem ent to color-singlet is larger for the ${ }^{0}$. We also considered the contribution from dipole penguin operators, $O_{11}=\left(g_{s}=16{ }^{2}\right) m_{b s} S \quad R T^{a} b G_{a}$ and $O_{12}=\left(e=16^{2}\right) m_{b} S \quad R b F_{a}$. Here $G$ and F are the ghon and photon eld strengths, respectively. It has been show n that the operator $\mathrm{O}_{11}$ can enhance certain B decay branching ratios by as much as 30\% [1] $\left.\overline{1}\right]$. H ow ever, its contribution to B ! ( ${ }^{9}$ ) $X_{s}$ branching ratio is less than $10^{4}$ and to partial rate asymmetry is less than $10^{5}$. $\mathrm{O}_{12}$ contributions are even sm aller. W e rem ark that even if the operator $\mathrm{O}_{8}\left({ }^{1} \mathrm{~S}_{0}\right)$ contributes signi cantly to the branching ratios, it w ill not introduce new strong phases in the am plitude because its contributions are proportional to $\left(C_{4}^{u(t) c} \quad C_{6}^{u(t) c}\right)$ which generate vanishing absonptive am plitudes. A nd therefore, it will not
a ect the asym $m$ etries evaluated here.
It is clear from com parison of Fig. 1 and $F$ ig 2 that inclusion of the color-octet enhances the asym $m$ etries. The asym $m$ etries are bigger by about a factor of ve. At present the CP violating phase is not well determ ined; sin can vary from 0.1 to 1 . If we use the best $t$ value from the experim entaldata, is about 70 [1501]. W ith this value, the rate asym $m$ etries for B ! ( ${ }^{0}$ ) are about $4 \quad 10^{4}\left(\begin{array}{ll}6 & 10^{4}\end{array}\right)$. In order to observe the asym $m$ etries at the 3 level in B! $\quad X_{s}$ and B! $\quad{ }^{\circ} X_{s}$, one would need about $4 \quad 10^{9}$ B decays. This num ber does not include any factor(s) for experim entale ciencies. So the num ber of B's needed is likely to be even higher depending on the speci c nalstates of the ( ${ }^{0}$ ) that are accessible.

The situation with B! ( $\left.{ }^{0}\right) \mathrm{X}_{\mathrm{d}}\left(\mathrm{X}_{\mathrm{d}}\right.$ denotes states w ithout strangeness num ber) is better. The analysis is sim ilar to B ! ( ${ }^{0}$ ) $X_{s}$ case. O ne only needs to change the relevant CKM m atrix elem ents $\mathrm{V}_{\mathrm{cb}} \mathrm{V}_{\mathrm{cs}}$ and $\mathrm{V}_{\mathrm{tb}} \mathrm{V}_{\mathrm{ts}}$ to $\mathrm{V}_{\mathrm{cb}} \mathrm{V}_{\mathrm{cd}}$ and $\mathrm{V}_{\mathrm{tb}} \mathrm{V}_{\mathrm{td}}$, respectively in Eq. '5. The results are show $n$ in $F$ igure 3. The asym $m$ etries can be as large as $1.5 \%$. They are about 1\% (1.5\%) for B ! ( $\left.{ }^{9}\right) \mathrm{X}_{\mathrm{s}} \mathrm{w}$ ith $=70$. It is interesting to observe that these asym $m$ etries are sim ilar to those obtained in Ref. [1-q] by considering absonptive contribution from rescattering of $\propto c$ color-octet states. For the $X_{d}$ nal state the branching ratios are sm aller by a factor of $\mathrm{J}_{\mathrm{cd}}=\mathrm{V}_{\mathrm{cs}}{ }^{\rho}$ com pared with B ! ( $\left.{ }^{0}\right) \mathrm{X}_{\mathrm{s}}$. Therefore to observe the asymmetries in B ! ( ${ }^{9} \mathrm{X}_{\mathrm{d}}$ at the 3 level, one would need about $1 \quad 10^{8} \mathrm{~B}$ decays. A ssum ing an e ective e ciency of 02 (i.e. including the branching ratio into som e speci c nal state(s)) would $m$ ake the actual num ber be $m$ ore like $5 \quad 10^{8}$.

The number of B's needed is clearly rather large so that even B factories may have a di cult time. On the other hand the and ${ }^{0}$ tend to give distinctive signal which $m$ ay even be accessible in a hadronic environm ent w ith a B-detector.

In the above, we have considered the parton level processes, b ! s(d) ( ${ }^{9}$. If one considers the parton level processes, b! s(d)Y with $Y$ being and other oc states which can $m$ aterialize into, and do not isolate each individual $Y$ and let it decay into , then the hadron level process, B ! X w ill have m ore sources to provide strong phases. In addition to the parton level strong phases discussed above, there is also the possiblilty of generating
strong phases from resonant e ects [ī than what we obtained here. W e will discuss the results from these $m$ echanism s elsew here.

O ne might think that the samemechanism will also enhance the rate asym $m$ etry in B! ${ }_{c} X_{s}\left(X_{d}\right)$. It tums out that this is not true here ifonly $\mathrm{O}_{1 ; 8}\left({ }^{3} \mathrm{~S}_{0}\right)$ operators are included. In this case, for the sam e reason as for B ! ( ${ }^{0}$ ) X , the color-singlet only generates strong phases through electroweak penguins. H ow ever, the inclusion of color-octet contributions w illnot im prove the situation because the analogous color-octet param eter $\mathrm{A}_{8}(\mathrm{c})$ is di erent than the $A_{8}$ param eter in Eq'⿹ㅓ. . The strong penguin contribution in $A_{8}(c)$ isproportional to $\left(C_{4}^{u(t) c} \quad C_{6}^{u(t) c}\right)$ which generates vanishing strong phase too. H ow ever, if the operator $\mathrm{O}_{8}\left({ }^{1} \mathrm{~S}_{0}\right)$ contributes signi cantly, strong phases w illbe generated by the strong penguins because the contributions are then proportionalto $\left(C_{4}^{u(t) c}+c_{6}^{u(t) c}\right)$. There $m$ ay be sizable rate asym $m$ etries which also need further study.
