Recent Progress in Nonperturbative QCD Theory and Insight on Cosmological Phase Transition

The QCD phase transition at nite temperature is studied with the dual G inzburg-Landau theory, which is the QCD elective theory based on the dual Higgs mechanism by QCD monopole condensation. At high temperature, the connement force is largely reduced by thermal elects, which leads to the swelling of hadrons. Simple formulae for the surface tension and the thickness of the phase boundary are derived from the shape of the elective potential at the critical temperature. We investigate also the process of the hadron-bubble formation in the early Universe.

1. Introduction

Quantum chromodynamics (QCD) is the fundamental theory of the strong interaction [1-3]. In spite of the simple form of the QCD lagrangian,

itm iraculously provides quite various phenom ena like color con nem ent, dynam ical chiral-sym m etry breaking, non-trivial topologies, quantum anom alies and so on, as shown in Fig.1. Then, it would be interesting to compare QCD with the history of the Universe, because a quite simple big bang' also created various things including galaxies, stars, lives and thinking reeds [4]. Therefore, QCD can be regarded as an interesting m iniature of the history of the Universe. This is the most attractive point of the QCD physics.

Since it is quite di cult to understand the various QCD phenom ena and their underlying mechanism at the same time, many methods and models have been proposed to understand each phenomenon. We show in Fig2 a brief sketch on the history of QCD and typical QCD e ective models [1] as listed in Table 1. The bag model and the Nambu-Jona-Lasinio (NJL) model are simple relativistic quark theories. The nonlinear model and the SkyrmeW itten soliton model are described by the Nambu-Goldstone pion. In particular, the SkyrmeW itten model is stimulative because a fermionic baryon can be described as a soliton made by bosonic pions in this framework. The origin of this magic is found in the non-trivial topology of the avor dynamics in QCD. The lattice QCD simulation [5] using a supercomputer is a hopeful and promising method based on QCD directly, and its importance becomes larger and larger according to the great progress of the computational power. In particular, recent lattice QCD studies [6] shed a light

on the con nement mechanism, which is one of the most dicult problems in the particle physics. In these years, the origin of color con nement can be recognized as the dual Higgs mechanism by monopole condensation, and the nonperturbative QCD vacuum is regarded as the dual superconductor. The dual Ginzburg-Landau (DGL) theory [7-14] was formulated with this picture, and can reproduce con nement properties like the string tension and the hadron ux-tube formation.

Now, you may not a current of the QCD physics. In '80s, chiral symmetry breaking was the central issue. The chiral bag model, the NJL model and the model were formulated with referring chiral symmetry. In '90s, on the other hand, the connem ent physics is providing an important current of the hadron physics. The key word for the understanding of connem ent is the \duality", which is recently paid attention by many theoretical particle physicists after Seiberg-Witten's discovery on the essential role of monopole condensation for the connem ent in a supersymmetric version of QCD [15].

2.ColorCon nem ent and DualHiggsMechanism

We brie y show the modern current of the con nement physics. About 20 years ago, Nambu, 't Hooft and Mandelstam proposed an interesting picture for color con nement based on the analogy between the superconductor and the QCD vacuum [16]. In the superconductor, the magnetic eld is excluded due to the Meissner e ect, which is caused by Cooper-pair condensation. As the result, the magnetic ux is squeezed like the Abrikosov vortex. On the other hand, the color-electric ux is excluded in the QCD vacuum, and therefore the squeezed color-ux tube is formed between color sources. Thus, these two systems are quite similar and can be regarded as the dual version each other. This idea is based on the \duality" of the gauge theories, which was retly pointed out by Dirac more than 50 years ago [17].

W ith referring Table 2 and Fig.3, we compare the ordinary electrom agnetic system, the superconductor and the nonperturbative QCD vacuum regarded as the dual superconductor. In the ordinary electrom agnetism in the Coulomb phase, both electric ux and magnetic ux are conserved, respectively. The electric-ux conservation is guarantied by the ordinary gauge symmetry. On the other hand, the magnetic-ux conservation is originated from the dual gauge symmetry [8-14], which is the generalized version of the Bianchi identity. As for the intercharge potential in the Coulomb phase, both electric and magnetic potentials are Coulomb-type.

The superconductor in the H iggs phase is characterized by electric-charge condensation, which leads to the H iggs mechanism or spontaneous breaking of the ordinary gauge sym metry, and therefore the electric ux is no more conserved. In such a system obeying the London equation, the electric inter-charge potential becomes short-range Yukawa-type similarly in the electro-weak unied theory. On the other hand, the dual gauge sym metry is not broken, so that the magnetic ux is conserved, but is squeezed like a one-dimensional ux tube due to the Meissner

e ect. As the result, the magnetic inter-charge potential becomes linearly rising like a condenser.

The nonperturbative QCD vacuum regarded as the dual H iggs phase is characterized by color-m agnetic m onopole condensation, and resembles the dual version of the superconductor, where the \dual version" means the interchange between the electric and magnetic sectors. M onopole condensation leads to the spontaneous breaking of the dual gauge sym metry, so that color-magnetic ux is not conserved, and the magnetic inter-change potential becomes short-range Yukawa-type. Note that the ordinary gauge sym metry is not broken by such monopole condensation. Therefore, color-electric ux is conserved, but is squeezed like a one-dimensional ux-tube or a string as a result of the dual Meissner electric. Thus, the hadron ux-tube is formed in the monopole-condensed QCD vacuum, and the electric intercharge potential becomes linearly rising, which can nest the color-electric charges as quarks [8-11].

As a remarkable fact in the duality physics, these are two \see-saw relations" between in the electric and magnetic sectors.

- (1) There appears the D irac condition eg = 2 [17] in QED or eg = 4 [8] in QCD. Here, unit electric charge e is the gauge coupling constant, and unit magnetic charge g is the dual gauge coupling constant. Therefore, a strong-coupling system in one sector corresponds to a weak-coupling system in the other sector.
- (2) As shown in Fig.3, the long-range con nem ent system in one sector corresponds to a short-range (Yukawa-type) interaction system in the other sector.

Let us consider usefulness of the latter \see-saw relation". One faces highly non-local properties am ong the color-electric charges in the QCD vacuum because of the long-range linear con nem ent potential. Then, the direct form ulation am ong the electric-charged variables would be dicult due to the non-locality, which seems to be a destiny in the long-distance con nem ent physics. However, one nds a short-range Yukawa potential in the magnetic sector, so that the electric-con nem ent system can be approximated by a local form ulation among magnetic-charged variables. Thus, the con nem ent system, which seems highly non-local, can be described by a short-range interaction theory using the dual variables, which is the most attractive point in the dual Higgs theory.

Colorm agnetic monopole condensation is necessary for color con nement in the dualH iggs theory. As for the appearance of colorm agnetic monopoles in QCD, 't Hooft proposed an interesting idea of the abelian gauge xing [18,19], which is dened by the diagonalization of a gauge-dependent variable. In this gauge, QCD is reduced into an abelian gauge theory with the colorm agnetic monopole [8,18], which will be called as QCD-monopoles hereafter. Similar to the 't Hooft-Polyakov monopole [2] in the Grand Unied theory (GUT), the QCD-monopole appears from a hedgehog con guration corresponding to the non-trivial homotopy group $_2$ (SU (N $_{\rm C}$)=U (1) $^{\rm N_{\, C}-1}$) = Z $_1^{\rm N_{\, C}-1}$ on the nonabelian manifold.

M any recent studies based on the lattice gauge theory have supported QCD-m onopole condensation and abelian dom inance [6,13,20-22], which m eans that only abelian variables are relevant for the nonperturbative QCD, in the 't H ooft abelian

gauge. Hence, the dual-superconductor scenario seems workable for color con nement in the QCD vacuum, and the nonperturbative QCD would be described by the dual G in zburg-Landau (DGL) theory, which is the QCD excitive theory based on the dual G in zburg-chanism.

3.D ualG inzburg-Landau Theory

The dual G in zburg-Landau (DGL) lagrangian [13,14] for the pure-gauge system is described with the dual gauge eld B and the QCD-monopole eld ,

where \hat{D} \hat{Q} + igB is the dual covariant derivative including the dual gauge coupling constant g=4 =e.

The dual gauge eld B B B H = B 3 T 3 + B 8 T 8 is de ned on the dual gauge m anifold U (1) $_{\rm m}^3$ U (1) $_{\rm m}^8$ [13,14], which is the dual space of the m axim al tonus subgroup U (1) $_{\rm e}^3$ U (1) $_{\rm e}^8$ em bedded in the original gauge group SU (3) $_{\rm c}$. The abelian eld strength tensor is written as F = (@ $^{\circ}$ B) so that the role of the electric and m agnetic elds are interchanged in comparison with the ordinary A description.

The QCD-m onopole eld is de ned as $2^{p} = 1$ E [13,14] where $E_1 = \frac{1}{2}$ ($\Gamma_6 + i\Gamma_7$), $E_2 = \frac{1}{2}$ ($\Gamma_4 = i\Gamma_5$) and $E_3 = \frac{1}{2}$ ($\Gamma_1 + i\Gamma_2$). Here, has the magnetic charge g~ proportional to the root vector ~. In the QCD-m onopole condensed vacuum with j j= v, the dual gauge symmetry U (1) $_m^3$ U (1) $_m^8$ is spontaneously broken instead of the gauge symmetry U (1) $_e^3$ U (1) $_e^8$. Through the dual Higgs mechanism, the dual gauge eld B acquires its mass $m_B = \frac{1}{2}$ 3gv, whose inverse provides the radius of the hadron ux tube [8], and the dual M eissner electric eld excluded from the QCD vacuum, which leads to color connement. The QCD-monopole uctuations ~ v (=1,2,3) also acquire their mass $m_B = \frac{1}{2}$ v in the QCD-monopole condensed vacuum. As a relevant prediction, only one QCD-monopole uctuation ~ $m_B = \frac{1}{2}$ appears as a color-singlet scalar glueball in the connement phase, although the dual gauge eld B and the other two combinations of the QCD-monopole uctuation are not color-singlet and cannot be observed [13,21,22].

The DGL theory reproduces con nement properties like the inter-quark potential and the hadron ux-tube formation. We studied elects of the ux-tube breaking by the light quark-pair creation in the DGL theory, and derived the infrared screened inter-quark potential [8-10], which is observed in the lattice QCD with dynamical quarks [5]. We studied also the dynamical chiral-symmetry breaking (DSB), which is also an important feature in the nonperturbative QCD, by solving the Schwinger-Dyson equation for the dynamical quark [8-10]. The quark-mass generation is brought by QCD-monopole condensation, which suggests the

close relation between D SB and color con nem ent. Thus, the DGL theory provides not only the con nem ent properties but also D SB and its related quantities like the constituent quark m ass, the chiral condensate and the pion decay constant [8-10,23,24].

4.QCD Phase Transition in the DGL Theory

In this chapter, we study the QCD phase transition [10-12,14,24] in the DGL theory. Although quarks and gluons are conned inside hadrons in the nonperturbative QCD vacuum, these colored particles are liberated and the system becomes the quark-gluon-plasma (QGP) phase [1] at high temperature (T > $T_{\rm C}$ 200M eV), which is called as the QCD phase transition. The experimental creation of the QGP, one of the most central subjects in the RHIC project, is expected to be realized in ultra-relativistic heavy-ion collisions [1,25]. On the other hand, the QCD phase transition occurred in the early Universe, and its process strongly in venced the afterward nucleosynthesis [26].

In the D G L theory, the Q C D phase transition is characterized by Q C D -m onopole condensate j j which is an order parameter on the con nement strength. The Q C D -m onopole condensed vacuum ($\[\in \]$ 0), where the dual gauge sym m etry is spontaneously broken (m $_B$ $\[\in \]$ 0), is the con nement phase with a non-vanishing string tension (k $\[\in \]$ 0). Without Q C D -m onopole condensation (= 0), the dual gauge sym m etry is manifest (m $_B$ = 0), and the system corresponds to the deconnement phase, where the string tension disappears (k = 0).

To study the QCD phase transition, the e ective potential $V_{\rm e}$ (;T) at nite tem perature, which physically means the therm odynam ical potential, is form ulated as the function of QCD-m onepole condensate j j[10-12,14],

with m $_{\rm B}$ = $^{\rm p}$ $_{\rm S}$ and m = $^{\rm p}$ $_{\rm S}$. Here, we have used the quadratic source term to avoid the imaginary scalar mass problem [10-12,14].

The QCD-m onopole condensate $_{\rm phys}(T)$ at nite temperature is obtained from the local minimum of the elective potential $V_{\rm e}$ (;T). As temperature increases, $_{\rm phys}(T)$ decreases and disappears at a critical temperature $T_{\rm c}$. Above $T_{\rm c}$, the decon nement phase is realized as the Coulomb phase with $_{\rm phys}(T)=0$, where the dual gauge symmetry is restored. With the parameters in Ref.[8], we note a weak instituted phase transition at $T_{\rm c}=0.2{\rm G\,eV}$, and the mixed phase or the two-phase coexistence is allowed only in $T_{\rm low}< T< T_{\rm up}$ with $T_{\rm low}$ ' 0.193GeV and $T_{\rm up}$ ' 0.201GeV [10,12,14].

Now, let us consider the con nem ent and hadron properties. Fig.4 shows the string tension k(T) at nite temperature. As the temperature increases, k(T) becomes smaller and drops rapidly near T_c [10-12,14,27]. Therefore, the slope of the inter-quark potential is reduced and the inter-quark distance inside hadrons

increases at high tem perature. In addition, the color-electric eld spreads according to the decrease of m_B . Thus, the reduction of the con nem ent force leads to the swelling of hadrons at high tem perature [14].

W e predict also a large m ass reduction of the scalar glueball originated from QCD-m onopoles near $T_{\rm c}$ [10-12,14]. W e guess that the violent excitation of these scalar glueballs with a reduced mass would promote the QCD phase transition.

Finally, we consider the relation between the surface tension—and the ective potential V_e (; T_c) [10,11]. The surface tension—characterizes the strength of the rst order in the phase transition, and is very in portant for the shape of the boundary surface in the mixed phase, where the two phases correspond to the two minima, = 0 and = _c, in V_e (; T_c). U sing the sine-G ordon kink ansatz [10,11] for the boundary pro_le, (z) = _c tan ^1 e^{z^-}; we derive simple formulae for the surface tension ' $\frac{4^n 3^n}{3^n}$ h_c; and the phase-boundary thickness 2 ' $\frac{2^n 3^n}{3^n}$ c= h; where h is the \barrier height" between the two minima in V_e (; T_c). We nd 2 ' 3:4fm and ' (112M eV) [10], which seems consistent with the lattice QCD data [28].

5. Hadron Bubble Form ation in the Early Universe

In this chapter, we study the hadron bubble form ation [29] in the early Universe using the DGL theory [14]. As W itten pointed out [30], if the QCD phase transition is of the rst order, the hadron and QGP phases should coexist in the early Universe. During the mixed-phase period, there appears the inhom ogeneity on the baryon density distribution [26,31], which can strongly a ects the primordial nucleo-synthesis and the successive history of the Universe.

Let us consider how hadron bubbles appear in the QGP phase near the critical tem perature T_c in the DGL theory. The hadron bubbles are created in the supercooling QGP phase with T_{low} < T < T_c . We use the sine-Gordon kink ansatz [14] for the prole of the QCD-m one-pole condensate in the hadron bubble as a function of the radial coordinate r, $(r;R) = _{phys}(T) \tan ^1 e^{(R-r)} = \tan ^1 e^{R}$; where R and 2 correspond to the hadron-bubble radius and the phase-boundary thickness, respectively. The QCD-m one-pole condensate (r;R) is nite only inside the bubble, $r \le R$. The energy density E(r;R) of the hadron bubble is shown in Fig.5. It is negative inside and positive near the boundary surface. The total energy is roughly estimated as the sum-of the positive surface term and the negative volume term.

On the other hand, the creation of large bubbles is suppressed because of the small creation probability [14]. In the hadron-bubble formation, there is a penetration over a large barrier height h (T) in the elective potential per unit volume, and therefore the creation of large bubbles needs a large energy uctuation. Such a process is strongly suppressed because of the thermodynamical factor P (T) $\exp\left(\frac{4}{3}R_{\rm C}(T)^3h(T)=T\right)$, which is proportional to the hadron-bubble formation rate. Thus, the only small bubbles are created practically, although its radius should be larger than $R_{\rm C}$ [14].

Using V_e (;T) in the DGL theory, we can estimate the critical radius R_c (T) and the hadron-bubble formation factor P(T) at nite temperature as shown in Fig.7 and Fig.8, respectively. As the temperature decreases, the created hadron bubbles becomes smaller, while the bubble formation rate becomes larger [14].

From these results, we can imagine how the QCD phase transition happens in the big bang scenario [14] as shown in Fig.9.

- (a) Slightly below T_{c} , only large hadron bubbles appear, but the creation rate is quite sm all.
- (b) As tem perature is lowered by the expansion of the Universe, smaller bubbles are created with much formation rate. During this process, the created hadron bubbles expand with radiating shock wave, which reheats the QGP phase around them [29].
- (c) Near T $_{\rm low}$, m any sm all hadron bubbles are violently created in the una ected region free from the shock wave.
- (d) The QGP phase pressured by the hadron phase is isolated as high-density QGP bubbles [29,30], which provide the baryon density uctuation [26].

Thus, the num erical simulation using the DGL theory would tell how the hadron bubbles appear and evolve quantitatively in the early Universe.
