A chiral Lagrangian for excited pions

A bstract

We construct a chiral Lagrangian containing besides the usual pion eld () also its rst radial excitation (0). The Lagrangian is derived by bosonization of a N am bu { Jona-Lasinio quark model with separable non-local interactions, with form factors corresponding to 3{dimensional ground and excited state wave functions. Chiral symmetry breaking is governed by the NJL gap equation. The elective Lagrangian for { and 0 {mesons shows the decoupling of the Goldstone pion and the vanishing of the 0 leptonic decay constant, for in the chiral limit, as required by axial current conservation. We derive the excited states contribution to the axial current of the model using Noether's theorem. For nite pion mass and 0 masses in the range of 750 MeV {1300 MeV, for efficient is found to be of the order of 1%.

1 Introduction

Radial excitations of light mesons are currently a topic of great interest in hadronic physics. During the next years, facilities at CEBAF and IHEP (Protvino) will provide improved experimental information about excited states in the few (GeV region, e.g. on the ⁰ meson. The resonance usually identified as the rst radial excitation of the pion has a mass of (1300 100) MeV [1]. Recently, indications of a light resonance in diractive production of 3 (states have lead to speculations that the mass of the ⁰ may be considerably lower at 750 MeV [2].

A theoretical description of radially excited pions poses some interesting challenges. The physics of normal pions is completely governed by the spontaneous breaking of chiral sym m etry. A convenient way to derive the properties of soft pions is by way of an e ective Lagrangian based on a non-linear realization of chiral symmetry [3]. When attempting to introduce higher resonances to extend the e ective Lagrangian description to higher energies, one must ensure that the introduction of new degrees of freedom does not spoil the low (energy theorem s for pions, which are universal consequences of chiral sym metry. In the case of vector resonances (;!;A1) this problem can be solved by introducing them as gauge bosons. Such \gauged" chiral Lagrangians have proven very successful in describing meson phenomenology up to 1GeV [4]. When trying to include 0 { resonances as elementary elds, however, there is no simple principle to restrict the form of interactions the has the same spin {parity quantum numbers as the normal pion itself. Nevertheless, the normal pion eld must decouple from the \hard" degrees of freedom in the chiral lim it in order to describe a Goldstone boson. At the same time, the ontributes to the axial vector hadronic current, and is thus itself a ected by chiral sym m etry: when the axial current is conserved (chiral $\lim_{t \to 0}$), one expects the 0 weak decay constant to vanish [5]. This shows that chiral sym metry plays an important role in the description of the 0 .

A useful guideline in the construction of e ective m eson Lagrangians is the N am bu { Jona-Lasinio (N JL) m odel, which describes the spontaneous breaking of chiral sym m etry at quark level using a four{ ferm ion interaction [6, 7]. The bosonization of this m odel and the derivative expansion of the resulting ferm ion determ inant reproduce the Lagrangian of the linear sigm a m odel, which embodies the physics of soft pions, as well as higher{ derivative term s. W ith appropriate couplings the m odel allows to derive also a Lagrangian for vector m esons. This not only gives the correct structure of the term s of the Lagrangian as required by chiral sym m etry, one also obtains quantitative predictions for the coecients, such as f, g, etc., which are in good agreement with phenomenology. One may therefore hope that a suitable generalization of the N JL {model may provide a means for deriving an elective Lagrangian including also the 0 m eson.

When extending the NJL model to describe radial excitations of mesons, one has to introduce non-local (nite(range) four{ferm ion interactions. Many non-local generalizations of the NJL model have been proposed, using either covariant{euclidean [8] or instantaneous (potential{type) [9,10] e ective quark interactions. These models generally require bilocal meson elds for bosonization, which makes it dicult to perform a consis-

tent derivative expansion leading to an elective Lagrangian. A simple alternative is the use of separable quark interactions. There are a number of advantages of working with such a scheme. First, separable interactions can be bosonized by introducing local meson elds, just as the usual NJL {model2.0 ne can thus derive an e ective meson Lagrangian directly in terms of local elds and their derivatives. Second, separable interactions allow one to introduce a limited number of excited states and only in a given channel. An interesting m ethod for describing excited m eson states in this approximation was proposed in [13]. Furtherm ore, the separable interaction can be de ned in M inkowski space in a 3 (dim ensional (yet covariant) way, with form factors depending only on the part of the quark {antiquark relative m om entum transverse to the meson m om entum [10, 14]. This is essential for a correct description of excited states, since it ensures the absence of sourious relative (time excitations [15]. Finally, as we shall see, the form factors de ning the separable interaction can be chosen in such a way that the gap equation of the generalized NJL (model coincides with the one of the usual NJL (model, which has as solution a constant (momentum (independent) dynamical quark mass. Thus, in this approach it is possible to describe radially excited mesons above the usual NJL vacuum . A side from the technical simplication the latterm eans that the separable generalization contains all the successful quantitative results of the usual NJL model.

In this paper, we derive an elective chiral Lagrangian describing and 0 m esons from a generalized N JL (model with separable interactions. In section 2, we introduce the elective quark interaction in the separable approximation and describe its bosonization. We discuss the choice of form factors necessary to describe excited states. In section 3, we solve the gap equation dening the vacuum, derive the elective Lagrangian of the 0 meson elds, and perform the diagonalization leading to the physical and 0 states. The elective Lagrangian describes the vanishing of the mass (decoupling of the Goldstone boson) in the chiral limit, while the 0 remains massive. In section 4, we derive the axial vector current of the elective Lagrangian using the Gell-Mann (Levy method and obtain a generalization of the PCAC formula which includes the contribution of the 0 to the axial current. The leptonic decay constants of the and 0 mesons, f and 0 , are discussed in section 5. It is shown that for vanishes in the chiral limit as expected. In section 6, we we the parameters of the model and evaluate the ratio for effective interaction of the 0 mass.

We stress that we are using the NJL model to derive an elective lagrangian description of excited mesons, in which the coupling constants and elds are defined at zero 4 momentum (derivative expansion), not an on shell description of bound states. For this reason the lack of quark con nement of this model is not an issue here. While there is no a priori proof of the quantitative reliability of an elective lagrangian description of excited states, this approach allows us to investigate a number of principal aspects in a simple way. Moreover, the fact that elective lagrangians work well for vector mesons gives some grounds to hope that such an approach may not be unreasonable for excited states.

¹An exception to this are heavy{light m esons, in which the heavy quark can be taken as static. An e ective Lagrangian for excited heavy m esons was derived from bilocal elds in [11].

Nambu{Jona-Lasinio model with separable inter-2 actions

In the usual NJL model, the spontaneous breaking of chiral symmetry is described by a local (current (current) e ective quark interaction. The model is de ned by the action

The model can be bosonized in the standard way by representing the 4 (ferm ion interaction as a Gaussian functional integral over scalar and pseudoscalar meson elds [6, 7]. Since the interaction, eq.(2), has the form of a product of two local currents, the bosonization is achieved through local meson elds. The elective meson action, which is obtained by integration over the quark elds, is thus expressed in terms of local meson elds. By expanding the quark determ inant in derivatives of the local meson elds one then derives the chiral meson Lagrangian.

The NJL interaction, eq.(2), describes only ground (state mesons. To include excited states one has to introduce e ective quark interactions with a nite range. In general, such interactions require bilocal meson elds for bosonization [8, 10]. A possibility to avoid this complication is the use of a separable interaction, which is still of current (current form, eq.(2), but allows for non-local vertices (form factors) in the de nition of the quark currents, eq.(3),

Here, $F_{i}(x;x_1;x_2); F_{i}(x;x_1;x_2); i = 1; ... N$, denote a set of non-local scalar and pseudoscalar ferm ion vertices (in general m om entum { and spin {dependent), which will be speci ed below. Upon bosonization eq.(4) leads to an action

It describes a system of local meson elds, $_{i}(x)$; $_{i}^{a}(x)$; $_{i}^{i}=1$;:::N, which interact with the quarks through non-local vertices. We emphasize that these elds are not yet to be associated with physical particles (; 0;:::;; physical elds will be obtained after determ ining the vacuum and diagonalizing the e ective meson action.

To de ne the vertices of eq.(5, 6) we pass to the momentum representation. Because of translational invariance, the vertices can be represented as

and $sim ilarly for F^a_{ii}(x; x_1; x_2)$. Here k and P denote, respectively, the relative and total momentum of the quark {antiquark pair. We take the vertices to depend only on the component of the relative m om entum transverse to the total m om entum,

Here, P is assumed to be time-like, $P^2 > 0$. Eq.(9) is the covariant generalization of the condition that the quark (m eson interaction be instantaneuos in the rest fram e of the m eson (i.e., the fram e in which P = 0). Eq.(9) ensures the absence of spurious relative { time excitations and thus leads to a consistent description of excited states³ [15]. In particular, this fram ework allows us to use 3 (dim ensional \excited state" wave functions to model the form factors for radially excited mesons.

The simplest chirally invariant interaction describing scalar and pseudoscalar mesons is de ned by the spin (independent vertices 1 and i 5 a, respectively. We want to include ground state m esons and their rst radial excitation (N = 2), and therefore take

³ In bilocal eld theory, this requirem ent is usually im posed in the form of the so {called M arkov {Yukawa condition of covariant instanteneity of the bound state amplitude [10]. An interaction of transverse form, eq.(9), autom atically leads to meson amplitudes satisfying the Markov{Yukawacondition.

The step function, ($_3$ $_3k_2$), is nothing but the covariant generalization of the usual $3\{m \text{ om entum cuto of the NJL m odel in the meson rest fram e [10]. The form factor f (<math>k_2$) has for $d < _3^2$ the form of an excited state wave function, with a node in the interval $0 < _3k_2$ j < $_3$. Eqs.(10, 11, 12) are the rst two terms in a series of polynomials in k_2^2 ; inclusion of higher excited states would require polynomials of higher degree. Note that the normalization of the form factor f (k_2), the constant c, determines the overall strength of the coupling of the $_2$ and $_2$ elds to the quarks relative to the usual NJL (coupling of $_1$ and $_1$.

We remark that the most general vertex could also include spin (dependent structures, P= and $_5P=$, which in the term inology of the NJL model correspond to the induced vector and axial vector component of the and ({ and {A}_1 mixing}), respectively. These structures should be considered if vector mesons are included. Furthermore, there could be structures $k_?$; $P=k_?$ and $p=k_?$; $p=k_?$, respectively, which describe bound states with orbital angular momentum L=1. We shall not consider these components here.

W ith the form factors de ned by eqs.(10, 11, 12), the bosonized action, eq.(7), in m om entum representation takes the form

3 E ective Lagrangian for and 0 m esons

We now want to derive the elective Lagrangian describing physical and 0 mesons. Integrating over the ferm ion elds in eq.(13), one obtains the elective action of the $_{1}$; $_{1}$ { and $_{2}$; $_{2}$ { elds,

This expression is understood as a shorthand notation for expanding in the meson elds. In particular, we want to derive the free part of the elective action for the $_1$ { and

where it is understood that we restrict ourselves to timelike momenta, $P^2 > 0$. Before expanding in the $_1$ { and $_2$ { elds, we must determ in the vacuum, i.e., the mean scalar eld, which arises in the dynamical breaking of chiral symmetry. eqs.(17, 18) adm it a solution with $_2$ = 0 and thus with a constant quark mass, m = $_1$ + m 0 . In this case, eq.(17) reduces to the usual gap equation of the N JL m odel,

Obviously, condition eq.(19) can be fullled by choosing an appropriate value of the parameter d de ning the \excited state" form factor, eq.(12), for given values of 3 and m . Eq.(19) expresses the invariance of the usual NJL vacuum , $_1$ = const.; with respect to variations in the direction of 2. In the following, we shall consider the vacuum as de ned by eqs.(19, 20), i.e., we work with the usual NJL vacuum. We emphasize that this choice is a matter of convenience, not of principle. The qualitative results below could equivalently be obtained with a di erent choice of form factor; however, in this case one would have to re-derive all vacuum and ground (state m eson properties with the m om entum {dependent quark m ass. P reserving the N JL vacuum m akes form ulas below

much more transparent and allows to carry over the parameters xed in the old NJL model.

W ith them ean eld determ ined by eqs.(19, 20), we now expand the action to quadratic order in the elds $_1$ and $_2$. The quadratic form K $_{ij}^{ab}$ (P), eq.(16), is obtained as

A graphical representation of the loop integrals in eq.(21) is given in g.1. The integral is evaluated by expanding in the meson eld momentum, P. To order P^2 , one obtains

Here, I_n ; I_n^f and I_n^{ff} denote the usual loop integrals arising in the momentum expansion of the NJL quark determinant, but now with zero, one or two factors f $(k_?)$, eq.(12), in the numerator. We may evaluate them in the rest frame, $k_? = (0;k)$,

The evaluation of these integrals with a $3\{m \text{ om entum cuto is described e.g. in ref.[16].}$ The integral over k_0 is performed by contour integration, and the remaining $3\{d \text{ im ensional integral regularized by the cuto . Only the divergent parts are kept; all nite parts are dropped. We point out that the momentum expansion of the quark loop integrals, eq.(21), is an essential part of this approach. The NJL <math>\{m \text{ odel is understood here as a model only for the lowest coecients of the momentum expansion of the quark loop, not its full momentum dependence (singularities etc.).$

Note that a mixing between the $_1\{$ and $_2\{$ elds occurs only in the kinetic (O (P 2) $\{$) term s of eq.(22), but not in the mass term s. This is a direct consequence of the de nition of the vacuum by eqs.(19, 20), which ensures that the quark loop with one form factor has no P $^2\{$ independent part. The \softness" of the $_1\{$ $_2$ m ixing causes the $_1\{$ eld to

decouple at P^2 ! 0. This property is crucial for the appearance of a Goldstone boson in the chiral lim it.

To determ ine the physical $\{$ and $^{0}\{$ m eson states we have to diagonalize the quadratic part of the action, eq.(16). If one knew the full momentum dependence of the quadratic form, eq.(22), the masses of the physical states would be given as the zeros of the determinant of the quadratic form,

This would be equivalent to the usual Bethe{Salpeter (on{shell) description of bound states: the matrix K $_{ij}$ (P 2) is diagonalized independently on the respective mass shells, P 2 = m 2 ; m 2 $_0$ [9, 17, 19]. In our approach, however, we know the quadratic form, eq.(22), only as an expansion in P 2 at P 2 = 0. It is clear that a determination of the masses according to eq.(28) would be incompatible with the momentum expansion, as the determinant involves O (P 4){terms which are neglected in eq.(22). To be consistent with the P 2 {expansion we must diagonalize the kinetic term and the mass term in eq.(16) simultaneously, with a P 2 {independent transformation of the elds. Let us write eq.(22) in matrix form

The elds and ⁰ can thus be associated with physical particles.

Let us now consider the chiral lim it, i.e., vanishing current quark m ass, m 0 ! 0. From eqs.(23{26}) we see that this is equivalent to taking m $_{1}^{2}$! 0. (Here and in the following, when discussing the dependence of quantities on the current quark m ass, m 0 , we keep the constituent quark m ass xed and assume the coupling constant, g, to be changed in accordance with m 0 , such that the gap equation, eq.(20) remains full led exactly. In this way, the loop integrals and eq.(19) remain una ected by changes of the current quark mass.) Expanding eqs.(35) in m $_{1}^{2}$ / m $_{0}^{0}$, one nds

Thus, in the chiral lim it the elective Lagrangian eq.(34) indeed describes a massless Goldstone pion, , and a massive particle, 0 . Furthermore, in the chiral lim it the transformation of the elds, eq.(30), becomes

At $m_1^2 = 0$ one observes that has only a component along $_1$. This is a consequence of the fact that the $_1$ { $_2$ coupling in the original Lagrangian, eq.(22), is of order P^2 . We remark that, although we have chosen to work with a particular choice of excited (state form factor, eq.(19), the occurrence of a Goldstone boson in the chiral limit in eq.(14) is general and does not depend on this choice. This may easily be established using the general gap equations, eqs.(17, 18), together with eq.(21).

4 The axial current

In order to describe the leptonic decays of the and ⁰ m esons we need the axial current operator. Since our elective action contains besides the pion a eld describing an \excited state" with the same quantum numbers, it is clear that the axial current of our model is, in general, not carried exclusively by the eld, and is thus not given by the standard PCAC formula. Thus, we must determ ine the conserved axial current of our model, including the contribution of the ⁰, from rst principles.

In general, the construction of the conserved current in a theory with non-local (momentum {dependent) interactions is a dicult task. This problem has been studied extensively in the fram ework of the Bethe{Salpeter equation [18] and various 3{dimensional reductions of it such as the quasipotential and the on{shell reduction [20]. In these approaches the derivation of the current is achieved by \gauging" all possible momentum dependence of the interaction through minimal substitution, a rather cumbersome procedure in practice. In contrast, in a Lagrangian eld theory a simple method exists to

derive conserved currents, the so{called G ell{M} ann and Levy m ethod [21], which is based on Noether's theorem. In this approach the current is obtained as the variation of the lagrangian with respect to the derivative of a space{time dependent symmetry transformation of the elds. We now show that a suitable generalization of this technique can be employed to derive the conserved axial current of our model with quark{m eson form factors depending on transverse momentum.

To derive the axial current we start at quark level. The isovector axial current is the Noether current corresponding to in nitesimal chiral rotations of the quark elds,

Following the usual procedure, we consider the parameter of this transformation to be space{time dependent, "a" (x). However, this dependence need not be completely arbitrary. To describe the decays of and 0 m esons, it is su cient to know the component of the axial current parallel to the meson $4 \{ m \text{ om entum}, P . \text{ It is easy to see that this component is obtained from chiral rotations whose parameter depends only on the longitudinal part of the coordinate$

since $(^{ma}(x_{jj}) / P)$. In other words, transform ations of the form eq.(40) describe a transfer of longitudinal momentum to the meson, but not of transverse momentum. This has the important consequence that the chiral transformation does not change the direction of transversality of the meson (quark interaction, cf. eq.(9). When passing to the bosonized representation, eq.(7), the transformation of the $_1$; $_1$ { and $_2$; $_2$ { elds induced by eqs.(39, 40) is therefore of the form

This follows from the fact that, for xed direction of P, the vertex eq.(9) describes an instantaneous interaction in x_{jj} . Thus, the special chiral rotation eq.(40) does not m ix the components of the meson elds coupling to the quarks with dierent form factors.

W ith the transform ation of the chiral elds given by eqs.(41), the construction of the axial current proceeds exactly as in the usual linear sigm a model. We write the variation of the elective action, eq.(14), in momentum representation,

Here we have already used that $_2 = 0$ in the vacuum, eq.(19). Expanding now in the momentum Q, making use of eq.(19) and the gap equation, eq.(20), and setting $_1 = m$ (it is su cient to consider the symmetric limit, m $_0 = 0$), this becomes

The fact that D a (Q 2) is proportional to Q 2 is a consequence of the chiral sym m etry of the e ective action, eq.(14). Due to this property, D a (Q 2) m ay be regarded as the divergence of a conserved current,

Eq.(45) is the conserved axial current of our model. It is of the usual \PCAC" form, but contains also a contribution of the $_2$ eld. The above derivation was rather form al. However, the result can be understood in simple terms, as is shown in g2: Both the $_1$ and $_2$ { eld couple to the local axial current of the quark eld through quark loops; the $_2$ { eld enters the loop with a form factor, f (k_2). The necessity to pull out a factor of the meson eld momentum (derivative) means that only the O (P^2){parts of the loop integrals, I_2 and I_2^f , survive, cf. eq.(27). Chiral sym metry ensures that the corresponding diagrams for the divergence of the current have no P^2 {independent part.

The results of this section are an example for the technical simplications of working with separable quark interactions. The fact that they can be bosonized by local meson elds makes it possible to apply methods of local eld theory, such as Noether's theorem, to the elective meson action. Furthermore, we note that the covariant (transverse) denition of the 3 (dimensional quark interaction, eq.(9), is crucial for obtaining a consistent axial current. In particular, with this formulation there is no ambiguity with dierent denitions of the pion decay constant as with non (covariant 3-dimensional interactions [9].

5 The weak decay constants of the and 0 m eson

We now use the axial current derived in the previous section to evaluate the weak decay constants of the physical and 0 m esons. They are dened by the matrix element of the divergence of the axial current between meson states and the vacuum,

In term s of the physical elds, and $^{^{0}}$, the axial current takes the form

Here, we have substituted the transform ation of the elds, eq.(38), in eq.(45). The decay constants of the physical and ⁰ states are thus given by

The corrections to f due to the inclusion of excited states are of order m⁴. Thus, within our accuracy f is identical to the value obtained with the usual N JL m odel, $\overline{Z_1}$ m, which follows from the Goldberger (Treim an relation at quark level [6]. On the other hand, the 0 decay constant vanishes in the chiral lim it m 0 m $_{1}^{2}$! 0, as expected. W e stress that for this property to hold it is essential to consider the full axial current, eq.(45), including the contribution of the 2 (component. As can be seen from eqs. (38, 45), use of the standard PCAC formula A^a / e^a would lead to a non-vanishing result for $f \circ in$ the chiral lim it.

The ratio of the ⁰ to the decay constants can directly be expressed in terms of the physical and 0 m asses. From eqs.(49, 50) one obtains, using eqs.(36, 37),

This is precisely the dependence which was derived from current algebra considerations in a general \extended PCAC" fram ework [5]. We note that the same behavior of f o in the chiral limit is found in models describing chiral symmetry breaking by non-local interactions [9, 17].

The e ective Lagrangian illustrates in a compact way the di erent consequences of axial current conservation for the pion and its excited state. Both matrix elements of @ A , eq.(46) and eq.(47), must vanish for m^0 ! 0. The pion matrix element, eq.(46) does so by m²! 0, with frem aining nite, while for the excited pion matrix element the opposite takes place, $f \circ ! 0$ with $m \circ rem aining nite.$

6 N um erical estim ates and conclusions

We can now estimate numerically the excited pion decay constant, fo, in this model. We take a value of the constituent quark mass of $m = 300 \,\mathrm{MeV}$ and x the $3 \,\mathrm{mm}$ om entum cuto at $_3$ = 671 M eV by tting the normal pion decay constant f = 93 M eV in the chiral limit, as in the usual NJL model without excited states, cf. [16]. With these param eters one obtains the standard value of the quark condensate, $hqqi = (253 \text{ M eV})^3$, and $g = 0.82 \,\mathrm{m}^{-2} = 9.1 \,\mathrm{GeV}^{-2}$; $\mathrm{m}^{0} = 5.1 \,\mathrm{MeV}$. With the constituent quark mass and cuto xed, we can determ ine the param eter d of the \excited { state" form factor, eq. (12), from the condition eq.(19). We nd d = $1.83_3^2 = 4.06$ G eV 2 , corresponding to a form factor $f(k_2)$ with a radial node in the range 0 \mathbf{j}_{2} \mathbf{j}_{3} . W ith this value we determ ine the $_1\{$ $_2$ m ixing coe cient, , eq.(26), as

Note that is independent of the normalization of the form factor $f(k_2)$, eq.(12). In fact, the parameter centers only the mass of the 0 meson, cf. eqs.(25, 37); we do not need to determine its value since the result can directly be expressed in terms of m $_{0}$. Thus, eq.(51) gives

For the standard value of the 0 m ass, m $_{\circ}=1300\,\text{M}$ eV, this com es to f $_{\circ}=0.48\,\text{M}$ eV, while for a low mass of m $_{\circ}=750\,\text{M}$ eV one obtains f $_{\circ}=1.46\,\text{M}$ eV. The excited pion leptonic decay constant is thus very small, which is a consequence of chiral symmetry. Note that, as opposed to the qualitative results discussed above, the numerical values here depend on the choice of form factor, eq.(19), and should thus be regarded as a rough estimate.

We rem ark that the numerical values of the ratio $f \circ = f$ obtained here are comparable to those found in chirally symmetric potential models [17]. However, models describing chiral symmetry breaking by a vector (type conning potential (linear or oscillator) usually understimate the normal pion decay constant by an order of magnitude [9]. Such models should include a short (range interaction (N JL (type), which is mostly responsible for chiral symmetry breaking.

The small value of f \circ does not imply a small width of the $^{\circ}$ resonance, since it can decay hadronically, e.g. into 3 or $^{\circ}$. Such hadronic decays can also be investigated in the chiral Lagrangian fram ework set up here. This problem, which requires the evaluation of quark loops with external meson elds of dierent 4 (momenta, will be left for a future investigation.

In conclusion, we have outlined a simple fram ework for including radial excitations in an elective Lagrangian description of mesons. The Lagrangian obtained by bosonization of an NJL (model with separable interactions exhibits all qualitative properties expected on general grounds: a Goldstone pion with a nite decay constant, and a massive \excited state" with vanishing decay constant in the chiral limit. Our model shows in a simple way how chiral symmetry protects the pion from modications by excited states, which in turn in uences the excited states' contribution to the axial current. These features are general and do not depend on a particular choice of quark (meson form factor. Furthermore, they are preserved if the derivative expansion of the quark loop is carried to higher orders.

In the investigations described here we have remained strictly within an elective Lagrangian approach, where the coupling constants and eld transformations are dened at zero momentum. We have no way to check the quantitative reliability of this approximation for radially excited states in the region of 1 GeV, i.e., to estimate the momentum dependence of the coupling constants, within the present model. (For a general discussion of the range of applicability of elective Lagrangians, see [22].) This question can be addressed in generalizations of the NJL model with quark con nement, which in principle allow both a zero (momentum as well as an on (shell description of bound states. Recently, rst steps were taken to investigate the full momentum dependence of correlation functions in such an approach [23].




Figure 1: The quark loop contribution to the quadratic form K $_{ij}$ (P), eq.(21), of the elective action of the $_1$ { and $_2$ { elds. The solid lines denote the NJL quark propagator. The $_1$ { eld couples to the quarks with a local vertex, the $_2$ { eld through the form factor, f (k,), represented here by a shaded blob.
