Strong U_A (1) breaking in radiative decays

A bstract

1 Introduction

It is well known that the QCD action has an approxim ate U_L (3) U_R (3) chiral sym m etry and its sub-sym m etry, U_A (1) sym m etry, is explicitly broken by the anomaly. The U_A (1) sym m etry breaking is manifested in the heavy mass of the 0 m eson. The physics of the and 0 m esons have been extensively studied in the $1=N_C$ expansion approach [1]. In the N_C ! 1 limit, the U_A (1) anomaly is turned o and then the meson becomes degenerate with the pion and the 0 m eson becomes a pure ss state with m 2 0 (Normally in 2 1 more 2 2 more 2 3. So

the U_A (1) anomaly pushes up m by about 400M eV and m $_0$ by about 300M eV. It means that not only the 0 meson but also the meson is largely a ected by the U_A (1) anomaly.

In order to understand the role of the U_A (1) anomaly in the low-energy QCD, it may be important to study the -meson decays as well as its mass and decay constant. Among the -meson decays, ! , ! II⁺ (1 denotes e and/or) and ! 0 decays are interesting. They have no nalstate interactions and involve only neutral mesons so that the electromagnetic transitions are induced only by the internal (quark) structure of the mesons.

The decay is related to the Adler-Bell-Jackiw (ABJ) triangle anomaly [3] through the partial conservation of axialvector current (PCAC) hypothesis. One of the useful and widely used fram eworks for studying the phenomena related to the axial-vector anom aly and the spontaneous chiral sym metry breaking is the chiral e ective meson lagrangian given by Wess and Zum ino [4] and developed by Witten [5]. The ; 0! decays have been studied using the Wess-Zum ino-Witten (WZW) lagrangian with the corrections at one-loop order in the chiral perturbation and it has been shown that the two-photon decay widths can be explained with the -0 m ixing angle ' 20 [6]. From the chiral perturbation theory (ChPT) [7] point of view, the W ZW term is derived in the chiral lim it and is of order p4. As discussed in [8], to reliably calculate SU (3) breaking e ects of the ; 0! 2 decays, the low-energy expansion to order p6 has to be carried out. However in [6] full analysis of order p⁶ has not been performed. Furtherm ore, because of the U_A (1) anomaly, the singlet channel decay amplitude derived using PCAC + ABJ anomaly should be modied so as to become renormalisation group invariant [9].

The ! ll decay is closely related to the ! decay since it is considered as ! ! ll . By observing the muon pair invariant mass square spectrum of the ! ll decay, one is able to obtain the transition form factor for the vertex. It gives us the information of the size of the meson. In [10] the transition form factors for the 0 , and 0 vertices have been studied in the vector meson dominance model, the constituent quark loop model, the QCD—inspired interpolation model by Brodsky-Lepage and the ChPT. However none of the models have taken into account the elects of the Ua (1) anomaly explicitly.

decay, there is no low-energy theorem for the Unlike the decay and therefore it is not trivial. In ChPT [11{13}, there is no lowest order $0 (p^2)$ contribution to the ! 0 process because the involved mesons are neutral. Likewise the next order O (p4) tree diagrams do not exist. Thus the 0 (p⁴) one-loop diagram s give the leading term in this process, but the contribution is two orders of magnitude smaller than the experimental value. This is because the pion loop violates the G-parity invariance and the kaon loop is also suppressed by the large kaon mass. The O (p6) contributions are dominant and the result is a factor two smaller than the experimental value. Although these results based on ChPT are not too far from the experimental value, it is noted that the higher order 0 (p^6) term s in the perturbation expansion are larger than the leading 0 (p4) term s and the results contain am biguous param eters that cannot be determined well from other processes.

The purpose of this paper is to study the !, ! ! and !

decays in the fram ework of a chiral quark model so that the quark structure of the meson is explicitly taken into account. In such a model the explicit chiral symmetry breaking by the current quark masses can be included in a nonperturbative way. The elects of the $\rm U_A$ (1) anomaly can also be represented by the coupling of light quarks to the instanton as was pointed out by 't Hooff [14]. We here take the three-avor Nambu-Jona-Lasinio (NJL) model as the chiral quark model. The model involves the $\rm U_L$ (3) $\rm U_R$ (3) symmetric four-quark interaction and the six-quark avor-determinant interaction [14,15] incorporating elects of the $\rm U_A$ (1) anomaly. It is widely used in recent years to study such topics as the quark condensates in vacuum, the spectrum of low-lying mesons, the avormixing properties of the low-energy hadrons, etc. [16{21}. In this approach the explicit chiral symmetry breaking and the $\rm U_A$ (1) anomaly on the $\rm !$

! 11^{+} and ! 0 decay am plitudes can be calculated consistently with those on the -m eson mass, decay constant and mixing angle within the model applicability. Furthermore one is able to study how the -m eson properties change when the strength of the U_{A} (1) breaking interaction is changed in this approach.

We have studied the ! decay [22] and the ! 0 decay [23] in this approach and found that these decay widths are reproduced when the $U_{\rm A}$ (1) breaking interaction is much stronger than the previous studies in the three-avor NJL model [16{21}. The $U_{\rm A}$ (1) breaking six-quark avor-determ inant interaction

induced by the instanton [14] gives rise to avormixing not only in the pseudoscalar channel but also in the scalar channel. It is further argued that the instanton can play an important role in description of spin-spin forces, particularly for light baryons [24{26]. Since the U_A (1) breaking interaction is found to be rather strong, it is in portant to reexam ine the e ects of the U_A (1) breaking interaction on the scalar quark contents in the nucleon, the $_{

m K\,N}$ term s and the baryon number one and two systems.

The paper is organized as follows. In sect. 2 we explain methods for calculating the -m eson m ass, m ixing angle and decay constant in the three- avor NJL model. We describe the calculations of the decay amplitudes in sect. 3. The numerical results of the -meson decays are presented in sect. 4. We study the uu, dd and ss contents in the nucleon and the $_{\rm N}$ and $_{\rm K\,N}$ terms in sect. 5. Sect. 6 is devoted to the study of the e ects of the U_A (1) breaking interaction on the baryon number one and two systems. Finally, summary and concluding remarks are given in sect. 7.

2 -m eson in the three-avor NJL model

Here the quark eld is a column vector in color, avor and Dirac spaces and a (a = 0:::8) is the U (3) generator in avor space. The free D irac lagrangian L_0 incorporates the current quark mass matrix $m^2 = diag (m_u; m_d; m_s)$ which breaks the chiral U_L (3) U_R (3) invariance explicitly. L_4 is a QCD motivated four-ferm ion interaction, which is chiral U_L (3) U_R (3) invariant. The 't Hooft determ in ant L_6 represents the U_A (1) anomaly. It is a 3 determ in ant with respect to avor with i; j = u;d;s.

Quark condensates and constituent quark masses are self-consistently deter-

So depends on q^2 . At $q^2 = m^2$, represents the mixing angle of the ⁸ and ⁰ components in the -meson state. In the usual elective pseudoscalar meson lagrangian approaches, the and ⁰m esons are analyzed using the q^2 -independent - ⁰m ixing angle. Because of the q^2 -dependence, cannot be interpreted as the

- 0 m ixing angle. The origin of the q^{2} -dependence is that the $\,$ and $\,$ 0 m eson have the internal quark structures.

For the 0 m eson, since the NJL m odel does not con ne quarks, the 0 -m eson state has the unphysical in aginary part which corresponds to the 0 ! qq decays. Therefore we do not apply our model to the 0 m eson in this article.

We de ne the elective -quark coupling constant g by introducing additional vertex lagrangian,

Here is an auxiliary meson eld introduced for convenience and the elective -quark coupling constant is calculated from the residue of the qq-scattering amplitudes at the pole, i.e. $g^2 = \lim_{q^2 \mid m^2} (q^2 - m^2) D - (q^2)$. The decay constant f is determined by calculating the quark-antiquark one-loop graph,

One can easily show that in the U_A (1) \lim it, i.e., $G_D=0$ and $m_{u;d} \notin m_s$, the meson becomes the ideal mixing state composed of u and d-quarks, namely, m=m, g=g, f=f and $tan=\frac{p}{2}$.

Finally, $f_0^2 = 0$) ' $f_0^2 = 0$) ' $f_0^2 = m^2$) and $f_0^2 = m^2$ and $f_0^2 = m^2$) are assumed in the usual analysis of the -0 m ixing angle [27]. Since m and m o are not significantly smaller than the typical hadronic mass scale, the above results should not be taken quantitatively. Furthermore, because of the ABJ anomaly by the gluons (U_A (1) anomaly) in the avor singlet channel, the saturation of the avor singlet axialvector current by the and 0 eld is rather questionable.




Figure 1: The quark triangle diagram for 0; ! decays.

We can see that the integrand of F_p^a has an unphysical pole when m_p 2M $_a$. It is due to lack of the con nement mechanism in the NJL model.

In the chiral lim it, the pion mass vanishes and F u_0 becomes 1=M $_u$. In this lim it, the Goldberger-Treim an (GT) relation at the quark level, M $_u$ = gf, holds in the NJL model and this leads to a_0 ! = =(f) which is same as the tree-level results in the W ess-Zum ino-W itten lagrangian approach [4,5]. It should be mentioned that we have to integrate out the triangle diagram s without introducing a cuto in order to get the above result though the cuto is introduced in the gap equations in the NJL model. In the U(3) $_L$ U(3) $_R$ version of the NJL model, the W ZW term has been derived using the bosonization method with the heat-kernel expansion [29,30]. In their approach, O(1=) term has been neglected and it is equivalent to taking the ! 1 lim it.




Figure 2: The quark triangle diagram for 0 ; ! 11^{+} decays.




Figure 3: The quark box diagram for ! decay.

We evaluate A and B num erically and further integrate (65) to obtain the $\,^{\,0}$ decay rate.

4 Numerical results

4.1 -m eson m ass, m ixing angle and decay constant

We discuss our numerical results of the -m eson mass m, mixing angle and the decay constant f in this subsection. The parameters of the NJL model are the current quark masses m_u = m_d, m_s, the four-quark coupling constant G_S, the U_A (1) breaking six-quark determinant coupling constant G_D and the covariant cuto . We take G_D as a free parameter and study meson properties as functions of G_D. We use the light current quark masses m_u = m_d = 8.0 MeV to reproduce M_u = M_d ' 330 MeV (' 1=3M_N) which is the value usually used in the nonrelativistic quark model. Other parameters, m_s, G_S and , are determined so as to reproduce the isospin averaged observed masses, m = 138.0 MeV, m_K = 495.7 MeV and the pion decay constant f = 92.4 MeV.

We obtain m $_{\rm S}=193$ M eV , =783 M eV , M $_{\rm u,d}=325$ M eV and g $_{\rm qq}=3.44$, which are almost independent of G $_{\rm D}$. The ratio of the current s-quark m ass to the current u,d-quark m ass is m $_{\rm S}$ =m $_{\rm u}=24.1$, which agrees well with m $_{\rm S}$ =m $^{\circ}=24.4$ 1.5 (m $^{\circ}=\frac{1}{2}$ (m $_{\rm u}$ + m $_{\rm d}$)) derived from ChPT [34]. The kaon decay constant f $_{\rm K}$ is the prediction and is almost independent of G $_{\rm D}$. We have obtained f $_{\rm K}=97$ M eV which is about 14% sm aller than the observed value. We consider this is the typical predictive power of the NJL model in the strangeness sector. The quark condensates are also independent of G $_{\rm D}$ and our results are huui $^{\frac{1}{3}}=216$ M eV and hssi $^{\frac{1}{3}}=226$ M eV , which give

As reported in the previous studies in the NJL model, the Gell-Mann-Oakes-Renner relations hold well for both the pion and kaon sectors.




Figure 4: Dependence of the $\,$ m eson m ass on the dim ension-less coupling constant G $_{D}^{\,\rm e}$. The horizontal dashed line indicates the experim ental value.




Figure 5: Dependence of the mixing angle on the dimension-less coupling constant G_D^e . The horizontal dashed line indicates the experimental value.

We de ne dimensionless parameters $G_D^e = G_D (=2)^4 N_c^2$ and $G_S^e = G_S (=2)^2 N_c$. The calculated results of the -m eson mass m and the mixing angle are shown in Fig. 4 and Fig. 5, respectively. When G_D^e is zero, our lagrangian does not cause the avormixing and therefore the ideal mixing is achieved. The \ " is purely uu + dd which corresponds to = 54:7 and is degenerate to the pion in this limit.

It may be useful to compare our results with those in the 1=N $_{\rm C}$ expansion approach. In the 1=N $_{\rm C}$ expansion approach, with the inclusion of the O (1=N $_{\rm C}$)




Figure 6: Dependence of the $\,$ m eson m ass on the m ixing angle. The solid line indicates the result calculated in the NJL m odel and the short-dashed line indicates that in the $1=N_{\rm C}$ expansion approach. The horizontal long-dashed line shows the experimental $\,$ m eson m ass.

From Eqs. (76) and (77), it is obvious that in the U_A (1) $\lim_{}^{}$ it the $\lim_{}^{}$ and $\lim_{}^{}$ become the ideal mixing state with m = m ' 138 M eV and m $_0$ = $\lim_{}^{}$ $\lim_{}^{}$ $\lim_{}^{}$ ' 687 M eV . We compare the dependence of the meson mass on the mixing angle calculated in the NJL model with that given in Eq. (77) in the $1=N_C$ expansion approach in Fig. 6 and nd that the meson mass calculated in the NJL model is somewhat smaller than that in the $1=N_C$ expansion approach at the same mixing angle (except for the ideal mixing point) though the shapes are similar. The value of the mixing angle is one of the important quantity to understand the physics of the and $\lim_{}^{}$ mesons. The mixing angle determined from the $\lim_{}^{}$ mass formula is often discussed in the literature. However since the meson mass is not so sensitive to the mixing angle as shown in Fig. 6, it is not suitable to determine the mixing angle from the meson mass.

We next discuss the decay constant f. The calculated decay constant




Figure 7: Dependence of the decay constant f on the dimension-less coupling constant $G_{\,\mathrm{D}}^{\,\mathrm{e}}$.

is shown in Fig. 7. It is almost independent of G_D and f' f. For example, f = 91.2 M eV at $G_D^e = 0.7$. Therefore it seems that the meson does not lose the Nambu-Goldstone boson nature though its mass and mixing angle are strongly a ected by the U_A (1) breaking interaction.

The charged pion and kaon decay constants can be directly obtained by measuring the ! and K ! decays. On the other hand the decay constants for the light neutral pseudoscalar mesons 0 , and 0 cannot be obtained from the direct measurements. As discusses in Sect. 3.1, they are related to the P! decay amplitudes in the soft limit. It is widely accepted that the soft meson limit is close to the on-shell point in the pion case. However it is the matter of discussions how good the soft and 0 limits are. We will discuss this point in the next section by comparing the ! decay amplitude which is directly calculated in the NJL model with that obtained using PCAC + ABJ anomaly in the soft limit.

Since the NJL model does not con ne quarks, the 0 meson is not a bound state. Therefore we do not apply our model to the 0 meson. On the contrary, the meson appears as a bound state. Nevertheless, one may ask whether the present model is applicable to the meson since the binding energy of the meson (2M $_{\rm u}$ m) is much smaller than those of the pion and kaon. In order to con rm it, we study the constituent u, d-quark mass dependence of the meson properties. By changing the current u, d-quark mass m $_{\rm u,d}$ from 7.5 MeV to 8.5 MeV, the constituent u,d-quark mass M $_{\rm u,d}$ is changed from about 300 MeV to 360 MeV. O there parameters of the model are chosen so as to reproduce the experimental values of m, m $_{\rm K}$, m, and f. This change causes the change of the binding energy of the meson from about 50 MeV to 170 MeV. The change of the calculated decay constant is within 2% and the change of the calculated mixing angle is within 12%. This stability of the meson properties indicates that the NJL model can describe the essential feature of the meson.

4.2 ! decay

The recent experimental results of the 0 ; ! decay widths are (0 !) = 7:7 0:6 eV and (!) = 0:510 0:026 keV [35] and the reduced amplitudes are

Here we have used the two photon measurement result for the ! decay width. From Eq. (44) and Eq. (45), we get $f_! = (5=3)f_{0!}$ in the U_A (1) lim it. Therefore in order to reproduce the experimental value of $f_!$, the elect of the U_A (1) anomally should reduce $f_!$ by a factor 3/5.

We rst discuss the 0 ! decay. The calculated result is $^{\circ}f_{0!}=2.50$ 10^{11} (1=eV) which agrees well with the observed value given in Eq. (78). The current algebra result is $^{\circ}f_{0!}==(f)=2.514$ 10^{11} (1=eV), and thus the soft pion limit is a good approximation for 0 ! decay. The chiral symmetry breaking a ects $^{\circ}f_{0!}$ in two ways. One is the deviation from the G-T relation and another is the matrix element of the triangle diagram $^{\circ}f_{0!}$ 0 our numerical results are $^{\circ}g_{0!}=3.44$, $^{\circ}f_{0!}=3.52$ and $^{\circ}f_{0!}=1.015$, therefore the deviations from the soft pion $^{\circ}f_{0!}=3.52$ and $^{\circ}f_{0!}=1.015$, relation and the matrix element of the triangle diagram.




Figure 8: Dependence of the $\,\,!\,\,$ decay am plitude on the dim ension-less coupling constant G $_{\rm D}^{\rm e}$. The horizontal dashed line indicates the experim ental value.

Let us now turn to the discussion of the ! decay. The calculated results of the ! decay amplitude $\hat{\mathbf{f}}_!$ is given in Fig. 8. The experimental value of the ! decay amplitude is reproduced at about $G_D^e = 0.7$. The calculated -m eson mass at $G_D^e = 0.7$ is m = 510 MeV which is 7% smaller than the observed mass. As for the elects of the symmetry breaking on $\hat{\mathbf{f}}_!$, our results are F (u;) $M_u = 1.36$ and F (u;)=F (s;) = 1.99 at $G_D^e = 0.7$. Therefore it seems that the soft $f_{0}^e = 0.7$. Therefore it seems that the soft $f_{0}^e = 0.7$. Recently, Bernard et al. [36] calculated the ! decay width using a similar model. They used a rather weak instanton induced interaction and their result of (!) is about 50% bigger than the experimental value. It is understandable from our analysis.

 $G_D^e = 0.7$ corresponds to G_D hssi= $G_S = 0.44$, suggesting that the contribution from L_6 to the dynam icalm assofthe up and down quarks is 44% of that from L_4 . In the previous study of the and 0 m esons in the three-avor NJL m odel [16{21],

the strength of the instanton induced interaction has been determ ined so as to reproduce the observed 0 m ass though the 0 state has the unphysical decay m ode of the 0 ! uu;dd. The strength determ ined from the 0 is much smaller than $G_{D}^{e}=0:7$, about 1/4 of the present case. One of the shortcom ings of the NJL model is the lack of the connem ent mechanism. It is expected that the connem ent gives rise to the attractive force between quark and antiquark in the 0 m eson to prevent the 0 m eson from decaying to the quark and antiquark pair.

In the PCAC + ABJ anomaly approach, if one assumes the SU (3) symmetry, i.e., $f_8 = f$, and using Eqs. (42) and (43), the mixing angle—and the meson decay constant in the avor singlet channel f_0 can be determined so as to reproduce the observed (!) and (0 !). The results are = 17.4 and f_0 =f=1.1. The pion and kaon loop corrections are then included in ChPT [6] and the results are = 21.8, f_8 =f=1.25 and f_0 =f=1.07.

In the NJL model, the mixing angle at $G_D^e = 0.7$ is = 1.3 and that indicates a strong OZI violation and a large (u,d)-s mixing. This disagrees with the \standard" value ' 20 obtained in the PCAC + ABJ anomaly approach and ChPT. One of the origin of the dierence is that the mixing angle in the NJL




Figure 9: The avor singlet decay constant f_0 which is determined so as to reproduce the observed ! decay width as a function of using the formula derived in the PCAC + ABJ anomaly approach. The solid line indicates in the case of f_8 = f and the dashed line indicates in the case of f_8 = 1.25 f .

m odel depends on p^2 of the $\overline{q}q$ state and thus rejects the internal structure of the meson. On the contrary the analyses in the PCAC + ABJ anomaly approach and ChPT assume an energy-independent mixing angle, i.e., $(p^2 = m^2) = (p^2 = m^2_0)$. A nother point is that the SU (3) breaking of the ! decay amplitude is rather large in the NJL model as we have shown above. It indicates that the soft and p^0 limits used in the PCAC + ABJ anomaly approach are not so good. In the ChPT point of view, it suggests that the tree diagram contributions from p^0 0 (p^0 0) terms may be rather large.

If the PCAC + ABJ anomaly approach is considered not to be applied for the 0 ! decay, then one cannot determ ine the mixing angle and the avor singlet decay constant f_0 from the observed ; 0 ! decay widths. However the relation between and f_0 can be obtained from Eq. (42) only by the ! decay amplitudes assuming that f_8 is given. Fig. 9 shows the f_0 relations for the SU (3) value f_8 = f and the ChPT estimation f_8 = 1.25f. One sees that a smaller avor singlet component of the meson corresponds to a smaller f_0 . It




Figure 10: Dependence of the $\,\,!\,\,$ $^+$ decay width on the dimension–less coupling constant G $_D^e$. The horizontal solid line indicates the experimental value and the dashed lines indicate its error widths.

is not strange that f_0 is smaller than f since the 0 m eson has larger gluonic component than pion because of the U_A (1) anomaly.

4.3 ! 11⁺ decay




Figure 11: Dependence of the ! e e^+ decay width on the dimension—less coupling constant G_D^e . The horizontal solid line indicates the experimental value and the dashed lines indicate its error widths.

and the calculated ! $^+$ and ! $e e^+$ decay widths are shown in Fig. 10 and Fig. 11 respectively. At $G_D^e = 0.70$ where the ! decay width is reproduced, we obtain (! $^+$) = 0.407 eV, which is in good agreement with the experimental result shown in (80). On the other hand, our calculated

result of the ! e e^+ at $G_D^e = 0.70$ is $(! e e^+) = 9.72$ eV, which is about 50% bigger than the observed value given in (81).

It is clear from the electron-positron pair invariant mass square spectrum of the ! $e e^+$ decay given in Eq. (48) that the strength is mostly saturated in the small region just above $q^2 = (2m_e)^2$. Since in this region, the transition form factor $f(q^2)$ is almost unity and the radiative corrections are found to be negligible [37], the ! $e e^+$ decay width is strongly related to the ! decay width and it is rather hard to explain the present experimental values of (!) and (! $e e^+$) simultaneously.




Figure 12: q^2 -dependence of the transition form factor f (q^2) calculated at $G_D^e = 0.7$

The calculated transition form factor f (q^2) at $G_D^e = 0.7$ is shown in Fig. 12 and the calculated slope parameter de ned in Eq. (55) is = 0.94 GeV. The recent experimental results of the slope parameter are as follows. The TPC=2 Collaboration at the SLAC gives = 0.70 0.08 GeV [38] and the CELLO Collaboration at the DESY gives = 0.84 0.06 GeV [39]. So our result is somewhat larger than the experimental results. As for the slope parameter of

the 0 form factor, our model gives the simple result in the chiral limit, i.e., $= \frac{p}{12M_{u}}$ 1:126 GeV, which is also larger than the CELLO result $= 0.75 \quad 0.03 \text{ GeV}$ [39].

Am etller et al. [10] studied the transition form factors for the P vertices with $P = {}^{0}$, and 0 using the most successful and/or traditional models of the low-energy QCD including the vector meson dominance model (VMD), the constituent quark loop model (QL), the QCD-inspired interpolation model by Brodsky-Lepage (BL) and the ChPT. They concluded that all the models considered agree in the correct value for a m ean $_{\rm P}$, but dier in the breaking pattern of the SU (3) avor sym metry. Our approach is close to QL approach. In Ref. [10], a rather small constituent quark mass (Mux) '023GeV) has been used and that is the main reason why QL prediction of is in reasonable agreem ent with the experim ental results. However, it should be noted here that since the constituent quark mass used in QL is smaller than m = 2, the unphysical imaginary part appears in the ! transition amplitude corresponding to the unphysical channel! uu;dd.

Our interpretation of the present result in the NJL model is as follows. Since the pseudoscalar mesons in the NJL model have the quark-antiquark structures and therefore have the size. For the vertices, it is roll 1= 9 ZM $_{u}$ / 0:43 fm, which is about 67% of the experimental value roll 6= 0:64 fm. Our result of the vertex size is r = 9 6= 0:64 fm, which should be compared with the experimental results r our line of the quark-antiquark correlations in the vector channel may solve the problem of the dilerence of the sizes for the P vertices between our results and the experimental ones.

4.4 ! 0 decay

The experimental value of the ! 0 decay width is $[35]^{5}$




Figure 13: Dependence of the ! decay width on the dimension-less coupling constant G_D^e . The horizontal solid line indicates the experimental value and the dashed lines indicate its error widths.

and the calculated ! decay width is shown in Fig. 13. At $G_D^e = 0.70$ where the ! decay width is reproduced, we obtain (! $^0) = 0.92eV$, which is in good agreement with the experimental data shown in (82).

In ChPT [11,12], since the lowest order 0 (p²) term and the next order 0 (p⁴) tree diagram s do not contribute to the ! 0 process, the 0 (p⁴) one-loop diagram s are the leading contributions. The calculated pion and kaon one-loop contributions to the ! 0 decay width are (4) (! 0) = 0.84 10^3 eV, $^{(4)}_{K}$ (! 0) = 2.45 10^3 eV and $^{(4)}_{K}$ (! 0) = 0.84 10^3 eV, which are m ore than two orders of magnitude below the observed width (82). This is because the pion loop violates the G-parity invariance and the kaon loop is also suppressed by the large kaon m ass. At 0 (p⁶), there exists contribution coming from tree diagram s, one-loops and two-loops. The loop contributions are smaller than those from the order 0 (p⁴). In [11], the coupling strengths of the 0 (p⁶) tree diagram s are determined assuming saturation by the scalar meson a₀ (980) and the tensor meson a₂ (1310) resonances as well as the and! vector meson resonances. The obtained resonance contributions are $^{(6)}_{+!}$ (! 0) = 0:18eV and $^{(6)}_{+!+a_0+a_2}$ (! 0) = 0:18 0:02eV. The contributions of other mesons, such as b₁ (1235); h₁ (1170); h₁ (1380) [40] and other tree diagram s [13], are found

to be small. Therefore, up to 0 (p^6), ChPT estimation of the ! 0 decay width is about 1/4 of the experimental result.

On the other hand in [41] the O (p6) tree diagrams are evaluated by using the extended NJL (ENJL) model [42]. They calculated three contributions in ENJL, namely, the vector and scalar resonance exchange and the quark-loop contributions. Their result is (! 0)' 0.5 eV. They further introduced the 0 (6)chiral corrections as well as the axialvector and tensor meson exchange contribu-0 tions, and nally obtained (!) = 0.58 0.3 eV.A recent similar analysis in ENJL concludes som ewhat smaller value for the decay width [43]. The difference between our approach and that in [41] are as follows. The ENJL model lagrangian has not only the scalar-pseudoscalar four quark interactions but also the vector-axialvector four quark interactions. However, the $U_{\rm A}$ (1) breaking is not explicitly included in their model and therefore the duced by hand with the mixing angle = 20. We stress that the introduction of the U_A (1) breaking interaction is in portant to understand the structure of m eson. There is another di erence. The coupling constants of the chiral




Figure 14: Spectrum of the photon invariant mass m 2 .

e ective meson lagrangian predicted in the ENJL model are parameters of the Green function evaluated at zero momenta. On the other hand we evaluate the quantities at the pole position of the mesons.




Figure 15: Spectrum of the photon energy E.

Calculated spectrum of the photon invariant mass square m 2 for the ! decay is shown in Fig 14. As this spectrum is compared with those calculated by ChPT in [13], we not ours to be similar to the one for $d_3 = 4.5 ext{ } 10^2$ GeV 2 in [13] which involves an additional O (p 6) contribution to the original lagrangian. Spectrum of the photon energy E for the ! 0 decay is shown in Fig 15, and given in [11] in ChPT. Both are also similar, though there is no experimental result.

In our calculation of the ! decay, we evaluate only the quark-box diagram given in Fig 3. Since the vector and axialvector four-quark interactions are not included in our model, the only other contribution to this process is the scalar resonance exchange. In the ENJL model the contribution of the scalar resonance exchange is small [41]. The relevant process is ! a_0 0 ! 0 . Since the a_0 ! decay amplitude is known to be small experimentally, the scalar resonance contribution is suppressed. Although the elect of the scalar

channel quark-antiquark correlation is not taken into account in our calculation, the scalar resonance contribution is (partly) included in the box diagram.

If one includes the vector and axialvector four-quark interaction in the NJL model, the pseudoscalar meson properties are a ected through the pseudoscalar-axialvector channelmixing and the model parameters with and without the vector and axialvector four-quark interaction are dierent. We expect that the models with and without the vector-axialvector interaction predict similar results for the processes involving only the pseudoscalar mesons with energies much below the vector meson masses. It is further argued that the contribution of the quark-box diagram to the $\frac{1}{2}$ 0 process, that is similar to $\frac{1}{2}$ 0, is quite close to that of the vector meson exchange in the vector dominance model [44].

5 Scalar Quark Contents in Nucleon

The U_A (1) breaking six-quark avor-determ inant interaction L_6 given in Eq. (4) gives rise to avor mixing not only in the pseudoscalar channel but also in the scalar channel. Therefore, it is important to study the e ects of the U_A (1)

breaking interaction in the scalar og channels.

In the NJL model, it is known that the masses of the scalar mesons become just the twice of the constituent quark mass in the chiral limit. Introducing the explicit breaking of the chiral symmetry by the current quark masses pushes up the scalar meson masses above the quark-antiquark threshold. Since the NJL model does not conne quarks, we do not apply it to the scalar mesons in this article.

In this section we will discuss the scalar quark contents in nucleon as well as the pion-nucleon sigm a term $_{\rm N}$ and the kaon-nucleon sigm a term $_{\rm K\,N}$. We use a rather naive additive quark model for the nucleon state, namely, the nucleon is made up by three noninteracting constituent quarks whose masses are determined by the gap equation shown in Eq. (5). The scalar quark content of avora in the proton is then obtained as follows.

with J i (D i) is the constituent u-(d-) quark state. The amount of the qq content of avora in a constituent quark Q of avorb is deduced by using the Feynman-Hellman theorem, i.e.,

where m_a and M_b are the current and constituent quark m asses, respectively. Here the isospin sym m etry is assumed and therefore the following relations hold. HU juuJU i = hD jddJU i = hD juuJU i = hD jssJU i = hD




Figure 16: Dependence of the scalar quark contents in the constituent u-quark on the dimension-less coupling constant G_D^e . The solid line, dashed line and dotted line indicate hU juujU i, hU jddjU i and hU jssjU i, respectively.

We have calculated the scalar quark contents in the constituent u-quark as functions of G_D^e and the results are shown in Fig. 16. At $G_D^e=0$, both MJ jiddJ i and MJ jssJJ i vanish as expected. Because of the larger mass of the strange quark, MJ jssJJ i is strongly suppressed compared to MJ jiddJ i. At $G_D^e=0.7$, our results are

and therefore, the strange quark content in the proton is rather small,

This value is smaller than the \standard" value y 0.2. However, as we will see later, our result depends on the choice of the current u,d-quark mass and therefore should not be taken seriously.

Assuming the isospin symmetry, the $_{\rm N}$ and $_{\rm K\,N}$ terms are represented using the scalar quark contents in the nucleon as follows.




Figure 17: Dependence of the $_{\rm N}$ and $_{\rm K\,N}$ terms on the dimension-less coupling constant $G_{\rm D}^{\,\rm e}$. The solid line indicates $_{\rm N}$ term and the dashed line indicates $_{\rm K\,N}$ terms, respectively.

with m = $(m_u + m_d)$ =2. The calculated $_N$ and $_{KN}$ terms are shown in Fig. 17. The $_N$ term is almost independent on G_D^e . At G_D^e = 0:7, we obtained $_N$ = 43.2 M eV which is in good agreement with the value extracted from the low-energy N scattering data [45]: $_N$ = (45 10) M eV. As for the $_{KN}$ term, our result at G_D^e = 0:7 is 280 M eV.

In the additive quark assumption of the nucleon states, the following relation holds.

Therefore, it vanishes if there exists no avorm ixing in the scalar channel. Our result at $G_D^e = 0.7$ is hP j2dd uu jP i = 0.89.

$\Sigma_{\pi N}$ and Σ_{KN} [MeV]

The pion-nucleon sigm a term and the scalar quark contents in the nucleon are extensively studied in the three- avor NJL model in Ref. [18]. As pointed out there, the scalar quark contents in the constituent quarks depend on the current quark masses nonlinearly. In order to study this nonlinearity, we change the current u,d-quark mass from 7.5 MeV to 8.5 MeV. O ther four parameters of the model (ms, Gs Gp and) are determined so as to reproduced the observed values of m, m, m, and f. Thus the size of the chiral symmetry breaking is xed though the current u,d-quark mass is changed. The calculated results are shown in Table 1. The scalar quark contents in the constituent u-quark and the sigma terms, especially, NU jss jU i and $_{\rm K\,N}$ depend on the current u,d-quark mass rather strongly.

We next discuss the validity of the additive quark assumption for the nucleon state. Kunihiro and Hatsuda [17,46] studied the elects of the connement and the short-range spin-spin interaction between the constituent quarks in baryons in the framework of the nonrelativistic potential model. They have found that the elects of the residual interactions between the constituent quarks in the

proton increase the uu, dd and ss contents of the proton by about 5%, 24% and 13%, respectively. The contributions of the kinetic term of the con ned quark are avor independent and negative, while those of the short-range spin-spin interaction are avor dependent and positive. The avor-mixing elect by the short-range spin-spin interaction is rather large. For simplicity, we consider the hU jdd jU i = hU jss jU i = 0 case. U sing the expression of hP jqiqi jP i given in Ref. [17], one obtains

where $b = (176.4 \text{M eV})^3$ is the strength of the short-range spin-spin interaction. Inserting our num erical results at $G_D^e = 0$, i.e., $M_u = 325 \, \text{M eV}$ and $M_U = 1.79$, we get $M_U = 1.79$.

Recently, the static properties of the nucleon have been studied in the relativistic Faddeev approach using the two-avor NJL model [47]. Their results of the scalar quark contents in the nucleon are hP juu jP i=1:795 and hP jdd jP i=1:095. Since the single quark renormalization factor 0M =0m is not included in their calculations, one should compare above numbers with those in the additive quark model, i.e., hP juu jP i=2 and hP jdd jP i=1. The residual interactions between quarks in the nucleon decrease the u-quark content by about 10% and increase the d-quark content by about 10%. It is a contrast to the results in the nonrelativistic quark model. As for the avormixing elect, one gets hP j2dd uu jP i=0:395hU juu jU i'=0:71. Here we have used our result: hU juu jU i=1:79. In the nonrelativistic quark model approach, the avormixing elect entirely comes from the short-range spin-spin interaction. On the other hand, in the relativistic Faddeev approach, only the scalar diquark state is included. Inclusion of the axialvector diquark may be important for the avor

m ixing in the scalar quark contents in the nucleon.

In the above two approaches, the e ects of the pion cloud around the quark-core of the nucleon is not taken into account. Wakamatsu has studied the scalar quark contents in the nucleon using the chiral quark soliton model as functions of the constituent u,d-quark mass [48]. His results are as follows. At Muxl = 350M eV, hP juu jP i = 1:807, hP jdd jP i = 1:223 and at Muxl = 450M eV, hP juu jP i = 1:382, hP jdd jP i = 0:978. As discussed in [48], the avor-asymmetry of the sea-quark in the nucleon gives rise to the avor mixing phenomena and the calculated results are hP j2dd uu jP i = 0:639 at Muxl = 350M eV and hP j2dd uu jP i = 0:574 at Muxl = 450M eV. Since the chiral quark soliton model do not have the dynamics of the spontaneous breaking of chiral symmetry, the elects of the single quark renormalization factor @M = @m is not taken into account.

In conclusion, as is expected, the avor mixings in the scalar channel are approximately proportional to the strength of the $U_{\rm A}$ (1) breaking interaction in the NJL model. However their magnitudes depend on the choice of the model parameters. Furthermore, the scalar quark contents in the proton have many origins, and therefore we cannot draw a denite conclusion on the excess of the $U_{\rm A}$ (1) breaking interaction.

6 E ects of the U_A (1) A nomaly in Baryons

Since the e ects of the U_A (1) anomaly are rather large in the pseudoscalar sector, it is natural to ask if one can see some e ects in the baryon sector. It was pointed out in [24] that the instanton can play an important role in the description of spin-spin forces, particularly for light baryons. The pattern of these e ects can be very hard to disentangle from one-gluon exchange. The e ects of the instanton induced interaction in baryon number B=2 systems were studied in [25]. It was shown that an attraction between two nucleons is obtained by the two-body instanton induced interaction, while the three-body interaction is strongly repulsive in the H-dibaryon channel and makes the H-dibaryon almost unbound.

We estimate the elects of the U_A (1) anomaly on the B=1 and B=2 systems by employing the six-quark determinant interaction given in Eq. (4) whose strength was determined so as to reproduce the observed -m eson mass,

the ! decay width and the ! 0 decay width, namely, $G_{D}^{e}=0.7$. It is done by calculating the matrix elements of the the U_{A} (1) breaking interaction ham iltonian with respect to unperturbed states of the M IT bag model and the nonrelativistic quark model (NRQM). For B=2 systems, we only consider the $(0S)^{6}$ conguration of the six valence quark states. Therefore, the matrix element with respect to such a state gives a measure of the contribution of the U_{A} (1) breaking interaction either to the dibaryon or to the short-range part of the interaction between two baryons. The determinant interaction induces not only three-body but also two-body interactions of valence quarks when the vacuum has a nonvanishing quark condensate. The details of the calculation are described in [26].

Table 2 shows the contribution of the two-body term for B=1. The contribution to the decuplet baryons vanishes in the SU (3) \lim it and therefore comes only from the SU (3) asymmetry of the quark wave function. The three-body term does not contribute to the B=1 states. Thus the N mass dierence due

to the U_A (1) breaking interaction is about 15% of the observed one.

We next discuss the case of B=2. We consider all the possible channels which are made of two octet baryons listed in Table 3. Table 4 shows the contribution of the two-body term. The channel VIII gets the strongest attraction, about 170 MeV, and the channel VIII gets the second strongest attraction. The contributions of the three-body term to the H-dibaryon and strangeness. I channels are given in Table 5. It should be noted that the three-body term has no elect on the NN channels, and that the contributions to the channels III, IV and V relect the SU (3) breaking in the quark wave function. The contributions of the three-body term in channels VI, VII and VIII are remarkable and one will be able to observe some elects experimentally.

We should comment on the dierence between the determinant interaction used here and the instanton-induced interaction used in ref. [25]. The relative contributions of the U_A (1) breaking interaction within the baryonic sector or within the mesonic sector are similar for the two interactions. However, the ratio of those in the baryonic sector to those in the mesonic sector is about $\frac{4}{7}$. Namely, if one xes the strength of the interaction so as to give the same mass dierence of and 0 , the elects of the instanton-induced interaction in the baryonic sector would be about $\frac{7}{4}$ stronger than those of the determinant interaction. After this

correction the strength of the present U_A (1) breaking interaction is consistent with that used in the calculation of the baryon-baryon interaction in ref. [25].

7 Sum m ary and conclusions

U sing an extended three—avor N JL m odel that includes the 't H ooft instanton induced U_A (1) breaking interaction, we have studied the ! , ! + , ! e e+ , and ! 0 decays as well as the -m eson m ass, decay constant and avor SU (3) singlet-octet m ixing angle of the m eson. A dvantages of our approach are as follows. (1) E ects of the explicit chiral sym m etry breaking by the current quark m asses and the U_A (1) anomaly can be evaluated consistently on the -m eson decay amplitudes. (2) One can study how the -m eson properties change when the strength of the U_A (1) breaking interaction is changed.

We have found that the -m eson mass, the ! , ! $^+$ and ! 0 decay widths are in good agreement with the experimental values when the U_A (1) breaking is strong and the mixing angle is about zero.

The calculated decay constant is almost independent of the strength of the U_A (1) breaking interaction and is close to the pion decay constant. It indicates that the meson does not lose the the N ambu-G oldstone boson nature though its mass and mixing angle are strongly a ected by the U_A (1) breaking interaction.

Our result of the mixing angle is about zero which is dierent from the value '20 obtained in the PCAC + ABJ anomaly approach and ChPT.We have discussed the possible origin of this dierence in Sect. 42. It should be stressed here that the '! decay width is used to obtain the mixing angle in the PCAC and ChPT approaches. However, since the 'meson is heavy, it is rather questionable to study the '! decay in the PCAC and ChPT approaches.

Since the 't Hooft instanton induced U_A (1) breaking interaction gives rise to the avormixing not only in the pseudoscalar qq channels but also in the scalar qq channels, we have studied the scalar quark contents in the nucleon, the pion-nucleon and the kaon-nucleon sigma terms. The calculated pion-nucleon sigma term is almost independent of the strength of the U_A (1) breaking interaction and in good agreement with the value extracted from the low-energy N scattering data. Concerning the avormixing elects, we have found that the amount of the avormixing in the scalar quark contents in the nucleon depends on the strength of the spontaneous breaking of chiral symmetry and the residual interactions

between the constituent quarks in the nucleon rather strongly. In this sense, the scalar quark contents of the nucleon are interesting and important quantities. Further studies are necessary.

We have estimated the elects of the U_A (1) anomaly on the baryon number B=1 and B=2 systems too. We have found that the N mass dierence due to the U_A (1) breaking interaction is about 15% of the observed one and the three-body term of the U_A (1) breaking interaction gives 40-50 MeV repulsion in the H-dibaryon channel.

Finally, we should note that the N JL m odeldoes not con nequarks. Since the N am bu-G oldstone bosons, , K and are strongly bound, the N JL can describe their properties fairly well. However the $^0\text{-m}$ eson state in the N JL m odel has an unphysical decay of 0 ! qq. Therefore, we do not apply our model to the 0 m eson. In order to study the role of the U_A (1) anomaly on the low-energy QCD further, the studies of the $^0\text{-m}$ eson properties are desirable.
