Enhanced photon production near the light { cone by a hot plasm a γ

Strong collinear divergences, although regularized by a therm alm ass, result in a breakdown of the standard hard therm alloop expansion in the calculation of the production rate of photons by a plasm a of quarks and gluons using therm all eld theory techniques.

1. IN FRARED AND COLLINEAR PROBLEM SAT FIN ITE T

1.1. H ard therm al loop resum m ation

In this talk, we study the production of soft photons by a hot quark gluon plasma. Indeed, this is a good way of testing our understanding of the infrared and collinear behavior of therm al gauge theories. Intuitively, these di culties are increased with respect to the T = 0 case, because of the presence in the Feynman rules of Bose-E instein factors $n_B(k_0) = 1 = (\exp(k_0=T) - 1)$ which can be large if k_0 is much smaller than the tem perature T. Concerning the collinear singularities, they can no longer be factorized in the hadronic structure functions since we are now in a decon ned phase.

To improve the infrared behavior of them al eld theories, a resum mation, known as the hard therm al loop (HTL) resum mation, has been proposed by [1]. Basically, this resum mation lies in the fact that certain therm al radiative corrections can be as large as the bare corresponding quantity. In particular, this is the case when the external legs of a propagator or vertex carry only soft m om enta (i.e. of order gT).

1.2. E ective propagators and vertices

In QCD, we need e ective gluon and quark propagators, as well as e ective vertices. The

resulting e ective theory turns out to be gauge invariant. For later reference, let us quote the e ective gluon propagator:

in a covariant gauge with gauge parameter , where the sum runs over the transverse and longitudinalmodes. The P are the adequate projectors. The corresponding self{energies are (see [1]):

where $m_g^2 = g^2 T^2 N + N_f = 2 = 9$. This resummed gluon propagator possesses two mass shells above the light cone: a transverse and a longitudinal one. Therefore, everything happens as if the gluon had acquired a kind of mass through thermal corrections, this mass being of order gT. Concerning the elective quark propagator, we will need only its hard momentum limit:


where $M_{f}^{2} = g^{2}C_{F}T^{2}=4$ is a therm alm assoforder gT (we started from m assless bare quarks).

To achieve gauge invariance in the e ective theory obtained by this resummation, we need also



some e ective vertices. In actual calculations, they are simply replaced by their diagram matic expansion (another way to deal with these vertices is to use the W ard identities veri ed by the HTLs). For example, the e ective qqg vertex reads (where a solid dot denotes an e ective vertex or propagator):



It is important to note that m ay exist some effective vertices without bare equivalent, like the qq vertex:



1.3. Physical interpretation

P hysically, this resum m ation is closely related to the D ebye screening in a plasm a. Indeed, if we look at the static lim it of the self-energies $_{\rm T,L}$ for space-like gauge bosons, we may obtain a mass: m $_{\rm T,L}^2$ $\lim_{\rm H\,l}$ 0 $_{\rm T,L}$ (l₀ = 0;1). The interaction range is the inverse of this mass, and we have an exponential screening of the eld of a test charge put in the plasm a. In QED , where exists the classical m odel of D ebye and H uckel, we can verify that the mass m $_{\rm L}$ is precisely the classical D ebye mass for electric elds, whereas the nullity of m $_{\rm T}$ corresponds to the fact that static magnetic elds are not screened.

1.4. Subsidiary problem s

Even if this HTL resummation is carried on, there remain some residual divergences.

The rst kind of problem s is related to the fact that static m agnetic" (transverse) elds are not screened in a plasm a. This fact is well known in a QED plasm a, for which it has been proven that the m agneticm ass" m_T does vanish at all orders of perturbation theory. For QCD and other non abelian gauge theories, the status of thism agnetic m ass is not so clear; nevertheless it is strongly expected that it is beyond the abilities of perturba-

tive m ethods and of order $g^2 T$ or sm aller. A long standing problem where this kind of transverse infrared divergence does appear is the calculation of the ferm ion dam ping rate.

O ther divergences which are not cured by the HTL resum m ation, at least in itsm in im alversion, are collinear ones. Indeed, collinear divergences m ay occur w henever w e have m assless particles in a diagram . Since in the standard HTL fram ework only soft lines are resum m ed and can therefore acquire a therm alm ass, we can still have problem s with hard massless particles. If we come back to the circum stances which necessitate a resum mation, we see that we should compare the quantities P^2 and the self-energy (P) = O (g^2T^2). Of course, as said before, we need a resummation when the components of P are soft; but we need also e ective propagators when the com ponents of P are hard, but P is close to the light{ cone. It has been shown recently in [2] that this supplem entary resum m ation still preserves gauge invariance. We will see in the next section on the example of photon production that it can cure the collinear divergences, and, unexpectedly, som e transverse infrared divergences.

2. SOFT PHOTON PRODUCTION

2.1. Various approaches

2.1.1. Sem i-classical m ethods

Recently, in order to compute the em ission rate by an ultrarelativistic parton of the plasm a, sem i-classicalm ethods have witnessed a renew ed interest. Basically, the idea of these approaches is to look at the emission of a single photon by a quark undergoing multiple scatterings while crossing the plasma. An essential hypothesis of this method is to assume that the scattering centers are static, so that only longitudinal bosons are exchanged in the scattering process. Also, the interaction is assumed to be Debye screened. The essential physical result of this approach is a suppression of the emission rate at small energies, known as the Landau-Pomeranchuk-Migdal (LPM) e ect [3]. Indeed, the lifetim e of a quark em itting a of energy! at an angle after a scattering is $= 1 = !^2$. If this lifetime is greater than the mean free path of the quark in the medium,


then the emission is suppressed because a new scattering occurs before the emission: this is the case when ! < 1 = .

2.1.2. Therm al eld theory


In therm al eld theory, the emission rate per unit volum e of the plasm a is related to the imaginary part of the self{energy by:

the imaginary part being itself obtained by a generalization at nite T of the standard cutting rules. In the standard HTL fram ework at 1 loop [4], we have three diagram s:



where the symbol 0_{HTL} means that we obtain a null result within the standard rules for the HTL expansion. Some of the relevant corresponding processes are:




We can see that the diagram (a) involves the interference of a brem sstrahlung-like" process with

a very complicated one (see (a^0)), whereas the diagram s (b) and (c) involve only brem sstrahlung processes (see (b^0) and (c^0)). From a physical point of view, it seems very suprising that brem sstrahlung is subdom inant in front of the complicated process of diagram (a). This was ourm otivation to study the last two diagram s beyond the standard HTL scheme. Moreover, since the parton exchanged in the scattering is soft and since in that kinem atical regime a bosonic statistical weight dom inates over a ferm ionic one, the diagram (c) is dom inant with respect to (b).

2.2. B rem sstrahlung diagram s

The remaining of this talk will be devoted to the study of the diagram (c). In order to do this calculation, we replace the gg e ective vertex by the corresponding bops, which gives:



In fact, we have a third diagram, involving a selfenergy correction on the upper ferm ion line (not represented here). Since we are interested in the production of photons with a positive virtuality $Q^2 = 0$ (which is the case of interest for the production of real photons or of pairs of leptons), the cuts () and () are vanishing for kinem atical reasons.

2.2.1. Sim pli ed form of Im

In order to calculate the contribution to Im of the previous two diagram s, we use the so-called R etarded/A dvanced form alism [5]. It appears that the terms corresponding to the cut () are very similar in the two diagrams (the cut (0), to be combined with the non vanishing cut of the other self-energy correction, gives a contribution equal to that of the cut ()). In our kinem atical dom ain (P; R T and Q; L T), we obtain:

where $n_{B,F}$ (!) = 1=(exp(!=T) 1) and $T_{F,L}$ is the imaginary part of the longitudinal or transverse part of the ective gluon propagator: $T_{F,L}$ (l_0 ; l) = 2Im ($L^2 T_{F,L}$ (L) + i)¹. The symbol (1) denotes an extra m inus sign in the longitudinal gluon exchange contribution. It is straightforward to verify that the gauge dependent part of this propagator disappears when the self-energy and vertex corrections are combined. Two kinds of contributions arise in $T_{F,L}$, corresponding to very di erent features of the analytic structure of the ective propagator. The

rst contribution, arising at $L^2 > 0$, is made of D irac delta functions corresponding to the therm alm ass shells of the resum m ed propagator (i.e. from poles in the lo plane). The second contribution to this in aginary part com es from the logarithms in $_{T,L}$ at $L^2 < 0$ (i.e. from a cut in the $l_{\!0}$ plane) and corresponds to the e ect known as Landau dam ping (dam ping of a wave by absorption of virtual photons by quarks of the plasm a). In fact, in our rate, the term containing the pole part of the functions T;L corresponds to a production by C om pton e ect, where a therm alized on-shell gluon is absorbed by a quark which reem its a photon, rather than brem sstrahlung. In (a^{0}) ; (b^{0}) and (c^{0}) we represented only the amplitudes corresponding to brem sstrahlung. Nevertheless, a careful analysis of the D irac delta constraints in (6) shows that the region $L^2 > 0$ is forbidden as far as $Q^2 = q_0^2$ 1, which is the situation we are interested in. Therefore, the brem sstrahlung production dom inates over the Compton one.

2.2.2. Enhancem ent m echanism

Taking into account the constraints provided by the two D irac delta functions, we obtain for the denom inators (in the region where P;R T and Q;L T):

where is the angle between the spatial components of R and Q, is the azim uthal angle between the spatial parts of Q and L, and $M_{eff}^2 = M_f^2 + Q^2 r^2 = q_0^2$ (we integrated over here since $(P + L)^2 = M_f^2$ is the only place where appears). At that point, it is clear that the potential collinear divergence at = 0 is regularized by a combination of the ferm ion therm alm ass and of the photon virtuality. At $Q^2 = 0$, it appears to be essential to keep this ferm ion therm alm ass, despite the fact that the ferm ion has a hard m om entum.

N a vely, we obtain the following order for the integral over \cos :

In order to explain the enhancem ent m echanism, we can roughly approxim ate:

where u; $w = M_{eff}^2 = r^2$ and $u = w = L^2 = r^2$, so that we get:

Therefore, we have an enhancement over the order one expects na vely as far as u 1, i.e. if $Q^2 = q_0^2$ 1 (this is the meaning of \near the light-cone"). The origin of this enhancement lies in the residues of collinear singularities: potential collinear divergences, although regulated by a ferm ion thermal mass, are at the origin of the break-down of the power counting rules of the HTL expansion, which fails to handle properly collinear sensitive processes.

2.2.3. Final expression of Im

Finally, after taking into account the constraints and perform ing the angular integration, we obtain:

where we introduced som e useful dim ensionless quantifies:

In the expression above, we have factorized out the parameters xing the dimension and the order of magnitude on the rst line, so that the remaining two factors are only a numerical factor, which will be denoted by $J_{T,iL}$ in what follows.

3. CONCLUSIONS

Let us review some properties of the brem sstrahlung production rate quoted before in (12).


(i) The regions R T and L T are negligeable in the integral, so that our approximations based on these assumptions are safe.

(ii) The result is infrared nite, without the need of a magnetic mass for the transverse gluon exchange. This feature is very important for QED, where this magnetic mass is known to be zero to all orders. At $Q^2 = 0$, if we look at the form all in it M f mg, we obtain:

O ne power of that logarithm, common to both the transverse and longitudinal contributions, is due to the potential collinear singularity. The additional power of that logarithm in the transverse term is a remnant of an infrared divergence (related to the absence of magnetic mass at this order), unexpectedly screened by the ferm ion therm alm ass. (iii) At Q² = 0, the brem sstrahlung contribution is of order Im $e^2g^2T^3=q_0$ and therefore dom inates over the contribution of the soft ferm ion loop ($e^2g^4T^3=q_0$).

(iv) Let us end with a plot of $J_{r,L}$ as a function of log (Q²=q₀²), with g = 0:1, N = 3 and N_f = 3:



We note a atness at small Q², re ecting the fact that the mass M_{eff} is dom inated by the ferm ion therm alm ass, and we see that the enhancement disappears if $Q^2=q_0^2$! 1.

(v) The transverse and longitudinal contributions are of the same m agnitude, which seems to indicate that the static scattering centers hypothesis of the sem i-classical approach is wrong.
