V iolation of universal Y ukawa coupling and quark masses

ABSTRACT

We analyse the quark mass hierarchy and CKM matrix using the universal Yukawa coupling model with small violations precisely. We estimate the ranges of the values of 8 violation parameters ($_{1}^{u}$, $_{2}^{u}$, $_{3}^{u}$, $_{1}^{d}$, $_{2}^{d}$, $_{3}^{d}$, $_{2}^{d}$, $_{3}^{d}$) in our quark mass matrices satisfying quark mass ratios and CKM matrix, where $_{2}$, $_{3}$ are phases. Without these phases, the solution satisfying quark mass ratios and CKM matrix is not obtained. These parameters obtained can explain the CP violation elects.

1. Introduction

The origin of the mass hierarchy of quarks and leptons has been investigated by the various theories beyond the standard model (SM) by many authors [1]-[3]. Although it is necessary to study precisely the theories beyond the SM, in the present circum stances where there are the precise analysis of B $^{\,0}$ B $^{\,0}$ mixing, the CP-violating parameter "of the K $^{\,0}$ K $^{\,0}$ system and the determination of the top-quark mass, one should analyse the mass hierarchy of quarks and Cabibbo-Kobayashi-Maskawa (CKM) matrix independently of model assumed. Furthermore, many attempts beyond SM [3] constructing mass matrix patterns at the GUT scale in SUSY theories or at the string scale in string models, although quite successful, cannot produce results in complete agreement with precise low energy data. Thus, for the model building beyond SM, the analysis using only the minimal qualities to be sure at present is now to be very necessary.

For quark mass matrix patterns in low energy, there are Fritzsch type, Stech type model [1], the democratic type model [2] and the universal Yukawa coupling type model [4]. We adopt a quark mass matrix like the democratic [2] and the universal Yukawa coupling type models [4] with the small violations from the universality which cause the mass hierarchy. Our model does not take any assumptions on the violations and treats violation parameters as free parameters. First, we see the mass hierarchy mechanism in the limit of the universal Yukawa coupling. The (u; c; t) and (d; s; b) quark mass matrices are expressed, under the universality of Yukawa coupling strength, as

where u and d are real, and are not assumed universal. This u and d unuiversality is guaranteed by e.g., a m in in alsupersym metric gauge model [5] in which the up and down quarks acquire their masses through the couplings to two dierent Higgs multiplets. It is well known that this type of the mass matrix is diagonalized as diag [0; 0; 3 q] by the

orthogonal matrix T_0 ; diag $[0; 0; 3]^q = T_0 M^q T_0^1$, where T_0 is

Thus the type of Eq. (1) gives the large m ass gap between the heaviest quark and other two quarks.

Next, we introduce small violations with phases of Yukawa coupling strength in universal coupling (Eq. (1)) as

We do not take any assum ptions on the violation parameters except that q_i 's are very small. Introducing small violations of coupling, we assumed that the violations are caused from the coupling between dierent quarks. Here it should be stressed that the large mass dierences are produced by the universal coupling then what distinguishes the quarks is not the masses but other characters. Thus the assumption that the diagonal elements of couplings between same quarks are same each other and do not have violations is reasonable. In the parametrization (Eq. (3)), we used the sign before q_i because, in this notation, q_i are allowed only to be positive in the quark mass analysis as shown later. Branco, Silva-Marcos and Rebelo [4] studied the type of mass matrix (3) but they equate the type of this mass matrix to the quark mass squared.

Under the assumption of small violation in universal coupling, we can get the second mass gap between two degenerate zero mass states which are taken from the universal mass matrix (1). This is shown from the mass matrix (3) neglecting phases

This mass matrix is transformed by $T_{\rm 0}$ to

then if $_{1}^{q}$ $_{2}^{q}$ $_{3}^{q}$ 1, three eigenvalues turn to (0; 4 $_{2}^{q}$ $_{3}^{q}$ =3; (3 $_{2}^{q}$ =3) $_{3}^{q}$), approximately. This tendency is certiled and the allowed ranges of ($_{1}^{q}$; $_{2}^{q}$; $_{3}^{q}$) are determined precisely from the analysis of quark mass ratios and CKM matrix in the following numerical study.

In last section (3.D iscussions), we will comment on the dierence between the results of our model and others [1]-[4]

2. N um erical analysis

The mass matrices (3) contain 6 violation parameters for (u; c; t) and (d; s; b) sector except for the $^{\rm q}$, respectively. First, we consider 3 parameters ($_1^{\rm q}$; $_2^{\rm q}$; $_3^{\rm q}$) case (Eq. (5)) for simplicity and later we will consider the case containing phases. We diagonalize the mass matrices (5) to the diag [mu; mc; mt] and diag [md; ms; mb] for q = u and d by the unitary matrices T ($_1^{\rm u}$; $_2^{\rm u}$; $_3^{\rm u}$) and T ($_1^{\rm d}$; $_2^{\rm d}$; $_3^{\rm d}$), respectively,

E igenvalues of the mass matrices are not the physical masses but the parameters in the Lagrangian. Theses quark masses (eigenvalues) are running masses which should be all taken on a single energy scale. In order to estimate the parameters $\begin{pmatrix} q \\ 1; & 2 \end{pmatrix}$, we use the quark mass ratios. These mass ratios are, to a good approximation, independent of the energy scale, then the scale can be arbitrarily chosen [6].

For the values of the light and medium heavy quark u; d; s and c m asses, we use the

world average cited in Ref. [7];

because these values are almost similar to the mass values at the scale = 1G eV [6]; $m_u = 5:1$ 1:5M eV; $m_d = 8:9$ 2:6M eV; $m_s = 175$ 55M eV; $m_c = 1:35$ 0:05G eV.

For the heavy quark b and t m asses, we estim ate the running m ass m $_{\rm q}$ ($\,=\,1{\rm G\,eV}\,)$ related to the physical m ass m $_{\rm q}^{\rm phys}$ in the $\,$ rst order QCD as

The estimated m $_{\rm b}$ (= 1G eV) and m $_{\rm t}$ (= 1G eV) from the physical mass m $_{\rm b}^{\rm phys}$ = 43 02 G eV and m $_{\rm t}^{\rm phys}$ = 174 $_{23}^{22}$ G eV [7] are

We write the values of m $_{\rm b}$ (= 1GeV) and m $_{\rm t}$ (= 1GeV) for the renorm alization group invariant scale = 0:1GeV and = 0:2GeV cases, because these m ass values are sensitive to the values of . Hereafter, we write the m ass m $_{\rm q}$ (= 1GeV) as m $_{\rm q}$. From these m ass values, we get the quark m ass ratios,

where we used the average values of m_b (= 1G eV) and m_t (= 1G eV) for = 0:1G eV and = 0:2G eV and involved the deviation from the average value in errors.

We estimated numerically the allowed regions of $({}^q_1; {}^q_2; {}^q_3)$ satisfying the constraint in which the ratios of the eigenvalues $(m_u; m_c; m_t)$ and $(m_d; m_s; m_b)$ of them assmatrices (5) are included in the experimental ranges of quark mass ratios (12). We showed the allowed regions for $(m_u; m_c; m_t)$ sector in Figs. 1(a), (b), (c) and for $(m_d; m_s; m_b)$ sector in Figs. 1(d), (e), (f).

The Figs. 1 (a), (b), (c) represent the allowed regions of ($\frac{u}{2}$; $\frac{u}{3}$) plane corresponding to the $\frac{u}{1} = 0.00005$; 0.0001; 0.0004 for (u; c; t)sector, respectively and Figs. 1 (d), (e), (f) the allowed regions of ($\frac{d}{2}$; $\frac{d}{3}$) plane corresponding to the $\frac{d}{1} = 0.005$; 0.01; 0.02 for (d; s; b) sector, respectively. For $\frac{u}{1} < 0.000012$ and $\frac{d}{1} < 0.00085$, the allowed regions for ($\frac{u}{2}$; $\frac{u}{3}$) plane do not exist, respectively. It is seen in this Fig. 1 that the allowed regions for ($\frac{d}{2}$; $\frac{d}{3}$) are symmetric with respect to the interchange between $\frac{d}{2}$ and $\frac{d}{3}$. This symmetry is found easily in the approximate expressions for the eigenvalues and eigenvectors of the mass matrix (5). The eigenvalues are

Though these expressions are obtained approximately, the allowed regions for $({}^{q}_{2}; {}^{q}_{3})$ obtained from these approximate expressions are almost same as those in Fig. 1.

Next we consider the CKM matrix V,

The m atrix elements of V are determined by various experiments, for example, nuclear beta decays, K_{e3} decays, neutrino and antineutrino production of charm o valence d quarks, neutrino production of charm, sem ileptonic decays of B m esons produced on the (4S) bb resonance and etc. The absolute values for these m atrix elements are tabulated as [7]

We calculated numerically the allowed regions of $\begin{pmatrix} q \\ 1; q \\ 2; q \end{pmatrix}$ satisfying the restriction in which the absolute values of matrix elements of V in Eq. (17) are included in the experimental range of matrix elements (Eq. (18)). First, we estimated the allowed regions of $\begin{pmatrix} q \\ 1; q \\ 2; q \end{pmatrix}$ independent of the experimental constraint of ranges of the mass ratio (12). We showed the allowed region of $\begin{pmatrix} u \\ 2; q \end{pmatrix}$ for $\begin{pmatrix} u \\ 2; q \end{pmatrix}$ for $\begin{pmatrix} u \\ 2; q \end{pmatrix}$ for $\begin{pmatrix} u \\ 2; q \end{pmatrix}$ and $\begin{pmatrix} d \\ 1; q \end{pmatrix}$ for $\begin{pmatrix} d \\ 2; q \end{pmatrix}$ and $\begin{pmatrix} d \\ 1; q \end{pmatrix}$ are almost similar to those of the case $\begin{pmatrix} u \\ 1; q \end{pmatrix} = 0.0001$ and

 $_{1}^{d} = 0.01$ shown in Fig 2. All combinations of all points in allowed region of $(_{2}^{u}; _{3}^{u})$ with all points in allowed regions of $(_{2}^{d}; _{3}^{d})$ are not allowed but the restricted combinations between some points in allowed region of $(_{2}^{u}; _{3}^{u})$ and some points in allowed region of $(_{2}^{d}; _{3}^{d})$ are allowed. For example, the combinations of a point in $(_{2}^{u}; _{3}^{u})$ plain (shown by a large dot) with points in the area shown by the large dotts in $(_{2}^{d}; _{3}^{d})$ plane are allowed. In Fig.2, though we showed the solution corresponding to the case, $_{2}^{u} > _{3}^{u}$ and $_{2}^{d} < _{3}^{d}$, there exist also the solutions corresponding to the cases, $_{2}^{u} < _{3}^{u}$ and $_{2}^{d} > _{3}^{d}$.

As shown in Fig. 1 and Fig. 2, there is no common regions satisfying both constraints of the mass ratios and the CKM matrix in $(\frac{d}{2}; \frac{d}{3})$ plane of (d; s; b) sector. This fact is easily understood from the analytic expressions for V. U sing the approximate expression (15) for T $(\frac{q}{1}; \frac{q}{2}; \frac{q}{3})$, we can get the approximate expression for V

From this expression, for $\frac{d}{2}$ $\frac{d}{3}$ $\frac{d}{1}$, we can get the ratio $\mathbf{j}V_{cb} = V_{tb}\mathbf{j}$ \mathbf{j} (u d) $\sin^{u} + (^{u}$ d) $\cos^{u}\mathbf{j}$ $\mathbf{j}^{d}\mathbf{j}$ and then $\frac{d}{2}$ $\frac{d}{3} > 0.20$ from the experimental ratio $\mathbf{j}V_{cb}^{exp} = V_{tb}^{exp}\mathbf{j} > 0.032$. On the other hand, from the ratio of mass eigenvalues (13), for $\frac{d}{2}$ $\frac{d}{3}$ $\frac{d}{1}$, we can get $\mathbf{m}_{2}^{d} = \mathbf{m}_{3}^{d}$ $2(\frac{d}{2} + \frac{d}{3}) = 9$ then $\frac{d}{2}$ $\frac{d}{3} < 0.13$ from the experimental range $\mathbf{m}_{s} = \mathbf{m}_{b} = 0.038$ 0.019. We comment here on the difference between the values calculated by Eq. (19) and by numerically exact procedure. The values for V_{us} and V_{cd} elements calculated by Eq. (19) are different from the values calculated by

num erical and exact procedure about 2% , and for V_{ub} , V_{cb} , V_{td} and V_{ts} about 20% and for V_{ud} , V_{cs} and V_{tb} about 0.1% .

Because of the fact that there is no common region in $(\frac{d}{2}; \frac{d}{3})$ plane satisfying the quark mass ratios and the CKM matrix, we consider the case containing the phases $'\frac{q}{i}$ in the quark mass matrix as Eq. (3). Although there are 6 degrees of freedom for phases $'\frac{q}{i}$, only two phases $'\frac{d}{2}$ and $'\frac{d}{3}$ are considered in our analysis because only $\frac{d}{2}$ and $\frac{d}{3}$ in the violation parameters are about 0.1 and other parameters are extremely small ($\frac{d}{1}$ 0.01, $\frac{u}{1}$ 0.0001, $\frac{u}{2;3}$ 0.01), then the phases with these other parameters scarcely contribute to CKM matrix in contrast to two phases $'\frac{d}{2}$ and $'\frac{d}{3}$. We parametrize the (d;s;b) sector quark mass matrix using the very small phases $\frac{d}{2}$ and $\frac{d}{3}$ instead of the phases $'\frac{d}{2}$ and $'\frac{d}{3}$, as

The approximate expressions for the eigenvalues of the mass matrix (20) are the same expressions for m $_1^{\rm d}$; m $_2^{\rm d}$ and m $_3^{\rm d}$ as Eq. (13), but the expression for $^{\rm d}$ is changed to containing the phases $_2$ and $_3$ as follows,

We calculated the allowed regions of $\begin{pmatrix} u \\ 1 \end{pmatrix}; \begin{pmatrix} u \\ 2 \end{pmatrix}; \begin{pmatrix} u \\ 3 \end{pmatrix}$ and $\begin{pmatrix} d \\ 1 \end{pmatrix}; \begin{pmatrix} d \\ 2 \end{pmatrix}; \begin{pmatrix} d \\ 3 \end{pmatrix}; \begin{pmatrix} d \\ 2 \end{pmatrix}; \begin{pmatrix} d \\ 3 \end{pmatrix}$ num erically and exactly satisfying two constraints of the experim ental values of ranges of the quark mass ratios Eq. (12) and the CKM matrix V^{exp} Eq. (18) and showed these regions in Fig. 3. We showed the case $\begin{pmatrix} u \\ 1 \end{pmatrix}; \begin{pmatrix} d \\ 1 \end{pmatrix}; \begin{pmatrix} d \\ 2 \end{pmatrix}; \begin{pmatrix} d \\ 3 \end{pmatrix} = \begin{pmatrix} 0.00005, 0.005, \begin{pmatrix} 0.005, \begin{pmatrix} 4 \end{pmatrix}, \begin{pmatrix} 4 \end{pmatrix} \end{pmatrix}$ in Fig. 3(b). Solutions corresponding to the cases other than $\begin{pmatrix} u \\ 2 \end{pmatrix}; \begin{pmatrix} u \\ 3 \end{pmatrix} = \begin{pmatrix} 0.0001, 0.01, \begin{pmatrix} 4 \\ 3 \end{pmatrix}; \begin{pmatrix} 4 \end{pmatrix}$ do not exist.

In order to see the e ects of the CP violation, we rephase the CKM matrix $V = T(_1^u;_2^u;_3^u)T^y(_1^d;_2^d;_3^d;_2;_3)$ to the standard parametrized CKM matrix V^R where the matrix elements V_{ud}^R , V_{us}^R , V_{ub}^R and V_{tb}^R are real number, by using the rephasing matrix P_u and P_d as

The phenomenological constraints for parameters and has been examined by Pith and Prades [8] using the recent information on the non-perturbative hadronic inputs needed in the analysis of B⁰ B⁰ mixing and the CP-violating parameter "of K⁰ K⁰ system. They gave the results of parameters and for the best estimate set of input parameters. 3. Discussions

We analysed precisely the mass hierarchy of quarks and CKM matrix in the law energy by the universal Yukawa coupling model with small violations (Eq.(3)). Violation parameters estimated are 8: ($_{1}^{u}$, $_{2}^{u}$, $_{3}^{u}$, $_{1}^{d}$, $_{2}^{d}$, $_{3}^{d}$, $_{2}$, $_{3}$), and estimated values of these are tabulated in Table 1.0 ther phases than $_{2}$ and $_{3}$ do not contribute to our present

analysis because of extrem e sm allness of (${}^{u}_{1}$, ${}^{u}_{2}$, ${}^{u}_{3}$, ${}^{d}_{1}$). We tted 8 violation param eters to 8 experim ental data: 4 quark mass ratios (Eq. (12)), 3 m ixing angles determined by CKM matrix elements (Eq. (18)) and 1 phase determined by CP violation which relates to and .

Here we comment on the dierences between our model and others [1]- β]. The mass matrices depending on models adopted and CKM matrix are connected through the unitary matrices T_{uxl} depending on models as follows;

From $V = T_u T_d^y$ and V^{exp} 1, Fritzsch type, Stech type model and many other models [1], [3] adopt the unitary matrices $T_{u;d}^{Fritzsch}$ type as $T_{u;d}^{Fritzsch}$ type 1 and then $(M^u)^{Fritzsch}$ type = $(T_u^{Fritzsch})^1$ diag $[m_u; m_c; m_t] T_u^{Fritzsch}$ type diag $[m_u; m_c; m_t]$ and $[M^d)^{Fritzsch}$ type = $(T_d^{Fritzsch})^1$ diag $[m_d; m_s; m_b] T_d^{Fritzsch}$ diag $[m_d; m_s; m_b]$. where T_0 is the unitary matrix dened in Eq. (2). CKM matrix does not depend on the unitary matrices $T_{u,d}$ adopted but the weak interaction eigenstates do on it then on the mass matrices adopted.

Even in Fritzsch type models, there are many parametrizations and all parametrizations cannot explain precisely the present quark mass hierarchy and CKM matrix. For example, original Fritzsch model can not explain the observed large top quark mass and model ed model (see the literature of B D utta and S.N andi in [1]) can explain the large

top quark mass but has to use the up quark mass matrix in which the (2;3) and the (3;2) elements are unequal. Recent Peccei and W ang analysis (the literature in [3]) uses the mass matrix M $^{\rm u}$ = $T_{\rm u}^{-1}$ fdiag m $_{\rm t}$ [$_{\rm ut}^{-7}$; $_{\rm ct}^{-4}$; 1]g $T_{\rm u}$ diag m $_{\rm t}$ [$_{\rm ut}^{-7}$; xi $_{\rm ct}^{-4}$; 1] and M $^{\rm d}$ = $T_{\rm d}^{-1}$ fdiag m $_{\rm b}$ [$_{\rm db}^{-4}$; $_{\rm sb}^{-2}$; 1]g $T_{\rm d}$ diag m $_{\rm b}$ [$_{\rm db}^{-4}$; $_{\rm sb}^{-2}$; 1], where $_{\rm ut}$ = 0:49; $_{\rm ct}$ = 1:46; $_{\rm db}$ = 0:58; $_{\rm sb}$ = 0:55 and $_{\rm sb}$ is the parameter in W olfenstein parametrization [9] of CKM matrix, and takes the mass matrices explaining the law energy data precisely. But the principle to take their mass matrices is not so clear.

We will analyse the problem of neutrino mixing using the present our model in next work. As we mentioned above, the weak interaction eigenstates depend on the unitary matrices $T_{u,d}$ adopted, then the analysis of mass matrix involving the lepton sector like the neutrino mixing problem will give the clue to check the validity of our model and other models.








