## The Universe after in ation: the wide resonance case

## Abstract

We study numerically the decay of massive and massless in atoms into massive excitations, via a  $^{2}X^{2}$  coupling, in the expanding Universe. We indicate that a wide enough resonance can survive the Universe expansion, though account for the expansion is very important for determining precisely how wide it should be. For a massive in atom, the elective production of particles with mass tent times that of the in atom requires very large values of the resonance parameter q, q > 10<sup>8</sup>. For these large q, the maximal size of produced uctuations is signing cantly suppressed by the back reaction, but at least within the Hartree approximation they are still not negligible. For the massless in atom with a  $^{4}$ =4 potential, the Universe expansion completely prevents a resonance production of particles with masses larger than  $^{10^{6}}$ .

The quantitative theory of reheating after in ation is an important problem in in ationary cosm ology [1] because the way the reheating proceeds determ ines possibility of certain phase transitions and scenarios of baryogenesis. It was recently realized that stimulated processes, due to large occupation numbers of produced bosons, can be most signi cant during reheating [2{5]. However, despite considerable progress made [2,6,7], still little was known quantitatively about the important case when the coupling of the in atom eld () to bosonic elds (X) is relatively large (the wide resonance case). It was not clear precisely how wide the resonance should be (for a given mass of X) to overcome the expansion of the Universe. If the coupling required by this condition turns out to be too large, the resonance will be prevented by non-linear elds, which in this case will set in when X uctuations are still of the quantum strength. Thus even the existence of a wide resonance in the expanding Universe was not may established, let alone its quantitative details. The purpose of the present work was to study the wide resonance case by num ericalm eans.

The main quantity that one wants to know for a given in ationary model is the maximal size of uctuations of elds produced in the in aton decay. The size of these uctuations determ ines which phase transitions took place after in ation [8,9], whether enough of heavy leptoquarks could be produced to generate the baryon asymmetry [8,9,7,10], and how strong was the cosm ological breakdown of supersymmetry [11,12].

The reason why uctuations produced at reheating could be su ciently large for the above e ects to exist is that, as now recognized, reheating in many cases starts with a stage of parametric resonance (called preheating in ref. [2]), during which the bosonic uctuations grow extremely (exponentially) fast. In the expanding Universe, a parametric resonance is e ective only when it is su ciently wide or when the system is (classically) conformally invariant. O therw ise, the redshift of m om enta prevents the resonance from developing [13]. The conformally invariant case is realized when a massless in aton decays into a massless uctuation eld. Production of a massive eld can only take place in the wide resonance regime. In that case, there can occur an interesting and somewhat counterintuitive phenomenon, when quanta of a eld that strongly couples to the in aton can be e ciently produced even if their mass is much larger than the frequency of the in aton oscillations. The e ect can be thought of as a \m any! few " process, in which m any quanta of the in aton eld assemble together to produce a few heavy quanta. If the elds that can be e ciently produced by thism echanism include leptoquarks of a grand uni ed theory (GUT), the subsequent non-equilibrium decay of these leptoquarks could give rise to a sizable baryon asymmetry [8,9,7,10].

In the present work, we wanted, rst of all, to nd the regions of parameters, for which a wide resonance can overcome the redshift of elds and momenta in the expanding Universe. We considered two models: in the rst one, the in aton potential wasm<sup>2</sup><sup>2</sup>=2, in the second, it was <sup>4</sup>=4. In both cases, we considered decay of the in aton into a heavy scalar eld X of mass M<sub>X</sub>, due to coupling  $\frac{1}{2}g^2$ <sup>2</sup>X<sup>2</sup>. The width of the resonance in these models is determined by parameter q: in M odel1 (a massive in aton) q  $g^2$ <sup>2</sup>(0)=4m<sup>2</sup>, where (0) is the value of the in aton eld when it starts to oscillate;<sup>1</sup> in M odel2 (the massless in aton), q  $g^2$ =4.

In M odel 2, we have found no resonance for any  $M_x > {}^{p-}$  (0) with q up to  $q = 10^6$ . In M odel 1 with  $M_x = m = 10$ , which m ay be appropriate for scalar leptoquarks, we have found that the redshift is overcom e only for very large q,  $q > 10^8$ . Thus, a wide enough resonance can indeed survive in the expanding Universe, though account for the expansion is very in portant for determ ining precisely how wide it should be.

Our second objective in this work was to determ ine the maximal size achieved by X uctuations in M odel 1. In general, both the Universe expansion and the back reaction play a role in determining the maximal size of uctuations. A fully non-linear calculation along the lines of ref. [5], which would allow us to include consistently all back reaction e ects, was technically unfeasible for q  $10^3$ . So, we took the back reaction into account approximately, using a simple Hartree procedure [2,4].

The Hartree approximation may overestimate the maximal size of uctuations. The interaction term in the equation of motion for becomes important when  $hX^{2}i$   $^{2}(0)=q$  (the brackets denote averaging over space). One might expect that this value signiles the end of the resonance stage. However, in the Hartree approximation, when this value is reached,  $hX^{2}i$  merely renormalizes the mass of [2] and continues to grow. We cannot say at present if that further growth is an artifact of the Hartree approximation in this model and will disappear in the fully non-linear picture. In the conformally invariant case (see below), the limited set of data points that we have for the full problem does t on a 1=q curve, in disagreement with the Hartree approximation. We are not willing to make any inferences for the present case, however, because the time evolution of is rather model dependent.

W e neglected any self-coupling of the ed X. In the Hartree approximation, an estimate shows that a quartic self-coupling  $^{X}$ <sup>4</sup>=4 can be neglected during the entire resonance stage when  $^{<}$  g<sup>2</sup>. If the maximal size of uctuations is in fact smaller than obtained in the Hartree approximation, this self-coupling can be neglected at the resonance stage even for larger  $^{\sim}$ .

The resulting hX  $^{2}i_{max}$  as a function of q (the brackets denote averaging over space) is shown in Fig. 1. It is suppressed for large q but is still not negligible. If we measure the strength of the (massive) uctuations with regard to symmetry restoration [8,9] using the e ective \temperature":  $T_{e}^{2} = 12$  hX<sup>2</sup>  $i_{max}$ , then for  $q = 10^{8}$ , the Hartree approximation gives  $T_{e}$  of order 10  ${}^{3}M_{P1}$ . This is of order of the GUT scale, so the process could be relevant for symmetry restoration even in G rand Uni ed models.

One should keep in mind, though, that the size of uctuations can be further altered (apart from the redshift) by the subsequent chaotic evolution [5], absent in the Hartree approximation. That chaotic evolution is rather fast because it is due to stimulated, i.e. classically enhanced, processes. For example, in applications to GUT baryogenesis, the chaotic evolution will in large part take place before the B-non-conserving decays of X particles. Therefore, som e quantitative understanding of it is required before reliable estimates of the baryon asymmetry can be made; this will be a subject of a forthcom ing paper.

Below we describe our models and calculations in more detail.

de nition of the parameter q of the canonical M athieu equation [14].

M cdel1: M assive in aton. In conform alvariables, and after a convenient rescaling, the action for the matter elds is

where = m a(0), is the conformal time; = m a(0)x; ' = a() = (0)a(0), = X a() = (0)a(0); a() is the scale factor of the Universe.

We take = 0 at the moment of the rst extrem um of (). Solving the equation of motion for the zero-momentum mode of the in aton coupled to gravity, together with the E instein equation for the scale factor, we have found (0) =  $0.28M_{\rm Pl}$ . At later times, we continued to determ ine the evolution of the scale factor self-consistently, including the inuence of produced uctuations in the E instein equations. A fler = 0, a matter dom inated stage quickly sets in, for which one can use

However, as our self-consistent solution con  $\,m\,s$ , for some values of the parameters the expansion later crosses over into a radiation dominated stage. That happens when the interaction potential  $\frac{1}{2}g^2$   $^2X$   $^2$  overtakes the mass term of  $\,$ .

In the H artree approximation, the zero-momentum mode is the only non-vanishing mode of the eld '; we keep for it the notation '. Its equation of motion is

where the brackets denote an average over space. This should be solved with the initial conditions '  $(0) = 1, '_{(0)} = 0$ . The equation of motion for the Fourier components of the eld is

The Fourier components are normalized in such a way that the variance of the uctuation eld is

Because uctuations are produced mostly with relatively small values of (com oving) momenta k, the inevitable presence of a momentum cuto in our calculation, somewhere at larger momenta, will automatically result in a properly renormalized h<sup>2</sup>i. If we wanted to embed our calculation into a fully quantum – eld-theoretical picture, we would identify the parameters we use (m, g<sup>2</sup> etc.) with the running parameters of that picture, taken at a normalization point of the order of our momentum cuto ; moderate changes in the normalization point will only cause corrections of relative order g<sup>2</sup>=4 = qm<sup>2</sup>=4 <sup>2</sup> (0).

The initial conditions for k are random ly distributed with the probability density

A coording to eq. (1),  $m^2 = 2$  (0) is the parameter that regulates the strength of quantum uctuations compared to classical ones in this model. The initial \velocities" are locked to their corresponding \coordinates"

where  $h = \underline{a}=a$ . For a derivation of these initial conditions, see ref. [5]. The sem iclassical description is reliable as long as  $q^2=4 = qm^2=4$  <sup>2</sup> (0) 1.

The results of num erical calculations for the realistic case  $m = 10^{6} M_{Pl}$  are presented in Figs. 1{3.

Three factors can potentially suppress a param etric resonance in the expanding U niverse, each represented by the corresponding term in the equations of motion. In our conform al variables, they are: the time dependent mass term /  $M_X^2$  in eq. (5), which redshifts the modes away from the resonance; the time dependent mass term of the eld ' in eq. (3), which makes the oscillations of the background eld aperiodic; and the back reaction term / q in eq. (3). A very useful quantity to introduce is the eld experiment.

where is the (decreasing) am plitude of the physical eld , and  $m_e$  is that eld's e ective m ass including the H artree correction. In a slow ly expanding U niverse (the adiabatic lim it),  $q_e$  () would indeed be the correct resonance parameter at time .

To understand the e ects of the redshift and the back reaction, it is convenient to see rst what happens when the back reaction is neglected. This is indeed the correct lim it for su ciently small q (a more precise criterion depends on m). Then,  $m_e = m$  and

For a parametric resonance to be elective at time  $, q_{\rm ele}$  ( ) should not be much smaller than unity. Because a resonance will need some time  $_0$  to start, the condition for it to begin at

all,  $q_e(_0) > 1$ , already requires large values of  $q = q_e(0)$ . By our de nition, a resonance starts when hX<sup>2</sup> i rises above quantum uctuations. E.g. in Fig. 2,  $_0$  6; som e k-m odes can start to grow earlier, however.

Consider not the case of massless X, M<sub>X</sub> = 0. We have found that even then the resonance starts only for  $q > 10^3$ , see Fig. 1. With  $q > 10^3$ , the parametric resonance starts at some point but term inates when  $q_e$  drops below unity. Hence, in the expanding Universe, the resonance stops and the maximal size of produced uctuations is limited in this model<sup>2</sup> even without back reaction. We have calculated the maximum value of hX<sup>2</sup> i that would be achieved without back reaction for a wide range of values of q. It is plotted in Fig. 1 by the dotted curve and for massless X has the labelm = 0. This curve can be approximated by hX<sup>2</sup> i<sub>max</sub> /  $q^{12}$ , which is plotted in Fig. 1 by a solid straight line.

Next, consider the case  $M_X \notin 0$ . The rapidly growing mass term of is a resonance suppressing factor. In the case of the <sup>4</sup> model, we will see that it works against the resonance extremely electively. In the present model, however, the frequency of oscillations of the eld' is growing at the same rate as the elective mass of , compare eqs. (3) and (5). In a sense, massive modes can remain tuned to the resonance, in some analogy with the conform all case. Still, for a non-zero  $M_X$ , the resonance term inates before  $q_e$  drops below unity. This is why the curves with m  $\notin 0$  are shifted in Fig. 1 to the right with respect to the m = 0 case.




FIG.1. Maximal value of the variance of uctuations in Model1 as a function of the resonance parameter. Dotted lines correspond to no back reaction and are tted by a power law. Solid curves are obtained in the Hartree approximation. The dashed straight line is a power law to the Hartree data.

In the absence of the Universe expansion and back reaction, the linearized equation for uctuations, eq. (4), would be a M athieu equation. In that case, a necessary condition for the X particle production to fall into the strongest resonance band would be, for  $m \ge 1$ :  $m < q^{1=4}$ , or equivalently  $q > (M_x = m)^4$ . As one can see from Fig. 1, this estimate is four orders of m agnitude o in the expanding Universe: e.g. with  $q = 10^4$  the resonance barely develops even for m = 1. To take the Universe expansion into account, we can replace q in the above estimate with  $q_{e}$  at some time before the end of the resonance stage,  $q_{e}$  (1). As evident from eq. (11), nding  $q_e$  (1) is equivalent to nding (1). The quantities 1 and (1) in general depend on q. Although som e analytical estimates of (1) can be made [8], its reliable determ ination requires our num erical results. We have found that for the range of q we consider in Fig. 1, one can use generically  $^{2}(_{1})$   $10^{4}$   $^{2}(_{0})$ . Using q. instead of q repairs the estimate: to e ciently produce particles of mass M  $_{\rm X}$  , one needs  $q_{e}(1) > (M_{X} = m)^{4}$ , or  $q > 10^{4} (M_{X} = m)^{4}$ , in agreement with Fig. 1. For  $M_{X} = m = 10$ , we get  $q > 10^8$ , which for  $m = 10^{13}$  GeV translates into  $g^2 > 4$ : 10<sup>3</sup>. Considering the complexity of the phenom ena involved, the estim at  $q^2 > 10^4$  m ade for this case in ref. [10] is in a reasonable agreem ent with our result.

The term \wide" parametric resonance is to some extent m isleading. The resonance band itself is narrow,  $k = q_e^{1=4}$ . However, the resonance band can be anywhere in the interval  $0 < k_{res} < q_e^{1=4}$ , and indeed m oves through this interval back and forth when  $q_e$  slightly changes. Now, since  $q_e$  is time dependent in expanding Universe, all k from this

range become resonant in turn,<sup>3</sup> and it is for that reason that one m ay consider  $q_e^{1=4}$  as a kind of electrive width of the resonance. As a result of the motion of the resonance band, all k up to  $q^{1=4}$  become led up in the power spectrum, although to a varying extent.

In Fig. 1, notice also the sensitivity of the maximal size of uctuations with respect to small changes in q. Small changes in q can be simulated by small numerical uncertainties, such as that of the coe cient in the relation  $(0) = 0.28M_{Pl}$ . It anyway makes sense to average out the rapid changes in Fig. 1 and concentrate on the general pattern. As a general trend, we observe a broad maximum of hX  $^{2}i_{max}$  as a function of q, at xed M  $_{X}$ . It occurs in the region of q where the redshift and the back reaction play comparable roles in term inating the resonance.

Now consider the limit when the maximum value attained by uctuations is determined by the back reaction. This is the case of asymptotically large q. The general trend in hX  $^{2}i_{max}$  in this region of q is given by

which is plotted in Fig. 1 by the dashed straight line. In this region, we can also estimate hX  $^{2}i_{max}$  in the Hartree approximation analytically, and the estimate is in rather good agreement with eq. (12). It proceeds as follows. We rest notice that because the decay of into X is a stimulated process, it mostly takes place in a short period close to the end of the resonance, when X uctuations are already large. Then, we should distinguish between the amplitude of the in aton oscillations just before the decay, (1), which is determined mostly by the redshift, and its amplitude right after the decay, (2). For a wide resonance,

 $(_{2})$  can be smaller than  $(_{1})$  by orders of magnitude. Such a drop is clearly seen in Fig. 3 (even though for m = 10 the value q =  $10^{8}$  is not an asymptotically large q). Because  $_{2}$  \_\_\_\_\_1 is such a short time, the Universe expansion during it can be neglected, and from energy conservation we get

The second ingredient of our estimate is the observation [2] that the presence of hX<sup>2</sup> i changes the e ective mass of the in aton; the e ective mass is given by  $m_e^2 = m^2 + g^2 hX^2 i$ , where  $hX^2 i$  is a slow ly changing part of hX<sup>2</sup> i. When hX<sup>2</sup> i becomes su ciently large,  $m_e^2$  $g^2 hX^2 i$   $g^2 hX^2 i$ , and the elective resonance parameter becomes  $q_e = g^2 = 4m_e^2$  $^2 = hX^2 i$ . The resonance stops when  $q_e$  (2) 1; using eq. (13), this gives

The value of (1) is weakly depends on q. As before, we use the generic estimate (1) 10<sup>2</sup> (0) for all q considered. We then obtain hX<sup>2</sup>i<sub>max</sub> 10<sup>3</sup>M<sup>2</sup><sub>P1</sub>  $\stackrel{P}{=}$   $\overline{q}$ , in reasonable agreement with the numerical result (12). A 1  $\stackrel{P}{=}$   $\overline{q}$  (up to logarithms) estimate for hX<sup>2</sup>i<sub>max</sub> appears in refs. [2,8,11], although the way the estimate is obtained and the numerical coe cient are somewhat di erent from ours. We stress again that we do not know at present if the 1  $\stackrel{P}{=}$   $\overline{q}$  behavior is an artifact of the Hartree approximation in this model. See also the discussion of the conformally invariant case below.

Note that at asymptotically large q, the interaction term  $\frac{1}{2}g^2X^{2} dom$  inates over the mass term of X during the entire resonance stage. So, at the resonance stage, the uctuations of X cannot really be described as particles, since they are strongly coupled to the oscillating background.

M odel 2: M assless in aton. In rescaled variables, the action for the matter elds in this model is

W e again take = 0 to be the rst extrem um of (). In this case we nd  $(0) = 0.35M_{P1}$ . There is no resonance for a massive enough X (see below). In that case, after the in aton oscillations start, the U niverse quickly becomes radiation dominated and we can use

All other form ulas are obtained from the corresponding ones for M odel 1 by replacing m<sup>2</sup> with  $^{2}$  (0). A coordingly, we now use m = M<sub>X</sub> = (0).

For a massless eld the problem becomes conformally equivalent to the one in the M inkowski space-time: the expansion of the Universe decouples in the conformal coordinates. The parametric resonance is always elective. We have done a complete non-linear analysis of this problem in the range 1 q 1000, using the approach developed in ref. [5]. At q 1, the evolution of the system is fast and we were able to trace the sem iclassical thermalization [5] up to a slow ly evolving state with a developed K olm ogorov turbulence. These results will be described in more detail elsewhere; for previous discussions of kinetic phenomena after preheating, see refs. [5,16]. For the limited set of values of q for which we now have the data, hX<sup>2</sup>i at the end of the resonance stage in the full problem ts a 1=q curve. If

the mass of actually helps the resonance for a while, as we have indeed observed in our num erical results.

con med by more extensive calculations, such behavior would be in disagreement with the approximately  $1=\frac{p}{q}$  dependence obtained in the Hartree approximation.

W ith a massive eld we have not found any parametric resonance for m > 1 and q up to  $q = 10^6$ . Analytically, the condition for the resonance to exist at time (neglecting back reaction) is  $q^{1-4} > m$  a ()=a (0). In the conform ally invariant case (m = 0), the uctuations reach appreciable strength at 100. U sing that value in the estimate for m  $\neq$  0, we would expect that for m = 1, the resonance exists when  $q > 10^7$ . We indeed observed a slow (physically insigni cant) resonance at m = 1 and q =  $10^8$ .

In conclusion, we have studied the decay of massive and massless in atoms into massive excitations in the expanding Universe. We have found that a wide enough resonance can survive in the expanding Universe, though the expansion is very important for determining precisely how wide it should be. For a massive in atom, the elective production of particles with mass tent in esthat of the in atom requires very large values of the resonance parameter  $q, q > 10^8$ . For these large q, the maximal size of produced uctuations is significantly suppressed by the back reaction, but at least within the Hartree approximation they are still not negligible. We do not know at present if this conclusion will persist in the fully non-linear picture; the full account for rescattering is thus an important problem for the future. For the massless in atom with a <sup>4</sup>=4 potential, the Universe expansion completely prevents a resonance production of particles with masses larger than <sup>(0)</sup> for q up to  $q = 10^6$ .




FIG.2. Fluctuation variance in M odel 1, as a function of time, for two values of the m ass of the uctuating eld; back reaction of uctuations on the in atom eld was included in the H artree approximation.




FIG.3. Time evolution of the hom ogeneous in atom eld and the uctuation variance in M odel 1 in the H artree approximation, for given values of the parameters.
