# A $Z_2$ C lassi cation for 2D Ferm ion Level C rossing

#### A bstract

We demonstrate that the number of fermionic zero modes of the static 2-dimensional Dirac operator in the background of SU (2) static gauge-Higgs eld congurations is a topological invariant modulo four. Static congurations which are everywhere odd under parity with even-parity pure gauge behaviour at in nity admit 4n, n 2 Z; zero modes of the Jackiw-Rebbi (JR) type. Odd-parity congurations with odd-parity pure gauge behaviour at in nity are topologically disconnected from the vacuum and admit 4n + 2 fermionic zero energy solutions. The classication implies the collapse of half of the fermion zero modes upon embedding a 2-dimensional gauge-Higgs conguration (string) with odd-parity pure gauge behaviour at in nity into the 3-dimensional Minkowski space.

### 1 Introduction

A nom alous ferm ion level crossing in gauge theories is intrinsically connected to their topologically nontrivial periodic vacuum structure. For theories with the gauge symmetry spontaneously broken there appears a potential barrier between the topologically inequivalent vacua which is proportional to the mass scale of the theory. At nite temperatures them ally induced transitions above the barrier are accompanied by fermion level crossing. It is due to the presence of static gauge-higgs elds with Chem-Simons number CS = 1=2, the sphalerons, which are saddle points to the eld equations. In the context of the standard SU(2) = U(1) electroweak theory such congurations induce an odd number of normalizable zero energy solutions to the 3D D irac equation.

It was previously found [1, 2] that for the gauge elds  $A_i$  having odd parity everywhere the Chem-Sim ons number is a topological charge. In a gauge where  $A_i$  is odd under parity transform ation the U-odd con gurations (where U is dened via the asymptotic behaviour of  $A_i$  at in nity,  $A_i$ !  $i @_i U$  (x)U (x)  $^1$ ) have CS = n+1=2,  $n \ge Z$ , and adm it an odd number of ferm ionic zero modes. They contribute to unsuppressed B+L violating thermal transitions. The U-even con gurations have CS = n with an even number of ferm ionic zero modes. They are homotopically equivalent to the vacuum and are not directly connected to the U-odd con gurations. In other words the 3D D irac operator in the background of odd-parity gauge-Higgs elds adm its a topological invariant number modulo 2 of zero modes. The presence of U-odd con gurations is a consequence of a nontrivial  $Z_2$  structure in the space of static nite energy con gurations in the electroweak theory. It follows from the existence of the homotopy groups  $[S^2=Z_2;SU(2)=Z_2]=Z_2$  and  $[S^3=Z_2;SU(2)=Z_2]=Z_2$  [2].

In the present note we exam ine the eigenvalue spectrum of the static two dimensionalD irac operator in the background of SU (2) and U (1) gauge elds respectively. The presence of zero modes in the background of embedded string loops of the Nielsen-O lesen type [3] was rst demonstrated by Jackiw and Rebbi [4]. For Z-string loops the issue was studied by Earnshaw and Perkins [5].

The organization of the paper is the following. In section 2 we discuss the SU (2) theory in (2+1) dimensions and the problem of extension of its topological defects into (3+1) dimensions. In section 3 we discuss the U (1) gauge theories in dierent dimensions and the problem of embedding the low dimensional topological defects into higher dimensions. We close by summarizing the results of the paper.

## 2 SU (2) gauge theory in (2+1) dim ensions

We discuss the spectrum of the Dirac operator in the background of a static conguration.

To that end we consider the 2D D irac equation for the D irac 2D ferm ion in an

external gauge eld  $A_{i}(x)$

where i=1;2:T he m atrix  $_3$  plays the role of the 4D  $_5$  since it anticom mutes with all 2D matrices. Thus the D irac spinor can be split into two one component chiral spinors  $=(_1;_2):It$  is worth emphasizing that a chirality cannot be defined in 3D. The anticommutation property of the  $_3$  matrix automatically means that in 2D for any spinor which obeys eq.(1) one can construct the spinor  $i_3$  which corresponds to the eigenvalue i:W e thus prove that in 2D all non-zero eigenvalues are paired (i:V): Moreover for the case of an SU(2) gauge group we can choose the eigenfunction for any eigenvalue i:V0 be \real"

while the real eigenfunction for i reads  $i_3$  (x): Here i, i = 1; 2; 3 are the isospin matrices.

It is easy to see that there is also a doubling of zero m odes of the D irac operator. Indeed let us consider ( $_1$ ;0) and (0; $_2$ ) as a basis of the kernel of the D irac operator. For these components we have the following equations

Here  $r = r_1$  ir  $_2$  and  $r = r_1 + ir_2$ : It is now easy to see that for any  $_1 \notin 0$ ,  $r_1 = 0$ , one can explicitely construct  $_2 = i_2$   $_1 \notin 0$ ,  $r_2 = 0$ , where  $_2$  is the isospin matrix. This proves the doubling of zero modes.

In the case of an odd-parity gauge eld, A(x) = A(x), we have an additional degeneracy for all the non-zero eigenvalues. Let be a real eigenfunction for an non-zero eigenvalue i:W e can easily check that the real spinor  $i_3(x)$  corresponds to the eigenvalue i while (x) corresponds to i:M or eover the eigenfunctions constructed above are linearly independent. Indeed let us assume that the wave functions and  $i_3(x)$  were linearly dependent, i.e.  $(x) = a_3(x)$ , where a is a constant. Then it is easy to see a = 1. Let us now consider the reality condition of  $(x) = a_3(x)$ . By combining it with the condition of linear dependence one can get that  $(x) = i_3(x)$ . It clearly contradicts with a = 1, if a = 10. We thus have that each eigenfunction with non-zero generates a different eigenfunction for the same a = 11. This doubling for non-zero modes is of course a result of the odd parity behaviour of the gauge eld.

Let us consider the zero m odes of the above D irac operator in an odd-parity gauge eld. If there is a zero m ode we can then construct the above four wavefunctions which obey the same equation. However such a wave function can be odd or even with respect to a parity transformation (x) = (x): Therefore the number of linearly independent zero modes may be less than 4. However it is easy to see that the number of linearly independent zero modes is always even. Indeed for any

real zero mode with a wave function (x) we can separately construct a linearly independent one i  $_3$  (x) (as discussed above).

Thus we see that the number of zero modes of the Dirac operator is invariant modulo 4 (but not modulo 2 as we had in 3 dimensions) when we smoothly change the external odd-parity gauge eld. Indeed if we change smoothly the external (odd under parity) gauge eld a non-zero eigenvalue i can cross zero. At some moment i gets to be zero while by continuity the four above eigenfunctions being linearly independent (the wave functions for dierent values of are orthogonal) are zero mode wave functions. Hence under smooth deformations of the gauge eld (odd under parity) the number of zero modes can change only by 4k; where k is an integer.

It is worth emphasizing that the quadroupling of the non-zero modes is of course a result of the odd parity behaviour of the gauge eld as well as of the above index theorem modulo 4. In the case of non-constrained gauge elds (without a de nite parity) there is no index theorem since the number of zero modes is always even while the non-zero modes are paired and there is no additional doubling for them. This corresponds to the trivilatity of the homotopy group  $_1(SU(2)) = 0$ .

Thus at least for the gauge group SU (2) the topological classes of parity odd gauge elds are two classes which allow for the number of ferm ionic zero modes to be 2 m od 4 and 0 m od 4, respectively. Following the approach of ref. [1, 2] one can now show that these classes correspond to the odd-parity gauge elds with even and odd pure gauge behaviour at ininity,  $A_i(x)$ ! i( $\theta_i U U^{-1}$ )(x), U(x) = U(x). Since a vacuum con gurationt obviously does not allow for ferm ionic zero modes and has U(x) = U(x) behaviour at in nity we conclude that the sector of gauge elds with such a behaviour requires 0 (modulo 4) ferm ionic zero modes. Thus the hom otopically non-trivial sector corresponds to gauge elds with U(x) = U(x). These elds require 2 (modulo 4) ferm ionic zero modes.

The above group element U(x) is a map from  $S^1$  into SU(2). Thus we have proved that there is a non-trivial hom otopy group [6]

This group is responsible for the above index theorem. Formally eq. (4) follows from the facts that  $S^1=Z_2$  is isomorphic to  $S^1$  and  $SU(2)=Z_2=SO(3)$ :

We will now discuss an embedding of two-dimensional topologically non-trivial objects, such as strings, into three dimensional space. In particular we consider the 2D D irac operator in the external eld of the Nielsen-O lesen string, i.e. we consider a 2D slice perpendicular to the line of the vortex. The fermionic zero mode in such a eld is proportional to 1=r at in nity (r is the distance to the line of the vortex). Hence the normalization integral is logarithmically divergent. Nevertheless these zero modes are still relevant if we assume that the 2D space is compactifed. For example the simplest way to compactify the space is to introduce an external metric which makes the normalization integral convergent. In this case we have a couple of zero modes [4] that agrees with the above analysis.

We now construct a loop of such a string. Since any con guration in three dimensional space is contractable such a loop may allow for any number of ferm ionic zero modes. Therefore we have to formulate the prescription for making a three dimensional object if we want to not a correspondence between the homotopy properties of two and three dimensional conguration. We shall assume that the radius of the loop is much larger than the size of its core. We will also assume that we construct a three dimensional gauge eld conguration which is odd under parity transformation. In this case there are two dimensional congurations as it has been demonstrated in ref. [1, 2]. One of two sets of three dimensional congurations allows for an even number of fermionic zero modes. In this case one considers a twisting [7] of the string which corresponds to pure gauge behaviour of the three dimensional gauge eld  $A_i(x)$ !  $i(@_iUU^{-1})(x)$  at in nity with even U(x) = U(-x): The second set of three dimensional elds corresponds to a non-trivial twisting of the string. The resulting three dimensional gauge elds have pure gauge behaviour at in nity with odd U(x) = U(-x). These elds allow for an odd number of fermionic zero modes.

From the analysis of [1, 2] it follows that some ferm ionic zero modes which existed on the two-dimensional slice do not cause an appearance of zero modes of the three dimensionalD irac operator in the string loop con guration. Therefore we conjecture that a non-trivial twisting of the string con guration (odd-parity pure gauge behaviour at in nity) kills half of the zero modes of the Dirac operator since a three dimensionalDirac operator has an odd number of normalizable zero modes in this case. The reason for the disappearance of half of the zero modes is probably that only one of their linear combinations can satisfy the condition of single-valuedness of the wavefunction when we extend the two dimensional object into three dimensions. In the opposite case of a topologically trivial twist (even-parity pure gauge behaviour at in nity) all zero modes might survive.

We thus conjecture that there is a correspondence of the  $Z_2$  structure of the theory in (2+1) dimensions to that of the (3+1) dimensional theory. This correspondence is non-trivial because it depends on the twisting. For an appropriate twisting the non-trivial homotopy class in (2+1) dimensions maps to the non-trivial homotopy class in (3+1).

# 3 U (1) gauge theory in (3+1), (2+1) and (1+1) dim ensions

Here we shall consider the gauge theories with U (1) gauge group.

Let us rst start with a gauge theory in (1+1) dimensions dened on I R; where the intervalI = [ ; ] stands for the \space". In this case the hom otopic properties of static con gurations are described by the fact that the hom otopy group of maps [0]; U(1)] = 0, where [0] consists of the two end points of the interval I. Therefore there is no index theorem for the static D irac operator in this case. Let us now turn to the static gauge elds even under the parity transform ation. This restriction is due

to the fact that the sphaleron con guration in (1+1) dimensions is a constant gauge eld (see e.g. [8]). In this case we have the following non-trivial homotopy group  $[0] = Z_2; U(1) = Z_2] = Z_2$ : Therefore there are two classes of gauge elds which are not continuously related to each other: with odd-parity and even-parity pure gauge behaviour at the ends of the space interval I = [; ]. A particular representative of the non-trivial homotopy class is just the above sphaleron  $A_x = 1 = 2$ . More generally  $A_x = n = 2$ , where n is an odd-integer. For the trivial class we have n to be even. The existence of a non-trivial homotopy group  $[0] = Z_2; U(1) = Z_2] = Z_2$  in plies the existence of an index theorem for the D irac operator in 1 dimension in the presence of even-parity gauge elds. The D irac operator has one zero mode for odd n and 0 zero modes for even n (we assume the antiperiodicity of the ferm ionic wavefunctions).

For the U (1) gauge theory in (2+1) the relevant hom otopic group form ally reads

since U (1)= $Z_2 = RP^1 = U$  (1): If we denote an element of the U (1) group as expi (); where is a coordinate on  $S^1$ ; 2 [0;2]; then the classes of the above hom otopic group are represented by group elements for which exp 2i () is periodic on [0; ]: This group element can have any integer winding number on the interval [0; ]: This is the same winding number as for the element expi () on the interval [0;2]: Therefore all the classes of Z are split by parity into two subgroups: with odd and even winding numbers, respectively.

Let us now consider the spectrum of the D irac operator. In the case of a gauge group U (1) the eigenfunctions cannot be generally chosen real. For a generic gauge eld there is no doubling of zero m odes and the number of zero m odes can be both odd and even in contrast to the above example. However there is a pairing of nonzero wave functions given by (x) and i  $_3$  (x) for eigenvalues and respectively. We see that the number of zero modes can change only by an even number under smooth deform ations of gauge elds due to a pairing of non-zero levels. Hence we have an index theorem that the number of ferm ionic zero modes is invariant modulo 2. A ctually in this case it is well known that the index of the 2D D irac operator is given by the winding number of the gauge eld [6].

Let us now consider the case of an odd under parity gauge eld. Because of non-reality the wave functions (x) and i  $_3$  (x) which correspond to the same eigenvalue can be linearly dependent. Therefore in general there is no doubling of non-zero modes. The same is obviously true for zero modes. Indeed, given a wave function (x) for a zero mode we can construct three more wave functions (x); i  $_3$  (x) and i  $_3$  (x): It is easy to see that the condition of linear dependence of all these 4 wave functions is not contradictory. Therefore we see that when we constrain the gauge elds to be odd under parity the index theorem mod 2 for zero modes still holds without any changes. This fact agrees with the above statement that no hom otopy classes appear due to oddness under parity. Instead we get a classication of the usual Z classes: with odd and even winding numbers. The sense of the index theorem can be expressed as follows: it is not possible to change the

number of zero modes from odd to even and back under a smooth deformation of the gauge eld.

We conclude that the number of zero modes of the Dirac operator is invariant modulo 2. Thus it is odd in the non-trivial class of the gauge elds and even in the trivial class with respect to the above splitting of Z into 2Z and 2Z + 1: Such a conclusion agrees with the index theorem for the Dirac operator which is coupled to a U (1) gauge eld, which states that the dierence of numbers of left-handed and right-handed zero modes is given by a winding number of the gauge eld.

Let us now consider an embedding of (1+1) static con gurations into (2+1) dimensions. Under such an embedding the coordinate on an interval I is naturally identied with  $S^1$  which corresponds to the polar angle—in two dimensional space. Then it is easy to see that odd—elds  $A_x = (n+1=2)$  cannot be embedded since they would correspond to a not single-valued group element at in nity. Hence only gauge—elds  $A_x = n$  can be embedded. Thus the spectrum of the Dirac operator reduces under such an embedding since half of the zero modes of the 1-dimensional Dirac operator become non-single-valued. The above Z : 2Z = 2Z + 1 homotopic classication in (2+1) dimensions corresponds to the odd-parity gauge—elds with even or odd pure gauge behaviour at in nity. Thus there is no connection between the  $Z_2$  structure in (1+1) and (2+1) dimensions under such an embedding.

We now turn to the 3D U (1) gauge theory. Since the group  $_2$  (U (1)) = 0 there is no index theorem for the D irac operator. We restly consider the sector of odd-parity gauge elds. The relevant hom otopy group for this case is also trivial  $\mathbb{RP}^2$ ; U (1)] = 0: This follows from the fact that [6]

$$[RP^2; U(1)] = Hom(Z_2; Z) = 0:$$

We also present here a simple intuitive explanation of this result. The RP  $^2$  sphere is equivalent to a hem isphere with identied opposite points on the boundary. Formally by following what we did in the SU (2) case we get two classes of gauge elds which are odd under parity: the ones with odd and even respectively pure gauge behaviour at in nity, i.e. on  $S^2$ : These U (1) group elements are given by exponentials of imaginary functions expi (x): We want now to show that the class of odd  $g = \exp i$  (x) is empty. Let us consider the boundary of the above hem isphere: g is odd on this boundary which is  $S^1$ : Then by continuity it is clear that (x) is shifted by 2 when moving around this boundary. Due to the non-triviality of g (U (1)) is not contractable to unity. Hence when extended to the whole hem isphere there appears a singularity at some point on it. Therefore we conclude that the class of odd g is empty because by denition we have to consider smooth group elements on  $S^2$ : Such an analysis could not prove the absence of odd classes for the SU (2) group because g (SU (2)) = 0:

Thus there is no non-trivial classes in the 3D case for the group U (1):

Let us now consider the case of an SU (2)  $\,$  U (1) gauge group in (2+1) and (3+1) dimensions. In (2+1) dimensions there is a non-trivial  $Z_2$  structure which

depends on the embedding of the  $Z_2$  group into SU (2) U (1). In particular there is a non-trivial  $Z_2$  structure if  $Z_2$  2 U (1). However as it was shown in ref. [2] the corresponding hom otopy group  $[RP^2;SU(2)]$  U (1)= $Z_2$ ] = 0 for the case  $Z_2$  2 U (1). Therefore this part of the  $Z_2$  structure of a (2+1) theory is lost under the embedding into (3+1) theory. Therefore only the  $Z_2$  structure that corresponds to the center of SU (2) survives under this embedding.

### 4 Conlusions

We extended our previous study of hom otopic classication of odd-parity deformed sphalerons to lower dimensions. Remarkably enough we found for the SU (2) gauge theory a non-trivial  $\mathbb{Z}_2$  structure in (2+1) dimensions which implies an index theorem modulo 4 for the Dirac operator. This implies that the number of zero modes of the Dirac operator is a topological invariant which takes values (0 or 2) modulo 4. This corresponds to the existence of the non-trivial hom otopy group  $\mathbb{S}^1=\mathbb{Z}_2$ ; SO (3)]=  $\mathbb{Z}_2$ :

We argued for the existence of a non-trivial correspondence of such a  $\rm Z_2$  structure for static gauge elds in two and three dimensions. More specically the embedding of a 2-dimensional static conguration, such as a Nielsen-O lesen vortex, into a 3-dimensional one, such as a string loop results in the collapse of an odd number of zero modes from the 2 mod 4 it may otherwise possess.

We also investigated the  $Z_2$  structure in the U (1) gauge theories in (1+1), (2+1) and (3+1) dimensions. We argued that there is no non-trivial map of the  $Z_2$  structure from the (2+1) dimensional theory into the (3+1) dimensional one, and also there is no non-trivial map of the  $Z_2$  structure from the (1+1) dimensional theory into the (2+1) dimensional one.

For its potential physical implications the rst part of our results is the more relevant. It suggests that the existence of zero modes of the Dirac operator in 2 dimensions does not imply the existence of zero modes in three dimensions. Thus we see that the B-violating properties of three dimensional congurations, such as the electroweak strings, are not directly related to the homotopic properties of the two dimensional congurations which are embedded into the three dimensions.
