## H adronic Antenna Patterns to D istinguish Production M echanisms for Large- $E_T$ Jets

#### ABSTRACT

Hadronic antenna patterns provide a toolable to diagnose dierent patterns of colour ow in large- $E_{\rm T}$  jet events. They reject the underlying short-distance dynamics, and are sensitive to colour coherence and interference between the initial—and nal-state partons. We discuss how hadronic antenna patterns may be used on large- $E_{\rm T}$  events from the Fermilab Tevatron or the CERN LHC to distinguish between conventional QCD and new physics production mechanisms such as a possible Z  $^0$  boson or compositeness.

#### 1 Introduction

Stimulated by recent data [1, 2] from the Fermilab Tevatron collider and by the prospects for future experiments with the CERN LHC, there is currently much interest in the possible interpretations of hadronic jets at large transverse energy  $E_T$  [3, 4]. It is premature to focus on speculative interpretations of the CDF data [1] until they have been reconciled satisfactorily with those from D; [2], and until there there is consensus whether it is possible to make a new global to parton distributions within the proton which accommodates the new data: for contrasting approaches, see [5, 6]. Nevertheless, it is appropriate to ask whether there are other ways in which one could in principle distinguish between a conventional QCD interpretation of large- $E_T$  jet data and possible new physics such as a  $Z^0$  boson [3] or compositeness [7]. This question is also in portant for future experiments at the LHC, which may well be confronted by it in their own large- $E_T$  data a decade or so hence.

The purpose of this paper is to publicize a diagnostic tool which has been proposed in the literature but has not, to our know ledge, been discussed in connection with current large- $E_T$  data: it is the pattern of hadronic energy ow around the large- $E_T$  jet axes.

It has been known for a long time [8, 9] that the structure of multi-jet events in hard processes is in uenced by the underlying colour dynam ics at short distances. Detailed features of the parton shower, in particular the ow of colour quantum numbers, control the distributions of colour-singlet hadrons in the nal state [10]. To leading order in the large-N c limit, the analytic results for such antenna patterns coincide with the Lund string picture [11]. The rst, and still the best, example of such a colour-related phenomenon is the so-called string [12] or drag [13] e ect in e<sup>+</sup> e ! qqq events, which is very well established experimentally, see for example Refs. [14, 15]. Colour coherence e ects have also been seen very clearly in multi-jet events in pp collisions [16].

Patterns of hadron production in the large- $E_T$  event plane have been measured, and shown [16] to dier signicantly from the predictions of M onte Carlo models that do not include colour coherence and interference e ects. On the other hand, the measurements agree very well with the predictions of M onte Carlo models, such as HERW IG [17], JETSET [18], ARIADNE [19] and JETRAD [20], which incorporate QCD colour coherence with interfering gluons<sup>1</sup>. In particular, initial/ nal-state colour interference e ects have been seen very clearly in the data. Thus the hadronic structure of a multi-jet event draws its colour portrait, and can be regarded as a \partonom eter" mapping the basic interaction process.

A natural idea which has been proposed [8,21,22,23,24,25,26], is to use this \partonom - etry' to help distinguish new physics signals from backgrounds due to conventional QCD. One example of particular interest to the LHC is the possible use of rapidity gaps to favour Higgs production events [8,23], and the pattern of QCD radiation in the production has been examined [27]. Our suggestion here is to use \partonom etry" to dissect the colour structure of the large- $E_T$  jet events observed by CDF [1] and D; [2], as a way to distinguish between conventional QCD and possible new production mechanisms such as a  $Z^0$  boson [3] or compositeness [1,7].

For any given pattern of colour ow between the initial and nal states, there is a characteristic [21,24,26] pattern of gluon em ission and hence hadronic energy ow in the transverse event plane. This is universal for hadron energies in the range  $_{\rm QCD}$  E  $_{\rm T}$ , in the approximation of a large number of colours N  $_{\rm C}$ . This should be a good approximation for secondary jet em ission in the qq(qq), qg and gg scattering processes of most interest for the Tevatron and the LHC. In this paper, we collect and compile the relevant form ulae for conventional QCD, Z  $^{\rm O}$  and composite-model contributions to the large-E  $_{\rm T}$  cross section, and discuss how these may be used to distinguish between these possible production mechanisms.

# 2 An Example of the Diagnostic Power of Hadronic Antenna Patterns

We begin by considering a simple illustrative example, the subprocess  $qq! q^0q^0$ , where q and  $q^0$  denote dierent quark avours, which makes a distinctive contribution to the hadronic energy ow in large-E  $_T$  jet production at the Tevatron collider. In QCD, this process is dominated by s-channel gluon exchange. Suppose that there is an additional non-standard contribution from the s-channel exchange of a new, heavy Z  $^0$  vector boson,  $qq! Z^0! q^0q^0$ . If we assume, for simplicity, that the Z  $^0$  has a vector coupling of strength  $q^0$  to the quarks, then the matrix element squared is

where  $C_F = (N_c^2 - 1) = 2N_c$ , and  $M_{Z^0}$  and  $M_{Z^0}$  are the  $Z^0$  m ass and width respectively. If the nal-state quarks are produced at wide angle with transverse energy  $E_T$  then all the kinem atic invariants are of order  $E_T^2$ . For  $E_T$  (S=2)  $M_{Z^0}$ , the QCD process dom in ates. As  $E_T$  increases, the  $Z^0$  contribution becomes more important, becoming maximal when  $E_T = M_{Z^0} = 2$ .

Next consider the em ission of a soft gluon in the above process, i.e.  $q(p_1) + q(p_2) !$   $q^0(p_3) + q^0(p_4) + g(k)$ . In the soft gluon and large-N  $_{\text{C}}$  approximations, the matrix element is

The distribution of soft gluon radiation is controlled by the basic antenna pattern (see for example Ref. [10])

which describes the em ission of soft primary gluons with energies  $E:_{QCD}$  E  $E_{i}$ ;  $E_{j}$ . The production of soft hadrons is then described by extra multiplicative cascading factors  $N_{q}^{0}(E_{T})$  and  $N_{q}^{0}(E_{T})$  within quark and gluon jets respectively (for details see Refs. [9, 13]):

where N  $_{\rm qg}$  (E ) is the particle multiplicity in an individual q; g jet with energy E . A sym ptotically

Note that in the various asymmetry parameters (e.g. those used to describe the string e ect) the cascading factors normally cancel. In the present study we will mainly be interested in the distribution of soft jets accompanying large- $E_{\rm T}$  jet production. We shall assume that this is well-approximated by the distribution of a soft primary gluon which is given by matrix elements such as (2).

Returning to the qq!  $q^0q^0$  process, we see from (2) that the radiation pattern is di erent for the QCD and Z  $^0$  contributions. At small E  $_{\rm T}$ , the distribution is given by the sum of the [13] and [24] antennas. Soft gluon radiation is enhanced in the phase space region between the directions of partons 1 and 3 (and also between 2 and 4). If, however, at large E  $_{\rm T}$  the Z  $^0$  contribution is dominant, then the distribution is given by the sum of the [12] and [34] antennas, which yields a more symmetric radiation pattern. Thus the soft gluon distribution acts as a \partonometer" for probing the hard scattering process. In general, each type of 2! 2 scattering will have its own distinctive radiation pattern.

In order to make the study more quantitative we must de ne appropriate kinematic distributions and then compute the contributions of the various subprocesses. In order to fully understand the dierences between these, we rest consider the soft gluon distribution at the parton-parton scattering level with xed kinematics. The generic process is

where the gluon is soft relative to the two large-E  $_{\rm T}$  partons c and d. Ignoring the gluon m om entum in the energy-m om entum constraints, and using the notation p = (E; $p_{\rm x}$ ; $p_{\rm y}$ ; $p_{\rm z}$ ), we write

This is the appropriate form for studying the angular distribution of the soft gluon jet relative to the large- $E_T$  jet 3, the separation between these being parametrized by

. A Itemative variables, m ore suited to the experim ental analysis, are the radial and polar angle variables in the \LEGO plot":

which are de ned in such a way that that the LEGO {plot separation between soft jet k and hard jet  $p_3$  is constant: R  $(k;p_3) = \frac{p}{2} + \frac{2}{2} = R$ , (0 R < 1), and the azimuthal orientation of jet k around jet  $p_3$  in the LEGO plot is parametrized by the angle , (0 < 2).

In term s of these variables, the soft gluon phase space is

We will be particularly interested in the behaviour of the cross section as a function of for xed  $k_T$ ; R and xed  $E_T$ ; .

Note that the distributions presented here should be considered only as instructive examples. In the quantitative study of interference phenomena it may prove useful to exploit other variables, for example the variable used in the CDF analysis [16]. Another useful discriminator for studying the underlying scattering dynamics is provided by correlations of the type [9, 29]

where N  $_{ij}$  is the number of events with the soft jet in the angular region ij of the scattering plane (idenotes the upper (U) or lower (L) quadrant and j denotes the left (L) or right (R) quadrant).

There are a large number of processes of type (7). The matrix elements are collected in the Appendix. In addition to the QCD contributions, we include also the contributions from  $Z^0$  exchange to qq! qq scattering (including processes related by crossing), assuming an interaction of the form

For illustrative purposes in our num erical calculations, we use the set of parameters suggested in Ref. [28] on the basis of a combined to LEP and CDF data:

with  $q^0 = e = \sin_W \text{ and } M_{z,0} = 1 \text{ TeV}$ .




Figure 1: Jet con guration for the num erical studies described in the text.




Figure 2: Ratio of the 2! 3 and 2! 2 m atrix elements as a function of the soft gluon azim uthal angle about the large- $E_T$  jet, for various QCD and  $Z^0$  subprocesses.

We rst show results for a very simple kinematic con guration,  $2 \,! \, 2$  scattering at 90 in the parton centre-ofm ass frame, i.e. = 0 in Eq. (8). We  $x \, k_T$  and  $E_T$  at  $10 \, \text{GeV}$  and  $100 \, \text{GeV}$  respectively, so that  $k_T$   $E_T$ , and study the angular ( ) distribution of the soft gluon jet around one of the two large- $E_T$  jets  $(p_3)$ , see Fig. 1. Following the D; analysis [2], we use the variables R and de ned above. For small R, the radiation pattern is domainated by the matrix-element singularity when k and  $p_3$  are parallel: the distribution is constant and simply rejects the colour charge of the emitting parton. For large R, the pattern is sensitive to the colour ow in the scattering process. We display results for R = 1, which is typical of the values used in the experimental analyses. Figure 2 shows the soft gluon distribution for various  $2 \,! \, 2$  scattering processes as a function of  $^2$ . The quantity plotted is the ratio of the  $2 \,! \, 3$  and  $2 \,! \, 2$  matrix elements, on itting an overall factor of  $g_s^2$ . The

characteristics of these distributions can be understood in terms of the colour strings linking the initial—and nal-state partons, see for example Ref. [10]. Notice in particular that the distribution for the gg! gg process is approximately constant, rejecting the comparable contributions to the radiation pattern from the incoming and outgoing gluons. For the qg! qg and qg! qg processes, the distributions are peaked in the backward (qg) direction. For the former, this corresponds to the colour string between an outgoing 8 and qg, as for qg! qg.

A lso shown in Fig. 2 is the radiation pattern for the process qq!  $Z^0$ !  $q^0q^0$ . In this case the distribution has the sim ple analytic form

Note that the [12] antenna corresponding to gluon radiation from the initial-state qq gives a contribution which is independent of . In the large-N  $_{\rm c}$  lim it, the corresponding QCD process gives the distribution




Figure 3: Ratio of the 2! 3 and 2! 2 m atrix elements as a function of the soft gluon azim uthal angle about the large- $E_{\rm T}$  jet for the uu! dd(g) subprocess, including QCD and Z  $^{\rm 0}$  contributions.

In contrast to (14), this distribution is not symmetric about =90. For a heavy Z  $^0$  with sizeable couplings to quarks, we would expect a transition from the \QCD " radiation pattern at low E  $_{\rm T}$  to the \Z  $^0$ " radiation pattern at high E  $_{\rm T}$ . This is illustrated in Fig. 3, for the parton scattering process uu! dd. The distribution is obtained from Eq. (A 4) and

contains the contributions from the QCD and Z $^0$  processes, and their interference. For these simple kinematics, E $_{\rm T}$  = M $_{\rm Z}$   $_{\rm 0}$ =2 = 500 GeV corresponds to the resonance peak where the Z $^0$  contribution is maximal. Notice the signicant change in the shape of the distribution as E $_{\rm T}$  approaches this value from below .

The interference between the QCD and Z $^0$  contributions deserves further discussion. By colour conservation, this is absent in the leading-order (no gluon radiation) amplitudes, and at O( $_{\rm s}$ ) is suppressed by a single power of N $_{\rm c}$  in the large-N $_{\rm c}$  limit, see Eq. (A4). The corresponding antenna pattern is given by

where we have substituted the kinematic variables relevant to Fig. 3, ie. = 0. The interference contribution vanishes on the Z  $^{0}$  resonance (i.e. for E  $_{T}$  = 500 G eV in Fig. 3) and is everywhere numerically small relative to the sum of the Q CD and Z  $^{0}$  amplitudes squared.




Figure 4: Decom position of the uu! dd(g) radiation pattern of Fig. 3, for E $_{\rm T}=400$  GeV. The curves represent the various contributions to the 2! 3 m atrix element squared, normalized in each case to the totalQCD+Z $^0$ 2! 2 m atrix element squared.

As an illustration, Fig. 4 shows the decomposition of the uu! dd(g) radiation pattern for  $E_T=400\,\mathrm{GeV}$ . For this kinematic conguration (90 scattering in the parton centre-of-mass frame) the interference is antisymmetric about = 90. Note that the antenna pattern in Eq. (16) is asymmetric with respect to the interchange  $p_3$  \$  $p_4$  and therefore vanishes if one does not distinguish the nal-state jets. It also vanishes after integration over the angles between the qq and  $q^0q^0$  antennae, see Ref. [27]. This can readily be seen by writing Eq. (16) as

where  $_{1;3}$  is the polar angle between the K and and  $p_{1;3}$  vectors, and is the azim uthal angle between the planes form ed by  $K;p_1$  and  $K;p_3$ .

M ore generally, the interference between diagram swith dierent colour ows at the amplitude level destroys the factorization of the radiation pattern into a product of the eikonal

antenna factors and the lowest-order cross sections. Note that an analogous interference contribution induces \colour interconnection e ects" in the pattern of gluon radiation accompanying  $e^+e^-$ !  $q_1q_2q_3q_4$  events, see Ref. [30].

W e conclude this section with some remarks on the validity of the soft gluon and large-N  $_{\rm c}$  approximations. Consider, for example, the QCD 2! 3 process  $qq^0$ !  $qq^0g$ . The exact matrix element is [31]

The soft gluon approximation which we have used in the above calculations corresponds to




Figure 5: Ratio of approximate and exact matrix elements, as described in the text.

To test the validity of these approximations, we consider the ratios of the matrix elements in (20) and (21) to that in (18). For the latter, we use exact 2! 3 kinematics de ned by

with E  $_4$  =  $jp_4$  j and 2E = E  $_3$  + E  $_4$  + E  $_k$ . Figure 5 shows the ratio of the approximate and exact matrix elements as a function of for = 0, R = 1, and  $k_T$ =E  $_T$  = 0:1;0.2. The solid lines indicate that the corrections to the radiation pattern in the soft approximation scale as 0 ( $k_T$ =E  $_T$ ). The difference between the dashed and solid lines is 0 (10%), consistent with 0 (1=N  $_c^2$ ) corrections to the large-N  $_c$  approximation. The curves in Fig. 5 attain their maximum deviation from unity at the end-points,  $\cos$  = 1, since for this choice of kinematics the ratio of the gluon energy to that of jet 3 is E  $_k$ =E  $_3$  =  $\cosh$  ( $\cos$  ) $k_T$ =E  $_T$ , which for xed  $k_T$ =E  $_T$  is maximal at large jcos j. In what follows we shall use the soft gluon matrix elements listed in the Appendix, retaining the complete set of antennas valid for arbitrary N  $_c$ .

#### 3 Convolution with Parton Distributions

To obtain realistic predictions for the distribution of soft gluon radiation accompanying large- $E_T$  jets at, say, the Tevatron pp collider, we must convolute the matrix elements with appropriate parton distributions. This then gives a  $E_T$ -dependent mixture of the various distributions shown in Fig. 2. To avoid unnecessary complications from kinematics, and to make contact with the parton-level results obtained above, we consider the production of a pair of large- $E_T$  jets at zero rapidity in the laboratory frame, i.e.  $E_{T3} = E_{T4} = E_T$ ,  $e_{T4} = e_{T4} = e_{T4$

with  $x_1 = x_2 = x_T$   $2E_T = \frac{p}{s}$  for our choice of kinematics. The symmetry factor  $_{cd}$  is 1 (0) for identical (non-identical) partons in the nal state. Next-to-leading order corrections to the inclusive cross section are approximately taken into account by the scale choice  $= E_T = 2$ . We use the recent MRS (R2) parton set ( $_s$  (M $_z$ ) = 0:120), which gives a good overall description of the CDF and D; large- $E_T$  inclusive jet cross section [32]. The corresponding two-jet + soft gluon inclusive cross section is

For the additional factor of  $_{\rm S}$  coming from the soft gluon emission we use  $= k_{\rm T}$ . As before, we consider the ratio of the cross sections in (24) and (23) as a function of the soft




Figure 6: Radiation pattern for the soft gluon jet in large- $E_{\rm T}$  dijet production in pp collisions at 1.8 TeV . All scattering processes are included, weighted by the appropriate parton distributions.

gluon variables:

Figure 6 shows the distribution  $k_T\,d$  =dk  $_T\,d$  R d as a function of for  $k_T$  = 10 G eV , R = 1 and various values of  $E_T$  . The solid curves are the QCD predictions, and the dashed curves include also the Z  $^0$  contribution with same parameters as in the previous gures. We note the following.

(i) All the distributions are symmetric about = 90. This is due to our choice of symmetric large  $E_{\rm T}$  jet kinematics, and because we have summed over all combinations of partons (jets) in the initial and nal states, e.g. qg;qq! qg;qq.<sup>3</sup>

- (ii) For the QCD curves, the radiation pattern decreases in magnitude as  $E_{\rm T}$  increases. This is simply a colour charge e ect: as one moves from small  $E_{\rm T}$  to large  $E_{\rm T}$  the dominate subprocess scattering changes from gg to qg to qq.
- (iii) The e ect of the Z  $^0$  contribution is clearly visible in the dashed curves at large E  $_{\rm T}$  . As already seen in F ig. 2, the Z  $^0$  radiation pattern has a peak at =90 . The e ect is most significant for E  $_{\rm T}=$  M  $_{\rm Z}$   $_0=$ 2, as expected. But note also a similar (though weaker) peak structure in the QCD background'. This arises from the qq! qq+ g process which, for the t-channel gluon exchange contribution, has a dominant  $C_{\rm F}$  ([12]+ [34]) antenna pattern as for qq! Z  $^0$ ! qq. The e ect only arises for the identical quark process { there is no such t-channel contribution for qq!  $q^0q^0+q$ .




Figure 7: As for Fig. 6, except that only the large-E $_{\rm T}$  bb nal state is included. The QCD (solid) curves for E $_{\rm T}$  = 300 GeV and 500 GeV are indistinguishable.

- (iv) This latter comment suggests a method for further enhancing the Z  $^0$  signal, or other new physics contributions, over the QCD background. Figure 7 shows the elect of selecting only the bb component of the nall state in Fig. 6. Such a selection could in principle be achieved experimentally by means of a vertex detector. At small E  $_{\rm T}$  the dominant process is gg! bb with a large, approximately at distribution. At large E  $_{\rm T}$ , the QCD process qg! bb has a dominant antenna pattern given by C  $_{\rm F}$  ([13]+ [24]), which is very dierent from the C  $_{\rm F}$  ([12]+ [34]) pattern of qq! Z  $^0$ ! bb. We note in passing that purely in the context of QCD , a bb subsample of the large-E  $_{\rm T}$  dijet events should exhibit a markedly dierent distribution of soft hadronic radiation.

#### 4 Application to Composite Models

If the quarks and leptons of the Standard M odel are composite objects, one would expect to see new four-ferm ion contact interactions well below the scale—characterizing the size of the composite states [7]. In particular, a four-quark contact interaction would produce a attening of the large-E  $_{\rm T}$  jet distribution at scales E  $_{\rm T}$  . The colour structure of such a contact interaction would generate a distinctive antenna pattern of soft radiation, which could be used to distinguish between standard QCD and dierent types of contact interactions between quarks.

It is straightforward to write down the most general SU (3) SU (2) U (1) invariant fourquark contact interaction, see for exam ple Ref. [33]. The generic form is

where the sum is over the colour, avour and helicity labels carried by the quark elds. There are two possible colour structures for such interactions:

where i; j;k;l = 1;2;3 are colour labels and the  $T_{ij}^a$  (a = 1;:;8) are the SU (3) colour matrices of QCD. The two terms in Eq. (27) correspond to colour singlet and octet exchange respectively. Combining these new contact interactions with those of standard QCD, one

obtains additional contributions to the 2! 2 scattering processes involving quarks. For example, for the qq! qq am plitude squared, the additional contributions are or order (contact interaction squared) and (t $^2$ )  $^1$ , (u $^2$ )  $^1$  for the QCD-contact interference.

The additional contributions to the radiation pattern can be calculated in the sameway. As a specie cexample, we consider the most widely used interaction of type (26), involving the product of left-handed, colour-singlet, isoscalar rst-generation quark currents:

where q = (u;d) and = 1 determines whether the interference with the standard QCD interaction is constructive or destructive. In fact the e ect of such an interaction can be readily obtained as a limiting case of the Z<sup>0</sup> results listed in the Appendix, speci cally by

Radiation patterns for the other quark interactions can be obtained in a sim ilar way. The num erical results will be qualitatively sim ilar to those for the heavy Z $^0$  presented in Sections 2 and 3.

For a four-quark interaction corresponding to colour octet exchange, the e ect on the radiation pattern at large  $E_{\rm T}$  will be much less dramatic, since the antenna structure for, say, qq! qq scattering will be the same for both standard gluon exchange and for the contact interaction. In principle, therefore, the radiation pattern provides a unique method for unravelling the colour structure of a new four-quark interaction.

#### 5 Conclusions

We have demonstrated in this paper how the hadronic antenna pattern due to gluon radiation may be used as a diagnostic tool which reveals the short-distance colour ow dynamics, and hence may be used to discriminate between dierent production mechanisms for large  $\mathbf{E}_{\mathrm{T}}$  jets in pp or pp collisions. In particular, we have discussed in some detail the hadronic antenna pattern associated with the production of a Z  $^0$  boson decaying into jet pairs, and contrasted it with that predicted by conventional Q C D . We have also related contact interactions with dierent colour exchanges to the Q C D and Z  $^0$  cases, so that they may also be distinguished by their hadronic antenna patterns.

The diagnostic tool provided by these hadronic antenna patterns m ay be useful in the analysis of current large-E  $_{\rm T}$  jet events at the Ferm ilab pp. If they turn out to have some component beyond conventional QCD, gluon radiation m ay help pin down the additional production mechanism. Even if the current large-E  $_{\rm T}$  data turn out to be satisfactorily tted within conventional QCD, this toolm ay be a useful addition to the kit of analysis methods to be applied to future hadronic-jet data at even larger E  $_{\rm T}$  at the LHC.

Finally, we note that the technique of using hadronic antenna patterns as a probe of new physics has many other applications other than those discussed in detail in this study. For example, in Higgs production by gluon-gluon fusion at hadron colliders the density of hadrons in the plateau corresponding to the incoming partons (the [12] antenna) should be approximately twice as large as for  $Z^0$  production. A nother application is to nal states in deep-inelastic scattering, where the technique could be used, for example, as a probe of \rapidity-gap" physics.
