NONPERTURBATIVERENORMALIZATION OF QED $\mathbb{N}$ LIGHT-CONE QUANTIZATION

## ABSTRACT

As a precursor to work on QCD, we study the dressed electron in QED nonperturbatively. The calculational schem e uses an invariant $m$ ass cuto, discretized light-cone quantization, a Tam m \{D anco truncation of the Fock space, and a sm all photon m ass. N onperturbative renorm alization of the coupling and electron m ass is developed.

## 1 Introduction

We are in the process of studying dressed ferm ion states in a gauge theory．To give the work speci c focus，we concentrate on the nonperturbative calculation of the anom alous m om ent of the electron．［iil i T his is not intended to be com petitive w ith perturbative calculations．［＂］Instead it is an exploration of nonperturbative $m$ ethods that $m$ ight be applied to Q CD and that $m$ ight provide a response to the challenge by


The m ethods used are based on light－one quantization $[\overline{4}]$ and on a number of approxim ations．Light－cone coordinates provide for a well－de ned Fock state expan－ sion．We then approxim ate the expansion with a $\operatorname{Tamm}\{D$ anco［5］ no $m$ ore than two photons and one electron．The Fock－state expansion can be writ－ ten schem atically as $=0 \dot{e} i+{ }_{1} \dot{j}$ i＋${ }_{2} \dot{j} \quad$ i．The eigenvalue problem for the wave functions $i$ and the bound－state $m$ ass $M$ becom es a coupled set of three in－ tegral equations．To construct these equations we use the H am iltonian $\mathrm{H}_{\mathrm{Lc}}$ of T ang et al．［ब్̄］The anom alous $m$ om ent is then calculated from the spin－ip $m$ atrix ele－ $m$ ent of the plus com ponent of the current．［ī］T he regulator is an invariant－m ass cuto ${ }_{i}\left(P^{+}=p_{i}^{+}\right)\left(m_{i}^{2}+p_{? i}^{2}\right) \quad{ }^{2}$ ．Additional approxim ations and assum ptions are a nonzero photon $m$ ass of $m_{e}=10$ ，a large coupling of $=1=10$ ，and use of num erical $m$ ethods based on discretized light－cone quantization（D LCQ）．［⿶凵⿱⿱一厶土刂灬］

## 2 R enorm alization

W e renorm alize the electron $m$ ass and couplings di erently in each Fock sector，as a consequence of the Tamm \｛D anco truncation．$\underline{\theta}_{-1 / 1}^{i} T$ The bare electron $m$ ass in the one－ photon sector is com puted from the one－loop correction allowed by the two－photon states．$W$ e then require that the bare $m$ ass in the no－photon sector be such that $M^{2}=m_{e}^{2}$ is an eigenvalue．
$T$ he three－point bare coupling $e_{0}$ is related to the physicalooupling $e_{R}$ by $e_{0}\left(k_{i} ; \underline{k}_{f}\right)=$ $Z_{1}\left(k_{f}\right) e_{R}=\frac{q}{Z_{2 i}\left(\underline{k}_{i}\right) Z_{2 f}\left(\underline{k}_{f}\right)}$ ，where $\underline{k}_{i}=\left(k_{i}^{+} ; k_{\text {？}}\right)$ is the initialelectron $m$ om entum and $\underline{k}_{f}$ the nalm om entum．The renorm alization functions $Z_{1}(\underline{k})$ and $Z_{2}(\underline{k})=j 0 \jmath$ are generalizations of the usualconstants．The am plitude o m ust be com puted in a basis where only allow ed particles appear．

The function $Z_{1}$ can be xed by considering the proper part of the transition am plitude $\mathrm{T}_{\mathrm{fi}}$ for photon absonption by an electron at zero photon m om entum（ $\underline{q}=$ $\left.\underline{\mathrm{k}}_{\mathrm{f}} \quad \underline{\mathrm{k}}_{\mathrm{i}}!0\right): \mathrm{T}_{\mathrm{fi}}^{\text {proper }}=\mathrm{V}_{\mathrm{fi}}=Z_{1}\left(\underline{k}_{\mathrm{f}}\right)$ ，where $\mathrm{V}_{\mathrm{fi}}$ is the elem entary three－point vertex．
 dressed electron state and $0=\frac{q}{Z_{2 f}\left(k_{f}\right)}$ ．The proper am plitude is then obtained from $T_{f i}^{p r o p e r}=T_{f i}=\left(Z_{2 i} Z_{2 f}\right)$ ，where the $Z_{2}$＇s rem ove the disconnected dressing of the electron lines．

Thus the solution of the eigenvalue problem for only one state can be used to com pute $\mathrm{Z}_{1}$ ．Full diagonalization of $\mathrm{H}_{\mathrm{LC}}$ is not needed．Because $\mathrm{Z}_{1}$ is needed in the
construction of $\mathrm{H}_{\mathrm{LC}}$, the eigenvalue problem and the renorm alization conditionsm ust be solved sim ultaneously.

M ost four-point graphs that arise in the bound-state problem are log divergent. To any order the divergences cancel if all graphs are included, but the Tam m \{D anco truncation spoils this. For a nonperturbative calculation we need a counterterm
$\left(p_{i}^{+} ; p_{f}^{+}\right)$log that includes in nite chains of interconnected loops. The function
m ight be t to C om pton am plitudes. $\left.\mathrm{t}_{\mathrm{l}}^{\mathrm{p}}\right] \mathrm{T}$ hus w eneed to be able to handle scattering processes.

## 3 P relim inary R esults and Future W ork

Som e prelim inary results are given in $F$ ig. 'ī1. In the two-photon case there rem ain divergences associated w ith four-point graphs.

The next step to be taken in this calculation is renom alization of the four-point couplings, follow ed by num erical veri cation that all logs have been rem oved. C onstruction of nite counterterm $s$ that restore sym $m$ etries $w$ ill then be considered. $W e$ can also consider photon zero m odes, Z graphs, and pair states.
