# FIN ITE TEM PERATURE EFFECTIVE THEORIES

Lecture Notes, Summer School on E ective Theories and Fundamental Interactions, Erice, 1996. I describe the construction of e ective eld theories for equilibrium high-temperature plasma of elementary particles.

#### 1 M otivation

H igh-tem perature and dense m atter of elem entary particles appears in several areas of physics. The rst and m ost fam iliar example is the Universe at the early stages of its expansion. The B ig B ang theory (for reviews see, e.g.  $^{1,2}$ ) states that the Universe was hot and dense in the past, with a tem perature ranging from a few eV up to the Planck scale  $M_{P\,1} = 10^{19}$  G eV. Another place, where m atter exists in extrem e conditions of high densities, can be created in the laboratory. Nam ely, in heavy-ion collisions extended dense reballs of nuclearm atter are created, with the energy density exceeding the QCD scale

From a practical point of view, there is quite a wide area of applications of nite-tem perature eld theory to cosm ology and laboratory experiments. The high-tem perature phase transitions, typical for grand uni ed theories (GUTs), may be important for cosm ological in ation and primordial density uctuations. Topological defects (such as monopoles, strings, domain walls) can naturally arise at the phase transitions and in uence the properties of the Universe we observe today. The rst-order electroweak (EW) phase transition is a crucial element for electroweak baryogenesis; it may also play a role in the form ation of the magnetic elds observed in the Universe. The QCD phase transition and properties of the quark-gluon plasm a are essential for the understanding of the physics of heavy-ion collisions. The QCD phase transition in cosm ology may in uence the spectrum of the density uctuations relevant to structure form ation.

In most cosm ological applications, the deviations from them al equilibrium play a most important role. For example, the concentration of prim ordial monopoles depends a lot on the dynamics of the grand uni ed phase transition; the baryonic asymmetry, produced in GUTs or in the EW theory, depends on the rate of the Universe expansion or other time-dependent phenomena. The signatures of the heavy-ion collisions are greatly in uenced by the non-equilibrium dynamics. The study of non-equilibrium properties of the plasm a is very hard. To understand the therm al non-equilibrium better, the system s in therm al equilibrium should be completely understood. W ithout this understanding, we cannot even say what a deviation from therm al equilibrium is. A fler the structure of the ground state is found, sm all deviations from therm al equilibrium can be treated by this or that perturbative m ethod.

The topic of my lecture here is the study of the equilibrium properties of the plasm a at high temperatures. As we will see, even this problem in gauge theories is highly non-trivial and requires the use of e ective eld theory m ethods.

The study of dense matter is interesting in itself from a theoretical point of view. At very small temperatures and densities the plasm a can be considered as a collection of weakly interacting individual particles; its therm odynam ical properties are close to those of the ideal Bose or Ferm i gas. W hen the tem perature or density increases, this is not true any longer, and the collective properties of plasm a become important. The change of tem perature and/or density of the system may induce phase transform ations in the system. For example, the Higgs phase of the electrow eak theory, realized at sm all tem peratures, may be transformed into a sym m etric" phase<sup>3;4;5;6</sup> (it is often said that the sym m etries are \restored" at high tem peratures). A nother exam ple is the theory of strong interactions. At sm all tem peratures the con nem ent phase of QCD is realized, while at higher tem peratures the con nem ent is believed to be absent<sup>7;8</sup>, so that a better description of the system may be achieved in terms of quarks and gluons. Thus, the study of nite-tem perature eld theory can be considered as a theoretical laboratory to test our understanding of the Higgs mechanism in the EW theory, con nement and chiral symmetry breaking in QCD, etc.

The plan of the lecture is as follows. In section 2 we discuss the accuracy of the equilibrium approximation in cosmology. In section 3 we introduce the main de nitions of nite-temperature eld theory, and in section 4 we explain why ordinary perturbation theory breaks down at high temperatures. In section 5 we explain the main idea of an elective eld theory approach and in section 6 apply it to the dilerent physical theories. In section 7 we discuss phase transition in the EW theory. Section 8 is the conclusion. Our discussion is carried out mainly on the qualitative level, many technical details can be found in the original papers cited below.

# 2 Equilibrium approximation

In loose terms, the thermal equilibrium approximation may be valid if the system is considered after some time substantially exceeding the typical equili-

bration time. Let us see how this general rule works for the expanding Universe.

The measure of deviation from the therm alequilibrium is the ratio of two time scales. The stone is the rate of the Universe expansion, given by the inverse age of the Universe  $t_{U}^{-1}$ :  $t_{U} = \frac{M_{-0}}{T^{-2}}$ . Here M\_{-0} = M\_{\rm P}\,\_{1} = 1:66N^{\frac{1}{2}} - 10^{18} GeV, and N is the elective number of the massless degrees of freedom. The expansion rate of the Universe is a unique non-equilibrium parameter of the system (at least in the absence of di erent phase transitions). The second time scale (di erent for di erent types of interaction) is a typical reaction time, given by ( $_{\rm reaction}$ )  $^1$  h nvi; where is the corresponding cross-section, n is the particle concentration and v is the relative velocity of the colliding particles.

As an example, let us consider the Universe at the electroweak epoch, at temperatures T  $m_W$ . The fastest reactions are those associated with strong interactions (e.g. qq ! GG); their rate is of the order of  $(_{strong})^1$   $_s^2 T$ . The typical weak reactions, say e ! e , occur at the rate  $(_{w eak})^1$   $_w^2 T$ , and the slowest reactions are those involving chirality ips for the lightest fermions, e.g. e. H ! W with the rate  $(_e)^1$   $f_e^2$  w T, where fe is the electron Yukawa coupling constant. Now, the ratio  $\frac{1}{t_U}$  varies from 10<sup>14</sup> for the fastest reactions of quarks and gluons, interm ediate vector bosons, H iggs particle and left-handed charged leptons and neutrino are equal to the equilibrium ones with an accuracy better than 10<sup>13</sup>; the largest deviation from them al equilibrium (  $10^2$ ) is being expected for the right-handed electron.

These estimates show that the equilibrium description of the Universe is a very good approximation at the electroweak scale. At other temperatures the situation may not be so optimistic. For instance, if the Universe was as hot as, say,  $10^{17}$  GeV, then the equilibrium description of the (grand uni ed) interactions would be questionable, since the ratio  $\frac{i}{t_U}$  would be of the order of 1. By equating the rate of the Universe expansion with the rate of this or that reaction, one can estimate a range of temperatures where the process under consideration was in them al equilibrium. For example, the rate of the electrom agnetic interactions exceeded the rate of the Universe expansion at (few eV) < T <  ${}^2M_{Pl}$   $10^{15}$  GeV, weak interactions were in them al equilibrium at temperatures up to the nucleosynthesis temperature (few keV), etc.

The same type of consideration can be carried out for the heavy-ion collisions. Again, if the therm al equilibration time is much smaller than the time the reball exists, equilibrium therm odynam ics can be applied to the description of the extrem e state of matter appearing as an interm ediate stage of the collision process. Since strong dynam ics is involved, the estimates of the corresponding time scales are much less certain, but quite encouraging <sup>9;10;11</sup> (for a review see, e.g.<sup>12</sup>).

The general conclusion is that the equilibrium approximation is valid in a wide range of physical situations in cosmology and, less certainly, in the laboratory.

# 3 The basics of nite-tem perature eld theory

This section is a short introduction to nite-tem perature eld theory. More details can be found in a number of excellent reviews and books, see, e.g. refs.  $^{13;14;15}$ .

If some system is described by the H am iltonian H , and there are several conserved charges Q<sub>i</sub>,  $[Q_i;H] = 0$ , then the therm all equilibrium state of the system is described by the density matrix ,

where  $_{i}$  is a set of chem ical potentials. The parameter Z is nothing but the statistical sum of the system :

In what follows we constrain the general situation to the case when all chem ical potentials of the system are equal to zero. In this particular case the statistical sum is related to the density of the free energy F of the system through

where V is the volume of the system. The analogy of expression (1) with the quantum -m echanical time evolution operator exp( if t) allows us to write down a functional-integral representation for the statistical sum:

where the integral is taken over all bosonic ( ) and ferm ionic ( ) elds, and  $S_E$  is Euclidean action for the system , de ned on a nite  $\time"$  interval 0 < < =  $\frac{1}{\pi}$  ,

where L is the Euclidean Lagrangian density. The bosonic elds, entering the functional integral, obey periodic boundary conditions with respect to in aginary time, (0;x) = (;x), and ferm ionic elds are antiperiodic, (0;x) =

(;x). The case of gauge theories requires the ordinary gauge xing and introduction of ghost elds. In spite of the anticommuting character of the ghost elds, they obey periodic boundary conditions.

The form all analogy with zero-tem perature eld theory allows the introduction of an important notion of the so-called imaginary time (as opposed to real time), or M atsubara G reen's functions. For example, the bosonic G reen functions are de ned as

Ferm ionic G reen's functions are derived by a simple replacement of the bosonic elds by ferm ionic elds.

The construction described above is the basis of the statem ent that the nite tem perature equilibrium eld theory is equivalent to the Euclidean eld theory de ned on a nite \time" interval. Thus, many methods developed for the description of zero-tem perature quantum eld theory (e.g. perturbation theory, sem i-classicalanalysis, lattice num erical simulations) can be easily generalized to the non-zero tem perature case.

For example, perturbation theory at nite temperatures looks precisely like perturbation theory at T = 0 with substitutions of quantities associated with the zero component of 4-m om entum p, as follows:

where the discrete variable ! is 2 nT for the bosons and (2n + 1) T for ferm ions, with n being an integer number. The niteness of the time intervalm akes the energy variable discrete, since the Fourier integral used at zero tem perature is substituted by the Fourier sum .

The equilibrium properties of a plasm a are completely de ned by the statistical sum and by the set of G reen's functions. Thus the problem of equilibrium statistics is to compute these quantities reliably.




Figure 1: Vacuum diagram s contributing to the free energy density in a scalar theory.

#### 4 The breakdown of perturbation theory

In this lecture we will constrain ourselves to the theories of the following type. W e will require that the running coupling constants of the theory, taken at the scale of the order of tem perature, are sm all. This class is su ciently wide and includes m any interesting cases. The simplest example is a scalar theory

with 1. Since the scalar self-coupling is not asymptotically free, the temperature of the system is assumed to be much smaller than the position of the Landau pole. Another example is the electroweak theory, and another is QCD at su ciently large temperatures (T 100 MeV). Many GUTs also fall in this class.

An aim of this section is to show that the straightforward or modied perturbation theory fails in describing certain details of the properties of hightem perature plasm a. W e will also discuss here di culties in putting the whole problem on the lattice. W e will use here fairly loose term s, the precise m eaning of which, together with the true limitations of perturbation theory, will become clear in the next section.

A n attempt to compute perturbatively the statistical sum or G reen's functions at su ciently large temperatures in mediately shows the trouble <sup>6</sup>. A sthe simplest example let us take the theory (8) and compute its statistical sum. In perturbation theory, it is given by a set of vacuum graphs, see Fig. 1. Consider the temperatures T m. Then, with the use of Feynman rules de ned above, it is easy to see that in addition to an ordinary, zero-temperature expansion

param eter, , a new expansion param eter appears,

A most simple way to see this is to take the n=0 contribution to the statistical sum (as we will see later, these modes are crucial in constructing e ective eld theories). The simple loop gives m $^3T$ , the  $\setminus$  gure of eight" graph gives  $T^2m^2$ , etc. Therefore, the straightforward perturbation theory breaks down at  $T \ > m =$ . For the theories containing, in perturbation theory, massless bosons (such as QCD) perturbation theory does not work for any temperature  $^{16;17}$ .

There is a deep physical reason why this happens. At zero tem perature we apply perturbation theory for consideration of processes where only a sm all number of particles participate. Thus, the expansion parameter is . At high tem peratures, the number of particles, participating in collisions, may be large. M oreover, for bosonic degrees of freedom there is a well-known Bose am pli cation factor, associated with the bosonic distribution

where  $E = \frac{p}{k^2 + m^2}$  is the particle energy. So, the expansion parameter becomes n (E), coinciding with (9) at small momenta.

In fact, perturbation theory breaks down in the most interesting place, namely at the temperatures where di erent phase transitions are expected. One of the ways to deal with this problem is to rearrange the perturbative series and make a resum mation of the most divergent diagrams. Partially, this helps in some cases. For example, for our pure scalar model the sum mation of the bubble graphs is equivalent to the introduction of the temperature-dependent scalar mass, which comes from one-bop corrections<sup>5</sup> (see g.2):

which is to be used in propagators. For positive m<sup>2</sup> this procedure saves the situation and allow s the perturbative computation of all properties of the equilibrium plasm a in this theory. An interesting thing is that at high temperatures the expansion parameter of the resum m ed perturbation theory is  $\frac{T}{m_{eff}}$  rather than . For negative values of m<sup>2</sup>, corresponding to the spontaneous sym m etry breaking at zero temperatures, even resum m ed perturbation theory breaks down near the point m<sup>2</sup><sub>eff</sub> (T) ' 0, failing do describe the details of the sym m etry-restoring phase transition which occurs there.




Figure 2:0 ne-loop correction to the scalar mass.

Take now realistic theories. The resum med perturbation theory does not solve the problem, say, in QCD. The static gluon (n = 0 component of the gauge eld) mass remains zero in the one-loop approximation, so that infrared divergence inherent in (9) is not cut. A typical energy scale E, at which this happens is  $^{a}$  E  $_{s}T$   $^{16;17}$  and is much smaller than the temperature itself because, according to our assumption, the coupling constants are small at the temperature under consideration. The same problem appears in the description of the phase transitions in gauge theories with scalars (such as EW theory and GUTs), where the gauge elds at high temperature are massless in perturbation theory.

To sum marize this discussion, even the resum med perturbation theory breaks down at some infrared energy scale  $E_{infrared}$  T, where is a typical coupling constant of the theory under consideration. Thus, a num ber of properties in high-temperature plasma and di erent phenomena such as phase transitions cannot be described by perturbation theory.

If perturbation theory breaks down a natural inclination would be the use of direct num erical non-perturbative m ethods, such as lattice M onte C arlo simulations. This approach does not work, however, for theories containing chiral ferm ions, since we do not know how to put these on the lattice. Thus, theories such as the EW theory or grand unied models cannot be studied on the lattice with their complete particle content. This problem does not appear in pure bosonic models or in theories containing vector-like fermions, such as QCD. These m odels can be simulated on the lattice, but computations are often very dem anding. Quite ironically, the computations are more time consuming for weaker coupling constants. This can be seen as follows. At high tem peratures, the average distance between particles is of the order of T $^1$ , and it is clear that the lattice spacing a must be much sm aller than this T<sup>1</sup>. At the same time, the lattice size N a, where N is the distance, a num ber of lattice sites in the spatial direction, must be much larger than the infrared scale, described above, i.e. N a  $(T)^{1}$ . Therefore, the lattice size

is required to be rather large, N  $\frac{1}{2}$ , the larger the sm aller the coupling constant is.

The next section describes the form alism which allows one to deal with these problems, at least when the elective coupling constants are small at the tem perature under consideration. O ther limitations of the elective eld theory approach will be considered later.

#### 5 E ective eld theory approach

The main idea of the elective theory approach to high-temperature eld theory is the factorization of weakly coupled high-momentum modes, with energy E T, and of strongly coupled infrared modes with energy E < T, and the construction of an elective theory for infrared modes only. The construction of the elective eld theory is perturbative, while its analysis may be non-perturbative. Different methods can be applied: expansion, exact renormalization group, gap equations, M onte C arlo simulations, etc. Thus, a combination of perturbative and non-perturbative methods is to be used to solve the problem. The idea of this construction, known as dimensional reduction, goes back to the papers by G insparg<sup>18</sup>, and by Appelquist and P isarski <sup>19</sup>. It was developed in refs.<sup>20;21;22;23</sup>, in application to the phase transitions and applied to hot Q C D in refs.<sup>24;25;26;27;28</sup>. D i erent aspects of dimensional reduction were studied in refs.<sup>29;30;31</sup>.

The Euclidean formulation of the nite temperature eld theory, described in section 2, provides a natural recipe for the construction of elective eld theory. We learned there that the nite-temperature equilibrium eld theory is equivalent to the Euclidean eld theory de ned on a nite time interval. Let us expand the bosonic and fermionic elds into Fourier sum s,

where  $!_n^b = 2n T$  and  $!_n^f = (2n + 1) T$ . A fler inserting these expressions into the action, the integration over time can be performed explicitly. As a result, we get a three-dimensional action, containing an in nite number of elds, corresponding to dimensional actuar frequencies. Symbolically,

Therefore, a 4d nite-temperature eld theory is equivalent to a 3d theory with an in nite number of elds, and 3d boson and ferm ion masses are just the frequencies !<sup>b</sup> and !<sup>f</sup>. One can easily recognize here a perfect analogy to K aluza {K lein theories with compact higher-dimensional space coordinates.

Now comes a crucial step. The 3d \superheavy" modes (eds with masses T) interact weakly with each other and with light modes (bosonic eds corresponding to the zero M atsubara frequency). Therefore, they can be \integrated out" with the use of perturbation theory, so that the 3d e ective action, containing zero modes of bosonic eds, can be constructed. Form ally,

where the product is taken over non-zero frequencies. The e ective action contains the bosonic elds only and can be written in the form

where  $L_b(T)$  is a super-renormalizable 3d elective bosonic Lagrangian with temperature-dependent constants, containing a scalar self-interaction up to the fourth power,  $O_n$  are operators of dimensionality n + 3, suppressed by powers of temperature at n = 1, c is a perturbatively computable number (contribution of  $n \in 0$  modes to the free energy density). The existence of the elective action is closely related to the decoupling theorem  $^{32;33}$ .

A way to compute the elective action of the theory is by a matching procedure, which has a lot in common with the corresponding method for heavy quarks, described at this school by M. Neubert. Write the most general 3d elective action, containing the light bosonic elds only, and x its parameters (coupling constants and counterterms) by requiring that 3d G reen's functions at small spatial momenta k T, computed with an elective Lagrangian, coincide with the initial 4d static G reen's functions up to some accuracy,

D epending on the level of required accuracy, di erent numbers of operators O  $_{\rm n}$  m ust be included in the e ective theory. For a generic gauge theory with

 $\hat{g}$ ; f g, where (f) is a typical scalar self-coupling (ferm ion Yukawa coupling), m = 4 for a super-renorm alizable part of the e ective theory, i.e. when all operators O<sub>n</sub> are dropped.

The following, evident consistency check must be applied to the constructed e ective eld theory. The typical energy scales (m asses of excitations in 3d theory m  $_{\rm eff}$  ) m ust be sm all com pared with the energy scale  $\,$  T that we have integrated out:

In fact, the 3d approximation generalizes the so-called high-temperature expansion offen applied to the construction of the elective potential of the scalar eld at high temperatures.

A fler the eld theory is constructed, the statistical sum is expressed through the functional integral over 3d bosonic elds only:

In some cases this integral can be computed with the help of the perturbation theory, but in general its evaluation requires di erent non-perturbative m ethods.

The construction, described above, books quite form al. N evertheless, it has a nice physical interpretation associated with the classical statistics of the eld theory. Indeed, consider the bosonic elds appearing in  $L_b$  (T) as generalized coordinates for some classical eld theory with the H am iltonian

where  $P_i(x)$  is a set of generalized m omenta. Now, the partition function for this classical system is given by the functional integral

$$Z = DP(x)D(x) exp \frac{H}{T};$$

which coincides with eq. (19) after the integration over m om enta. Thus, it is often said that the high-tem perature lim it of the quantum eld theory is given by the classical statistics<sup>7</sup>.

W e willdem onstrate how this general procedure works on speci c examples in the next section. A s we will see, in several cases further simplication of the e ective theory is possible.

# 6 Exam ples

# 6.1 Pure scalar eld theory

Let us rst consider a simplest scalar theory with the 4d Lagrangian de ned by eq. (8). A coording to our rules, we must write down the most general 3d

Lagrangian, consistent with the sym metries of the theory. It looks like:

$$L_{eff} = \frac{1}{2} (\theta_{i 3})^2 + \frac{1}{2} m_{3}^2 \frac{2}{3} + \frac{1}{4} \frac{3}{3} \frac{4}{3} + L; \qquad (22)$$

where L represents the contribution of higher-order operators. In 3d, the dimensionality of the dimensionality constants and scalar eld are:  $_3: G eV^{\frac{1}{2}}$ ;  $m_3^2: G eV^2$ ;  $_3: G eV$ . The mapping procedure on the tree level (sometimes called naive dimensional reduction) in mediately gives the relation of 3d eld to 4d eld:  $_3 = -T$ , and other 3d parameters are given by  $m_3^2 = m^2$  and  $_3 = -T$ .

The structure of one-loop corrections to these relations can be easily found on general grounds. An important fact is that the 3d theory is super-renorm alizable and contains a nite number of divergent diagram sonly. The ultraviolet renorm alization of the coupling  $_3$  is absent in any order of perturbation theory, while the mass term contains linear and logarithm ic divergences on the oneand two-loop levels respectively. At the same time, the 4d self-coupling and mass m are scale-dependent. Thus, on the one-loop level the relation of the 3d param eters to the 4d ones must have the form :




Figure 3: 0 ne loop correction to the coupling constant.

where  $_{\rm m}$  and  $_{\rm m}$  are the -functions corresponding to the running mass and self-coupling. The parameters A and  $_{\rm T}$  cannot be xed by the requirement of renormalization group invariance and are to be found by explicit computation of diagrams in Figs. 2 and 3. In the modi ed m in in all subtraction scheme  $\overline{\rm M~S}$  they are:

In eqs. (23) the parameter is arbitrary, and taking it to be  $=_{T}$  m in im izes the corrections. This allows us to rewrite these equations in a simpler form,  $_{3} = (_{T})T$ ,  $m_{3}^{2} = \frac{1}{4}$  ( $_{T})T^{2} + m^{2}$ ( $_{T}$ ). The appearance of the running m ass and 4d coupling constant at scale T clari es our requirement concerning the amplitude of the coupling constant, needed for the perturbative construction of the elective eld theory. The higher-order corrections to relations (23) can also be found.

The super-renorm alizable theory gives the accuracy in G reen's function  $\frac{G}{G} = 0$  (<sup>2</sup>) provided we have spatialm om enta k T and a 3d m ass jm  $_3^2$  j

T<sup>2</sup>. A further increase in the accuracy m ay be achieved by adding higher-order operators. The one with dimensionality three appears on the one-loop level and is equal to h  $\frac{6}{3}$ , with

$$h = \frac{9 (3)}{256^4} ^3$$
:

Just on dimensional grounds, the perturbative expansion parameter in the elective 3d theory is  $_3=m_3$ . Thus, if the spontaneous symmetry breaking is absent at zero temperature (m<sup>2</sup> > 0), then the 3d theory is weakly coupled in the whole range of temperatures (of course, below the Landau pole). Thus, all equilibrium properties of a high-temperature state can be computed by rst constructing the elective eld theory and then by perturbative computations in the elective theory. In the opposite case, when m<sup>2</sup> is negative, the symmetry ! is broken at zero temperature, and the scalar eld acquires a non-zero vacuum expectation value:

As seen from our e ective Lagrangian (22), the 3d m ass changes its sign at

which is nothing but an estimate of the critical temperature of the phase transition with restoration of the ! symmetry. The mass squared of the particle excitation in the tree approximation is given by  $m_3^2$  at  $T > T_c$  and by  $2m_3^2$  at  $T < T_c$ . The perturbative analysis of the elective theory near  $T = T_c$  breaks down, since the expansion parameter  $_3 = jm_3 j diverges near this point. Non-perturbative methods (such as -expansion or lattice simulations) are needed in order to clarify the nature of the system here.$ 

Let us consider the advantages we gain by the construction of the elective eld theory. The straightforward perturbative analysis of the original theory is valid for  $1 \text{ and } T^2 = \frac{j\pi^2 j}{2}$ . The construction of the elective eld

theory requires only 1 and  $jn^2 j$  (T)<sup>2</sup>. In particular, it is applicable near the temperature of the phase transition T<sub>c</sub>. The original 4d theory at T<sup>2</sup> >  $\frac{m^2}{2}$  contains at least two important energy scales: an ultraviolet one

T and the infrared one  $m_3$ ; the elective theory contains an infrared scale only. Beyond the phase transition, the theory is perturbatively solvable, and the elective eld theory approach provides a convenient recipe for resumming the perturbation theory.

# 6.2 QCD

The QCD Lagrangian for n<sub>f</sub> quark avours is given by

$$L = \frac{1}{4}F F + \frac{X}{i}(D m_{i})_{i}:$$

For simplicity, let us consider the limit T  $m_i$ . The 3d e ective Lagrangian contains gauge elds  $A_i^a$  and a scalar octet  $A_0^a$ , a = 1; ..., 8, where  $A_0$  is a tem – poral component of the 4d gauge eld. The most general super-renorm alizable 3d Lagrangian, containing these elds, is

$$L_{3} = \frac{1}{4} F_{ij} F_{ij} + \frac{1}{2} (D_{i} A_{0}^{a})^{2} + \frac{1}{2} m_{D}^{2} A_{0}^{a} A_{0}^{a} + \frac{1}{4} A_{0}^{a} A_{0}^{a})^{2} : \qquad (28)$$

Here D<sub>i</sub> is a covariant derivative in adjoint representation. Of course, on the tree level  $m_A^2 = 0$  and A = 0 because of the structure of the 4d Lagrangian. The one-loop relations in the  $\overline{MS}$  scheme are  ${}^{30;34;22}$ :

The logarithm ic corrections to m $_D^2$  and  $_A$  appear on two-loop levelonly. The non-zero value ofm  $_D$  (the D ebyerm ass) ensures the screening of chrom o-electric elds in a high-tem perature plasm a and the absence of con nem ent.

Because of asymptotic freedom, the elective theory is valid at su ciently high temperatures, when  $_{s}(_{T}) = 1$ . In other words, it is applicable to

the quark-gluon phase of QCD only and describes physics on the energy scales k = T, but k = a be as large as qT.

The 3d Lagrangian (28) contains two essential mass scales. The largest one is the D ebye screening mass gT, and the smallest scale is associated with the 3d gauge coupling constant  $_3 = _{s}T$ . The scale hierarchy  $_3 m_D$ , appearing when the e ective eld theory approach is valid, suggests that a further simplication of the e ective theory is possible. Namely, the \heavy" scale gT (we used the term \superheavy" for the scale T) can be integrated out. The construction of the \second" level of e ective eld theory, containing the chrom o-m agnetic gauge elds only, goes precisely along the lines described above. The result is a pure SU (3) Y ang {M ills theory, describing the interaction of soft m odes with momenta k gT, but k may be as large as  $g^2T$ . The Lagrangian is:

$$L_{eff} = \frac{1}{4} F_{ij} F_{ij}$$
(33)

In the one-loop approximation the new gauge coupling is  $^{35}$ :

$$g_3^2 = g_3^2 \quad 1 \quad \frac{g_3^2}{16 \, m_D}$$
; (34)

and the accuracy of an elective description by a pure gauge theory at m omenta k gT is  $\frac{G}{G}$  0 (g<sup>3</sup>) <sup>22</sup>.

The 3d pure gauge theory which appeared as a nal stage of dimensional reduction contains just one scale,  $_3$ . It is strongly coupled at small energies and is believed to be con ning. No perturbative methods are available for its study. Thus, high-tem perature QCD, in spite of asymptotic freedom, contains a piece of non-perturbative physics described by a pure Yang{M ills theory in 3d. A simple power counting allow sone to ndeasily the limits of perturbation theory for the study of high-tem perature QCD. Let us take, for example, free energy. From dimensional grounds, the contribution from the non-perturbative pure 3d sector is of the order of  $_3^3$ T. Thus, the O (g<sup>6</sup>)T<sup>4</sup> correction to the free energy cannot be computed perturbatively. Recently, the perturbative computations were pushed to the very end: the O (g<sup>4</sup>) corrections to the free energy were computed in refs.<sup>36;37</sup> and O (g<sup>5</sup>) in <sup>38;27;28</sup>. In order to nd the O (g<sup>6</sup>) contribution, a non-perturbative method, such as lattice M onte C arlo simulations, must be applied to solve the pure 3d m odel. In addition, a num ber of 4-loop com putations should be done.

# 6.3 Electroweak theory

O unexperience with the pure scalar theory and QCD allows us an easy guess of the elective 3d action for soft strongly interacting bosonic modes with  $k_{\rm c}=gT$ ,

describing the high-tem perature EW theory. This is just the 3d SU (2) U (1) gauge theory with the doublet of scalar elds with the Lagrangian

$$L = \frac{1}{4} G_{ij}^{a} G_{ij}^{a} + \frac{1}{4} F_{ij} F_{ij} + (D_{i})^{y} (D_{i}) + m_{3}^{2} + (D_{i})^{2}; \quad (35)$$

where  $G_{ij}^{a}$  and  $F_{ij}$  are the SU (2) and U (1) eld strengths, respectively, is a scalar doublet, and  $D_{i}$  is a standard covariant derivative in the fundam ental representation. The four parameters of the 3d theory (scalar mass m<sup>2</sup><sub>3</sub>, scalar self-coupling constant <sub>3</sub>, and two gauge couplings  $g_{3}$  and  $g_{3}^{0}$ ) are some functions of the initial parameters and tem perature. They were computed in the one-and partially in the two-bop approximation in refs.<sup>20;22</sup>; we present here just the tree relations for the coupling constants:

and the one-loop relation for the scalar mass:

$$m_{3}^{2}() = \frac{1}{2}m_{H}^{2} + T^{2}\frac{1}{2} + \frac{3}{16}g^{2} + \frac{1}{16}g^{02} + \frac{1}{4}g_{Y}^{2}$$

Here m  $_{\rm H}$  is the zero-tem perature H iggs m ass,  $g_{\rm Y}$  is the Y ukaw a coupling constant corresponding to the t-quark.

As usual, the elective action does not contain fermions since their 3d masses are \superheavy". It does not contain zero components of the gauge elds { triplet and singlet of SU (2) { because these are \heavy" according to our classi cation of scales.

The most interesting area of application of the elective action (35) is the region of temperatures where the electroweak phase transition is expected to occur. As in the case of the pure scalar theory, a rough estim ate of the critical temperature follows from the requirement that the 3d m ass of the scalar eld is close to zero,  $m_3^2 = 0$ . In the vicinity of this point the electrive Lagrangian (35) has a much wider area of application than the minimal Standard M odel (M SM ). In fact, it plays the role of the universal theory which describes the phase transition in a number of extensions of the Standard M odel at least in a part of their parameter space. The set of models includes the minimal supersymmetric Standard M odel (M SSM ) and some extended versions of it, an electroweak theory with two scalar doublets, etc. O ne may wonder where are the other scalars, typical for the extensions of the Standard M odel. The answer is that all extra scalar degrees of freedom are naturally \heavy" (m ass

gT) near the phase transition tem perature and can be integrated out.

Indeed, let us take as an example the two-H iggs doublet model. The integration over the \superheavy" modes gives a 3d SU (2) U (1) theory with

an extra H iggs doublet in addition to the theory considered above. C onstruct now the one-loop scalarm assmatrix for the doublets and nd the tem peratures at which one of its eigenvalues is zero. Take the higher tem perature; this is the tem perature near which the phase transition takes place. D etem ine the m ass of the other scalar at this tem perature. G enerally, it is of the order of gT, and therefore, it is heavy. Integrate this heavy scalar out { the result is eq. (35). In the case when both scalars are light near the critical tem perature, a m ore com plicated m odel, containing two scalar doublets, should be studied. It is clear, how ever, that this case requires ne tuning.

The same strategy is applicable to the MSSM. If there is no breaking of colour and charge at high tem perature (breaking is possible, in principle, since the theory contains squarks), then all degrees of freedom, excluding those belonging to the two-H iggs doublet model, can be integrated out. We then return back to the case considered previously. The conclusion in this case is sim ilar to the previous one, namely that the phase transition in the MSSM can be described by a 3d SU (2) U (1) gauge{H iggsm odel, at least in a considerable part of the parameter space. The explicit relations were worked out in refs. <sup>39;40;41</sup>. W hat changes from going from one theory to another is the explicit perturbative relations between initial 4d parameters and parameters of the electrow eak phase transition occurs in them in a sim ilar way. The electrow edd theory approach again demonstrates its strength: instead of studying

m any m odels with di erent particle content, it is su cient to study just one 3d e ective theory by non-perturbative m eans; the result of this study m ay be used form any 4d m odels after perturbative com putations of 4d ! 3d m apping.

#### 7 Electroweak phase transition

O ne of the m ost interesting areas of application of nite-tem perature eld theory are phase transitions. O ur interest in this section will be an EW theory. The strength of the electrow eak phase transition is important for a num ber of cosm ological applications. For example, all mechanisms of electrow eak baryogenesis require that the phase transition should be strong enough, i.e. <sup>42;43</sup>

$$v(T_c)=T_c > 1;$$
 (38)

where  $v(T_c)$  is the vacuum expectation value of the Higgs eld at the critical tem perature.

A swe have learned in the previous section, to study the electroweak phase transition it is su cient to study an SU (2) U (1) gauge {H iggs theory in 3d. Let us simplify even further and om it the U (1) factor. Numerically the U (1)

coupling constant  $g^0$  is smaller than the SU (2) one g; thus the corrections are expected to be small. In this case, the Lagrangian is

$$L = \frac{1}{4} G_{ij}^{a} G_{ij}^{a} + (D_{i})^{y} (D_{i}) + m_{3}^{2} + _{3} (y)^{2}:$$
(39)

This 3d theory is de ned by one dimensionful parameter  $g_3^2 = g^2 T$  and two dimensionless ratios

x 
$$\frac{3}{g_3^2}$$
; y  $\frac{m_3^2}{g_3^4}$ : (40)




Figure 4: The value  $x=_{3}=g_{3}^{2}$  as a function of the physical Higgs mass m $_{\rm H}$  and the top quark mass m  $_{\rm top}$  near the critical temperature de ned from taking m $_{3}^{2}$  = 0. In general, x depends on the Higgs mass, the top mass, and logarithm ically on the temperature. From ref.  $^{23}$ .

The dimensionful coupling constant can be chosen to x the energy scale. Therefore, the phase state of this theory is completely de ned by the two numbers x and y. For the M SM the dependence of the parameter x on the mass of the Higgs boson near the critical temperature (near y = 0) is shown in Fig. 4.

At rst glance there are two phases in this theory. W hen the Higgs mass is positive, y > 0, one would say that this theory is analogous to QCD with scalar quarks. Thus, we are in the \con nem ent" phase (other nam es of this phase are \sym m etric" or \restored" phase) and the particle spectrum consists of the bound states of the scalar quarks, such as

$$= {}^{y}; W {}^{0}_{j} = i ( {}^{y}D_{j} ( D_{j} ) {}^{y});$$
$$W {}^{+}_{j} = (W {}_{j}) = ( {}^{y}D_{j} ~ (D_{j}) {}^{y} ~); \qquad (41)$$

Here  $\sim = i_2$  .

On the contrary, if the scalar mass is negative, one would say that the SU (2) gauge symmetry is broken, and the initially massless gauge bosons acquire non-zero masses. This phase is usually called \broken" or Higgs. In the usual folklore, the particle spectrum consists of fundamental massive gauge bosons and the Higgs particle.

W hen the tem perature changes, the sign of the elective mass term changes. If the consideration presented above were true, one would expect to have a rst-order or second-order phase transition between the two phases. In fact, the gauge symmetry is never \broken" { all physical observables by construction are gauge-invariant. Moreover, there is no gauge-invariant boal order-parameter that can distinguish between the \broken" (Higgs) and \restored" (symmetric or con nement) phases  $^{44;45}$ . The bound states de ned in (41) are com plementary to the \elementary" excitations in the Higgs phase. A simple exercise shows that in the Higgs phase in unitary gauge the composite elds de ned by eq. (41) are proportional to the \elementary" elds corresponding

to the Higgs particle and vector bosons. Thus, in a strict sense, there is no gauge sym m etry restoration at high tem peratures, but there can be (but not necessarily are) phase transitions.

This general consideration suggests three possible phase diagram s for the SU (2) {H iggs m odel (F ig. 5). F irst, because the qualitative di erence between sym m etric and H iggs phases is absent, we can have only one phase (H iggs-con nem ent phase) everywhere at the (x;y) plane (F ig. 5a). O f course, different points at this plane correspond to the theories which are quantitatively

 $<sup>^{\</sup>rm b}{\rm C}$  ontrary to the gauge sym m etry case, global sym m etries m ay be broken or restored. In the pure scalar m odel, considered in the previous section, the sym m etry ! is global, so that it is indeed restored at high tem peratures, provided it was broken at T = 0.




Figure 5: Three possible types of phase diagram for the SU (2) gauge(H iggs system .

di erent; nevertheless one theory can be analytically transform ed to another one. In the latter case any high-tem perature phase transition is absent. Another possibility is that there is a rst-order transition line separating the \sym m etric" phase from the \broken" phase. In this case the rst-order phase transition occurs at any value of the scalar self-coupling constant (Fig. 5b). An interm ediate possibility is when a rst order phase transition line has an end-point som ewhere on the phase plane (Fig. 5c). Then at x <  $x_{crit}$  the phase transition is of the rst kind, at x =  $x_c$  the phase transition is of the second kind, and at x >  $x_c$  the phase transition is absent.

O f course, som e com putations are necessary in order to clarify the phase structure. A simple one-loop perturbative analysis allows F ig. 5a to be ruled out, but cannot distinguish between F ig. 5b and F ig. 5c.

Let us de ne the eld-dependent vector boson mass as

$$m_T = \frac{1}{2}g_3$$
; (42)

and scalarm asses as

$$m_{1}^{2} = m_{3}^{2} + 3_{3}^{2};$$
(43)  
$$m_{2}^{2} = m_{3}^{2} + 3_{3}^{2}:$$

Then the 1-loop e ective potential for the scalar eld is

$$V_{1}() = \frac{1}{2}m_{3}^{2} + \frac{1}{4}m_{3}^{4} + \frac{1}{12}m_{T}^{3} + m_{1}^{3} + 3m_{2}^{3} :$$
(44)

This elective potential describes a rst-order phase transition, since at the critical value of  $m_3^2$  the jump of the order parameter is non-zero. Is the conclusion about the rst-order nature of the phase transition reliable? To answer this question, one can estim ate the value of the eld at the maximum of the eld et the maximum of the eld et use potential. At su ciently small values of  $_3$  it is of the order of  $\frac{g_3^2}{m_{\pi}}$ . The dimensionless expansion parameter at this point is  $\frac{g_3^2}{m_{\pi}}$  = x. Thus, the existence of the maximum of the eld ective potential is reliable at small values of x (small H iggsm asses in zero-tem perature language). Therefore, the \symmetric" and the \broken" phase are separated by a rst-order phase transition line, at least at small x. At larger x perturbation theory is not to be trusted, and the nature of the phase transition can be clari ed only by som e kind of non-perturbative analysis. An argument in favour of F ig. 5b follows from the -expansion<sup>18;46</sup> while an indication that the scenario of F ig. 5c m ay be realized com es from the study of 1-loop gap equations<sup>47</sup>.

The 3d lattice M C simulations, done in <sup>48</sup>, have established the absence of rst-and second-order phase transitions at x > 0.18 and singled out the phase diagram of the type shown in Fig. 5c. The value of the end-point of the rst-order phase transition line is likely to be near  $x = \frac{1}{8}$ , i.e. there is no phase transition at Higgs masses greater than 80 GeV in the minimal Standard M odel. In this case it is quite unlikely that there are any cosm ological consequences coming from the EW epoch. The 4d lattice simulations at su ciently small Higgs masses of a pure bosonic model were carried out in refs.<sup>49;50;51;52;53</sup>. W henever the comparison between 3d and 4d simulations is possible, they are in agreement, indicating the correctness of the dimensional reduction beyond perturbation theory.

The requirement of the EW baryogenesis provides an even stronger constraint on the strength of the EW phase transition. In fact, the constraint (38) does not hold for any Higgs mass in the MSM (if the mass of the top quark is 175 GeV)<sup>23</sup>. It is possible to satisfy this constraint in a speci c portion of the parameter space of the MSSM <sup>54</sup>: the Higgs mass is smaller than the Z mass, the lightest stop mass is smaller than the top mass, and tan < 3. This prediction can be tested at LEP2.

Near the critical point (the end-point of the rst-order phase transition line) the 3d gauge{H iggs system adm its a further sim pli cation at large distances  $\frac{1}{q_3^2}$ . At the critical point the phase transition is of second order, thus there is a massless scalar particle. The elective theory describing this nearly m assless state is a simple scalar theory of some eld with the Lagrangian

$$L = \frac{1}{2} (\theta_{1})^{2} + \frac{1}{2}m^{2} + \frac{1}{2}m^{4} + h :$$
 (45)

It is a challenge to de ne a mapping of the parameters of the gauge SU (2) Higgs model to the parameters of the scalar theory, since the perturbative methods fail in the strong coupling lim it.

# 8 Conclusion

The elective eld theory approach is a powerful method for studying hightem perature equilibrium eld theory. It has allowed to solve a number of longstanding problem s of high-tem perature gauge theories. The list includes the infrared problem of the therm odynamics of Y ang {M ills elds and the problem of the EW phase transition. The method allows reliable computations of the properties of the high-tem perature equilibrium plasm a of elementary particles.

Of course, the m ethod has a number of limitations. It cannot be used in theories where coupling constants are large at the scale of the order of the tem perature. It does not work at tem peratures below the relevant m ass scales. It is not applicable to tim e-dependent phenom ena and cannot be used for com putation of transport coe cients such as viscosity, etc. How ever, it allow s a description of the ground state of the system at high tem peratures, therefore providing a starting point for the study of non-equilibrium phenom ena.
