Property of (600) and Chiral Sym metry

The iso-singlet scalar resonance (600), found in the recent phase shift analysis, is pointed out to have the properties of the meson in the model. The role of the interaction as a source of the \background phase", which was essential there, is also discussed.

The chiral symmetry and the notion of its dynamical breaking have been playing a central role in understanding the spectroscopy of hadrons with light-quarks. Presently the non-linear representation (Non-Linear Model(NL M)) of chiral SU $(2)_L$ SU $(2)_R$ group is widely accepted to be realized in nature on the basis of the success of low energy theorems concerning mesons as Nambu-Goldstone bosons.

In the sim plest linear representation 1) (Linear Model(L M)) of the chiral symmetry, an iso-singlet scalar particle, as a chiral partner of , the meson, is required to exist in the elective Lagrangian. Both L M and NL M satisfy the current algebra and PCAC, which lead to the same low-energy scattering amplitude A (s;t;u) in the O (p²) level of the former in the tree-approximation (of the latter).

The possible existence of a rather light — meson has been inferred from various points of view . $^{2)} \quad ^{11)} \text{ However, experimentally its existence has not been accepted so far, mainly due to the negative results of extensive analyses }$ $^{12)} \quad ^{13)} \quad \text{of the scattering phase shift. The reason against its existence is that the I = 0 S-wave phase shift }$ $^{0} \quad \text{reaches only 270 at m} \qquad 1200\text{M eV}, \text{ which was considered }$ $^{0} \quad \text{to be due mainly to the narrow }$ $^{0} \quad \text{(980)} \quad \text{and the broad }$ $^{0} \quad \text{(1370), (leaving no room for light particle)}. \text{ In contrast with this conventional interpretation, the existence of a resonance has been inferred in a recent reanalysis }$ $^{14} \quad \text{(referred to as I) of }$ $^{0} \quad \text{The obtained values}$

where g is de ned by L $_{int}$ = $\,$ g 2 . The most crucial point of obtaining this result is that there was an introduction of a negative background phase of the form $^{B\,G}$ = $p_1 r_c$ (p_1 being the CM $\,$ pion m om entum), analogous to the case of the nuclear force, which implies a repulsive \hard-core type" interaction between pions. The obtained value of r_c is

In this paper a comm ent is given on the above properties of (600) and of BG

in relation to the chiral sym m etry. The e ective Lagrangian of L M $^{1)}$ is given by

in terms of the physical 0 eld rede ned by $= f + ^0$, corresponding to the spontaneous breakdown of chiral symmetry. In this \linear form " of L M the coupling is of a non-derivative type, and the -scattering amplitude A (s;t;u) is given by A L M (s;t;u) = $(2g)^2 = (m^2 s)^2 = (m^2$

As was mentioned, the A L M (s;t;u) reduces, due to Eq.(3), to the amplitude of NL M, A NL M (s;t;u) = (s M D)=f 2 in the O (p 2) approximation. Here it is seen that, to O (p 0), the rst term of A L M (s;t;u), representing the strong attractive force proportional to M due to virtual production, exactly cancels the second term due to the repulsive A interaction. This result is obtained directly if we start from the \non-linear form " of L M, where the transform ed elds ~ and have an interaction of a pure derivative type.

In I, the S m atrix is represented directly through B reit-W igner resonance form ula for interacting with non-derivative type, 'and the amplitude ought to be compared with that in linear form of L M with non-derivative type interaction.

Substituting the value of m in Eq.(1) together with (m ; f) = (140; 93)M eV into Eq.(3), we obtain the theoretical values of g and as

of which the value g is very close to the experim ental value Eq.(1).

The 4 term in L $^{\rm L}$ mepresents a repulsive and contact short-range interaction between pions and seems to have a plausible property as an origin of $^{\rm B\,G}$ in the small $^{\rm P}$ s-region. The relevant I= 0 am plitude consisits of a direct one, A $^{\rm L}$ M (s;t;u), and of its crossing terms. The crossing terms have a weak s-dependence and almost vanish in the low energy region. Thus the rst (second) term in A $^{\rm L}$ M (s;t;u) itself may be directly compared to the phenomenological amplitude of virtual production (background) in I, respectively. The corresponding background amplitude due to the 4 interaction, unitarized following the K-matrix method, gives $^{\rm B\,G}_{\rm th}$ = arctan3 $_1$, which simulates well the behavior of the $^{\rm B\,G}_{\rm core}$ = $p_1 r_c$ in the small s-region. Then the value of r_c , Eq.(2), corresponds to the experimental value of ,

which is only in qualitative agreement with the theoretical value Eq.(4b).

From the above considerations it is concluded that the observed properties of (Eq.(1)) in I are consistent with those predicted in the tree-approximation of L M, although some discrepancy exists concerning the 4 term as a repulsive BG force.

⁾ In connection to this point, it m ay be notable that out of m any phenom enological analyses, the ones $^{12);13)}$ against the -existence seem to overlook the repulsive background, while the ones $^{9)}$ suggesting its existence take it into account explicitly or in plicitly, as in our case.

F inally som e remarks are added on the related works or problem s: The existence of meson as a chiral partner of meson has been strongly suggested for many years in various works based on the NJL model or its extended version $^{2)}$ $^{4)}$. It is notable that the experim ental value of m , Eq.(1), obtained in I is consistent with the predicted one, $m = 2m_{G}$, in the N JL m odel. In addition to this, the above result of this paper seems to suggest the validity of a linear representation of the model. Historically, however, the L M, as a low energy elective theory of hadrons, has been rejected mainly from the analyses on the scattering lengths of all relevant Iso-spin and orbital momentum channels and on the K 14 decay form factors. 16) Corresponding to this situation I have made 'reanalysis of the scattering lengths with tree approximation (or in large Nc limit) in L M, including both e ects of - and exchange, and found rather consistent results with experiments (except for a², being som ew hat larger than the experim ents). The relevant a_0^0 is predicted to be a_0^0 = 0:16 + 0:04, where the correction of higher than $0 (p^4)$ (the second term) makes the 0 (p^2) value (the rst term) closer to the experim ental value $a_0^0 = 0.26 \quad 0.05.15$) Needless to say, to be de nitive, a more extensive investigation is necessary.

to onventionally in NL M similar amount of O (p^4) correction is obtained which is argued to be mainly due to the meson exchange. Here it should be noted that this elect does not occur in the tree level, and does only due to the scale-dependence of the coel cients. However, such a large scale-dependence cannot be expected if the exists with fairly lower mass and larger width than .
