Leptoquark Pair Production at the Ferm ilab Tevatron: Signal and Backgrounds

A bstract

I. IN TRODUCTION

Sym m etry considerations such as fam ily replication, anom aly cancellation and sym m etry between generations are them ain m otivations behind the prediction of leptoquarks. They are color-triplet particles which possess baryon number (B) and lepton number (L). They arise in various extensions of the Standard M odel (SM): GUT's [1], Strongly Coupled Standard M odel [2], com posite m odels [3], superstring—inspired m odels [4], where they appear as scalar, vector or even ferm ionic particles.

Leptoquarks (LQs) could in principle be produced in e^+e^- [5], e^- [6], e^- [7] and hadron colliders [8,9,10,11]. But hadron colliders have two advantages: the production is almost insensitive to the Yukawa coupling and the available center-ofm assenergy $\frac{1}{2}$ S is much higher. We perform our calculations with the Tevatron in mind, taking $\frac{1}{2}$ S = 1.8 TeV and L = 100 pb $\frac{1}{2}$. The current limits imposed on rst generation LQ mass by the D0 collaboration are 133 GeV for BR (LQ! eq) = 1 and 120 GeV for BR (LQ! eq) = 0.5 and BR (LQ! q) = 0.5 [12]. The object of the present paper is to evaluate the importance of SM background (Z jj where the Z is virtual, ZZ, WZ and the events) when producing a pair of scalar leptoquarks in the context of an E₆ model. So far, these major sources of background have only been identified [10] but no quantitative analysis has been made. We implemented leptoquark data into the ISA JET event generator to achieve this goal.

In this paper, we look at the pair production of rst generation E $_6$ scalar leptoquarks with Q = 1=3 and evaluate the importance of the SM sources of background for this signal. In the next section, we rst describe the E $_6$ m odel. In Section 3, we give the details of our simulation for the detector and the calorim eter plus the kinematic cuts that are imposed. The LQ signal and the SM backgrounds (Z jj, ZZ, W Z and heavy quark pair production) are discussed in Section 4. We analyze the results in Section 5 and conclude in the following section.

II.FRAM EW ORK

Up to now, the SM provides a satisfactory description of phenom enology. However, many problems still remain. Among them, we not gauge hierarchical and netuning problems, no explanation for the existence and the number of fermion families and too many parameters to be extracted from experiment.

In the context of an E $_6$ m odel [13], the low-energy lim it of an E $_8$ E $_8^0$ heterotic string theory, the gauge hierarchical and ne tuning problem s no longer appear due to the supersym m etric nature of the theory. In E $_6$ superstring m odels, each m atter superm ultiplet lies in the fundam ental 27 representation which m ay explain the replication of ferm ion families. A nother attractive feature of the m odel lies in the predictions it m akes about low-energy physics. The 27 representation possess the following SO (10) and SU (5) contents:

The particles belonging to this representation can be arranged as:

where we have the usual quarks and leptons and their superpartners along with new particles such as two ve-plets (D; H) and (D; H) and an SU (5) super eld singlet N. In particular, the super elds D and D are two SU (3) triplets and SU (2) singlets with electrom agnetic charge 1=3 and 1=3 respectively. They possess 1=3 and 1=3 and 1=3 respectively. They possess 1=3 and 1=3 and 1=3 contrary to the usual notation, those particles are supersymmetric and we denote their non-supersymmetric partners as D and D . Thus, scalar leptoquarks come out naturally for an 1=30 m odel. Restricting our study to the rst generation of fermions, the Yukawa Lagrangian will take the form:

where $_{L}$ and $_{R}$ are chosen to be equal to the electrom agnetic charge otherwise there would be important e ects in the process $e^{+}e^{-}$! qq [14] arising from the LQ exchange.

III.EVENT SIMULATION

A . D etector and calorim eter

We use ISAJET, a Monte-Carlo event simulator, to model the experimental conditions at the Tevatron. We simulate a toy detector with the following characteristics for the calorimeter:

cell size: 4 = 0.1 = 0.0875,

pseudorapidity range: 4 < < 4,

hadronic energy resolution: 70% = E,

electrom agnetic energy resolution: 15% = $\frac{P}{E}$.

B.K inem atic cuts

In order to qualify as a jet, any hadronic shower must satisfy the following kinematic cuts:

lie within a cone of radius $R = \frac{q}{(4)^2 + (4)^2} = 0.7$,

have a transverse energy $E_T > 25 \text{ G eV}$,

have a pseudorapidity j_i j 3:

Sim ilarly, we must impose some cuts on the leptons. More specifically, electrons are considered isolated if they:

are separated from any jet by R 03,

have a transverse m om entum p > 25 GeV,

have a pseudorapidity j_1j 2:5:

Our calculations are performed using the PDFLIB distribution functions of M or n and Tung (M-TB2) with = 191 GeV [15].

IV.SIGNAL AND BACKGROUNDS

A. Leptoquark signal

We study the pair production of E $_6$ scalar leptoquarks with Q = 1=3 decaying into an up quark and an electron or into a down quark and a electron neutrino with branching ratios of B R (LQ ! eq) = B R (LQ ! q) = 0.5. For comparison, we also consider the case of a leptoquark decaying into an up quark and an electron with B R (LQ ! eq) = 1. In both cases, we assume a Yukawa coupling with k = 1 in $_{Y} = k_{em}$.

The leptoquark pair production can occur via two di erent channels, either via qq annihilation qq! D^*D^* or gluon fusion gg! D^*D^* . The corresponding Feynm an diagram s are shown in Fig. 1. For the details of the calculation of the cross section, we refer the reader to Ref. [11]. We expect the rst of these channels to dominate at the Tevatron.

In the case BR = 0.5, we obtain three di erent signals [10]:

- (a) 2 jets + e e ,
- (b) $2 \text{ jets} + 6p_T$,
- (c) $2 \text{ jets} + e + 6p_T$.

The most distinctive of these signals [10] should be (a) but apart from that, very little is known about the signal and backgrounds expected from the SM . The background for signal (b) and (c) should be more important due to the missing transverse momentum ($\{\!p_T\}$). For the purposes of this paper, we therefore restrict ourselves to 2 jets + e^+e . For simplicity, we impose the same E $_T$ cut values on the jets and the leptons: 25 GeV , 30 GeV , 35 GeV , 40 GeV .

B.SM Backgrounds

The most probable sources of background as identied by Refs. [10] are (1) Z jj, (2) Z Z, W Z and (3) ttproduction (in which the top is decaying into a W and a b quark). Backgrounds from bb and co are ignored. Previous estimates have shown them to be negligible [9]. The Feynman diagrams of the background processes are shown in Fig. 2.

1. Z jj background

The Z jj background proceed through a D rell-Y an virtual Z (producing a pair of leptons) along with two jets: pp! Z jj! e^+e jj where $j=q_jq_jg$. We consider this background for an invariant m ass of the lepton pair ranging from 100 GeV to 260 GeV.

2. Z Z and W Z background

O ther possible sources of background come from the production of a pair of Z bosons with one of the Z decaying into a lepton pair and the other one decaying into a pair of quarks and/or the production of a Z and a W with the Z decaying into a lepton pair and the W decaying into a pair of quarks. We calculated those backgrounds and found them negligible. The small magnitude of this background can be explained by the fact that Z Z and W Z productions are suppressed by $_{\rm W}^2$ where $_{\rm W}$ is the weak coupling with respect to the LQ process and the tt background which involve only strong interactions and a factor of $_{\rm S}^2$ with $_{\rm S}$ ' 0.1. Therefore, we will not consider those background processes any further. In any case, the study of the invariant mass of the pairs could single them out.

3. tt background

The nalbackground process we consider comes from the where the top is decaying into a bottom, an electron and a neutrino, $_{\rm e}$. The presence of neutrinos implies a $6p_{\rm T}$ and a less energetic electron. However, our analysis has shown that this process can provide some very energetic jets and thus be an important source of background. We consider M $_{\rm t}$ = 175 GeV.

V.D ISCOVERING LEPTOQUARKS AT THE TEVATRON

In Fig. 3, we rst show the results for the total cross section for the leptoquark signal (2 jets + e⁺ e) as a function of the leptoquark m ass, M $_{\rm LQ}$ (solid lines) . For comparison, we also show the tt background (dashed lines) evaluated at M $_{\rm t}$ = 175 G eV as well as the Z jj background (dot-dashed lines) integrated over an invariant m ass of the lepton pair ranging from 100 G eV to 260 G eV . The Z jj signal dom inates the background while the tt signal is relatively small. Requiring a statistical signicance 5 , where = N $_{\rm signal}$ = N $_{\rm bckg}$, we not that the leptoquark signal dom inates the background for leptoquark m asses up to 150 G eV (200 G eV) for B R = 0.5 (B R = 1). These ranges are found to be insensitive to the value of E $_{\rm T}$ as long as it remains in the region 25 G eV E $_{\rm T}$ 40 G eV .

The tt background is higher than the heavy quark background predicted by D 0 [9] coming from cand be due to the masses of the particles involved. The relevance of this background can be associated to the available transverse energy which is comparable to that in the leptoquark process analyzed in this work. The absence of missing $\{p_T$ is however characteristic in the LQ case. In fact, such a cut increases the signal-to-background ratio even more but reduces the signal by about 10%. However, since the tt background is not signicant here, we chose not to include this cut in the rest of the analysis.

In general, one expects that in leptoquark production there will be a strong lepton-jet correlation due to the leptoquark decay while such correlation should be absent in thand Z jj backgrounds. Indeed, even if the signal and background total cross-section were comparable in magnitude, there can still be a detectable signal in the form of a peak in the invariant mass distribution of the lepton-jet pairs. The distribution in the invariant mass of the lepton-jet pairs are presented in Figs. 4-5 for the various processes for $E_T=25~{\rm GeV}$ and 35 GeV respectively. The invariant mass M $_{\rm ej}$ was calculated by pairing the most energetic electron

with the least energetic jet. This particular choice is based on the reasonable assumption that the two leptoquarks will emerge with approximately the same energy and that this lepton-jet pair will correspond to the decay products of the same leptoquark. Each gure displays the leptoquark signal for leptoquark mass inputs of M $_{\rm LQ}=130~{\rm G\,eV}$ (solid lines), M $_{\rm LQ}=150~{\rm G\,eV}$ (dashed lines) and M $_{\rm LQ}=170~{\rm G\,eV}$ (dash-dotted lines) as well as the background due to the Z jj (dash-dot-dot-dotted lines) and the tt (dotted lines) processes. Here, we have applied an invariant mass cut on the lepton pairs with 81 G eV M $_{\rm e^+\,e^-}=101~{\rm G\,eV}$ in order to eliminate the events near the Z 0 peak and minimize the Z jj background. We see from Figs. 4-5 that the optimal E $_{\rm T}$ cut is 25 G eV . An E $_{\rm T}$ cut of 35 G eV reduces the background signicantly. Our results show the expected strong lepton-jet correlation in the leptoquark signal. The Z jj background is mostly concentrated between 50 M $_{\rm ej}=100~{\rm G\,eV}$ but remains the dominant background for all values of the invariant mass. The 5 statistical signicance is satis ed for M $_{\rm LQ}=130~{\rm and}~150~{\rm G\,eV}$ with an E $_{\rm T}$ cut of 25 G eV .

In order to estimate the relative importance of the signal to the background near the peak in the M $_{\rm ej}$ distribution, we calculate the partial cross section $\,$ within a bin of width M $_{\rm ej}$ = 60 GeV around M $_{\rm ej}$ = M $_{\rm LQ}$ as a function of the invariant mass of the electron-jet pair for E $_{\rm T}$ = 25 GeV . The calculations repeated for several intermediate values of M $_{\rm LQ}$ and are shown in Fig. 6. We can then see more clearly how that the signal-to-background ratio is a ected by the leptoquark mass. A lso, we not that the 5 statistical signicance condition is satisfied for M $_{\rm LO}$ $\,$ 150 GeV .

Coming back to gure 3, we can estimate the discovery reach of scalar leptoquarks at the Tevatron. To that e ect, we require a minimum of 10 events in addition to the 5 statistical signicance condition imposed on the background. The integrated luminosity for the Tevatron current run is 100 pb 1 which leads to a discovery mass limit of 130 GeV for $E_T = 25$ GeV (Fig. 3). A similar estimate can be easily carried for leptoquarks that decay with BR (LQ ! eq) = 1 by arguing that the cross section for the production of 2 jets + e $^+$ e is four times larger in this case. A coordingly, the discovery reach is increased up to 170 GeV. On the other hand, the proposed luminosity upgrades of the Tevatron should enhance signicantly the signal and increase the discovery reach to approximately 200 GeV for BR = 0.5 (with a luminosity 2 fb 1).

Sum m arizing, we carried out a simulation for rst-generation scalar leptoquark pair production within the context of an E $_6$ m odel taking into account the SM backgrounds for the most promising signal, i.e. 2 jets + e⁺ e . The results are found to be sensitive on the choice of E $_{\rm T}$ cut for the jets and while background is dominated by the Z jj process, it does not overwhelm the signal for leptoquarks at the Tevatron. We note a discovery mass limit of 130 GeV (BR = 0.5) and 170 GeV (BR = 1) for an optimum E $_{\rm T}$ cut of 25 GeV.












