ABSTRACT:We calculate the baryon asymmetry created by the decay of a pseudo N am bu-G oldstone boson whose interactions violate baryon num ber conservation. O ur results are in disagreem ent w th previous results in the original spontaneous baryogenesis $m$ odels for the asym $m$ etry produced by the decay of an oscillating scalar eld w ith B num ber violating derivative couplings; we nd that the net baryon number density is proportional to ${ }_{i}^{3}$, where $i$ is the amplitude of the PNGB - eld in natural in ation at the onset of reheating. W e also discuss our disagreem ent with the intenpretation of - as an e ective chem ical potential for baryon num ber in spontaneous baryogenesis $m$ odels. W hile our calculation of the asym $m$ etry is carried out in the context of natural in ation our approach is generally valid for baryogenesis $m$ odels using decaying classical elds. In the A ppendices, we include a com plete derivation of the num ber density of particles produced by the decay of classicalscalar eld; this num ber density is proportional to the integral over $m$ om enta of the one pair production am plitude.

## Section 1: Introduction

In this paper, 1) we calculate the baryon asym m etry obtained during reheating follow ing naturalin ation using an approach that is generally valid forbaryogenesism odels using decaying classical elds. O ur results are in disagreem ent w ith the the results presented in the original spontaneous baryogenesis papers. 2) W e discuss an ob jection to the e ective chem ical potential interpretation used in m odels of spontaneous baryogenesis.

In natural in ation the role of the in aton is played by a pseudo N am bu-G oldstone boson, hereafter referred to as , w ith a potential of the form [1]

This m odel was proposed to \naturally" provide the at potential required for in ation to work [2], [3]. Here $=\quad=f$, where is a complex scalar eld and $f$ is the scale at which a global sym $m$ etry is spontaneously broken; soft explicit sym m etry breaking takes place at a low er scale. From eq. (1.1) one can see that the height of the potential is 24 while the $w$ idth is $f$. Since the scales of spontaneous and explicit sym metry breaking can \naturally" be separated by several orders of $m$ agnitude, one can obtain $10{ }^{3}$ f as required for successful in ation [4].

In ref. [14] an extensive study of the conditions under which the eld can drive in ation has been obtained. A fter the period of in ation, the energy density of the eld is converted to radiation during reheating through its decay to other form $s$ of $m$ atter as it oscillates in its potential. Below we shall assum e that is coupled only to ferm ions. W e treat as a classical scalar eld coupled to quantized ferm ion elds Q and L via an interaction term of the form $Q L e^{i}+L Q e^{i}$, where $Q$ carries baryon number but $L$ does not. W e show that the decay of gives rise to a net baryon number density ( $n_{0} \quad n_{0}$ ) proportional to ${ }_{i}^{3}$, where $i$ is the value of the eld at the onset of reheating.

O ur result disagrees w ith the calculation in the original spontaneous baryogenesis papers [15] where it was argued that the asym $m$ etry is proportional to $i$ to the rst power, independent of the details of the baryon num ber violating couplings of the eld. Specifically, in previous work, C ohen and K aplan [15] considered any theory in which a scalar eld is derivatively coupled to the baryon current $J \quad w$ ith a term in the interaction Lagrangian of the form $L_{\text {int }} / @ J$, and derived an expression for the baryon asym $m$ etry produced by the decay of the scalar eld as it oscillates about its $m$ in im um. The pseudo $N$ am bu-G oldstone boson in natural in ation can serve as an exam ple of such a scalar eld. $C$ ohen and $K$ aplan obtained $\eta_{B} j=f^{2} j-j$ where is the decay rate of the eld and $n_{B}$ is the net baryon num ber density. This gives

Below we discuss our concems w th this conclusion and present calculations for the speci c case of eq. (1.1); our results disagree with eq. (12). W e also com ment on our ob jections to interpreting - as a chem ical potential when is small, as was done in ref. [15]; we argue that a Lagrangian term $-J^{0}$ does not appear in the $H$ am iltonian, and therefore it is incorrect to identify $-w$ ith an e ective chem ical potential for baryon num ber.

The fram ew ork of this paper is as follow s. In Section 2, we w rite dow $n$ the Lagrangian density for the in aton eld and present the equation ofm otion for as it oscillates during the reheating phase, as derived in ref. [16]. In Section 3 we discuss our concems w ith eq. (12) as obtained in ref. [15] (these concems were raised in an earlier paper [16] by tw o of the authors $\mathbb{D}$ olgov and Freese]). W e then proceed to calculate the total baryon number and antibaryon number produced during the decay of the eld, and nd a
 density of the produced particles is equal to the initial energy density of the eld as a a check on our calculation. In Section 4, we discuss how constraints on param eters in natural in ation obtained in ref. [14] a ect the quantitative results for baryogenesis. W e also discuss our ob jections to the therm odynam ic generation of the baryon asym $m$ etry via an e ective chem ical potential interpretation in models of spontaneous baryogenesis. $F$ inally we sum $m$ arize our results. In the A ppendices we provide details of the calculations outlined in the $m$ ain body of the paper. In particular, in A ppendices A and B, we include derivations of the num ber density of particles produced by the decay of a classical scalar eld; the num ber density of particles produced is proportionalto the integraloverm om enta of the one pair production am plitude.

Section 2: The M odel
A s in ref. [16] we consider a sim ple model involving a com plex scalar eld and ferm ion elds $Q$ and $L$ w ith the Lagrangian density ${ }^{1}$

$N$ ote that, despite their nam es, $Q$ and $L$ cannot be actual quarks and leptons, since the interaction term does not conserve color. T hey could, how ever, represent heavy ferm ions w th other interactions w th the elds of the Standard M odelwhich $x$ the assignm ents of globalcharges. In particular, we shall assum e that the eld $Q$ carries baryon num ber while the eld $L$ does not. The $U$ (1) sym $m$ etry that corresponds to baryon num ber is therefore identi ed as

[^0]W e assum e that this global sym $m$ etry is spontaneously broken at an energy scale $f$ via a potential of the form

Below the scale $f$, we can neglect the radialm ode of since it is som assive that it is frozen out; $m_{\text {radial }}={ }^{1=2} \mathrm{f}$. The rem aining light degree of freedom is , the Goldstone boson of the spontaneously broken $U$ (1). For sim plicity of notation we introduce the dim ensionless angular eld $\quad=f . W$ e then obtain an e ective Lagrangian density for ,$Q$, and $L$ of the form

W th a rotation of the form in eq. (2.5) w ith $=$, the Lagrangian can altematively be w ritten

$w$ here the ferm ion current derives from the $U$ (1) sym $m$ etry; here, $J=Q \quad Q$.
W e now assum e that the sym metry (2.2) is also sub ject to a sm all explicit breaking which gives rise to a potentialas in eq. (1.1) and which provides a nonzero $m$ ass for the eld
. This explicit sym m etry breaking could com e from P lanck scale physics. A ltematively, one can im agine a scenario sim ilar to that involving the Q CD axion where, at energy scales of the order of QCD, instanton e ects create the ferm ion condensateh i ${ }_{Q C D}^{3}$, giving rise to a $m$ ass term for the axion. $N$ ote that for the natural in ation $m$ odel, the required $m$ ass scales are $m u c h$ higher than for the QCD axion. Thew idth of the potentialm ust be roughly the $P$ lanck $m$ ass in order to achieve enough e-foldings of in ation, and the height of the potential must be roughly $\quad 4 \quad\left[10^{16} \mathrm{GeV}\right]^{4}$ in order for density perturbations appropriate for structure form ation to be produced (see the D iscussion section at the end of the paper for $m$ ore detail). C onsequently the scale at which the relevant gauge group (not QCD) m ust becom e strong is roughly the GUT scale. These and other mechanism s such as those found in technicolor and schizon $m$ odels for generating a potential for pseudo N am bu-G oldstone bosons are discussed in ref. $[4,14]$.

Initially, as the eld rolls dow $n$ tow ards the $m$ in $m$ um of its potential, its potential energy drives in ation. Let $i$ be the value of the eld at the beginning of the reheating epoch, after in ationary expansion has ended. (W e shall ignore spatial variations in the eld.) D uring the reheating epoch the eld oscillates about them inim um of its potential. W hile oscillates it decays to the elds $Q$ and $L$. The interactions of the ferm ionic elds create a them albath thereby reheating the universe. N ote that we must take $g 1$ so that ferm ion $m$ asses generated for the ferm ions from the Yukaw a coupling, $m \quad g f$, are sm all enough that the ferm ions can in fact be produced by decays of the pseudo N am buG oldstone bosons. See ref. [10] in D olgov and Freese [16] for further discussion of this point.

The equation ofm otion for the eld w ith the back reaction of the produced ferm ions was rigorously derived in the one loop approxim ation in ref. [16]. For sm all deviations of from the equilibrium the potential can be approxim ated as $V()=\frac{1}{2} m_{R}^{2} f^{2} 2$ and the equation of $m$ otion during the oscillating phase can be e ectively w ritten in the well known form

where $m_{R}$ is the renorm alised $m$ ass de ned as $\lim _{w}!1 m_{R}^{2} 1+\frac{g^{2}}{4^{2}} \log \left(2 w=m_{R}\right)=m{ }^{2}$, where $m$ is the bare $m$ ass of the eld, and $\quad g^{2} m_{R}=8 \quad$ (O ur expressions above di er by a factor of 2 from those in ref. [16] because a factor of $1={ }^{p} \overline{2}$ was dropped from eq. (2.5) in ref. [16].) The solution to this equation is

where we have assum ed that the initialvelocity of the eld is negligible and have therefore set an arbitrary phase in the cosine to zero. The results obtained below can be easily generalized for arbitrary initialconditions. The above solution $w$ as derived assum ing $m_{Q}=$ $m_{L}=0$. H ow ever, it can be shown that non-zero values of $m_{Q}$ and $m_{L} w$ ill not change the solution for signi cantly as long as $m_{Q} ; m_{L} \quad m_{R}$, which we shall assum e below.

## Section 3: B aryogenesis

Previous C alculations and C oncems: In previous w ork, C ohen and K aplan [15] considered any theory in which a scalar eld is derivatively coupled to the baryon current with a term in the interaction Lagrangian of the form $L_{\text {int }} /$ @ $J$, and derived an expression for the baryon asym $m$ etry produced by the decay of the scalar eld as it oscillates about its $m$ in im um. From eq. (2.6) one can see that our pseudo $N$ am bu-G oldstone boson is an exam ple of such a scalar eld as it has the appropriate coupling. C ohen and K aplan obtained $\dot{n}_{B} j=f^{2} j-j$ where $n_{B}$ is the net baryon num ber density. This gives

In a previous paper [16] by two of the authors $\mathbb{D}$ olgov and Freese], several concems w ith this interpretation were raised. W e will outline tw o of these concems again here, and then proceed w ith a direct calculation of the baryon asym metry. O ur results will disagree w ith eq. (3.1).

O ne conœem is as follow $s$ : in $m$ aking the identi cation $\dot{n}_{B} j=f^{2} j-j$ one is com paring an operator equation, nam ely, the Euler-Lagrange equation $+m^{2}=n_{B}=f^{2}$, with an equation of the form ofeq. (2.7) which is obtained after vacuum averaging. In ref. [16] the average value $\mathrm{h}_{\mathrm{n}}$ i was found to be not just $\mathrm{f}^{2}$ - but a $m$ ore com plicated expression (eq. (3.3) in ref. [16]).

A second concem is with regard to energy conservation. The initial energy density of the eld which creates the baryons and antibaryons is $\left(t_{i}\right) \quad f^{2} m^{2}{ }_{i}^{2}$. At the end some of this energy density has been converted to baryons and antibaryons, w ith energy density $\left(t_{f}\right)>n_{B} E_{B}$ where $E_{B} \quad m$ is the characteristic energy of the produced ferm ions (note that $n_{B}$ refers to the di erence between baryon and antibaryon num ber densities and not to the total num ber density of produced particles). C learly it $m$ ust be true that
$\left(t_{f}\right)<\quad\left(t_{i}\right)$. If we were to use eq. (3.1) we would see that this requires $<m$. From the de nition of we see that this is satis ed for sm all values of coupling constant $g$ as long as is not too sm all; for sm all values of $\quad$, this relationship can never be satis ed.

New Calculations and Results: W e now proceed to calculate the net baryon num ber density of the particles produced during reheating. W e perform an explicit calculation and nd a di erent result from eq. (3.1). The eld decays to either Q L pairs or $Q L$ pairs. ( $T$ he $Q$ and $L$ elds are not the $m$ ass eigenstates. Later in this section we consider e ects of oscillations betw een $Q$ and $L$ elds.) A smentioned earlier, we treat the eld classically, $Q$ and $L$ are quantum elds and $Q$ carries baryon number. For now we ignore any dilution of the baryon num ber density due to the expansion of the universe.

A s show $n$ in A ppendix A w th the B ogolyubov transform ation $m$ ethod [17], the average num ber density $n$ of particle antiparticle pairs produced by decay of a hom ogeneous classical scalar eld, to low est order in pertunbation theory, is given by
$w$ here A is the one pair production am plitude, subscripts 1 and 2 refer to the nalparticles produced and $\overline{\text { En }}=d^{3} p=\left[(2)^{3} 2 p^{0}\right]$. Eq. (3.2) can also be obtained using the $m$ ethod presented in Sec. 4-1-1 of ref. [18], as discussed in A ppendix B .

Thus, to low est order in perturbation theory, the average num ber density of $Q L$ pairs
produced during reheating in our $m$ odel is given by ${ }^{2}$

W e also use a convergence factor at early tim es to regularize the integral. W e w illexam ine a series of possible term $s$ to nd the rst nonzero contribution in perturbation theory. ${ }_{\mathrm{R}}^{\mathrm{T}}$ he lowest order term com es from using $\mathrm{e}^{i}=1$ from eq. (3.7) in eq. (3.6) and gìves $d^{2 i!}{ }^{2 i!} /(2!)=0$ since we can not have $!=0$ for particle production. $T$ he next term in the expansion, the term in (3.7), when squared gives the sam e contribution to $n_{b}$ and

$T$ he factor of 2 in eq. (3.9) arises from the fact that the cross term $s$ in $n_{b}$ and $n_{b}$ term $s$ are the same up to a minus sign. O ne can see from the form of eq. (3.9) that we expect the asym $m$ etry to be proportional to ${ }^{3}$. The details of this calculation are outlined in A ppendix C, and the results are presented here.

 $w$ ith the calculation in ref. [15] which gives an asym $m$ etry proportional to $i$. W e also note that the num ber density of pairs of particles $n_{b}+n_{b}$ is equal to $\frac{1}{2} m_{R} f^{2}{ }_{i}^{2}$. Since the energy per pair of particles is $m_{R}$, the energy density in the produced particles is $\frac{1}{2} m_{R}^{2} f^{2}{ }_{i}^{2}$, which agrees w the initial energy density of the eld. W e have also done the calculation of
and have veri ed that we obtain $\frac{1}{2} \mathrm{~m}_{\mathrm{R}}^{2} \mathrm{f}^{2}{ }_{\mathrm{i}}^{2}$.
$M$ ass $M$ ixing: In $m$ any cases eq. (3.13) is not yet the com plete story because of $m$ ass $m$ ixing. A s we m entioned earlier the $Q$ and $L$ elds are not $m$ ass eigenstates. Therefore a
particle which is produced as a $Q$ m ay later rotate into an $L$. This e ect $m$ ust be taken into account. Eq. (3.13) is com pletely correct for the case where the ferm ions $Q$ and $L$ are converted im m ediately to regular quarks $q$ and leptons $l$ as soon as they are produced (assum ing that the tem perature is low enough that the $q$ and $l$ cannot convert back into $Q$ and $L)$. In that case, there is no opportunity for $m$ ixing to take place, e.g., there is no opportunity for $Q$ to convert to an $L$. On the other hand, if $Q$ and $L$ do not decay im $m$ ediately into stable lighter $m$ ass particles $w$ ith appropriate quark quantum num bers, they $m$ ay have the chance to $m$ ix into one another. O ne can calculate the e ects ofm ixing in either the $Q$; L basis or in the basis ofm ass eigenstates; below we will do both.

In the 1; 2 basis, one can now calculate the baryon asym m etry as a sum of term s , each of which is a product of a number density of produced particle/antiparticle pairs tim es the (tim e averaged) quark content of the pair,


Here $n(1 ; 2)$ and $n(2 ; 1)$ are the num ber densities of 1 and 2 pairs and 2 and 1 pairs respectively; and the $j i^{i}{ }^{?}$ is the probability that a particle which is produced as a
$i$ (where $i=1 ; 2$ ) is m easured as a $Q$. Hence, for exam ple, the rst term is the product of the num ber density of $1 \quad 2$ pairs produced tim es the quark content of 1 .
$N$ ote that we are here com puting a tim e averaged baryon asym $m$ etry; actually the value of the baryon asym $m$ etry oscillates in tim $e$, as discussed in A ppendix D. From eq. (3.16) we see that the probability that $1 ; 2$ is $m$ easured as a $Q$ is

In A ppendix D we work in the $Q$; L basis. We nd the oscillations of the baryon asym $m$ etry $w$ ith tim e, and obtain the sam e expression as in eq. (3.28) for the tim e averaged baryon asym $m$ etry.

Therm alization: A fter the eld has decayed into 1 and 2 particles, them al equilibrium can be established if these particles have other interactions with each other and with other particles. A s long as one introduces interactions such as 11 and 22 as a part of a realistic $m$ odel, the num ber of $1 \quad 1$ particles and of $2 \quad 2$ particles does not change, thereby preserving the baryon asymmetry. (Interactions such as $12+\mathrm{hic}$ : would, how ever, destroy the baryon asymmetry.) The elds 1 and 2 w ill annihilate or decay to lighter particles which will them alize. If these interactions preserve the net baryon num ber, then the asym $m$ etry will survive.

Q uantitative Results: So far we have not inchuded the e ects of the expansion of the universe. For baryon number created when $H \quad$, we may neglect the expansion and directly use the results obtained above in eq. (3.28) with ireplaced with the value of at $\mathrm{H}=$. Since the eld dom inates the cosm ic energy density, the condition $\mathrm{H}=$ xes the am plitude of at that $m$ om ent to be

In the early stages of reheating $w$ ith $>1$, expansion of the univense $m$ ust be taken into account.

The decay of the - eld produces relativistic $1 ; 2$ and $1 ; 2 \mathrm{w}$ ith energies ! $m_{R}=2$. $T$ his state is far from them al equilibrium (the tem perature of the them alized plasm a in eq. (3.30) below $m$ ay be $s m$ aller than the $m$ asses). The rate of them alization depends upon the interaction strength of the ferm ions created in the decay. It is typically higher than the decay rate because $g \quad 1$ to ensure reasonable ferm ion $m$ asses. Ther$m$ alization could occur either through annihilation of 1 and 1 or 2 and 2 into light particles or through their decays and subsequent elastic scattering. A ssum ing that these processes are fast we can roughly estim ate the reheat tem perature in the instantaneous
decay approxim ation, $\operatorname{rad}=\left(t={ }^{1}\right)$, as

It is conserved in the com oving volum e if the expansion of the universe is adiabatic, in particular in the absence of rst order phase transitions as the universe cools. B aryonic charge density is also assum ed to be conserved inside a com oving volum e during and after therm alization and so the baryon-to-entropy ratio $n_{B}=s$ rem ains constant in the course of expansion.

In fact the asym $m$ etry should be noticeably larger than that given by eq. (3.31). The result that we got above refers to the case when $H \quad<\quad$ but the process of particle production starts much earlier when $H \quad m_{R}$ and the in aton eld begins to oscillate around the bottom of the potential. The net baryon num ber density produced while $H \quad>\quad$ is again proportional to ${ }^{3}$, as it is associated w ith the interference between the and the 2 term $s$ in $j^{R} d t e^{2 i!t}\left(1+i \quad{ }^{2}=2\right) \jmath^{\text {f }}$ in eq. (3.6). The generation of the asym $m$ etry is $m$ ore e cient at early tim es ( $\mathrm{H}>$ ) since the amplitude of the - eld, which goes down w th the scale factor as R ${ }^{3=2}$, is larger. H ow ever when $H>$ one must include the e ects of the expansion of the universe on the production of the baryon asym $m$ etry. $T$ his $m$ akes the exact calculations considerably m ore com plicated. Still we can roughly estim ate the asym $m$ etry in the follow ing way. The di erence between the production of particles and antiparticles is $m$ ost profound at early tim es, $t a \quad 1=m_{R}$, when is large. $T$ he total num ber of particles produced in tim e $t_{a}$ is proportional to $t_{a} n$ and, as we mention above, the baryon num ber asym $m$ etry m ust vary as ${ }^{3}$. Therefore, a reasonable estim ate of the net baryon number density created while $H>$ is $n_{B} \quad f^{2}{ }_{i}^{3}$. Between the tim e of peak production of baryon asymmetry at $t_{a} \quad 1=m_{R}$ and the peak entropy production at $t_{0} \quad 1=$ we $w$ ill take the baryon asym $m$ etry to be diluted by a factor of $\left(R_{a}=R_{b}\right)^{3} \quad\left(t_{a}=t_{b}\right)^{2} \quad\left(=m_{R}\right)^{2}$ due to the expansion of the universe, where we have taken the universe to behave as $m$ atter dom inated with $R / t^{2=3}$ in the usual
fashion during reheating. Thus the baryon-to-entropy ratio at time to and afterw ards is $\frac{n_{B}}{s} 2 \quad f^{2}{ }_{i}^{3}\left(=m_{R}\right)^{2}=s$. The calculation of the entropy density is exactly the same as described above eq. Section 4: D iscussion
In ref. [14], the authors obtain constraints on the param eters and $f$. The stipulation that a large fraction of the universe after in ation have in ated by at least 60 e-foldings gives $\mathrm{f} \quad 0: 06 \mathrm{M}_{\mathrm{P}}$. A stronger constraint can be obtained by requiring the form ation of galaxies to take place early enough in the history of the universe; in this way one obtains f $0: 3 \mathrm{M}_{\mathrm{Pl}}$. A constraint on is derived by using COBE data on the density uctuation am plitude and is plotted in 9.1 of ref. [14]; the upper bound on thus obtained ranges from $10^{13} \mathrm{GeV}$ to $10^{16} \mathrm{G}$ eV for f betw een $0: 3 \mathrm{M} \mathrm{Pl}$ and $1: 2 \mathrm{M} \mathrm{Pl}$. If one desires the density uctuations from in ation to be responsible for the large scale structure of our universe and hence for the COBE anisotropy, then $m$ ust be equal to the above values rather than sim ply being bounded by these num bers.

If the baryon asym $m$ etry produced above is accom panied by an equal lepton asym $m$ etry, so that B $L=0$, it w illlbe w ìed out by baryon num ber violating sphaleron processes unless the reheat tem perature is below 100 GeV . The low reheat tem perature condition $m$ ay be a desirable feature of our $m$ odel as $m$ any in ation $m$ odels have di culy creating a high reheat tem perature. Furthem ore, we shall require that $T_{\text {reh }}>10 \mathrm{M}$ eV so that we reproduce standard nucleosynthesis. If, in addition, one requires the density uctuations from in ation to serve as the explanation for the COBE data rather than m erely being bounded by it, then is determ ined as a fiunction of $f$ as described in the previous paragraph; then the combination of these constraints im plies that $10^{14}<\mathrm{g}<10^{10}$ for and $f$ equal to $10^{13} \mathrm{GeV}$ and $0: 3 \mathrm{M}_{\mathrm{P}}$ r respectively, and the asym $m$ etry generated by the $m$ echanism considered above is by far below the necessary observed value. H ow ever if is $m$ erely bounded by COBE m easurem ents (density uctuations $m$ ust then be generated som e other way than by the in ation), then $g$ can be $m$ uch larger as can the baryon asym $m$ etry. A ltematively if a nonzero ( $B \quad L$ ) is generated, for exam $p l e$, if the $L$ elds carry no lepton num ber, then it is not destroyed by the electrow eak processes and the coupling constant g need not be so sm all.

In our perturbative calculations of the num ber of pairs of particles produced we have assum ed that the $m$ asses of the ferm ions are sm aller than the $m$ ass $m_{R}$ of the theta- eld and that $\mathrm{gf}<\mathrm{m}_{\mathrm{Q} ; \mathrm{L}}$; otherw ise the perturbative approach is not applicable. This im plies that $\mathrm{gf}<\mathrm{m}_{\mathrm{R}}={ }^{2}=\mathrm{f}$ or $\mathrm{g}<(=\mathrm{f})^{2}$. In this case, the baryon asym m etry is rather sm all as $\frac{\mathrm{n}_{\mathrm{B}}}{\mathrm{s}}{ }_{2}<10^{3}(=\mathrm{f})^{5}\left(\mathrm{~m}_{\mathrm{P}}=\mathrm{f}\right)^{1: 5}<10^{18}$ (in obtaining this lim it we have inchuded the sim ultaneous constraint on and $f$ from density uctuation constraints in ref. [14]). If, how ever, is not the in aton eld, as in the originalversion of the spontaneousbaryogenesis soenario [15], then the param eters and $f$ do not necessarily satisfy the above bounds and the asym $m$ etry $m$ ay be quite large, especially if $f \quad m_{P 1}$. In such a case, one would have to redo the calculation of the entropy if does not dom inate the energy density of the universe when it decays. A period of in ation prior to the decay of the PNGB would also be required so that and, consequently, the baryon asymm etry have the sam e sign w thin present-day dom ains of sizes 10 M pc or greater. (Existing data do not rule out a $m$ atter sym $m$ etric universe $w$ ith dom ains ofm atter and antim atter on scales of 10 M pc or m ore [19].)

A $n$ interesting possibility is that the $m$ ass of ferm ions is not below $m_{R}$ and the perturbative approach is not applicable. T he non-perturbative calculations in this case are $m$ ore com plicated and willbe presented elsew here.

W ewould also like to point out an ob jection to the $m$ echanism of creating the baryon asym $m$ etry therm odynam ically, via an e ective chem ical potential interpretation, as rst proposed in ref. [15] and later applied to spontaneous baryogenesis models at the electrow eak phase transition [20]. The approach in ref. [15] is to identify - in the term © $J=-J^{0}=-n_{B}$ in eq. (2.6) w ith an e ective chem ical potential that biases the $B$ violating interactions in the universe to create $m$ ore baryons than antibaryons. If this is the case then, as is argued in ref. [15], the net baryon num ber density in the them albath is given by the expression: $n_{B} \quad-T^{2}$. H ow ever this can not be true because it contradicts the equation ofm otion of the Goldstone eld: $@^{2}=@ J_{B}=f^{2}$. A ssum ing spatial hom ogeneity, this equation gives $n_{B} \quad-f^{2}$. (A sim ilar contradiction is obtained using the equation of m otion for a PNGB - eld in an expanding universe.) This contradiction is resolved because - does not shift energies of baryons and antibaryons and cannot be identi ed with a chem icalpotential. W hile the term @ J exists in the Lagrangian density in eq. (2.6), it does not in the H am iltonian density

where i represents all the elds in the Lagrangian density [21]. $T$ his is sim ilar to the interaction of a charged particle w th a magnetic eld, where the energy of the particle is
not changed due to the action of the eld as the force is proportional to the velocity and orthogonal to it. Thus the term $\quad-n_{B}$ does not appear in the $H$ am iltonian density and can not be interpreted as an e ective chem ical potential.

A smentioned above, the approach of ref. [15] has been applied to create the baryon asym $m$ etry in spontaneous baryogenesis $m$ odels at the electrow eak phase transition [20]. The role of the eld is associated w ith the H iggs eld in electrow eak baryogenesis. Since we feel that the identi cation of - as an e ective chem ical potential is incorrect, these $m$ odels too are sub ject to the sam e criticism .

In conclusion, we have calculated the baryon asym $m$ etry created by a pseudo $N$ am buG oldstone boson w ith baryon num ber violating couplings in the context ofnaturalin ation. W e have obtained a general result for the baryon asym $m$ etry created by the decay of an oscillating scalar eld w th baryon num ber violating couplings and dem onstrated explicitly that the asymmetry is not proportional to $i$ to the rst power as claim ed in earlier work. W e have also discussed our ob jection to the them odynam ical generation of the baryon asym $m$ etry using an e ective chem icalpotentialapproach in $m$ odels ofspontaneous baryogenesis.

Eq. (3 2) can also be obtained using the method presented in Sec. 4-1-1 of ref. [18]. (W e have ignored the higher order vacuum graphs that give the exponential factor $\exp (\mathrm{n})$ in eq. (4-23) of ref. [18].) W e have veri ed that we obtain the Poisson distribution for the number of $(Q ; L)$ pairs and $(Q ; L)$ pairs as in ref. [18]. Indeed the derivation of the

Poisson distribution can be done exactly along the same lines as in ref. [18]. The only di erence is that in the exam ple considered in this book the $m$ atrix elem ent describes the production of a single photon by an extemal current while in our case it gives the am plitude for production of a pair of particles. For the $m$ ultiparticle production am plitude this gives rise to a di erent nom alization, nam ely, in the case of the production of $n$ photons the am plitude contains the factor $1=\frac{p}{n}$ ! connected $w$ ith identical photons while for the case of production of $n$ pairs of $Q L$ (or charge conjugate) the am plitude contains $1=n$ !. In the case of photons the $m$ ultiparticle am plitude squared contains the follow ing $n-$ dependent factors: $3 A_{n}{ }^{2} \quad j(n!)(1=n!)\left(1=\frac{p}{=} \bar{n}\right) \jmath^{2} \quad 1=n!$. T he factor of $1=\mathrm{n}$ ! com es from the expansion of the action $\mathrm{S}=$ $\exp \left(i^{R} d^{4} x A \quad J\right.$ ), and the factor of $1={ }^{p} \bar{n}$ ! com es from the norm alization of the $n-p h o t o n$ state. So the net result is proportional to $1=n!$, which is exactly what is needed to get the Poisson distribution $p_{n}=\exp (n) n^{n}=n!$. In the case of the production ofn-pairs, we have the sam e $1=n$ ! from the expansion of the action, but now we get $1=n$ ! com ing from the norm alization and not $1=\frac{p}{n}$ ! as before. H ow ever, the action of the product of the creation operators ofe and $L$, which can be sym bolically written as $\left(a_{Q}^{+} b_{L}^{+}\right)^{n}$, gives now an overall factor of $n$ ! from the action of, say, $\left(a_{Q}^{+}\right)^{n}$, as above, and also the sum of $n$ ! equal but not interfering term $s$, each of them being proportional to a di erent delta-function of the $m$ om enta, $\left(\mathbb{Q}_{j}+p_{L_{k}}\right)$. Thus in the $m$ atrix elem ent squared we $w$ ill get the sam e overall factor $1=n$ ! which is necessary for the P oisson distribution.

In a class of $Z_{2}$ sym $m$ etric $m$ odels the com bination ofterm $s$ like $m_{1}$ and $m_{0}\left(e^{i}+h: c:\right)$ can give rise to a potential as in eq. (1.1) for $w$ th $2 \quad \mathrm{~m}_{0} \mathrm{~m}_{1}$. These \schizon" m odels are further described in ref. $[5,6,7]$. In superstring $m$ odels, non-pertunbative e ects in the hidden sector can give rise to ferm ion condensates and, consequently, a potential for the $m$ odel independent axion (the im aginary part of the dilaton eld). In refs. $[8,9]$, the hidden $\mathrm{E}_{8}^{0}$ sector in $\mathrm{E}_{8} \quad \mathrm{E}_{8}^{0}$ heterotic string theory becom es strongly interacting, generating gaugino condensates that lead to SU SY breaking and a potential for the m odelindependent axion. P roblem $\mathrm{s} w$ ith the stability of the dilaton potential in such m odels has prom pted others to consider $m$ ultiple gaugino condensation m odels which give a suitable potential for the axion $[10,11,12]$. Ferm ion condensates in technioolor theories can also give rise to potentials of the form above for elds coupled to the ferm ions. A lso, a theory w ith an antisym m etric tensor eld B (which arises, for exam ple, in string theory) w ith a eld strength

has an e ective action which can be expressed in term s of a scalar eld with a potential of the form in eq. (1.1) [13]. In a variant of these models, the tensor eld can be coupled to a fundam ental real scalar eld $u$ w ith the sym $m$ etry breaking potential of the form $V(u)=\left(\frac{0}{4!}\right)\left(u^{2} \quad 6 m^{2}=9\right)^{2}$. This also leads to a potential as in eq. (1.1) for the scalar.
