expansion analysis of very weak rst-order transitions in the cubic anisotropy model, Part II

A bstract

A companion article analyzed very weakly rst-order phase transitions in the cubic anisotropy model using expansion techniques. We extend that analysis to a calculation of the relative discontinuity of specie heat across the transition.

I. IN TRODUCTION

In this work, we use expansion m ethods to compute the universal ratio $C_+ = C$ of specic heats for arbitrarily weak rst-order phase transitions in the cubic anisotropy model. C_+ and C_- are the specic heats of the disordered and ordered phases at the transition temperature. This work is a direct follow up to the computations of other universal ratios in ref. [1], and we shall exchew any discussion of motivation or review of method and notation; instead, we jump directly into the calculation. The reader should read ref. [1] rst.

In the next section, we review the leading-order calculation of the ratio, which was rst performed by Rudnick in ref. [2]. Our result diers by a factor of 4. In section III, we proceed to next-to-leading order in . Our nalresults are displayed in section IV.

II. LEAD IN G-ORDER ANALYSIS OF C+=C

Recall from the introduction of ref. [1] that, in the three-dimensional theory, the square m² of the scalar mass plays the roll of the reduced temperature near the transition and the elective potential V represents the free energy of the system. The special cheat can be extracted from the elective potential as

The proportionality constant will not matter to our determination of the ratio $C_+ = C_-^{-1}$

Because of this relationship, it is useful to begin by sum marizing the leading-order form of the e ective potential discussed in ref. [1].

¹ In particular, the reduced tem perature is proportional to m ² ($_0$) for som e xed renorm alization scale $_0$, but we will instead apply (1) with m ² () where u is roughly the order of the correlation length and varies as we approach the transition. [Speci cally, we choose so that u() = v().] However, m ² () is related to m ² ($_0$) by multiplicative renorm alization which, even though dependent, cancels in the ratio.

A . Sum m ary of leading-order potential

At one-loop order, the e extive potential along an edge $^{\sim}$ = (;0;0;), evaluated at the tree-level instability line u = v, is [eq. (3.9) of ref. [1]]:

in d = 4 spatial dim ensions.

A rst-order transition occurs as m 2 is varied. At the transition, in the asymmetric phase, m 2 =M 2 O (). In the asymmetric phase, the potential then reduces to

The transition occurs when

We will also need the variation of the asymmetric minimum as one varies m^2 slightly away from the transition:

Finally, we will need the renormalization group ow of the various couplings, previously presented in ref. [1]. At leading order,

It is also convenient to introduce f u=v and

B. Speci cheats

The most non-trivial task in computing the specic heat ratio at the transition will be to handle the renormalization group ow of the constant term in the potential. Before investigating this, we rst write down the expression for C_+ and C_- given the potential. From (2),

where the second derivative of $\,$ is understood to be evaluated at the transition m 2 = m $_1^2$ (1 + 0 ()). Using (4) for the asym m etric phase, and rem embering that Q_M V (M) = 0 at the asym m etric m in im um,

where M has been evaluated at the transition using (6) and (9). C_+ will be shown to be O(1=) while C_- is $O(1=^2)$.

C. The running of

Now we turn to the contribution to the speci cheat from the term . The renormalization group equation for at one-loop order is

and the integral is to be understood as evaluated along the leading-order solution for the coupling constant trajectory. The contribution of to the speci c heat is then

E ⁽¹⁾ can be easily evaluated by changing variables from ⁰ to f using (15) and noting that $\frac{(1)}{m^2} = \frac{(1)}{f}$ (12,16) depends only on f:

The remaining integral in (23) can be performed similarly if we make use of the following relation (A 10a) of ref. [1]) for the solution to the leading-order RG ow equations (11):

The only other elements we need are the values of f(0), f(0), and u(0) for the desired trajectory. As discussed in ref. [1], we can obtain the universal ratios of interest by studying the trajectory that lows away from the cubic xed point at f(0) = 0 to the line of classical instability u = 0 at f(0) = 0 and $u = u_2$, where, at leading order,

For this trajectory,

This is O(1=) and dominates C_+ (17), but it does not contribute at leading order to C (18). Putting it all together,

This result is 4 times smaller than the result originally quoted by Rudnick 2].

Because the contribution of dominated C_+ , our formula (17) for C_+ is adequate at next-to-leading order provided we extend our analysis of to next-to-leading order. Before doing so, let us rst consider C_- .

A. The asym metric phase: C

The two-loop e ective potential near the asymmetric phase is given in ref. [1] (see eqs. (4.1), (4.2), and (4.4)):

As discussed in ref. [1], we shall not need to know C $_{10}$ and C $_{20}$. The transition takes place at

Since the contribution of is sub-leading, the leading-order result (30) for the contribution is adequate here.

B. The NLO running of

Now we are left with calculating $d^2 = d (m^2)^2$ to next-to-leading order. The two-loop renormalization group equation is

which has the same form as the one-loop equation. It's solution then also has the same form,

but now both the -functions and renormalization group trajectories should be evaluated at two loops. The two-loop -functions are given in Sec. VIA of ref. [1]:

To evaluate the integrals, we again change variables from to f, and we shall treat the two-loop e ects on -functions and trajectories perturbatively. Following sec. VID of ref. [1], it is helpful to make the dependence explicit by rewriting (u;v) = (u;v), and the expansion of the trajectory gives

where $u^{[1]}(f) = fR(f;c)$ is the one-loop result described in sec. IV C of ref. [1]. The solution for (f) is given by eq. (6.23) of ref. [1].

To do the nalintegral of (43), we need an expansion of $(=^{0})$. This can be obtained by writing

This integration does not seem to have a simple form for general n. For n=2, we are able to obtain a simple result for the trajectory owing away from the cubic xed point to the classical instability line u=v:

Putting everything together, and using the next-to-leading order n= 2 result

for u from eq. (6.28) of ref. [1], our nal result is then

IV . D ISC U SSIO N

Evaluated num erically, the nal result (59) for the ratio is

$$\frac{C_{+}}{C} = 0.0531^{\text{h}} 1 + (0.2125 \text{ ln} + 1.3993) + 0.021^{\text{i}}$$
 (60)

This ratio is compared against M onte Carlo simulations [3] in ref. [4]. The 140% correction at next-to-leading order for = 1 suggests that the expansion will be at best marginally successful for this quantity.
