THEORETICAL REVIEW OF B-PHYSICS

A bstract

Weak decays and mixing of B-hadrons play a special role in our understanding of the physics of the Standard Model and beyond. The measured amplitudes, however, result from a complicated interplay of weak and strong interaction elects. Understanding strong interaction dynamics, which becomes simpler for heavy quarks, is thus a fundamental part of the game. In this review, several theoretical aspects of B dynamics which are relevant for current and future experimental measurements are discussed.

1 Introduction

Hadronic weak decays are a unique source of information on the physics of the Standard Model and beyond. Experimental measurements and theoretical studies of these decays may provide us the key for understanding still unsolved problems such as the reason for the existence of several fermion families, the origin of fermion masses and weak couplings and the mechanisms which give rise to CP violation. Through quantum—loop e ects, they are also a window which allows us to explore and constraint new physics e ects at high energy scales still unaccessible to particle accellerators, such as those due to heavy supersymmetric particles. Unfortunately the physical amplitudes result from a complicated interplay of weak and strong interaction e ects, which must be disentangled in order to extract the values of the fundamental parameters.

In this fram ework, B-hadron decays play a special role, since the b-quark belongs to the heaviest, and less \coupled", of the three known fam ilies and its partner, the top quark, $G_F^{1=2}$. This observation, for has a mass which is of the order of the weak scale, m + example, has led to several speculations: that spontaneous symmetry breaking occurs via the Nambu-Jona Lasinio mechanism [1], that quark masses are dynamically determined by radiative corrections [2] or that the fundamental quark mass matrix, at large energy scales, is constrained to have very speci c forms [3]. Another aspect which is speci c to B-hadron decays is that the mass of the b-quark is much larger than the scale of strong OCD. In this situation, QCD dynam ics becomes much simpler and in m any cases, by using the Heavy Quark Eective Theory (HQET) [4], we can obtain accurate theoretical predictions to compare with the experimental measurements. An example is given by the determ ination of the Cabibbo-Kobayashi-Maskawa (CKM) matrix element V_{cb} i from exclusive (B ! D 1_1 and B ! D 1_1) and inclusive (b ! $X_c 1_1$) sem i-leptonic decays. Since, however, the mass of the b-quark is large, but not in nite, a related problem, to be discussed in the following, is that of controlling power corrections, i.e. corrections suppressed as inverse powers of the heavy quark mass.

In this article, I review several theoretical issues in the physics of B decays which are relevant for current or future experimental measurements. A special attention is paid to the discussion of the systematic errors present in the dierent theoretical approaches, and of the possible progresses that we may expect in the near future. In preparing this talk, it has been unavoidable to make a selection of subjects. Among those for which new theoretical studies or new experimental measurements appeared this year, I have chosen those topics which look to me particularly interesting, and/or for which I have enough compentence to express a personal point of view. For lack of space, I am unable to cover here radiative decays and supersymmetric ects in FCNC processes. A discussion on these points can be found in the talks by A.Ali and A.M asiero at this workshop. For further information on other subjects related to B-physics, not covered here, the reader can also refer to some recent review papers

by A.Ali [5], A.Buras [6] and M.Neubert [7].

This article is organized as follows. In sec. 2, a brief overview of leptonic decays, B 0 {B 0 m ixing and CP violation is given; in sec. 3, B $^-$ m eson exclusive sem i-leptonic decays, and the extraction of $\mathbf{j'}_{ab}$ j and $\mathbf{j'}_{ub}$ j, are discussed; some aspects of exclusive non-leptonic decays are reviewed in sec. 4; power corrections in the HQET are discussed in sec. 5; some considerations on inclusive sem i-leptonic decays can be found in sec. 6; the present status, and unsolved problems, for B -hadron lifetimes will be summarized in sec. 7, followed by a brief conclusion, which contains also an outlook on possible improvements in the accuracy of the theoretical predictions, sec. 8.

2 f_B , B^0 { B^0 m ixing and CP violation

The leptonic decay width of the B meson is given by

A precise know ledge of the leptonic decay constant f_{B} , analogous to f in would allow an accurate extraction of the CKM m atrix element \dot{y}_{ub} , which is actually known with a relative error of about 25%, see below. One of the most precise determinations of f_B is presently given by lattice QCD calculations and it is shown in table 1, together with other results for several physical quantities of interest for B-physics [8] [10]. The error on f_B reported in the table comes mainly from the extrapolation of the lattice results to the continuum limit and does not includes the systematic error due to the quenched approximation, which has been estimated to be of the order of 10{30% [11]. A global theoretical error of 25 M eV, corresponding to a relative error of about 14%, would provide us with an accurate determination of y_{ub} ; through a measurement totally independent from the sem i-leptonic channel, and with experim ental and theoretical system atic e ects di erent from that case. Even though the rate (which goes as the squared lepton mass) is much sm aller, the B + ! + leptonic decay channel is also quite interesting, because the much smaller number of events could be compensated by a much higher e ciency in detecting the nal state charged lepton.

 f_B also enters in phenom enological analyses of the B 0 {B 0 m ixing am plitudes, together with the so called renorm alization group invariant B-parameter $\hat{B_B}$. The square of the m ixing parameter $= f_B$ $\hat{B_B}$ is in fact related to the matrix element of the renormalized B = 2 Ham iltonian [12]. All theoretical calculations of $\hat{B_B}$ tend to give values very close to one for both the B $_0^0$ and the B $_0^0$ m esons, see table 1 and ref. [14] for QCD sum rules. Thus

the strength of the mixing is essentially regulated by the meson decay constant. Taking into account the theoretical uncertainties, and the experimental errors on the relevant CKM matrix elements and on the B lifetime, one predicts M $_{\rm B_d} = 0.55$ 0.13 ps [15], to be compared with the experimental world average M $_{\rm B_d} = 0.464$ 0.018 ps.

The value of f_B is also important for CP violation in B decays. It was realized long time ago [16] that a value of 200 M eV, combined with a large value of the top mass, (in the following I will use m $_{\rm t}^{\rm M~S}$ (m $_{\rm t}^{\rm M~S}$) = 167 $\,$ 8 G eV) leads to a large value of sin 2 , the parameter which controls CP violation in B ! J= K $_{\rm S}$ decays

This is shown in g.1 where the distribution of acceptable values of sin 2 , obtained from a combined analysis of the kaon CP violation parameter and of the B_d^0 { B_d^0 m ixing rate M $_{B_d}$ is shown [15]. The histogram refers to the distribution of values of sin 2 obtained by varying within their errors the values of the dierent experimental and theoretical quantities which enter in the theoretical predictions. The dashed histogram is obtained as the previous one, by imposing the further condition that =207 30 MeV . From the dashed distribution shown in the gure, one gets sin 2 =0.68 0:10, a value quite reassuring for future experiments at the B-factories.

The reliability of the lattice estim ates of the meson decay constants is demonstrated by the fact that f_{D_s} , which was predicted long before the instruction entailm easurement [17], agrees with the present experimental world average from D_s ! decays, $f_{D_s} = 241$ 21 30 MeV (f_{D_s} 260 MeV if one includes the L3 measurement from D_s !) [18]. Further, indirect information can be extracted from the experimental lower bound on the B_s^0 { B_s^0 mixing amplitude. Taking M_{B_s} 92 ps from experiments and $f_{D_s} = f_{D_s} = 1:15$ 0:05 0:15 from theory, where the last error is an estimate of the error coming from the quenched approximation 2, one obtains f_{D_s} 160 MeV in good agreement with the direct theoretical




Figure 1: D istributions of values for \cos and \sin 2 , for m_t = (168 8) G eV . The values of the parameters are those used in the second of refs. [16]. The solid histogram s are obtained without using the inform ation \cos ing from the experimental determination of $_{\rm q} \frac{M_{\rm B_d}}{M_{\rm B_d}}$. The dashed ones uses M $_{\rm B_d}$ = 0.464 0.018, with the condition 177 M eV $_{\rm d}$ = $f_{\rm B_d}$ $\stackrel{\circ}{B}_{\rm B_d}$ 237 M eV .

prediction [15].

I want to conclude this section with a comment on the \heavyness" of the charm quark. The HQET is not a model. It is QCD system atically expanded in powers of a small param eter ocp = mo, where mo is the quark mass and ocp stands for a scale of the order of the 300 M eV, since m_{charm} strong interaction scale. Thus if QCD = QCDthe expansion parameter is a small number even in the charm case. If, instead, QCD = $2 f_D$ 12 GeV or of the order of the nucleon m ass, the expansion parameter is of order one and the heavy quark expansion is expected to fail. Lattice studies of the behaviour of the m eson decay constant f_M as a function of the inverse m eson m ass [8]{ [10] have shown that the expansion parameter is, at least in this case, of the order of 1 GeV. These results have been con rm ed by calculations using QCD sum rules [14]. Such a large value of OCD im plies that power corrections are 80% {100% for the charm ed m eson decay constant, and 25% {30% in the B-m eson case. Corrections of the sam e order are also expected, and were indeed found in lattice calculations, for the sem i-leptonic form factors relevant in B! decays [9]. A special, and probably unique, case where the application of the HQET to the charm is successful, because of Luke's theorem [19], is represented by the sem i-leptonic B! D and D decays which are discussed in sec. 3. In all the other cases, as in the discussion of the charmed hadron lifetimes of sec. 7, there is strong experimental evidence that the charm is not heavy enough to make HQET applicable.

3 Exclusive sem i-leptonic decays

In this section I will discuss some theoretical issues related to exclusive heavy-to-heavy and heavy-to-light sem i-leptonic decays.

$3.1 \quad V_{cb} \text{ from B ! D l}_1$

In heavy-to-heavy decays, a golden plated determ ination of y_{cb} is given by the comparison of the dierential decay rate for the process B ! D l₁ to its theoretical expression ³

where the variable w, related to the momentum trasfer q, is given by

In the in nite mass limit, up to logarithmic corrections, F (w) tends to the Isgur-W ise function (w). When both m_b and m_{charm} become very large, the normalization of (w) at zero recoil is xed by the conservation of the weak current, i.e. (w=1)=1. In these limits then, up to the trivial kinematical factors appearing in eq. (4), a model independent extraction of \dot{y}_{cb} j is possible. Two elements are important for an accurate determination of \dot{y}_{cb} j however: the control of the corrections due to different elects at zero recoil, and the extrapolation of the rate to w=1.

i) The norm alization of F (w=1) is modiled by short-distance strong interactions elects, which can in principle be computed in perturbation theory, and by non-perturbative 1=m $_{\mathbb{Q}}$ corrections (starting at second order by virtue of Luke's theorem [19]). We have then

A recent two-loop calculation has reduced the uncertainty coming from the perturbative corrections to less than 1%, giving $_{\rm A}$ = 0:960 0:007 [20]. The evaluation of $_{1=m^2}$ is m ore problem atic, since this is a non-perturbative quantity. Two di erent approaches were followed in the past. On the one hand, a classication of all the 1=m $_{0}^{2}$ local operators of the HQET contributing to $_{1=m^2}$ was made, and their matrix elements estimated in a model $_{1=m^{2}} = (3)$ dependent way [21]. These estimates gave 2)%. On the other hand, zerorecoil sum rules, which are in principle model-independent, gave a much larger correction $_{1=m^2} = 5.5\%$ {8% [22, 23]. A fter som e controversy, M. Neubert, by using a \hybrid" method, found a \Solom onic" result, which is \not-in-disagreement" with both $_{1=m^2}$ = (5.5 2.5)% [24]. This prediction is currently the values given above, namely adopted in all the estim ates of the theoretical error on V_{cb} jextracted from the experim ental m easurem ents of the exclusive sem i-leptonic decays.

A recent study of the accuracy of power corrections in elective theories, illustrated by several explicit examples, showed that the predictions from the zero recoil sum rules, though model independent, are potentially subject to large corrections coming from higher order perturbative terms which have not been computed yet [25]. The same arguments apply to the calculations of refs. [21, 24]. For this reason, and given the high accuracy reached by the experimental measurements, I believe that a further electric is needed to try to reduce, and to evaluate more realistically, the error on $_{1=m^2}$. This is very discult because the deviations due to $_{1=m^2}$ are rather small, and no theoretical method, including lattice simulations, can control the uncertanties to a suicient degree of accuracy.

ii) Since the rate vanishes at w=1 (see eq.(3)) in order to extract F (w=1) an extrapolation of the data is necessary. This extrapolation is usually done by expanding the form factor around w=1

The slope $^{\circ}$ and the curvature $^{\circ}$ can be ted directly from the experimental measurements of the dierential rate 4 [26, 27]. It is, however, helpful for reducing the uncertainty of the extrapolation to have theoretical estimates of these parameters, for which several bounds, and calculations, obtained using dierent techniques, exist. The spread of the theoretical predictions for $^{\circ}$ is, unfortunately, still rather large [8], while for $^{\circ}$ there are only analyticity bounds which relate its value to that of $^{\circ}$ [28]. In analogy to what is done experimentally, $^{\circ}$ has been extracted from lattice calculations by thing the form factor computed in numerical simulations to eq. (6). This thing procedure, however, introduces a rather large uncertainty in the nalresult [8]. I want to mention that a method to obtain directly the $^{\circ}$ and $^{\circ}$, without any thing procedure, or perturbative calculation, has been proposed in ref. [29], but only a preliminary feasibility study of this technique has been done to date [30]. Contrary to the case of $_{1=m^2}$, it is likely that more accurate theoretical results for $^{\circ}$ will be obtained in the near future.

As shown in g.2, the values of F (w = 1) y_{cb} j extracted by the dierent experiments are quite consistent. This is true in spite of the fact that the tted values of ^ are somehow dierent [27]. From the world average of F (w = 1) y_{cb} by assuming from the theory F (w = 1) = 0:91 0:03 one obtains,

where the last error comes from the estimated theoretical uncertainty.

3.2 V_{ub} from B ! l_1 and B ! l_1

For heavy-to-light sem i-leptonic decays, HQET is less useful since the normalization of the current is not xed by symmetry. Still scaling laws can be established for $q^2 = q_{\rm ax}^2$. For example, up to logarithmic corrections, one nds [31, 32]

where f_B^+ (p) is the form factor relevant in B! decays. P denotes the heavy pseudoscalar meson, M_P its mass, p the pion momentum and A and are non perturbative quantities.




Figure 2: Determ inations of y_{cb} from dierent experim entalm easurem ents. The average is also given.

The scaling law in eq. (8), and others which can be derived for the form factors relevant in B ! l_1 or B ! K decays, are valid in the heavy meson rest frame, for small values of the light meson three-momentum, i.e. for p M_P . Scaling laws at q^2 0 can also be derived by computing the form factors using light-cone wave functions [33]. For example one $\operatorname{nds} A_1$ ($q^2 = 0$) $M_P^{3=2}$, where A_1 is the axial form factor entering in B ! l_1 decays. Unfortunately, corrections to the asymptotic scaling behaviour were found to be large both in lattice calculations [9, 32] and using QCD sum rules [33], cf. also the discussion on power corrections in sec. 2. A further constraint which can be used in theoretical predictions is that coming from the equality of some of the form factors in the helicity basis at $q^2 = 0$, e.g. f^+ ($q^2 = 0$) = f^0 ($q^2 = 0$), and from analyticity [34]. The above information is particularly useful for lattice calculations, where only a modest range of the physical q^2 is presently accessible.

Several theoretical methods have been used to predict the form factors for B! decays. Besides the lattice calculations [9] and the QCD sum rules [33] mentioned above, several quark model calculations have also appeared in the literature. A complete list of theoretical calculations can be found in refs. [18, 26, 27]. It is interesting that, with the increasing experim ental precision, it is possible to discrim inate the \good" from the \bad" m odels by confronting the ratio of widths (B!)= (B!), in which the unknown \mathcal{V}_{ub} cancels, to the theoretical predictions [18, 26, 27]. A compilation of results, obtained by the CLEO collaboration using dierent theoretical models is shown in g.3. In the extraction of $y_{\rm ub}$; som e m odels, the results of which are given in the gure above the horizontal line, have also been used in the M onte C arlo analysis of the data, in order to generate events to be confronted to the experim ental measurements. The corresponding values for $V_{\rm ub}$ j are only given in these cases. The last value, denoted as \Endpoint m ethod" refers, for com parison, to the result obtained from inclusive charm less decays, to be discussed in the following. From the qure, we see that the dominant error is the theoretical one. This is true in spite of the encouraging progresses made by the theoretical calculations in the last few years. These progresses are evident if one compares the results of g. 3 to those available at the time of the 5th Symposium on Heavy Flavour Physics, held in Montreal in 1993 [35]. A further im provem ent of the present situation is likely to occur in the near future, particularly from lattice calculations.

4 Exclusive non-leptonic decays

In this section, I brie y discuss a few items connected to exclusive two-body non leptonic decays.

<u>Factorization</u>: Factorization is an interesting phenom enological idea which allows us to predict non-leptonic amplitudes in terms of sem i-leptonic form factors and of vector and pseu-




Figure 3: Experim ental determ inations of y_{ub} j from exclusive B ! and B ! sem ileptonic decays. The results depend on the theoreticalm odelused in the experim entalanalysis. Only the models above the orizontal line have been used to extract y_{ub} j from the data. The value of y_{ub} j from inclusive decays is also given at the bottom of the gure.

doscalar decay constants. In a way, it corresponds to an elaborated version of the vacuum saturation approximation. Factorization was originally used to estimate kaon decay amplitudes [36]. In the eighties, it was applied by Stech and collaborators in analyzing D meson decays [37] and its explanation in terms of the 1-N expansion, where N is the number of colours, was subsequently proposed [38]. More recently, it has been suggested that factorization holds in the heavy quark limit, for some energetic decay channels, because the ultrarelativistic lightmesons in the nal state do not have time to exchange gluons [39, 40]. In ref. [41] it was shown, however, that the demonstration of factorization given in [40] has some problems. It may be still true that factorization becomes valid in the in nitemass limit, but a convincing proof of this intuitive physical idea is still missing. Several observations are necessary at this point.

i) Factorization does not work for charm meson decays, where, moreover, large nal-state interaction e ects are measured (nal-state interactions are zero if amplitudes factorize). This may be due either to a failure of factorization, or to the fact that, as observed above, the charm quark is not heavy enough. Indeed factorization, combined with the assumption that nal-state interactions are dominated by nearby resonances, has been successfully applied to phenomenological studies of charmed meson decays, for example in ref. [42].

ii) The e ective Hamiltonian which controls weak charm decays has the form

where \hat{O}_i () are composite operators renormalized at the scale and C_i (M $_W$ =) the corresponding W ilson coecients. The dependence on of the operators is compensated by the dependence on of the W ilson coecients. The factorized matrix elements of the operators, however, are -independent. Thus the nalphysical amplitude, in the factorization approximation, seems to depend on the renormalization scale. It may be true that ther exists a scale at which non-factorizable contributions are small, e.g. = m_b for B-decays, but a violation of factorization must be present to some extent.

iii) As recently shown in ref. [43] factorization and quark-hadron duality are incompatible. To reconcile duality and factorization a certain amount of non-factorizable contributions has to be allowed.

In conclusion, we know that non-factorizable contributions ought to be there, and that they are important for charm decays. The basic question is then to have a quantitative estimate of their size in B-decays. This problem has been studied in extensive experimental analyses of two-body exclusive decays [26] and it could be possibly accessible to lattice simulations in the near future [44], see below.

Non-leptonic decays on the lattice: There exist only quite old (and not very accurate) studies of heavy-quark two-body non-leptonic decays on the lattice, performed at m_0 m_{charm}




Figure 4: Non-penguin Feynm an diagram s for non-leptonic two-body decays.

[45]. In these calculations only \non-penguin" am plitudes were considered, namely those corresponding to the following Feynman diagrams: disconnected emission (DE), denoted also as T or 0 in ref. [46]; the colour-suppressed connected (non-factorizable) emission (CE), denoted also as C or 0 ; the helicity suppressed disconnected annihilation (DA), denoted also as A or 0 , and connected annihilation (CA), denoted also as E or 0 . These diagrams are given in g.4.

In [45] it was found that the am plitude of the non-factorizable diagram CE was about one third of the leading contribution given by DE, as expected on the basis the 1=N expansion, and that the am plitude of DA was indeed compatible with zero. The am plitude corresponding to CA, which is assumed to be negligible in some theoretical analyses [46], was found, however, to be as large as one half of that from DE.All the above results were unfortunately a icted by large statistical and system atical errors, and have never been repeated since. The reason for this is that all lattice calculations of two-body non-leptonic am plitudes were abruptly interrupted when the Maiani-Testa no-go theorem was published [47]. This theorem states the following. In numerical simulations on the lattice, it is unavoidable to make a Wick rotation to the Euclidean space-time, where in-and out-states are indistinguishable. From the standard study of the correlation functions one obtains then the average of the in-and out-amplitudes instead of the physical one, thus bosing all information about nal

state interactions 5 . For exam ple, in the calculation of the decay of a B \pm m eson into two light m esons M $_1$ and M $_2$, m ediated by the weak H am iltonian H $^{\rm W}$, one gets

instead of $_{\rm out}$ hM $_1$ M $_2$ H $^{\rm W}$ B i only. Moreover, at large time-distances, the correlation functions from which the amplitudes are usually extracted are dominated by the oshellmatrix element hM $_1$ (p $_1$ = 0) M $_2$ (p $_2$ = 0) H $^{\rm W}$ B i, instead of the physical amplitude. In general, the Maiani-Testa theorem prevents the calculation of time-like electro-magnetic form factors and strong and weak decays in two or more hadron nal states. Its extension can be used to show that it also him its the possibility of computing inclusive cross-sections and decay rates [49]. A possible way out of this problem, under mild assumptions, although at the price of introducing some model dependence, has been recently suggested in ref. [44]. We do not know at present if the proposal of ref. [44] will, in practice, succeed in extracting the physical amplitudes including the phases due to nal state interactions. Feasibility studies are currently underway. If the proposal works, a new eld of investigation (factorization, scaling laws, e ects due to nearby resonances) will be open to lattice calculations.

Other interesting two-body amplitudes:

A theoretical calculation of the tree-level and penguin contributions using the method of ref. [44], combined with the experimental analysis, would certainly help to reduce the system atic uncertanties in the nalresults.

ii) Isospin analysis: by combining the measured rates of the B $^{\,0}$! $^{\,+}$ and B $^{\,0}$! $^{\,0}$ decays, one can remove the penguin contribution, by isolating the pure I = 3=2 amplitude [50]. The diculty of this method is due to the measurement of the decay rate into two neutral pions, which is expected to be colour suppressed. An alternative method, based on a combined study of B $^{\,0}$! K and B $^{\,0}$! K K decays, using approximate avour SU (3) symmetry has also been proposed. There is no space to discuss the details, and uncertainties, of this method, for which the reader can refer to [50]. I want only to add one observation, which may stimulate further investigation. In refs. [46, 50], it is usually

assumed that the non-factorizable annihilation diagram CA is negligible, in contrast, but within large errors, and for smaller heavy quark masses, with the results of ref. [45], see above. A reappraisal of the lattice calculations of the non-leptonic amplitudes, on large lattices, and by using the theoretical improvements developed in the last few years [49] would certainly be very useful in this respect.

5 Power corrections in the HQET

In this section the problem of controlling power corrections in the heavy quark e ective theory (HQET) is discussed. These corrections are necessary for an accurate evaluation of both inclusive and exclusive decays of hadrons containing a b-quark. The basic question is whether they can be computed with a theoretical error smaller than the corrections them selves [25]. To be special, we start by considering the generic expression for the inclusive decay rate [51] [55]

and the ratio of form factors in B ! D l 1 decays [4]

In the above expressions $h^{V;A}$ are the relevant vector and axial vector form factors; C_f^3 , C_f^5 , C_i^6 , C^V (!) and C^A (!) are short distance quantities that can be computed in perturbation theory; the quark mass m_b, the binding energy , the kinetic energy ₁, the chromo-magnetic term ₂ and the B_i^6 's, that are related to the matrix elements of four-fermion operators, require instead a non-perturbative evaluation.

In some cases the non-perturbative parameters can be directly related, at the leading order in $1=m_Q$, to a physical quantity. This is the case of the chromo-magnetic term which corresponds to the B {B mass splitting, $_2 = 1=4$ (M $_B^2$ M $_B^2$). In general, however, the coe cients of the $1=m_Q$ expansion, and the corresponding non-perturbative parameters, are plagued by renormalon ambiguities. This problem is present for example in the denition the binding energy appearing in eq. (13) and in the matrix elements B $_1^6$ of the four fermion operators in eq. (12) [25], [56]{ [58]. In these cases, the cancellation of the ambiguities occurs between the matrix elements of the higher dimensional operators and the Wilson coe cient functions ($C_{\rm f}^3$, $C_{\rm f}^5$, :::). The latter have to be computed to su ciently high order of perturbation theory for the cancellation to be under control. Let us imagine that we want to achieve an accuracy of 0 ($1=m_b^k$). A simple argument indicates that, in principle, the leading Wilson

coe cient has to be computed at least to an order such that $_s (m_b)^n (_{QCD} = m_b)^k$ [25, 59]. Since, in the calculations performed up to now, only the rst few terms of the perturbation series are known, it is not possible to check that the remaining terms are negligible. By studying some simple examples, it has been shown that the knowledge of only a few terms is, in general, insu cient to control the power corrections [25]. Although the results rely on some approximations that were adopted in these examples, it is likely that the conclusions will remain valid in general, and that in most cases a further theoretical e ort is needed.

Let us consider, for example, the unphysical parameter $= M_H - m_{pole}$ which is frequently used in phenomenological studies of B-physics. Results and bounds for have been presented in the literature [60]{ [63]. In order for this to make any sense, must be dened precisely in terms of some physical quantity, and its value will depend on this physical quantity and on the order of perturbation theory used to extract. In ref. [25] it has been shown that, even by using a consistent and renormalon-free denition of the binding energy, one expects that the value of w ill change by several hundred MeV, i.e. by an amount comparable to its value, as the order of perturbation theory is increased. The error on w can be seen as an error on the w mass of the b-quark w mass of the pass of the

where the last (and larger) error comes from an estimate of the uncertainty due to higher order corrections in perturbation theory.

Sim ilar problem s are encountered in the case of $_1$. One example is given by the zero recoil sum rules [67, 68]. In this case, in order to derive bounds on the relevant form factors, and on the heavy-quark kinetic energy parameter $_1$, a physical cut-o is introduced, to suppress the contribution of states with excitation energies greater than . The di-culty in achieving an accurate determination or bound with a physical cut-o is due to the higher order perturbative corrections and only by arriving to an order such that $_{\rm s}^{\rm n}$ 0 ($_{\rm l}$ = $^{\rm 2}$) it will be possible to obtain signicant results. A connected example is provided by the di-erent theoretical determinations of $_{\rm l}$, which are given in table 2. Some of them are not compatible, if we accept as realistic the errors quoted in the original papers. I believe that the di-erences are due to higher order perturbative corrections, which have not been computed, or estimated, yet.

6 Sem i-leptonic inclusive decays

The idea that inclusive decay rates of heavy quarks can be computed in the parton model is quite old and was used, for example, in ref. [73] to predict charm hadron lifetimes. To account for bound state e ects, the partonic calculation was successively improved by the introduction of a phenomenological model, called the \spectator model" [74, 75], which has

been and continues to be extensively used to extract y_{cb} and y_{ub} from inclusive semileptonic decays. A noble theoretical fram ework for the spectator model was then provided by the operator product expansion applied to inclusive decays of heavy quarks [51]{[55]. The general result is summarized in eq. (12), which holds for both inclusive semileptonic and non-leptonic decays. The rst term on the rh.s. of eq. (12) is the parton model result; corrections of 0 (1=m $_b^2$) are due to the kinetic energy $_1$ and the spin interaction $_2$ of the heavy quark in the hadron $_1^6$; the four-ferm ion operator contributions to the 1=m $_b^3$ correction, written in terms of the B $_1^6$ parameters, correspond, in the old language, to W-exchange and interference higher-twist elects. These elects were considered in order to explain the lifetime differences among the difference charmed hadrons [76].

In modern language, the use of the parton model to compute inclusive decays relies on the assumption of \quark-hadron" duality: in sem i-leptonic decays, where the integration over the lepton and neutrino momenta corresponds to an integration over the invariant mass of the recoiling hadronic system, we have global duality, whereas in non-leptonic decays, where the hadronic mass is xed to be equal to the heavy hadron mass, we speak of local duality. Duality is assumed, but cannot be proven in QCD. We know that it provides a good description of several physical processes such as inclusive deep inelastic scattering, inclusive e⁺ e annihilation into hadrons, D rell-Y an processes, etc. The assumption of global duality seems also to work for sem i-leptonic (and radiative) decays. This means that we are able to

predict the inclusive $_{SL}$ (b! X_{cl}_{1}), $_{SL}$ (b! X_{ul}_{1}) and $_{SL}$ (b! s) rates. This is not the case for local duality since there is strong experimental evidence that we are unable to explain B-hadron lifetimes in the fram ework of the 1=m $_{b}$ expansion, see sec. 7.

The situation for $_{\rm SL}$ (b! $_{\rm SL}$) is substantially unchanged since last year. For this reason, I direct the reader to ref. [7] for a discussion of the theoretical uncertainties in the calculation of this quantity. Here I lim it myself giving the upgraded world average values of $_{\rm SL}$ from inclusive decays

where the results from low energy and LEP energies have been given separated. The reason is that the di erent central values are induced mostly by the di erences in the sem i-leptonic branching ratio measured in the two cases [18]. Notice the excellent agreement between these results and the number given in eq. (7).

The above results make us con dent that we are able to make accurate predictions for $_{\rm SL}$ (b! $_{\rm SL}$). A related problem is whether we are also able to predict the sem i-leptonic branching ratio $_{\rm SL}$, and the average number of charmed hadrons $_{\rm C}$. Since the former is given by the ratio of $_{\rm SL}$ (b! $_{\rm SL}$) to the total width, the problem is whether we are able to predict inclusive non-leptonic widths. Recently, there was a lot of debate about whether the theoretical value of $_{\rm SL}$ is in agreement, or in disagreement, with the experimental measurements [55, 77, 78] and, in the second case, several explanations, within and beyond the standard model, have been proposed [79]{[82]. Since there are important dierences between low energy and LEP results [18]

it is probably premature to draw any conclusion at this stage.

 \dot{y}_{ub} j could be extracted, in principle, from the total sem i-leptonic width in the same way as \dot{y}_{cb} j. In practice, however, only the endpoint spectrum is used, in order to eliminate the background due to b! cl₁ decays. The cut on the lepton energy E₁ is xed by the requirem ent that the recoiling hadronic system X has an invariant mass M_X M_D, so as to inhibit charm decays. In this region, however, we run into troubles with the operator product expansion. Schem atically, we can write

where ::: represent term s which are suppressed as powers of m_b . Only the rst few term s in the expansion above are known because they can be related to $_1$, $_2$, etc. The higher order

term s depend on matrix elements of higher dimensional local operators, which can at most be estimated within a speci c phenomenological model.

Note that when M $_{\rm X}$ $\stackrel{\rm QCD}{=}$ M $_{\rm B}$, all the terms in the expansion (17) become equally important. At even larger values of E $_{\rm 1}$, M $_{\rm X}$ $_{\rm QCD}$. In this case we are in the elastic region (corresponding to B $_{\rm 1}$, B $_{\rm 2}$, etc.) and the decay cannot be analyzed with operator product expansion. Unfortunately, M $_{\rm X}$ $_{\rm QCD}$ M $_{\rm B}$ is about $1.2\{1.3~{\rm GeV}$, a value very close to the kinematical cut which is currently used in the experiments to extract $y_{\rm ub}$. This implies that the extraction of $y_{\rm ub}$ is still subject to an intrinsic model dependence, which can be reduced either by enlarging the region of E $_{\rm 1}$ from where $y_{\rm ub}$ is extracted, at the price of increasing the charm background, or by a sound theoretical prediction of the \wave" function [52,54] of the heavy quark.

7 Non-leptonic inclusive decays

In this section it will be shown that it is very unlikely that higher order corrections in $1=m_b$ can explain the discrepancy between the theoretical predictions for the B to $_b$ lifetime ratio $R = _B = _b$.

For R, the dependence on the $\,$ fth power of the quark mass, as well as all renormalon ambiguities up to order $1=m_b^3$, cancel out. We thus expect R to be one of the soundest predictions of HQET. The discrepancy between theory and experimental data is evidence for the failure of local duality in the calculation of the non-leptonic (NL) widths of heavy hadrons.

To order $1=m_b^2$ in the heavy quark expansion, the lifetime ratio R is given by

where the di erence of kinetic energies $_1$ (B) $_1$ ($_b$) = 0.01 0.03 G eV 2 can be obtained from the spectrum of the heavy hadrons; $_2$ ($_b$) = 0; $_2$ (B) = (M $_B^2$ M $_B^2$)=4 = 0.12 G eV 2 and C $_G$ =3 1.1. U sing the numerical values given above one obtains R = 1.02 + 0 (1= m_b^3), incompatible with the observed ratio of lifetimes R = 1.27 0.05. Within the standard HQET, in order to explain the large deviation from unity for this ratio it is necessary the the matrix elements of the four-quark operators entering in the 1= m_b^3 corrections (and in particular those relative to the $_b$) be much larger than those estimated in quark models, and more recently with QCD sum rules [55, 80]. In my opinion, this remains an open, but very unlikely possibility. An alternative explanation is that for NL widths there is evidence, contrary to the orthodox expectations, of corrections of 0 (1= m_b). These corrections are well

described by the $\sin p \cdot \mathbf{k}$ ansatz that replaces the quark m ass with the decaying hadron m ass in the m $_0^5$ factor in front of the NL width [8, 79]

This replacement provides a much better description of the NL widths. In ref. [79], it was shown that, for beauty, both the problems of the SL branching ratio and of the dierence in the lifetimes of the baryon and the B mesons are quantitatively solved. For charm a much better to the seven known lifetimes is obtained in terms of four parameters of reasonable size: one lifetime, one interference contribution for D⁺, one for ⁺ and a smaller W exchange term for D^s. I will now give more details on the analysis of ref. [79].

Given the agreement between the value of y_{cb} jextracted from inclusive b! c and exclusive B! D sem i-leptonic (SL) decays and the approximate equality of the SL widths for charmed hadrons (within large uncertainties and with a rather limited number of cases where measurements exist), it is assumed that the HQET is able to predict the SL widths of the heavy hadrons. Under this assumption, and using the ansatz (19), one gets

where the factor 2.24 arises from taking the electron, the muon and the tau SL m odes in the ratio 1:1:0.24 [83], and the dierence in the SL rates of the $_{\rm b}$ and B has been neglected. From M $_{\rm b}$ = 5623 $_{\rm b}$ 6 M eV [84] and M $_{\rm b}$ = 5279 $_{\rm b}$ 2 M eV [85], by using B $_{\rm SL}$ (B) = 10:77 $_{\rm b}$ 0:43%, one nds $_{\rm b}$

in perfect agreem ent with the experim ental result.

So far this agreement can be considered to be a numerical accident, lacking theoretical explanation. For this reason, it is quite interesting to consider what happens in the case of charmed particles for which seven lifetimes have been measured, see table 3. At lowest order in the 1=m $_{\rm Q}$ expansion, a much better agreement with the experimental results for the lifetimes is obtained by replacing the heavy-quark mass by the hadron masses as in eq. (19). We neglect at this stage any other mass correction and write $_{\rm NL}$ (M $_{\rm H}$) = $_{\rm tot}$ (M $_{$




Figure 5: Lifetim e vs. m ass for charm ed particles. The dashed line is the best t described in the text for all seven points assum ing proportionality of the NL widths to M $_{\rm H}^{5}$, M $_{\rm H}$ being the hadron m ass. The solid line is the best t restricted to only the D 0 , $_{\rm C}$, 0 and $_{\rm C}$ lifetim es with the same assumptions as before.

Let us x n = 5; M $_0 = 2.3$ GeV and $_{\rm SL} = 0.174$ ps 1 and tall seven known lifetimes in term s of (M_0) . $(m_0) = 0.181$ ps is then obtained. The corresponding t is shown in g.5 (dashed curve). We see that four out of seven lifetimes are in very good agreement with the tted curve. The lifetim es of D $^+$, of $^+$ and, to a lesser extent, of D $_{\rm s}$ are clearly out. The discrepancies for D + and + can be attributed to the interference e ect [87]. Note that D + is the only meson that can have interference at the Cabibbo allowed level and ' is the only baryon that can have double interference, in the sense that + = cus and both u and s can interfere with the corresponding quarks from c! sud. For D_s the observed smaller dierence is attributed to the possibility of W -exchange [87]. All of these e ects are of order $f_D^2 = m_c^2$ or $1=m_c^3$. The solid line in g.5 has been obtained from a modil ed twhere only the D⁰, c, ⁰ and $_{\rm c}$ lifetim es have been considered. In this case, $(M_0) = 0.161$ ps, with the respectable value of the 2 =dp:f:given by 3:5, is obtained. For comparison, the t of the quark mass to constant lifetim es results in a 2=dp:f: 250. Finally, for the same four lifetimes, one ts the power n in eq. (22), keeping xed the value of M $_0$ and M_0) at the observed values for the D 0 m eson. In this way one may check whether the best power for n is close to 5. 0.5 is found, where the error arises from the experim ental errors on the lifetimes. M oreover, if we write for D $^+$, $^+$ and D $_{\rm S}$ the expression $^{-1}$ = $^{-1}$ (M $_{\rm H}$) 1 is the experim ental number given in table 3 and (M_H) is taken from the previous t to the four remaining lifetimes (with n=5), = 1:6;22 and 1:3 GeV are obtained for D⁺; + and D s, respectively. We see that the resulting values of this correction are large, as it is obvious from g.5, but not unreasonable.

The conclusion is that a number of experimental facts show that $_{\rm N\,L}$ for charm and beauty decay approximately scale with the ffth power of hadron masses (apart from corrections of order 1= $_{\rm N\,L}^2$ or smaller) rather than having 0 (1= $_{\rm N\,L}^2$) corrections to the universal behaviour predicted by the HQET. Since M $_{\rm H_b}^5$ = (m $_{\rm b}$ + $_{\rm H_b}$) 5 = m $_{\rm b}^5$ (1+5 $_{\rm H_b}$ =m $_{\rm b}$)+::; this implies that the corrections are of 0 (1= $_{\rm m\,b}$). Since the validity of the operator expansion in the timelike region, in the vicinity of the physical cut, is not at all guaranteed [88, 89], the failure of the short distance approach can be attributed to a violation of the local duality property that has to be assumed for NL widths. This is to be compared to the case of the SL widths for which the predictions of the HQET are not inconsistent with the data. The experimental evidence for NL widths calls for a reexamination of the underlying theoretical framework. An attempt in this direction can be found in ref. [81]. More extended and accurate measurements of the SL widths of each hadron separately are also needed in order to assess the validity of the heavy quark expansion in semi-leptonic decays.

8 Conclusion and outlook

Beauty hadrons provide an extraordinary laboratory to test the Standard M odel, to look for hint of new physics and to understand QCD dynam ics. For this reason an exceptional experim ental and theoreticale orthas been invested in it. In this review, I have tried to point out those dynam ical aspects which we ought to understand and control at a quantitative level in order to extract the relevant inform ation on some fundam ental parameters, such as the m ass of the b quark, the relevant CKM m atrix elements and CP violation.

M uch theoretical progress, and improvement in understanding, has occured this year in the fram ework of the HQET and of the calculation of inclusive rates. Still a lot of work remains to be done, particularly for those quantities where the theoretical uncertainties are larger than the experimental errors. Progress can be expected quite soon for the slope and the curvature of the form factors in B ! D 1_1 decays, in the understanding of factorization and in the calculation of non-leptonic two-body decay amplitudes. It appears more dicult to reduce the error in the normalization of the form factor at zero recoil for B ! D 1_1 and to eliminate the model dependence in the extraction of y_{ub} from inclusive semi-leptonic decays. A real puzzle, which demands a deep reappraisal of current ideas, and prejudices, remains that of the y_0 lifetime, which seems to indicate a failure of local duality in inclusive non-leptonic decays.
