TOWARDSAUTOMATIC ANALYTIC EVALUATION OF MASSIVE FEYNMAN DIAGRAMS.

A method to calculate two-loop self-energy diagram s of the Standard M odel is demonstrated. A direct physical application is the calculation of the two-loop electroweak contribution to the anomalous magnetic moment of the muon $\frac{1}{2}$ (g 2). Presently we conneourselves to a \toy" model with only , and a scalar particle (H iggs). The algorithm is implemented as a package of computer programs in FORM . For generating and automatically evaluating any number of two-loop self-energy diagrams, a special C-program has been written. This program creates the initial FORM -expression for every diagram generated by QGRAF, executes the corresponding subroutines and sum sup the nal results.

1. Introduction

Recent high precision experiments to verify the Standard M odel of electroweak interactions require, on the side of the theory, high precision calculations resulting in the evaluation of higher loop diagram s. For special processes thousands of multiploop Feynm and diagram s do contribute, and it turns out in possible to perform these calculations by hand. That makes the request for automatization a high priority task. In this direction, several program packages are elaborated (1 2 and reports of the M inami-Tateya collaboration, Bauberger et al., Pukhov et al., Vermaseren and JXW and on this conference). It appears absolutely necessary that various groups produce their own solutions of handling this problem: the various ways will be of dierent electron, have dierent domains of applicability, and last but not least, should eventually allow for completely independent checks of the nalresults. This point of view motivated us to seek our own way for automatic evaluation of Feynm and diagram s. We have in mind only higher loop calculations (no multipoint functions).

We demonstrate here the functioning of a C-program (TLAMM) for the evaluation of the two-loop anom alous magnetic moment (AMM) of the muon $\frac{1}{2}$ (g -2), but on the same lines we have developed the program to an extent that it can be applied to arbitrary processes in the Standard Model. This piloting C-program must read the diagrams generated by QGRAF 3 for a given physical process, generate the FORM 4 source code, start the FORM interpreter, read and sum up the results

for the class of diagram's under consideration. For the purpose of demonstration, here we apply TLAMM to a closed subclass of diagrams of the Standard Model, which we refer to as a \toy" model.

Recent papers reduced the theoretical uncertainty of the muon AMM by partially calculating the two-loop electroweak contributions 5,6. Their results have been obtained in the following approximation: terms suppressed by $(1 \quad 4\sin^2)$ were om itted; the ferm ion masses of the rst two families are set to zero; in the third fam ily the - and b-quark m asses are taken to be zero as well; diagram s with two or m ore scalar couplings to the muon are suppressed by the ratio $\frac{m^2}{M^2}$ and have been discarded; the Kobayashi-Maskawam atrix is assumed to be unity; the mass of the Higgs particle is large compared to M $_{Z:W}$.

All of these approximations, except possibly the last one, are well justiled and give rise to small corrections only. We consider it of great interest to study also the M $_{Z:W}$. To perform this calculation is our main physical motivation. A part from that, for technical reasons, it may be interesting to study the functioning of TLAMM by calculating all 1832 two-loop diagram swithout any approximation.

The calculation of the anomalous magnetic moment of the muon reduces, after di erentiation and contractions with projection operators, to diagram s of propagator type with external m om entum on the m uon m ass-shell (for details see 7).

The method of Taylor expansion of diagrams in external momenta and Pade approximation 8 yields only slow ly converging results at the threshold. Since in the case of the muon AMM we are confronted with a low energy problem it appears naturalto expand with respect to the heavy m asses (M $_{
m Z}$;M $_{
m H}$ and m $_{
m t}$) of the theory. The applicability of the \asymptotic-R-operation" 9 in the limit of large masses has to be investigated for diagram s evaluated on the muon mass-shell (i.e. p^2 m²). Some diagrams already had a threshold at the muon mass-shell before the expansion. In other diagrams this threshold appears in some terms of the expansion. In dimensional regularization, threshold singularities (like any other infrared singularities if they are strong enough) manifest them selves as poles in " (d=4-2"). They ought to cancel for the total AMM. We check this in our toy model.

2. Large-m ass expansion

The asymptotic expansion in the \lim it of large masses is de ned 10 as

where G is the original graph, 's are subgraphs involved in the asymptotic expansion, G = denotes shrinking to a point; F = is the Feynm an integral corresponding to $\,$; $T_{q\,m}$ is the Taylor operator expanding the integrand in $\,$ sm $\,$ all $\,$ m $\,$ asses $\,$ fm $\,$ g and external m om enta fq g of the subgraph (before integration); \ "inserts the subgraph expansion in the num erator of the integrand $F_{G=}$. The sum goes over all subgraphs which (a) contain all lines with large masses, and (b) are one-particle irreducible relative to lines with light masses.

The following types of integrals occur in the asymptotic expansion of the muon AMM in the Standard Model: 1: two-loop tadpole diagrams with various heavy m asses on internal lines; 2: two-loop self-energy diagram s, involving contributions from ferm ions lighter or heavier than the muon, with the external momentum on the muon mass-shell; 3: two-loop self-energy diagram swith two or three muon lines and the external momentum on the muon mass-shell; 4: products of one-loop selfenergy diagram s on-shell and a one-loop tadpole with a heavy mass. A lm ost all of these diagrams can be evaluated analytically using the package $SHELL2^{11}$. For our calculation we have modi ed this package in the following way: 1: There are no restrictions on the indices on the lines (powers of scalar denom inators). 2: M ore recurrence relations are used, and the dependence on the space-time dimension is always explicitly reducible to powers of linear factors. 3:A new algorithm for sim pli cation of this rational fractions is im plem ented. These modi cations essentially reduce the execution time (in some cases, down to the order of a hundredth). 4: New programs for evaluating two-loop tadpole integrals with dierent masses are added. 5: New programs were written for the asymptotic expansion of one-loop self-energy diagram s (relevant for renorm alization) in the large-m ass lim it.

3. The toy-m odel

As the rst step, we concentrate on a \toy" model, a \slice" of the Standard Model, involving a light charged spinor , the photon A , and a heavy neutral scalar eld . The scalar has triple (q) and quartic () self-interactions, and the Yukawa coupling to the spinor (y). The Lagrangian of the toy-m odel reads (in the Euclidean space-time):

where e is the electric charge and is a gauge xing parameter.

The main aim s of the present investigation are the following:

1: Veri cation of the consistency of the large-m ass asymptotic expansion with the external m om entum on the m ass shell of a small m ass. In particular, we check the cancelation of all threshold singularities, that appear in individual diagrams and manifest them selves as infrared poles in ".

2: Estimation of the in uence of a heavy neutral scalar particle on the AMM of the muon in the fram ework of the Standard Model.

3: Veri cation of gauge independence: we use the covariant gauge with an arbitrary param eter .

In the following we analyze in some detail the diagram scontributing to the AMM of the ferm ion in our toy-model and specify the renormalization procedure. A part from counterterms 40 diagrams contribute to the two-loop AMM of the ferm ion. A firer perform ing the D irac and Lorentz algebra, all diagrams can be reduced to 4 Towards automatic analytic evaluating of massive Feynman diagrams




Figure 1: The prototypes and their subgraphs contributing to the large mass expansion. Bold, thin and dashed lines correspond to the heavy-mass, light-mass, and massless propagators, respectively. Dotted lines indicate the lines om itted in the subgraph.

some set of scalar prototypes. A \prototype" de nes the arrangement of massive and massless lines in a diagram. Individual integrals are specified by the powers of the denominators, called indices of the lines. From the point of view of the asymptotic expansion method the topology of the diagram is essential. All diagrams of the toy-model which contribute to the two-loop AMM can be classified in terms of 9 prototypes (we omit the pure QED diagrams). These prototypes and their corresponding subgraphs involved in the asymptotic expansion, are given in Fig. 1. In dimensional regularization, the last subgraphs vanish in cases 1;4;7, and 8, owing to massless loops.

All diagrams were generated in symbolic form by means of QGRAF 3 . The TLAMM -program

1:ReadsQGRAF output;

- 2: For each diagram, it creates a le containing the complete FORM program for calculating this diagram;
 - 3: Executes FORM;
- 4: Reads FORM output, picks out the result of the calculation, and builds the total sum of all diagrams in a single le.

All initial settings are dened in the \con guration le". It contains information about the use of le nam es, identi ers of topologies, choice of m om enta, and the description of the model in terms of the notation that is some extension of QGRAF's. A lldiagram s are classi ed according to their prototypes. Identi ers for vertices and propagators and explicit Feynman rules are read from separate les and then inserted into the FORM program. For each diagram, the relevant FORM subroutines are called. Since the number of identiers needed for the calculation of all diagrams may exceed FORM capacity, the TLAMM-program keeps for each diagram only those needed for its calculation. Finally, the total sum of all diagrams is put into one le and can be processed further by FORM. There exist several options which allow one to process only diagram s 1 with given numbers; 2 of a given prototype; 3 of a speci ed topology; and som e debugging options.

To perform the asymptotic expansion FORM -programs have been written for every prototype. For e ciency of the algorithm the following is essential:

- 1: The result of the calculation is presented as a series in small parameters. Care is taken to avoid the production of unnecessary high powers in intermediate results.
- 2: For the evaluation of the Feynm an integrals it is necessary to reduce scalar products of momenta in the numerator to the square combinations present in the denom inator. Moste ciently, this is done by means of recurrence relations proposed by Tarasov 12 in the proceeding of the A IHENP-95.

We use the on-shell renorm alization scheme. The renorm alization conditions are as follows: 1: The electric charge e is de ned in terms of the nonrelativistic Thom pson limit of the Compton scattering. 2: The physical masses are given as the pole of the propagators. Since we are interested here only in the AMM, we don't need the wave-function renormalization. All the tadpoles are canceled by mass counterterm s. Then at the two-loop level the interaction 4 does not contribute to the AMM of the ferm ion. No special functions but the logarithm's appear in the nalresult:

where $S_2 = \frac{4}{9^{\frac{6}{3}}}C \, l_2$ $\frac{1}{3} = 0.2604341$ with $C \, l_2$ the C lausen function, $e^2 = (4)$ and y;g are renormalized coupling constants. We see that

- 1 The two-loop contribution to the AMM is gauge independent.
- 2 The additional threshold singularities arising in the asymptotic R-operation have canceled.
 - 3 W ith the Standard M odel values it is $\frac{m}{M}$ 4.
