## Vector Leptoquark Pair Production in e<sup>+</sup>e Annihilation

## A bstract

The cross section for vector leptoquark pair production in  $e^+e^-$  annihilation is calculated for the case of nite anomalous gauge boson couplings  $_{;Z}$  and  $_{;Z}$ . The minimal cross section is found to behave /  $^7$ , leading to weaker mass bounds in the threshold range than in models studied previously.

Various extensions of the Standard M odel predict bosonic states carrying both lepton and quark quantum numbers, the leptoquarks. If their couplings are baryon and lepton number conserving, cf. see [1], these states may even exist in the mass range accessible at high energy colliders. Stringent bounds on the leptoquark (ferm ion couplings  $_{lq}$  are derived from low energy data [2]. In the mass range M  $_{V}$  1 TeV they are required to be much smaller than the electrom agnetic coupling. On the other hand the bosonic leptoquark couplings cannot be arbitrarily small but are determined by the respective gauge couplings and eventual anom alous couplings.

In this note we extend the analysis perform ed in a previous investigation [3], where m inimal vector couplings [4] = 1 and = 0 were considered, to the general case of four independent anomalous couplings ;  $_Z$ ; and  $_Z$  for the process of vector leptoquark pair production in  $e^+e^-$  annihilation,  $e^+e^-$ !  $VV^{-1}$ . Due to the smallness of the fermionic couplings we will consider the bosonic contributions only in the following. The annihilation process dominates at not too large cms energies. Additional contributions are due to the photon {photon fusion processes,  $e^+e^-$ !  $e^+e^-$  VVX, which were studied in refs. [6, 7].

The tri-linear coupling of the photon and Z-boson to a pair of vector leptoquarks is given by

Here Q (V) denotes the electric charge of the vector leptoquark and the Z-coupling is Q z (V) = [ $T_3$  (V) Q<sub>em</sub> (V)  $\sin^2$   $_W$  ]= ( $\cos$   $_W$   $\sin$   $_W$ ), with  $T_3$  being the third component of the weak isospin and  $_W$  the electroweak mixing angle. In the following we refer to the vector leptoquarks discussed in ref. [1]. Their quantum numbers can be found in ref. [3], table 1.

The di erential scattering cross section in the center of momentum frame reads

The lepton{gauge boson couplings are Q  $^{L\,;R}=1$  , Q  $^{L}_{Z}=(\frac{1}{2}+\sin^{2}_{W})=\cos_{W}\sin_{W}$  , and Q  $^{R}_{Z}=\tan_{W}$  .

The angular distribution depends strongly on the value of the anomalous couplings. For symmetric couplings = z and = z the constant part vanishes for the case = +2. The dierential cross section  $d = d\cos z$  is then proportional to  $\sin^2 z$  as in the case of scalar leptoquark pair production  $\beta$ . On the other hand, the dierential distribution turns out to be rather at form inimal vector couplings z = 1; z = 0, cf. ref. z = 0.

The minimal cross section among all possible choices of the four anomalous couplings  $;_{z}$ ; and  $_{z}$ , is

Unlike in the case of general values of the anomalous couplings and (11) the minimal cross section does not contain unitarity violating contributions / s=M $_{\rm V}^2$ . The anomalous couplings determining the minimal cross section (13) are depicted in gure 1. Due to the symmetry of the

i.e.  $^{m \text{ in}} = 7$ =4 for ! 0. Here the cross section grows /  $^3$  near the threshold as also in the case of m in im alvector couplings and Y ang{M ills type couplings. The weaker rise /  $^7$  in the previous case is thus a consequence of considering non{zero values of  $_{iZ}$  in eq. (1).

In gure 2 the mass dependence of the pair production cross section of the leptoquark  $U_1^2$  is shown at  $\bar{S} = 1\,\mathrm{TeV}$  for dierent choices of the anom alous couplings, upon which the accessible mass bounds strongly depend. Assuming a signal of 100 events at an integrated luminosity of  $L = 10\,\mathrm{fb}^{-1}$  for the minimizing anom alous couplings, a mass bound of 370 GeV can be reached, whereas the corresponding bound for minimal vector couplings is 470 GeV. A still larger cross section is obtained for Yang {Mills type couplings  $_{iZ} = _{iZ} = _{iZ$ 

In gures  $3a\{c$  the m inim alvalues of the integrated cross sections are shown for all leptoquark states of ref. [1] at  $^{D}$   $\bar{s}$  = M  $_{Z}$ ; 190 GeV, and 1 TeV. A coessible mass ranges are indicated assuming 100 signal events  $^{3}$  at integrated luminosities of L (M  $_{Z}$ ) = 150 pb  $^{1}$ ; L (190 GeV) = 500 pb  $^{1}$ , and L (1 TeV) = 10 fb  $^{1}$ , respectively. For all cms energies considered, the lowest mass bounds are estimated for the states U $_{1}$  and U $_{3}$ (0), respectively, which have the same bosonic quantum numbers. The largest cross sections are obtained for U $_{3}$ (1) for  $\bar{s}$  = M $_{Z}$  and U $_{3}$ (1) at  $\bar{s}$  = 190 GeV and 1 TeV, respectively.

In conclusion, we have shown that non{vanishing anom alous couplings and z may yield much weaker search limits in the threshold range as obtained varying the couplings and z only. This should be taken into account in forthcoming analyses of the LEP data z both for z = M z, the energy range at LEP2, and at future linear colliders.




Figure 1: The minimizing couplings min and min as a function of =  $\frac{q}{1}$   $\frac{q}{4M_V^2}$  =s. The dashed line corresponds to the value of minimizing the production cross section for = 0.




Figure 2: Integrated pair production cross section for the vector leptoquark  $U_1$ , ref. [1], for dierent values of the anomalous couplings  $_{;Z}$  and  $_{;Z}$ . Solid line: minimal cross section; dash {dotted line: minimal cross section for  $=_{Z}=0$ ; dotted line: cross section for minimal vector couplings (MC)  $_{;Z}=1$ ;  $_{;Z}=0$ ; dashed line: cross section for Yang {Mills type couplings (YM)  $_{;Z}=_{;Z}=0$ . The horizontal dotted line indicates the accessible search range at a lim inosity of L = 10 fb  $^{1}$  and 100 signal events.




Figure 3a:M ass dependence of the m inimal integrated pair production cross section for the vector leptoquarks ref. [1] at  $^p$   $\bar{s}$  = M  $_z$ . The lines correspond to the production cross sections for the states U  $_1$  (U  $_3$  (0)); V  $_2$  (1=2);  $\bar{v}_2$  (1=2);  $\bar{v}_2$  (1=2); V  $_2$  (1=2); U  $_3$  (1) and U  $_3$  (1) from left to right. The horizontal line indicates the accessible search range at a lum inosity of L = 150 pb  $^1$  and 100 signal events.




Figure 3b: M ass dependence of the m inim al integrated pair production cross section for the vector leptoquarks ref. [1] at  $^p$   $\bar{s}=190\,\text{GeV}$ . The lines correspond to the production cross sections for the states  $U_1$   $(U_3(0)); \hat{\nabla}_2(1=2); \hat{\nabla}_2(1=2); V_2(1=2); V_2(1=2); U_3(1); \hat{\nabla}_1)$  and  $U_3(1)$  from left to right. The horizontal line indicates the accessible search range at a lum inosity of  $L=500\,\text{pb}^{-1}$  and  $100\,\text{signal-events}$ .




Figure 3c: M ass dependence of the m inimal integrated pair production cross section for the vector leptoquarks ref. [1] at  $^p$   $\bar{s}=1$  TeV. The lines correspond to the production cross sections for the states  $U_1$  ( $U_3$  (0));  $^p$ \_2 (1=2);  $^p$ \_2 ( 1=2) ( $^p$ \_2 ( 1=2));  $U_3$  ( 1) ( $^p$ \_2 (1=2));  $U_3$  (1) from left to right. The horizontal line indicates the accessible search range at a lum inosity of L = 10 fb  $^1$  and 100 signal events.
