Im plications of anom alous gauge boson interactions to the ferm ion electrom agnetic m om ents

A bstract

We calculate the electrom agnetic form—factors of the ferm ions induced by the anomalous gauge boson interactions contained in the operators O_{DW}^0 and O_{DB} . The interplay between vertex corrections and gauge boson self-energies is studied in order to separate the non-universal form—factors. We apply the same procedure to reannalize previous results regarding other anomalous gauge boson interactions.

1 Introduction

So far, the standard theory of electroweak interactions is consistent with all the available experimental results. The secret of this success seems to lie in its gauge symmetry structure, based on the SU (2)xU (1) group and served by a Higgs breaking m echanism into U $(1)_{OED}$. Gauge invariance assures renormalizability, a crucial condition to evaluate and predict higher order corrections, and implies another fundam ental feature concerning the nature of gauge bosons self-interactions. Unlike the couplings to the matter elds, which require additional assumptions about the representations of matter (unless som e other principle is postulated 1), the couplings between gauge bosons are completely determined by local gauge invariance. However, no direct precise determ ination of the W; Z; self-couplings has been possible so far. The nding or elimination of anomalous boson self-interactions will reveal unknown high energy scale dynamics or con m the very nature of the weak bosons, as that of the photon is already established. So, a great part of the signi cance of a machine like LEP2 lies in the possibility of directly measuring couplings such as W W Z and W W . That is well known and has been studied by many authors [2, 3, 4, 5, 6].

One may also book at indirect low-energy e ects. A lot of work has been done focusing either on oblique corrections to 4-ferm ion amplitudes [7, 4, 8, 5] or on radiative corrections to the ferm ion-gauge boson couplings [9, 10, 11, 12, 13, 4]. Here, we are particularly interested in non-standard one-loop corrections to the electrom agnetic moments of the ferm ions induced by anomalous WW interactions. Previous works on that matter were based in one elective Lagrangian [3] that is the most general with up to 6-dimensional tri-linear operators if the gauge elds are restricted to be transverse (@W = 0 = @Z). That condition is satisted if the gauge bosons are on-shell or coupled to massless fermions but is not necessarily true otherwise and therefore, there is a potential lack of generality in that mentioned elective Lagrangian. Indeed, we identified [14] a lot of independent couplings that vanish for transverse bosons but not for the spin zero degrees of freedom, the single constraint being electromagnetic gauge invariance.

Since however, the standard model gauge group has proven to be a good sym-

metry, even if in a hidden form, up to scales as high as M $_{\rm Z}$, it is not so natural to expect non-invariant interactions at the scale of New Physics which is itself above the very Ferm i scale of weak symmetry breaking. Moreover, as emphasised by De Rujula et. al. [4], non-invariant operators produce divergent radiative corrections which, cut-o at the scale , give rise to deviations from the predictions of the Standard Model such as the M $_{\rm W}$ M $_{\rm Z}$ G relation, which no longer decouple in the limit ! 1 even if originated from 6-dimensional operators suppressed by 1= 2 . The anomalous interactions should then arise from an elective Lagrangian manifestly invariant under local SU (2)xU (1).

In the so-called linear realization, one includes also operators with the standard Higgs iso-doublet. A complete set of independent dimension-6 operators was identi ed by Buchmuller and Wyler [15]. Among the P and CP even operators, only seven generate gauge boson interactions: O $_{;1}$, O $_{\text{BW}}$, O $_{\text{DW}}$, O $_{\text{DB}}$ m odify the 2-point G reen functions at tree-level and O_{BW} ; O_{DW} ; O_{B} ; O_{W} ; O_{WWW} , give rise to triple gauge boson couplings. In all cases except one, the W W couplings reduce to the U (1)-invariant interactions usually cast [3] in a phenom enologic Lagrangian parametrized with k and (eq. (14) below). Their one-loop e ects on the ferm ion electrom agnetic couplings have been calculated. The exception is the operator 0_{DW} as it yields interactions that are not electrom agnetic gauge invariant by them selves but are rather undissociable from anomalous kinetic terms. That constitutes the primary motivation to study the one-loop corrections due to O_{DW} (in fact O $_{D\ W}^{0}$, a linear combination of O $_{D\ W}$ and O $_{W\ W}$) and in particular to determ ine whether or not it produces ferm ion magnetic moments that could be used to set lim its on the anom alous gauge boson interactions. We also do the calculations for the operator $O_{D\,B}$ in view of its sim ilarity with $O_{D\,W}$.

In section 2 we derive the results of the one-loop Feynm an diagram s. In section 3 we study the interplay between vertex corrections and gauge boson polarization functions including their longitudinal projections. It is then shown how to extract the non-universal electrom agnetic couplings. The same procedure is used to reannalize and brie y overview in section 4 previous results on the electrom agnetic form—factors induced by triple gauge boson interactions.

O_{DW}^{0} and O_{DB} radiative e ects

The e ective Lagrangian is a linear combination of SU (2)xU (1) invariant operators,

that are functions of the H iggs covariant derivatives and gauge eld strength tensors, denoted as (notation of refs. [5, 8]),

In addition to quadratic term s, O $_{\rm D~W}~$ includes also trilinear couplings, but part of them are already present in O $_{\rm W~W~W}~=~{\rm Tr~W}^{\hat{}}~{\rm W}^{\hat{}}~{\rm W}^{\hat{}}~{\rm W}^{\hat{}}~{\rm as~follow~s~from~the~identity}$

G iven the fact that O_{DW}^0 not only contains all the quadratic terms of O_{DW} and, just like O_{DB} and unlike O_{DW} , is directly related through the equations of motion to the matter currents,

we choose to replace O_{DW} by $O_{DW}^{\,0}$ in the set of linearly independent operators. The relation between the coupling constants in this basis ($O_{DW}^{\,0}$, O_{WWW}) and in the basis (O_{DW} , O_{WWW}) is straightforward: $f_{DW}^{\,0} = 2 \, f_{DW}$; $f_{WWW}^{\,0} = f_{WWW} = 4 \, f_{DW}$.

O $_{D\ B}$ and O $_{D\ W}^{\ 0}$ generate the following two-point G reen functions (f $_{D\ B}^{\ 0}$ = $2\ f_{D\ B}$):

for the charged W s and

For special processes like W pair production at LEP2 this interaction is not independent from the ones that have been considered so far [3, 5, 6] assembled in the phenomenologic Lagrangian

Indeed, it reduces for transverse bosons (@ $W^a = 0$) to a simple form -factor of the standard model vertex:

However, when considering one-loop e ects neither the running with the momenta nor the longitudinal degrees of freedom can be discarded in advance. In addition, as will be seen below, that interaction is not electromagnetic gauge invariant per se (unlike the ones of eq. (14)) but only when associated with certain W kinetic terms. This was the primary motivation to study its one-loop e ects.

The standard model W W coupling is just ie $_0$ in the R gauge but we used the Fu jikawa gauge—xing condition [16] for the W eld namely,

It elim inates the trilinear coupling of the photon with the W and G oldstone boson $^+$ and in addition, shifts the standard model W W coupling to:

The advantage of such W covariant gauge lies in that this W W coupling and the W full propagator obey a W and identity:

Then, since the O $_{\rm D\,W}^{\rm 0}$ coupling and self-energy satisfy a sim ilar identity,

one obtains an automatic Ward-Takahashi identity for the one-loop ferm ion vertex. Note that the last equation just proves the point that the above anomalous WW interaction is not electromagnetic gauge invariant by itself and therefore, cannot be reduced to the couplings of the phenomenologic Lagrangian of eq. (14).

We calculated the one-loop corrections to the ff vertices (once for all denoted as i) using dimensional regularization. There are two kinds of diagrams: the ones where the photon couples to the ferm ion line and the internal gauge bosons carry anom alous self-energies and the ones where the photon couples to the charged W (only in the case of O_{DW}^{0}) either with anom alous W W coupling or with the standard one plus anom alous W self-energy. Keeping only the divergent terms, we obtained for a on-shell ferm ion with charge Q and isospin

Here, J is the integral in momentum space

where the right-hand side is the result of a cut-o regularization, the cut-o scale naturally identied with the scale of New Physics. The $_{\rm W}$ dependence of the results is not surprising given the interplay between vertex and vacuum polarization functions already present in the standard model.

3 The physical electrom agnetic couplings

It is well known that in non-abelian theories the radiative corrections to the ferm ion-gauge boson couplings are not gauge-invariant per sineither are the gauge boson self-energies. Gauge invariant quantities are obtained as certain combinations of vacuum polarization and universal vertex functions. In the case of the standard model, some of the non-trivial features can be reduced to simple corrections of gand g⁰ propagated to all gauge boson couplings and masses [17]; when considering anomalous gauge boson couplings one also not additional mixing between W³ and B in the fermion vertices [8]. We present here an extension suitable for massive fermions covering the interplay between the longitudinal parts of the boson propagators and the anapole type of vertex.

In a 4-ferm ion amplitude at one-loop level, there are vacuum polarization diagrams and corrections to the vertices, the latter denoted as i_a for each boson a = ;Z;W. It is convenient to separate the gauge boson propagators and self-energies in their transverse and longitudinal components:

By looking at the dependence of the amplitudes on the ferm ion quantum numbers, one comes to the conclusion that a certain kind of one-loop vertices give the same results as the vacuum polarization diagrams. In the case of neutral currents, the most general form of these universal couplings is:

O f course, one could write the universal couplings in term s of Q and T_3 as well, but the above formulation m akes it particularly easy to show that the sum of vertex and

vacuum polarization diagrams remains invariant if one replaces the self-energies and couplings with:

In this way one can obtain gauge-invariant quantities².

We do not the electrom agnetic eld as the one that couples universally with the electric charge exclusively and obeys the M axwell equations of motion which implies a zero photon mass and a dynamical decoupling from the Z^0 eld. The rst condition is realized by the cancellation of the universal part of proportional to q_z by the z and Az terms. Hence, the remaining universal component of the electrom agnetic coupling reduces to a running electric charge unit $e(k^2)$:

The second condition is realized by chosing the functions ab so as to annihilate the real part of the renormalized polarization functions:

As a result, the renormalized transverse inverse propagator is just given by

where = stands for the imaginary part: the Z decoupling is manifest. Finally, A , A $_{\rm Z}$ and the longitudinal polarization functions , $_{\rm Z}$ are immaterial for on-shell ferm ion amplitudes, as they give contributions proportional to the operator qk & that vanishes in that case.

When these expressions are substituted in eq. (32) one obtains for the neutral current amplitudes what is called improved B om approximation [17, 18]: it means that the sum of the amplitudes with boson self-energies and vertex radiative corrections is written with expressions where the gauge boson propagators are the free particle propagators (except for imaginary parts, see eq. (35)) and the radiative corrections are collected in the new gauge-invariant vertices given by eq. (32). They contain both avour dependent and universal form-factors. The latter, once added to the tree-level vertices, can be expressed as running coupling constants. The boson self-energies contribute only to the universal vertices as follows: contributes to the running electric charge unit and zz; to the running one cients of T 3 and Q, in the Z 0 coupling (eq. (29)).

In what regards the e ects induced by O_{DW}^{0} and O_{DB} it is not dicult to isolate from eqs. (22, 23) the avour dependent electrom agnetic coupling as

This expression is clearly gauge independent and does not receive contributions from the boson self-energies. The remaining terms can be put in the form of eq. (28) and have to be summed to the universal contributions arising from the boson self-energies as explained before. As far as the electrom agnetic interaction is concerned the overall result is a running QED but such kind of contribution already appears in the tree-level self-energy specied by eq. (11) yielding

This is certainly the leading term of the universal electrom agnetic coupling and for that reason is not worth to calculate the one-loop boson self-energies. Furtherm ore,

that and other oblique corrections have been annalized by several authors [4, 7, 8, 5] and will not be further studied here. Our primary interest were the non-universal avour dependent electrom agnetic form—factors. The result shown in eq. (39) contains no magnetic moment term and comprises a charge radius (CR) and one anapole moment (AM) whose values depend on the charge and isospin quantum numbers of each particle. But, since they are proportional to the electric charge both vanish in the neutrino case.

In processes at very low energies, the CR and AM contributions are not dynam ically di erent from other local interactions such as the ones mediated by Z $^{\circ}$. That fact gives the opportunity for adopting di erent de nitions of CR and AM. A lthough such a discussion is out of the scope of this work, we just add that within the presentation given in this section, the CR and AM arise as the local interaction couplings that survive in four ferm ion amplitudes if the source of the electrom agnetic and Z $^{\circ}$ elds has a zero q_z charge (eq. (29)). That is approximately true if the source (target) is a medium made of unpolarized electrons and/or protons. But in the work of Gongora and Stuart [19] for instance, the CR and AM are the couplings that survive if the source has a zero t_3 isospin component. One should keep in mind however, that what matters is the total amplitude which may comprise other local interaction contributions such as box diagrams, or even charged current interactions in the case of elastic scattering. A ctually, both of them are produced by the operators O_{DM}° , O_{DB} at one-loop level.

4 Overview and conclusions

Boudjem a et. al. [11] calculated (in the unitary gauge) the ferm ion form-factors generated radiatively by the anom alous W W interactions specified by the Lagrangian of eq. (14). We are now in position to recognize that the couplings they obtained are just the universal kind of vertices with only one exception. Keeping only the divergent term s, one has for a ferm ion with mass m and isospin $t_3 = 1=2$:

It is clear that the a term is a particular case of the universal interactions identied in eq. (28).

M ore recently, Hagiwara et.al. [8] calculated the one-loop ferm ion gauge couplings arising from the SU (2)xU (1) invariant operators O_{WWW} ; O_{W} ; O_{B} . They restricted to the chiral conserving vector and axial-vector form-factors in the limit of zero ferm ion masses and found that O_{B} does not contribute and only O_{WWW} corrects the electromagnetic coupling. For a nite ferm ion mass the result is

In view of the relations [8] between the parameters of the phenomenologic and elective Lagrangians (eqs. (1, 14)) namely,

there is agreement in the $f_{W\ W\ W}$ case (the WW operators are exactly the same), but the two results seem in conject in what regards the charge radius and anapole moment proportional to k. That is not necessarily true because those are just the kind of universal couplings (eq. (28)) not expected to be independent

from the gauge-xing condition. Boudjem a et. al. worked in the unitary gauge and did not calculate the vacuum polarization functions whereas the 't-Hooft-Feynm an gauge was used in ref. [8].

In conclusion, the non-universal electrom agnetic form -factors contained in eqs. (42, 45) reduce just to a magnetic moment whose value is only signi cant (cf. eq. (44)), given the available experimental data, in the case of the muon. The associated coupling proportional to k is produced either in the operators O_W and O_B or in O_{BW} [4,8]. In turn, the operator O_{WWW} only yields oblique corrections that simply renormalize the coecients of O $_{\rm D\,W}^{0}$ and O $_{\rm D\,B}$ [8]. The analysis of the low energy constraints on the oblique corrections perform ed by Hagiwara et. al. [8] and updated in [5] gives upper lim its of the order of 2 and 40 to the absolute values of $f_{\text{DW}}^{\,0}$ and $f_{\text{DB}}^{\,0}$ respectively for a scale $\,$ = 1 TeV . The operators O $_{\text{DW}}^{\,0}$;O $_{\text{DB}}$ do induce avour dependent charge radius and anapole moments (eq. (39)) but not a magnetic moment. Therefore, although their quantum number structure is di erent from the tree-level oblique corrections, the magnitude is further suppressed by a factor =e of the order of 10 4 and cannot be used to give new limits on the anom alous interactions. Finally, some anom alous W W interactions also have e ects on the avour changing b! s transition [12, 13], but we checked that this is not the case of O_{DW}^{0} and O_{DB} .
