T-Violation in K⁺! ⁺ Decay And Supersymmetry

Abstract

M easurem ent of the transverse m uon polarization P[?] in the K⁺ ! ⁺ decay will be attempted for the st time at the ongoing KEK E246 experim ent and also at a proposed BNL experiment. We provide a general analysis of how P[?] is sensitive to the physical CP -violating phases in new physics induced four-Ferm i interactions, and then we calculate the dom inant contributions to P[?] from squark fam ily mixings in generic supersymmetric models. Estimates of the upper bounds on P[?] are also given. It is found that a supersymmetry-induced right-handed quark current from W boson exchange gives an upper limit on P[?] as large as a few per cent, whereas with charged-Higgs-exchange induced pseudoscalar interaction, P[?] is no larger than a few tenths of a per cent. Possible correlations between the muon polarization measurements in K⁺! ⁺ and K⁺! ⁰ ⁺ decays are discussed, and distinctive patterns of this correlation from squark fam ily-mixings and from the three-Higgs-doublet model are noted.

The on-going KEK E246 experiment [1] and a recently proposed BNL experiment [2] are both devoted to testing T-violation to a high precision in the K⁺ ! (K_{3}^{+}) decay by measuring the transverse muon polarization $P^{?()} = s$ (p p)=p p j where p and p are the momenta of the pion and muon in the kaon rest frame and s is the muon spin vector. The combined previous measurements [3] at the BNL-AGS constrained the muon polarization to be P⁽⁾ = (1:85 3:60) 10³, and this puts an upper limit of P? () j < 0.9% at the 95% con dence level. The standard model (SM) CP-violating contribution to P? is vanishingly small [4], and the nal state interaction (FSI) e ect is found to be of order 10 6 [5]. Therefore, if an e ect is detected at the 10 3 level or 10 4 level which the KEK experim ent and the proposed BNL experim ent are respectively sensitive to, it will be an unm istakable signature for new physics. It has been estimated [6] that P? () 10³ in the three-H iggs-doublet m odel [7]. M ore recently, we noted can be as large as that [8] large squark-fam ily-m ixings in supersymmetry (SUSY) could contribute to P?() at the level of 10 3 , which is three orders of m agnitude larger than that in the absence of squark-fam ily-m ixings [9].

The transverse muon polarization, denoted by P[?] and de ned as above with p substituted by the photon momentum p, will also be measured in the radiative decay mode $K^+ ! + (K_2)$ both at KEK [1] and at BNL [2]. Here the FSIe ect is expected to be large [10], and it could be on the order of 10³ [11]. Being electrom agnetic in nature, this e ect can be accurately computed and subtracted out. The more interesting standard model CP-violating contribution to P[?] arising from the K obayashiM askawa (KM) phase [12] is again negligible. The e ect of a CP-violating tensor interaction on the muon polarization was considered in Ref. [13]; and the contribution to P[?] from an electrice pseudoscalar four-Ferm i operator in the three H iggs-doublet model (3HDM) has recently been discussed [14]. In this work, we provide a more general analysis of the muon polarization in the K $_2$ decay by including the complete electrice four-Ferm i interactions induced from spin-zero

and spin-one boson exchange. Then we concentrate on supersymmetric theories with large squark-generational-mixings where dramatic enhancement e ects due to the third family heavy quark masses could give rise to a large $P^{?}$. Details of this will be given in a later section where SUSY e ects are examined.

The outline of the paper is as follows. The fram ework is laid out in section II for computing P[?] in K₂ decay in terms of generale ective four-Ferm i interactions. In section III, we focus on the elects of large squark-family-mixings which are allowed in fairly general SUSY models. Possible correlations of the muon polarization in K₃ and K₂ decays are then discussed, and an interesting comparison with multi-Higgs type models is made. The conclusions are presented in section IV.

II.GENERAL FRAM EW ORK

Consider the radiative K⁺₂ decay

where p, q, l and p denote the m om enta of the kaon, photon, m uon, and neutrino respectively. The SM amplitude for this decay consists of two separately gauge invariant pieces: the inner brem sstrahlung (IB) piece with the photon radiated o the external m uon or kaon line, and the structure-dependent (SD) piece for which the photon is em itted from the effective K vertex via some intermediate states. The total amplitude can be written as [15,16],

where G_F is the Ferm i constant, sin $_c = 0.22$ is the Cabibbo mixing, m and m_K are the masses of the muon and the kaon, is the photon polarization vector, f_K is the well determined kaon decay constant, and F_A and F_V are the axial-vector and vector form factors associated with the radiative decay. The kaon decay constant and the two form factors are defined by

where $f_K = 160 \text{ MeV}$, F_A and F_V are functions of $(p - q)^2$, J_{em} is the electrom agnetic current, and $_{0123} = 1$.

Ideally one would like to be able to extract separately F_V and F_A from experimental data. However, the accuracy of current data does not permit us to do so. On the other hand, various models [17] have been used to calculate the form factors. In chiral perturbation theory at the one-loop level, F_V and F_A are found to be real and are given by [16]

The momentum dependence of F_V and F_A shows up only at two loops in chiral perturbation theory. Furthermore in the SM, the KM phase will enter the form factors at the two-loop level and hence can be ignored. The above estimate will be used in our analysis of the muon polarization. A swill be shown later, contributions to the K⁺! ⁺ decay from physics beyond the SM can be parameterized by three dimensionless quantities, $_{IB}$, $_{A}$ and $_{V}$, to be associated with f_{K} , F_{A} , and F_{V} respectively. The new amplitude is obtained from Eqs. (2)– (7) by the following replacements:

The three parameters are in general complex, and could contribute to the T-odd transverse muon polarization P $^{\rm 2}$.

The transverse polarization of the muon in K $^+$! $^+$ decay is de ned as

where s is the spin vector of the muon, and p and p are the three-momenta of the photon and muon. A non-zero P[?] arises from the interference between the M _{IB} and M _{SD} amplitudes. A fter a general kinem atic analysis, we can express P[?] in the K⁺ rest frame as the sum of an IB $+_{V}$ interference piece and an IB $+_{A}$ interference piece. Explicitly,

where x = 2p $q = \hat{p} = 2E = m_{K}$ and y = 2p $l = \hat{p} = 2E = m_{K}$ are the normalized energies of the photon and the muon respectively. The functions v(x;y) and A(x;y) are given by

where $r = m^2 = m_K^2$, $f_V(x;y)$ and $f_A(x;y)$ are to be de ned later, and $(x;y) / \frac{d(K^+)}{dxdy}$ is the norm alized D alitz density consisting of the IB piece IB (x;y), the SD piece SD (x;y), and the interference term INT (x;y),

The next step in the analysis is to compute the parameters in Eqs. (12)-(14) in terms of parameters describing the new physics. It is reasonable to assume that at the energies we are considering, new physics can be described by general four-Ferm i operators of the form (neglecting possible tensor interactions),

where G_S , G_P , G_V and G_A parameterize the non-standard model interactions due to scalar, pseudoscalar, vector and axial-vector boson exchange respectively. In some models, elective right-handed neutrino-muon current can be constructed. Since the SM leptonic chargedcurrent is left-handed, its interference with such a right-handed current will be suppressed by the neutrino mass and will have a negligible contribution to P[?]. Therefore only lefthanded neutrinos need to be considered.

The contributions of the G_S and G_P operators are recently discussed by K obayashi et. al. [14] in the context of the three-H iggs-doublet m odel, where tree-level charged H iggs exchange is su cient to give rise to T violation. The relevant hadronic matrix elements involving the scalar current can be related to f_K via [14]

It is immediately seen that the elective scalar interaction (the G_S operator) does not a lect the K $_2$ decay rate as their hadronic matrix elements vanish by parity. On the other hand from Eqs. (24) and (25), the contribution of the G_P operator to the decay amplitude is seen to be non-vanishing and it has the same structure as M $_{\rm IB}$ of Eq. (3),

This amounts to a contribution to the parameter $_{\rm IB}$ only,

and the other two parameters, $_{\rm V}$ and $_{\rm A}$, remain zero.

The e ective vector and axial-vector four-Ferm i interactions give rise to corrections to the V A structure of the SM quark current. They can be analyzed by using the corresponding hadronic matrix elements given by Eqs. (8)–(10). The G $_{\rm V}$ operator contributes only to $_{\rm V}$,

As can be seen from Eqs. (16)–(18) and Eqs. (31)–(33), P[?] in the K⁺ ! ⁺ decay could receive contributions from the G_P , G_V and G_A e ective interactions of Eq. (23). By comparison, P^{?()} in the K⁺ ! ⁰ ⁺ decay is only sensitive to the G_S interaction [18]. These two decay modes are therefore complementary in searching for new physics e ects. As one would expect, if physics beyond the SM has only left-handed quark current, it will not contribute to P[?]. This can be seen explicitly from Eqs. (31)–(33). For a left-handed quark current ($G_V = G_A$ and $G_P = G_S = 0$), $_{IB} = _A = _V$, and therefore no relative phase exists between M $_{IB}$ and M $_{SD}$. However, a right-handed quark current as in left-right symmetric models will in general have an e lect on P[?], and the size of the muon polarization would be model dependent. Signatures of the elective four-Ferm i interactions of Eq. (23) for the muon polarization in the K $_2$ decay are summarized in Table I.

The success of the SM dictates that the magnitudes of the parameters of Eqs. (31)-(33) are much sm aller than one. We can therefore simplify the form ula for P[?] by neglecting terms quadratic in the 's and by considering only the relevant $G_{\,P}\,$ and $G_{\,R}\,$ interactions given by

Combining Eqs. (16)–(18) and (31)–(33), the muon transverse polarization can be rewritten as a sum of the G_P interaction contribution $P_{\mu}^{2}(\mathbf{x};\mathbf{y})$ and the G_R interaction contribution $P_{\mu}^{2}(\mathbf{x};\mathbf{y})$,

The contour plots of (x;y), (x;y), $_{v}(x;y)$, and $_{A}(x;y)$ are given in Fig.1. The infrared sensitivity of the K $_{2}$ decay rate manifests itself in the Dalitz plot (x;y) in the soft photon (i.e. small x) region.

D ue to the experim ental necessity of cutting out low energy photons, it is more useful to de ne the quantity $\overline{P^2}$ by

which is the average of $P^{?}(x;y)$ over a region of phase space S. In this de nition, the numerator measures the dimension number in the region S between muons pointing their spin vector along the direction p p and those along the opposite direction, and the

denom inator is a measure of the total number of muons in the region S. In terms of the ective four-Ferm i interactions, the average muon polarization is given by

P bts of the averaged $\overline{}$, $\overline{}_{V}$ and $\overline{}_{A}$ as a function of the energy cut on soft photons are given in Fig.2. The typical size of $\overline{}$ and $\overline{}_{V}$ for the K $^{+}_{2}$ decay can be seen to be of order 0:1, and it is a kinematic measure of the relative strength of the M $_{IB}$ $-M_{SD}$ interference and the IB plus SD contributions to the partial width. The corresponding values for the radiative decays of $^{+}$! $^{+}$ ($_{2}$) and K $^{+}$! e^{+} (K $_{e2}$) are expected to be roughly two orders of magnitude smaller than for K $_{2}$ decay because of the dom inance of the IB and SD contributions respectively. And this makes it di cult to measure the transverse lepton polarization in the $_{2}$ and K $_{e2}$ modes.

III.SUSY EFFECTS

In the m inim al supersymmetric standard model (MSSM, by this we mean with m inim al particle content and with R-parity conservation), T-violation in K⁺! ⁺ decay arises from the interference between the SM tree amplitude and the one-loop MSSM amplitude. Naively, this would be suppressed at least by $_{\rm S}$ = ($_{\rm S}$ is the QCD coupling) relative to the tree level interference e ect as in the three H iggs-doublet model [14], and would be too sm all to be seen. However, this would not be the case when the squark fam ily m ixings are taken into account. Then T-violation in K $_2$ decay could be sensitive to the top and bottom quarks of the third fam ily, and large enhancement e ects due to the heavy quark m asses could appear [8]. This scenario will be the focus of our attention in the discussion of the SUSY contributions to the muon polarization.

The notion of squark family mixings comes from the general assumption that the mass matrices of the quarks and squarks are diagonalized by di erent unitary transformations in generation space [19]. In principle, these mixing matrices could all be determined in speci c models. In the lack of a generally accepted SUSY avor model, we adopt a model-independent approach and refer interested readers to the literature for discussions of speci c models [20,21]. The relative rotations in generation space between the u_L , u_R , d_L , and d_R squarks and their corresponding quark partners are denoted by V^{U_L} , V^{U_R} , V^{D_L} , and V^{D_R} respectively. These matrices appear in the quark-squark-gluino couplings which lead to new contributions to avor-changing neutral current processes (FCNC) [19]. M eanwhile, these generationalmixing matrices give rise to the interesting possibility that the heavy fermions of the third family may play an important role in low energy processes, including the neutron electric dipole moment [22].

A s FCNC processes occur only at loop level in both the SM and the M SSM, severe constraints on the squark fam ily m ixings can be derived [19] based on available experimental data. For charged-current (CC) processes on the other hand, the SM contributions offen appear at tree level whereas e ects of squark fam ily m ixings arise only at loop-level, and current data in the hadronic sector are not precise enough to put useful bounds on the squark m ixing m atrices. The FCNC constraints can be written in the form of upper lim its either on product of di erent V^D 's, as from K K and B B system s and from b! s, or on product of di erent V^U 's, as from D D m ixing. W ithout assumptions on orm odel preference for these m ixing m atrices, the individual matrix element can however still be of order one.

Charged-current processes involve the product of V^U and V^D , and the size of both m ixing matrix elements can be of order one without violating the FCNC bounds. Because of the large top Yukawa coupling, sizable squark m ixings with the third generation could then lead to large enhancement e ects in low energy charged-current processes. A lthough this bop-level enhancement m ay not have signing cantelle ects on CP-conserving, tree-level CC processes, it could have dramatic consequences for CP-violating CC processes for which the standard model elements are negligible. This possibility has recently been discussed in the context of T violation in charged meson sem ileptonic decays [8]. In this work, we would like

to extend the analysis to the transverse muon polarization in the radiative K $_2$ decay.

The physical phases that are relevant for the transverse m uon polarization could come from both the squark m ixing m atrices and other soft SU SY breaking operators including the A term s and the gaugino m ass term s. For the sake of sim plicity and a clearer illustration of the underlying physics, we concentrate on the phases in the squark m ixing m atrices. M assinsertion approximation will be used for the $t_L \{t_R \text{ and } B_L \{B_R \text{ m ixings, and } m_{t_L} = m_{t_R} = m_t$ and $m_{B_L} = m_{B_R} = m_B$ will be assumed for the m ass parameters of the left and right top and bottom squarks. With large generational squark m ixings, the dominating contributions to P[?] are expected to come from the G_P and G_R four-Ferm i operators induced by the t-B-g loop diagram s with W boson and charged Higgs boson exchange. The muon polarization will then be directly proportional to $\mathbf{\hat{y}}_{31}^{U_{L,R}} \mathbf{V}_{32}^{D_{L,R}}$ j.

A.W Exchange

An elective right-handed current interaction $W = \overline{S_R} - u_R$ can be generated by the diagram with g-t-b sparticles in the loop and with $t_L \{t_R \text{ and } b_L \{B_R \text{ mass insertions (see Fig. 3(a))}.$ This gives rise to an elective G_R interaction,

where $_{s}$ ' 0:1 is the QCD coupling evaluated at the mass scale of the sparticles in the loop, A_t and A_b are the soft SUSY breaking A terms for the top and bottom squarks, denotes the two H iggs super elds mixing parameter, tan is the ratio of the two H iggs VEV s, m_g is the mass of the gluino, V^{SKM}_{ij} is the super KM matrix associated with the W -squark coupling W ⁺ w_{iL} \tilde{d}_{j_L} , and the integral function L_0 is given by

Note that $I_0 = 1$ for $\frac{m_t}{m_g} = \frac{m_b}{m_g} = 1$, but it increases rapidly to 8 as the squark-to-gluino m ass ratios decrease to $\frac{m_t}{m_g} = \frac{m_b}{m_g} = \frac{1}{2}$. For the case of $m_t = m_b$, the variation of I_0 with the m ass ratio is plotted in Fig. 4.

From Eqs. (43)-(44) and Eq. (40), the right-handed current contribution to $_{\rm R}$ is found to be

Later on, this will be used to estim ate the size of the muon polarization from W -exchange-induced G_R interaction.

An e ective pseudo-scalar four-Ferm i interaction can be induced at one-bop by invoking a $t_L \{t_R \text{ insertion (see Fig. 3(b))}.$ To linear order in the external momenta, the W -exchange diagram gives [8]

Both integrals $I_{1;2}$ are equal to one at $\frac{m_r}{m_g} = \frac{m_B}{m_g} = 1$, and both increase as $\frac{m_r}{m_g}$ and/or $\frac{m_B}{m_g}$ decreases from one. For example, $I_1 = 4$ and $I_2 = 8$ when $\frac{m_r}{m_g} = \frac{m_B}{m_g} = \frac{1}{2}$. The functions I_1 and I_2 are plotted in Fig. 4 for the case $m_r = m_B$.

Notice that the C₂ term in Eq. (47) can be rewritten as an elective scalar interaction by use of the D irac equation for the external leptons. The term $(p_s p_u)$ $(S_L u_R)$ in Eq. (47) can be G ordon decomposed into a tensor piece, a left-handed current piece, and a righthanded current piece. The tensor piece can be neglected as the tensor form factor is expected to be sm all¹. The left-handed piece, having the same structure as the standard model interaction, does not contribute to P[?] (see Table I). The relevant operators of the elective lagrangian L₂ can thus be rewritten as

where C_1 and C_2 m easure the strengths of the induced G_R and G_P interactions respectively.

It is readily seen that $_{R}j_{2}$ is suppressed relative to $_{R}j_{1}$ at least by a factor of $m_{b}=m_{s}$ 30 and will not be considered. By taking the sparticle masses to be about 100 GeV and assuming maximal squark family mixings, the size of $_{P}j_{2}$ is found to be at most of order 10⁴, and thus the contribution to the averaged transverse muon polarization is at best of order 10⁵. For these reasons, the elective Lagrangian L₂ will not be considered further.

We note in passing that a $B_L \{B_R \text{ insertion in a diagram similar to Fig. 3(b) can also induce e ective <math>G_R$ and G_P interactions analogous in form to Eqs. (52)-(54). However, R will be suppressed by $\frac{m_u m_B}{m_s m_t}$ 10⁻³ relative to that of Eq. (53), whereas the induced P can at most be comparable to that of Eq. (54) in the large tan limit when the left-right mixings in the top and bottom squarks could be of the same order of magnitude. Their contributions to the muon polarization are also negligible.

In contrast to $_{R}j_{2}$ and $_{P}j_{2}$, the magnitude of $_{R}j_{1}$ can be enhanced by a large tan . The present data constrains tan =m $_{H}$ < 0.52 GeV ¹ [23], where m $_{H}$ is the mass of the charged Higgs boson. For m $_{H}$ = 100 GeV, we can take tan = 50. The muon polarization also depends on the squark mixings $j_{32}^{D_{L}}j_{31}$ and $j_{31}^{U_{R}}j$ (taking $j_{33}^{SKM}j$ 1). As pointed out earlier, the V^U 's are constrained by D D m ixing only in the product of $V_{31}^{U_{L,R}}$ and $V_{32}^{U_{L,R}}$, and $j_{31}^{U_{R}}j$ = 0 (1) is still allowed. On the other hand, if assuming $j_{33}^{D}j$ = 0 (1), the FCNC process b! s can put a bound on $j_{32}^{D}j$ from the gluino diagram. However, other SU SY contributions to b! s , including the charged Higgs and chargino contributions [24], can dom inate over the gluino e ect and render the bound on $j_{32}^{D}j$ m eaningless. This is particularly true if the chargino is relatively light.

Recall that the integral I_0 can be of order 10 for reasonable m ass ratios of the squarks and gluinos. To estim ate the maximal size of $_R j_1$, we therefore take $I_0 = 10$, tan = 50, $A_t = A_b = jj = m_g = 100 \text{ GeV}$, and $y_{31}^{U_R} j = y_{32}^{D_R} j = \frac{p_2}{2}$ for maximal squark family mixings. Then we have for its magnitude

Depending on the soft photon energy cut, it is seen from Fig. 2 that averaging over phase space gives in the 0 0:11 range, whereas \overline{v} takes values between 0 and 0:17. For an estimate, we choose $E^{\text{cut}} = 120 \text{ MeV}$, for which \overline{v} 0:1 and $2\overline{v}$ ' 0:3. The magnitude of the average muon polarization from the W -induced e ective G_R interaction is then

By using the D irac equation and Lorentz invariance of the amplitude, it can be seen that charged H iggs exchange only gives rise to G_P but not G_R interactions. Them t-enhanced e ective four-Ferm i interaction is obtained from the diagram that contains a get b loop and the H $t_R B_L$ vertex (see Fig. 3 (c)). It is given by [8]

It should be noted that the diagram involving the H $\mathcal{E}_L \tilde{B}_R$ coupling is proportional to di erent squark mixing matrices than those appearing in Eq. (58), and that it is suppressed by m_b. To be explicit, the induced four-Ferm i operator is of the form

W ithin this region of the parameter space, the contribution to P[?] from the elective interaction of Eq. (62) can be comparable to the m_{t} -enhanced elect of Eq. (61). However, the maximal size of P[?] is not expected to be signilicantly modilied.

C.D iscussions

Several remarks concerning the e ective right-handed current contribution $_{R}j_{1}$ of Eq. (46) and the e ective pseudoscalar contribution $_{P}j_{H}$ of Eq. (60) are in order. As noted before, an e ective G_{R} operator can be induced by W boson exchange only, whereas the G_{P} interaction can arise from both the W and charged Higgs boson exchange. However, the W -induced G_{P} interaction never gives a large contribution to $P^{?}$ (see Eq. (54)). In

contrast, both the W -induced G_R operator (Eqs. (43)-(44)) and the charged H iggs induced G_P operator (Eqs. (57)-(58)) are enhanced in the large tan limit, and large contributions to the muon polarization are found to be possible.

Firstly, the enhancement e ects due to squark fam ily mixings are readily seen from Eqs. (46) and (60). W ithout squark fam ily mixings, _R will be suppressed by a factor of $\frac{m_{s}m_{u}}{m_{t}m_{b}}$ ' 10⁶ relative to the result of Eq. (46), and would make the e ective righthanded current e ect totally uninteresting. Sim ilarly, _P of Eq. (60) would be subject to a suppression factor of $\frac{m_{s}m}{m_{t}m} = \frac{m_{s}}{m_{t}}$ ' 10³ in the absence of squark avorm ixings.

Secondly, the di erent dependence of $_{R}j_{1}$ (Eq. (46)) and $_{P}j_{H}$ (Eq. (60)) on the SUSY parameters is to be noted. On one hand, $_{R}j_{1}$ involves $V_{32}^{D_{R}}$ whereas $_{P}j_{H}$ is proportional to $V_{32}^{D_{L}}$, and di erent models of avor physics could have very di erent predictions for these two squark family mixing elements. On the other hand, $_{R}j_{1}$ / $1=M_{SUSY}^{2}$ and $_{P}j_{H}$ / $1=m_{H}^{2}$. Depending on the the scales of M_{SUSY} and m_{H} , either the W exchange or charged Higgs exchange can give the leading contribution to $P^{?}$.

If however assuming $\mathbf{\hat{y}}_{32}^{D_R} \mathbf{j} = \mathbf{\hat{y}}_{32}^{D_L} \mathbf{j}$ and $M_{SUSY} = m_H$, the elective G_R and G_P operators contribute quite dimension of P^2 because of their dimension of the electron characteristic structures. As can been seen from Eqs. (44) and (58), $G_R / m_t m_b$ and $G_P / m_t m$, and therefore $G_R = G_P m_b = m$ 50. This dimension is strength is due to the fact that Yukawa couplings are proportional to the fermion masses whereas gauge interactions are not subject to light fermion mass suppression. We recall that the m_t and m_b factors in G_R come from left-right mixings in the top and bottom squark propagators. To estimate the relative contributions to P^2 from G_R and G_P , we use Eqs. (36) and (37),

where the value $\frac{2}{V} = 3$ has been used, $I_0 = 1$ 10 (see Fig. 4), and we have assumed the same magnitude for the phases of G_R and G_P . This ratio estimate is not sensitive to the value oftan , and for $I_0 = 10$ it agrees with our more detailed calculations of Eqs. (56) and

(61).

O ur third rem ark concerns the loop suppression factor $_{s}$ = and the enhancement e ects due to heavy quarks. For this purpose, it is interesting to compare the SUSY loop contribution and the tree level contribution in the three H iggs doublet m odel (3HDM) [14]. A ssum ing m axim all squark family m ixings and neglecting factors associated with ratios of the H iggs VEV s, we have for SUSY charged H iggs exchange

where $P_{3HDM}^{?}$ is them uon polarization in the 3HDM, and where the prefactor of $\frac{1}{5}$ com as from Eq. (65) and it accounts for the di erence in the hadronic matrix elements and kinematic factors between the G_P and G_R interactions. Note that $\frac{P_{R}^{?}}{P_{3HDM}^{?}} / \frac{m_{H}^{2}}{M_{SUSY}^{2}}$, and this ratio can be suppressed if the SUSY breaking scale is much higher than the charged Higgs mass. Therefore in the presence of large squark generationalm ixings, the heavy quark enhancement e ects can overcome the loop suppression and the SUSY contribution to P? could be larger than the 3HDM tree-level contribution by one or two orders of magnitude.

The fourth and nal remark concerns possible correlations of the muon polarization between the K $_3$ decay and the K $_2$ decay.

We ist consider charged Higgs exchange e ects. For both K₃ and K₂ decays, the dom inant contribution to the muon polarization could come respectively from the scalar and pseudoscalar components of the m_t-enhanced e ective operator of Eq. (57). It is therefore expected that charged Higgs contribution to the muon polarization is comparable for both decays, as con im ed by the explicit calculations of Eq. (61) for the K₂ decay and of Ref. [8] for the K₃ decay. Since $G_S = G_P$ from Eq. (57), it is found that the average muon polarization in K₃ decay is about a factor of 2 bigger than in K₂ decay, but with opposite

sign ². It is interesting to compare our results with the analysis by K obayashi et. al. [14] in the 3HDM . Since the charged H iggs coupling to light quarks is suppressed by the quark m asses, the dom inating four-ferm ion operator arising from tree level charged H iggs exchange in the 3HDM is expected to be of the form $(\bar{s}_R u_L) (\Gamma_L R)$. Therefore, $G_S = G_P$ in the 3HDM and the muon polarization has the same sign for K 3 and K 2 decays. This sign di erence is useful for distinguishing between the 3HDM and the SUSY-induced interaction in Eq. (57).

If however, the W -exchange-induced G_R interaction dominates over the charged Higgs-induced G_P (and G_S) interaction as we have argued on general grounds, $P^{?}$ in K $_2$ decay can be much larger than $P^{?()}$ in K $_3$ decay. In this case, di erent squark mixing matrices are involved in these two decays and the relative sign of the muon polarization can not be predicted. Such a large di erence in the magnitude of the muon polarization between the K $_2$ and K $_3$ decays is a special feature of squark-fam ily mixing and does not occur in the 3HDM.

$\ensuremath{\texttt{IV}}$. C O N C LU S IO N

As discussed before, the transverse muon polarization $P^{?()}$ in the $K^+ ! ^{0} + (K_3)$ decay is sensitive to an elective scalar interaction, whereas $P^{?}$ in the $K^+ ! ^{+}$ (K_2) decay can receive contributions from elective pseudoscalar, vector, and axial-vector four-Ferm i interactions. Due to the V-A nature of the standard model charged-current, only pseudoscalar (G_P) and right-handed current (G_R) interactions of Eq. (34) contribute to $P^{?}$ in the K $_2$ decay. These two decays are therefore complimentary in searching for

²N ote that when tan is as large as $m_t = m_b$, the charged-H iggs-exchange induced operator of Eq. (62) could be as important as the m_t -enhanced operator of Eq. (57). This interaction gives $G_s = G_P$, and contributes to the muon polarization in K₃ and K₂ decays with the same sign.

new sources of CP violation.

Generally speaking, GP is suppressed by light ferm ion masses. In our SUSY calculation, G_P is proportional to m . And G_R , being induced by W boson exchange only, is not subject to light ferm ion mass suppression. The relative enhancement factor $G_R = G_P$ $m_{b}=m$ can cause the dominance of a G_{R} interaction over a G_{P} interaction if the relevant mass scales and phases are of similar magnitude. This could turn out to be one advantage for measuring the muon polarization in K $^+$! + decay over that in K^+ ! ⁰ ⁺ decay, as P^{?()} in the K₃ decay is expected to be comparable in size to the charged Higgs contribution to P? in the K 2 decay. For example, we take an optim istic value of $\mathcal{Y}_{31}^{U_R} V_{32}^{D_{L,R}} j = 1=2$ for the squark family mixings and assume tan = 50 and a mass scale of 100 GeV for the charged Higgs and the gluino, the maximal e ects for the K₂ decay are P^2 j 3 10² for the W -induced G_R interaction and P^2 j 3 10³ for the charged Higgs induced G_P interaction. And these two contributions are larger by factors of m tm b=m sm u 10^6 and m t=m s 10^3 respectively than those in the absence of squark fam ily mixings. Both lim its could be accessible to the KEK E246 experiment and the proposed BNL experiment. However, the FSIe ect is possibly as large as 10^3 and needs to be subtracted out. In comparison, the three-Higgs-doublet model gives comparable contributions to the muon polarization in K $_3$ and K $_2$ decays [14], and is therefore easily distinguished from SUSY models with a dominating W -exchange induced GR interaction.

As the W -induced G_R interaction (/ $V_{32}^{D_R} V_{31}^{U_R} = M_{SUSY}^2$) and the charged-Higgs induced G_P interaction (/ $V_{32}^{D_L} V_{31}^{U_R} = m_H^2$) involve dimensional error squark mixing matrices and different mass parameters, the possibility of charged-Higgs-exchange dominance should not be discarded. For charged Higgs exchange, the m_t-enhanced elective interaction of Eq. (57) could have the largest elect on P², and it also gives $G_S = G_P$. The resulting muon polarizations in K₃ and K₂ decays are comparable in size but opposite in sign. By contrast, the dominating elect in the three-Higgs-doublet model gives $G_S = G_P$, and the muon polarizations are always comparable in size and have the same sign for the two decays [14]. Therefore, the three H iggs-doublet m odel is again distinguishable from SUSY m odels with charged H iggs exchange dom inance. However, when tan is roughly as large as $m_t = m_b$, the m_b -suppressed four-Ferm i operator of Eq. (62), which gives $G_S = G_P$, could be as in portant as the m_t -enhanced operator of Eq. (57), and the prediction of the relative sign between $P^{?()}$ in the K $_3$ decay and $P^{?}$ in the K $_2$ decay would then be lost in this particular region of the SUSY parameter space.

Unlike the K $_2$ decay for which the branching ratio is about half of a per cent, the branching ratios for the radiative D ! 1 (l = e;) and B ! 1 (l = e; ;) decays are too tiny form easuring the transverse lepton polarization P₁[?] at future -chanm and B factories. On the other hand, due to kinem atic suppressions of the interference am plitude and/or experimental technical di culties in measuring the electron polarization, other radiative pion and kaon leptonic decays including $^+$! $^+$, $^+$! e^+ , and K $^+$! e^+ , are not as suitable for studying T violation at present time. For these reasons, the radiative K $_2$ decay is unique as a probe of new sources of C P violation. We have considered large squark fam ily-m ixings in supersymmetry, and found the polarization measurement in the K $_2$ decay and charged meson sem ileptonic decays at current and future meson factories to be very valuable for probing this region of SU SY parameter space.




FIG.1. Contour plots of the normalized Dalitz density (x;y) (a), and the transverse muon polarization functions (x;y) (b), $_{V}$ (x;y) (c), and $_{A}$ (x;y) (d) in the K⁺! + decay.






FIG.2. The averaged transverse muon polarization functions vs. the soft photon energy cut E_{cut} for the K⁺ ! + process: (solid line), \overline{V} (long-dashed line), and \overline{A} (short-dashed line).




FIG.3. Supersymmetry diagrams for (a) the W -exchange induced elective G_R interaction (see Eq. (43)), (b) the W -exchange induced elective G_P interaction (see Eqs. (47) and (52)), and (c) the H⁺-exchange induced elective G_P interaction (see Eq. (57).




FIG.4. The integral functions vs. the parameter $a = \frac{m\frac{2}{r}}{m\frac{2}{g}} = \frac{m\frac{2}{p}}{m\frac{2}{g}}$ for I_0 (Eq. (45)) and I_2 (Eq. (51)) (solid line), I_1 (Eq. (50)) (long-dashed line), and I_H (Eq. (59)) (short-dashed line).
