# QCD Sum Rule for $\frac{1}{2}$ Baryons

#### Abstract

The $m$ asses of the avor octet and singlet baryons $w$ ith negative parity and spin $\frac{1}{2}$ are calculated using the QCD sum rule. We nd that the chiral sym $m$ etry breaking vacuum condensates cause the $m$ ass splltting of the positive and negative baryons. The present sum rule reproduces the observed $m$ asses of these baryons $w$ thin $10 \%$, and predicts the $m$ ass of the excited baryon w ith $\mathrm{J}^{\mathrm{P}}=\frac{1}{2}$ at $1.63 \mathrm{GeV} . \mathrm{W}$ e con m that the negative-parity state, $s$, is the ground state in the avor singlet baryon spectrum .


## 1 Introduction

T he negative parity excited states ofbaryons have been understood fairly well in the (nonrelativistic) quark $m$ odel as onequark excited states belonging to the SU (6) 70 representation [1][]. The observed spectrum tends to agree w th the prediction, although som e of the states, such as (1405), N (1535), have irregular $m$ asses and non-natural decay rates. M any re nem ents were proposed to adhieve a quantitative agreem ent.

Yet, our understanding of the hadron physics insists that the role of the chiralsym $m$ etry $m$ ust be im portant even in the baryon states. Indeed, the chiral sym $m$ etry suggests that the positive and negative parity states are paired into a parity doublet and the pair would be degenerate when the chiral sym $m$ etry is restored. Because the nonrelativistic quark $m$ odel does not observe the chiral sym m etry, a di erent approach is anticipated to understand the chiral structure of baryons, both the positive and negative parity states.
$T$ he technique of the QCD sum rule relates the hadron properties to the QCD param eters and is a powerfiul tool to extract the hadron properties from QCD, the rst principle of the strong interaction $\overline{\underline{R}} \overline{1}, \overline{2} 1]$. The Q CD sum rule for the baryon was rst proposed by Io e [ind. In the QCD sum rule a correlation function, such as $(p)=i d^{4} x e^{i p} \nprec 0 J J(x) J(0) j 0 i$, is calculated, where $J(x)$ is an interpolating eld ( $\mathbb{F}$ ) that couples to the state of the hadron in question. T he nonperturbative e ects, such as the quark condensate hqqi

[^0]and $\mathrm{h}-\mathrm{s}$ G G i, are included as the pow er corrections in the theoretical side. T he quark condensate hqqi, which is the order param eter of the chiral sym $m$ etry breaking, gives e ects of the chiralsym $m$ etry breaking to the hadron spectrum in the QCD sum rule.

In our previous paper $\left.\bar{W}_{1}\right]$, the techn ique to extract $m$ asses of negative-parity baryon in the QCD sum rule was proposed and the $m$ asses of the nucleons w ith positive and negative parity are calculated. It is im portant to separate contribution of the negative-parity baryon ( $B$ ) from that of the positiveparity baryon $\left(B_{+}\right)$, since the $\mathbb{F}$ forbaryon couples to the states of the B [if, [i] B contribution we use the \old-fashioned" correlation function de ned as

and construct sum rules in the com plex $p_{0}$-space in the rest frame $(\rho=0)$. O ur approach is suitable for investigating the $m$ ass splitting, because $B+$ and B can be treated sim ultaneously in this sum rule. In the present paper, we extend the technique to the hyperons and the avor singlet baryons s .

In Sec 2 the form ulation of our approach is explained and we see that the chiral sym $m$ etry breaking is responsible for the $m$ ass splitting of $B+$ and $B$. In Sec. 3 we present the $m$ ethod to extract the $m$ asses and to determ ine the param eters in the theoretical side. In Sec. 4 we give the num erical results for the $m$ asses of the baryons and the param eters in the theoretical side. W e also discuss the relation of the $m$ ass splltting to the chiral sym $m$ etry breaking vacuum condensate. W e show that the negative parity baryon is the low est state in the avor singlet spectrum and that the QCD sum rule predicts that the spin-parity of (1690) is $\frac{1}{2}$. A sum $m$ ary is given in Sec.5.

## 2 Form ulation

It is im portant to choose an appropriate interpolating eld (IF) in the correlation function in the QCD sum rule. The $\mathbb{F}$ should have the sam e quantum numbers as the baryon in question, so that it creates or annihilates a single particle state of the baryon from the vacuum. For the spin $\frac{1}{2}$ octet baryon two independent $\mathbb{F}$ s can be constructed $w$ thout a derivative $\left[\bar{T}_{1}\right]$. $T$ he $\mathbb{F}$ for the nucleon is, for instance, w ritten as

where a, b and c are color indiges, $C=i_{2} 0$ (standard notation) is for the charge conjugation and $t$ is a real param eter representing the $m$ ixing of two independent $\mathbb{F}$ s. If we choose $t=1$ and use the $F$ ierz transform ation, the
 $J_{N}$ w th $t=0: 8$ is appropriate for the nucleon resonance. For the baryon, we replace a d-quark by an s-quark in eq. ( (1, (2) and obtain

The $\mathbb{F}$ for the avor singlet baryon $s$ is given by the avor antisym $m$ etric com bination of the quark operators:

$T$ his $\mathbb{F}$ is unique and has no param eter such as $t$ in the octet $\mathbb{F}$.
$W$ e now explain the technique of the treating the $B$ in the QCD sum rule
 annihilate not only the positive parity baryon state, but also a single particle
 state can be reversed by multiplying i 5 , the $\mathbb{F}$ with negative parity $m$ ay be obtained as

where $\beta$ i denotes a single particle state of the negative parity baryon, is the coupling strength and $u(x)$ is the (corresponding) D irac spinor. From

Thus, $J(x)$ couples also to the negative-parity baryon. This short exercise tells us that the conventional sum rule for the ground state baryon already contains the negative parity baryon state as a part of the continuum spectrum .

O ur task is to separate the negative parity contribution properly. A ccording to the previous paper [b]l, we use the \old-fashioned" correlation function ( $\left.{ }_{1}^{\prime} 11\right)$. In the phenom enological side, if the low est energy states of $B+$ and $B$ are picked up and the rest is regarded as a continuum, the im aginary part of the \old-fashioned" correlation function is w ritten as

In this expression, the zerow idth pole approxim ation is applied. A though the resonances have signi cant widths (eg. about 150 M EV for N (1535)),
we expect that the approxim ation is valid because the $\mathbb{F} s$ for baryons are com posed of three quarks and $m$ ay not couple strongly $w$ th $q^{4} q$ states.

The di erence of the contributions of $B+$ and $B$ in eq ( ( 1 the chiral odd part. Therefore A $\left(p_{0}\right)+B\left(p_{0}\right)$ has only B + contribution and A ( $p_{0}$ ) B ( $p_{0}$ ) includes only B contribution. In this way we can separate the B contribution from the ground state baryon. M oreover we construct the sum rule in the $p_{0}$ complex plane, because the function $A\left(p_{0}\right)$ de ned in eq. ( $1,1 I_{1}^{\prime}$ ) is not an analytic function of $p^{2}$, while the functions A ( $p_{0}$ ) and B ( $p_{0}$ ) is analytic in the upper half $p_{0}$-space.

W e take the lowest $m$ ass pole and approxim ate others as a continuum whose behavior above a threshold $s_{0}$ is sam e as the theoretical side. Then we obtain sum rules for the positive- and negative-parity baryons:

where $M$ is the Borel $m$ ass and $A^{O P E}$ and $B^{O P E}$ are calculated based on QCD using the OPE at the region where $p_{0}$ is large. It should be noted that the OPE is valid for large $p_{0}$ even if $p=0$ because the singularity of the correlation function resides at the light cone [8, $\left.{ }_{6}^{-1}\right]$. T he explicit form $s$ of $A^{O P E}$ and $B^{O P E}$ are given in appendix for the avor octet and the singlet baryons up to dim ension six, $O\left(m_{s}\right)$ and $O\binom{0}{s}$. The odd higher dim ensional term $s$ in the OPE do not contribute to the sum rule after the B orel transform, since their im aginary parts are proportional to the odd rank derivatives of the delta-function w ith respect to $p_{0}$. It is easy to show that the integral van ishes after partial integration.
$N$ ote that the di erence of the sum nules for $B+$ and $B$ is the chiral odd term B $\left(p_{0}\right)$, which is proportional either to the quark condensate hqqi or to the $m$ ixed condensate hqg G qi. If the chiral sym $m$ etry is restored at high tem perature, for instance, the B ( $p_{0}$ ) term goes to zero in the chirallim it. Then the sum rules ( $(\overline{1} \overline{1} \overline{2})$ and ( $1 \overline{1} \overline{1}=1)$ are identical, and $w$ ill predict the sam e m asses for the positive and negative parity baryons. This situation is sim ilar to that in the linear sigm a m odel for parity-doublet baryons proposed by D eT ar and K unihiro $[\underline{9}]$. T here the positive and negative parity nucleons are assum ed to form a parity doublet and the Lagrangian has a chiral invariant $m$ ass term . U nder the restoration of the chiral sym $m$ etry, the nucleons have the sam $e$ m ass, while in the spontaneous sym $m$ etry broken phase the $m$ ass splitting is proportional to the nonvanishing vacuum expectation value of sigm a. In another article [ $[\underline{1} \overline{1}]$, we have show $n$ that this sim ilarity to the linear sigm a m odel is con m ed also in the N N coupling in the QCD sum rule.
$W$ e note several other approaches of the QCD sum rule for $B$. In the case that $B$ is the lowest energy state in the considering spectrum, the $m$ ass of $B$ is extracted in the usual sum rule. In $R$ ef. $\left\{\begin{array}{l}{[-\overline{4}], ~ I o ~ e ~ p o i n t e d ~ o u t ~ t h a t ~ t h e ~}\end{array}\right.$ negative-parity resonance is the ground state in the spectrum of the baryon $w$ ith spin $J=\frac{3}{2}$ and isospin $T=\frac{1}{2}$ and calculated its $m$ ass. Liu also applied the QCD sum rule to (1405) and concluded that for the (1405) the

IF consisting of three quarks and a avor octet quark-antiquark pair is im portant [1] In ${ }^{1}$. In his analysis, how ever, the continuum term is not considered. $W$ e obtain the realistic $m$ ass of (1405) in the three-quark sum rule with a continuum term. Som e other approaches treat B w ith an $\mathbb{F}$ which does not couple to the positive-parity ground state baryon. In Ref. [G] an optim ized $\mathbb{F}$ for $N$ w as proposed by requiring that the chiral odd correlation function, in which the $\mathrm{B}+$ contribution and the B contribution have di erent sign, becom es negative. Lee and $K$ im also investigated the $m$ ass of $N$ (1535) [1] $\left.\overline{1} \bar{Z}_{1}\right]$ and
(1405) [T] in the QCD sum rule. They proposed a new $\mathbb{F}$ w ith a covariant derivative, expecting that it has a large overlap $w$ ith the nonrelativistic quark wave function ofN (1535). They chose the $\mathbb{F}$ so that it does not couple to the ground state nucleon $[\underline{1} \overline{\mathcal{Z}}]$. W e, how ever, em ploy the nonderivative $\mathbb{F}$ in the present study because ourm ain interest is to study the $m$ echanism of $B+\{B$ m ass splitting.

## 3 D eterm ination of the $B \quad m$ asses

W e have three phenom enological param eters, the $m$ ass $m_{B}$, the threshold $s$ and the coupling strength to be determ ined from the sum rules ( (12 12 and ( $\left.1_{1}^{1} \overline{1} \overline{1}_{1}\right)$. Unlike the standard sum rule we have only one sum rule for each baryon. Therefore we are forced to solve the system of three equations, eq. ( $112 \overline{1} \overline{2}$ ), the rst and the second derivatives of ( 1 $m$ ass. In general, when we de emtiate the sum rule w ith respect to the B orel $m$ ass, the reliability of the Q CD sum rule is lost, since the derivative picks up the a factor $\mathrm{p}^{2}$, which m ay enhance the contribution of the continuum. But we should judge the reliability from the stability of the results against the B orelm ass. O ne sees that the baryon $m$ asses show enough stability in our analysis.

The theoretical side depends on the Q CD param eters, such as the quark m ass and the gauge coupling constant, and also on the other param eters that describe the properties of the nonperturbative vacuum of QCD, such as the quark and ghon condensates. W e take the chiral lim it for the up and down quarks, i.e. $m_{q}=0$, where we use the symbol $q$ for the up and down quarks. W e introduce the strange quark $m$ ass $m s, \quad h s s i=h q q i ~ a n d$ 5 hsg Gsi=hqg G qi for the avor SU (3) sym m etry breaking. The ghon condensate is xed to $h-s G G i=(0: 36 \mathrm{GeV})^{4}$ since the coe cient is sm all in com parison $w$ th the other term $s$ due to a suppression factor of $1=(2)^{2}\left[\begin{array}{ll}{[1 \overline{4}}\end{array}\right]$. $T$ he vacuum saturation is assum ed for evaluating the $m$ atrix elem ent of the four-quark operators, i.e. $h(q q)^{2} i=h q q i^{2}$. T hese param eters have som e uncrtainty, which depends on the truncation in the OPE. In order to rem ove this uncertainty, we use our sum rules in the follow ing way. T he value of hqqi and $m_{0}^{2}$ hqg Gqi=hqqi are determ ined so that the sum rules ${ }_{1}^{1}(\underline{1} 12)$ and ( $(1,13 \overline{1})$ ) for the nucleon reproduce the observed $m$ asses of $N+$ and $N$. In doing so we require that the prediction of the sum nule at $M \quad m_{B}$ coincides with the observed $m$ ass $w$ thin $5 \%$ and also that for the B orel stability variation of the predicted $m$ ass against $M$ in the region $m_{B} \quad m_{B}+0: 5 \mathrm{GeV}$ is less than $10 \%$. In the sam e way, the values ofm s , and 5 are determ ined so that the
sum rules ( $(1 \overline{1} \overline{1})$ for the hyperons give the observed $m$ asses of the $+r+$ and

## $4 \quad R$ esults and $D$ iscussion

T he determ ined param eters in the theoretical side are given in Table $m$ asses of the positive-parity hyperons, +,+ and + are sensitive to the $S U_{f}(3)$ breaking param eters $\mathrm{m}_{\mathrm{s}}$, and 5 . Therefore these param eters are determ ined well. A swe shallsee later, the value ofhqqi is determ ined from the $m$ ass splltting of $B+$ and $B$. The up and dow $n$ quark condensate agrees well to the \standard value" hqqi $=(0: 2250: 025 \mathrm{G} \mathrm{eV})^{3}$, which was estim ated in the chiralperturbation [15 w as estim ated in the Q CD sum rule for the octet and the decuplet baryons [1] The value $\mathrm{m}_{0}$ is also consistent w ith $\mathrm{m}_{0}^{2}=0: 5 \quad 1: 0 \mathrm{GeV}^{2}$ estim ated in the sum rules for baryon $\left[\overline{1} \bar{T}_{1}, 1 \overline{1} \bar{q}\right]$, and $\mathrm{m}_{0}^{2}=1: 1 \quad 0: 1 \mathrm{G} \mathrm{EV}^{2}$ in the lattioe calculation [1] ]. T he instanton contribution leads to the $m$ ixed condensate som ew hat larger, $\mathrm{m}_{0}^{2}=1: 4 \mathrm{GeV}^{2}\left[\overline{1} \overline{9}_{1}, \overline{1}, \overline{0} \overline{1}\right]$. The reason for this large value is that the higher dim ensional operators induced by the instanton reduce $m_{0}$ e ectively $\left.{ }^{[20} 0^{\prime}\right]$. A though the strange quark m ass $\mathrm{m}_{\mathrm{s}}$ is som ew hat sm aller than the update analysis $\left[\overline{2}_{2}^{1}\right]$, our results of the $B \quad m$ asses are insensitive to $\mathrm{m}_{\mathrm{s}}$. T he sum nules for the baryons gives $0: 8$ [1] $\left.\overline{\underline{G}}, \overline{2} \overline{2} \overline{2} \overline{2}\right]$. T he value of the 5 is expected to be close to , because both and 5 are related to the avor SU (3) breaking in QCD. In Ref. [2] $\overline{2}]$, how ever, the sum rule for baryon suggests $5=1: 4$.
$T$ he $m$ asses of the avor octet and singlet baryons calculated in the Q CD sum rule are show $n$ in $T a b l e{ }_{1}^{2}$, . The observed $m$ asses are reproduced fairly well. Them asses of the , , $s$ and $s+$ are the prediction $w$ thout adjustable param eters. T hese $m$ asses are taken at the B orelm ass $M$ ' $m_{B}$. $T$ he $M$ dependence of the $m$ asses are show $n$ in $F$ ig. 'i for the octet $B_{+}$, in Fig. ${ }^{\overline{2}}$, for the octet B , in Fig. stable against the B orelm ass M. The excited baryon with $J^{P}=\frac{1}{2}$ has not been identi ed by experim ent, but resonances $w$ th unknown spin and parity are found at 1690 M eV and 1950 M eV . The prediction of our sum rule prefers (1690). O ur result suggests that them asses of the B tend to be degenerate. $T$ his is the result of tw o di erent origins of the $m$ ass di erence. T he strange quark $m$ ass raises the hyperon $m$ asses, while the quark conden sate $w$ idens the $m$ ass splitting ofB + and B . Because the strange quark condensate is sm aller than the up and down quark condensate, the e ect of the strange quark $m$ ass is partly canceled in the negative parity baryons.

The hqqi dependence of the $m$ asses of $B$ is show $n$ in $F$ ig value of hqqi the other param eters in the theoretical side, $m 0, \mathrm{~m}$ s, and 5 are adjusted so that the $m$ asses of $N+,+,+$ and + are reproduced, while the $m$ ixed condensate hgg $G q i=m_{0}^{2}$ hqqi and the strange quark condensate hssi $=$ hqqi are varied along $w$ ith the quark condensate hqqi. W e see that the quark condensate pushes up the $m$ asses of the $N$ and as long as the $m$ asses of $N_{+}$and + are xed. Therefore the $m$ agnitude of the quark condensate determ ines the scale of the mass splitting of $B_{+}$and $B$. The
$m$ asses of and behave sim ilarly against the quark condensate as in $N$ and .

It is extrem ely interesting to observe that the Q CD sum rule predicts the avor-singlet $s$ spectrum in the reversed order. Nam ely, the baryon s is lighter than the positive parity $s+. T h i s$ is consistent $w$ ith the quark $m$ odel prediction that the Pauli principle forbids all quarks occupying the ground $s w a v e ~ s t a t e$. In the correlation function $B$ for the $s$, there is no dim ension ve term, hqg Gqi. If we put the dim ension ve term in the B correlation function by hand and calculate the $m$ asses of the $s+$ and $s$, then we nd that the increase of the dim ension ve term raises them ass of $s$ and lowers that of $s+$. Thuswe conclude that the absence of them ixed condensate term in the $s$ sum rule causes the reversed order of $s+$ and $s . W$ ealso con $m$ that the hqg $G$ qi term $s$, is essential in raising the $B \mathrm{~m}$ asses as w as stressed in $R$ ef. [ $[\underline{1} \overline{3}]$ ].

## 5 Sum mary

W e have proposed a technique to estim ate the $m$ asses of negative-parity baryon resonances $B$ in the QCD sum rule. It is important to separate the B contribution from the positive-parity state $B_{+} . W e$ nd that when the chiralsymm etry is restored, the $m$ asses of $B_{+}$and B becom e degenerate. $T$ his is quite natural from the chiral sym $m$ etry point of view and seem $s$ to suggest that $N$ (1535) (or in general B ) is the chiral partner of $N$ (940) (or $B+$ ). W e have calculated the $m$ asses of the avor singlet and octet $B+$ and $B$, and have con $m$ ed that the sum rule reproduces the observed $m$ asses. The mass of łoaryon is predicted 1.63 GeV and it m ay be assigned to the observed (1690) for which the spin-parity is not yet known. W e nd that the avor singlet baryon w ith negative parity is the ground state and that the predicted m ass is close to (1405). W e con m that the m agnitude of the chiral sym m etry breaking vacuum condensate, such as hqqi and hqg G qi, determ ines the scale of the $m$ ass splitting of $B_{+}$and B .

In the present analysis, we have not calculated the next-to-leading order of $s$ or higher dim ensional term $s$ in the theoretical side. A though they $m$ ay m odify our num bers slightly, we believe that the qualitative features of our calculation will not change. They are left for future analysis.
