The Rare Top Decayst! bW ⁺Z and t! dW ⁺W

Abstract

The large value of the top quark mass implies that the rare top decays t! bW ⁺Z, sW ⁺Z and dW ⁺Z, and t! dW ⁺W and uW ⁺W, are kinematically allowed so long as $m_t m_W + m_Z + m_{d_i}$ 171:5 GeV + m_{d_i} or $m_t 2m_W + m_{u,c}$ 160:6 GeV + $m_{u,c}$, respectively. The partial decay widths for these decay modes are calculated in the standard model. The partial widths depend sensitively on the precise value of the top quark mass. The branching ratio for t! bW ⁺Z is as much as 1 10 ⁵ for $m_t = 200$ GeV, and could be observable at LHC. The rare decay modes t! dW ⁺W and uW ⁺W are highly G M -suppressed, and thus provide a means for testing the G M mechanism for three generations of quarks in the u, c, t sector.

Now that the top quark mass is known to be quite large, it is possible to exam ine the question of which rare decay modes of the top are kinematically allowed processes. The current CDF and D0 average value of the top quark m ass $m_t = 175$ 8 GeV [1,2] im plies that the decays t! bW $^+$ Z, sW $^+$ Z and dW $^+$ Z, are allowed decay modes of the top so long $m_W + m_Z + m_{d_i}$ 171:5 GeV + m_{d_i} . The rare decays t! dW + W asm+ and uW +W 160:6 G eV + m cau. For the present central value of also are allowed if $m_t ! 2m_w + m_{cu}$ the measured top quark mass, all of these processes are occurring at or near threshold, and are highly phase space suppressed. The decays t! W Wand uW + Ware also highly G IM -suppressed, and thus are not likely to be seen at standard m odel rates. The decays $t! d_iW + Z$, however, are not G IM -suppressed and are potentially observable at the LHC.

The partial decay widths for these rare decay modes rapidly increase for larger values of the top quark mass, and thus are very sensitive to the precise value of the top quark mass. Since the decay widths are proportional to $\mathbf{j}_{td_i}\mathbf{j}$, $\mathbf{i} = 1;2;3$, the rare decay t ! bW ⁺Z (with $\mathbf{j}_{tb}\mathbf{j}$ 1) will dominate unless the value of the top quark is below or nearly at threshold for this process.

We begin with the calculation of the partial decay width (t ! bW + Z) in the standard m odel. The branching ratio for this decay process has been computed previously by D ecker, N ow akow ski and P ilaffsis [3] and M ahlon and Parke [4]. The authors of R ef. [4] included the nite widths of the W and Z in their calculation, and found a signi cant enhancement in the decay width near threshold due to nite width e ects. There is some disagreement in the numerical results of R ef. [3] and [4]. The numerical results presented here are basically consistent with the published results of R ef. [4] in the narrow width approximation. There is some numerical difference with R ef. [4] which probably stems from the inclusion of nite width e ects in that calculation. In addition, explicit analytic formulae for the squared amplitude of t ! bW + Z are presented in this work. These formulae do not appear elsewhere in the literature, and are useful formore detailed studies of the decay mode. Finally, the decay widths for the other rare decay modes t ! cW + W and uW + W also are computed. A search for these decay modes directly tests CKM unitarity in the u-quark sector.

The rare decay t ! bW + Z proceeds via the three tree-level graphs drawn in Fig. 1. The am plitudes for these Feynm an diagram s are

The decay process Q ! qW Z also was considered in Ref. [5] for very heavy fourth generation quarks and exotics with mass 240 GeV.

In the above amplitudes, $P_{L,R}$ stand for the left- and right-handed projectors $P_{L,R} = (1_5)=2$, and $_W$ is the weak mixing angle. The amplitude A₃ depends on the triple gauge vertex W^+W^-Z . This amplitude has been written in unitary gauge, where there is a contribution to the W gauge boson propagator proportional to $k_3k_3=m_W^2$. The amplitude also can be written in t'H ooft-Feynm an gauge (= 1), where this contribution is replaced by the exchange of the would-be G oldstone boson of the W.

The above square amplitudes have been written in terms of k_1 and k_2 , and p_t and p_b , in order to exhibit the symmetries of the square amplitudes explicitly. The total square amplitude can be rewritten in terms of the three dot products $(p_b \ p)$, $(p_b \ p)$, and $(p_W \ p)$, by eliminating p_t , k_1 and k_2 in the above form ulae.

The partial width for the decay mode t ! bW $^+$ Z is given by the three-body phase space integral

since one averages rather than sum s over the top quark spin.

The partial decay width (t ! bW ⁺Z) is plotted in Fig. 2 as a function of the top quark m ass. The phase space integral was performed numerically for the parameter values $m_W = 80.3 \text{ GeV}, m_Z = 91.2 \text{ GeV}, m_b = 4.5 \text{ GeV}, \sin^2_W = 0.23 \text{ and } \text{J}\text{V}_{\text{tb}}\text{j} = 1$. The partial width is plotted over the range from $m_t = 176 \text{ GeV}$, where the partial width vanishes, to $m_t = 200 \text{ GeV}$, where the partial decay width is 2.5 10^{-5} GeV . The branching ratio BR (t ! bW ⁺Z) also is plotted as a function of the top quark m ass in Fig. 3, assuming that the total width of the top quark is dominated by t ! bW ⁺,

The CKM matrix element $y_{tb} \hat{j}$ cancels out of the branching ratio. The branching ratio increases from zero for $m_t = 176 \text{ GeV}$ to 1:0 10⁵ for $m_t = 200 \text{ GeV}$.^Y Although this

 $^{^{}y}$ The value of the branching ratio for this value of m $_{t}$ is consistent with the result of M ahlon

branching ratio is too sm all to be observed at the Tevatron, it is large enough to be interesting for the LHC which is expected to yield about a million fully-reconstructed top quark events per year [6]. The observability of this decay mode depends on the precise value of the top quark mass. The branching ratio is greater than 10⁶ for $m_t > 187$ GeV. The extrem e sensitivity of the branching ratio to the top quark mass in plies that the decay mode could be used to extract or bound the top quark mass. The decay mode also is sensitive to the presence of the triple gauge vertex W⁺W⁻Z with the standard model coupling.

The rare decay t! bW^+Z is at threshold for the present central value of the top quark m ass, so the decays t! sW^+Z and t! dW^+Z could be m one in portant if t! bW^+Z is kinem atically forbidden or just allowed. A Itematively, it m ight be possible to book at these m odes by applying a tight cut on the invariant m ass of the W⁺ and Z m on enta to exclude t! bW^+Z but not t! sW^+Z and dW^+Z . The partial decay widths for the s and d nal states can be obtained from the partial decay width for the bm ode by replacing m_b by m_s or m_d, and $jV_{tb}f$ by $jV_{ts}f$ or $jV_{td}f$. The partial decay width (t! d_iW^+Z)= $jV_{ti}f$ is plotted as a function of the top quark m ass for vanishing m_{di} in Fig. 4. The partial width divided by the CKM m atrix element squared is zero at threshold where m_t = m_W + m_Z and increases to 2:7 10⁻⁵ G eV at m_t = 200 G eV. For canonical values of $jV_{ts}f$ and $jV_{td}f$, these partial widths will be too small to be observed at LHC.

II.T ! CW^+W

The rare decay t ! dW^+W proceeds through tree-level graphs with interm ediate d, s, and b quarks, as depicted in Fig. 5. The amplitude for the decay is

and Parke [4] in the narrow width approximation. There is some numerical di erence with their narrow width results for smaller values of m_t , which probably stems from the inclusion of nite width e ects proportional to $w = m_w$ and $z = m_z$ in their calculation.

where the factor of 1=2 com es from averaging over the top quark spin. Note that this square amplitude can be derived from Eq. (8) or (9). The amplitude squared can be rewritten in terms of the three dot products ($p_c \ p +$), ($p_c \ p$) and ($p_W + \ p$) of the nalparticle m om enta by eliminating p_t and k in the above formula.

The partial width for the decay mode t ! dW ^+W is given by the three-body phase space integral

The integrand of Eq. (21) is symmetric under the interchange $m_t^2 \ m_c^2$, but this symmetry is broken by the limits of integration of the remaining phase space integral. An important observation about the decay width is that the width vanishes for $m_j^2 = 0$ or $m_k^2 = 0$ by CKM unitarity,

Numerical integration of Eq. (26) (which assumes that GIM suppression is operative) shows that the decay width is completely dominated by the contribution with $m_j^2 = m_k^2 = m_b^2$. The partial width is plotted as a function of the top quark mass for $m_W = 80:3 \text{ GeV}$,

 $m_c = 1.5 \text{ GeV}$, $\sin^2_W = 0.23 \text{ and } V_{cb} = 0.036$ 0.046. The two curves correspond to the lower and upper values of the CKM matrix element V_{cb} . The partial width vanishes at threshold where $m_t = m_c + 2m_W$, and is at most 10^{-12} GeV for $m_t = 200 \text{ GeV}$. This extremely small partial width is a direct consequence of three-family unitarity of the CKM matrix in the u-quark sector. If the G M suppression condition Eq. (22) is relaxed, the integral appearing in Eq. (21) is a factor of 2 10^5 larger than I (m_b^2 ; m_c^2 ; m_c^2 ; m_W^2) for each value of m_j^2 and m_k^2 . Thus, it is quite possible that the rare decay t ! dW^+W occurs at an observable level in non-standard model theories. A search for this rare decay mode would directly test CKM unitarity of the tc rows of the CKM matrix.

The partial width for the rare decay t ! uW^+W can be obtained from the above with the replacement c \$ u. The partial width for the up mode is even smaller than for the charm mode due to smaller CKM matrix elements. This decay mode can be used to test CKM unitarity of the tu rows of the CKM matrix.
